described.

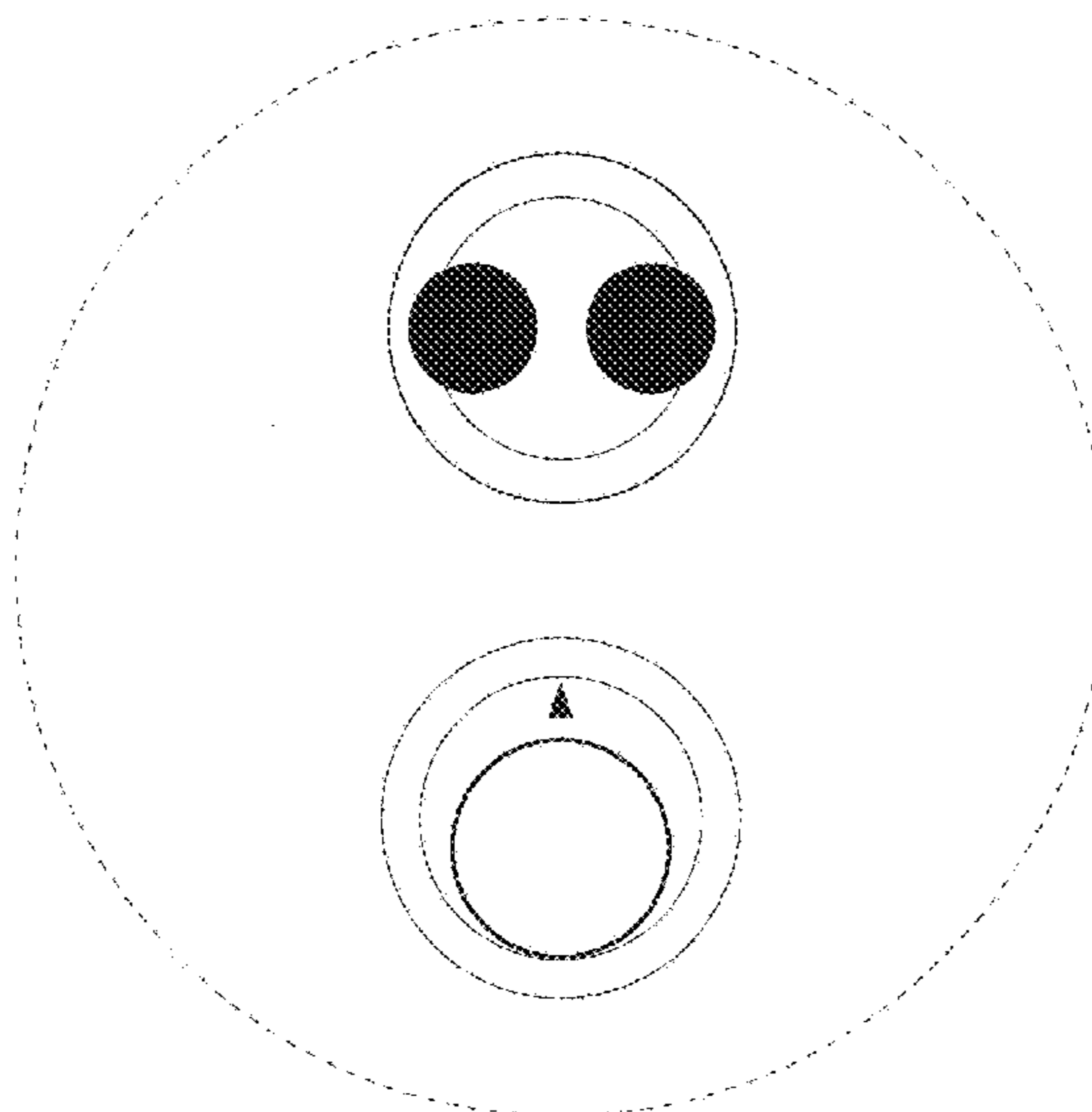
**DESCRIPTION**

moonphase and a movable tide indicator showing my new  
design, illustrated in a first configuration;

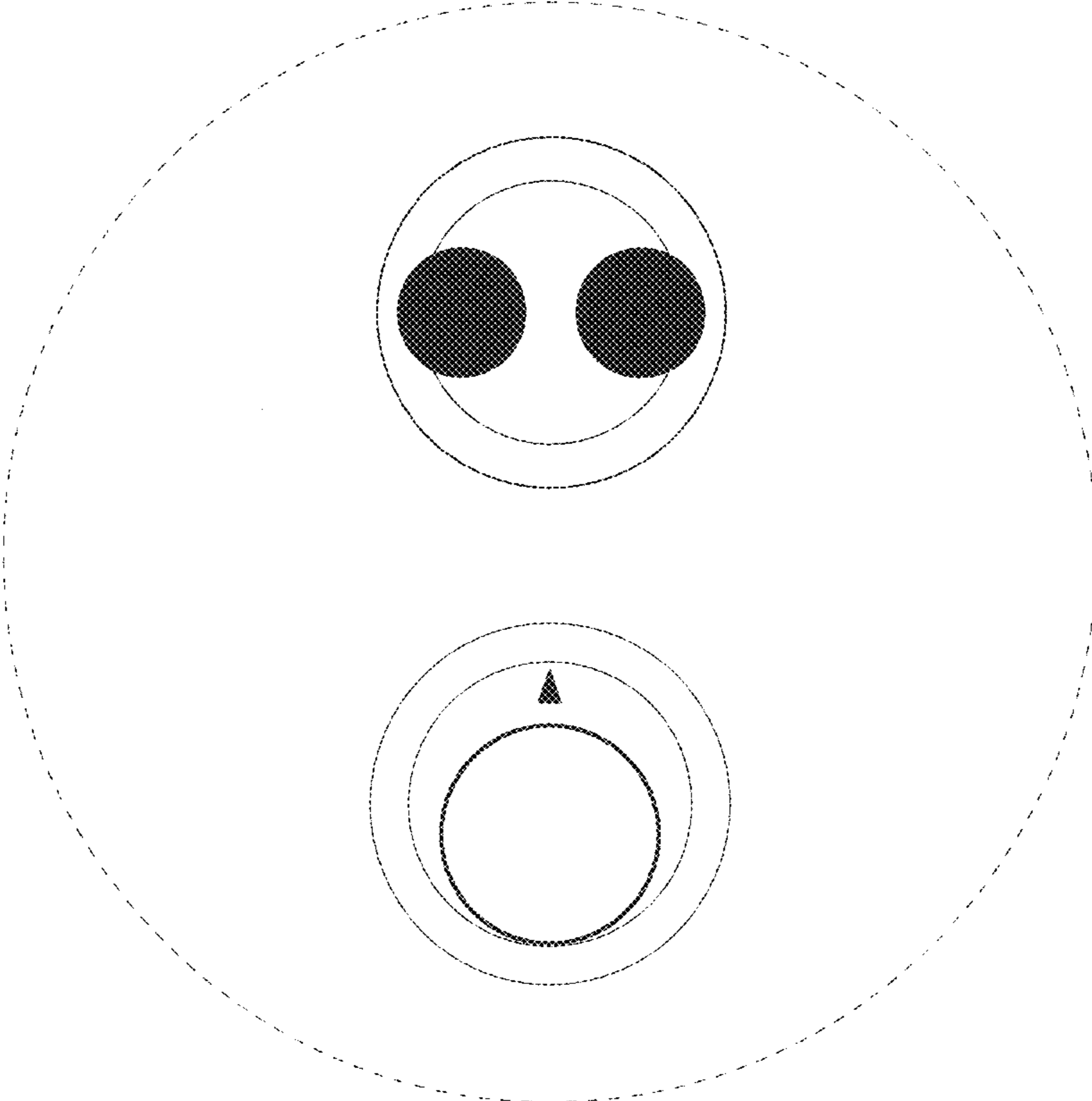

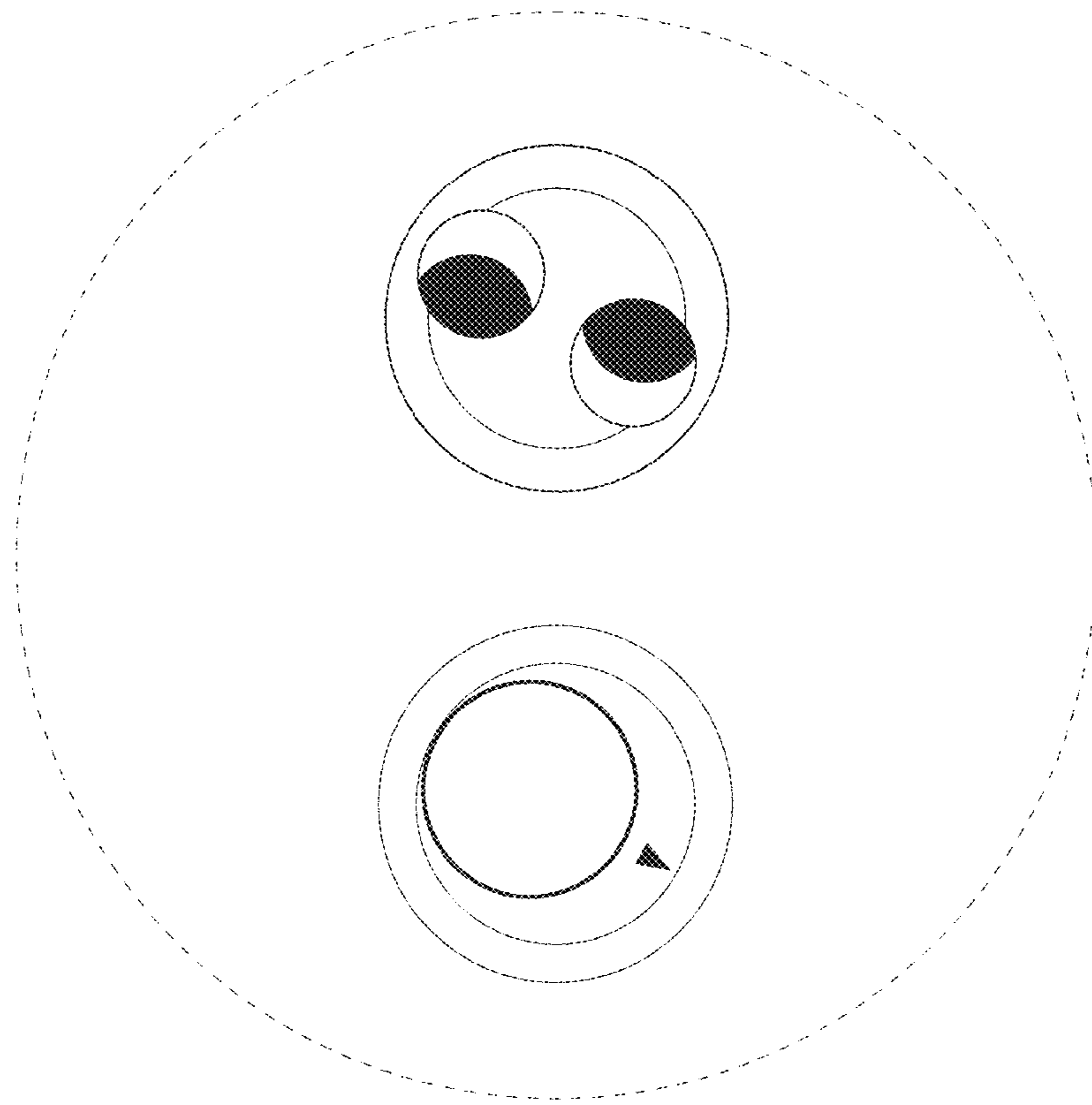

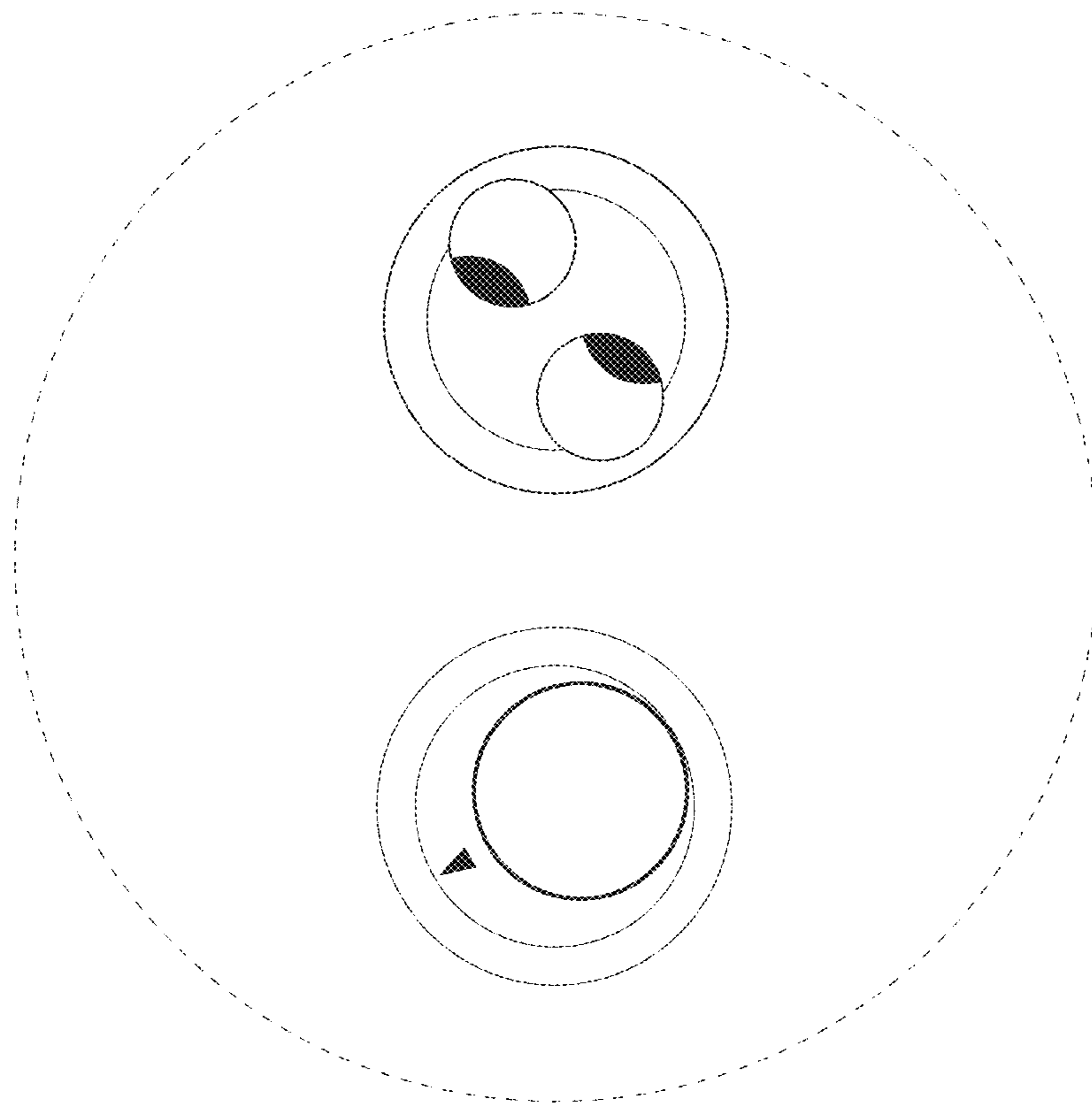

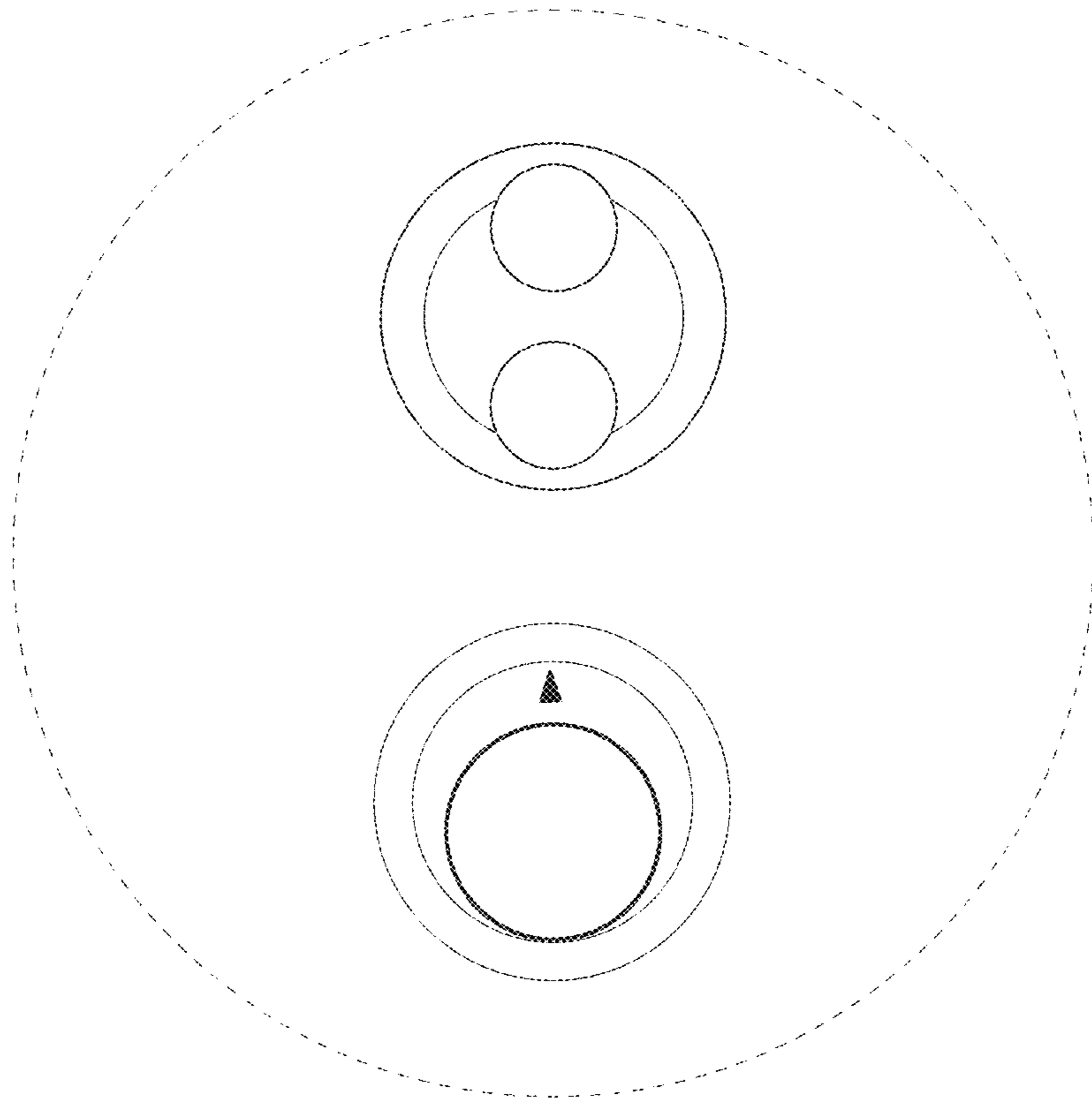

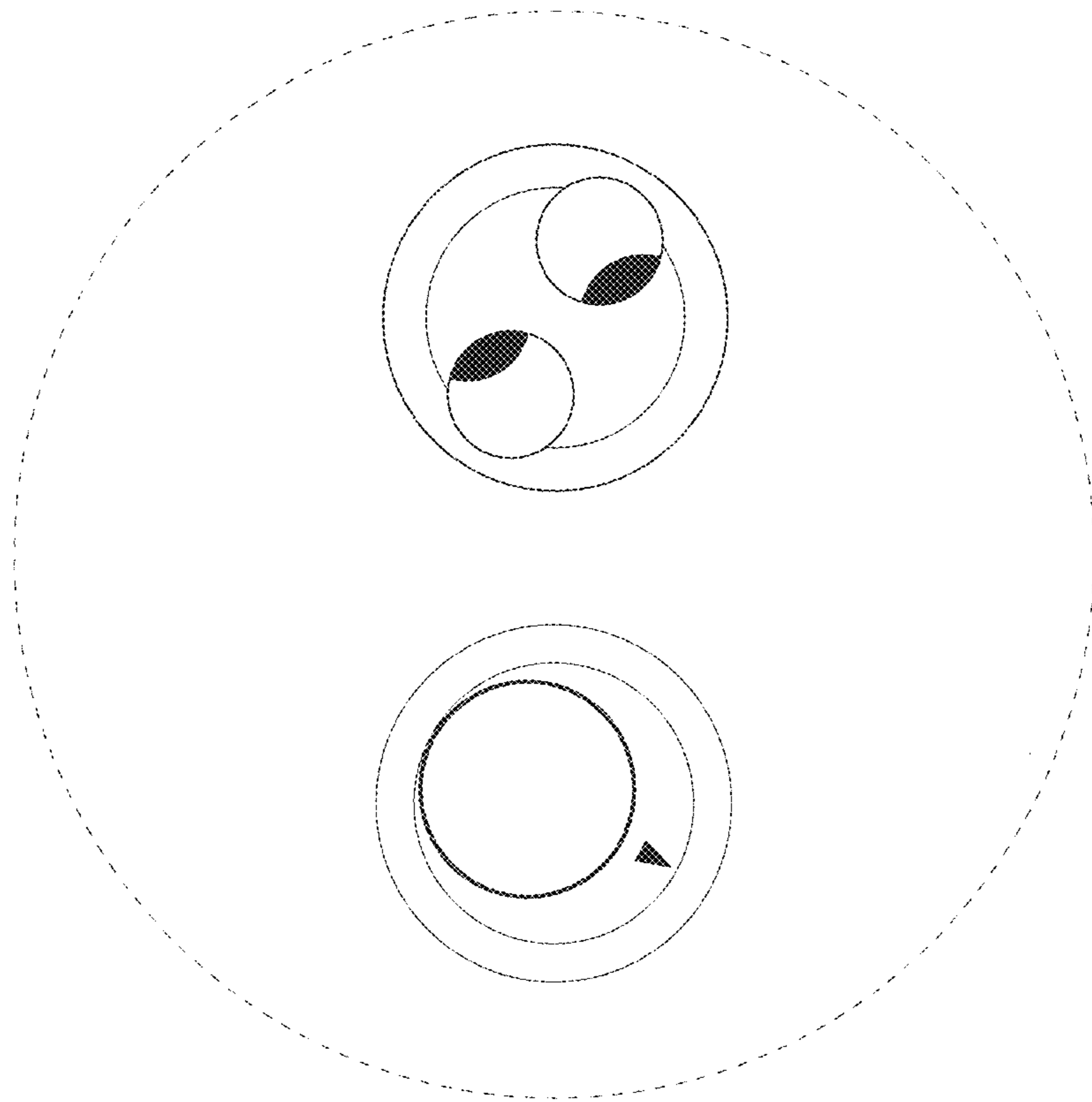

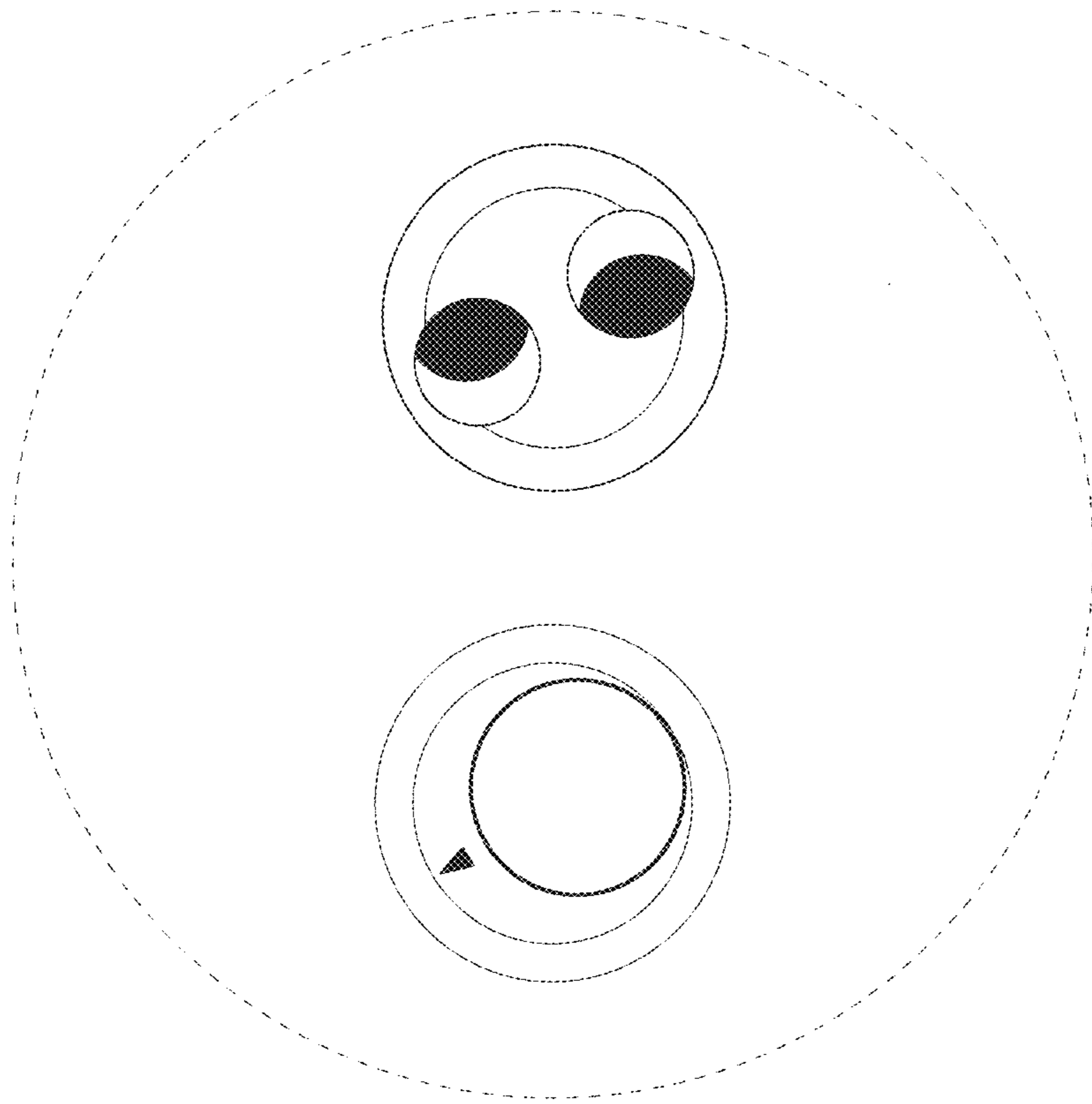

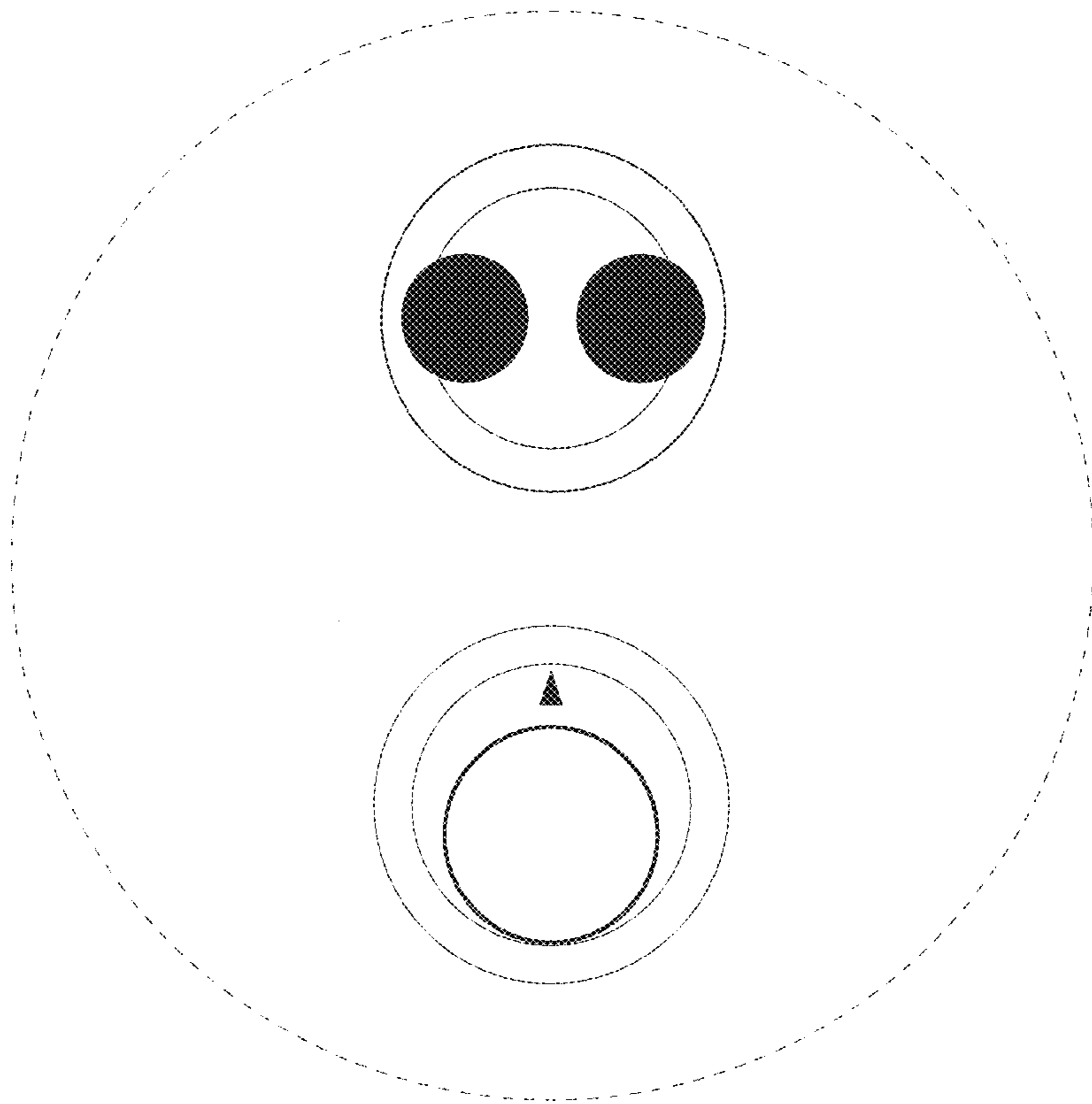
