DESCRIPTION

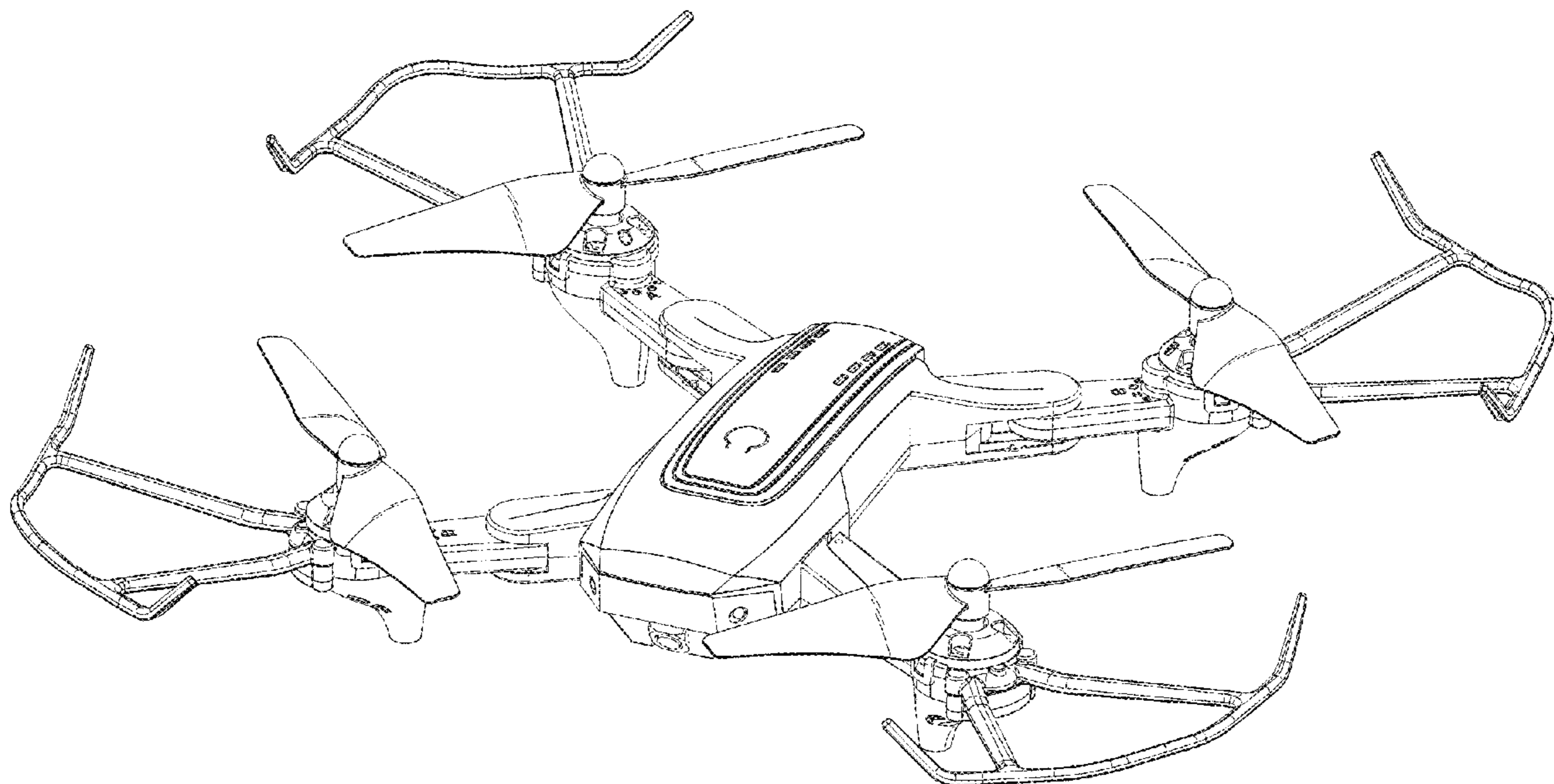
FIG. 1 is a front perspective view of an aerial vehicle showing my new design;

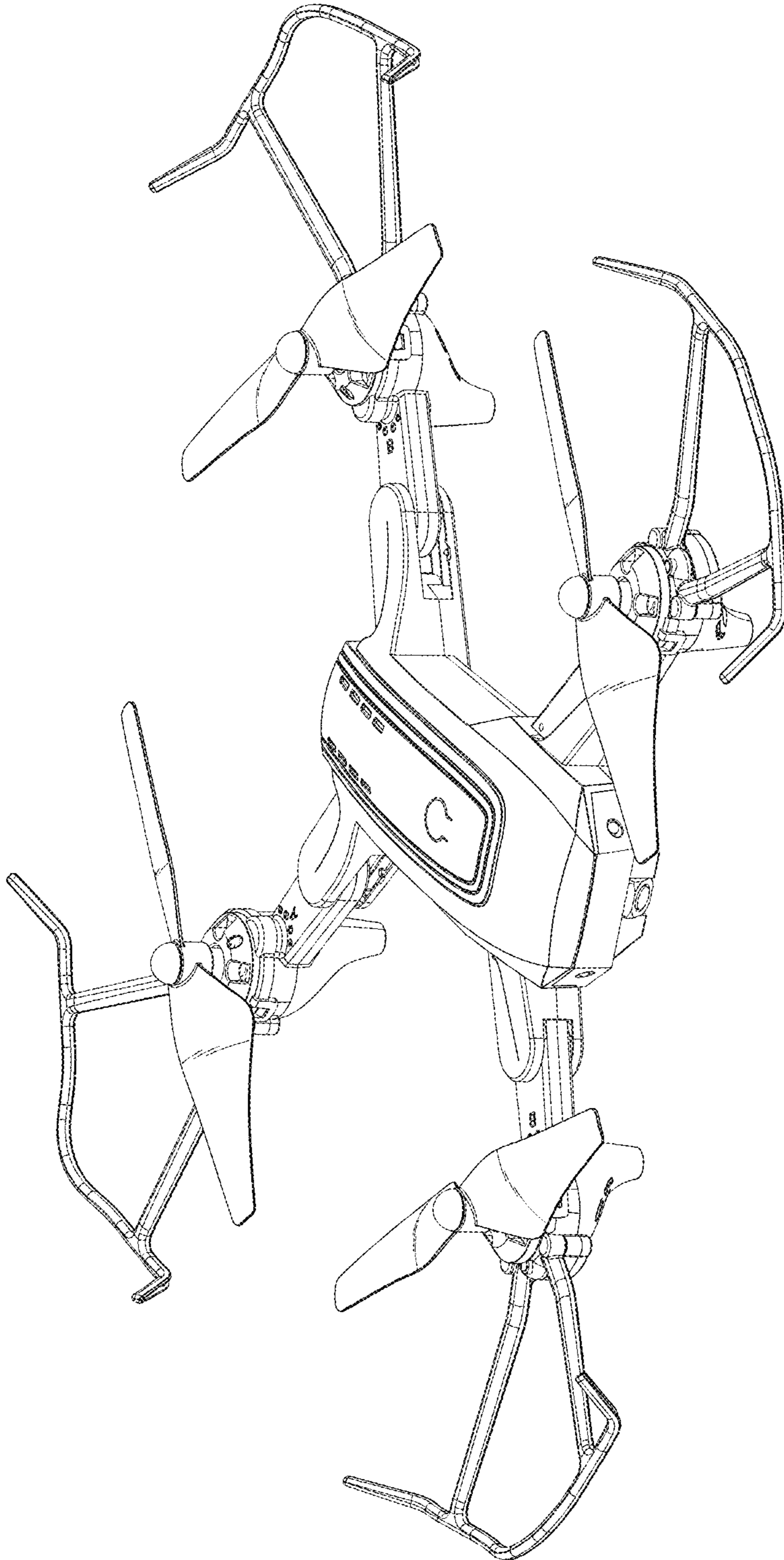

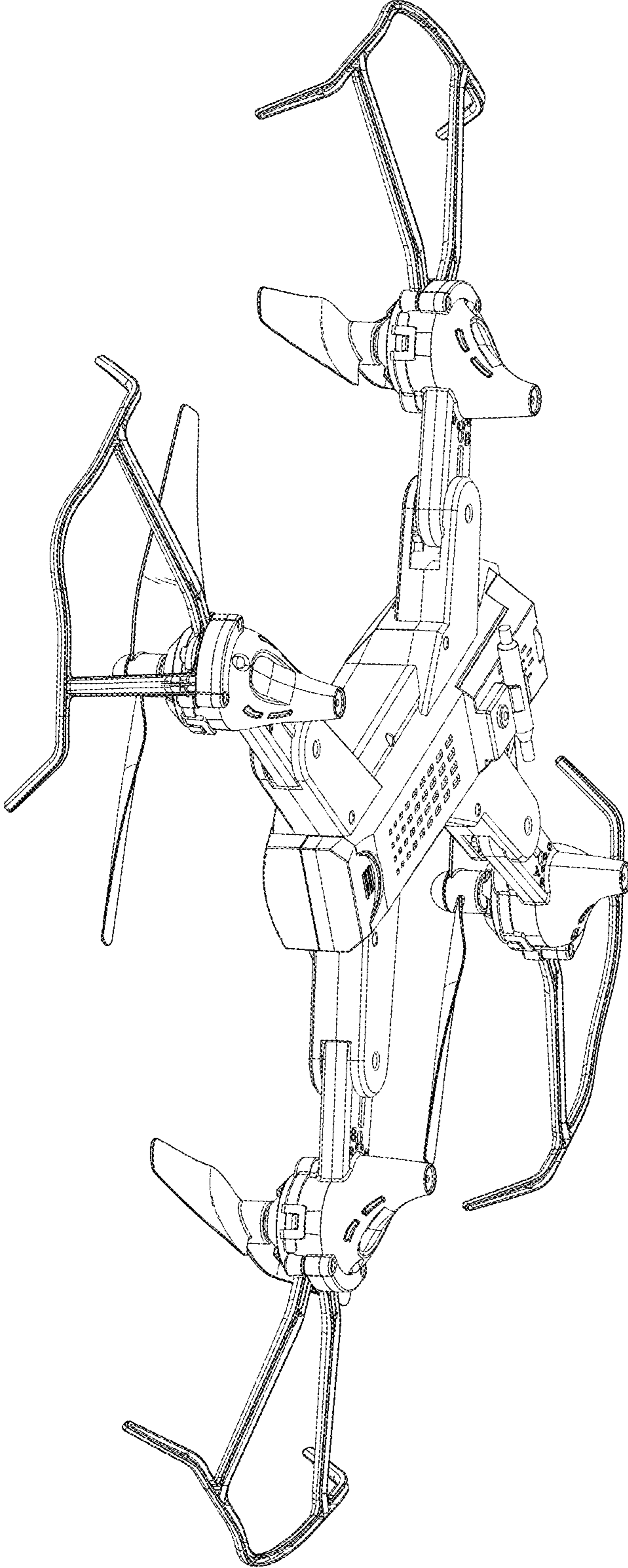

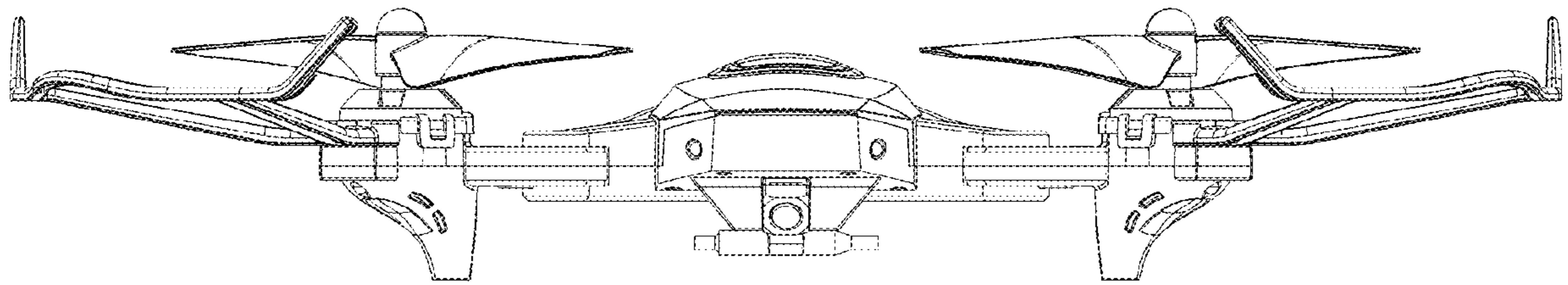

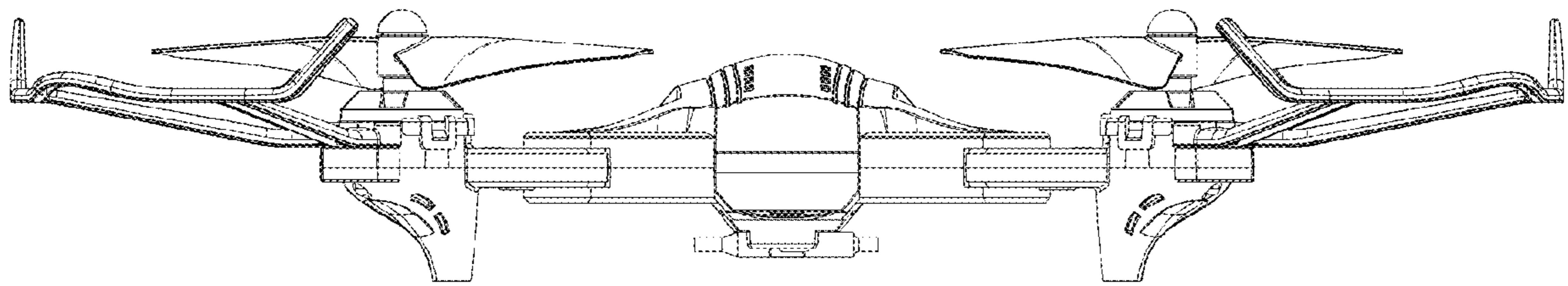

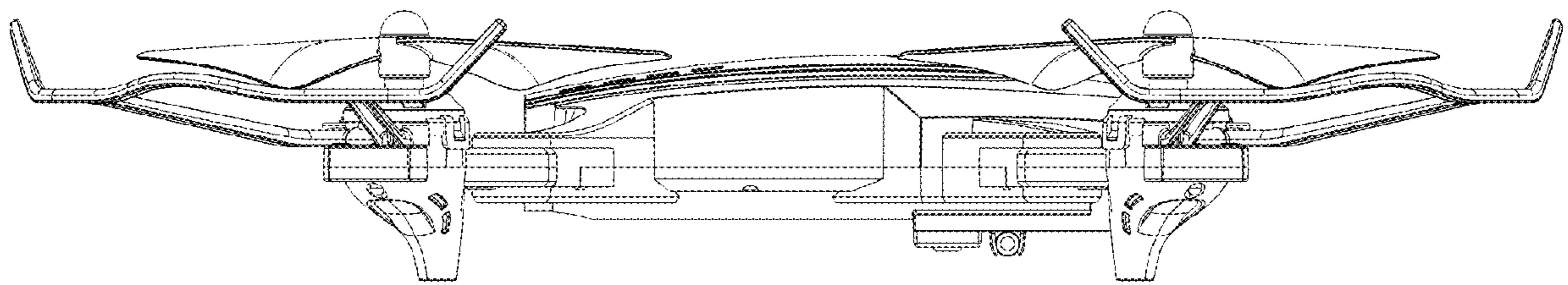

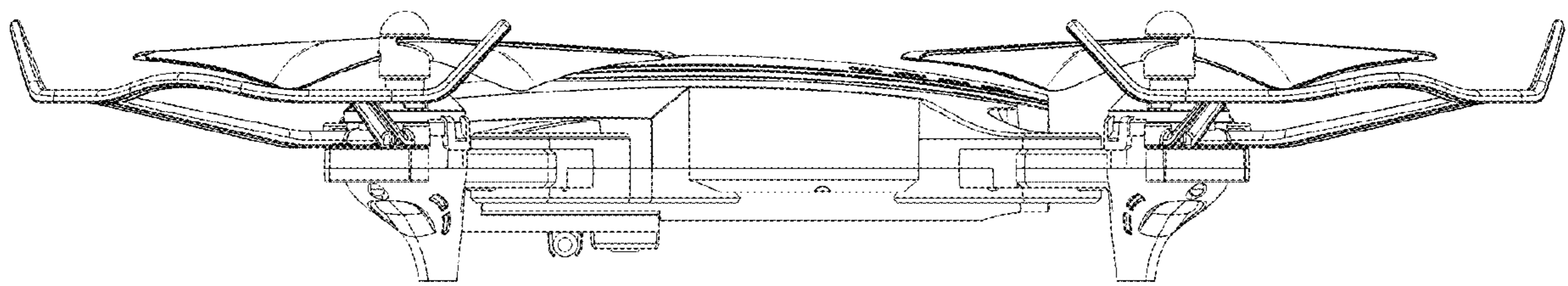

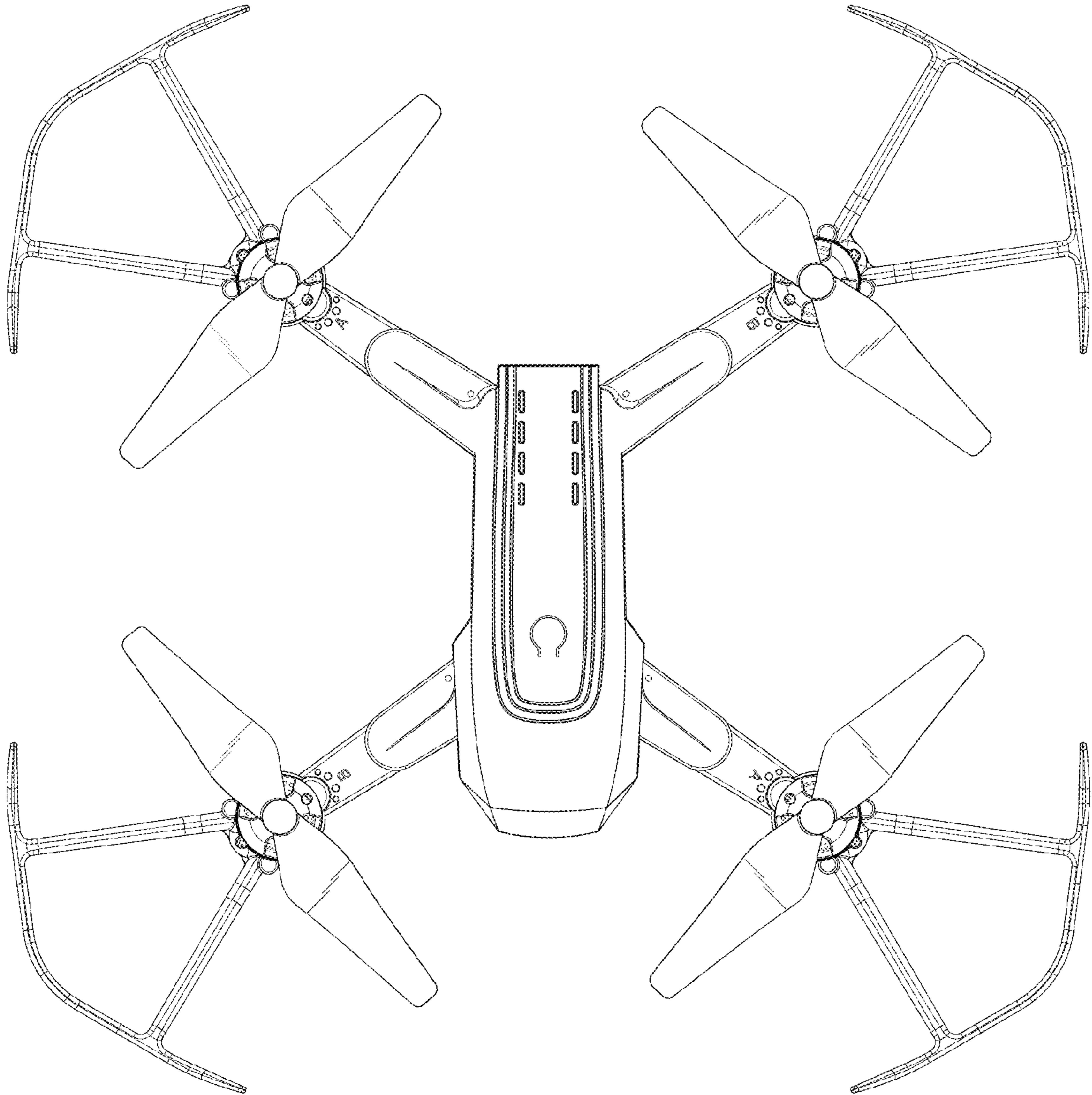

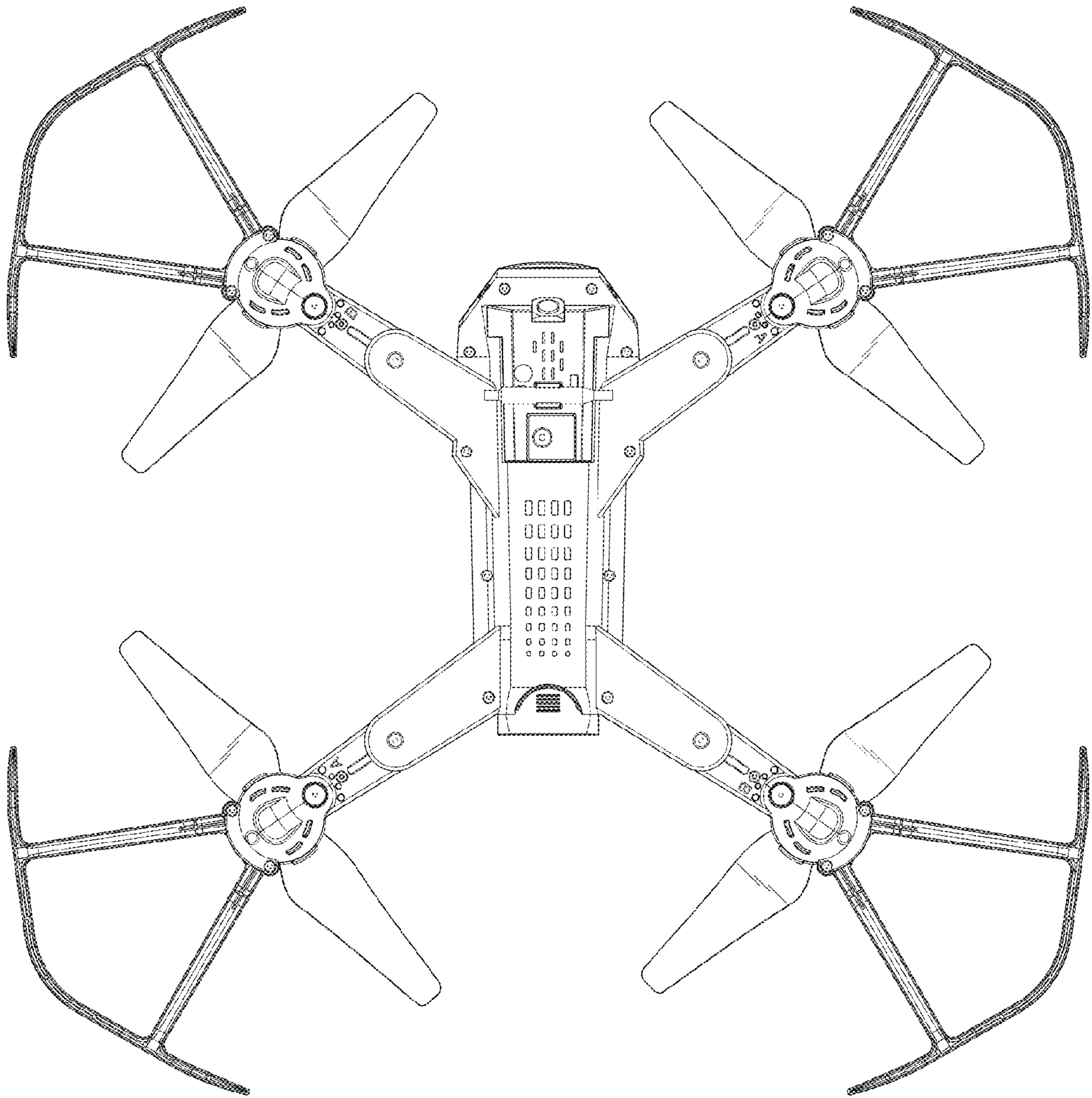
