(57) **CLAIM**

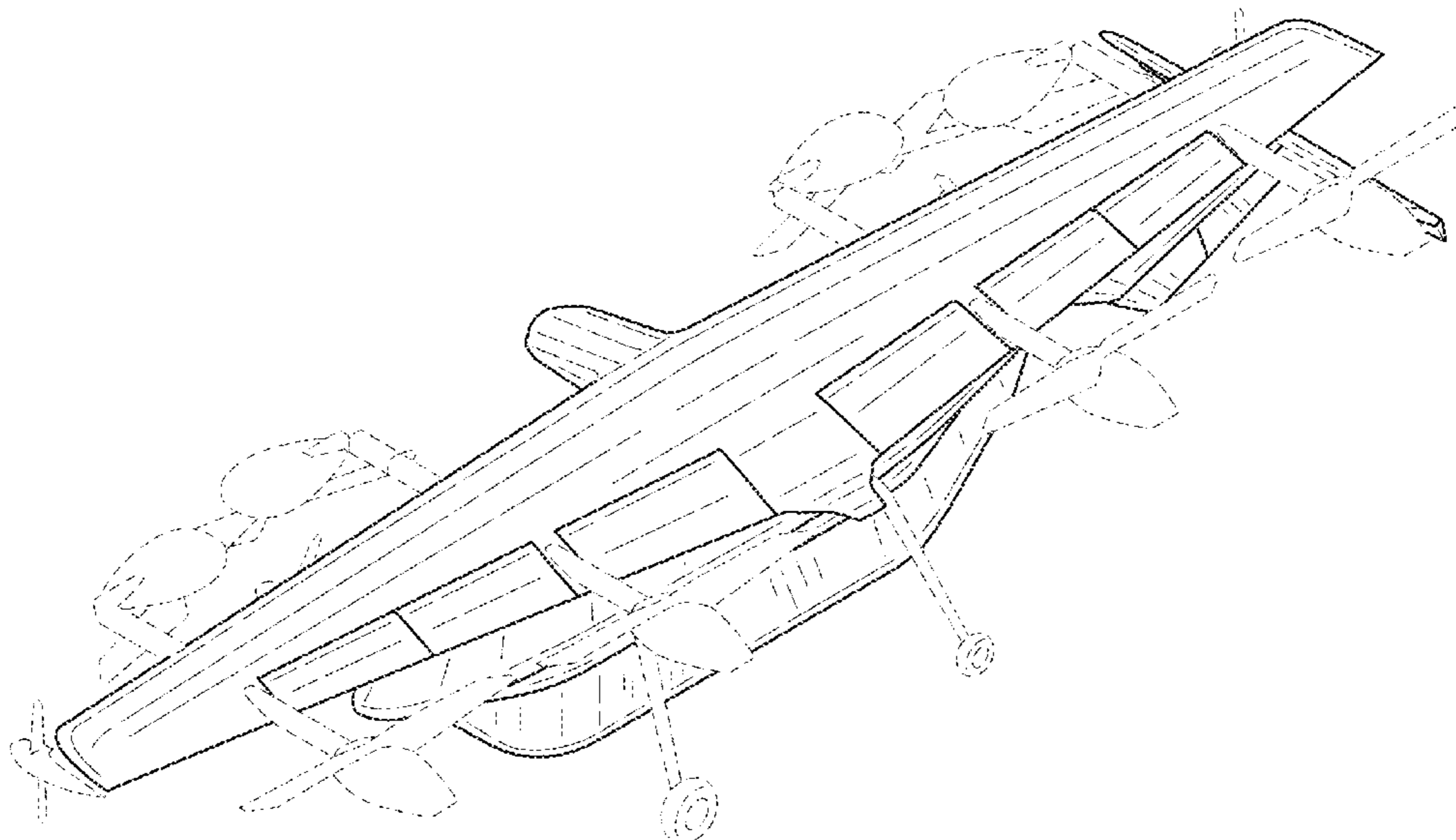
The ornamental design for a transportable unmanned cargo delivery aircraft, as shown and described.

**DESCRIPTION**

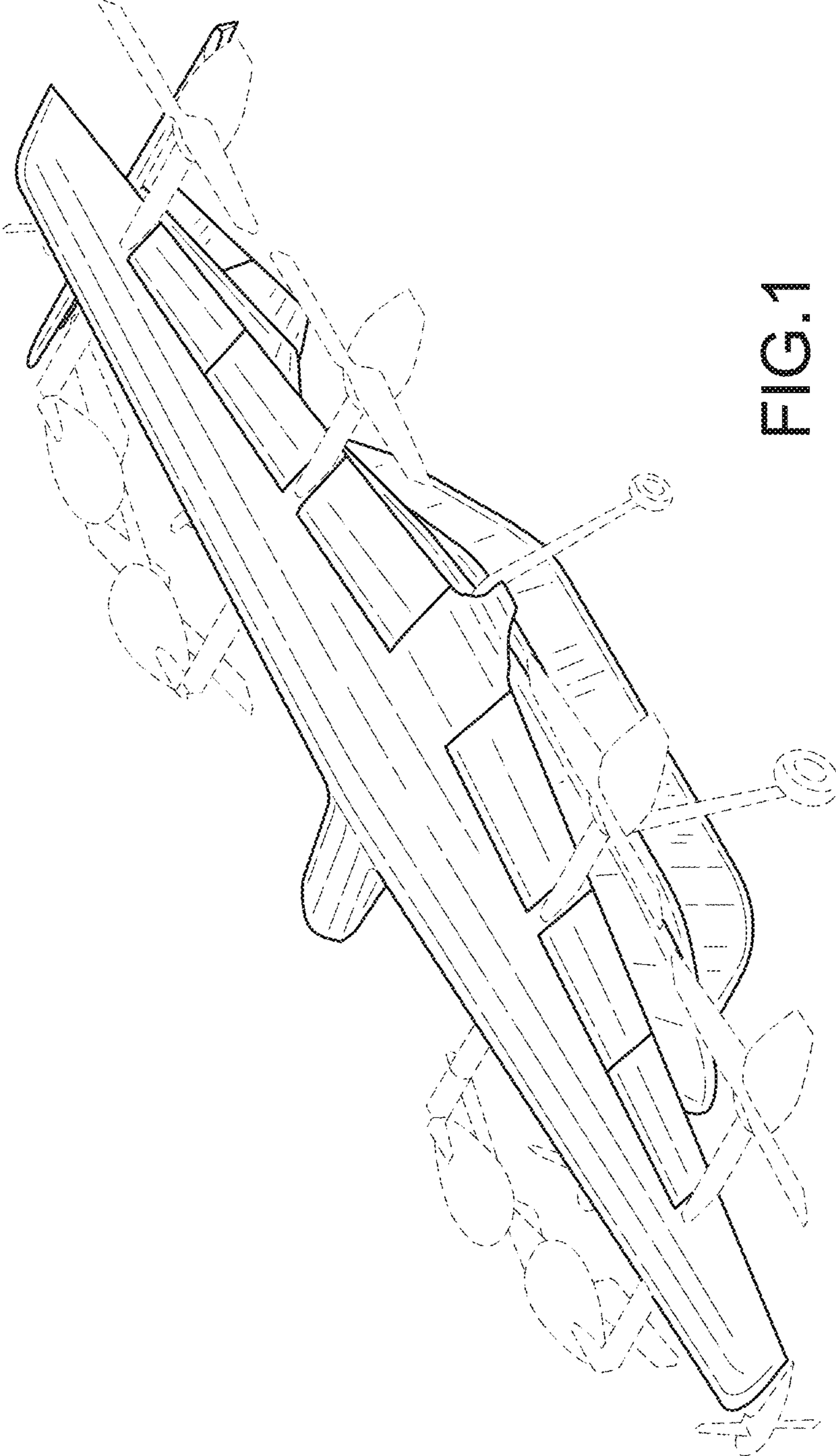

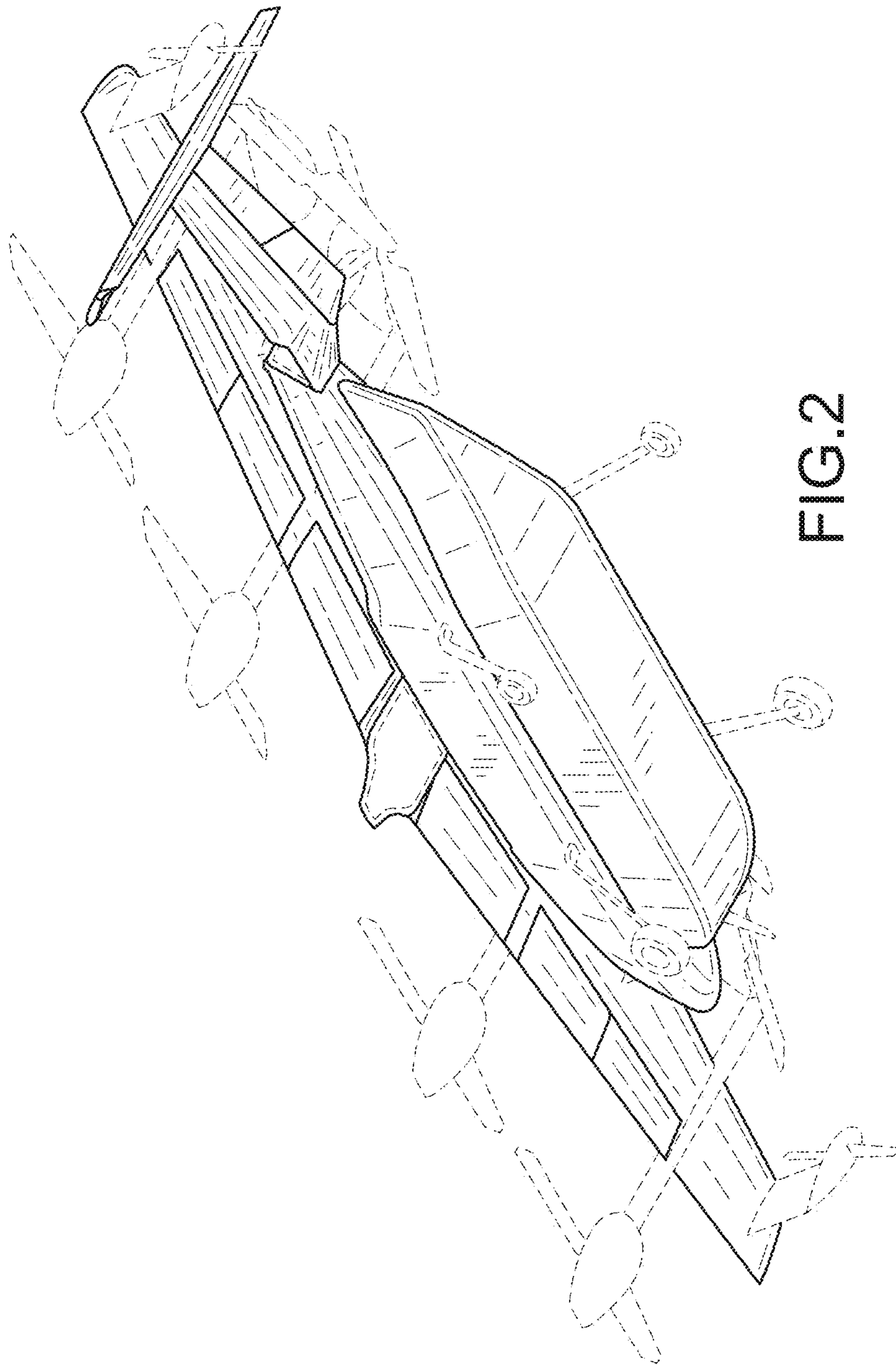

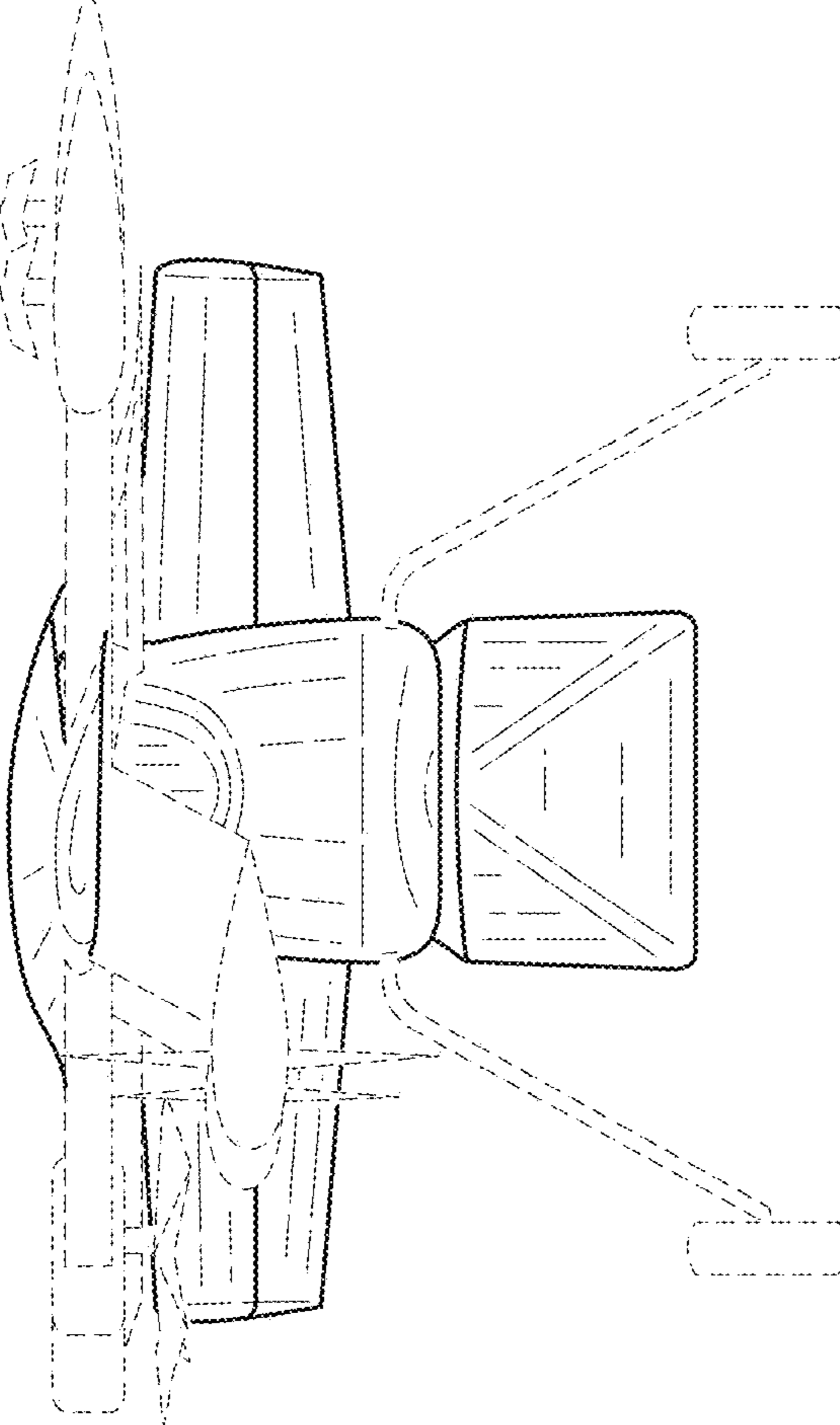

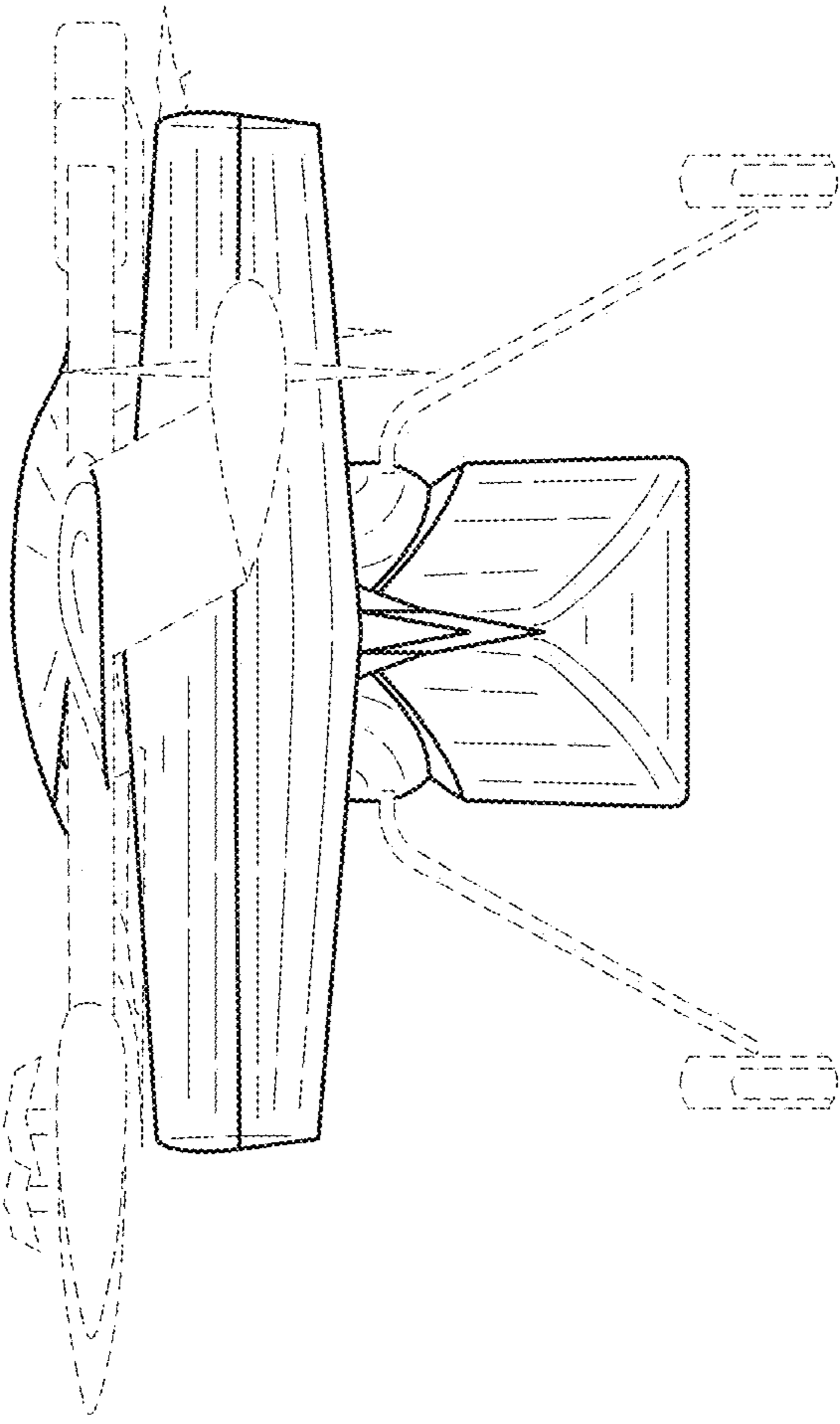

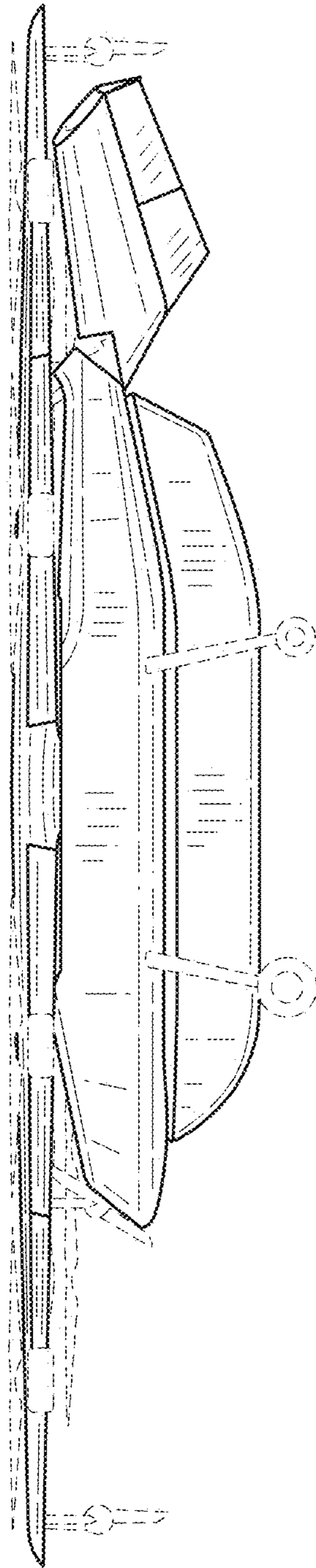

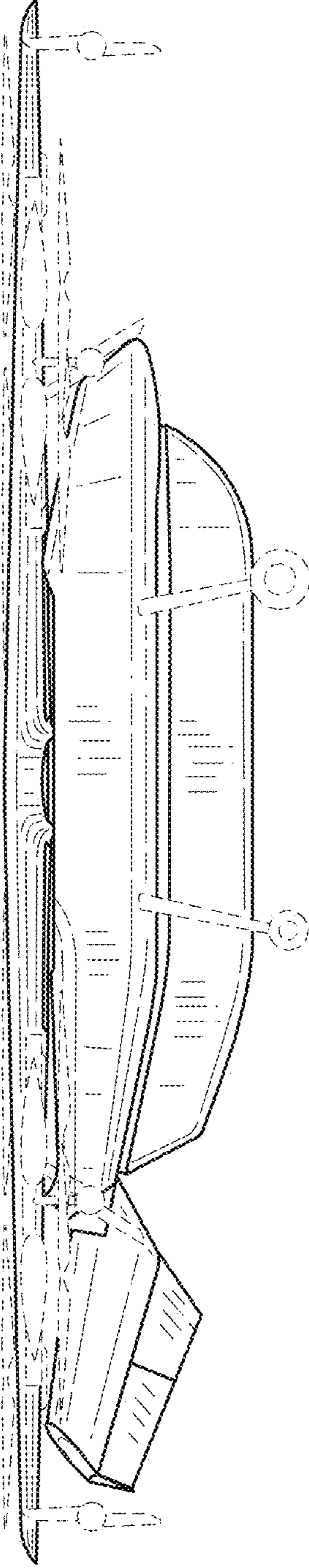

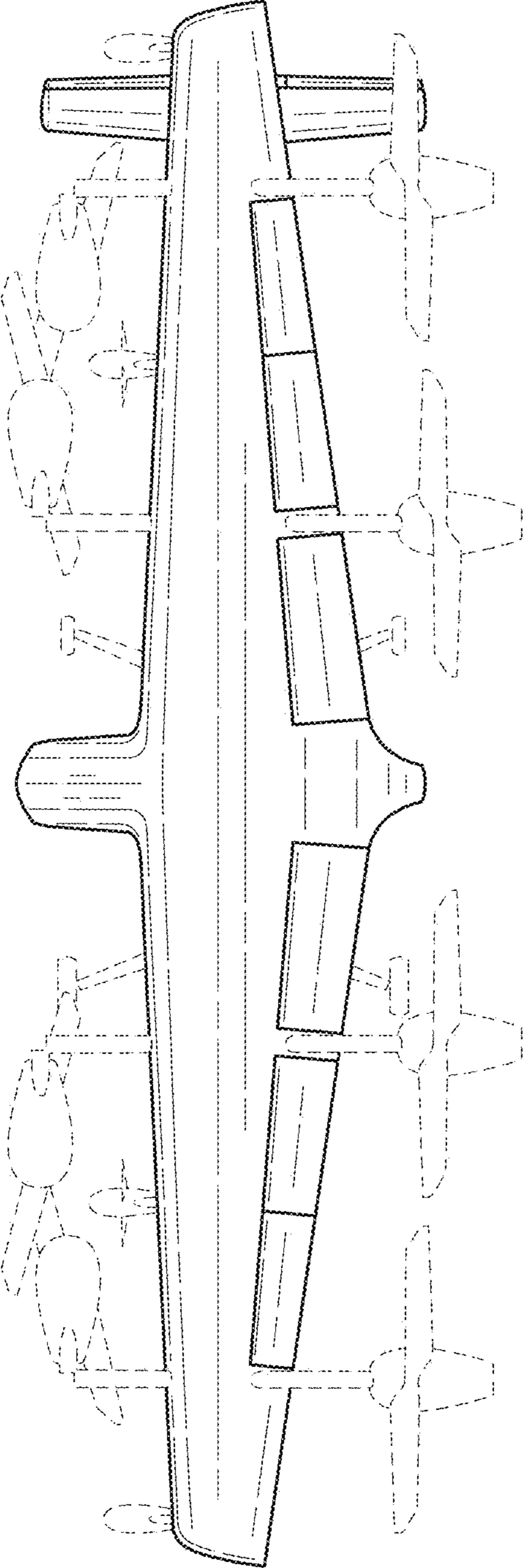

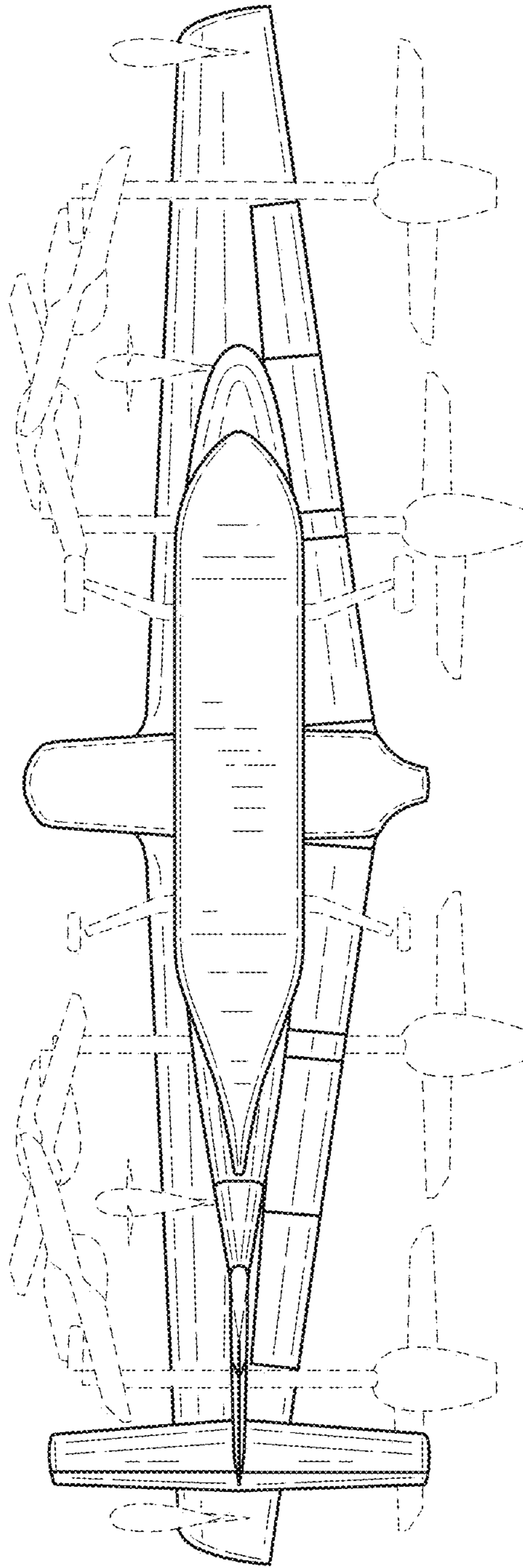

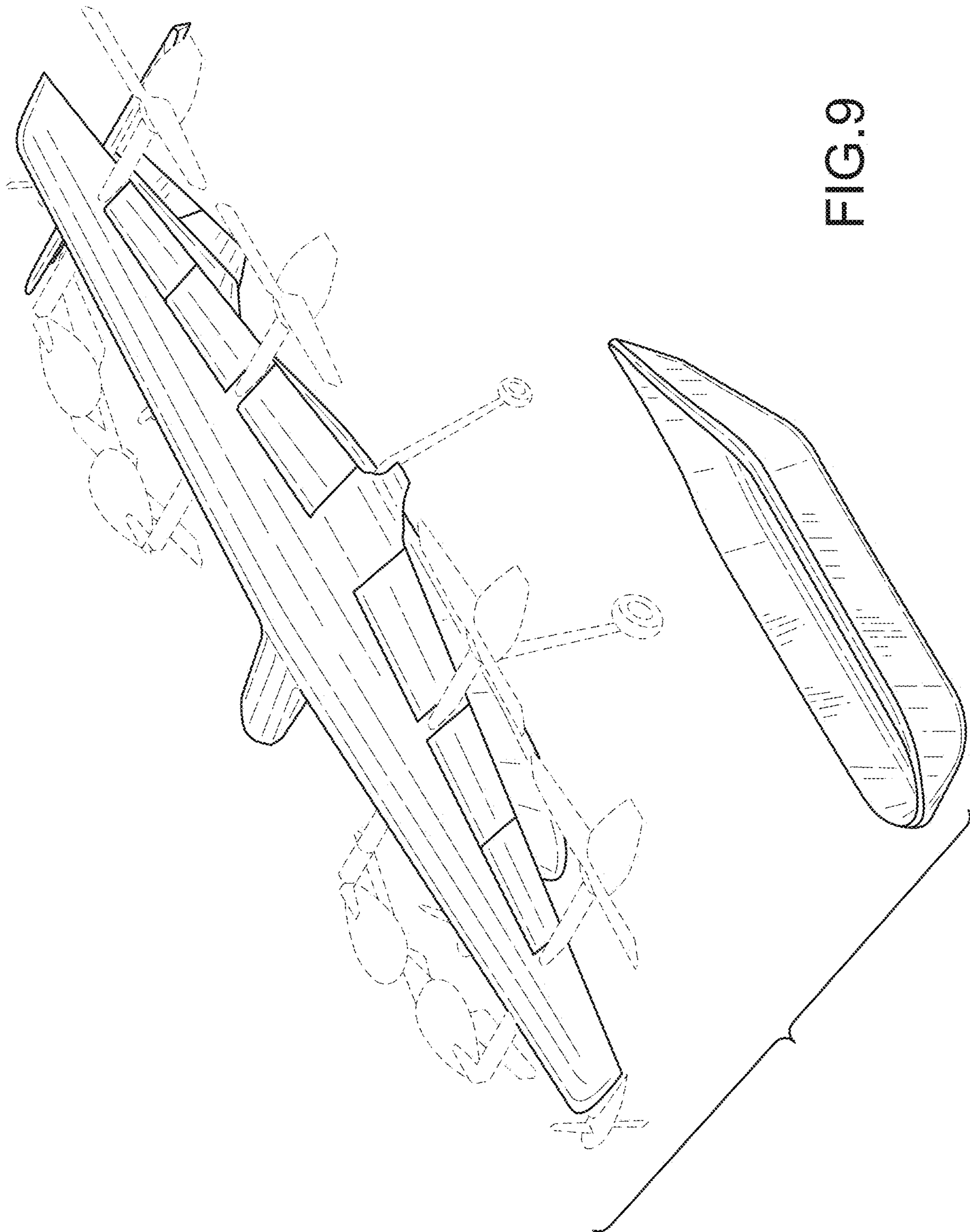

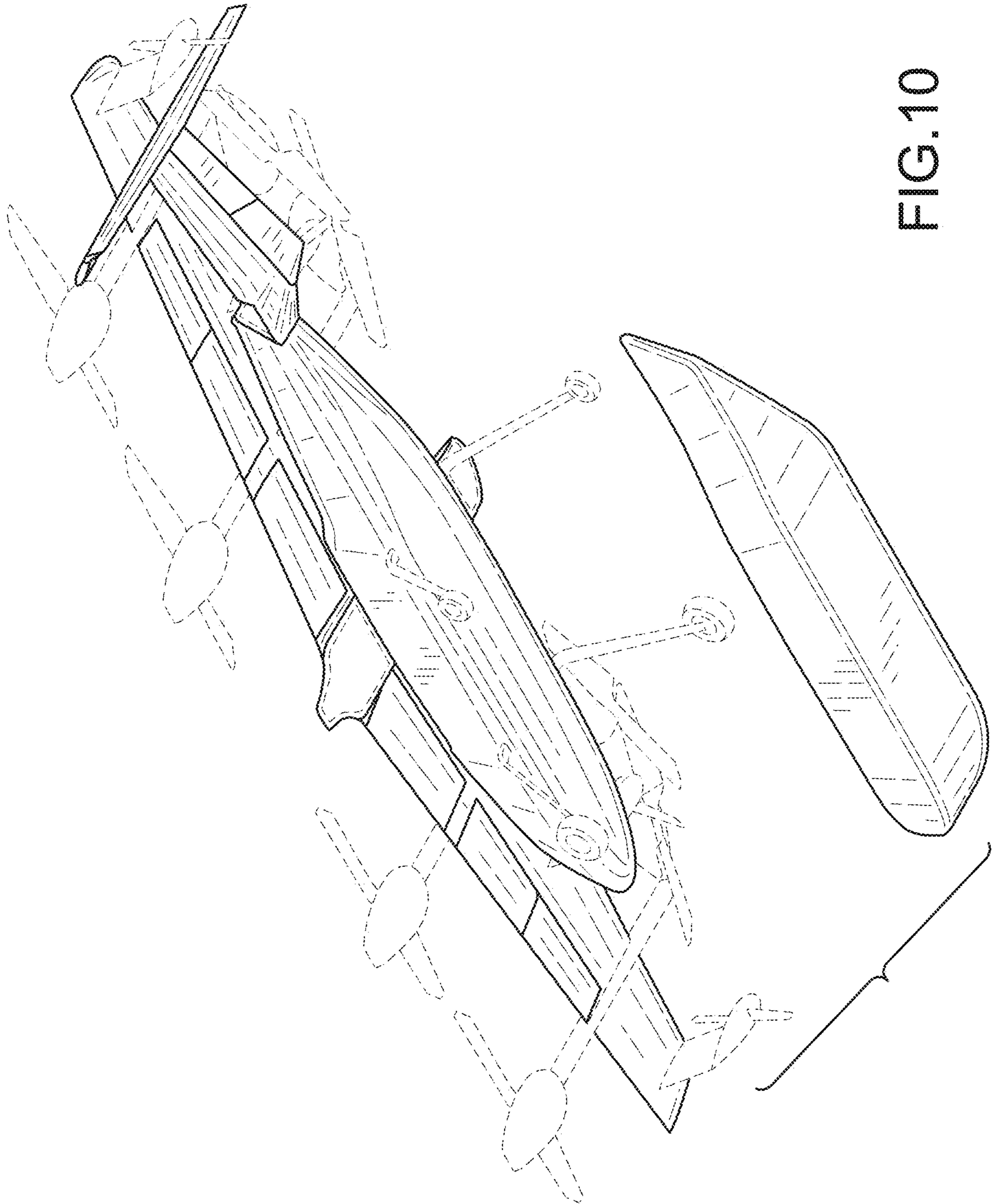

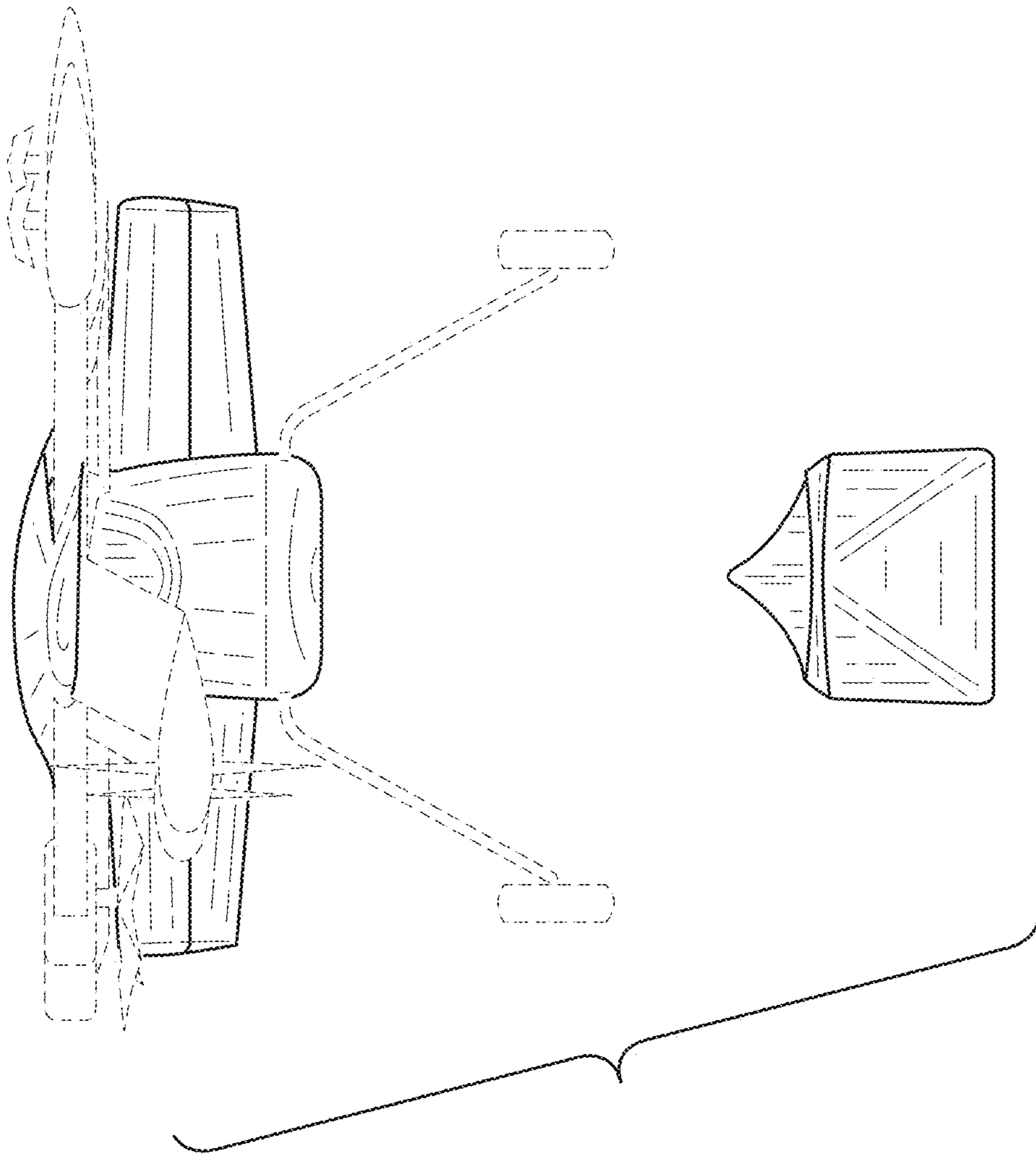

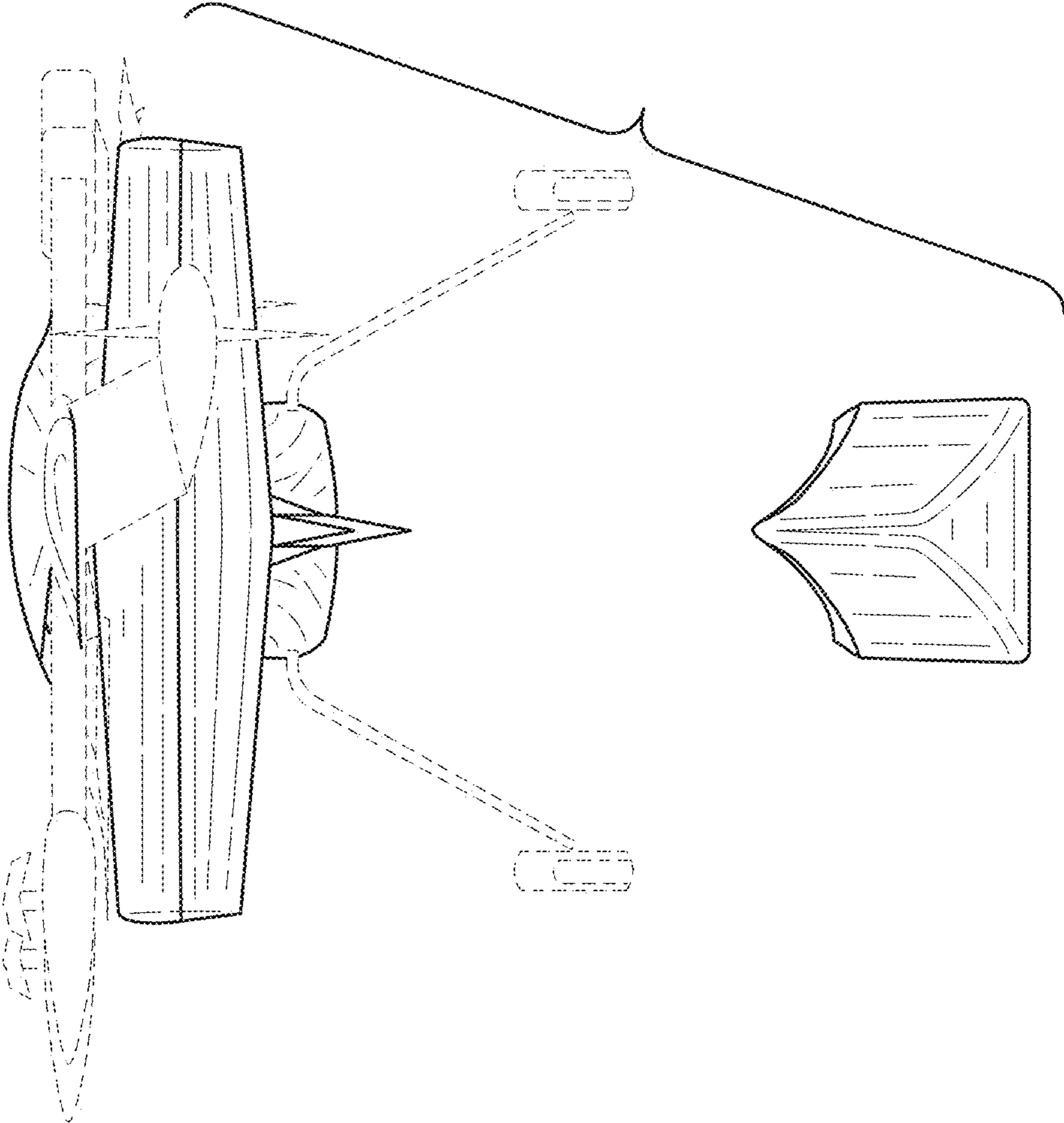

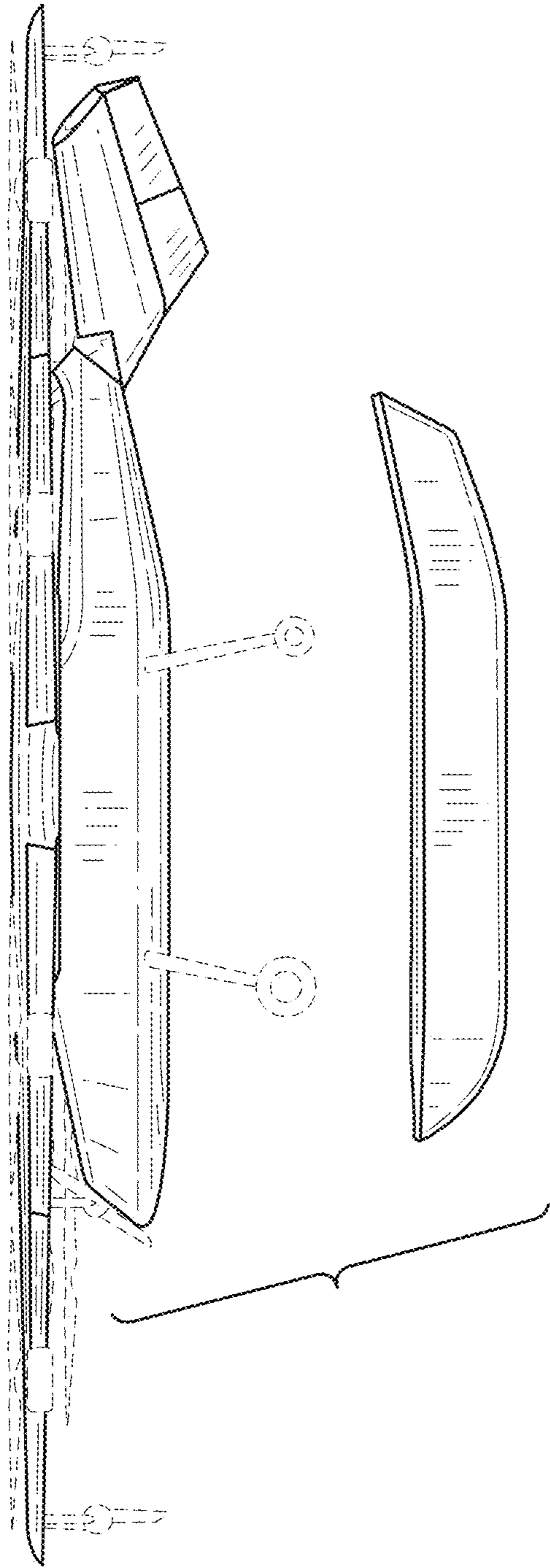

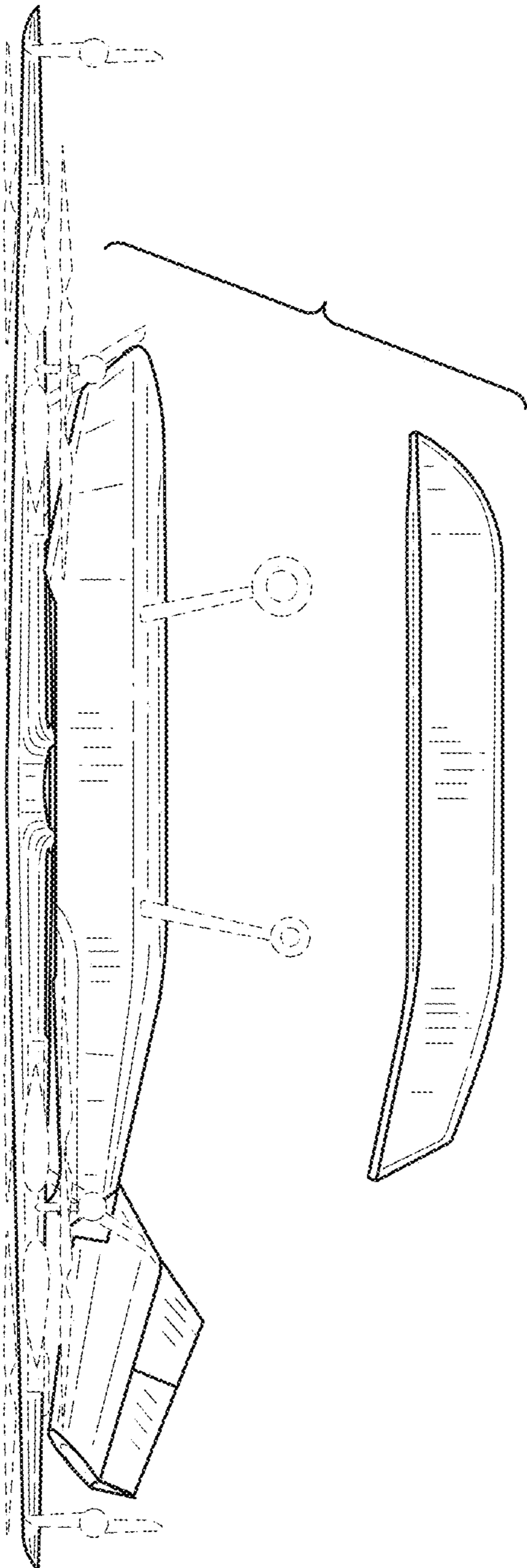

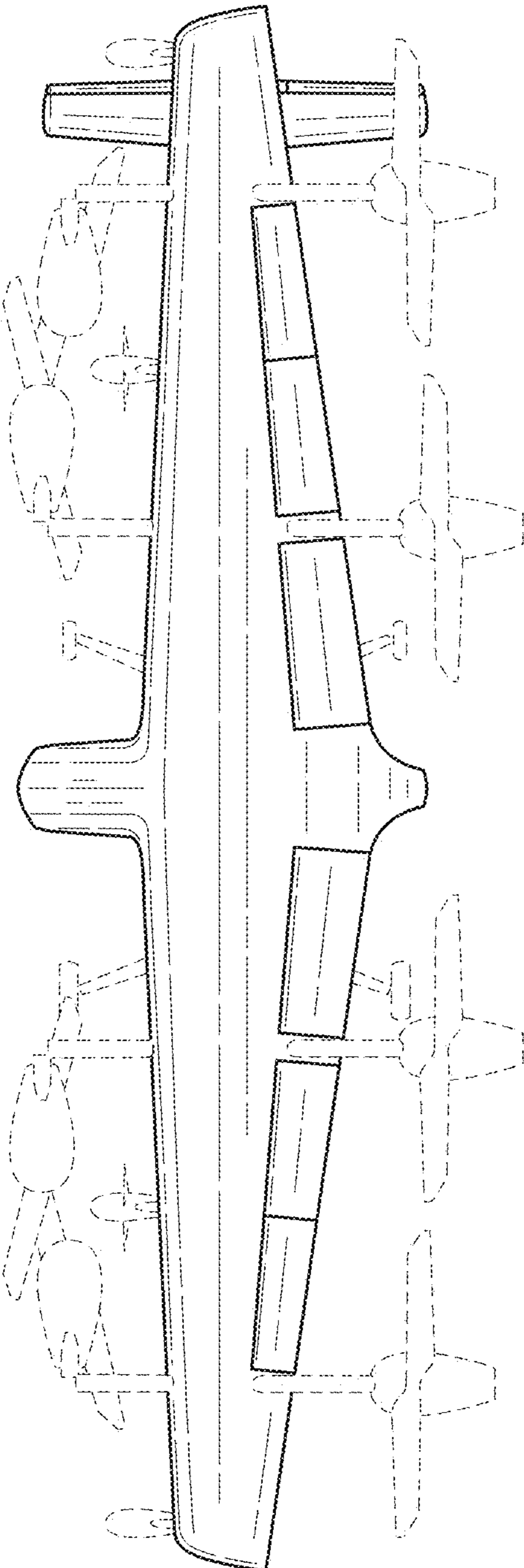

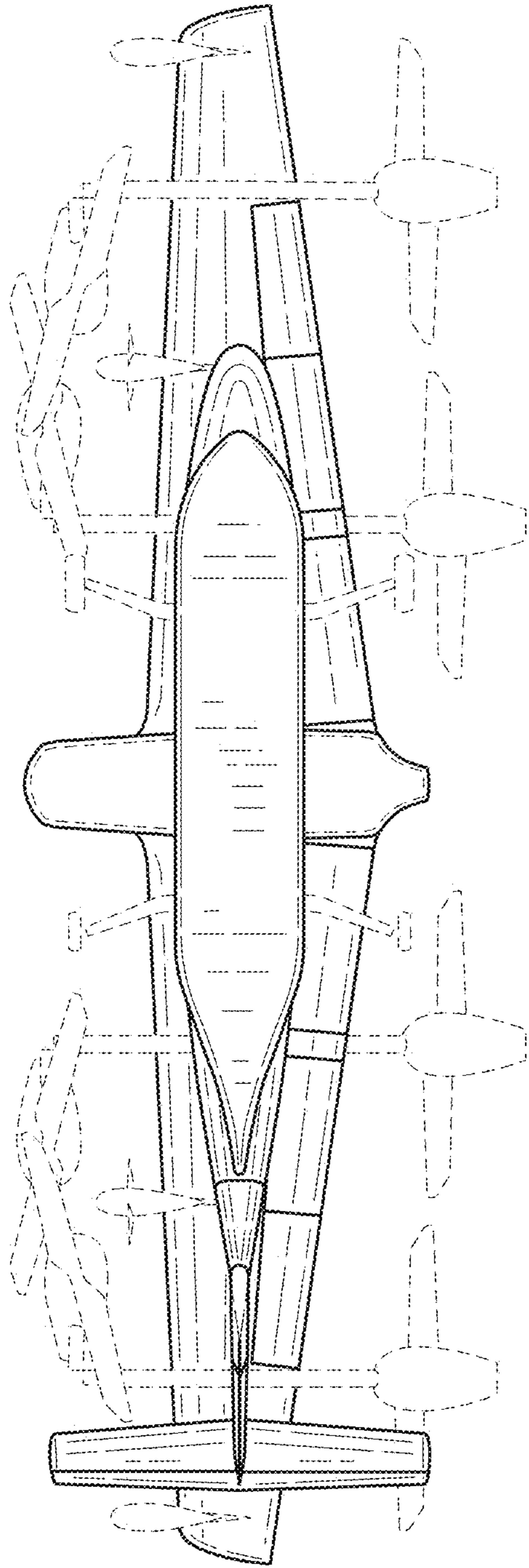
