FIG. 11 is a left-side view thereof;

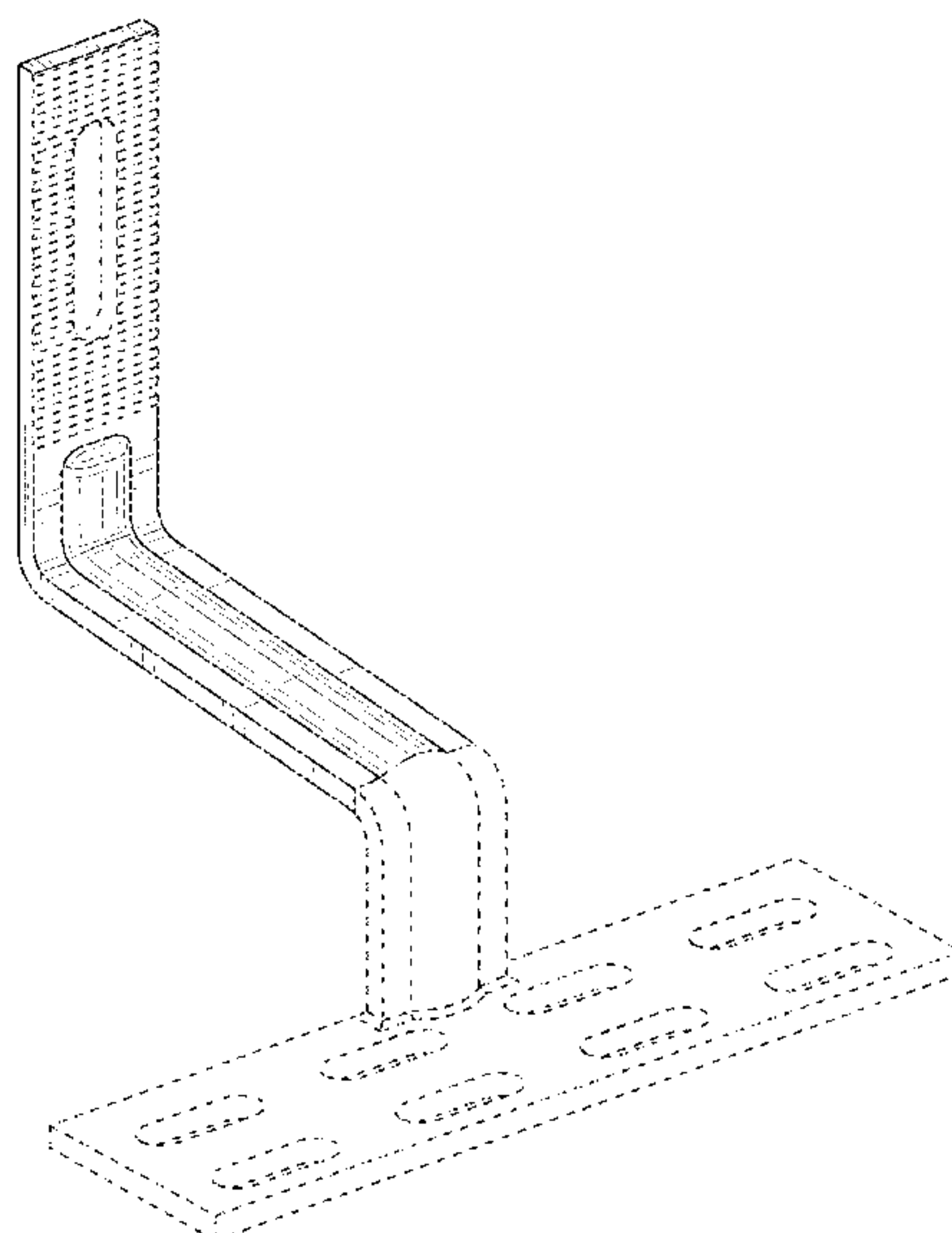
FIG. 12 is a right-side view thereof;

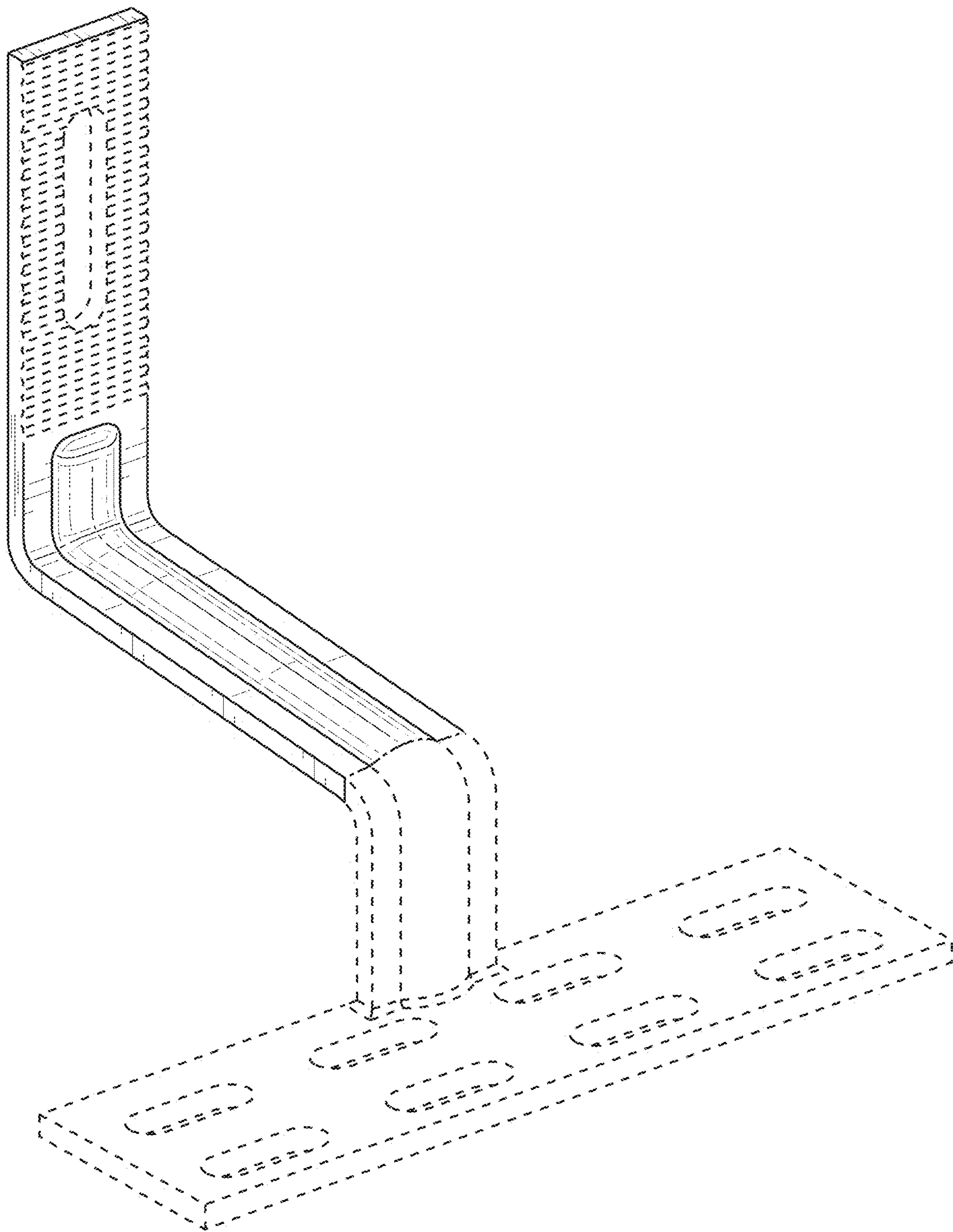

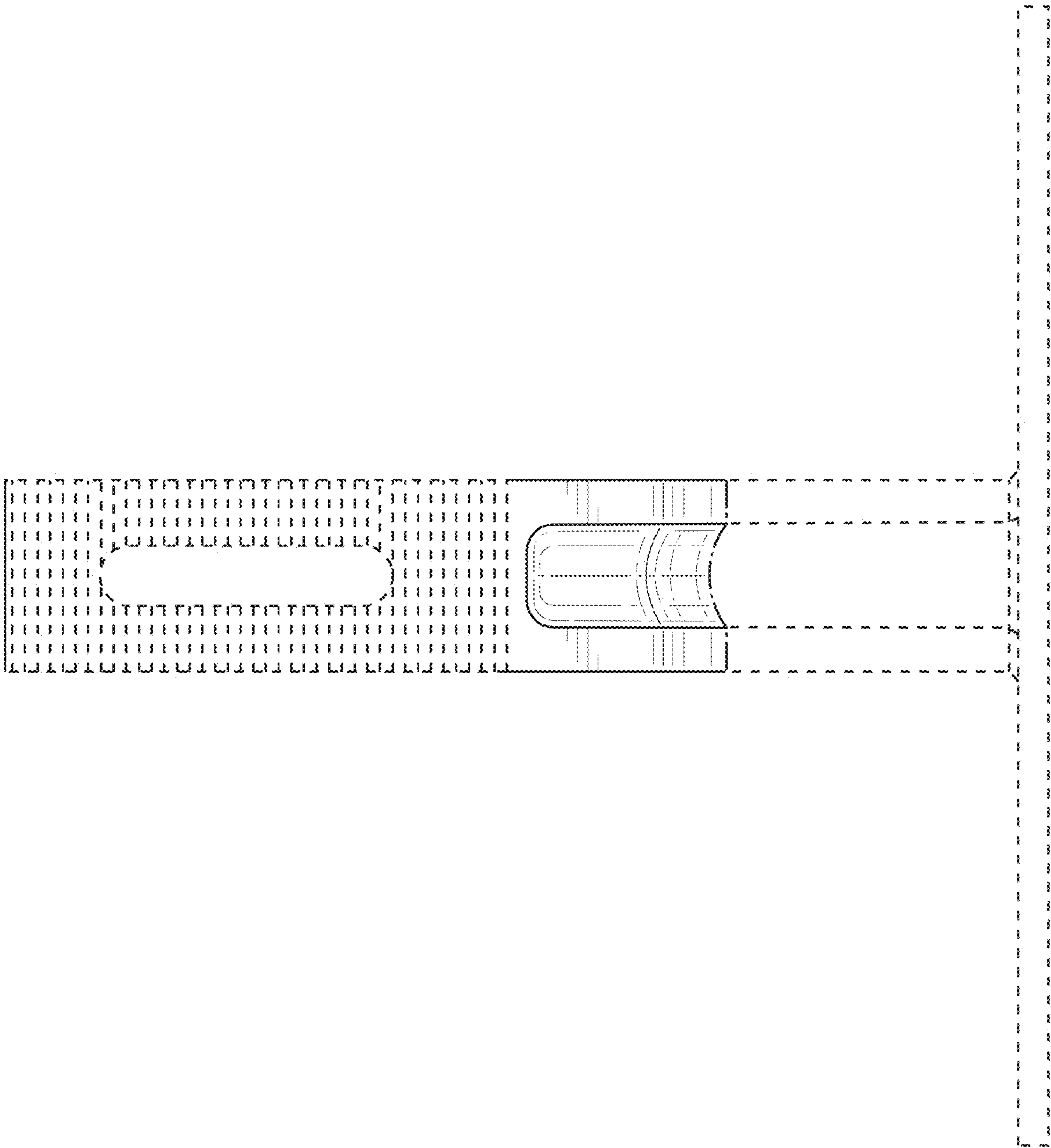

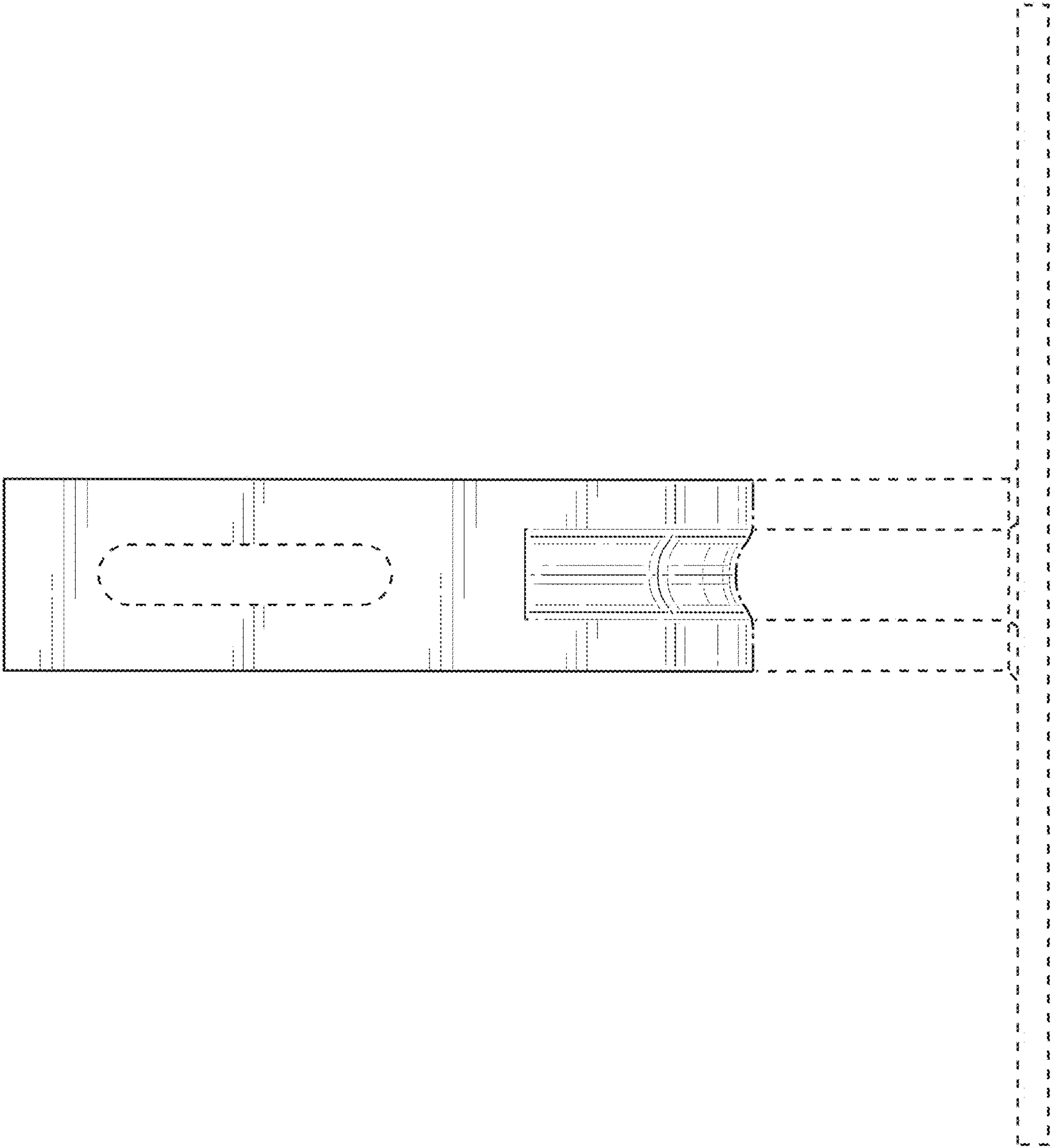

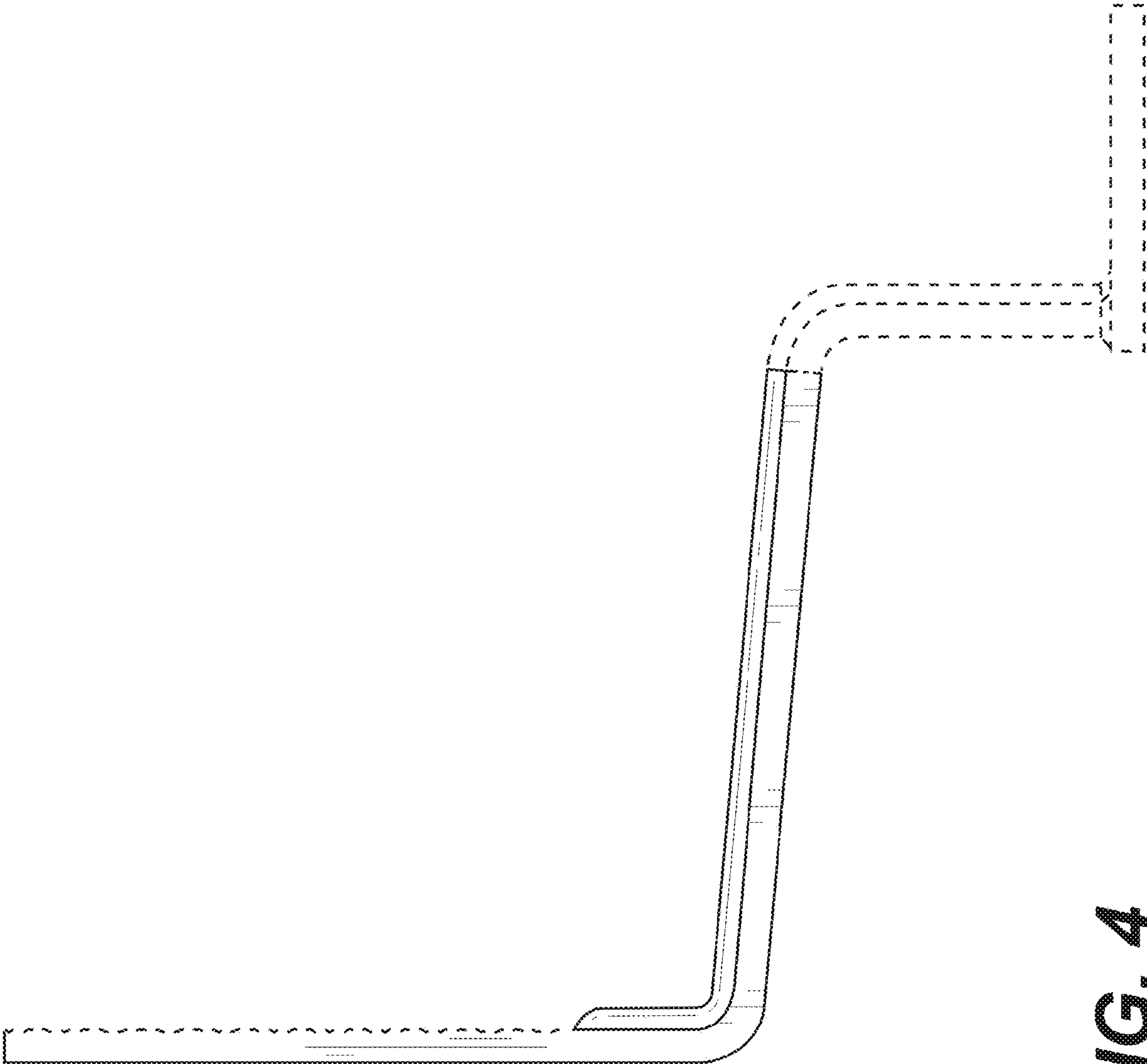

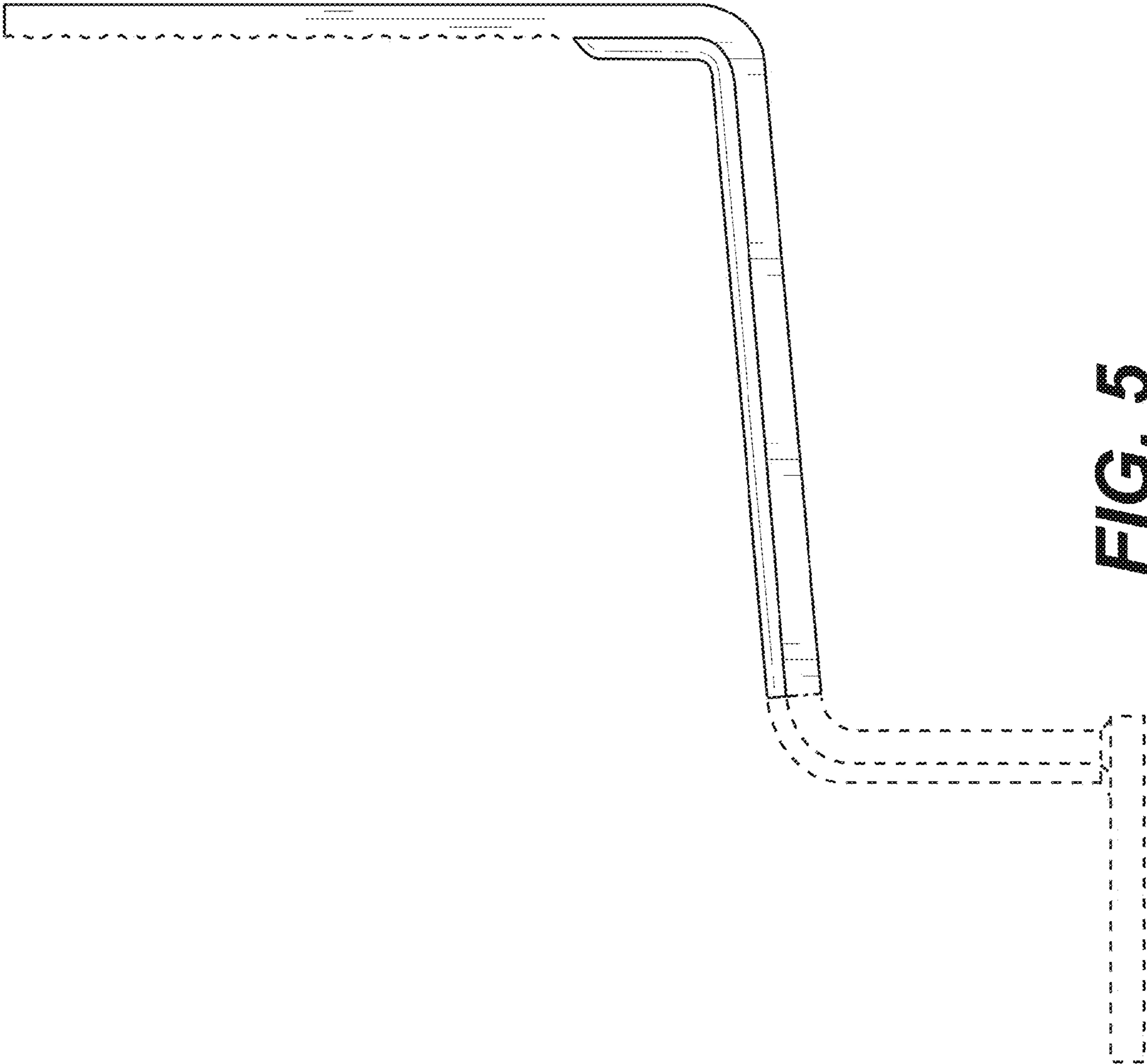

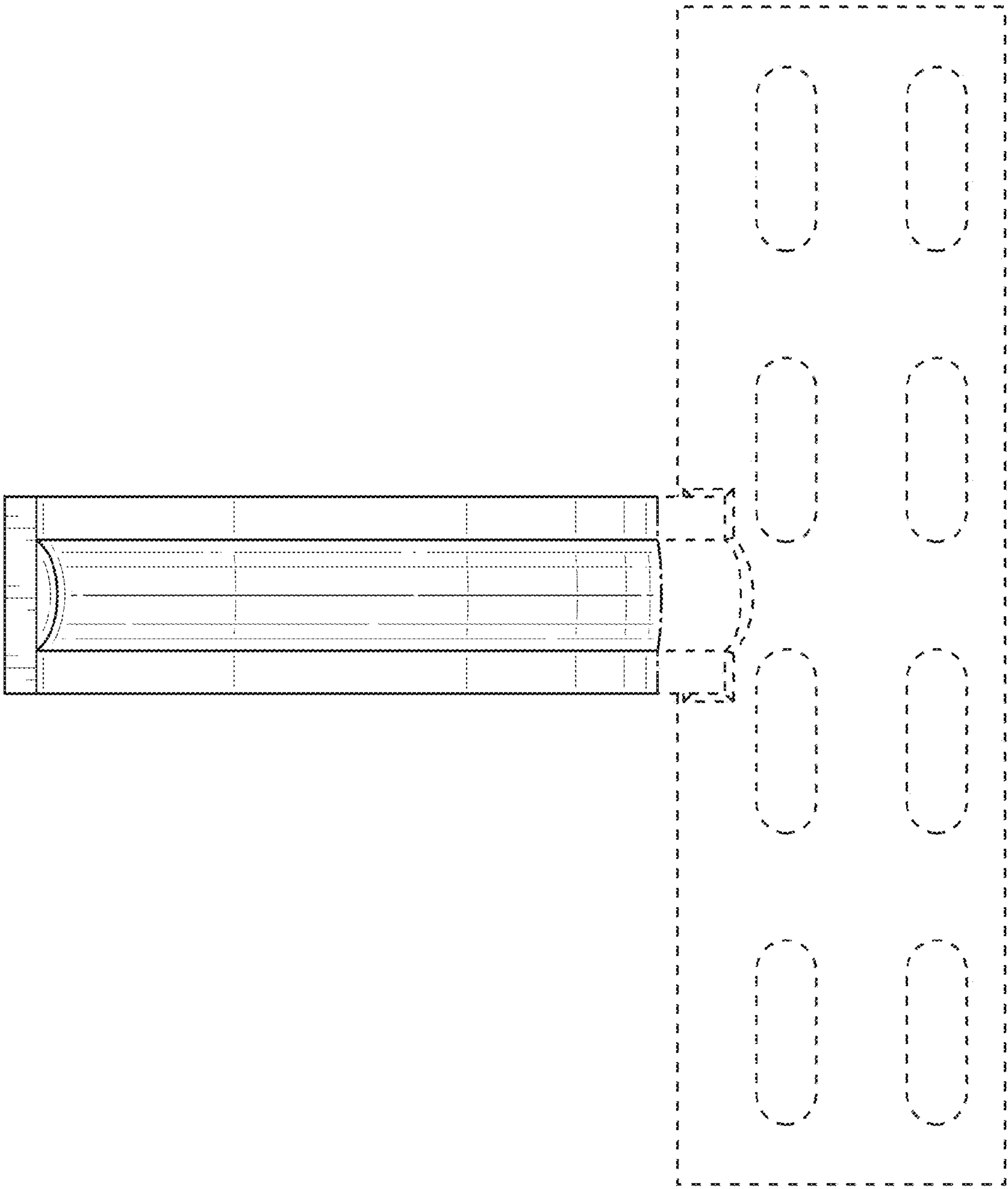

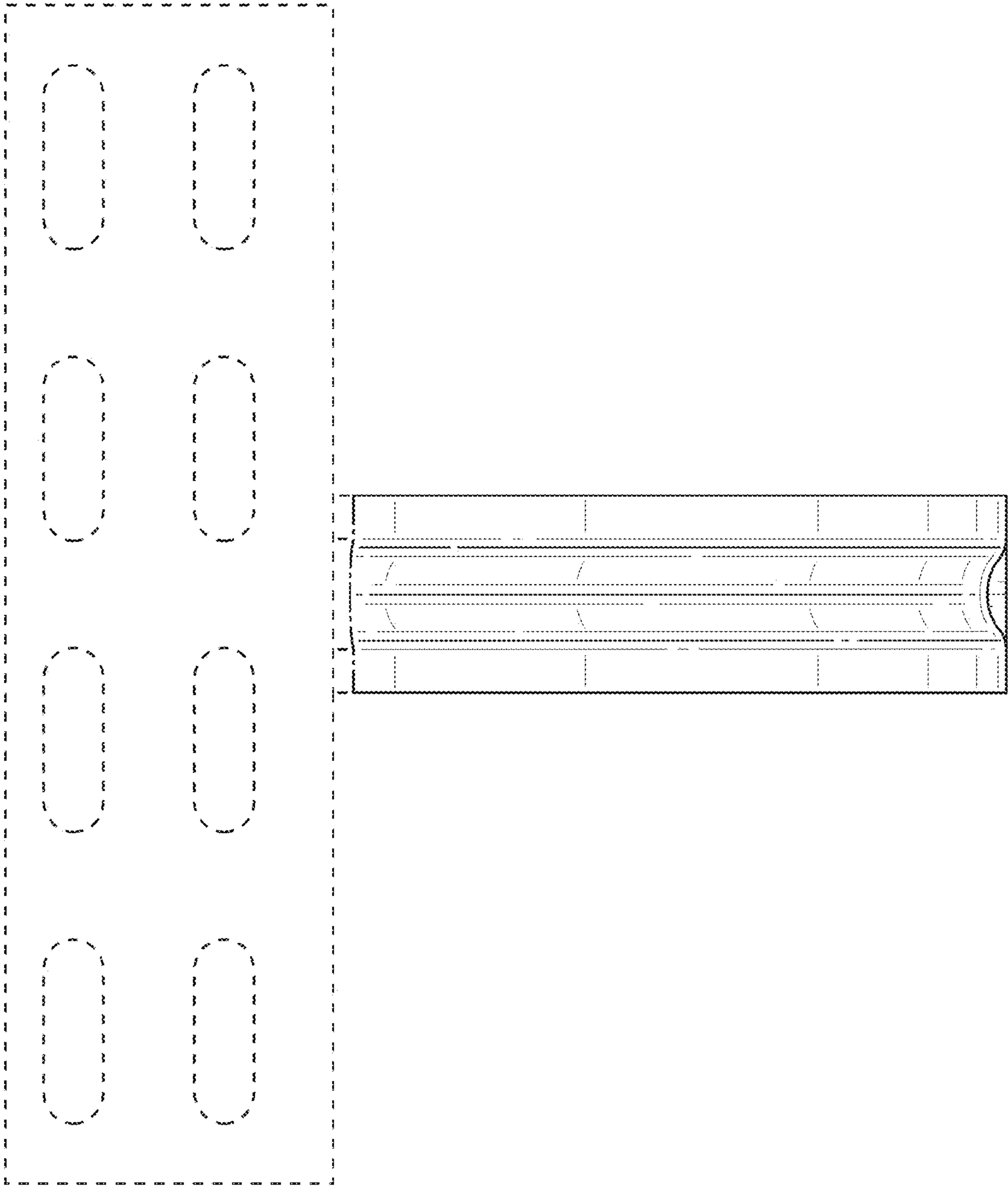

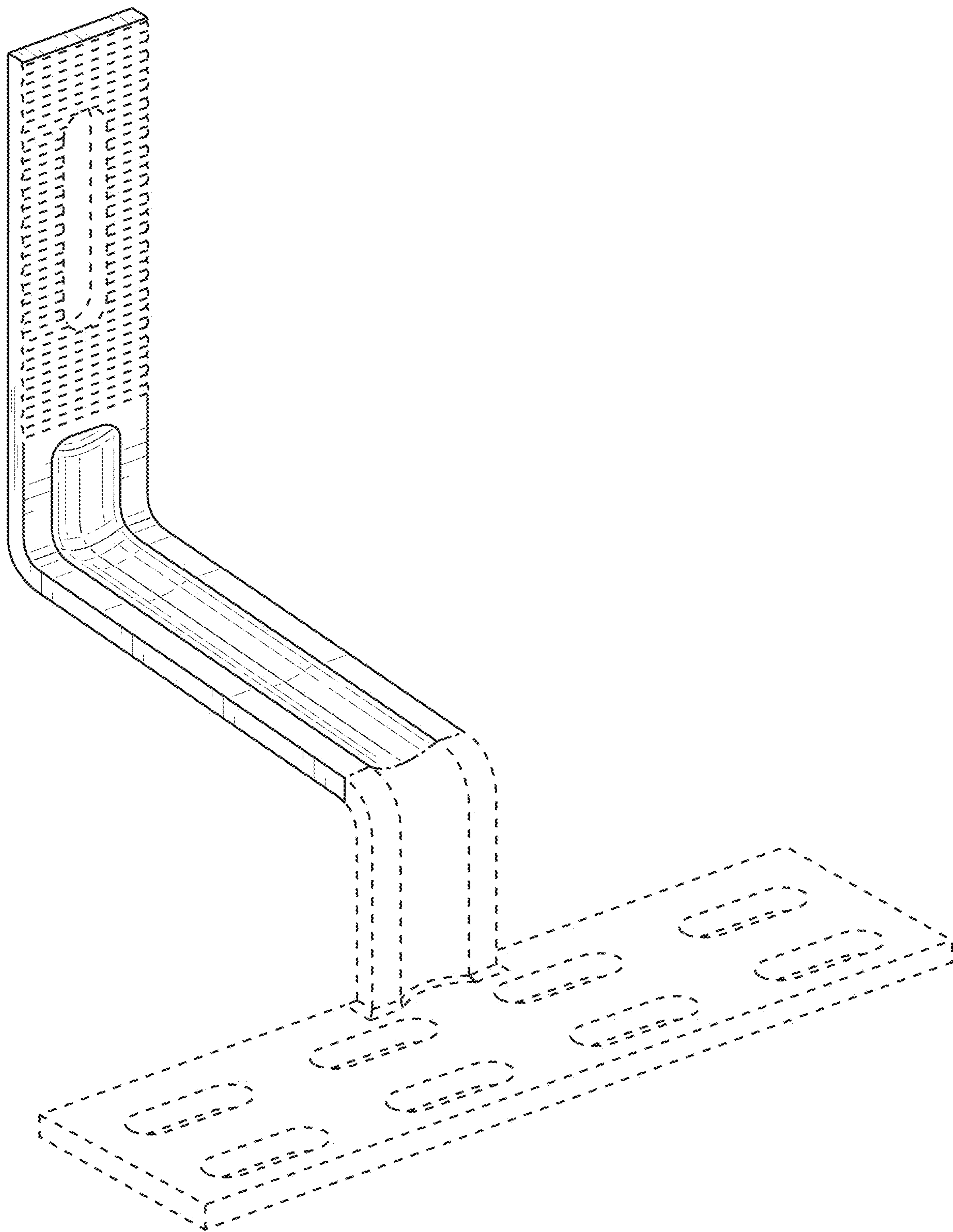

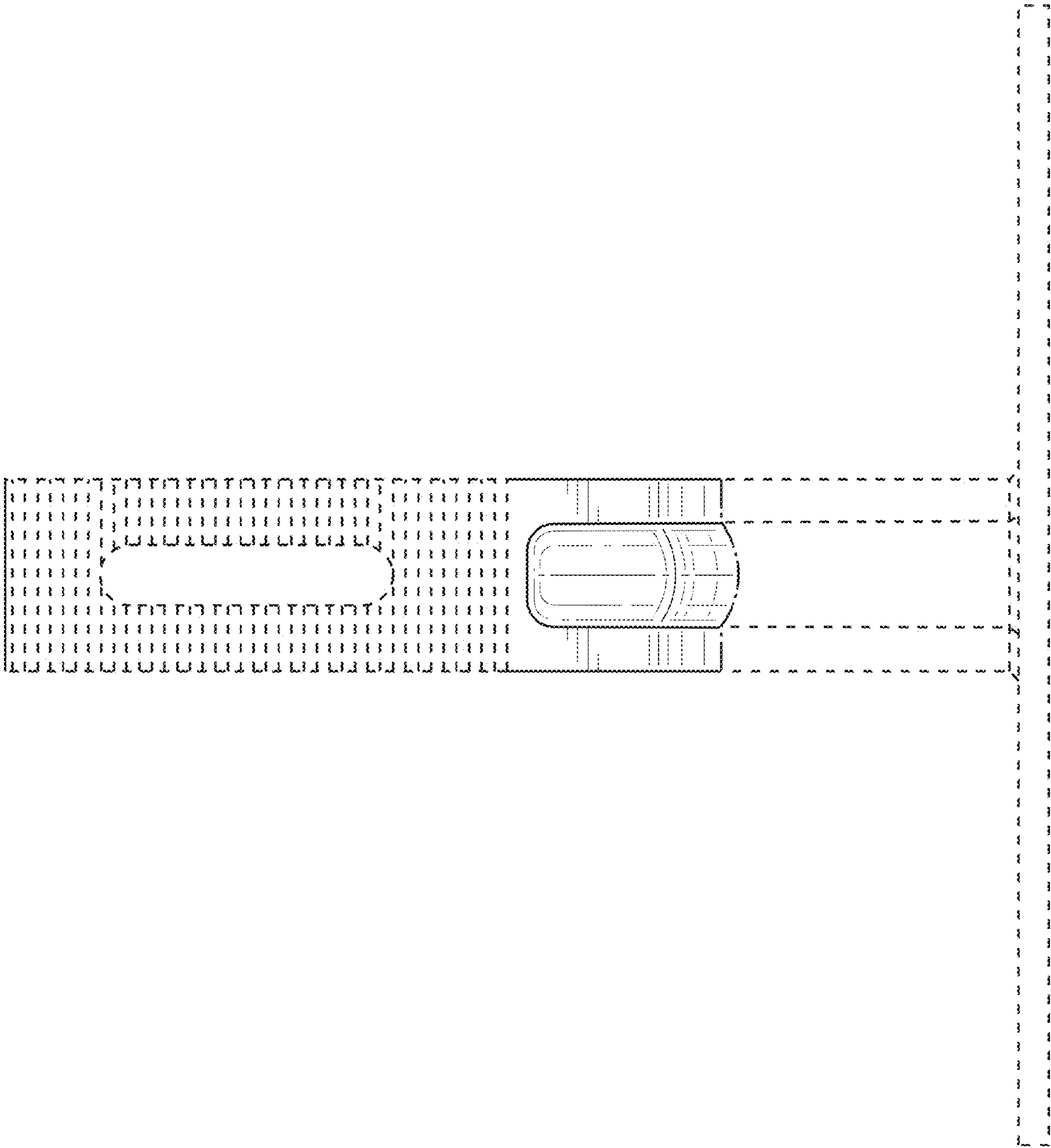

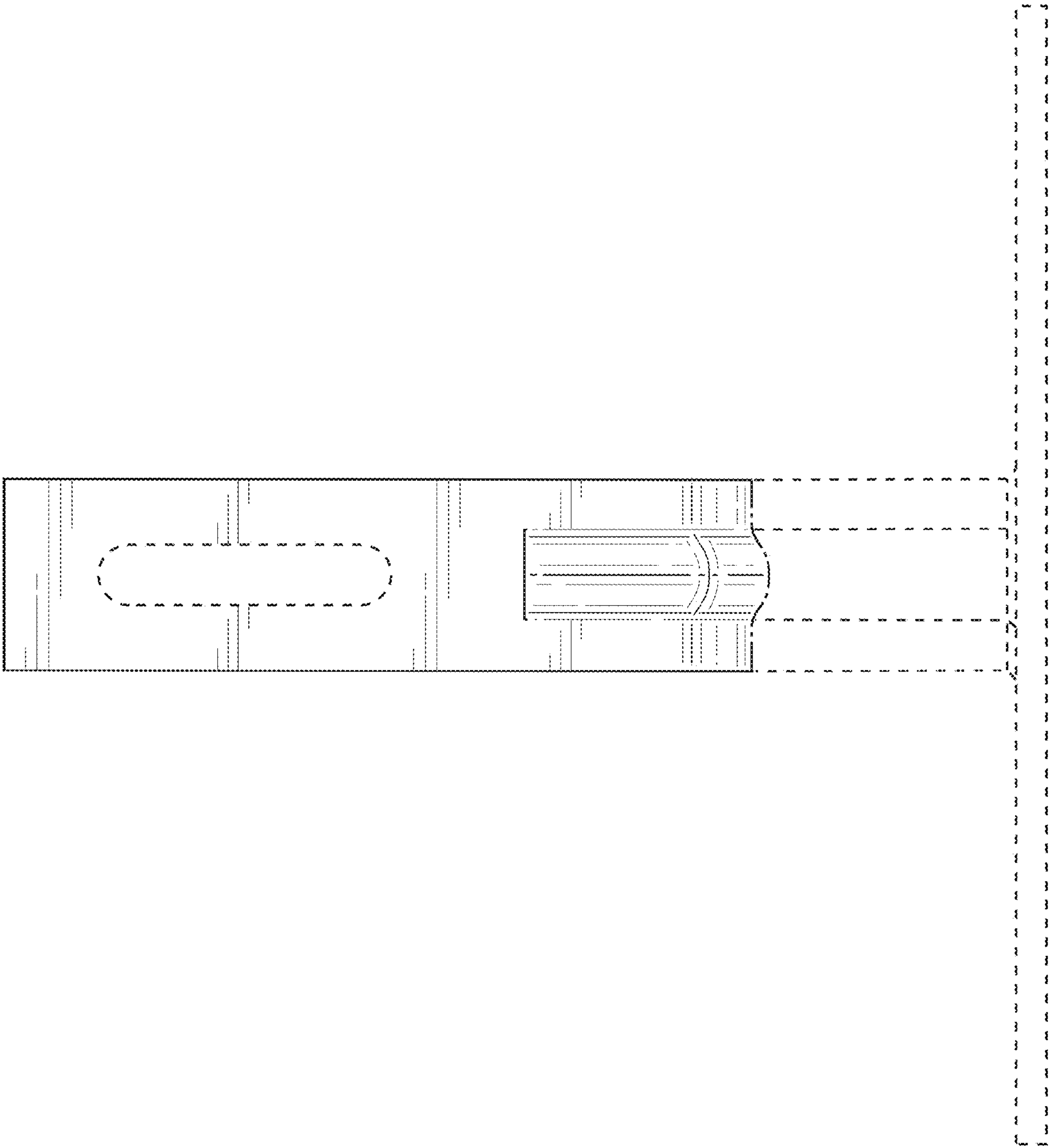

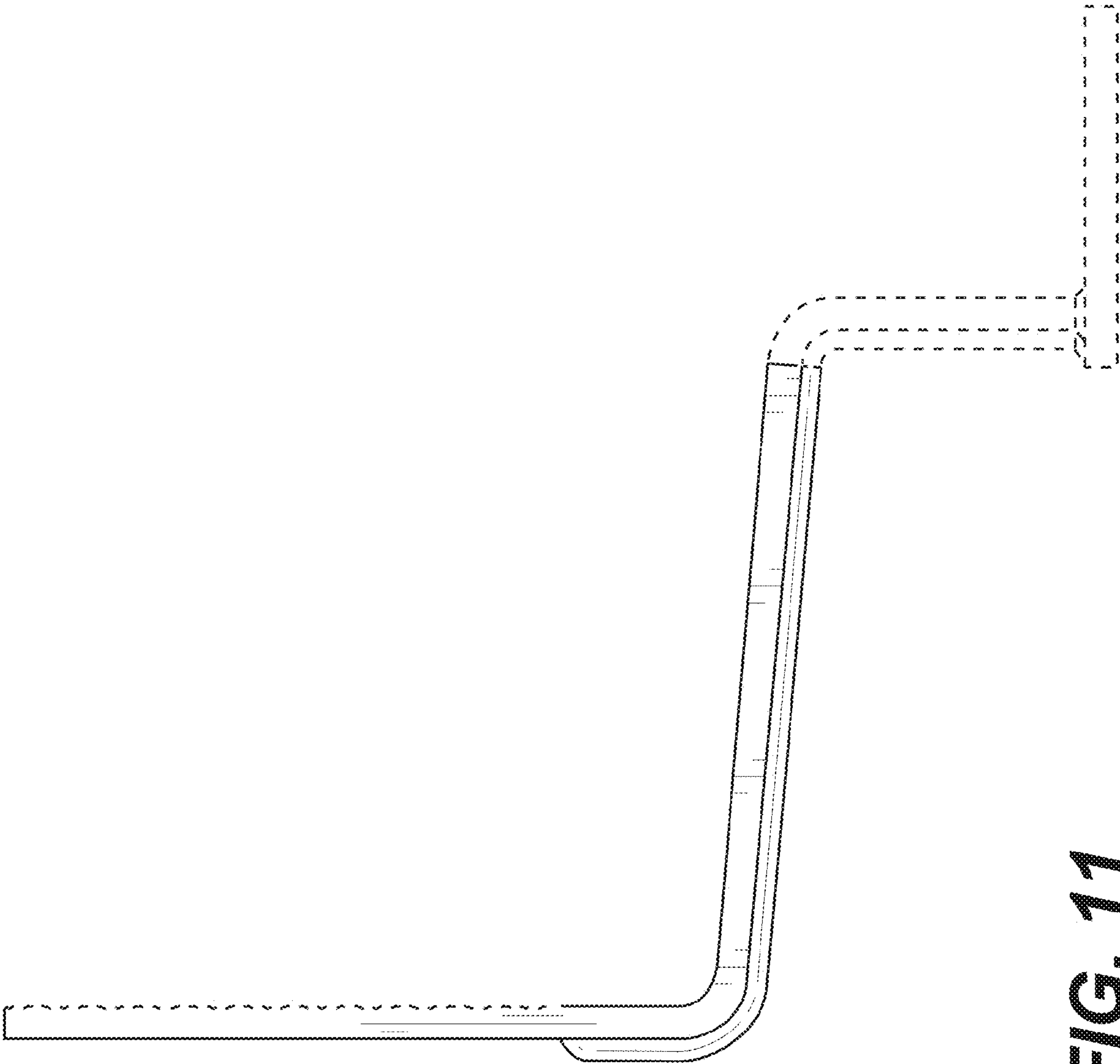

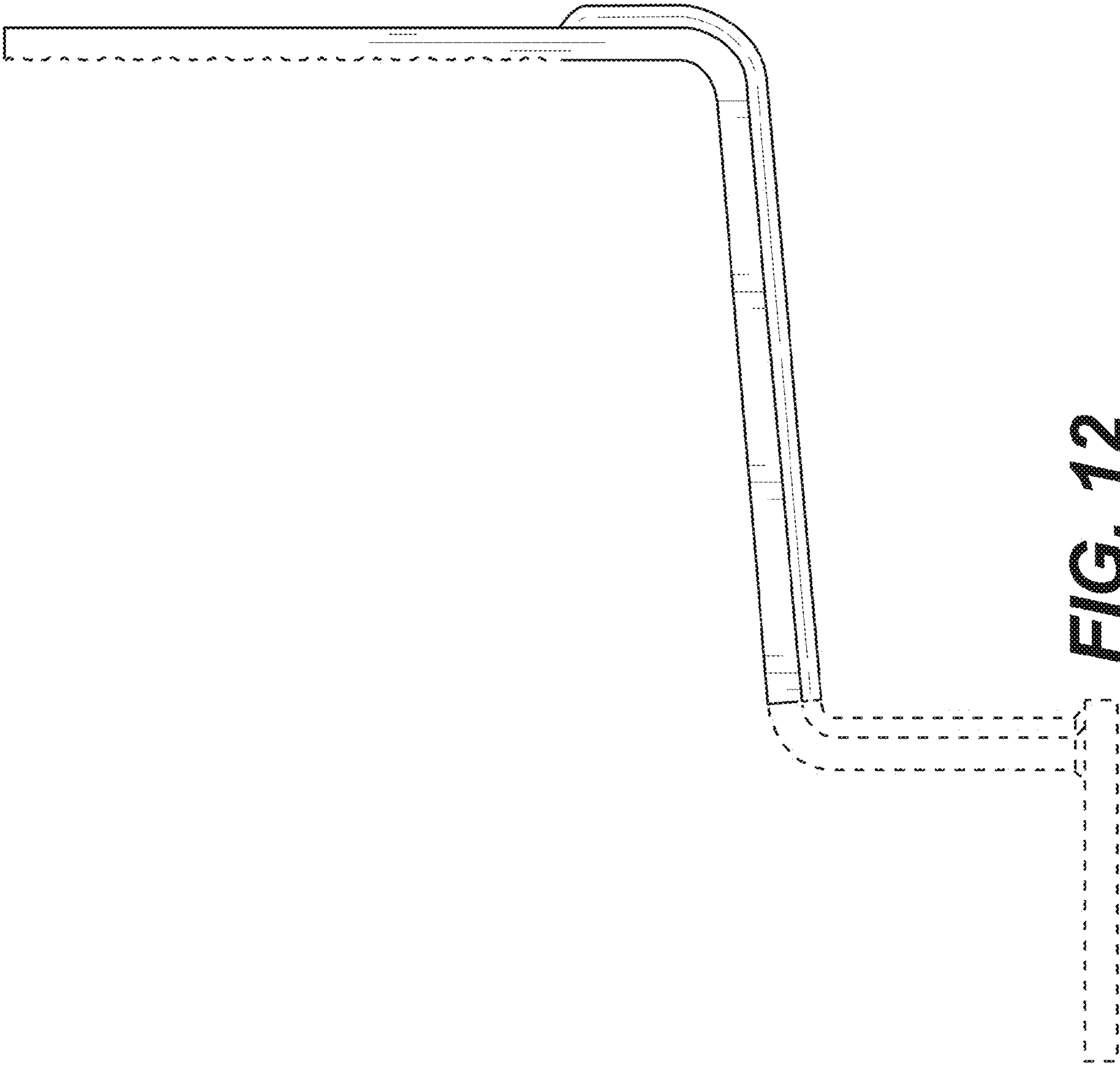

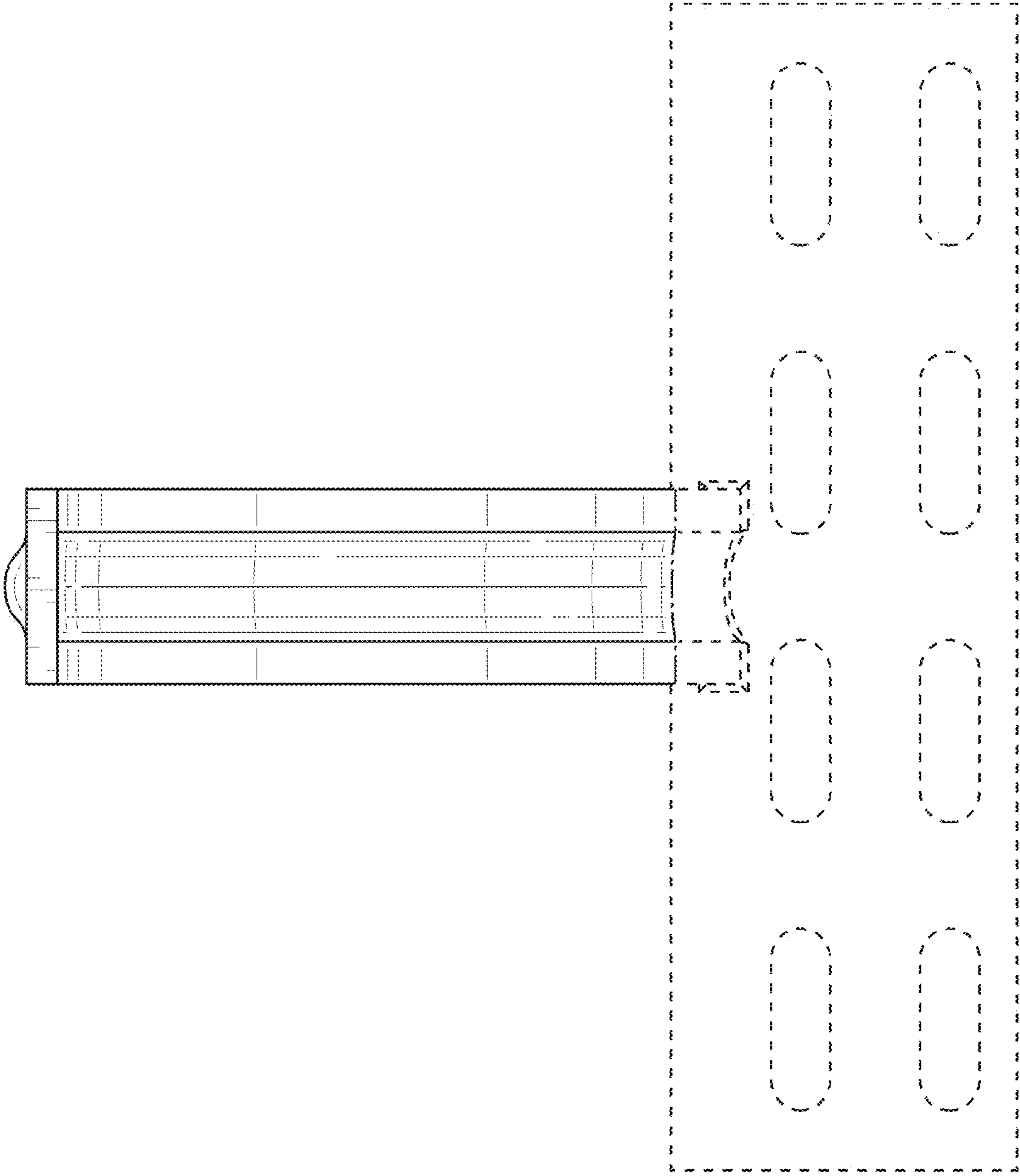

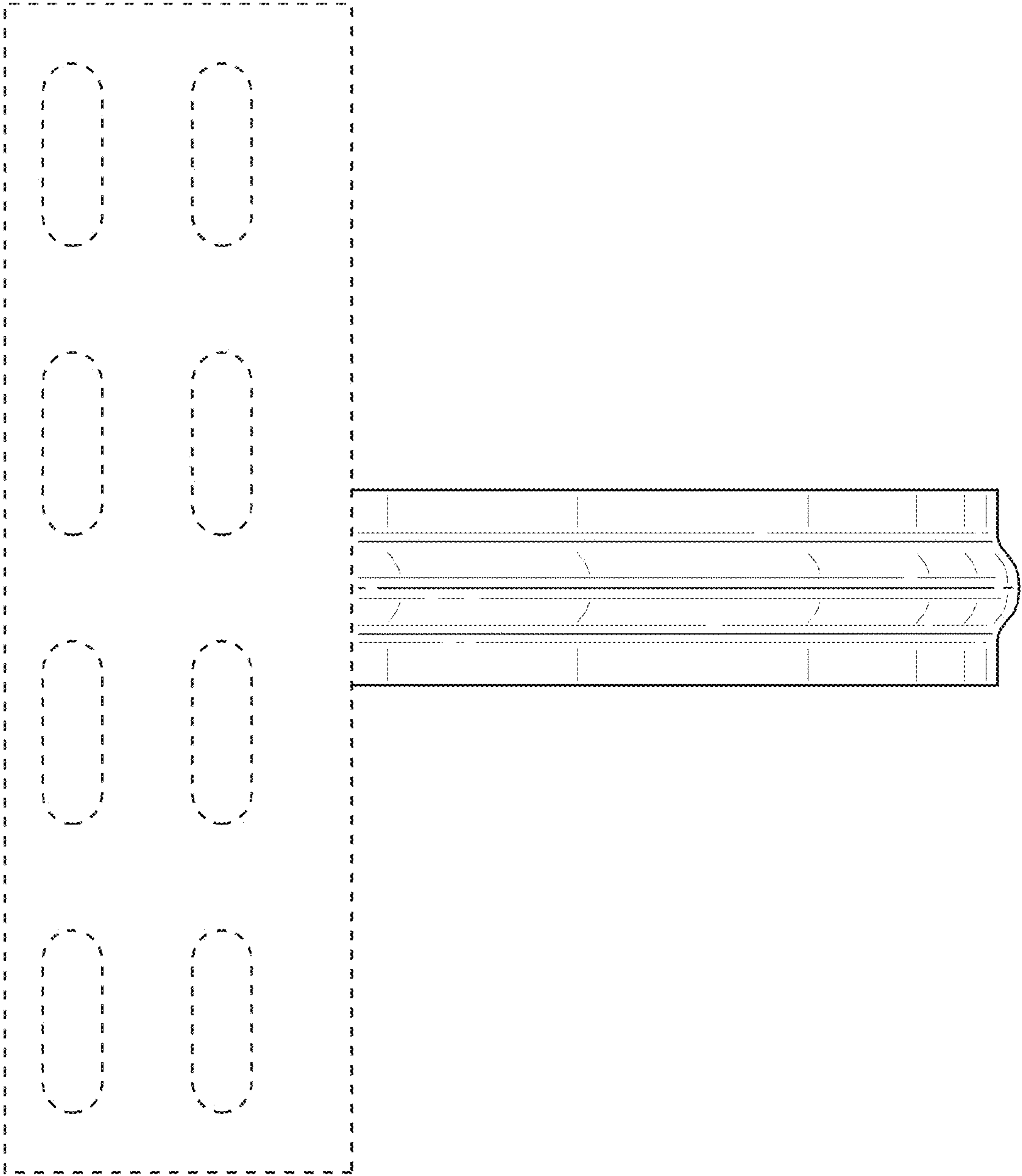
