The ornamental design for a safety plug, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a safety plug in a connected state of the present invention; FIG. 2 is a perspective view of a first embodiment of a safety plug in a disconnected state of the present invention; FIG. 3 is a front view of a first embodiment thereof; FIG. 4 is a back view of a first embodiment thereof; FIG. 5 is a left side view of a first embodiment thereof; FIG. 6 is a right view of a first embodiment thereof; FIG. 7 is a top view of a first embodiment thereof; and FIG. 8 is a bottom view of a first embodiment thereof. 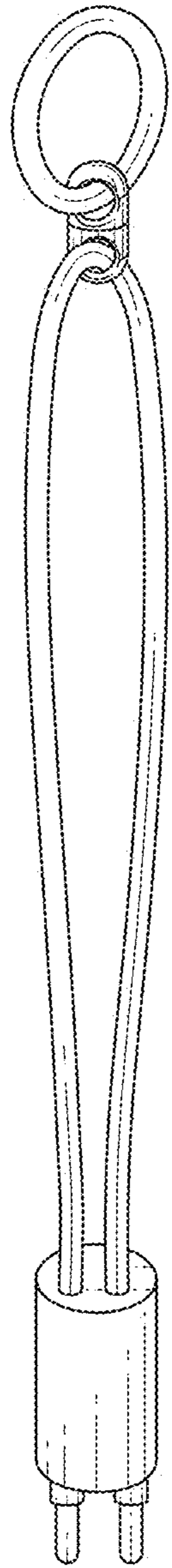

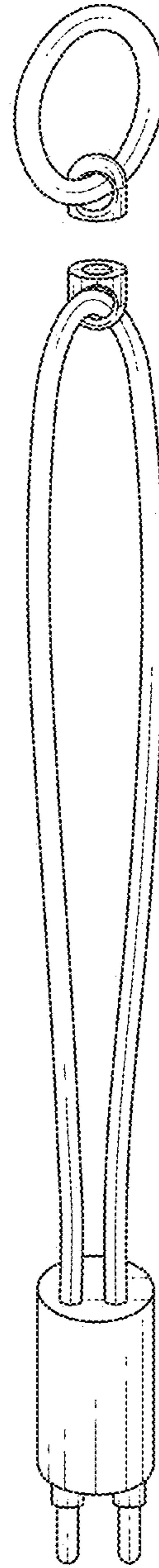

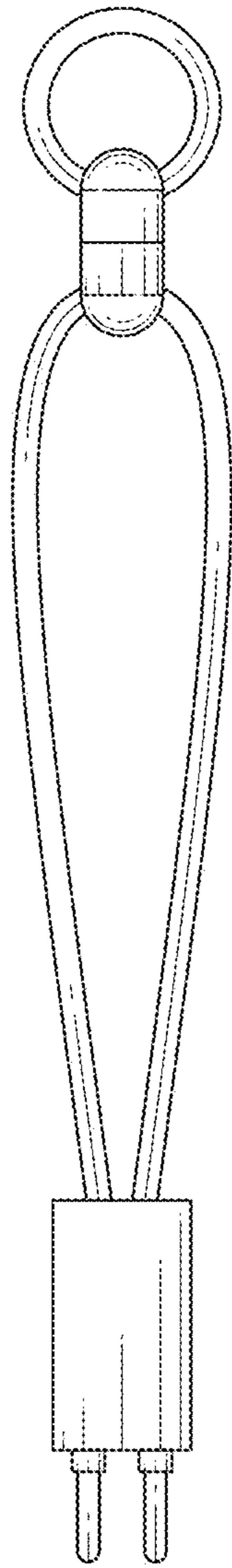

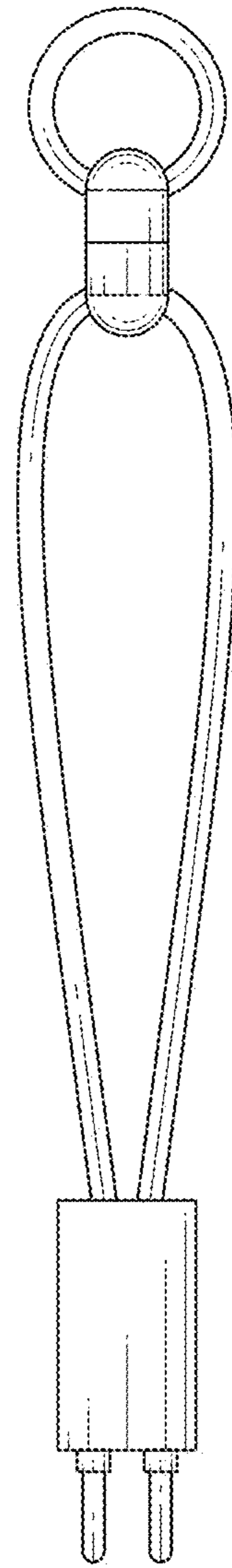

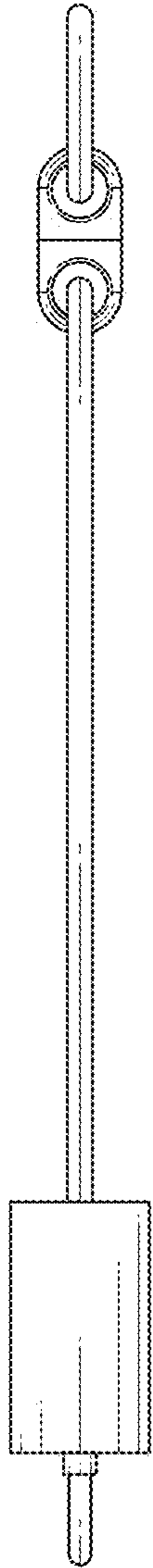

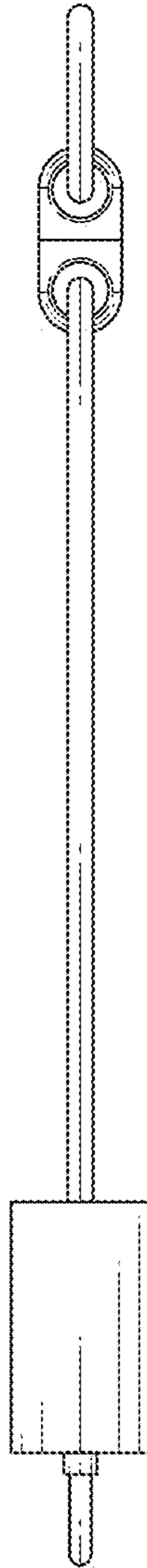

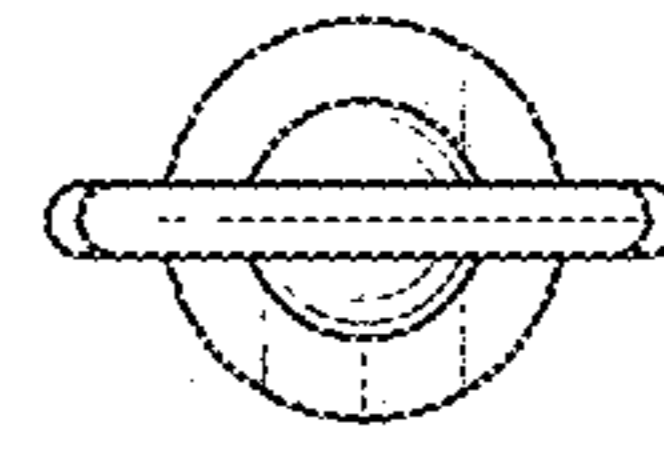

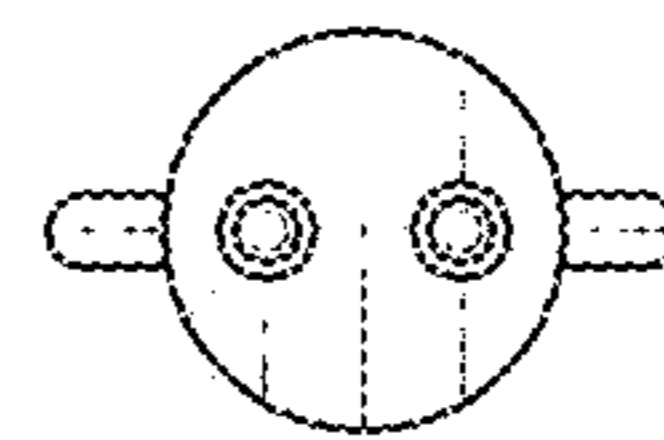

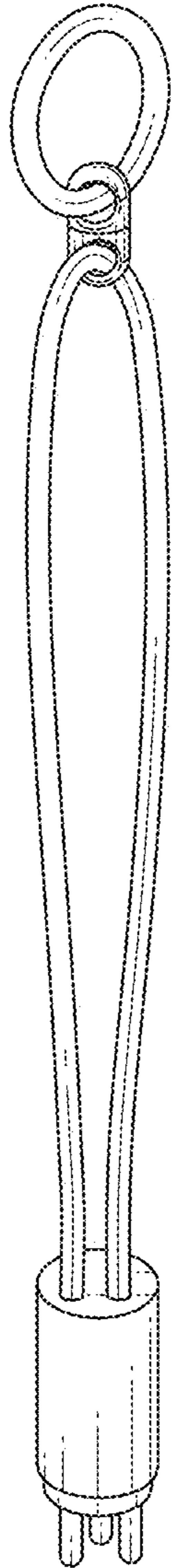

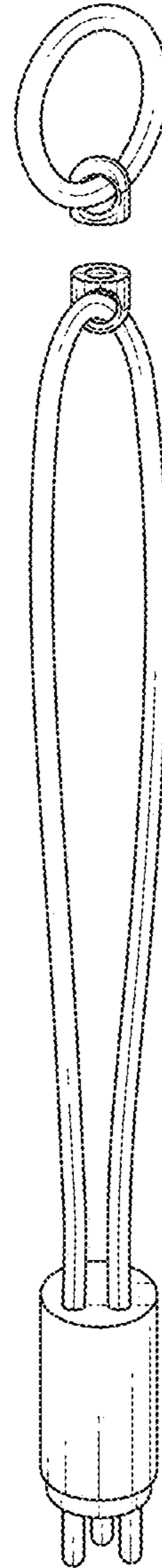

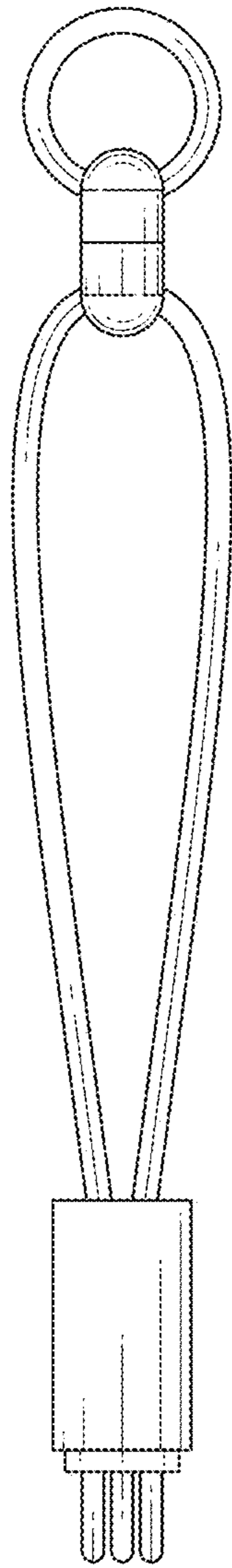

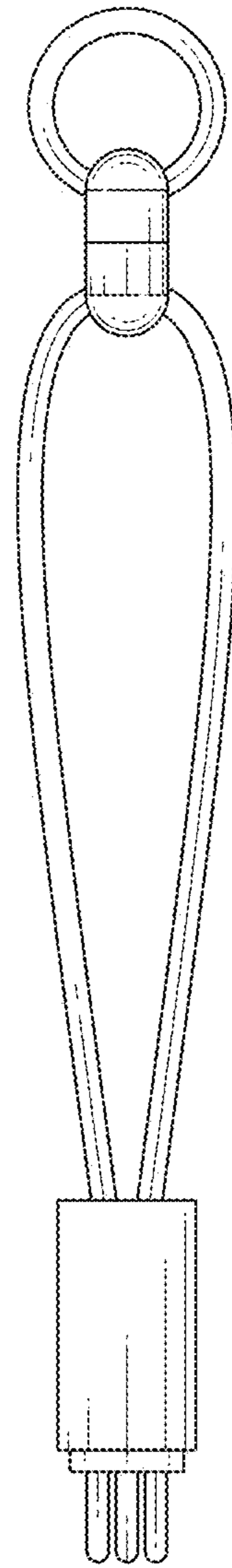

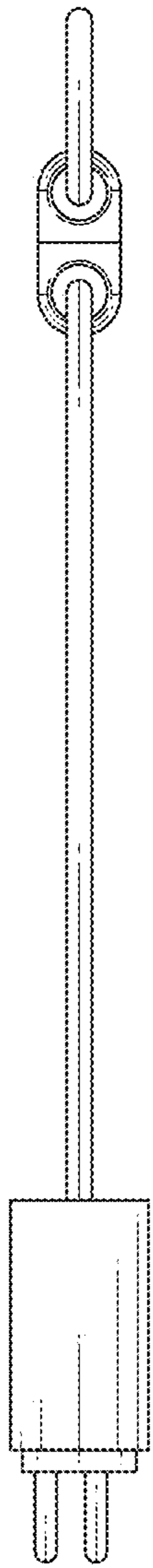

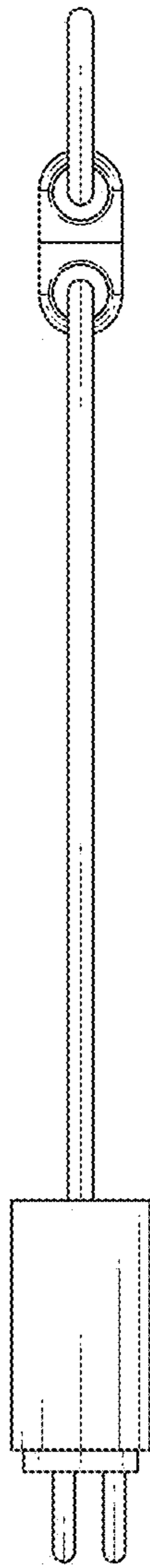

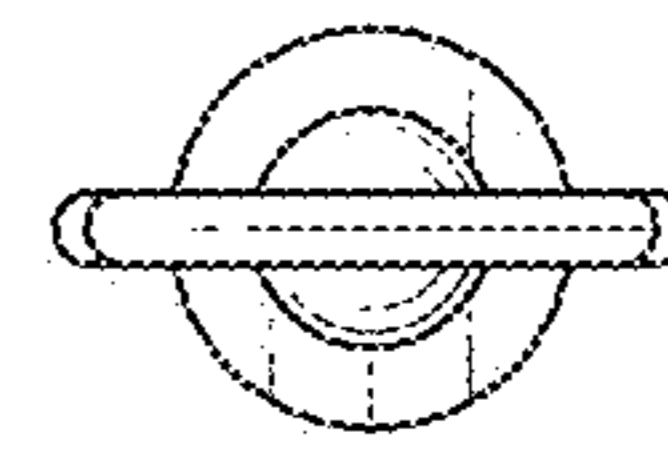

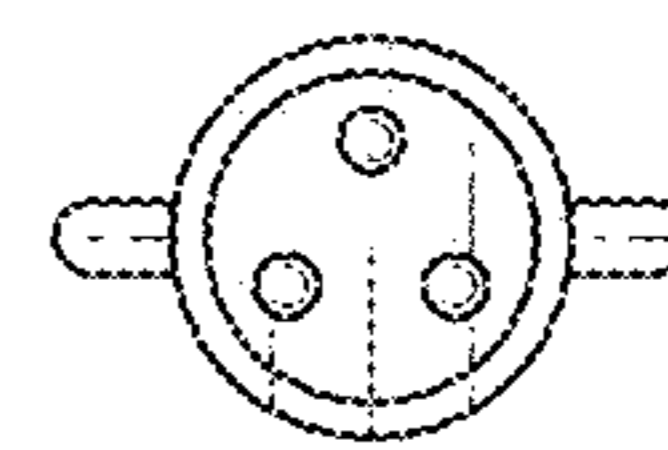
