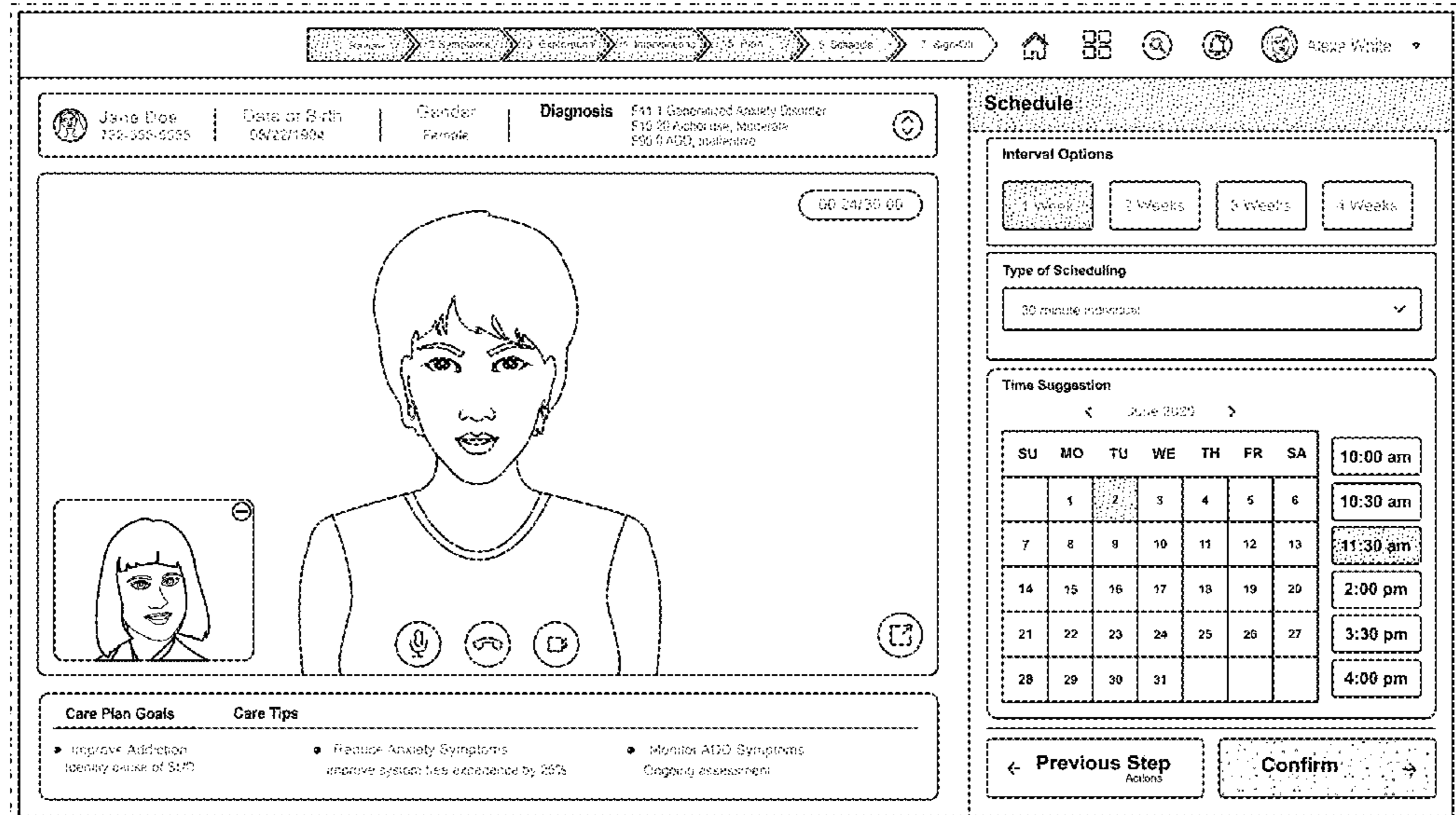
The ornamental design for display screen with graphical user interface, as shown and described.
