**DESCRIPTION**

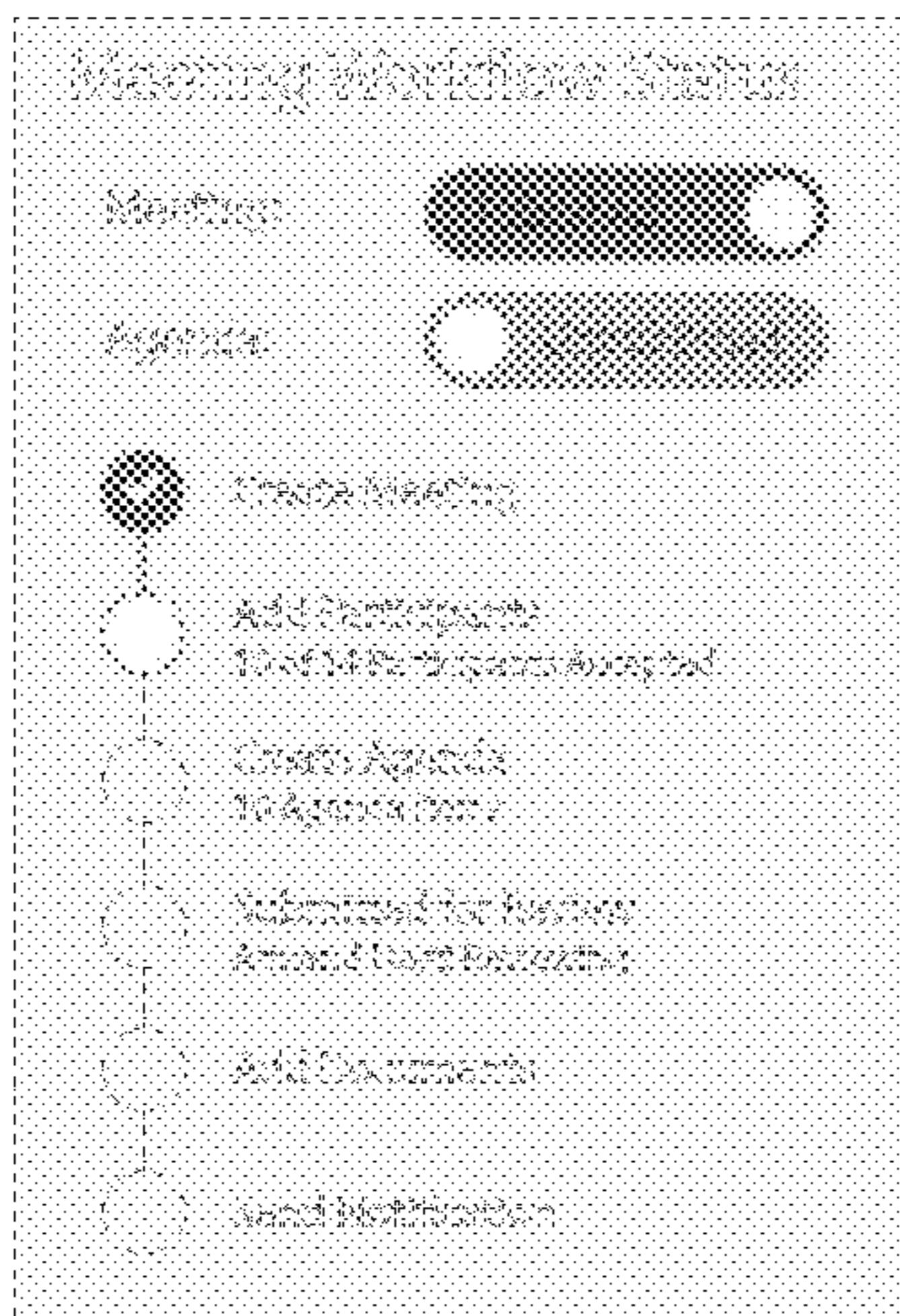
