FIG. 13 is a thirteenth embodiment thereof.

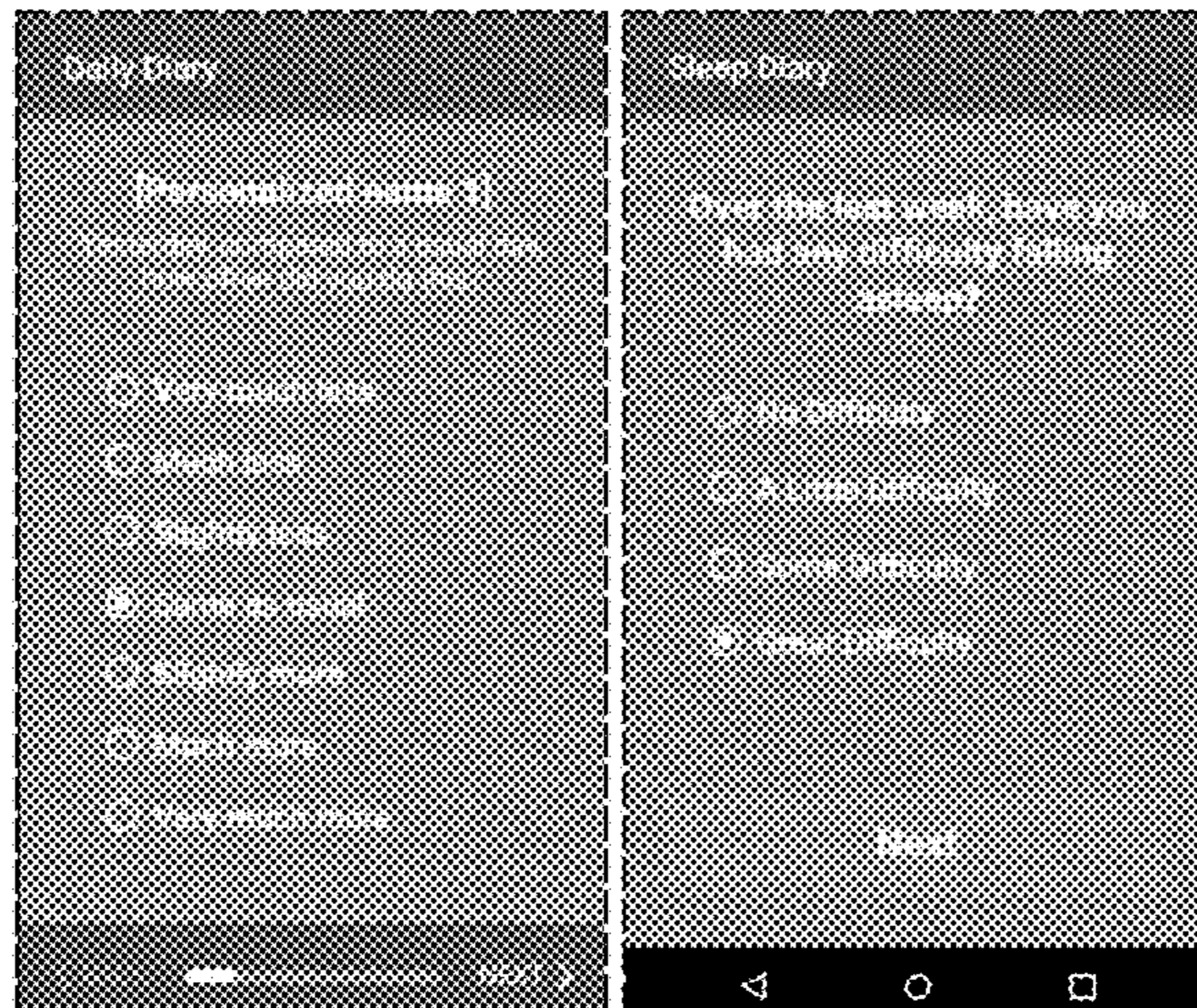
FIG. 14 is a fourteenth embodiment thereof.

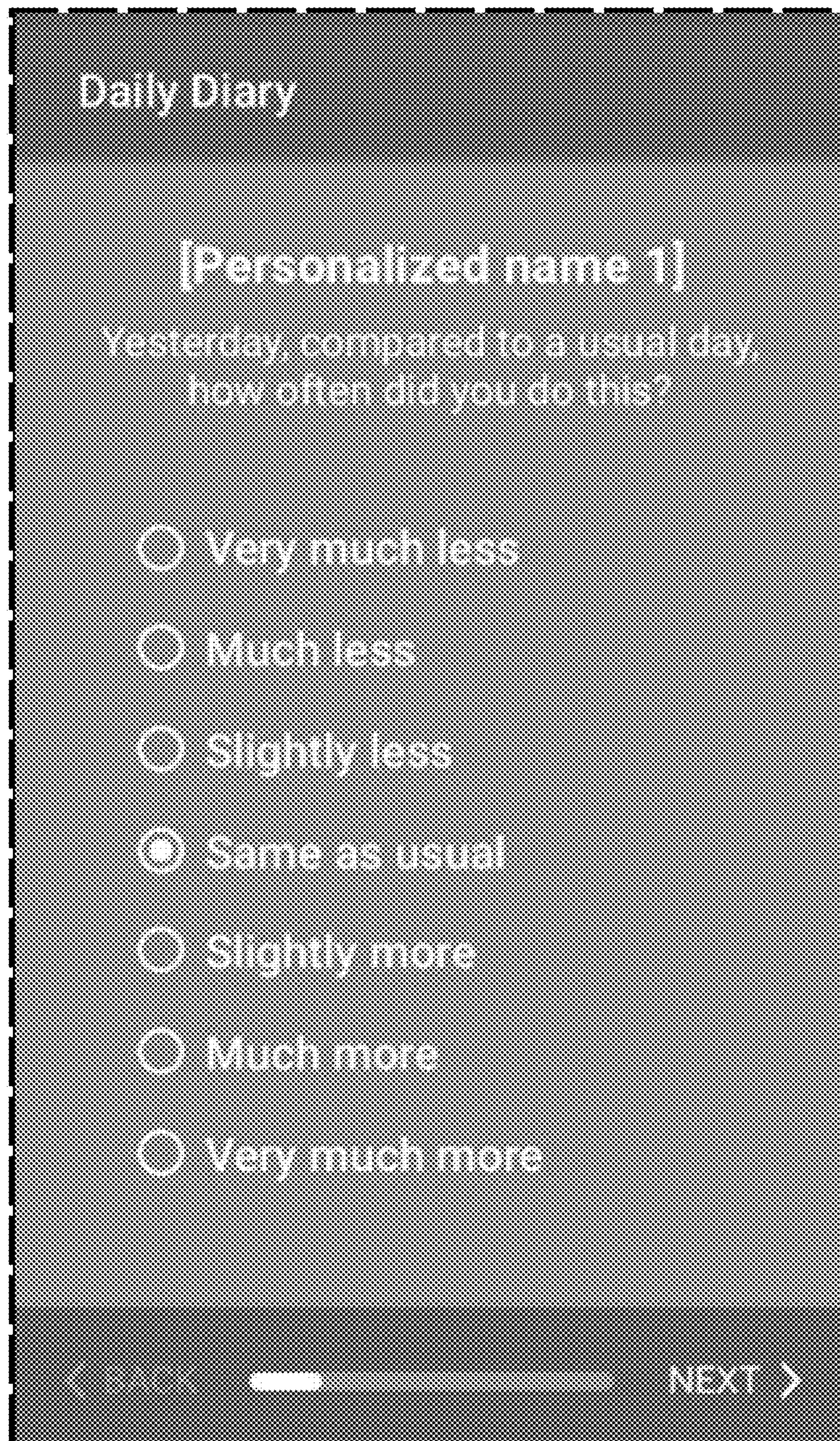

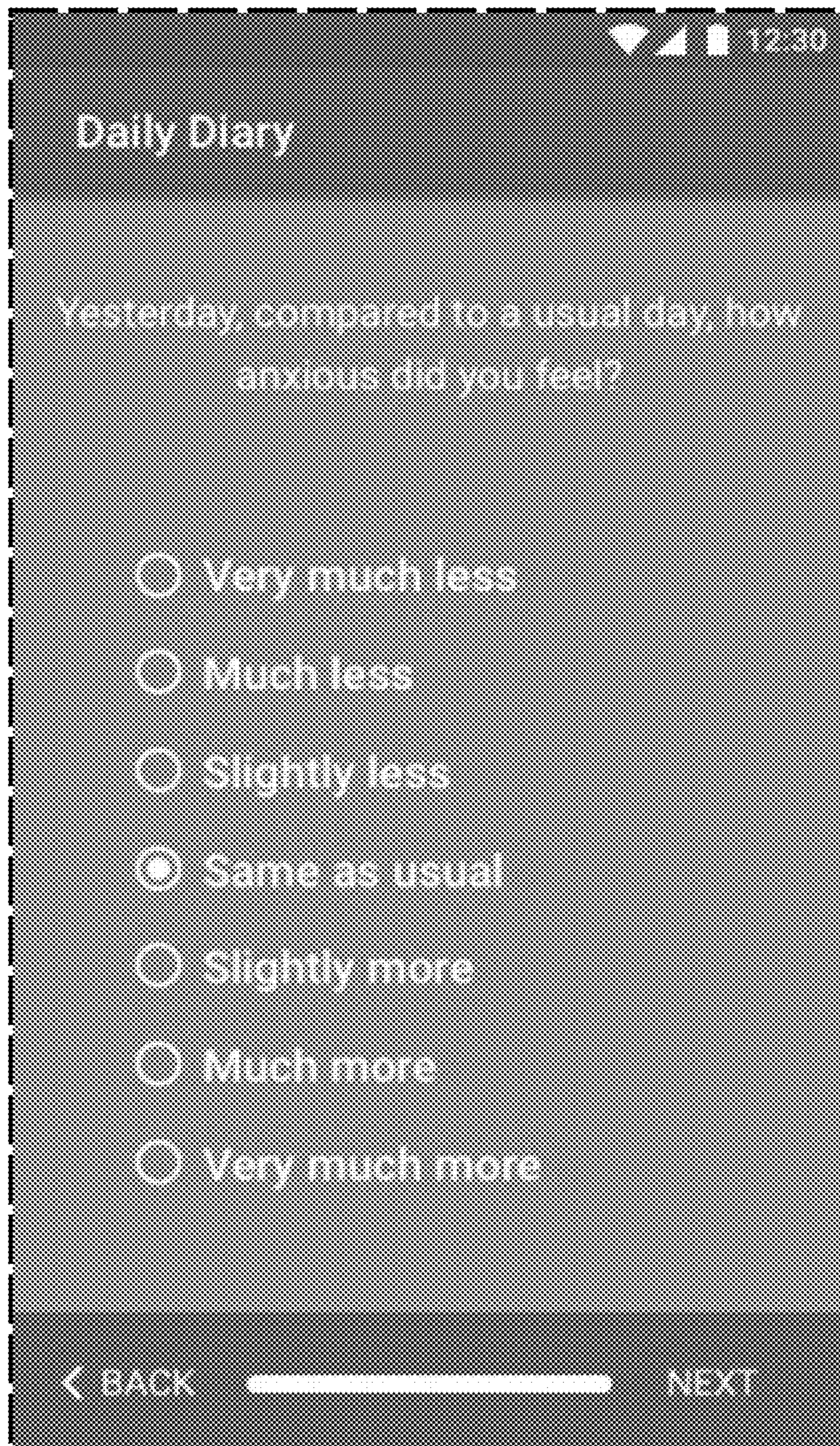

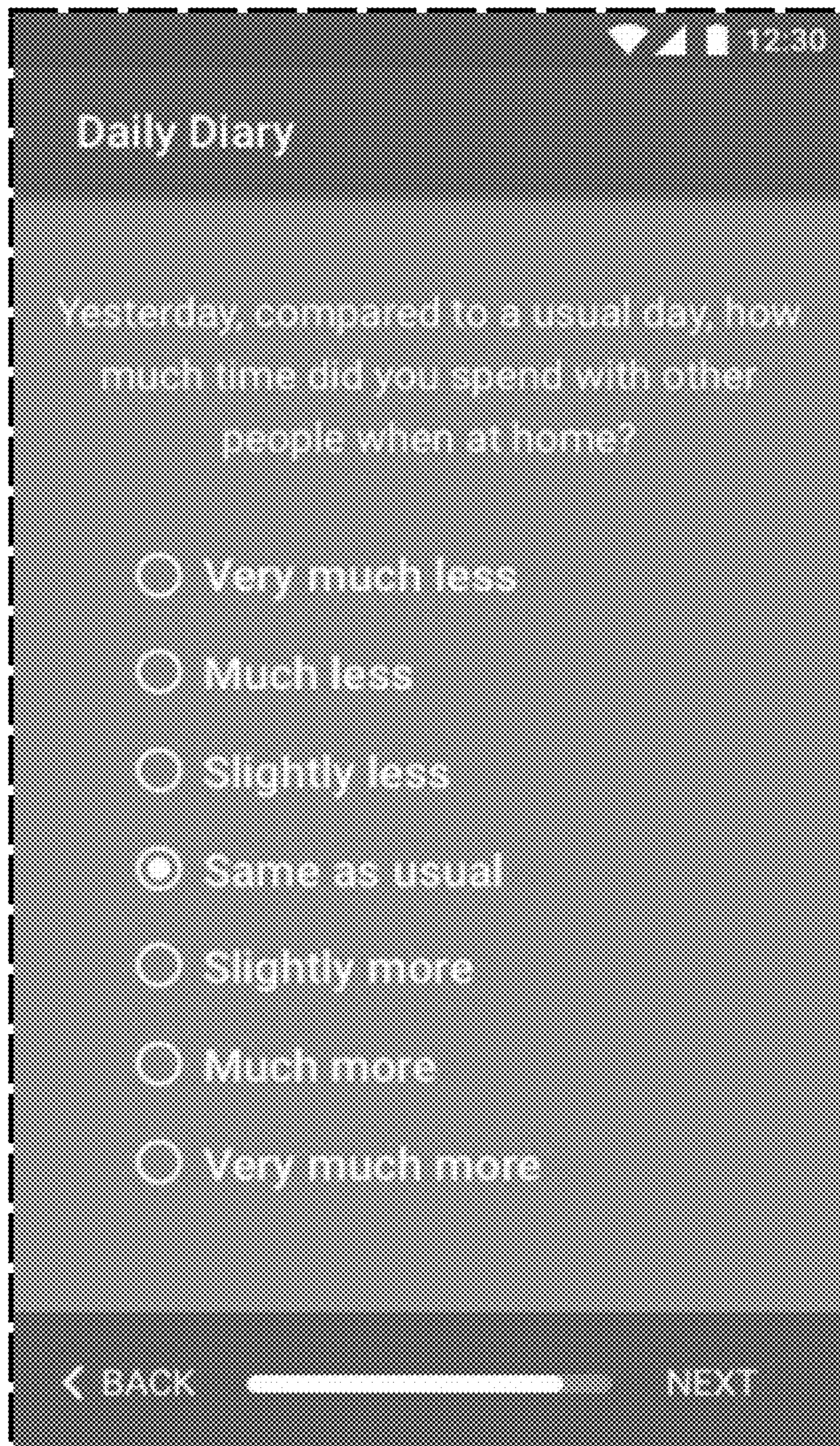

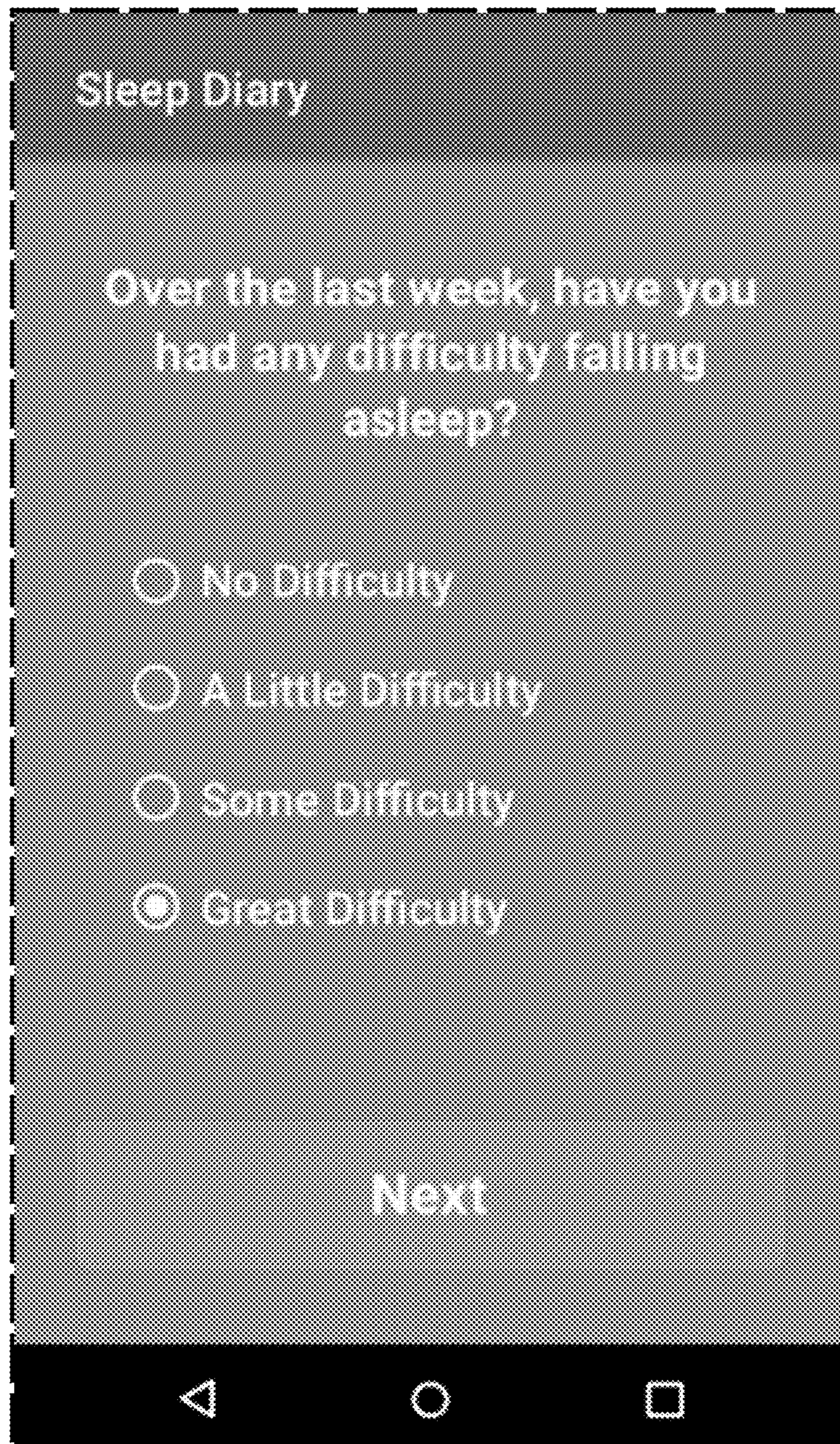

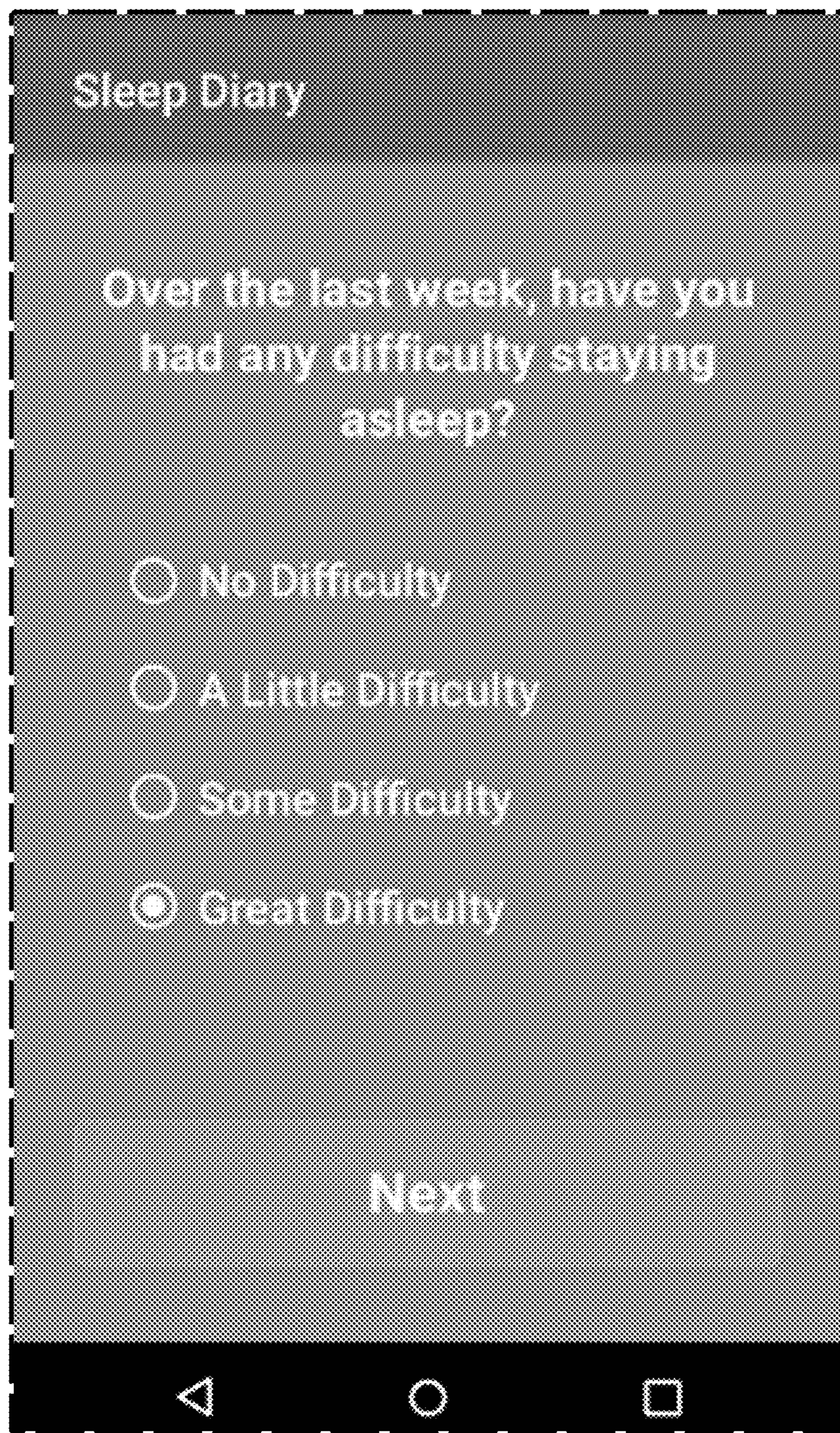

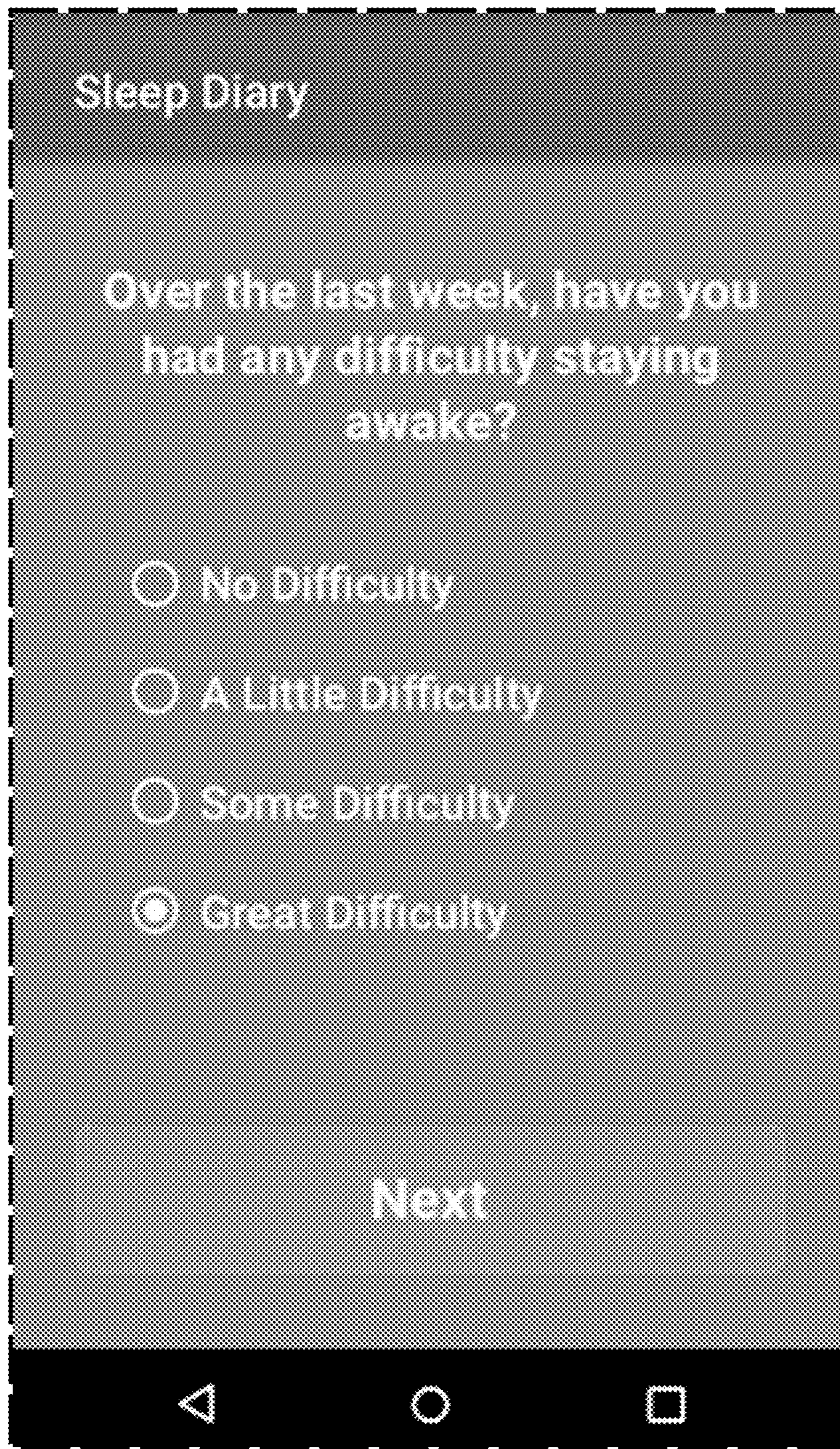

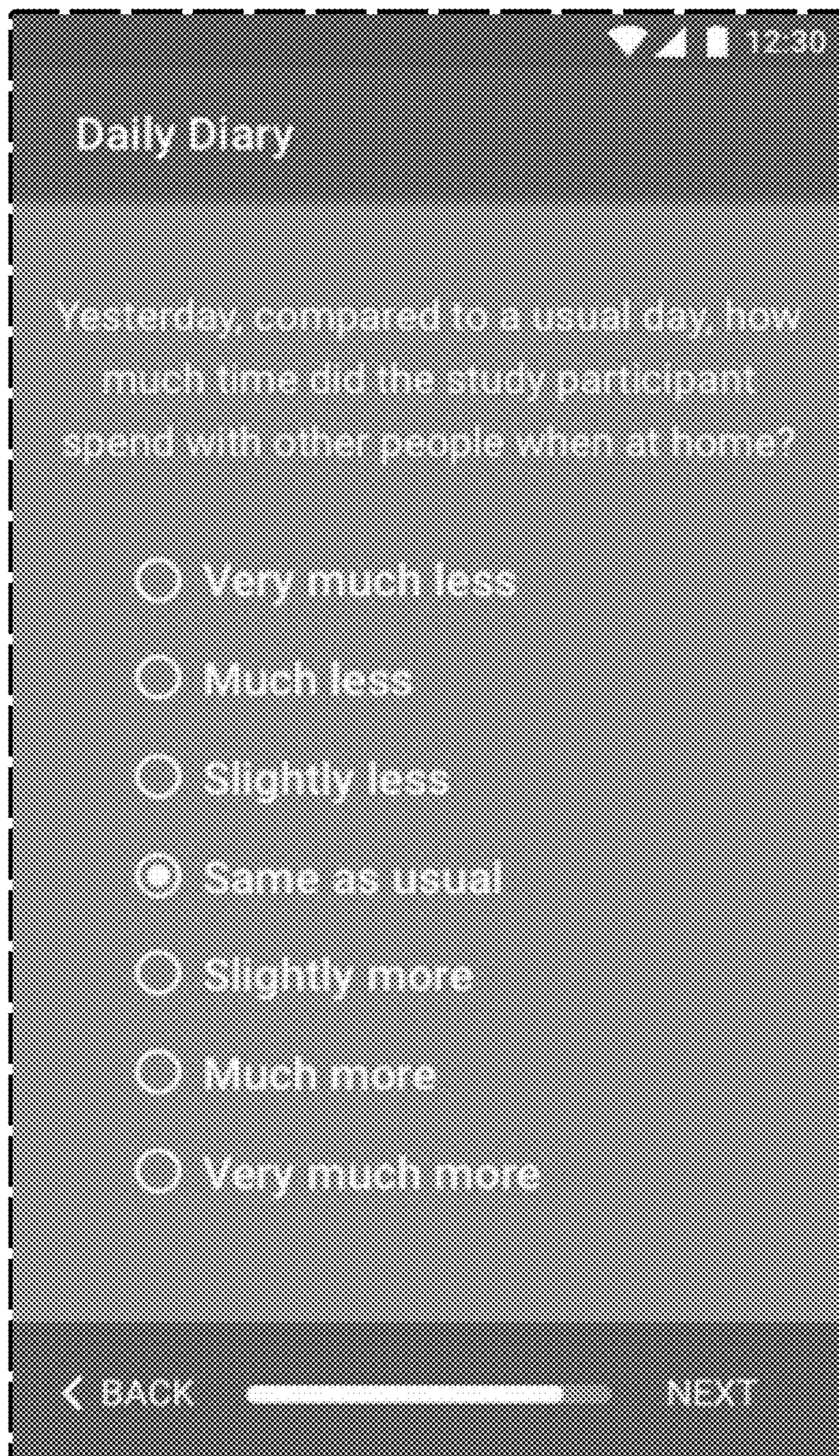

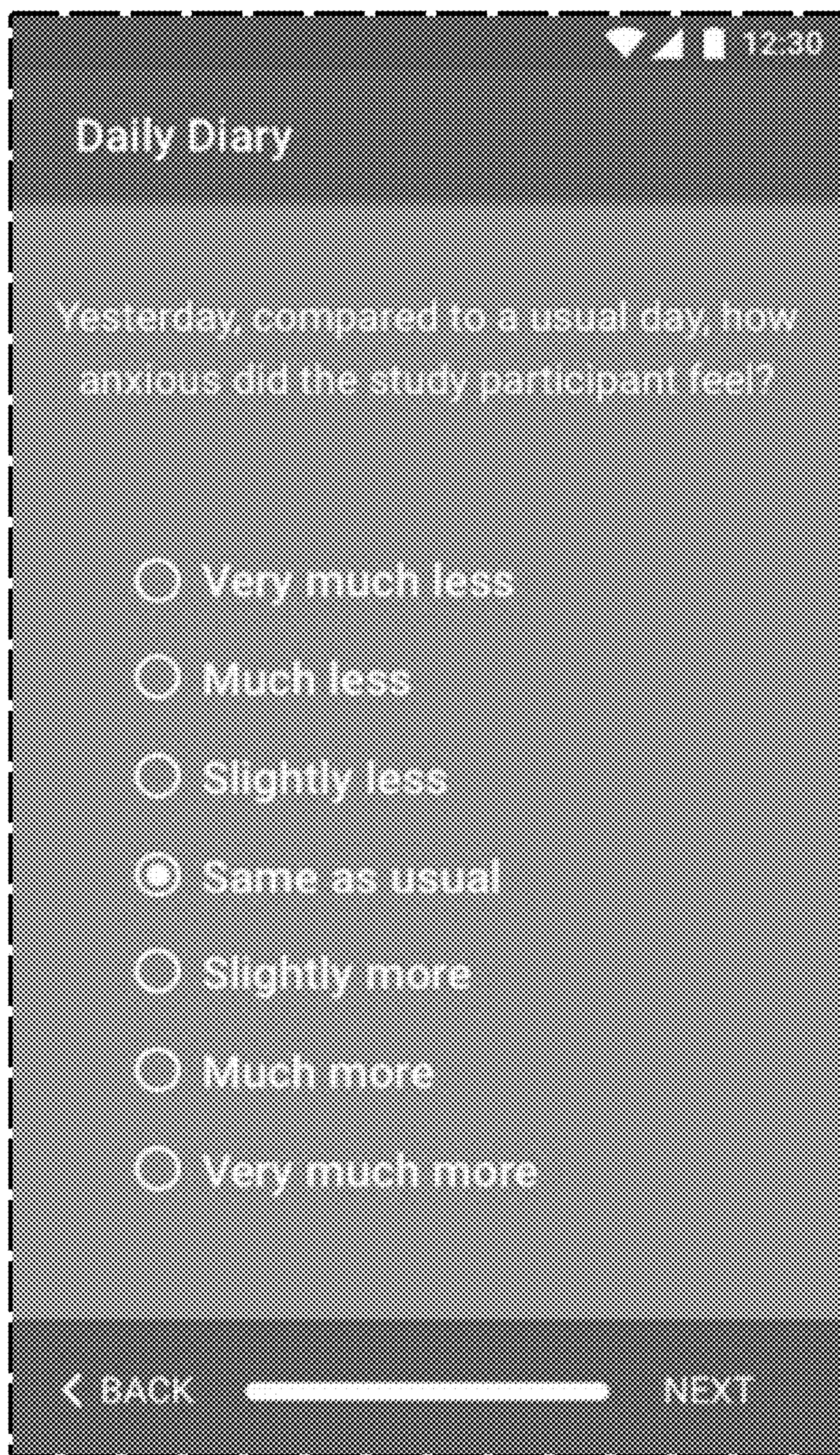

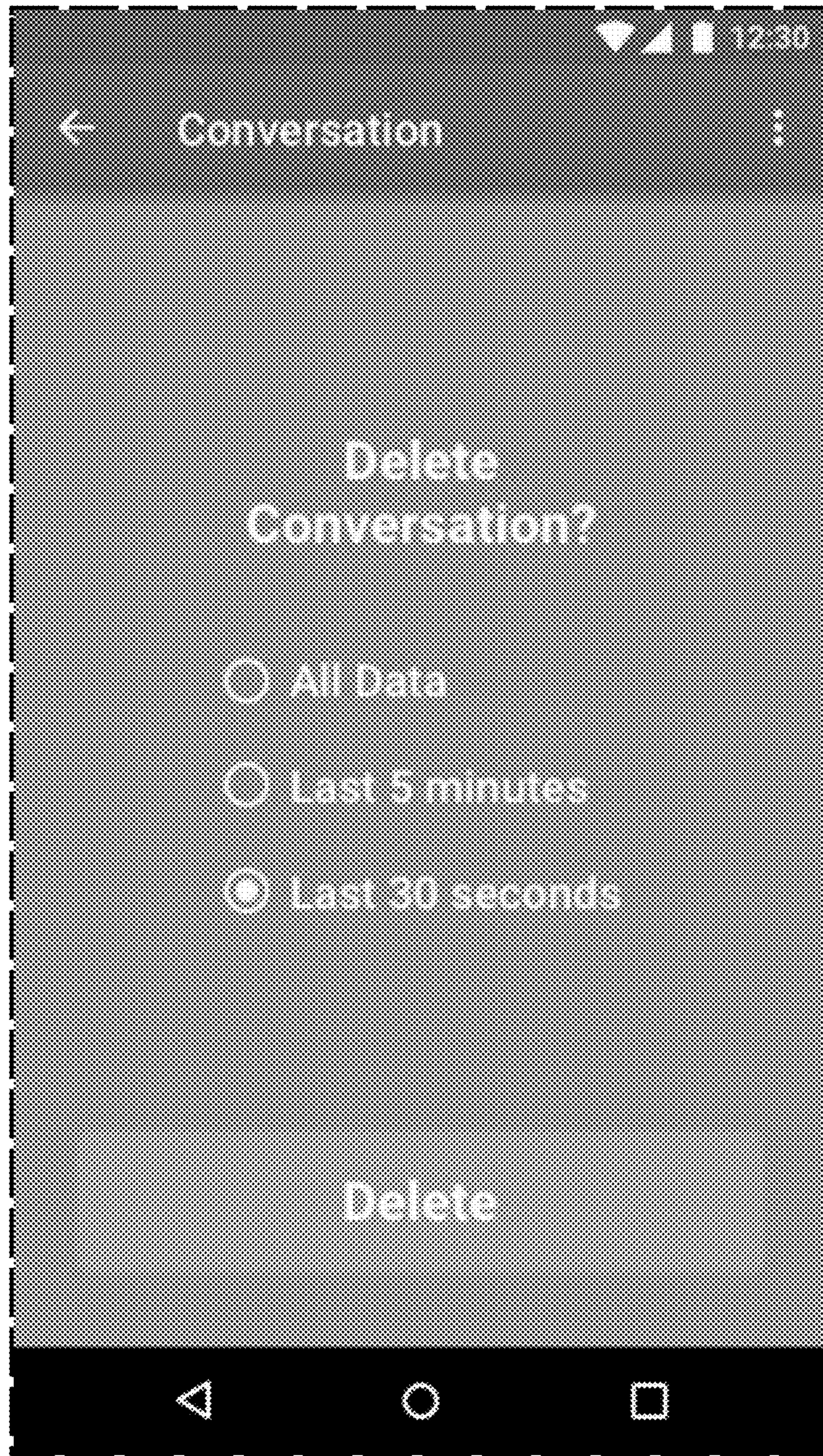

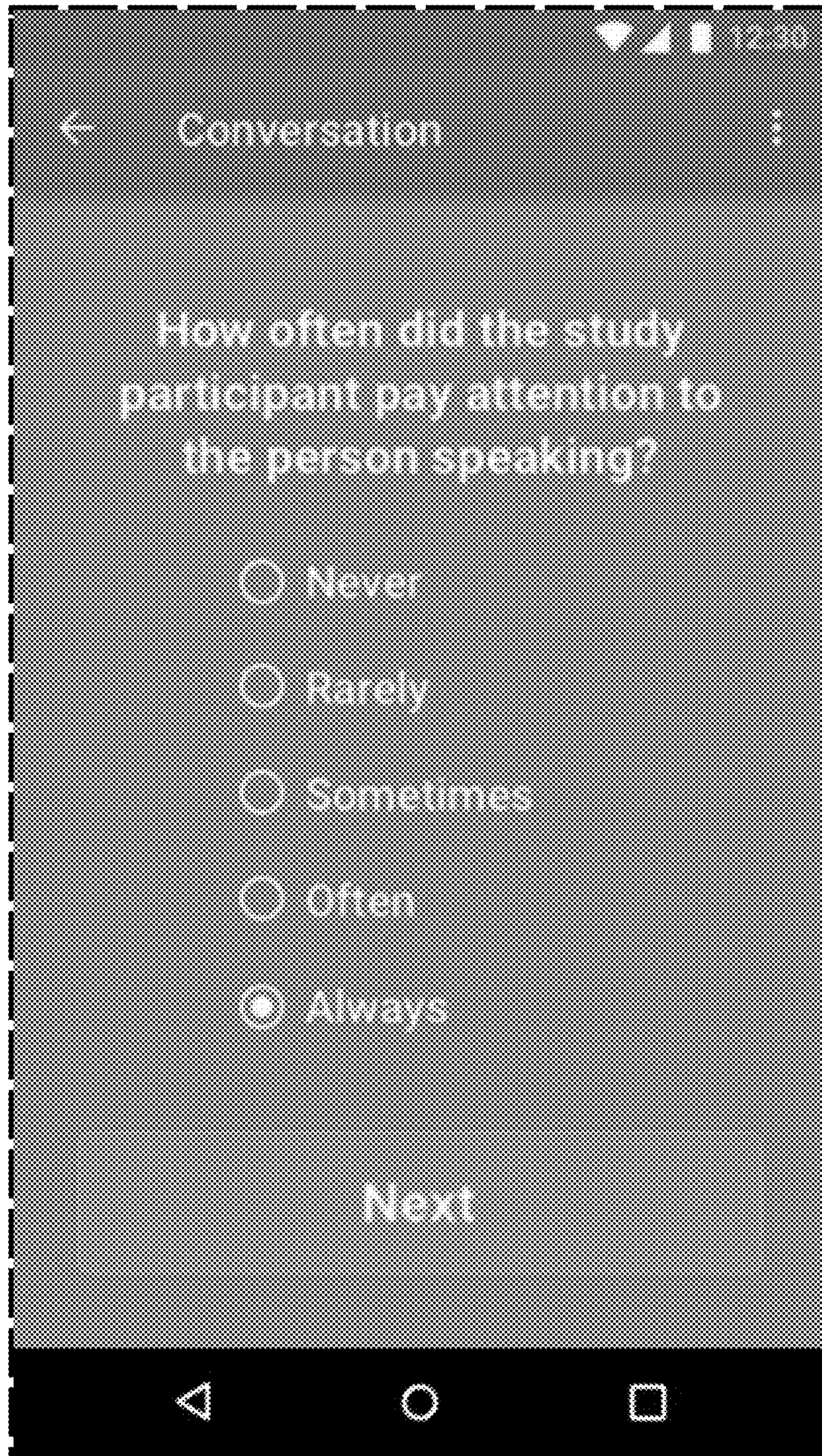
