(57) **CLAIM**

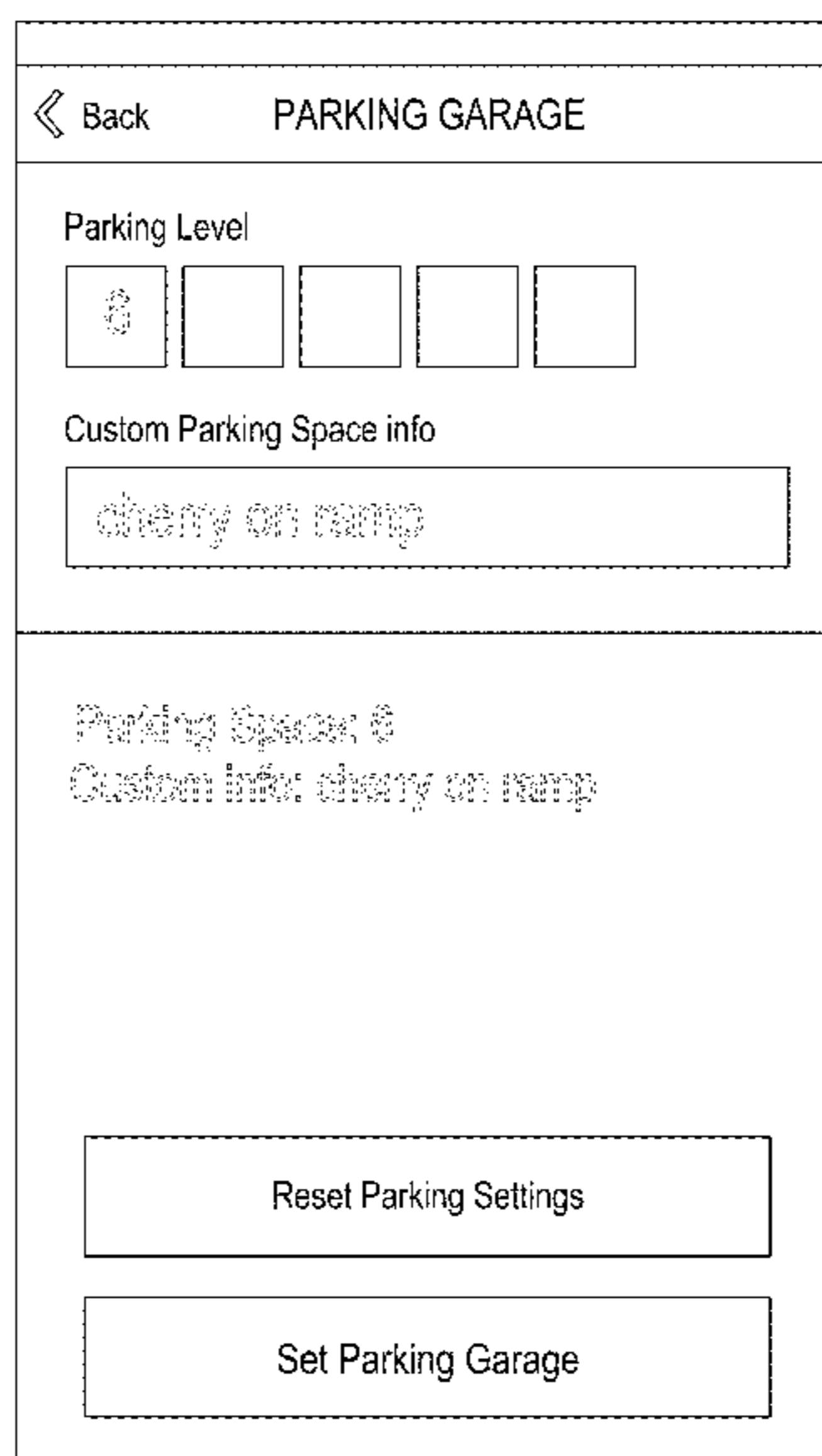
I claim the ornamental design for a display screen of a computing device with parking assistance graphical user interface, as shown and described.
