What is claimed is the ornamental design for a display panel of a programmed computer system with a graphical user interface, as shown and described.

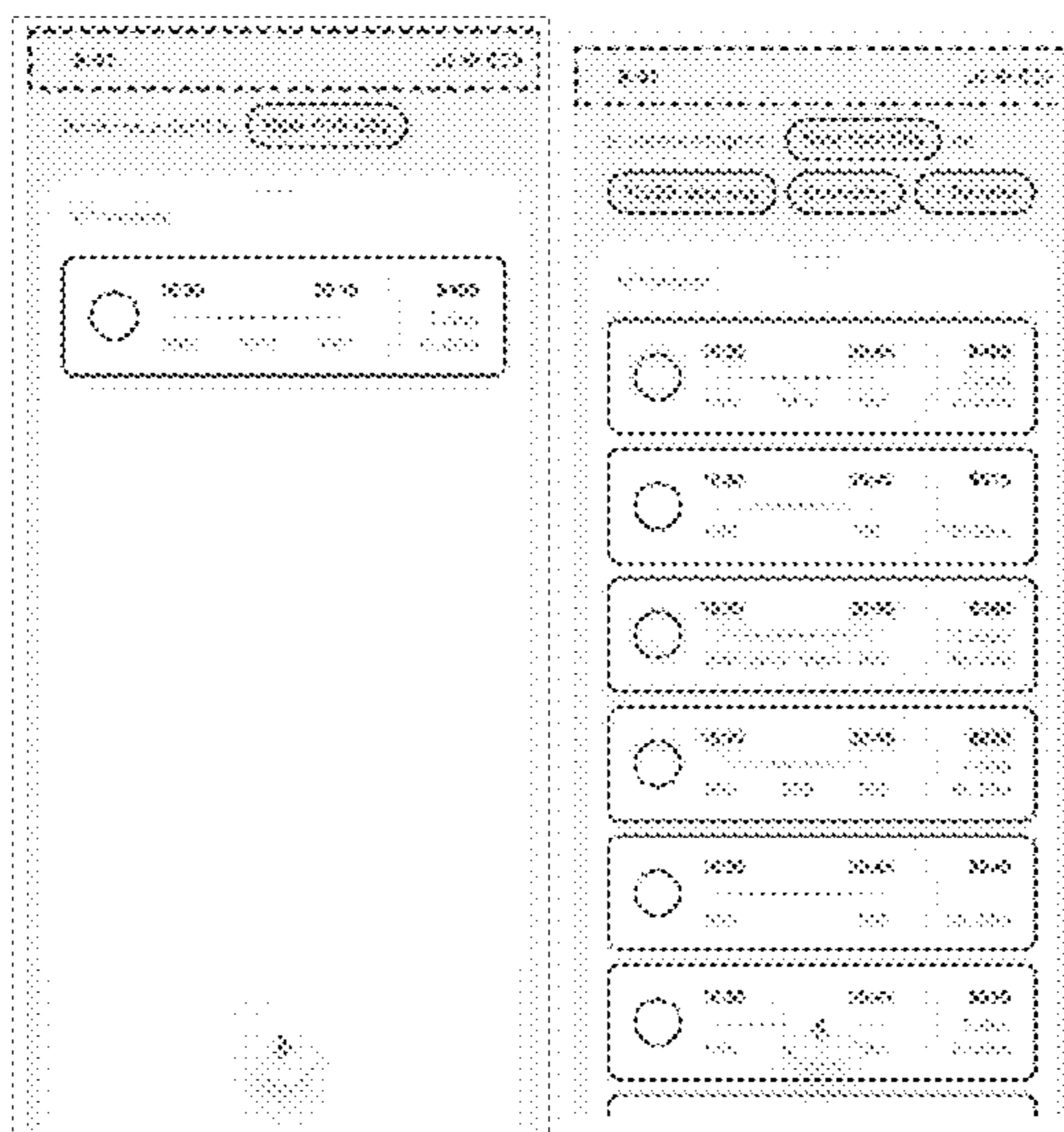
**DESCRIPTION**

FIG. 1 is a first view of a first embodiment of a display panel of a programmed computer system with a graphical user interface;

 FIG. 4 is a first view of a second embodiment of a display panel of a programmed computer system with a graphical user interface;  
 FIG. 5 is a second view thereof; and  
 FIG. 6 is a third view thereof;  
 FIG. 7 is a first view of a third embodiment of a display panel of a programmed computer system with a graphical user interface;  
 FIG. 8 is a second view thereof; and  
 FIG. 9 is a third view thereof;  
 FIG. 10 is a first view of a fourth embodiment of a display panel of a programmed computer system with a graphical user interface;  
 FIG. 11 is a second view thereof; and  
 FIG. 12 is a third view thereof.

The broken lines showing the display panel in FIGS. 4-6 and FIGS. 10-12 form no part of the claimed design. The remaining broken lines showing portions of the graphical user interface form no part of the claimed design.

The appearance of the animated image transitions sequentially between the images shown in FIGS. 1-3, 4-6, 7-9, and 10-12, respectively. The process or period in which one image transitions to another forms no part of the claimed design.

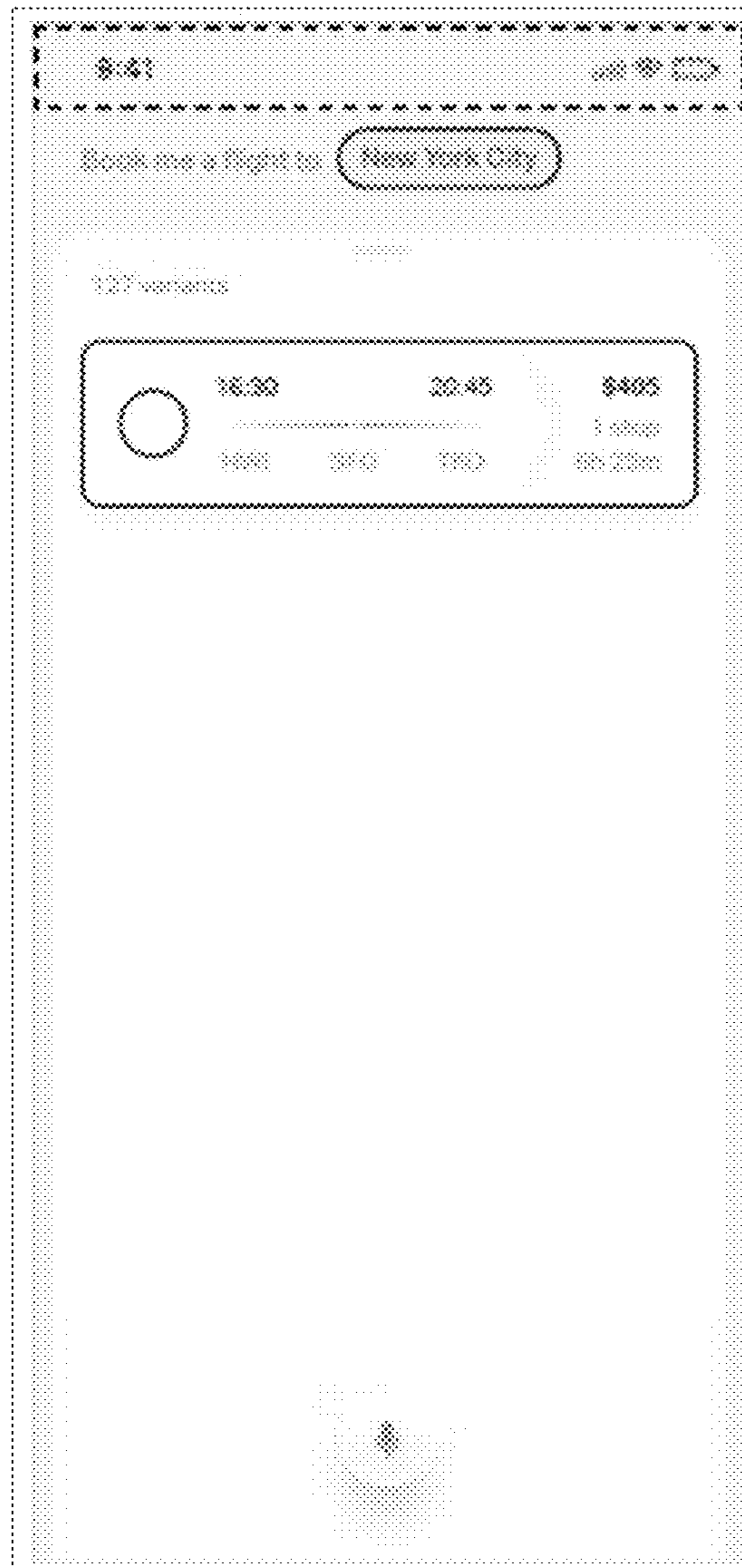

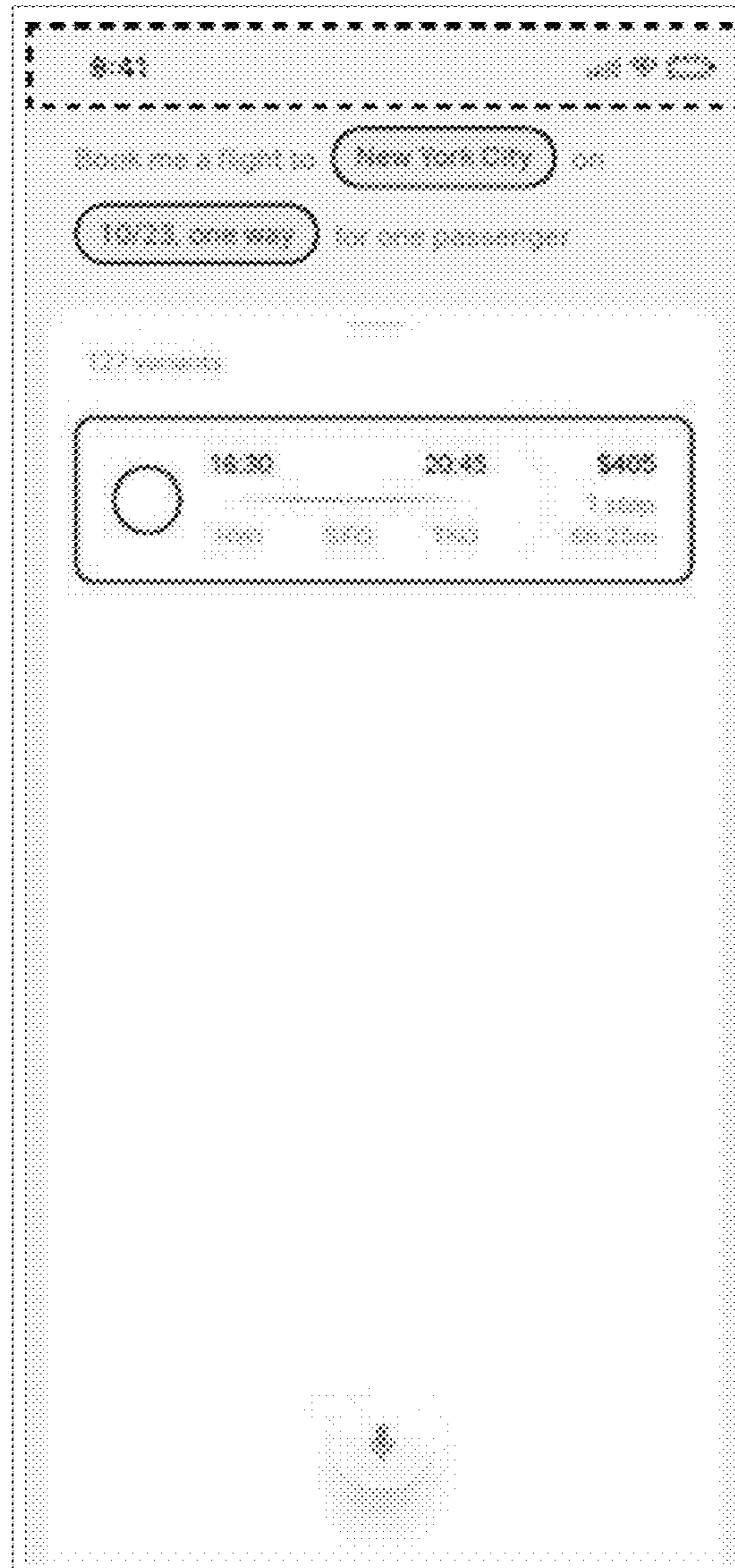

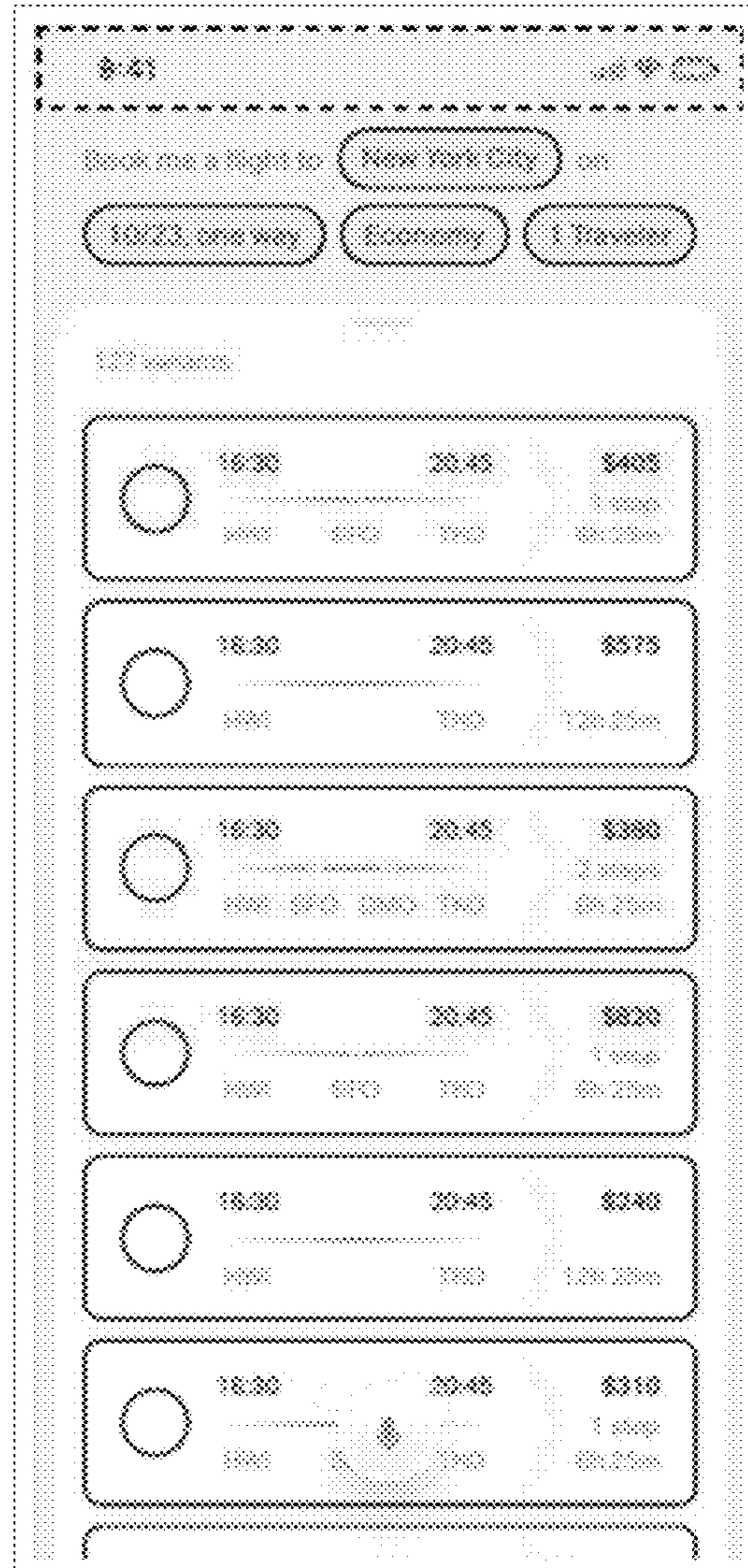

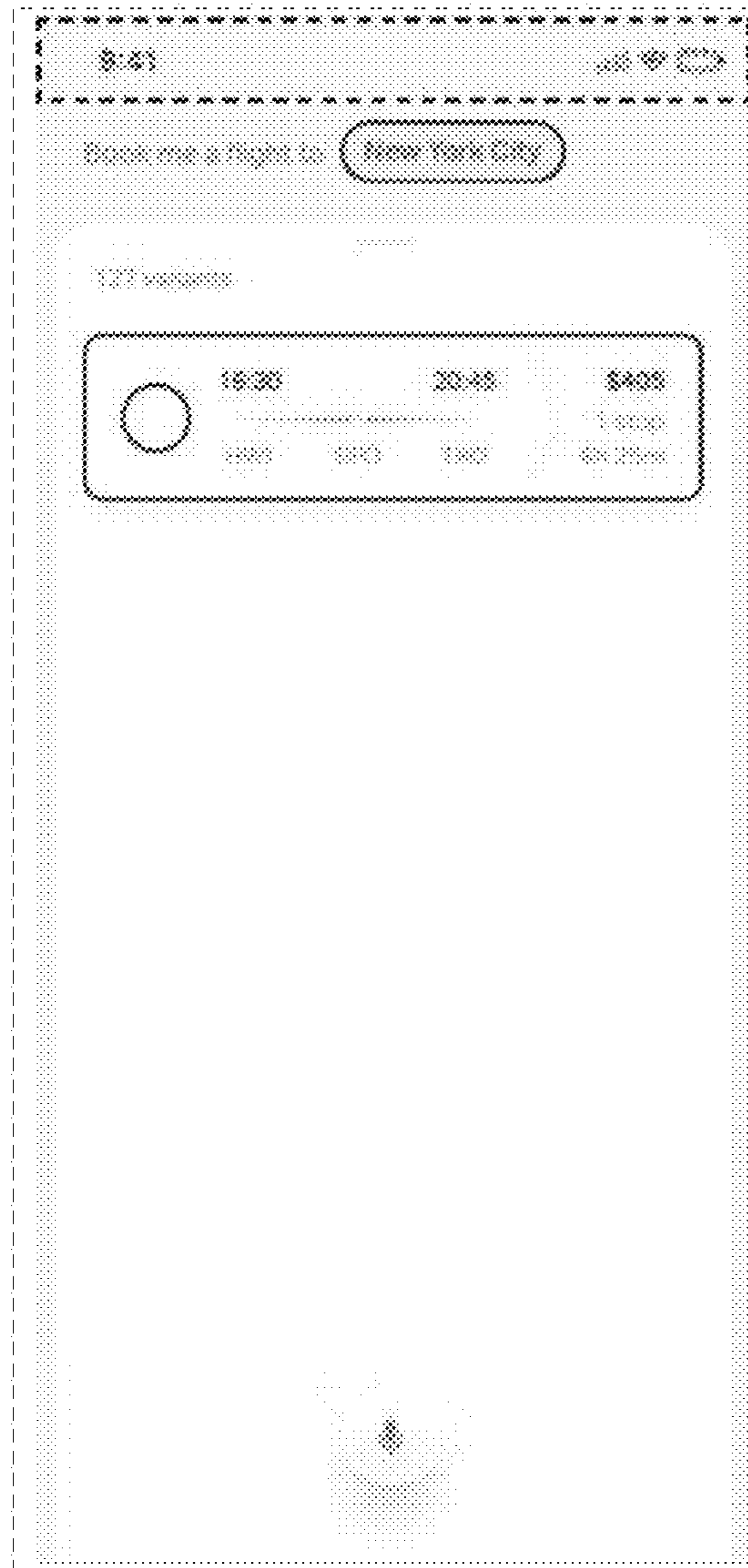

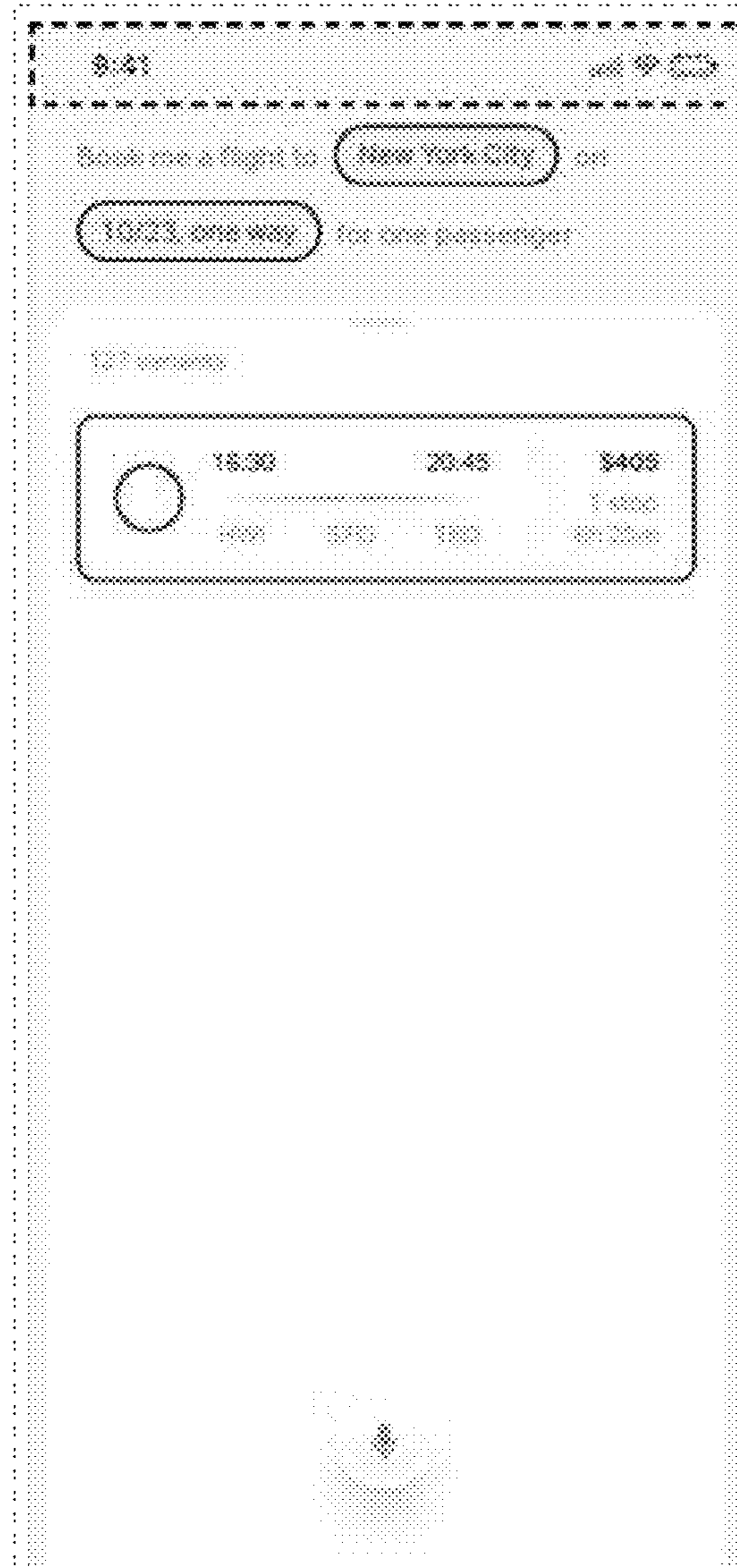

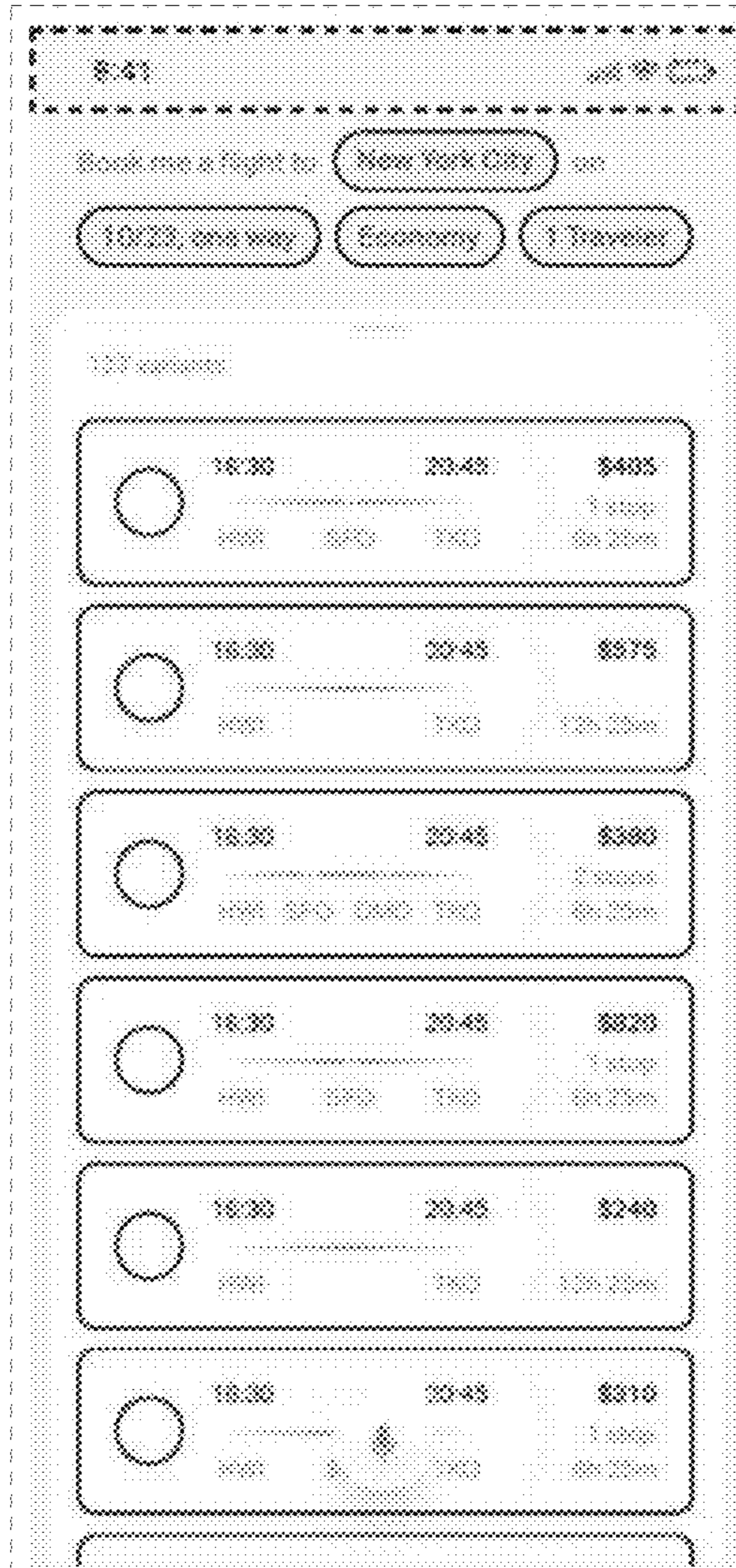

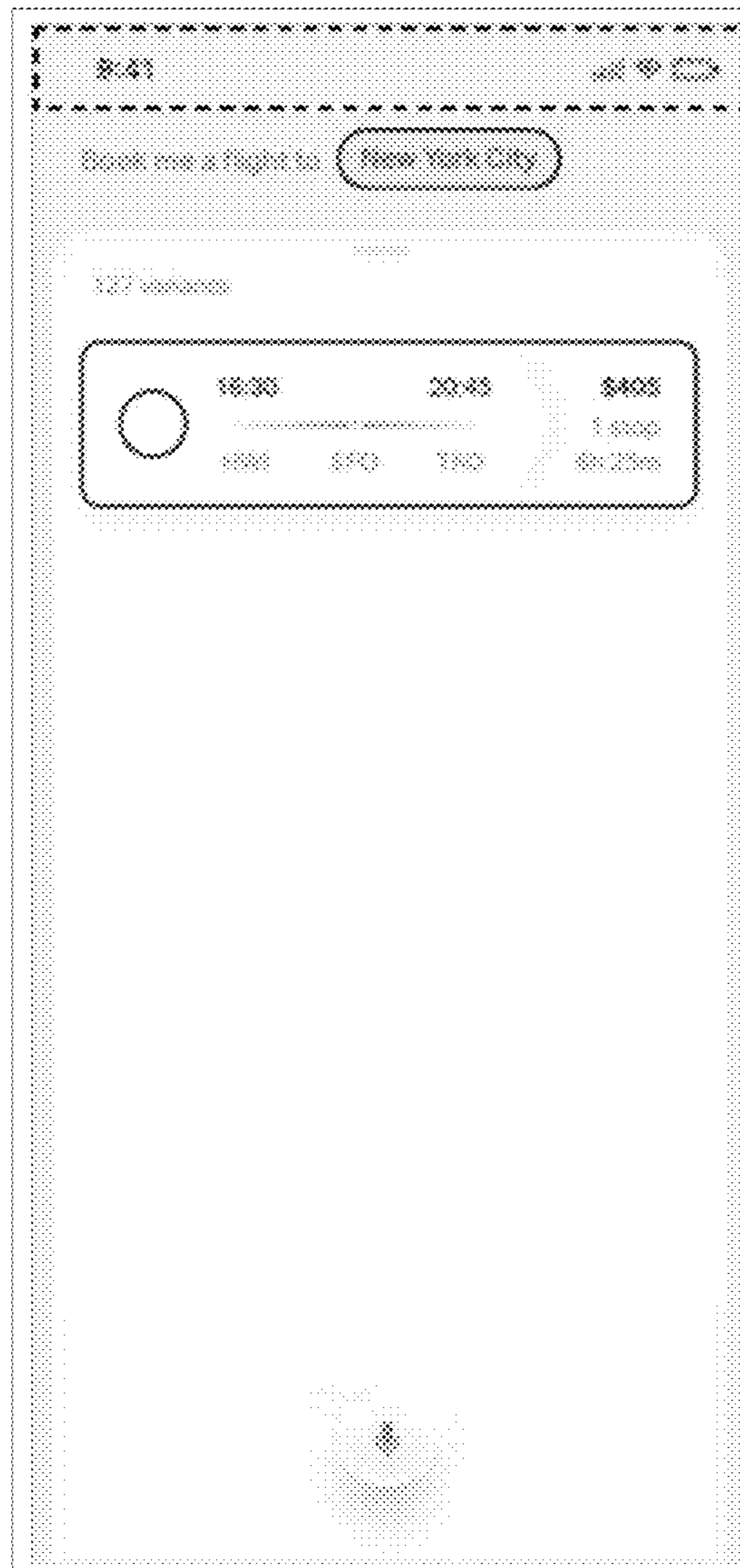

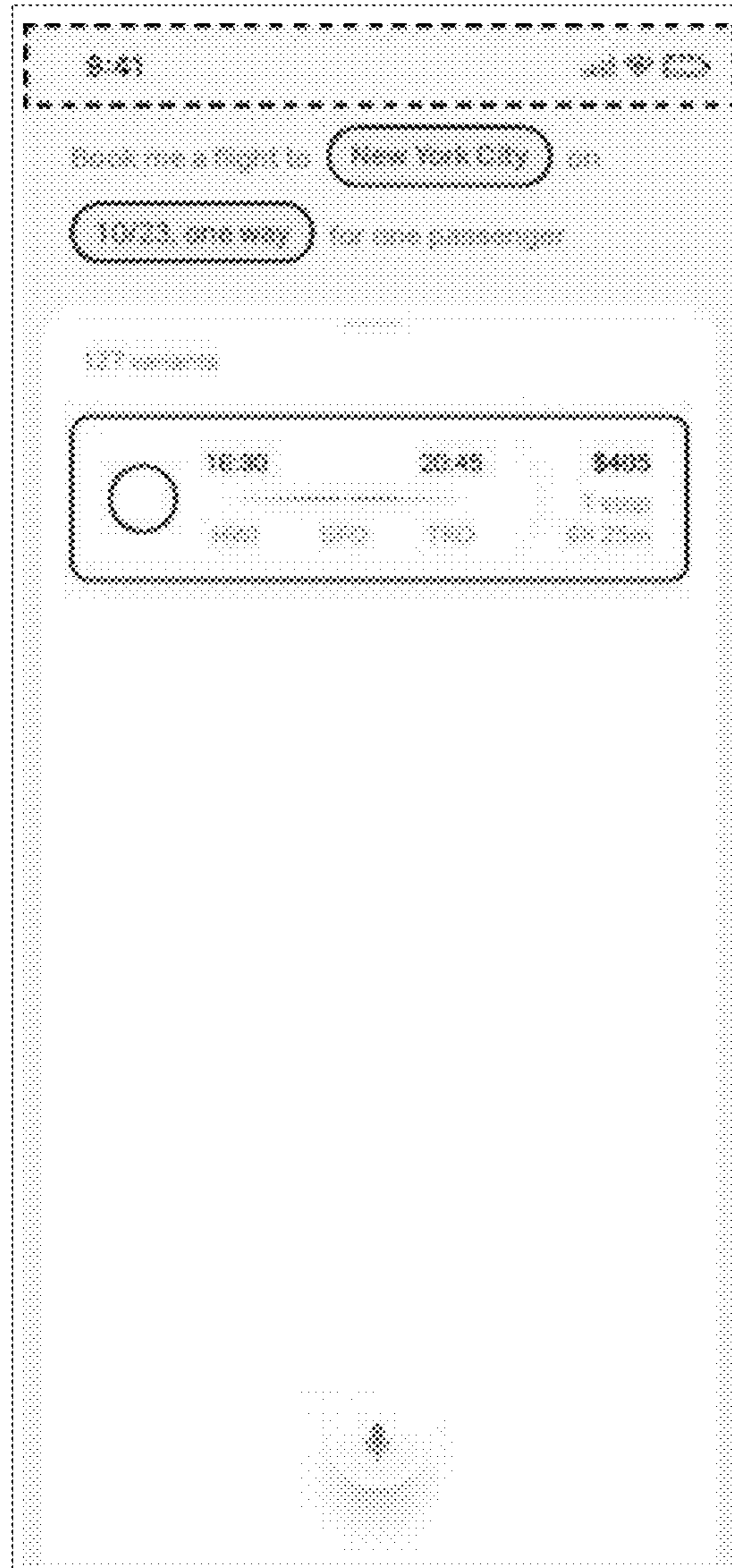

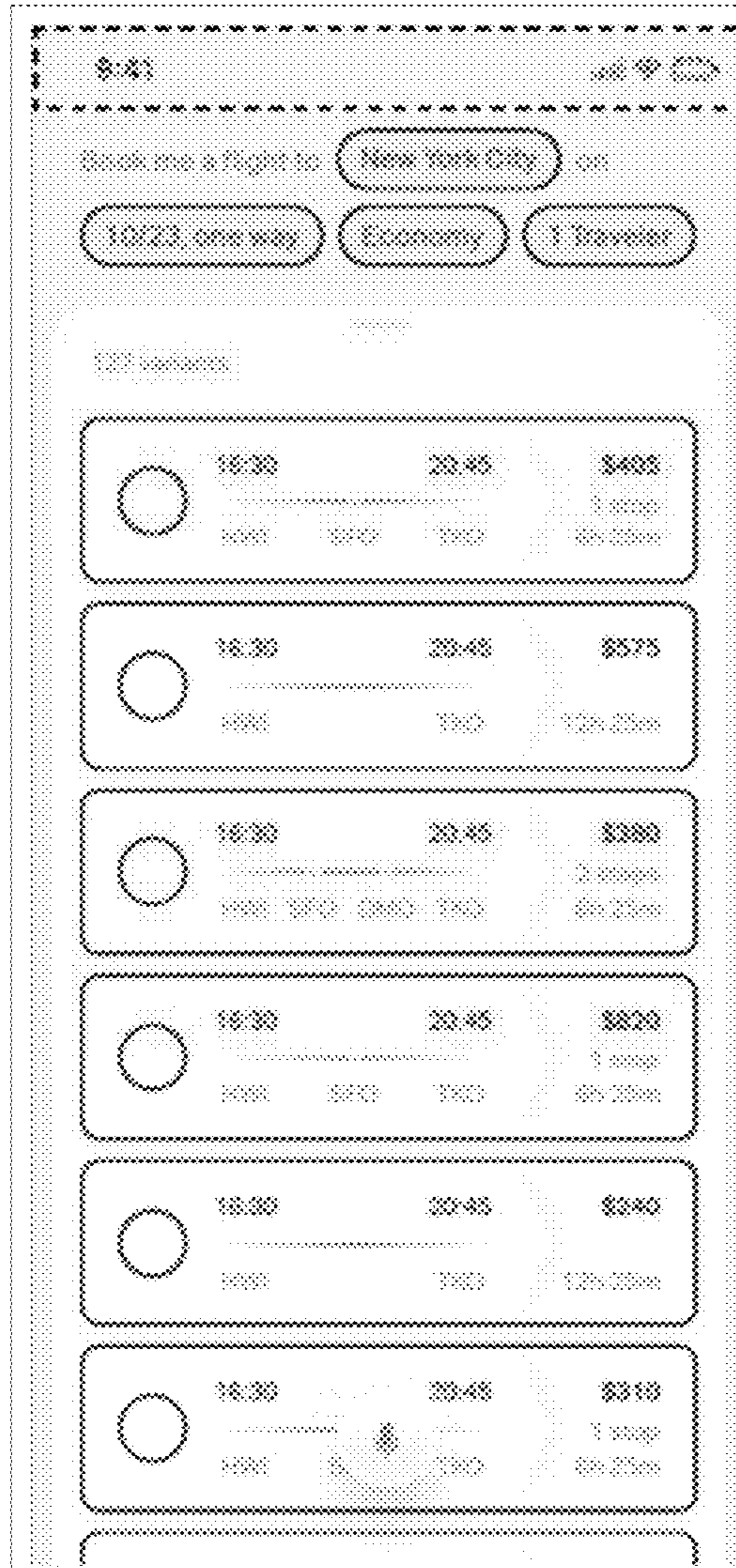
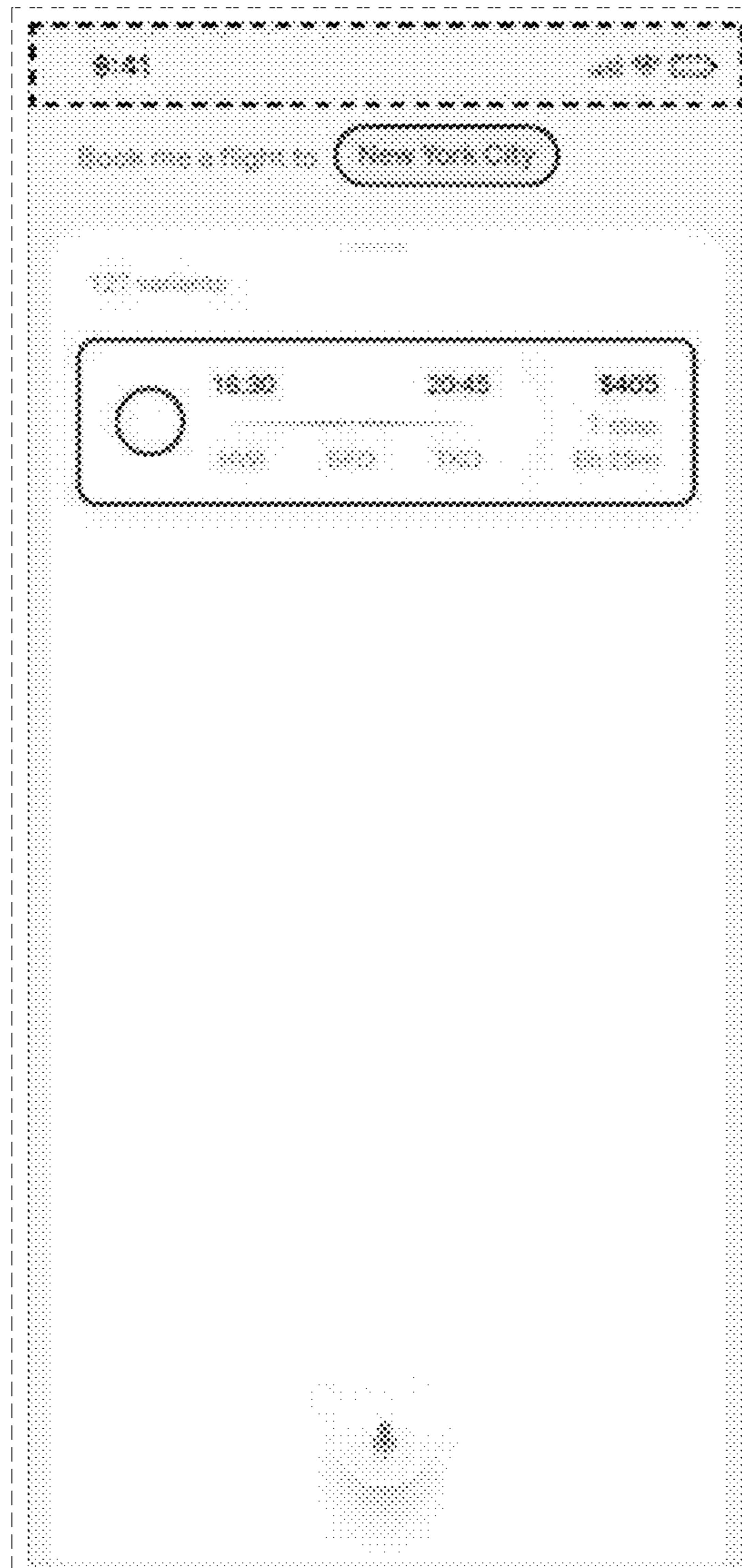

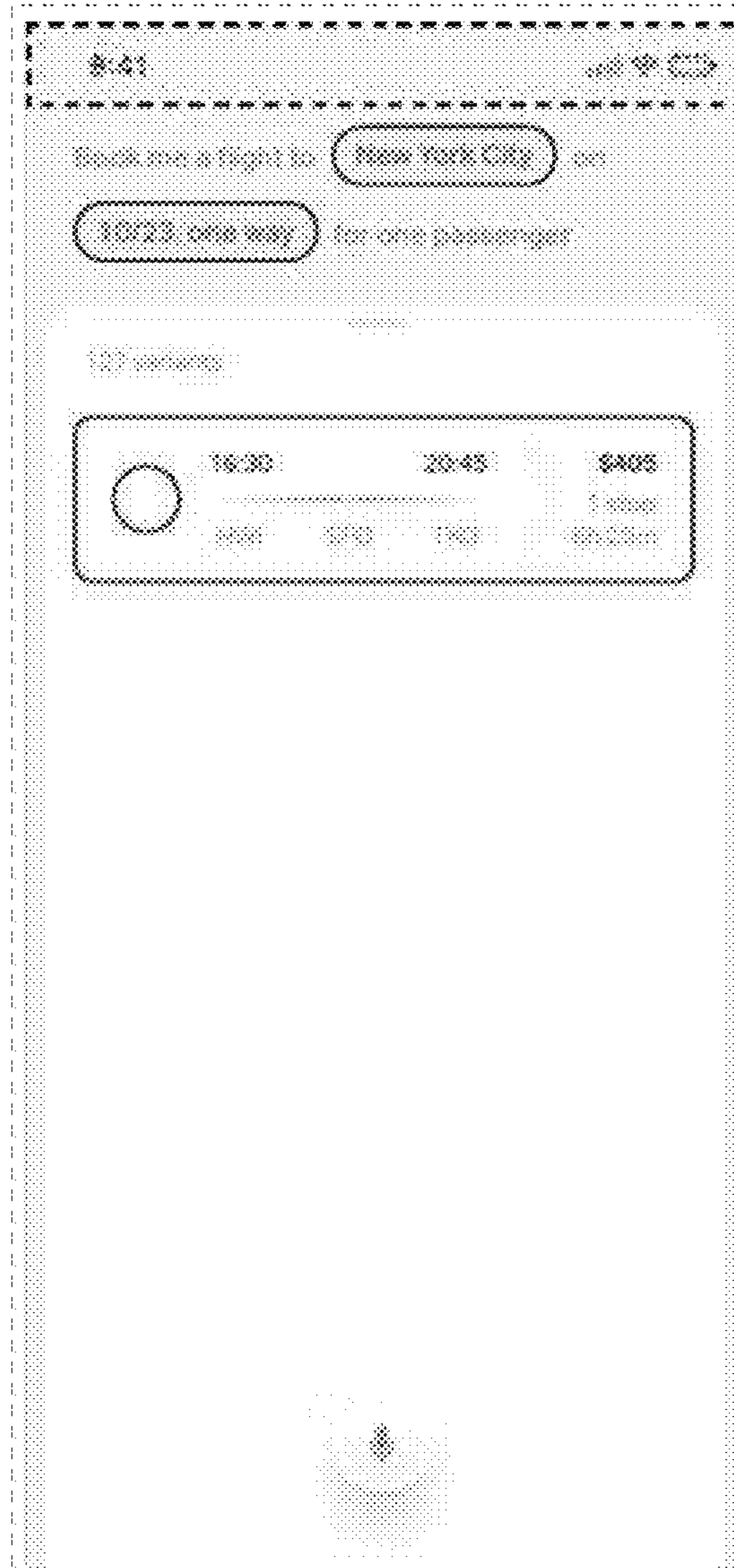

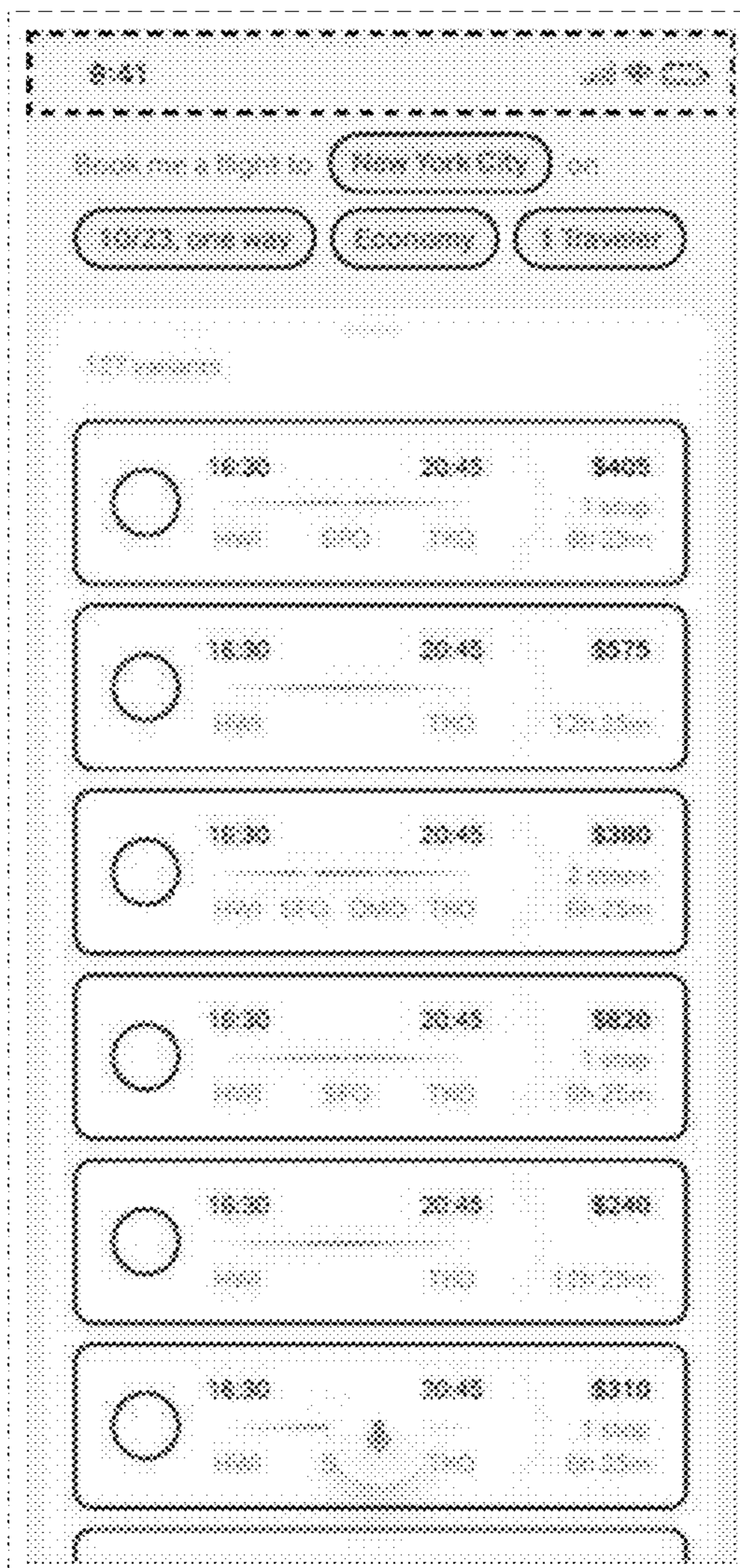
