(57) **CLAIM**

The ornamental design for a catch can housing for automotive applications, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of the catch can housing for automotive applications showing our new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

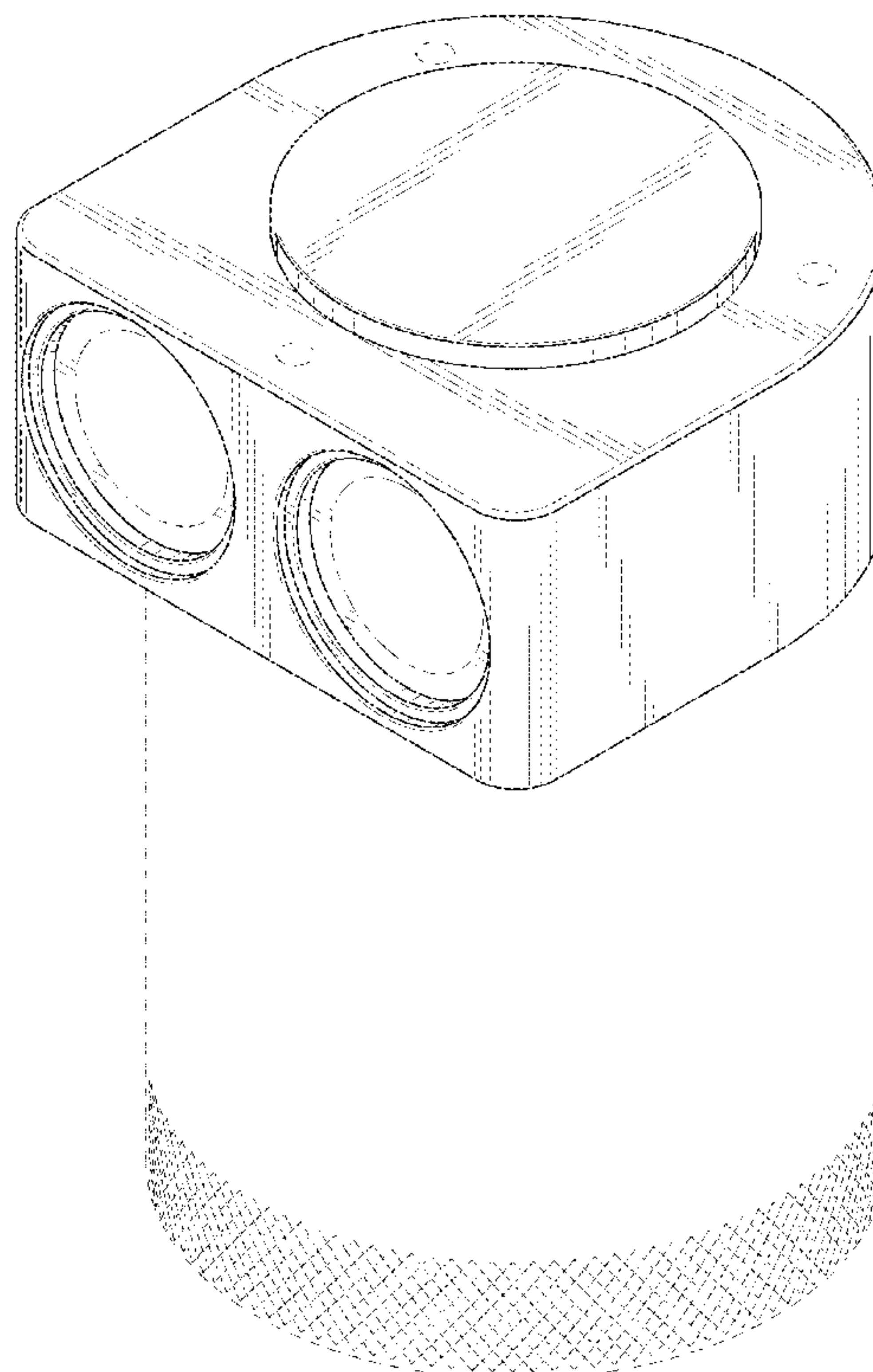
FIG. 4 is a right side elevation view thereof, with the left side elevation view being a mirror image thereof;

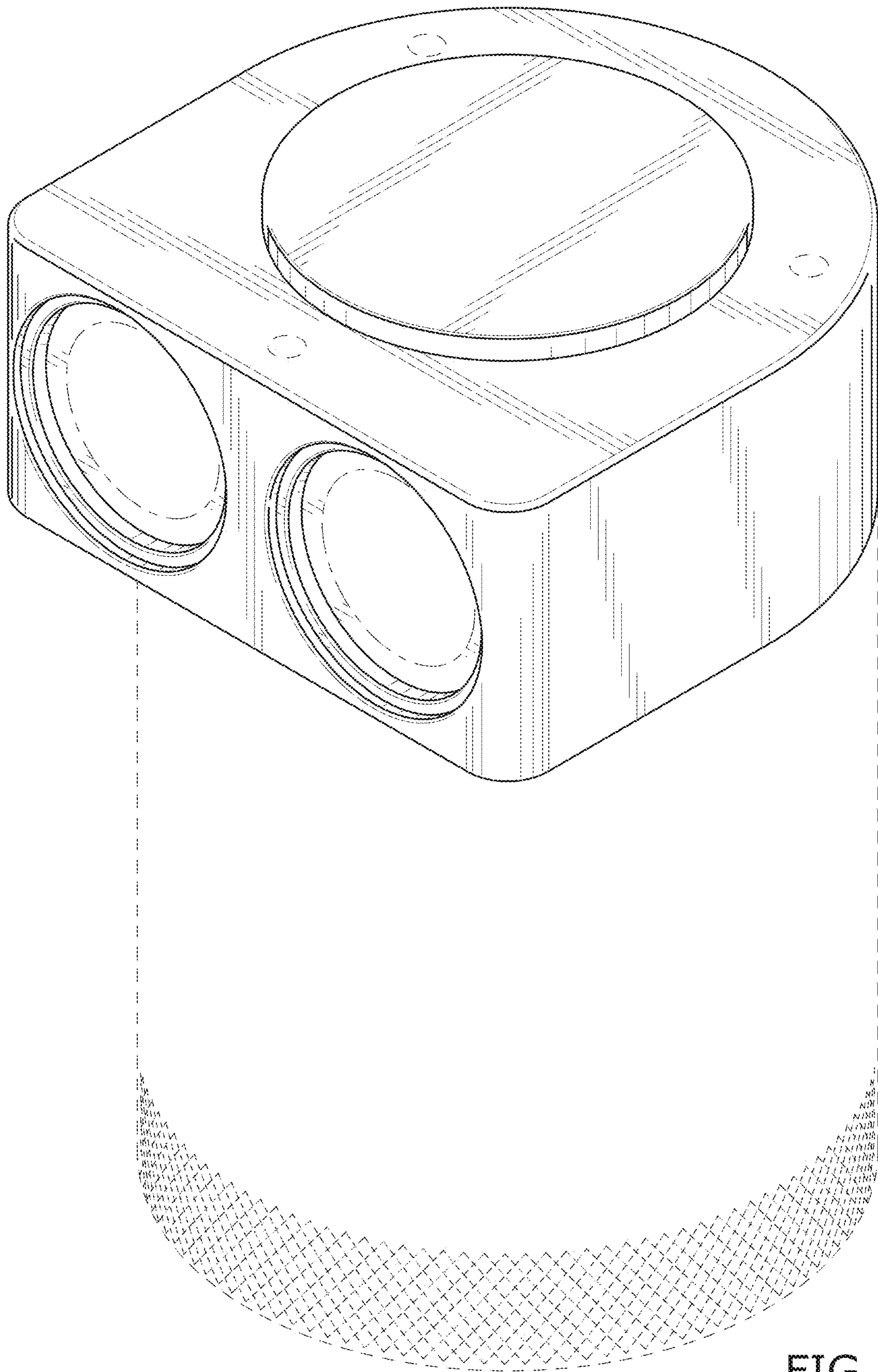

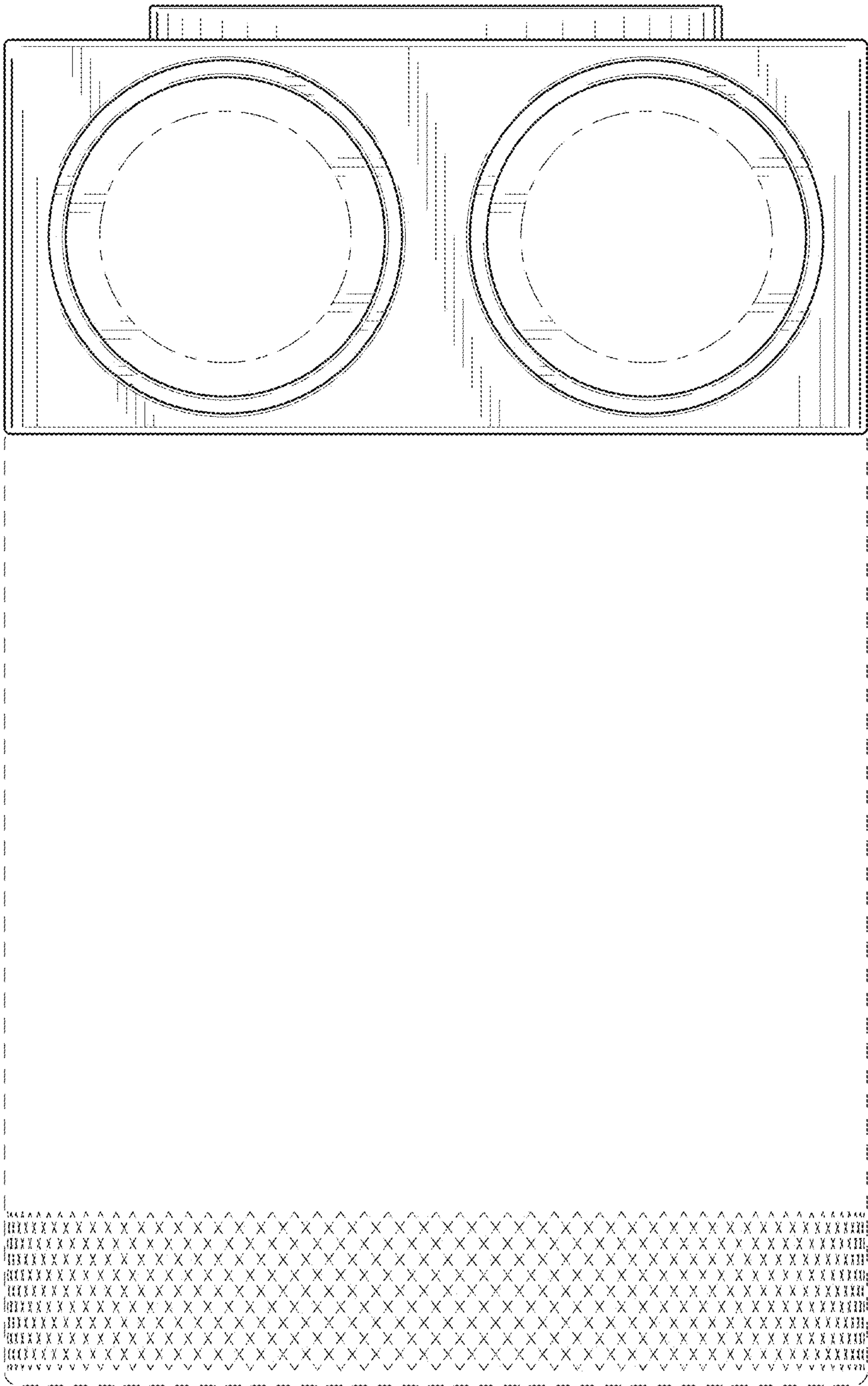

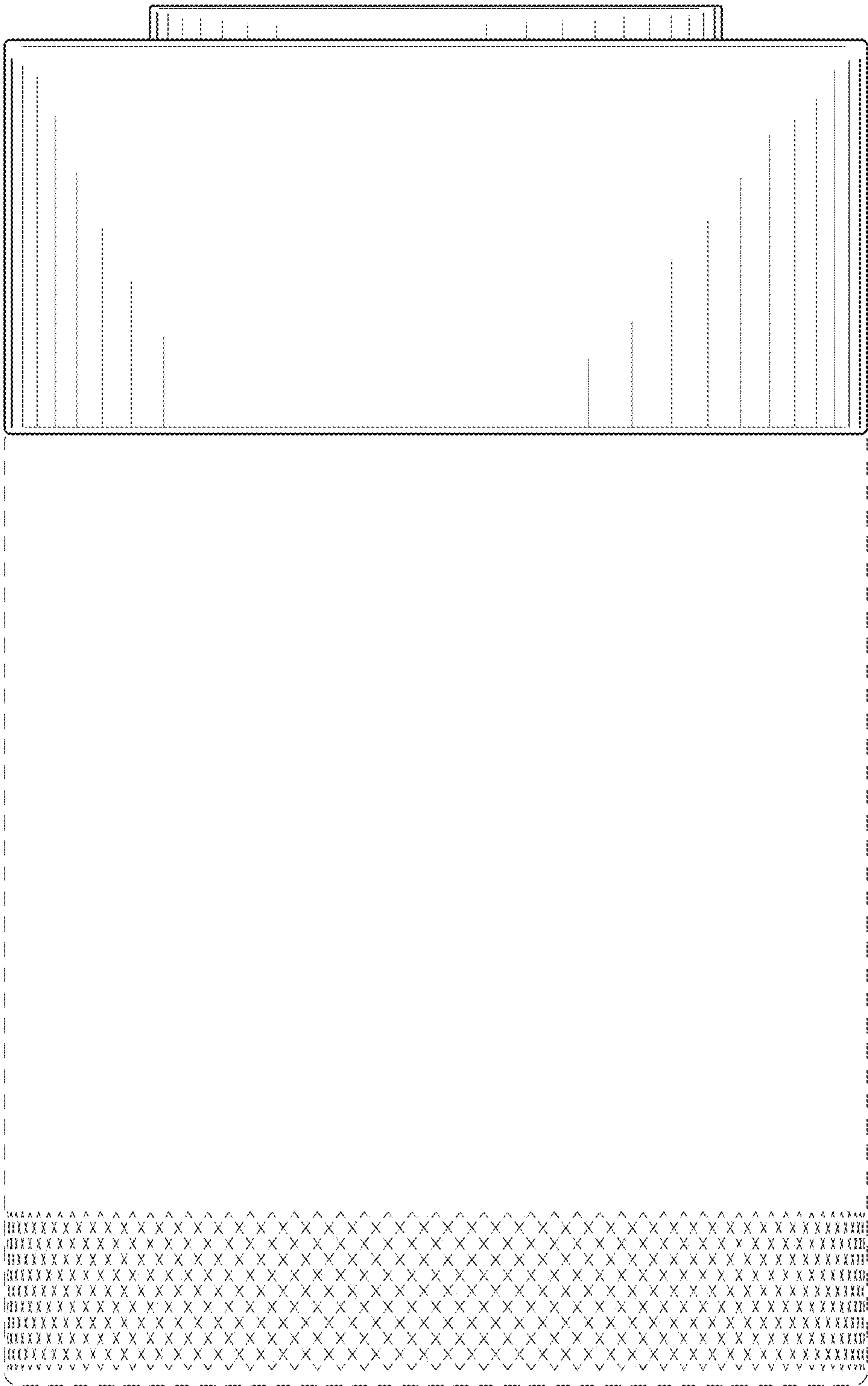

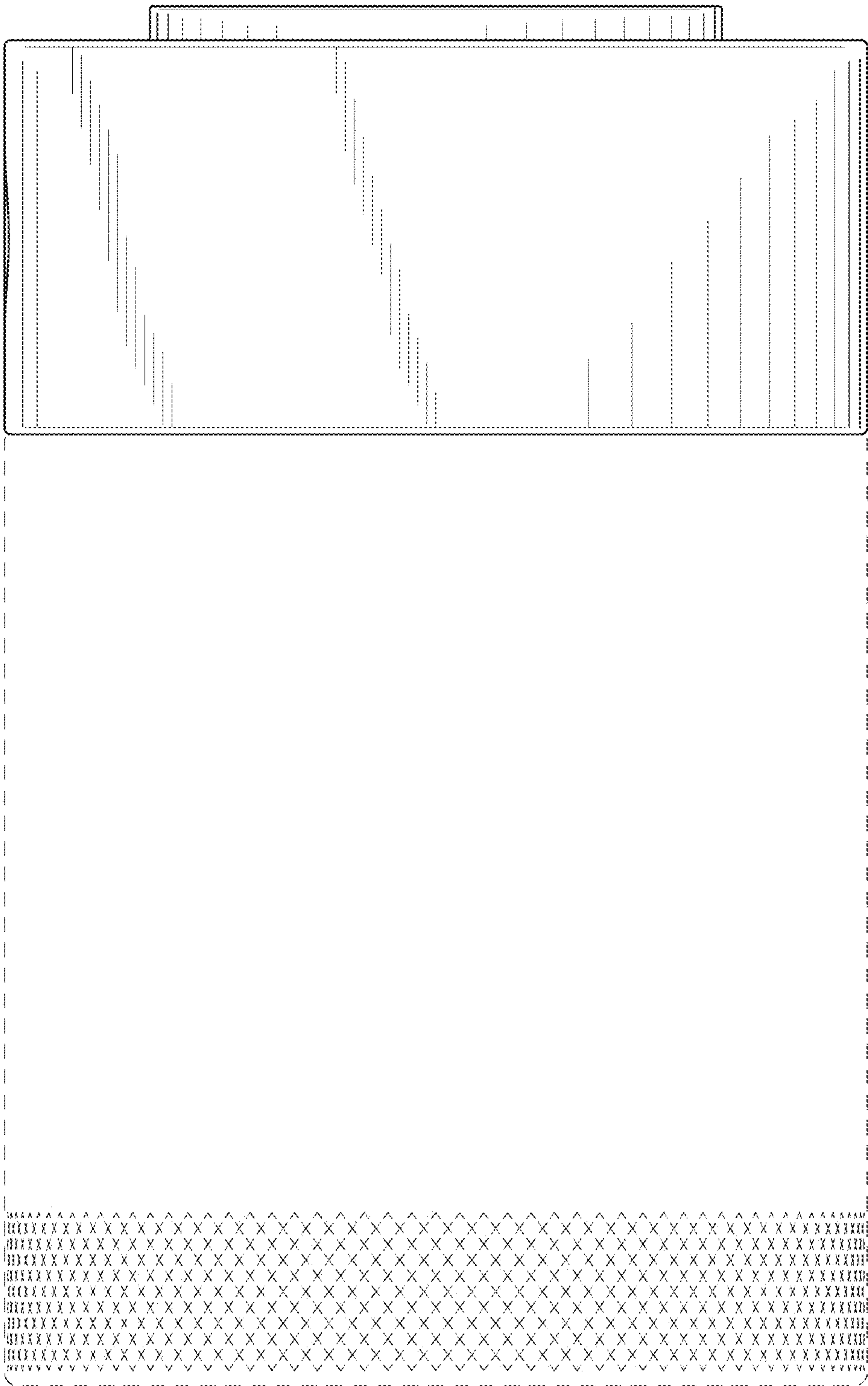

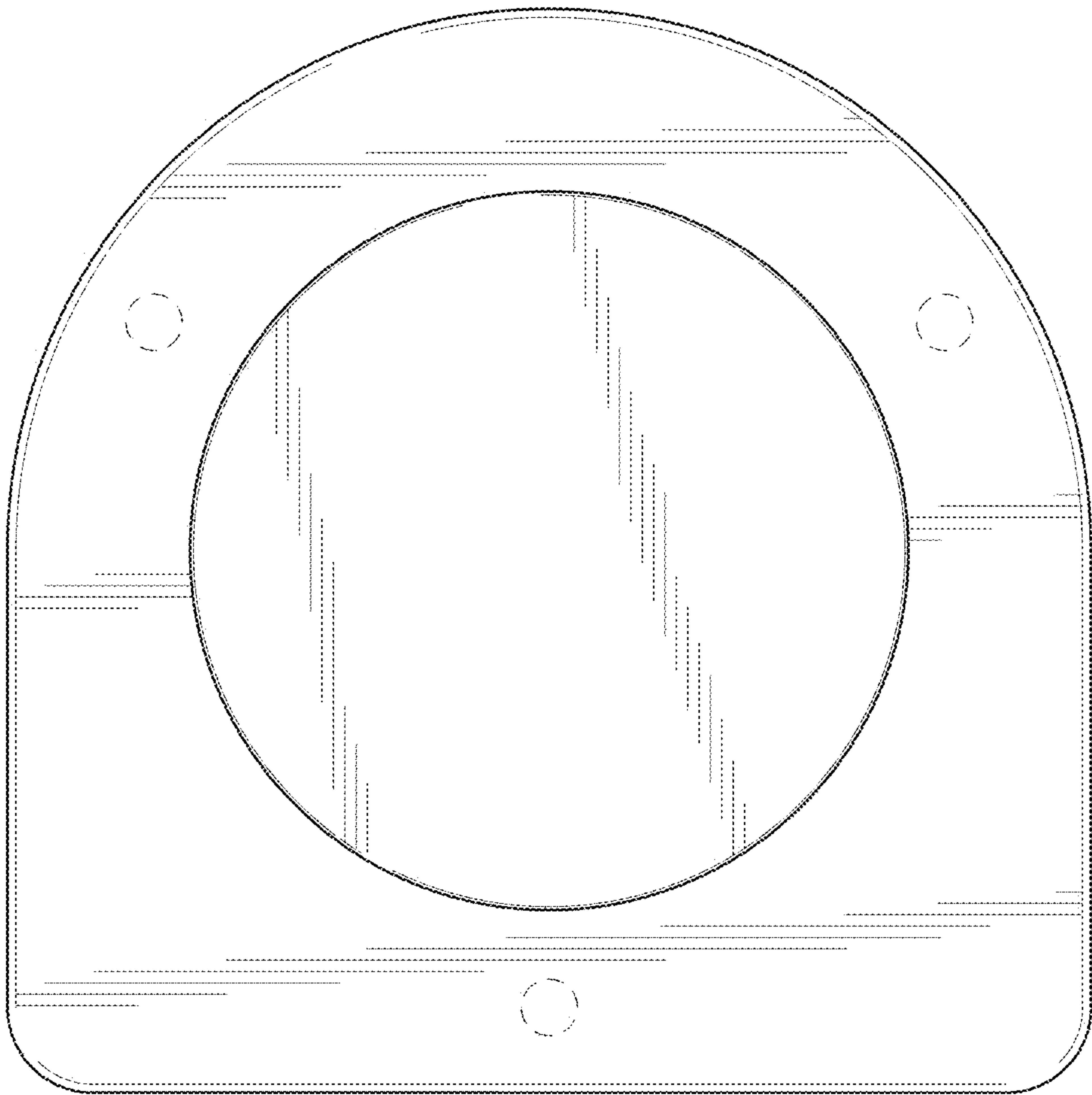

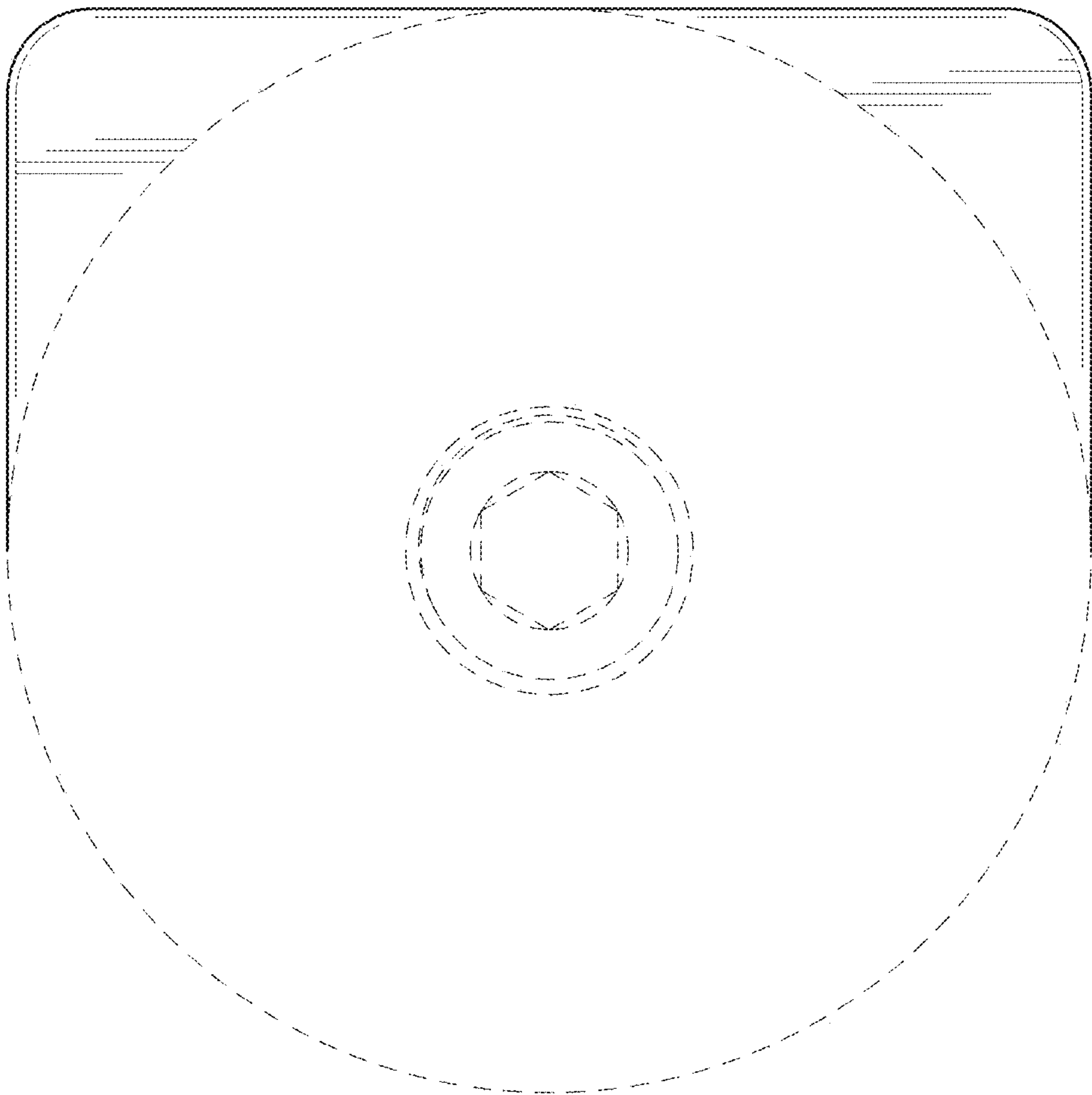
