(57) **CLAIM**

The ornamental design for a game controller, as shown and described.

DESCRIPTION

FIG. 1 is a top, right perspective view of a game controller; FIG. 2 is a bottom, left perspective view thereof; FIG. 3 is a top view thereof; FIG. 4 is a bottom view thereof; FIG. 5 is a left-side view thereof; FIG. 6 is a right-side view thereof; FIG. 7 is a front view thereof; FIG. 8 is a back view thereof; and, FIG. 9 is a magnified portion of the claimed design as designated in FIG. 8.

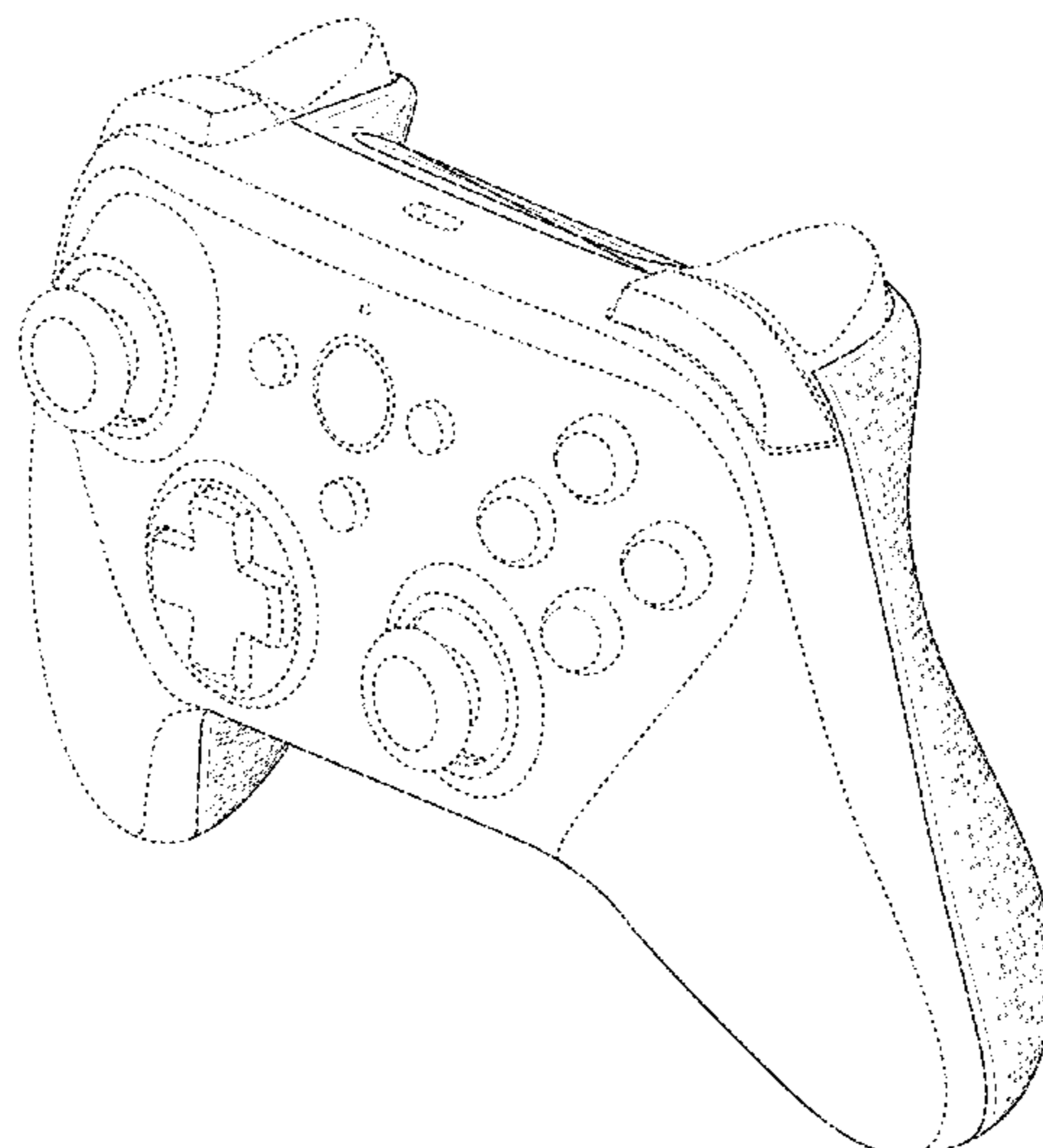
The raised features repent a stippled texture which is distributed over the surface of the claimed design upon which the texture occurs.

The evenly dashed broken lines showing of a game controller depict environmental structure that form no part of the claimed design. The long-short broken lines depict bounds of the magnified portion and form no part of the claimed design.

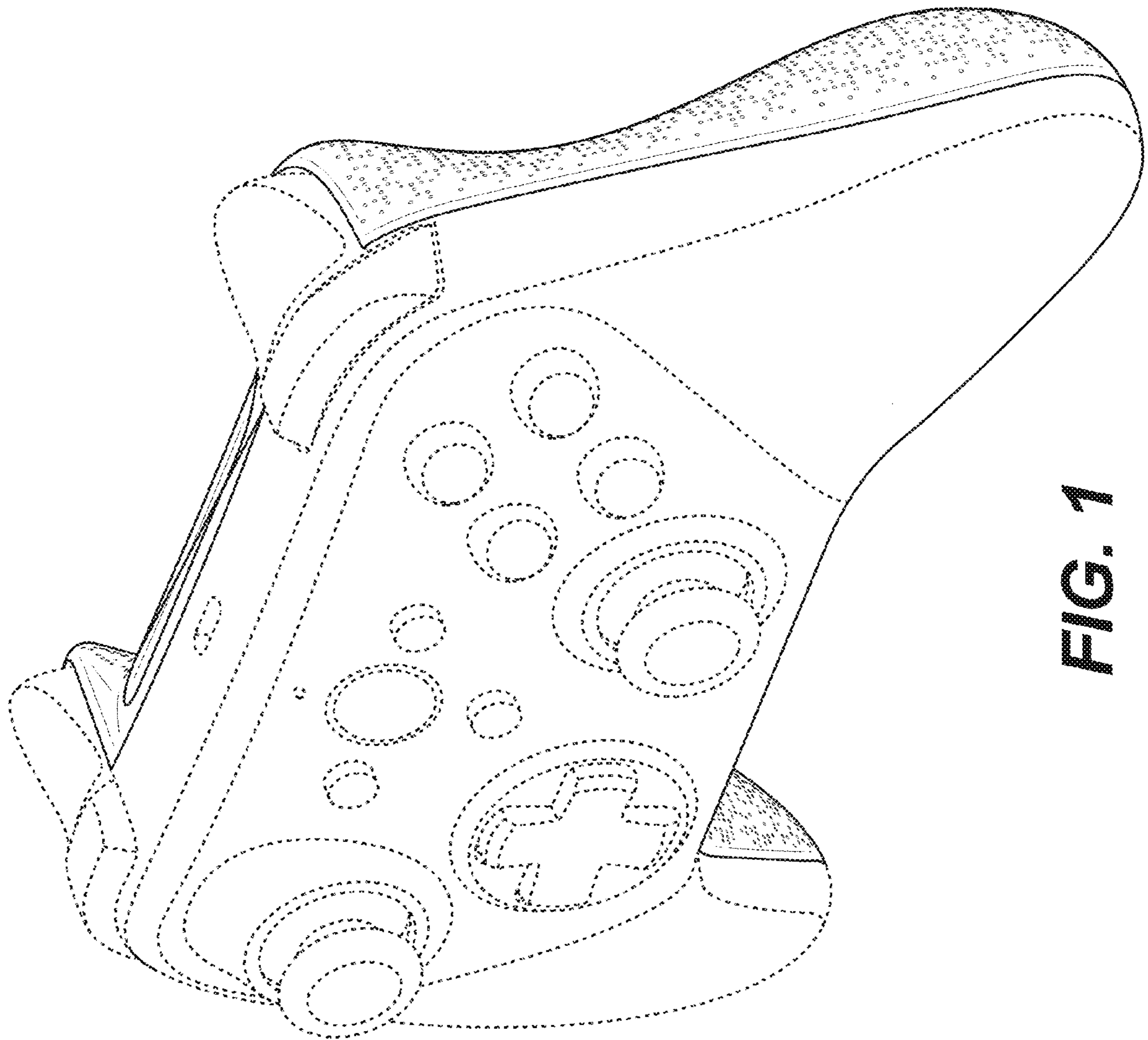

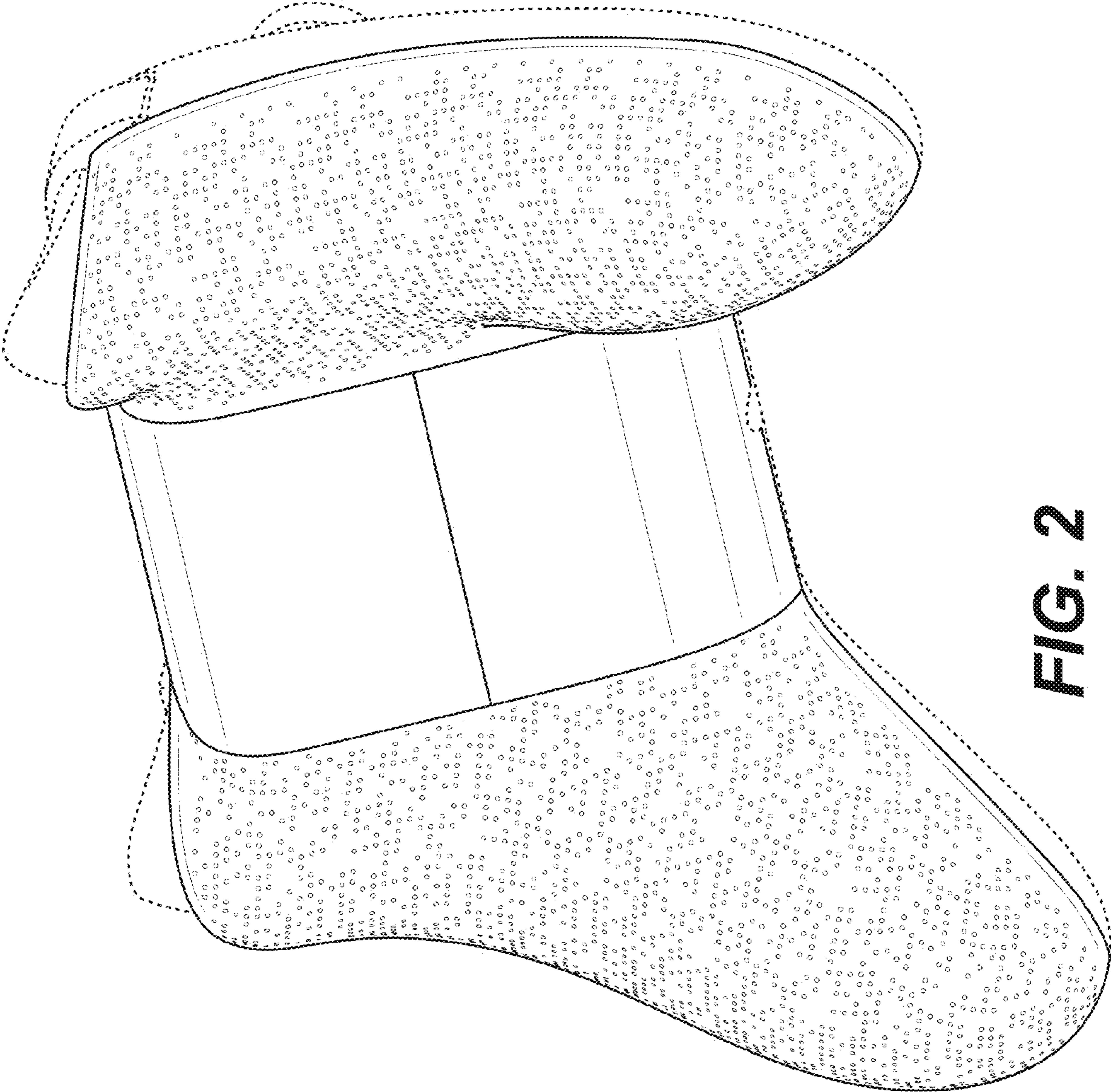

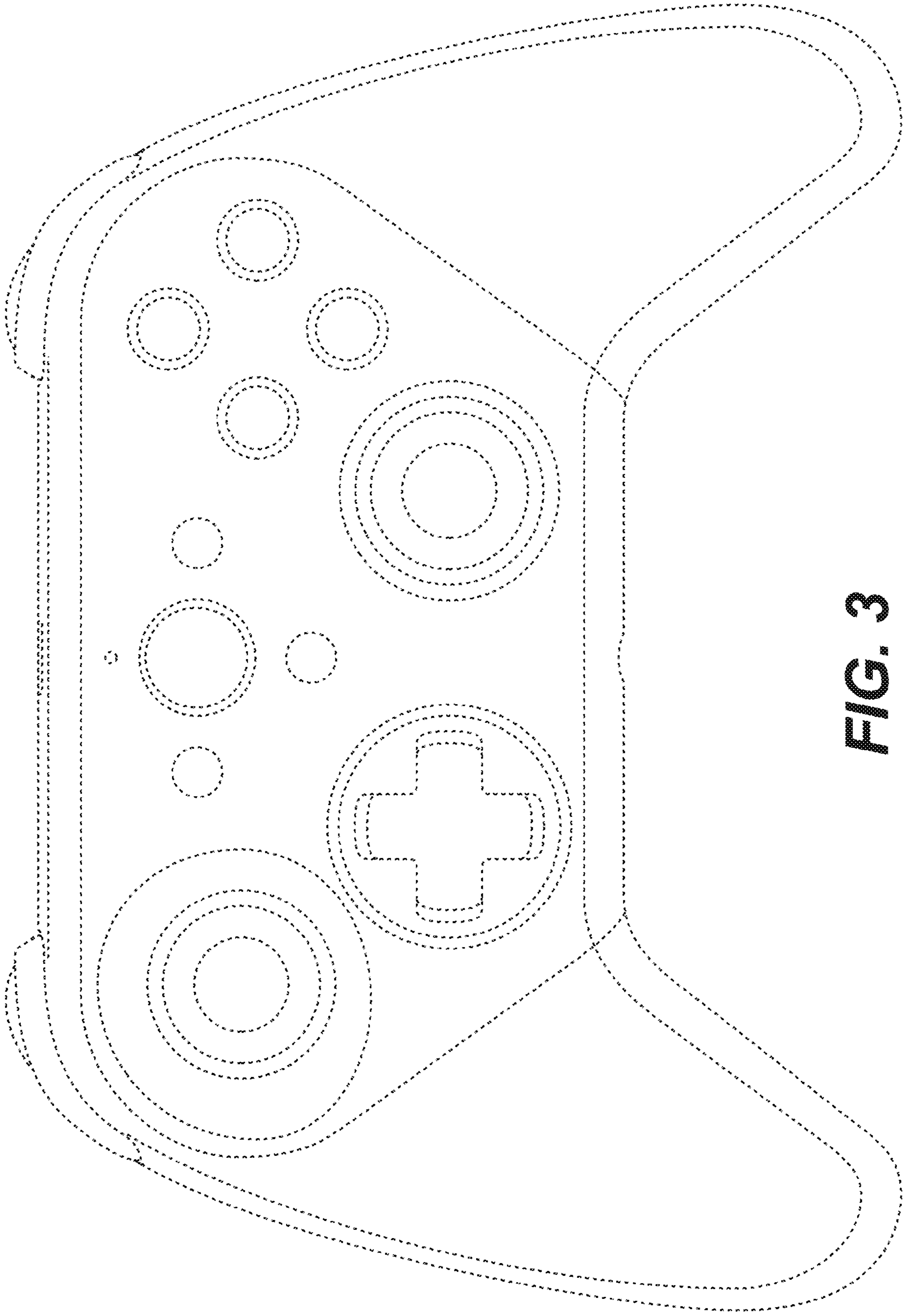

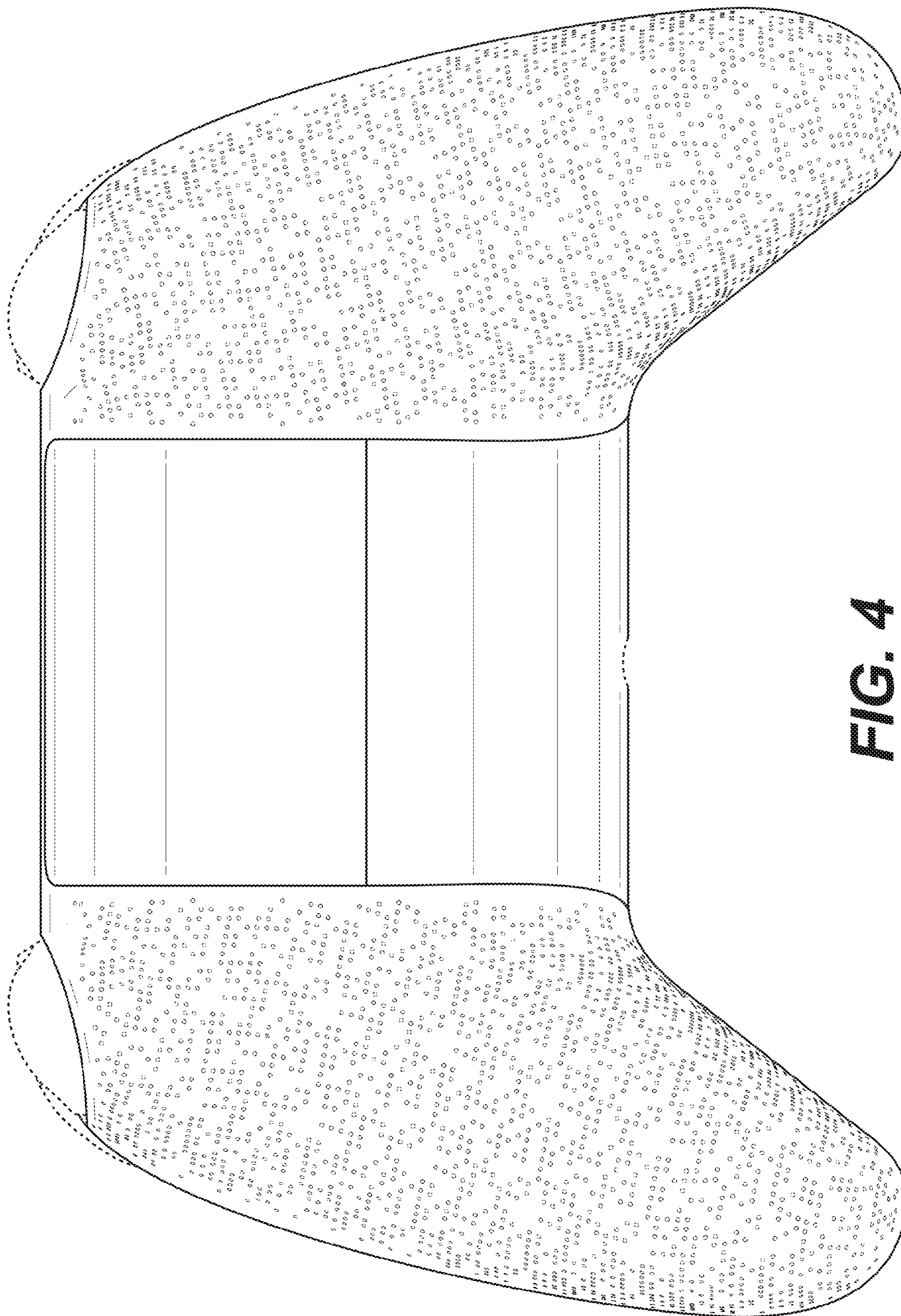

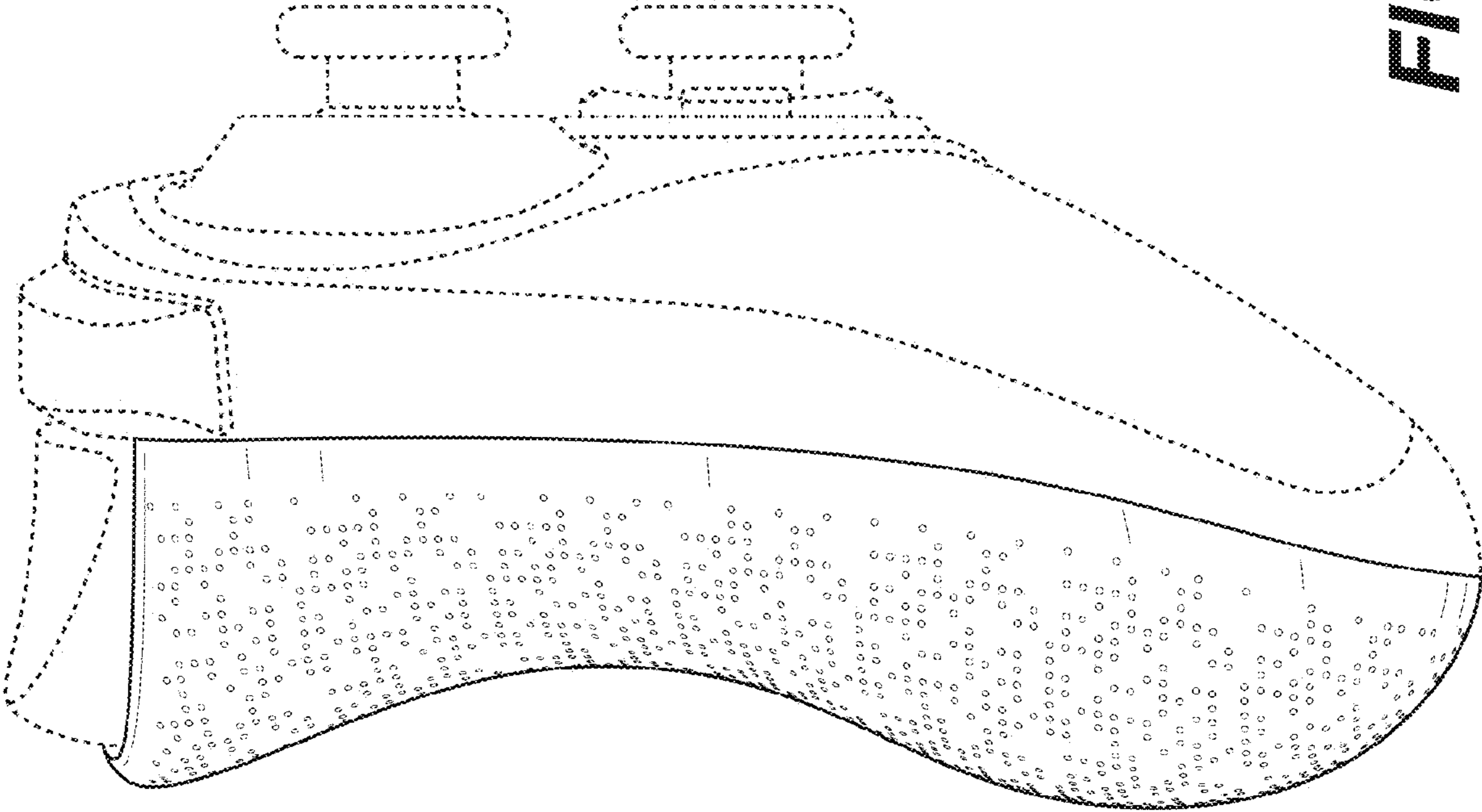

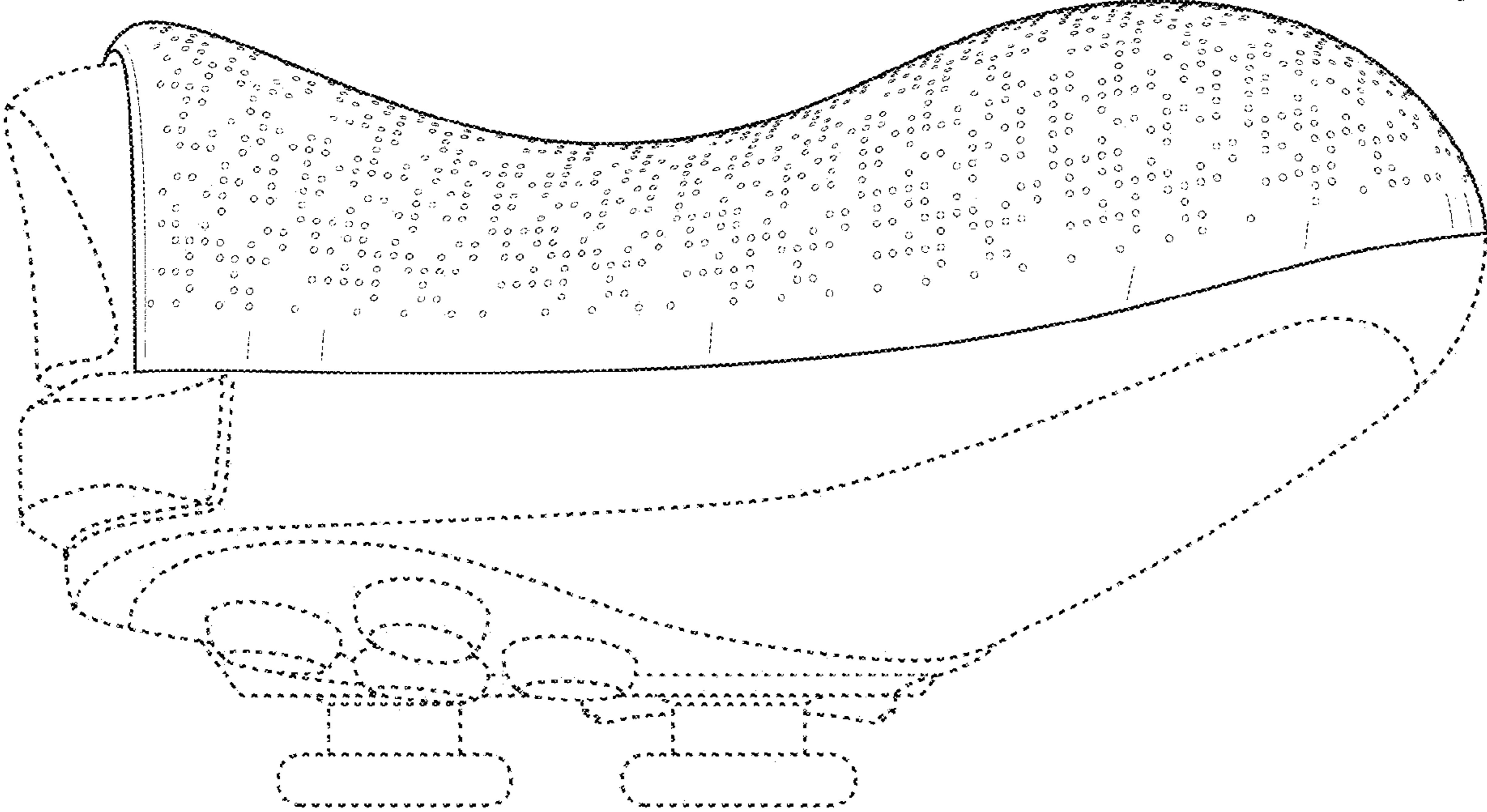

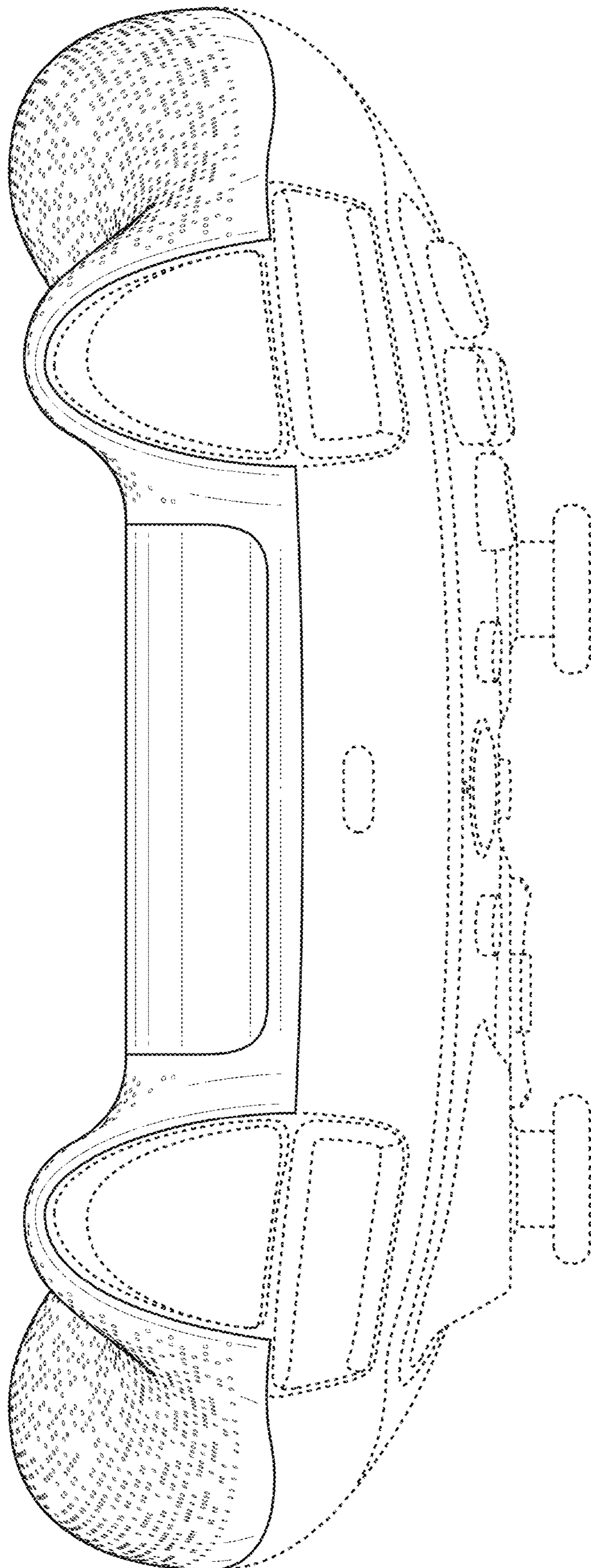

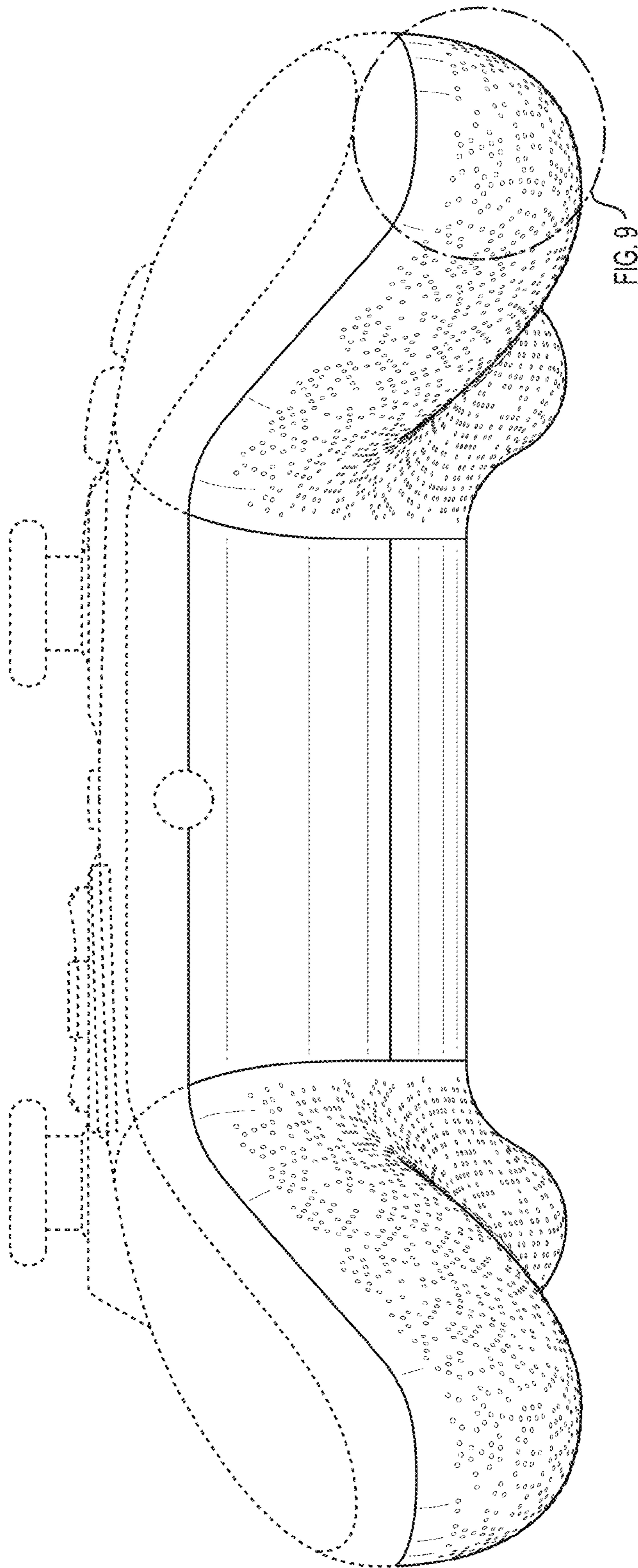

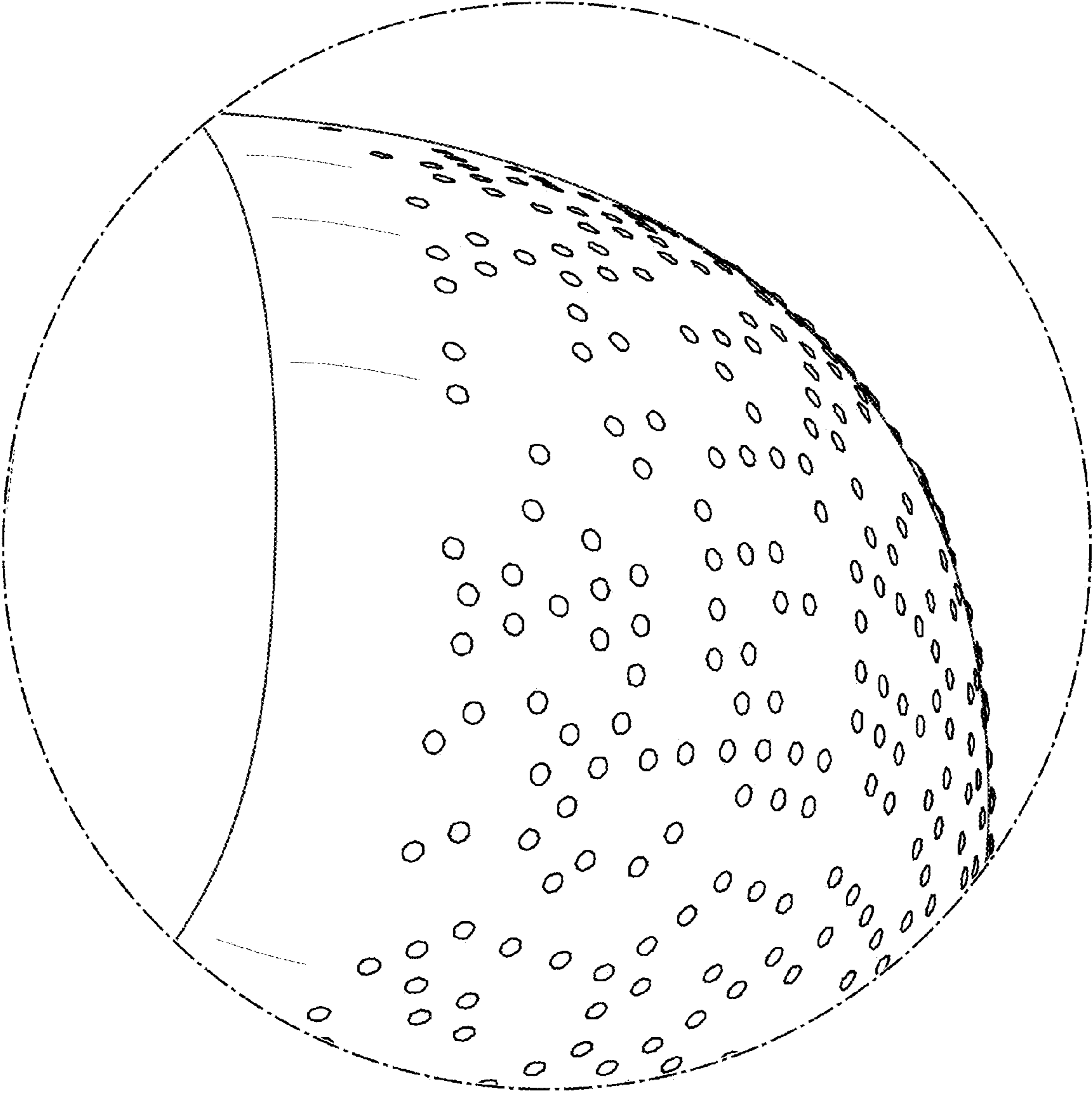
