FIG. 16 is a top rear perspective view thereof.

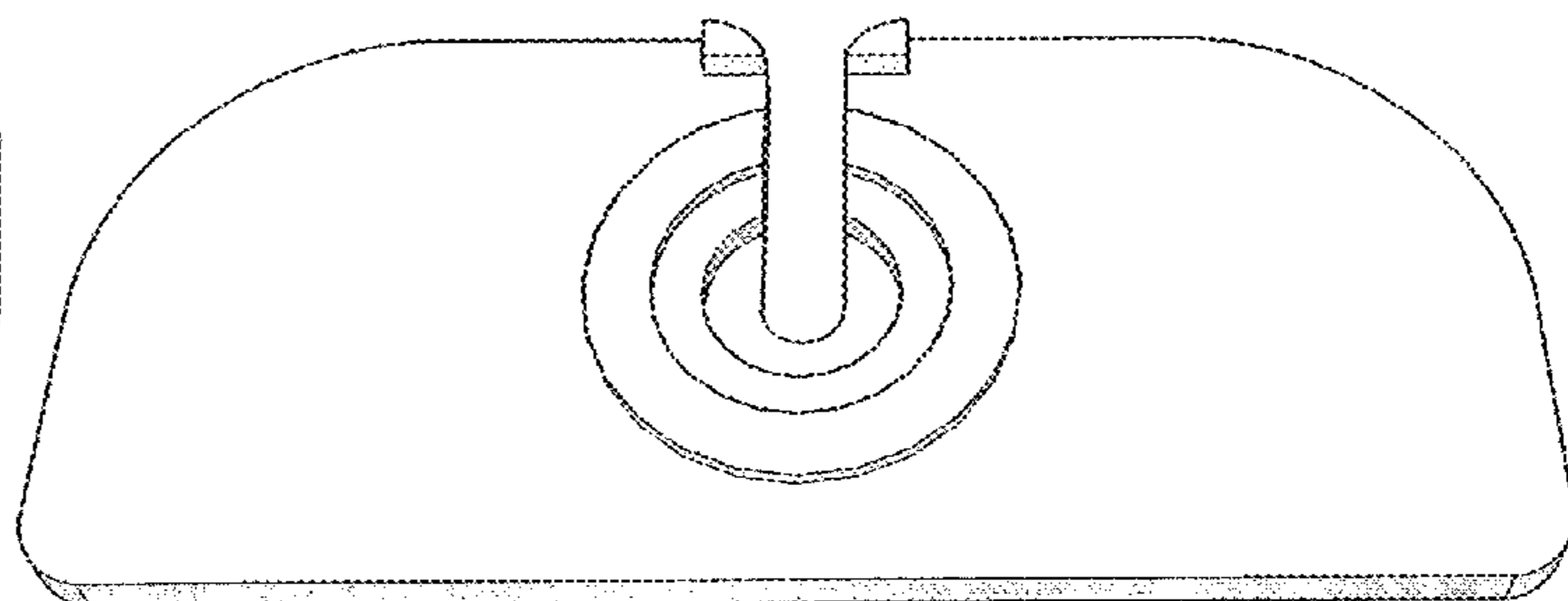
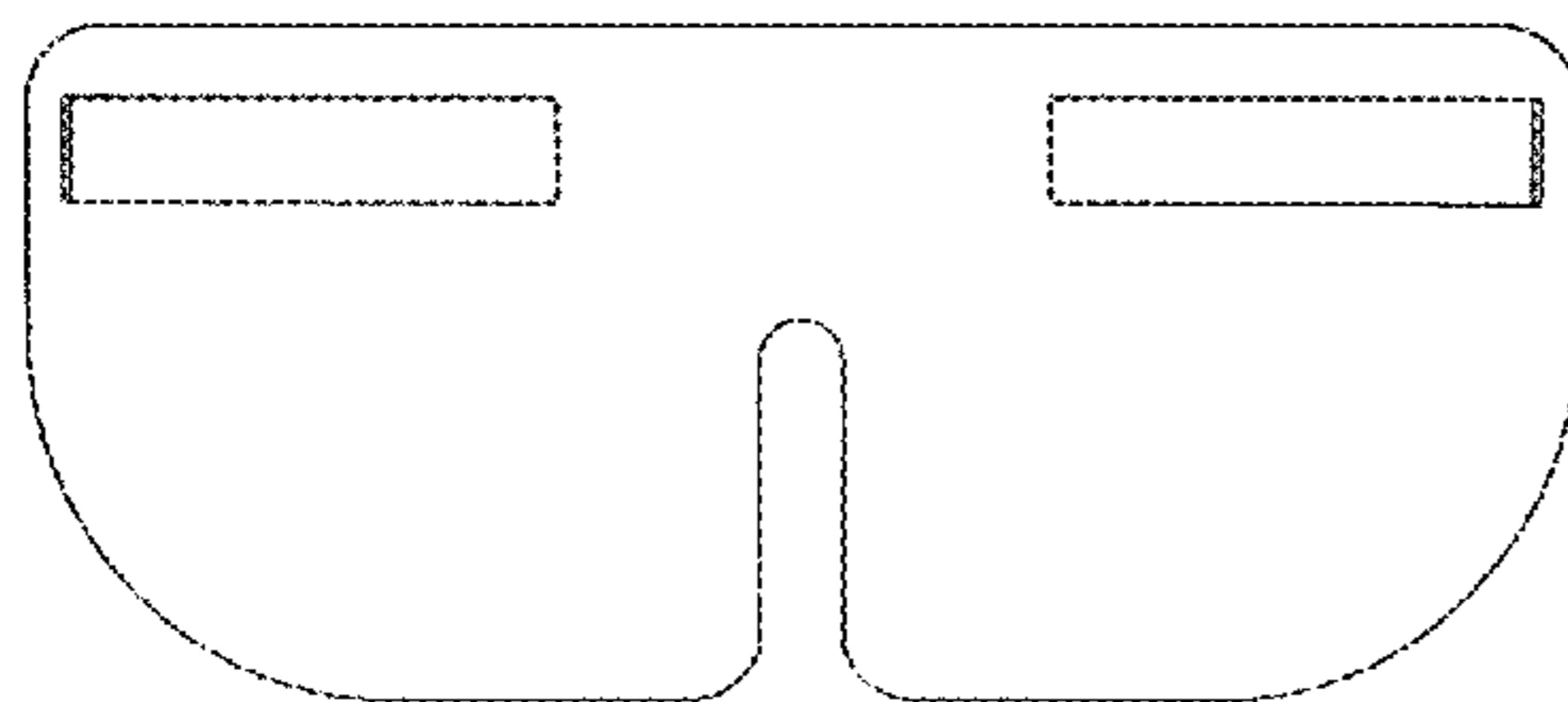

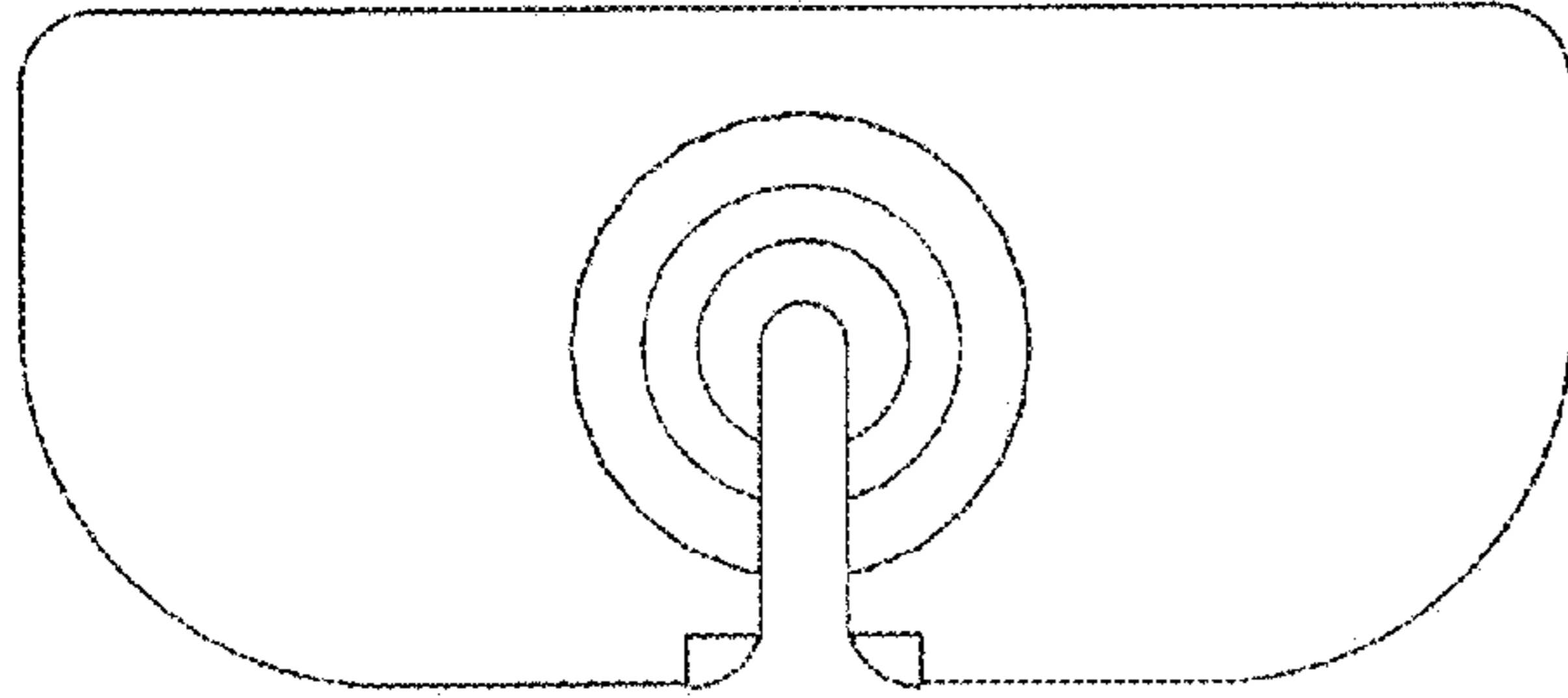

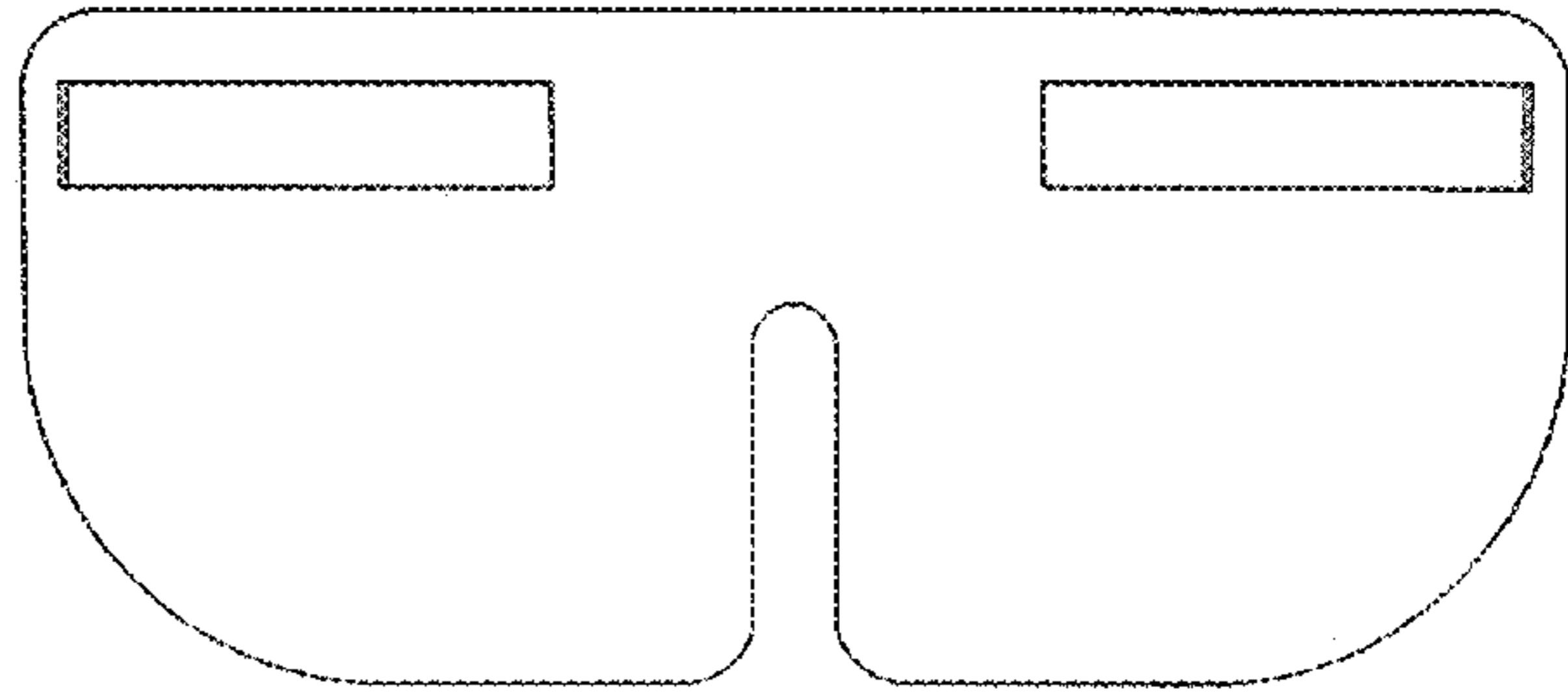

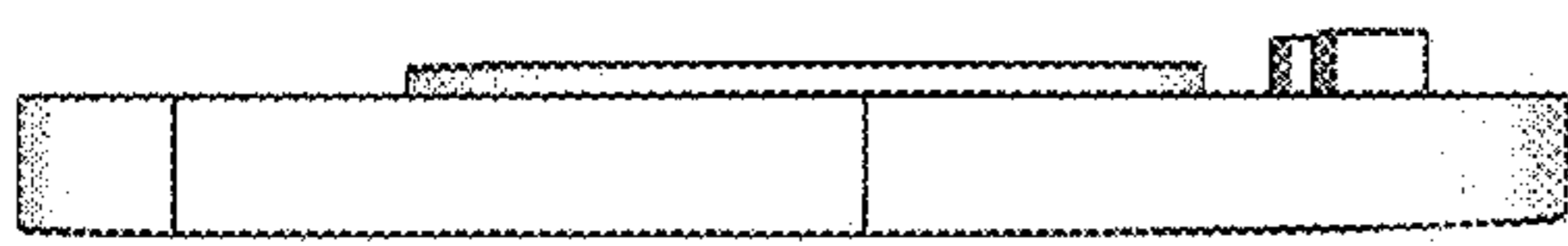

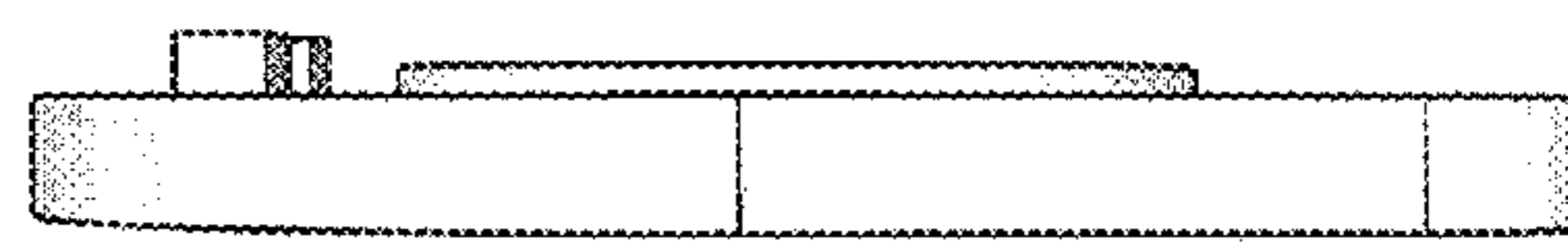

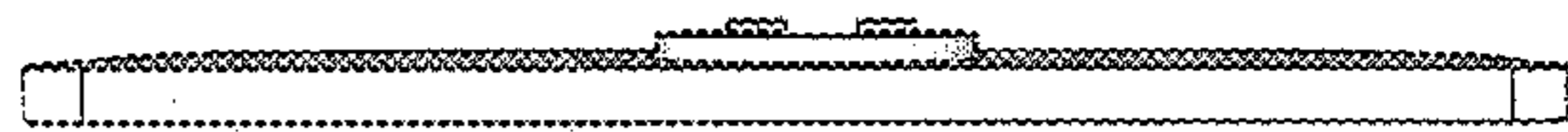

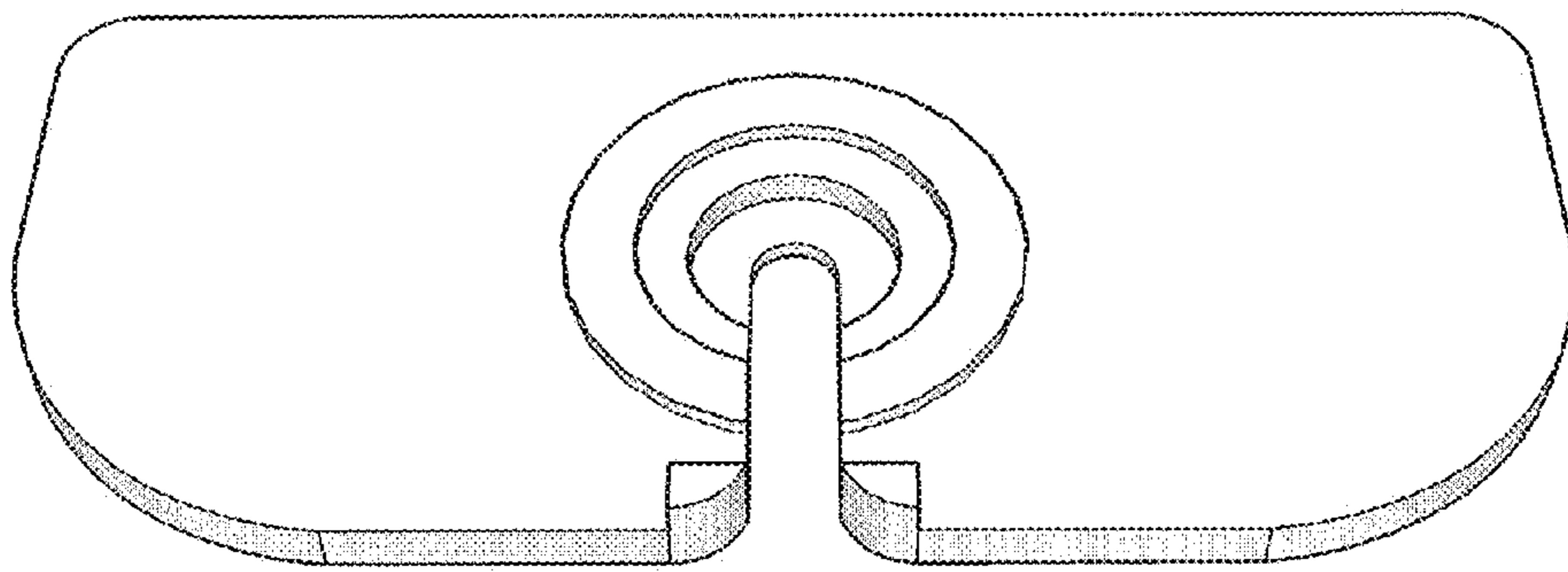

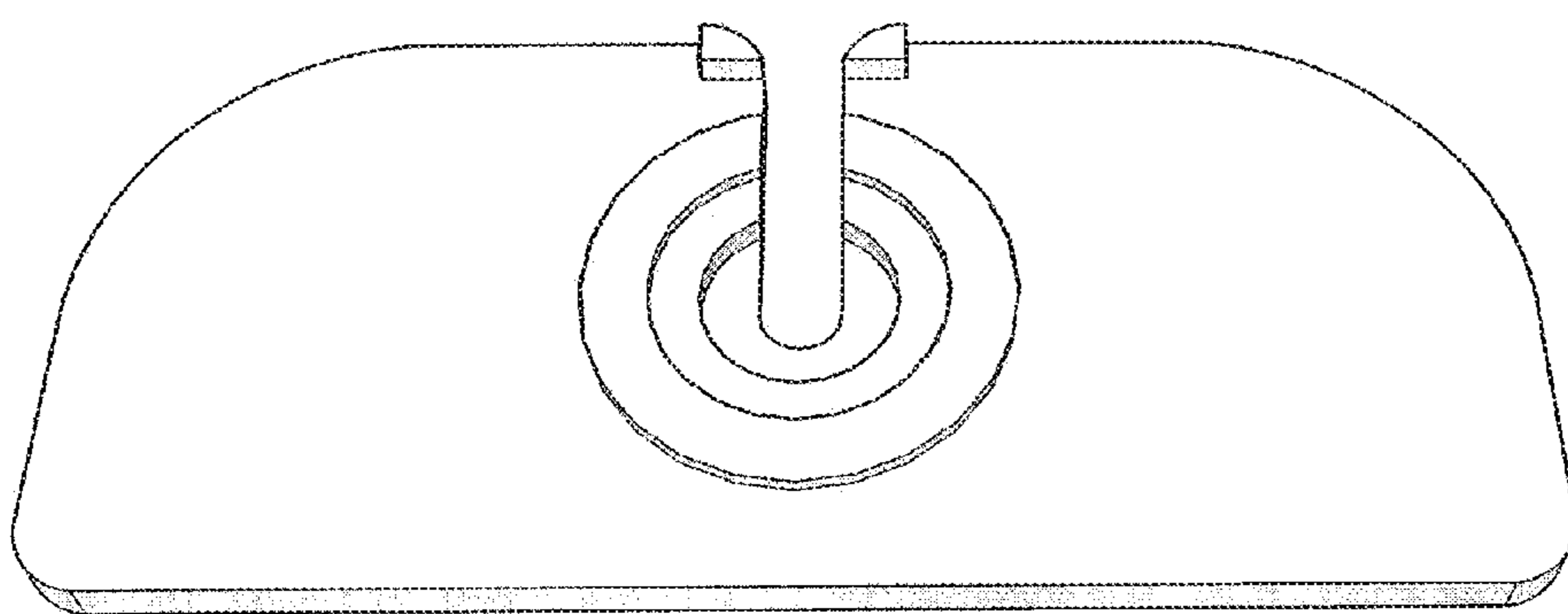

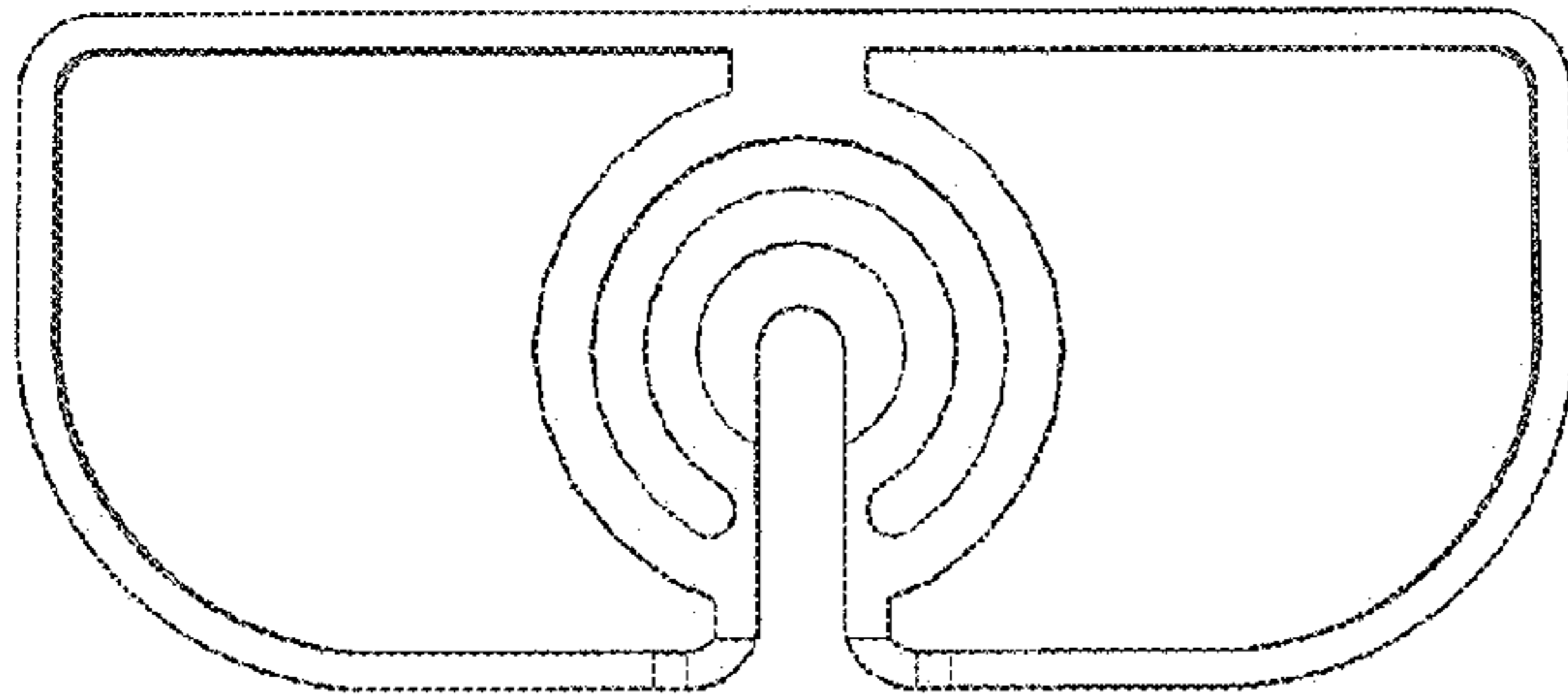

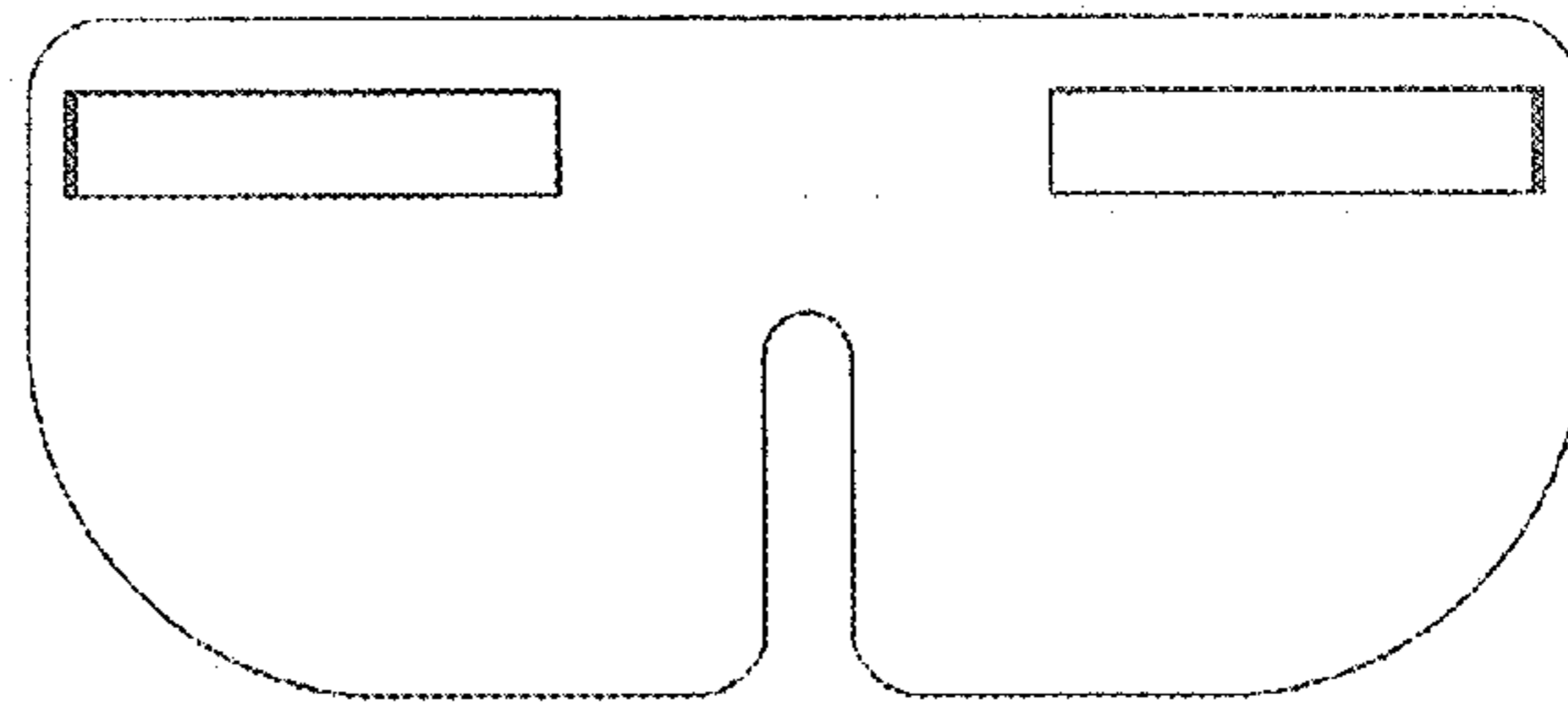

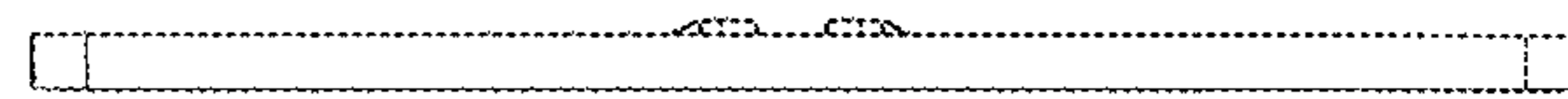

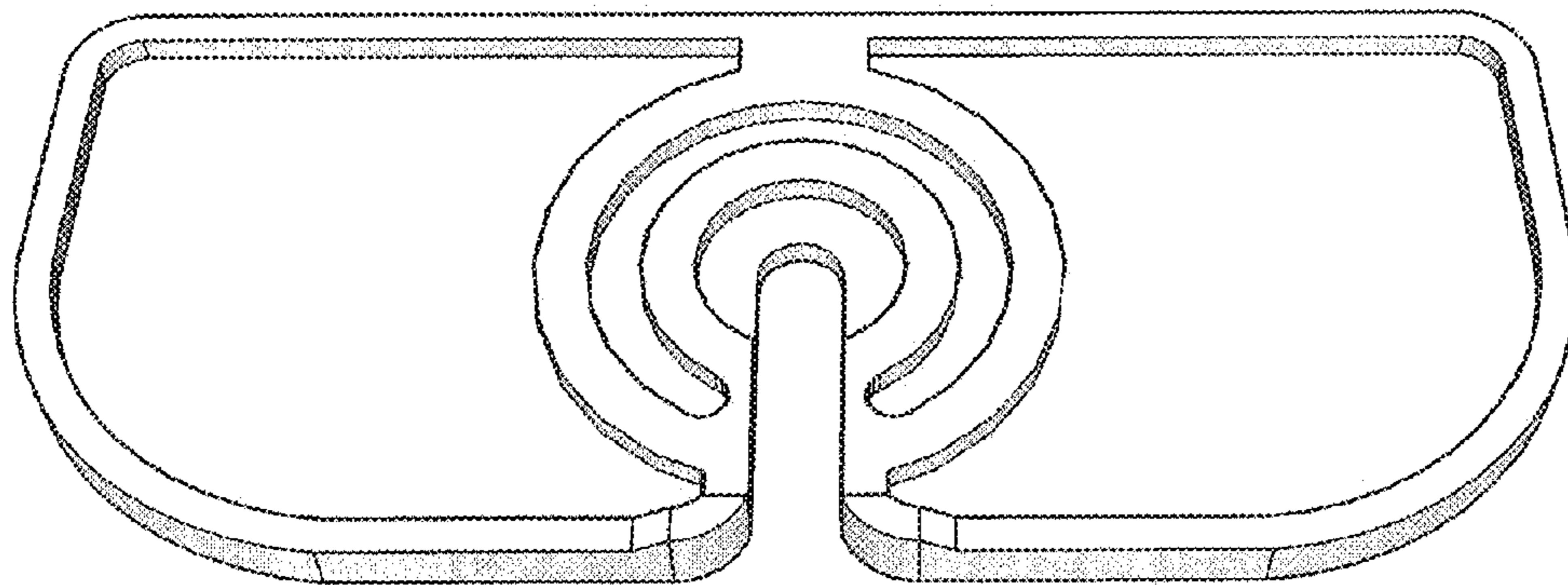
