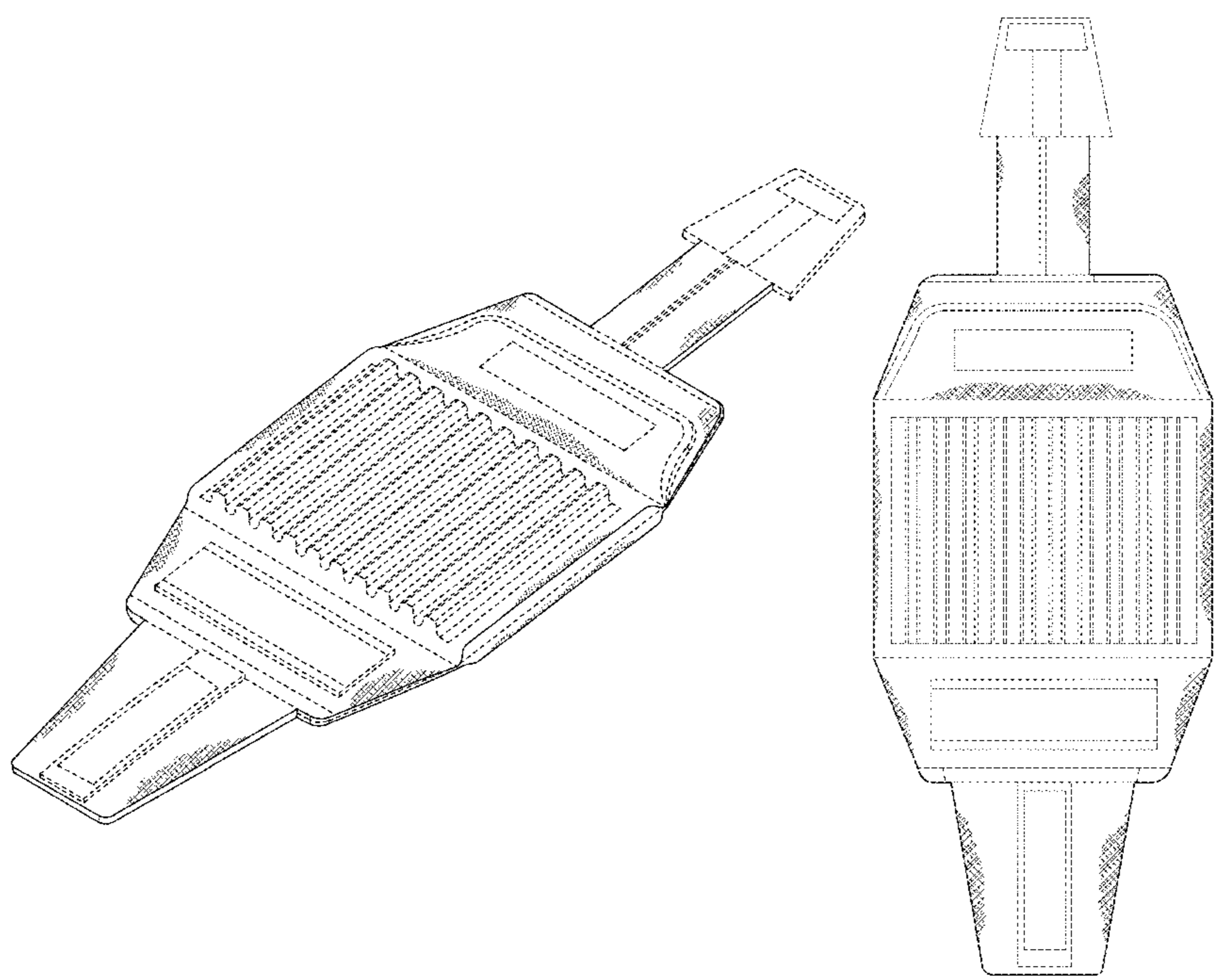

(57) **CLAIM**
I claim the ornamental design for a dumbbell thigh pad, as shown and described.

DESCRIPTION
FIG. 1 is a top perspective view of a dumbbell thigh pad showing my new design.
FIG. 2 is a front view thereof.
FIG. 3 is a rear view thereof.
FIG. 4 is a left side view thereof.
FIG. 5 is a right side view thereof.
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.
The broken lines in the drawings depict portions of the dumbbell thigh pad that form no part of the claimed design.

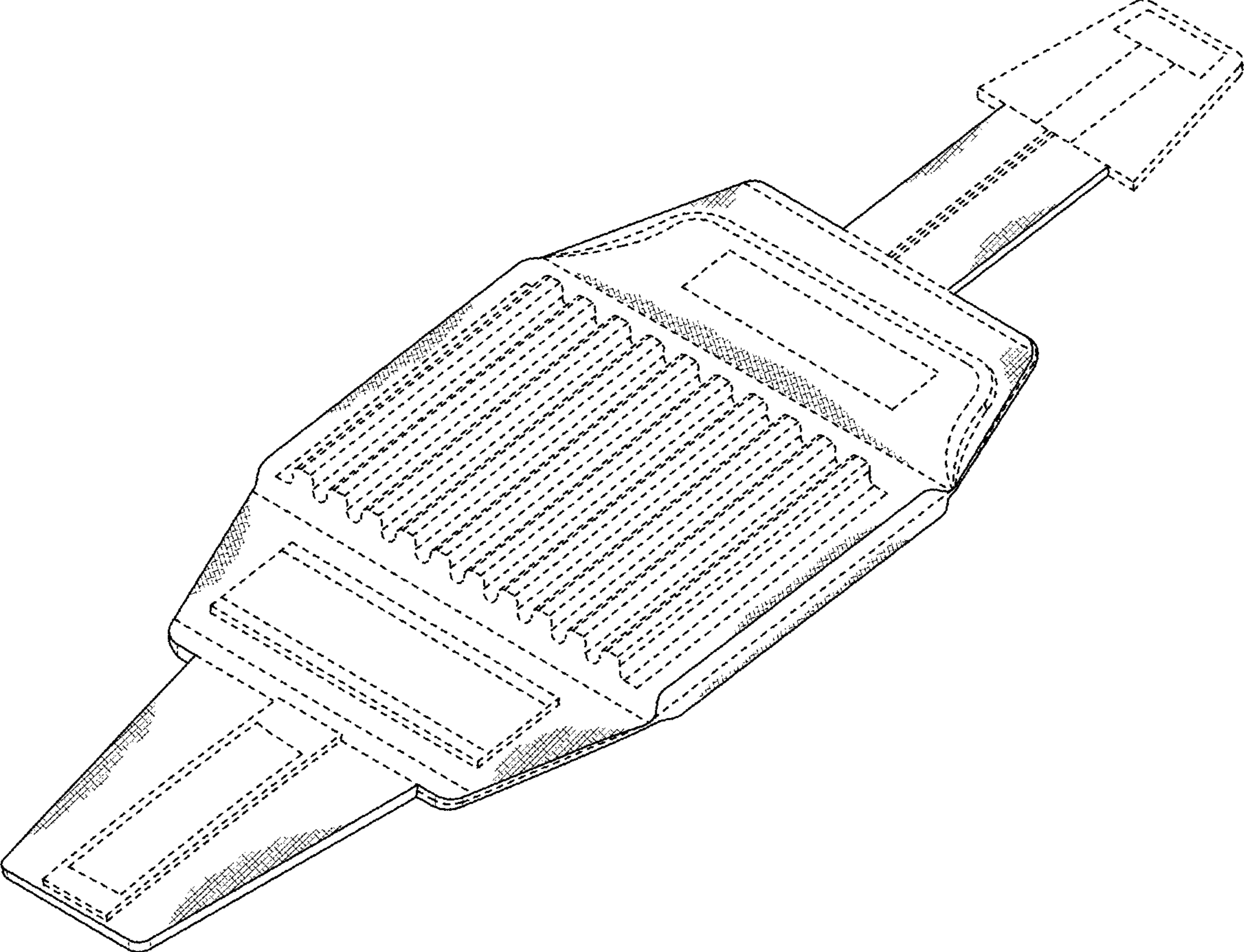

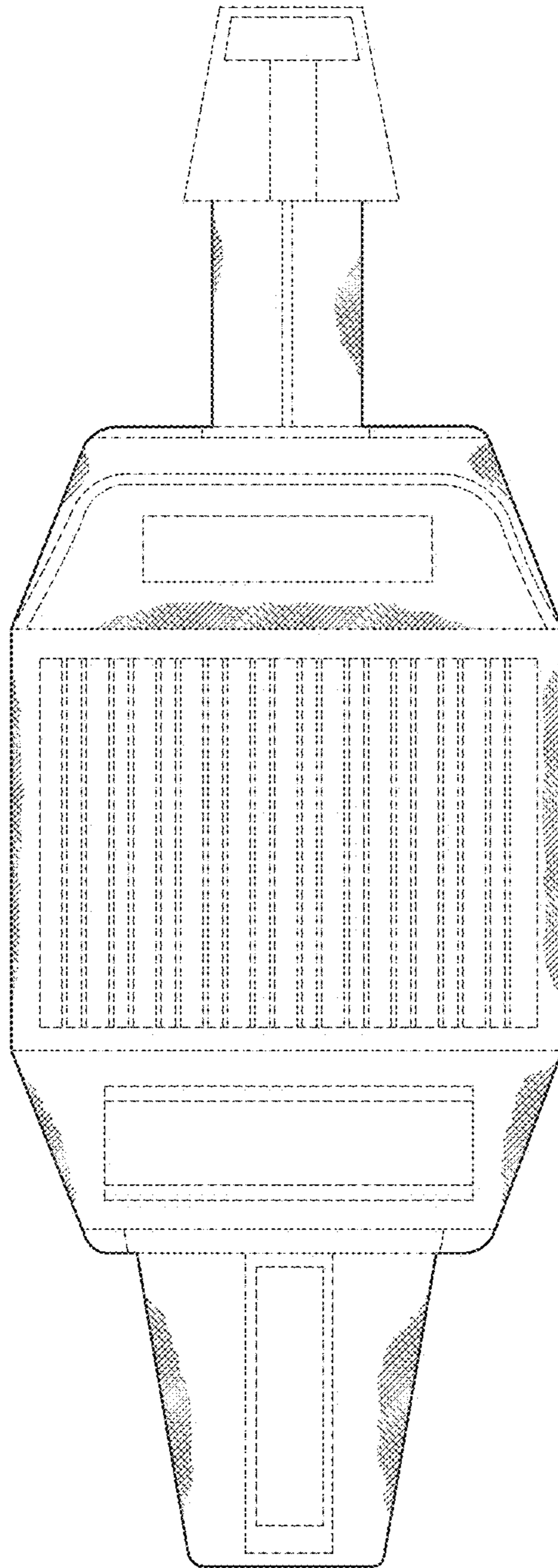

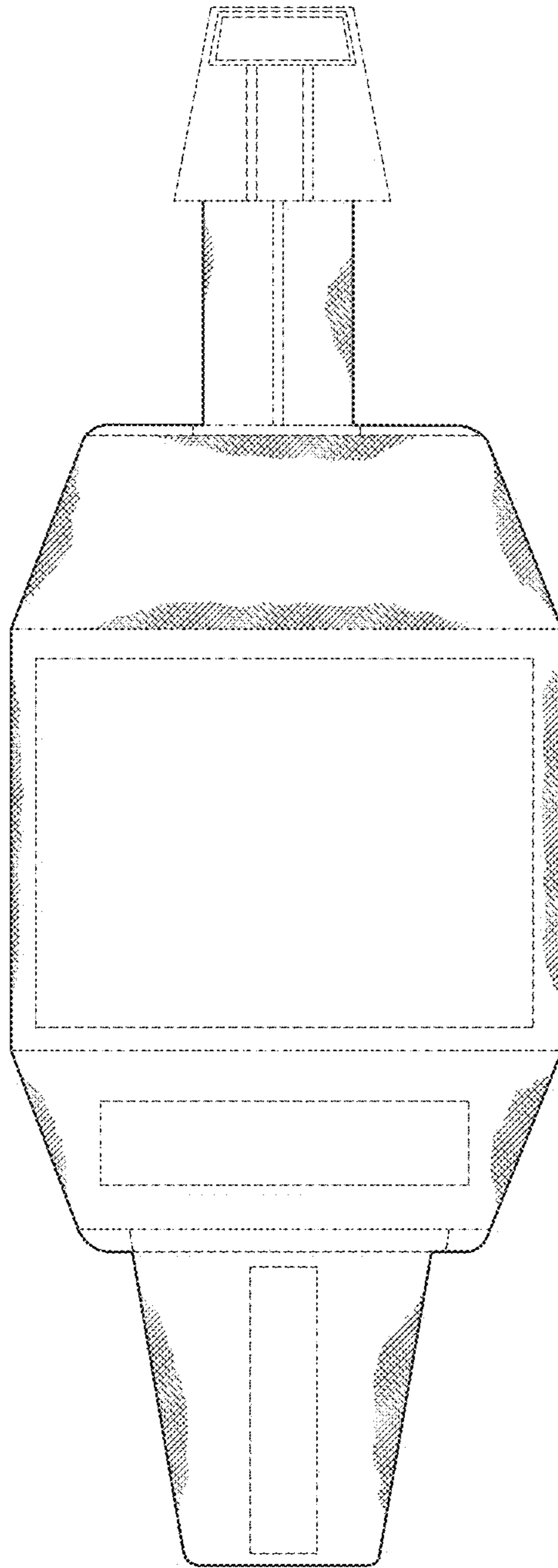

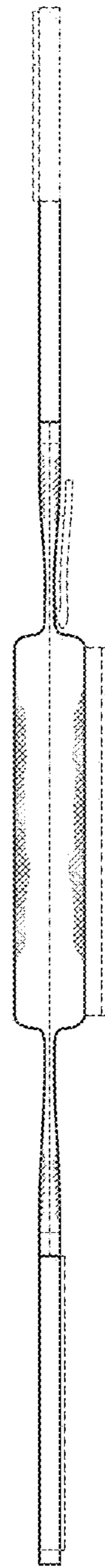

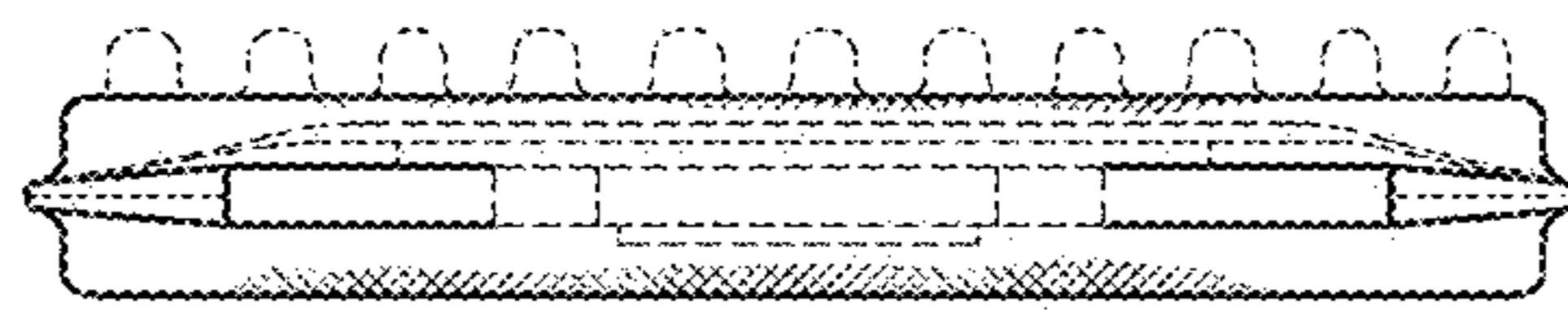
