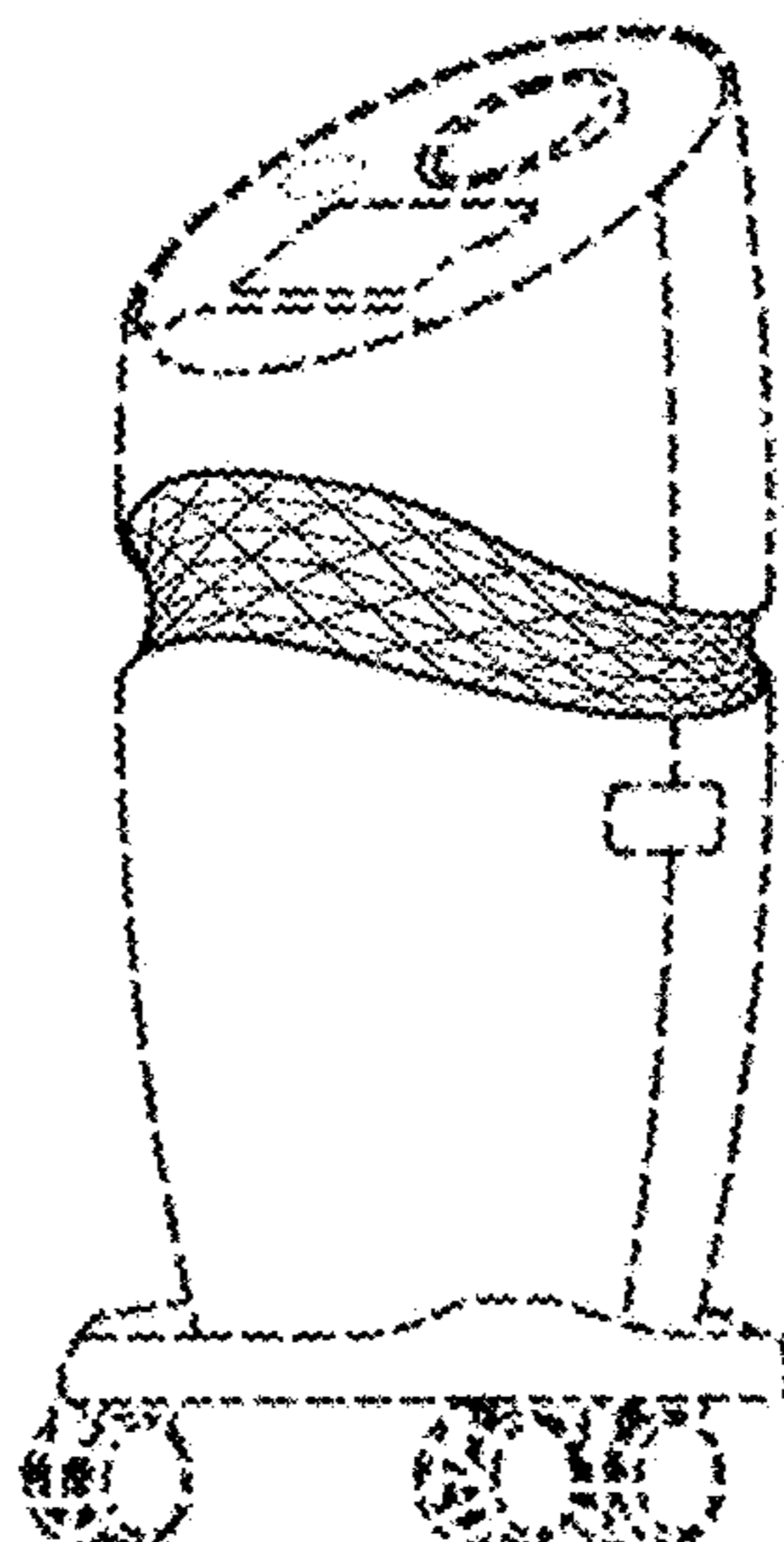
The ornamental design for a massage device, as shown and described.

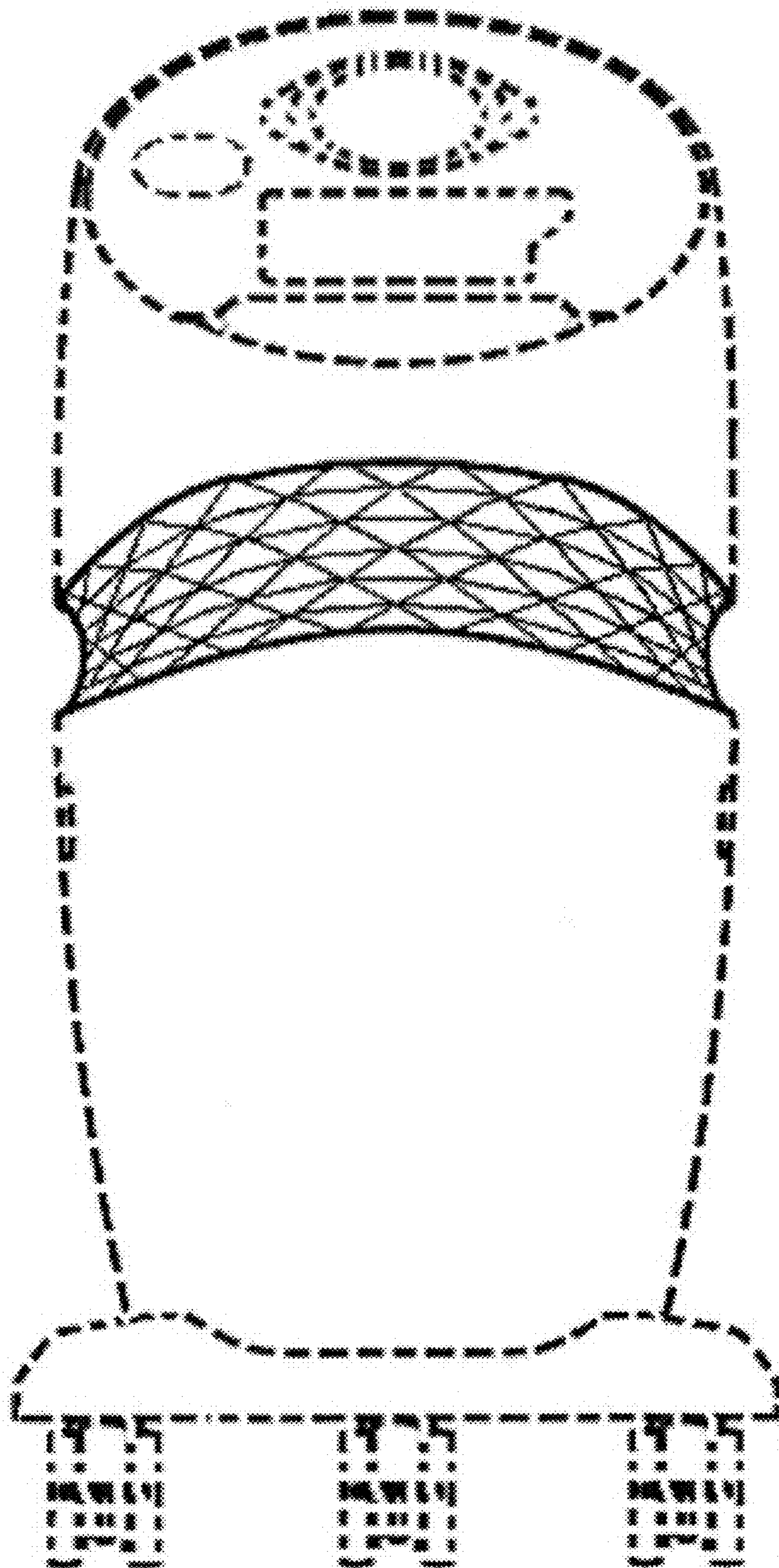

The broken lines in the reproductions disclose unclaimed subject matter only and form no part of the claimed design; The left view is a mirror image of the right view and it is not shown.

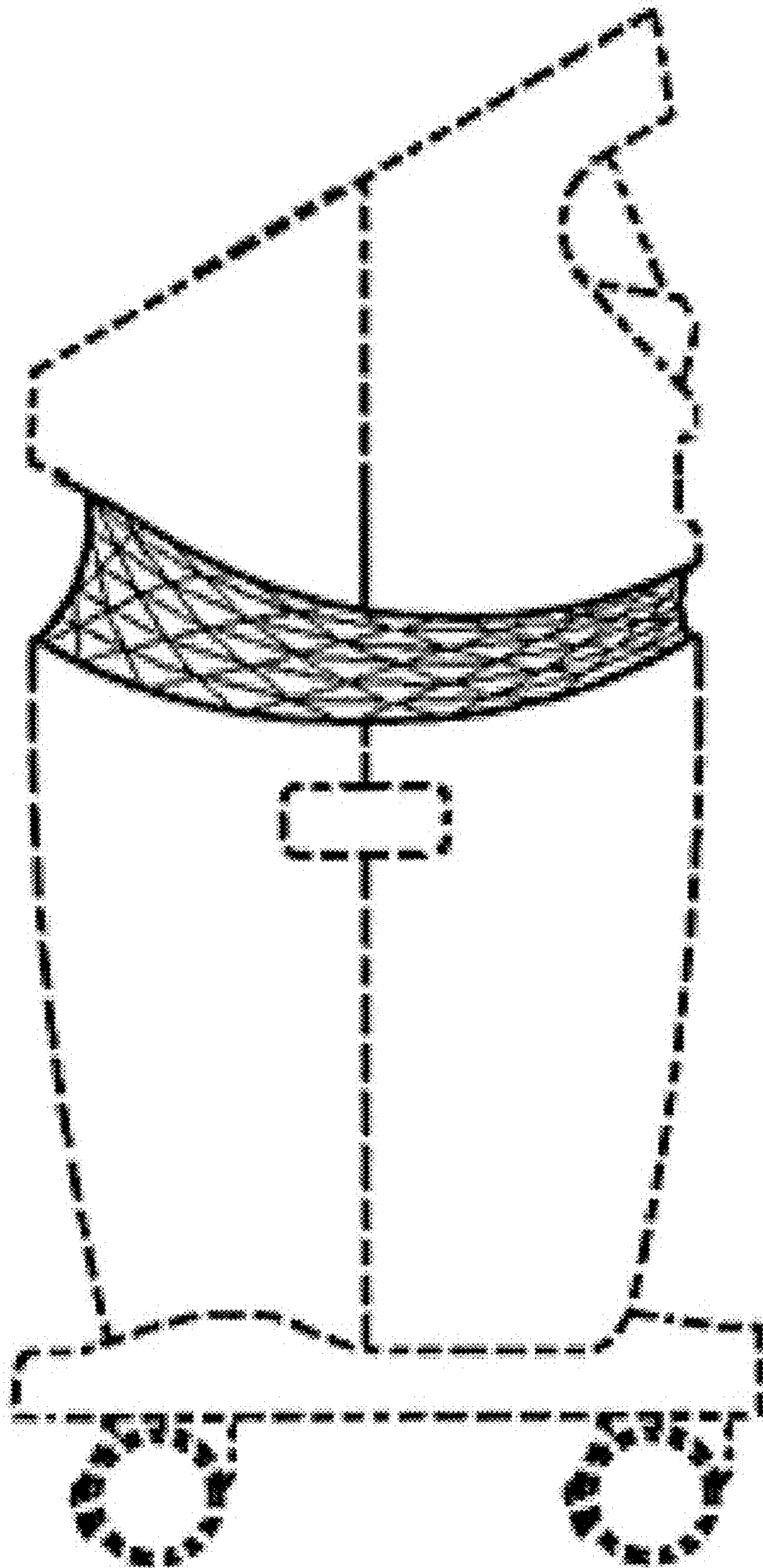

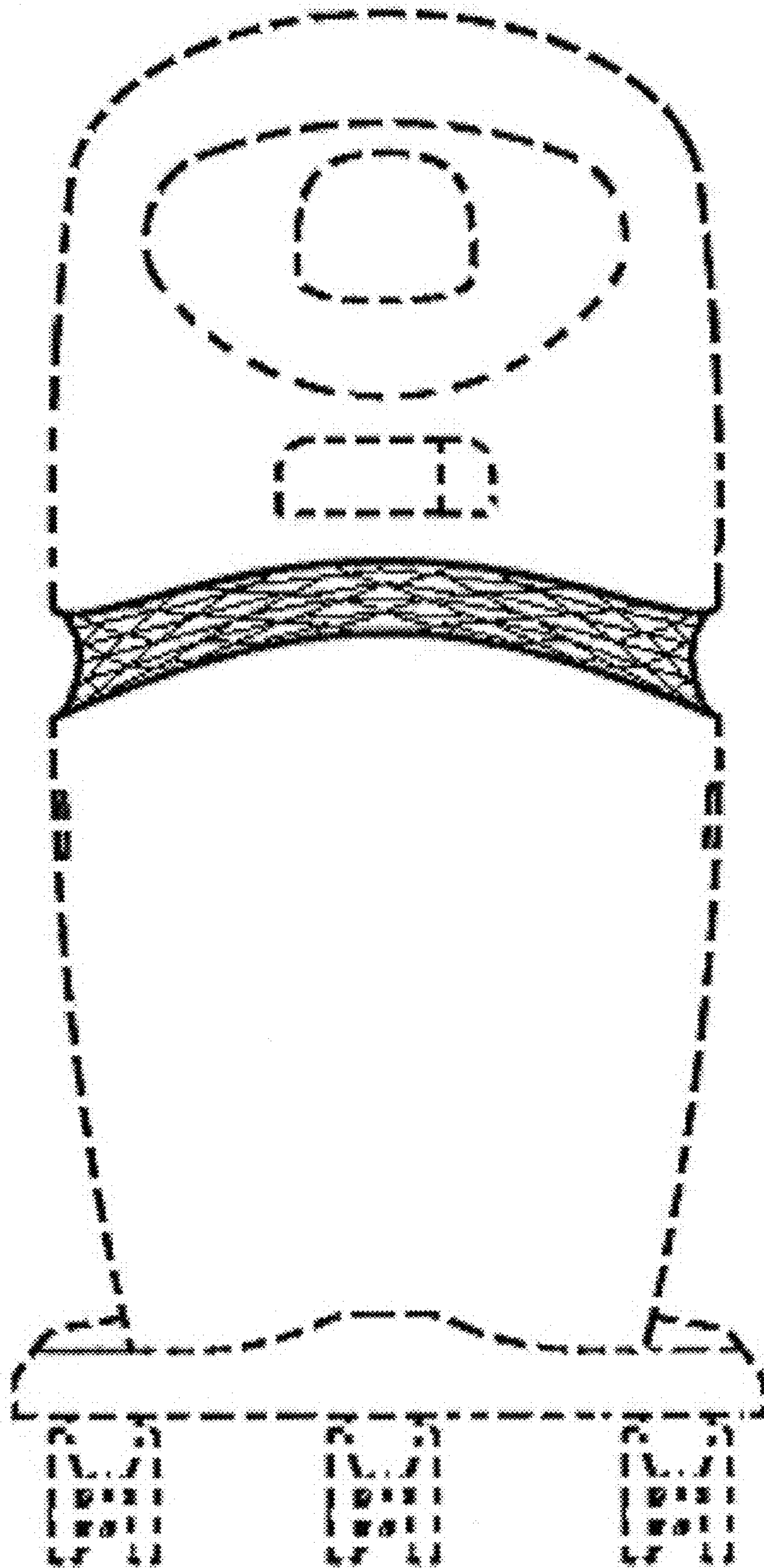

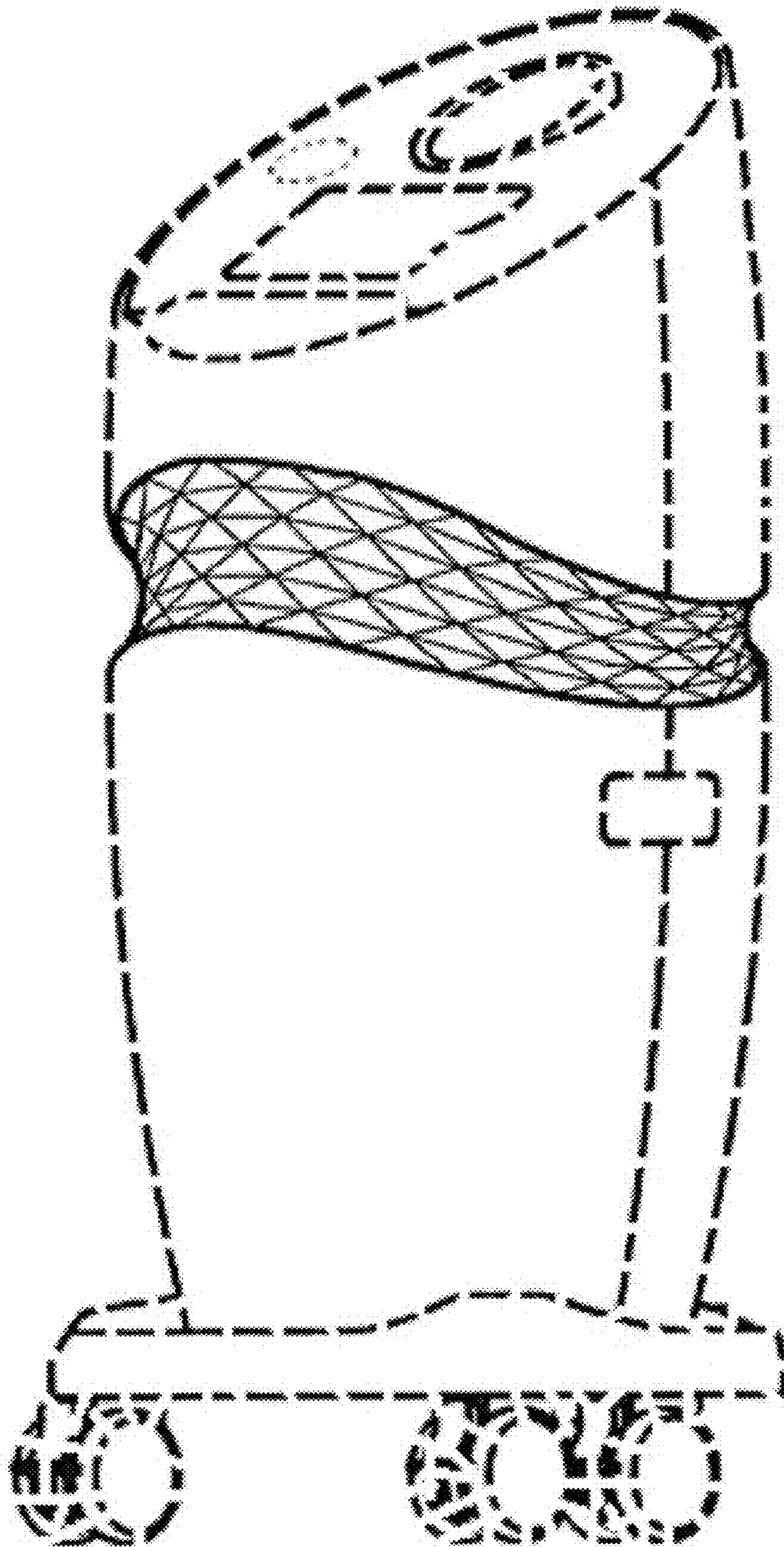

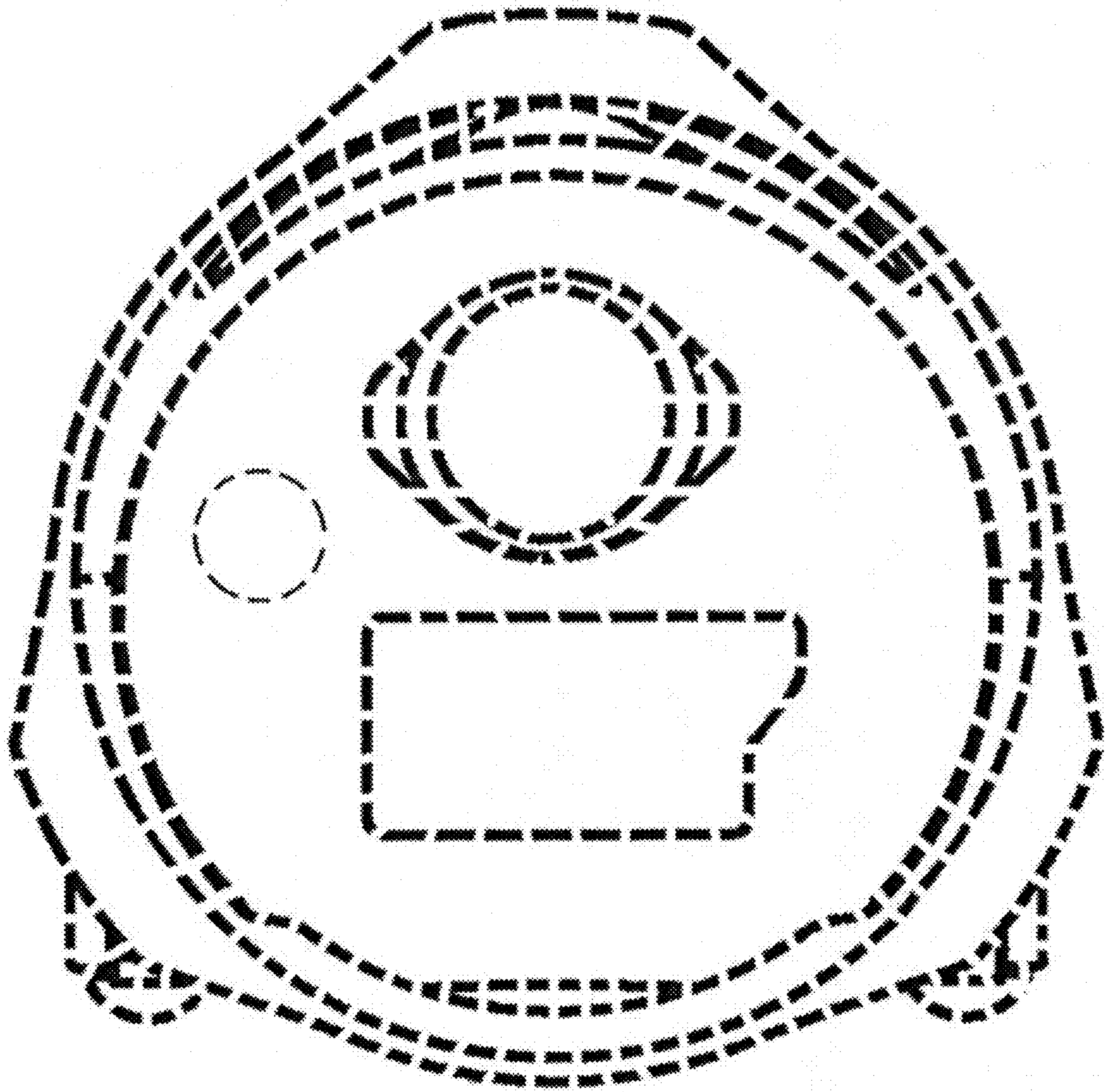
