DESCRIPTION

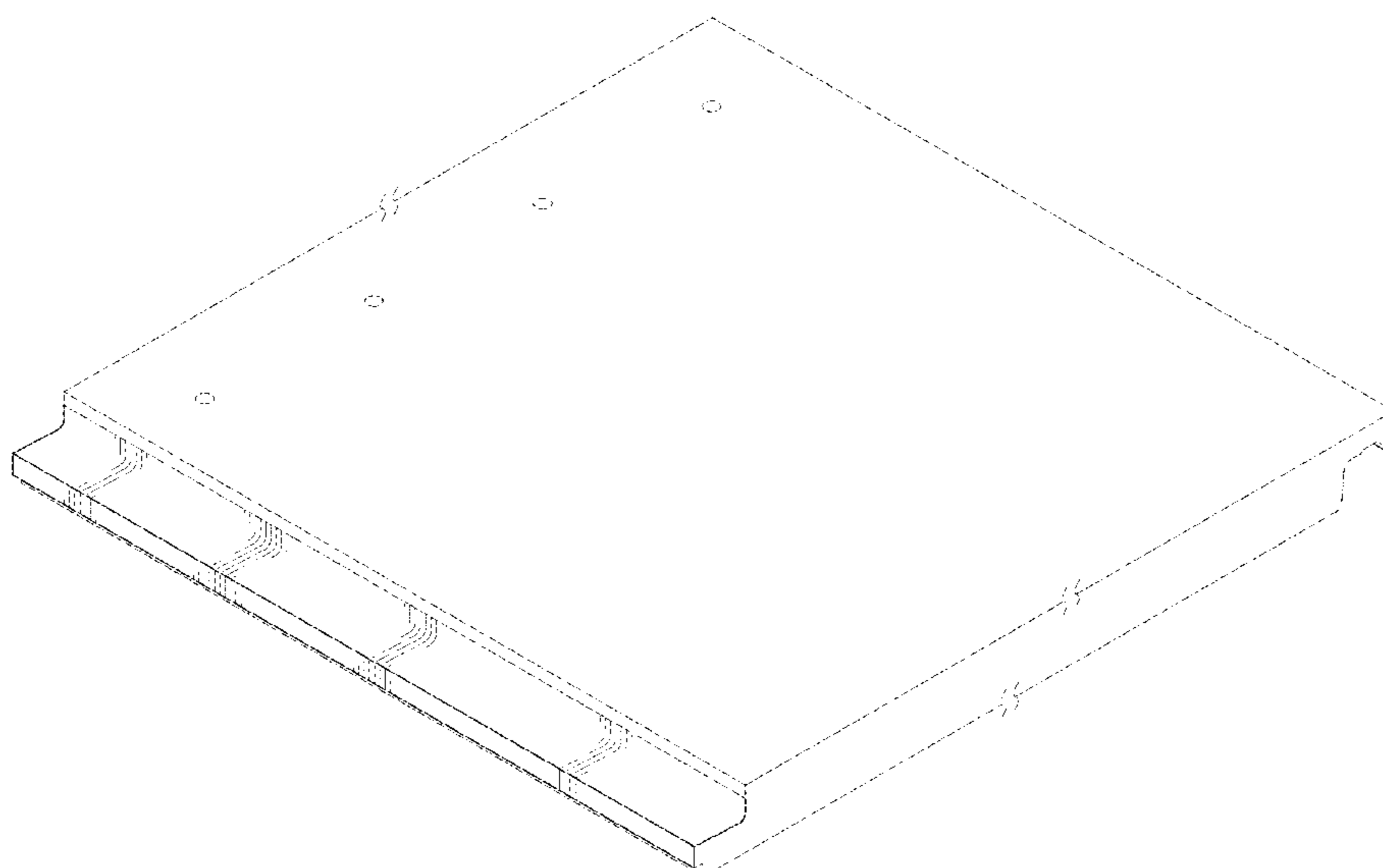
FIG. 1 is a front perspective view of a first embodiment of an interlocking tile portion,
 FIG. 2 is a top view thereof;
 FIG. 3 is a front view thereof;
 FIG. 4 is a back view thereof;
 FIG. 5 is a right side view thereof, the left side view being a mirror image of the right side view; and
 FIG. 6 is a bottom view thereof; and
 FIG. 7 is a right side view of the tile with design element of FIGS. 1-6 interlocking with a second tile with design element according to FIGS. 1-6; and
 FIG. 8 is a front perspective view of a second embodiment of an interlocking tile portion,
 FIG. 9 is a top view thereof;
 FIG. 10 is a front view thereof;
 FIG. 11 is a back view thereof;
 FIG. 12 is a right side view thereof, the left side view being a mirror image of the right side view; and
 FIG. 13 is a bottom view thereof; and,
 FIG. 14 is a right side view of the tile with design element of FIGS. 8-13 interlocking with a second tile with design element according to FIGS. 8-13.

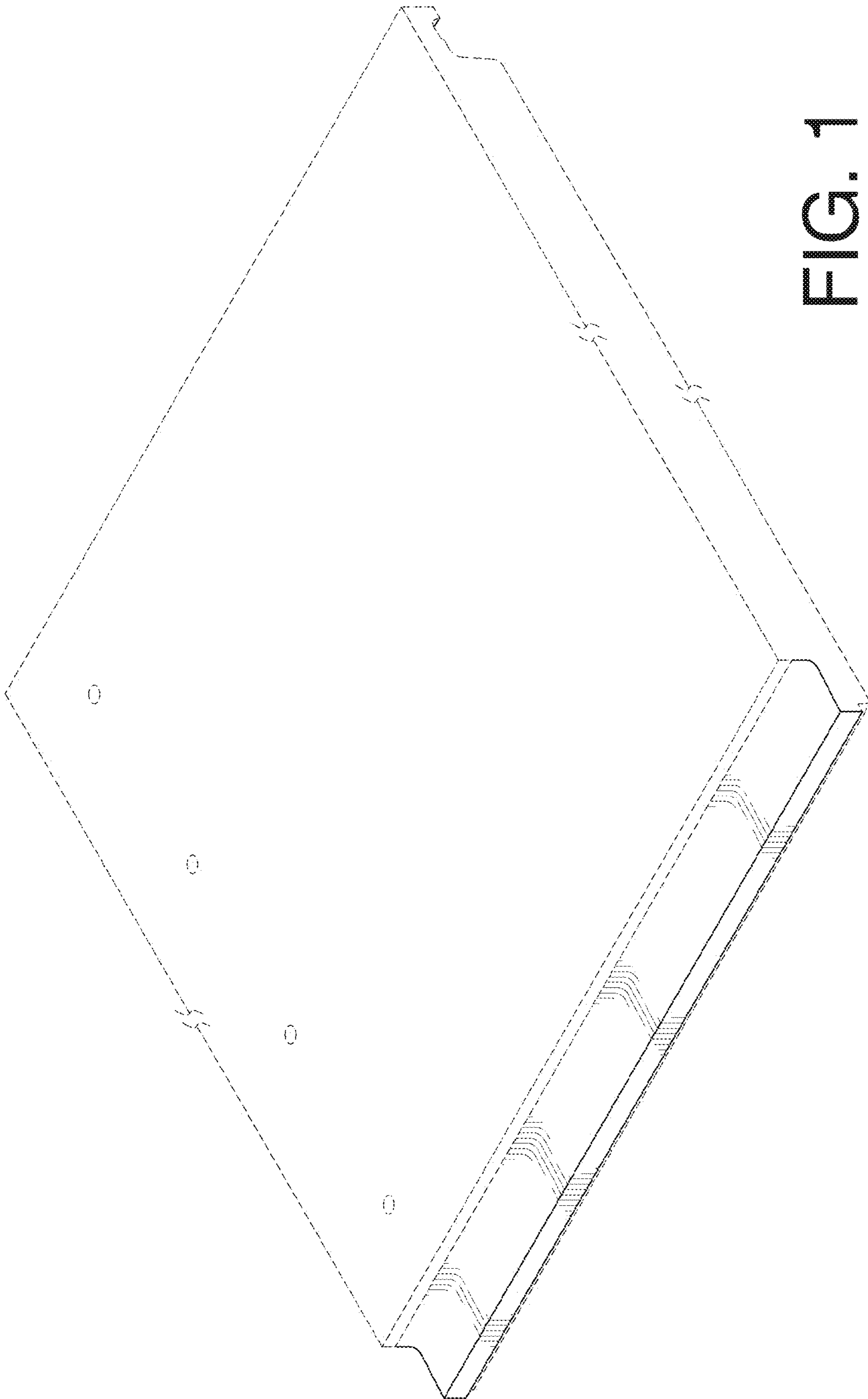

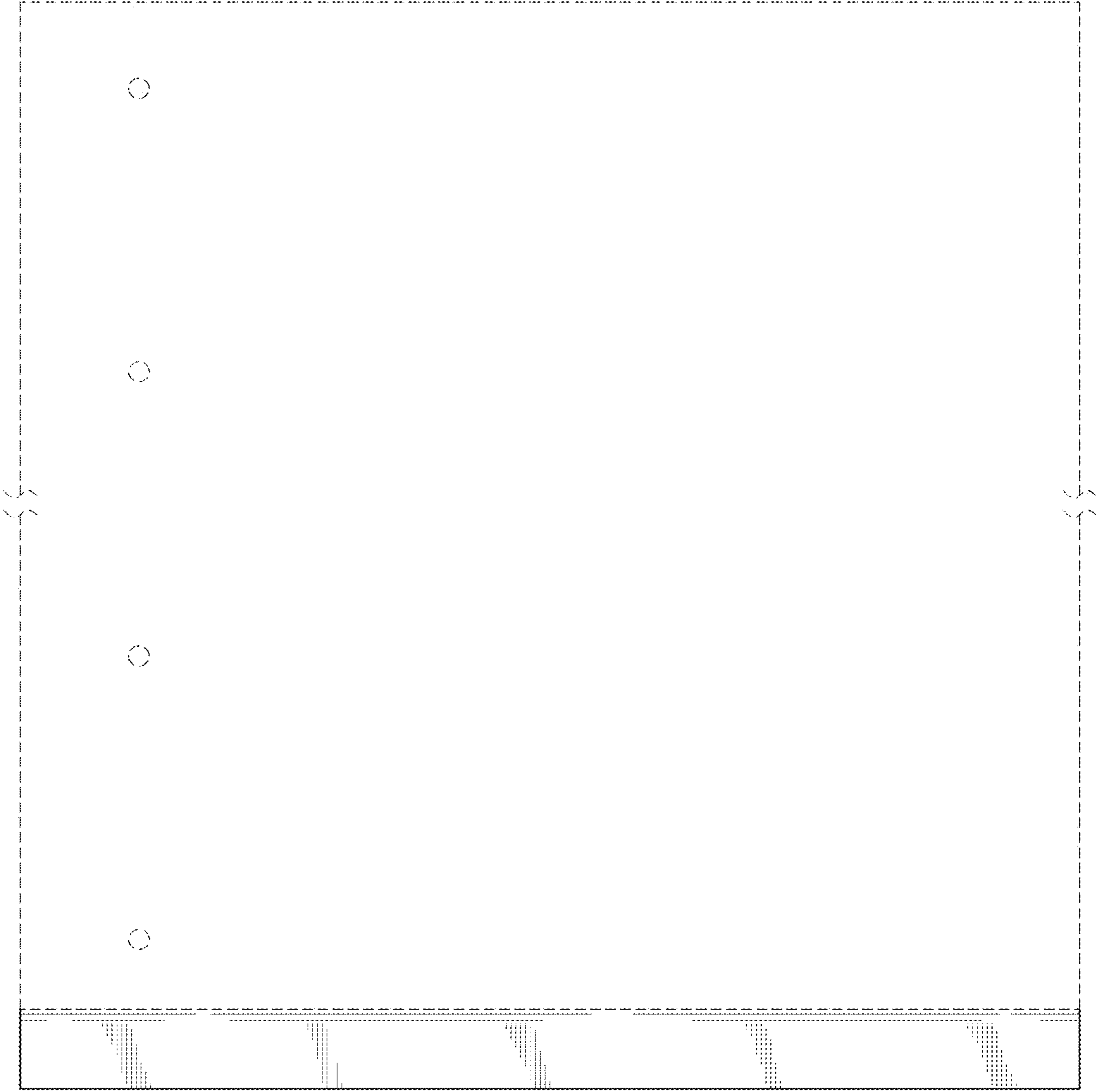

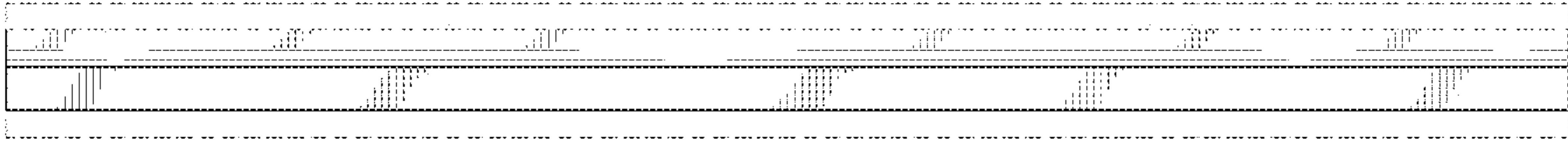

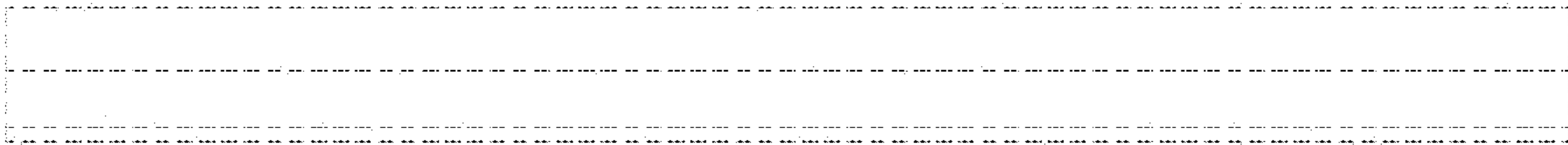

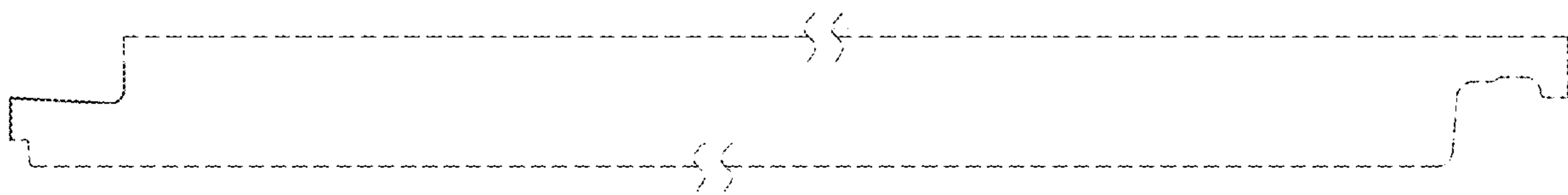

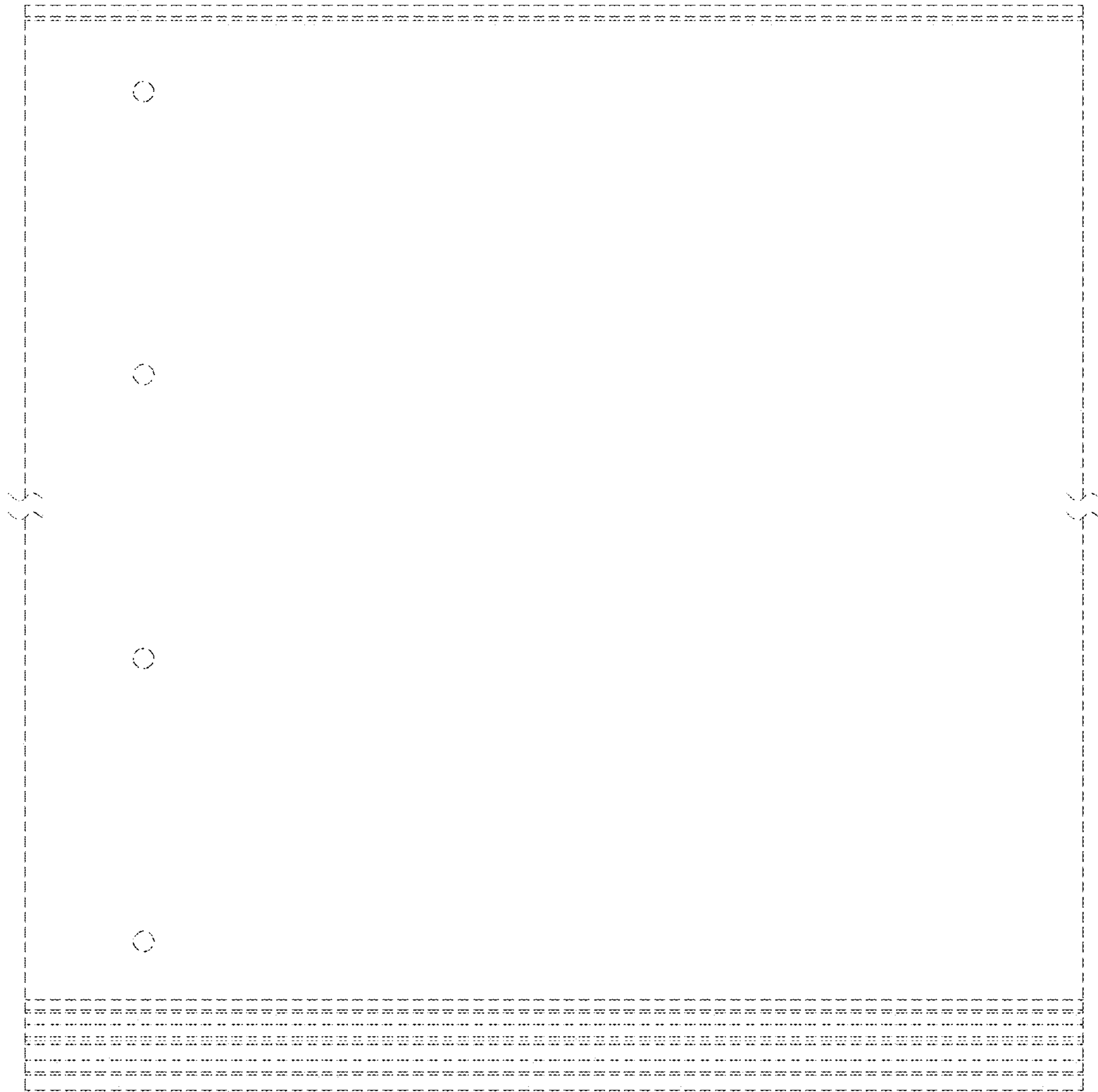

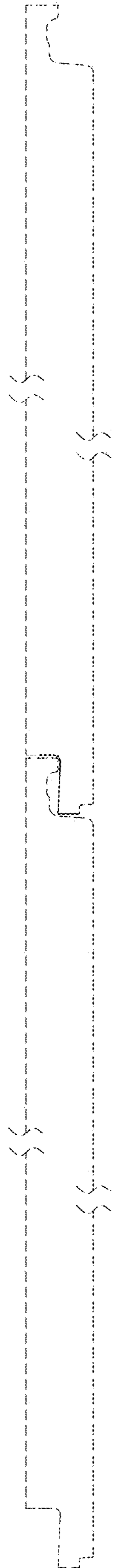

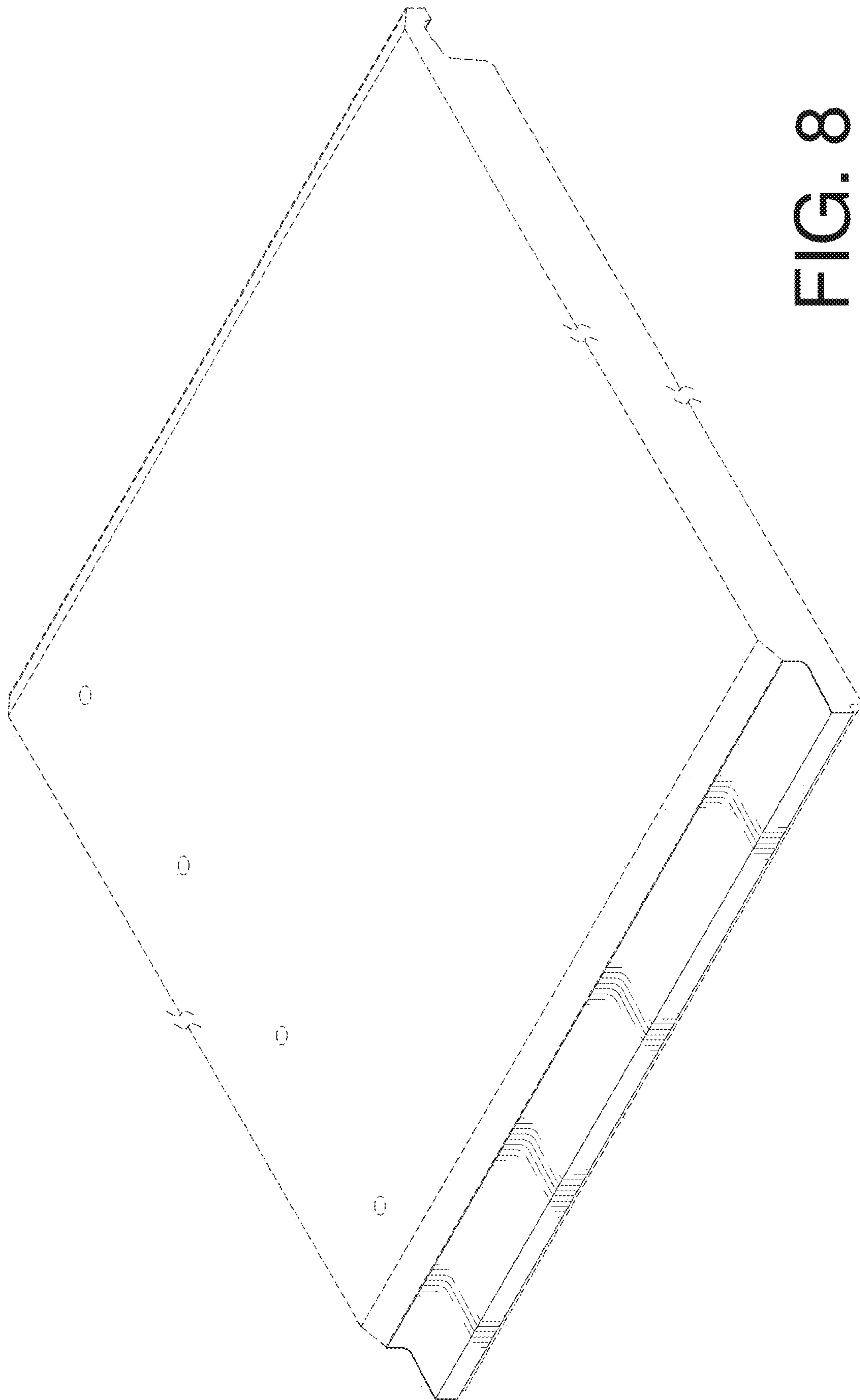

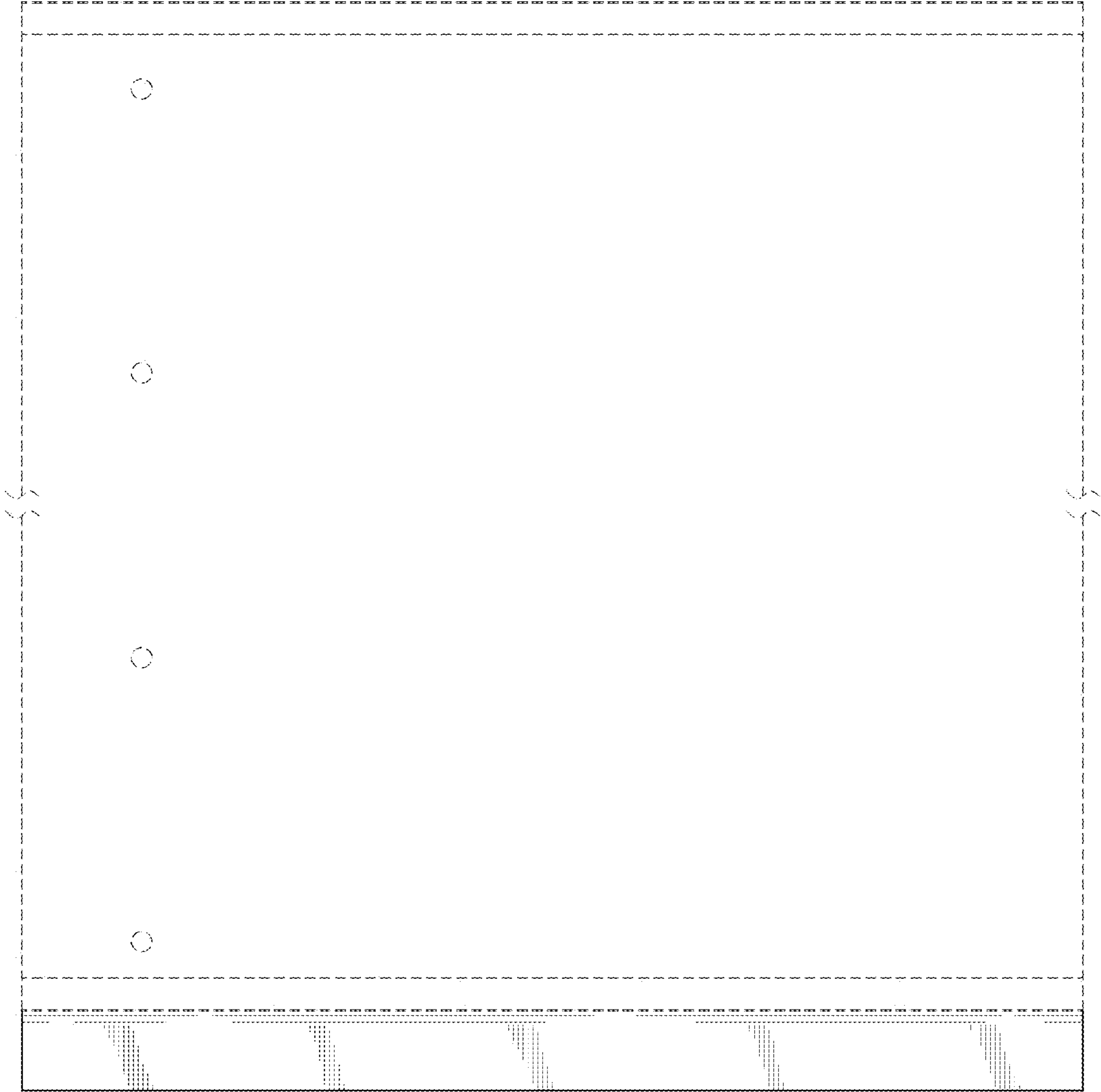

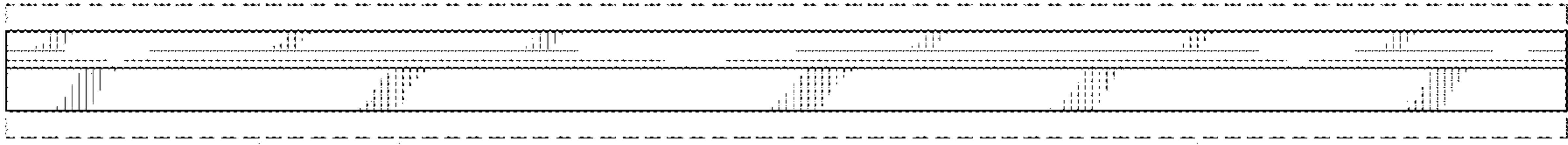

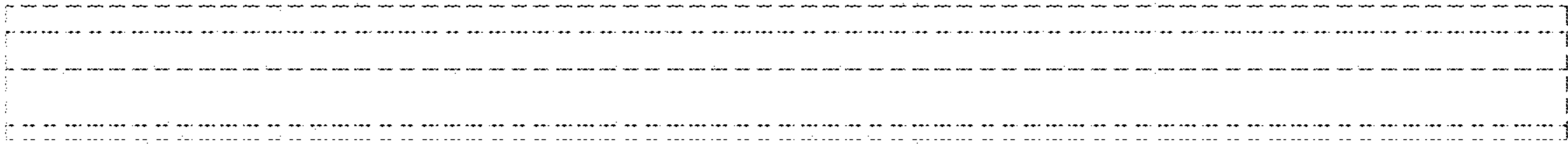

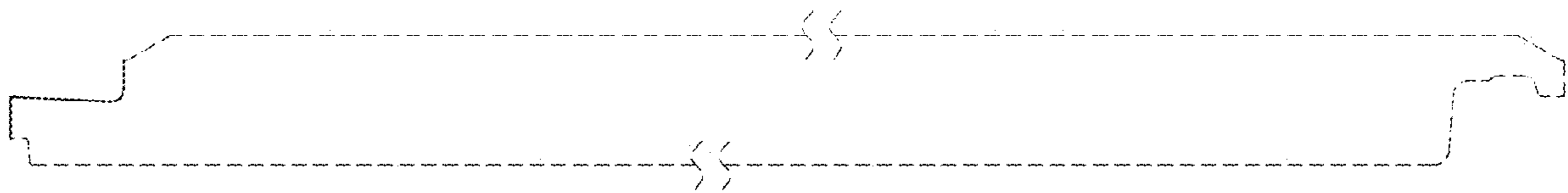

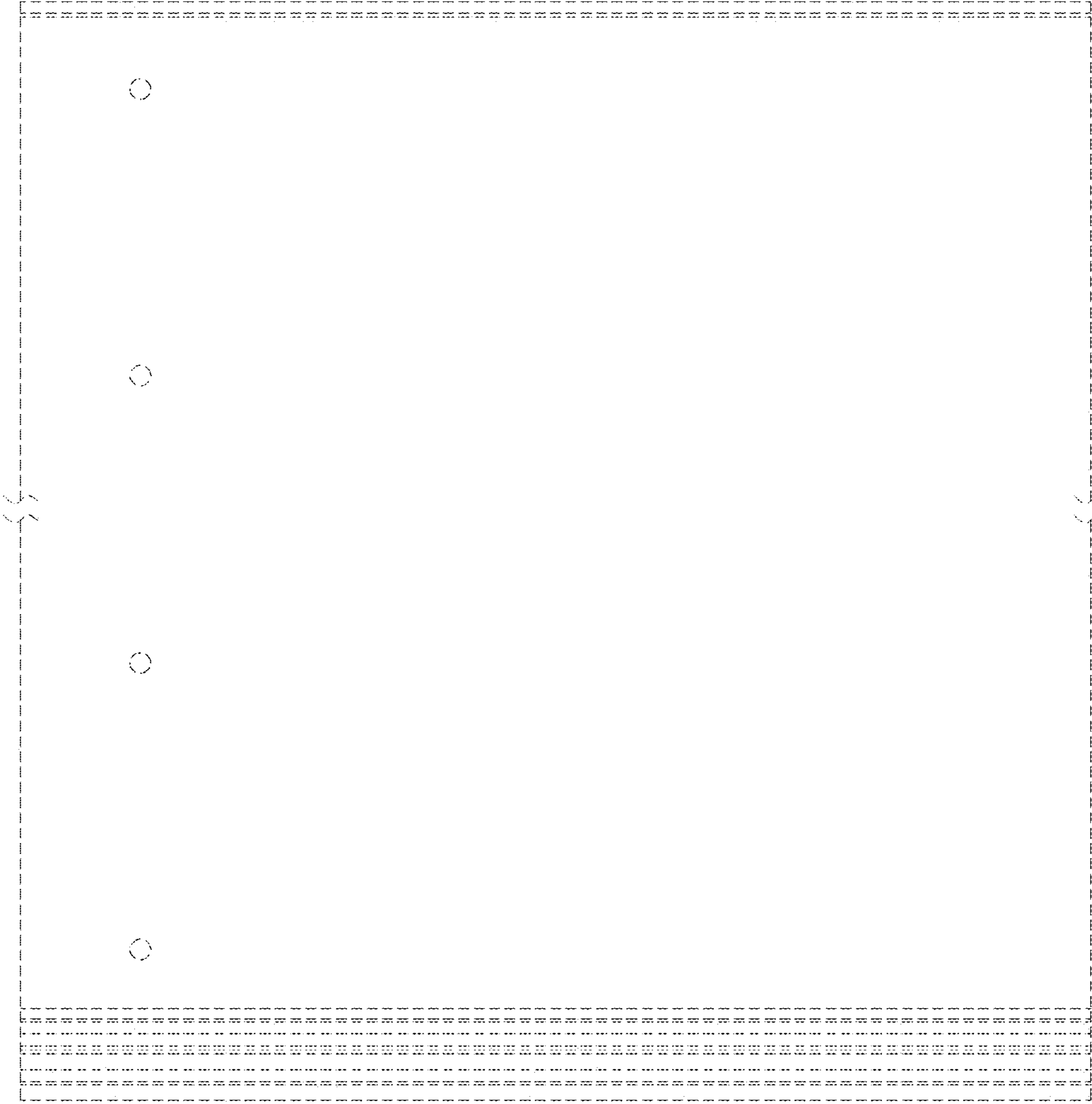

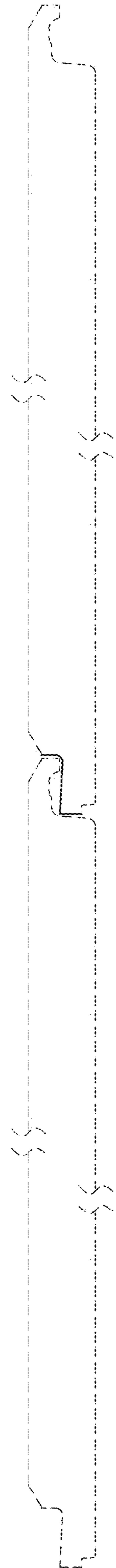
