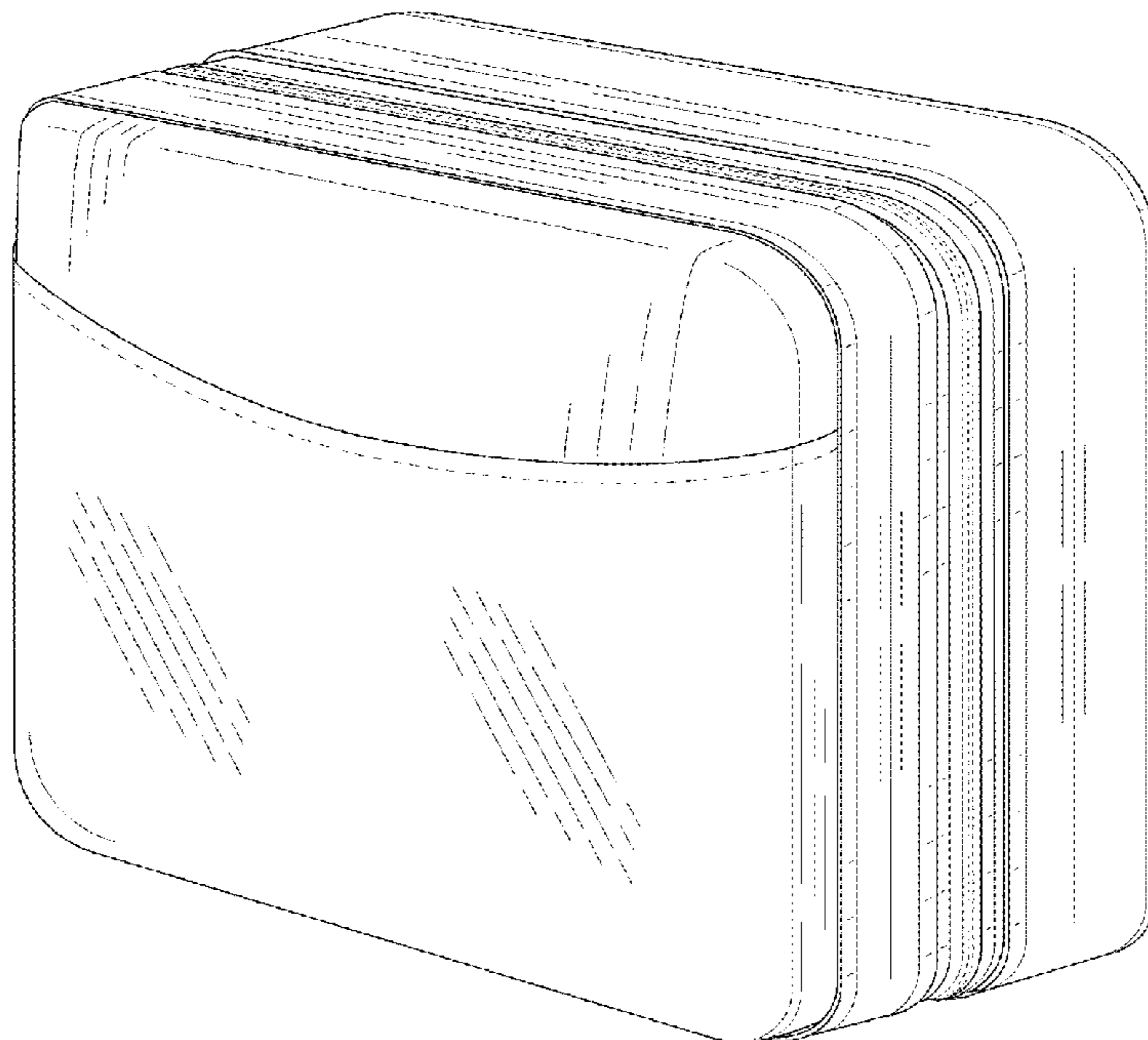
(57) **CLAIM**

The ornamental design for a travel cigar humidor case, as shown and described.

DESCRIPTION

FIG. 1 is a front and right perspective view of a travel cigar humidor case, showing my design.
FIG. 2 is a front elevation view thereof.

FIG. 4 is a left side elevation thereof.

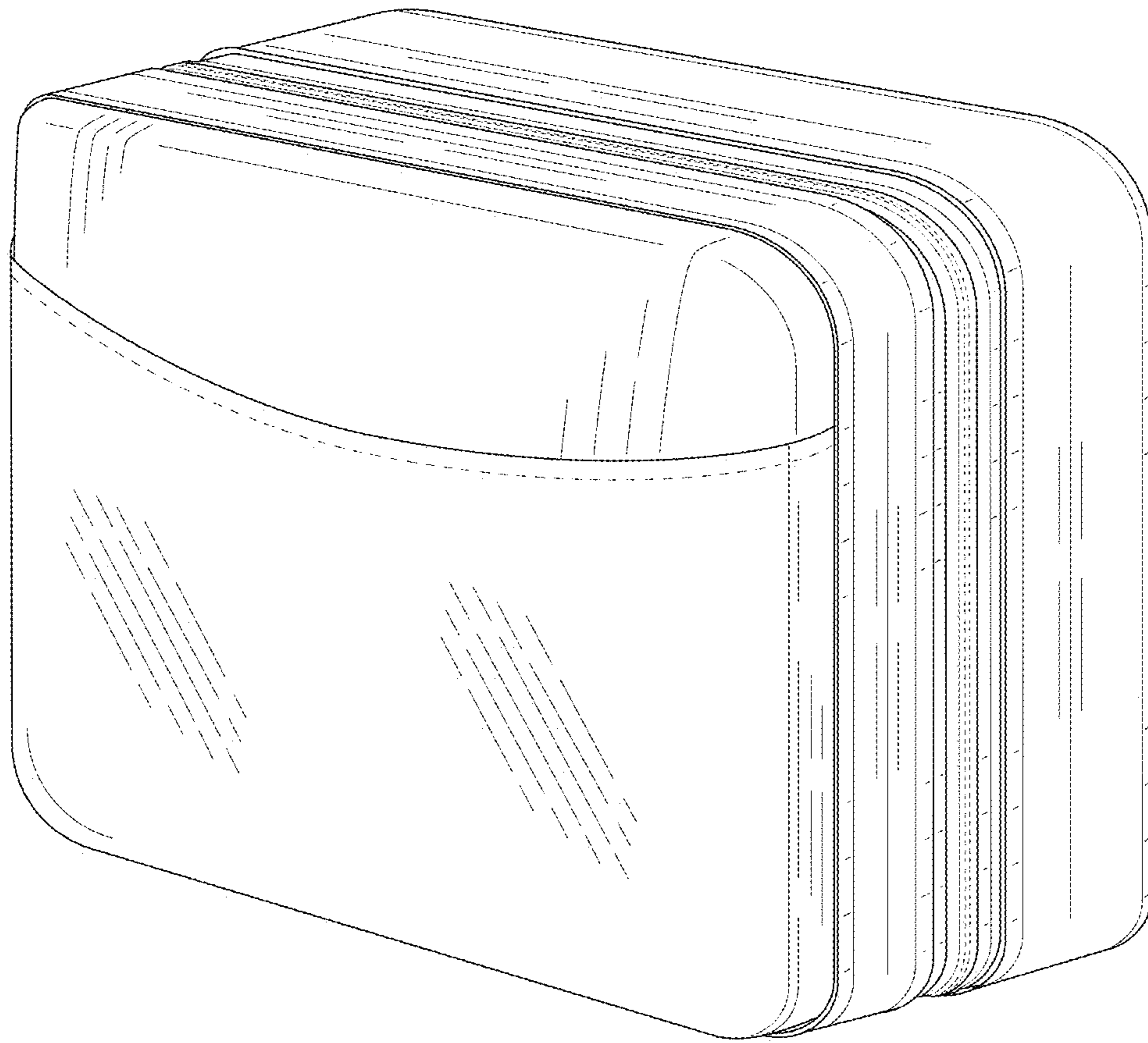

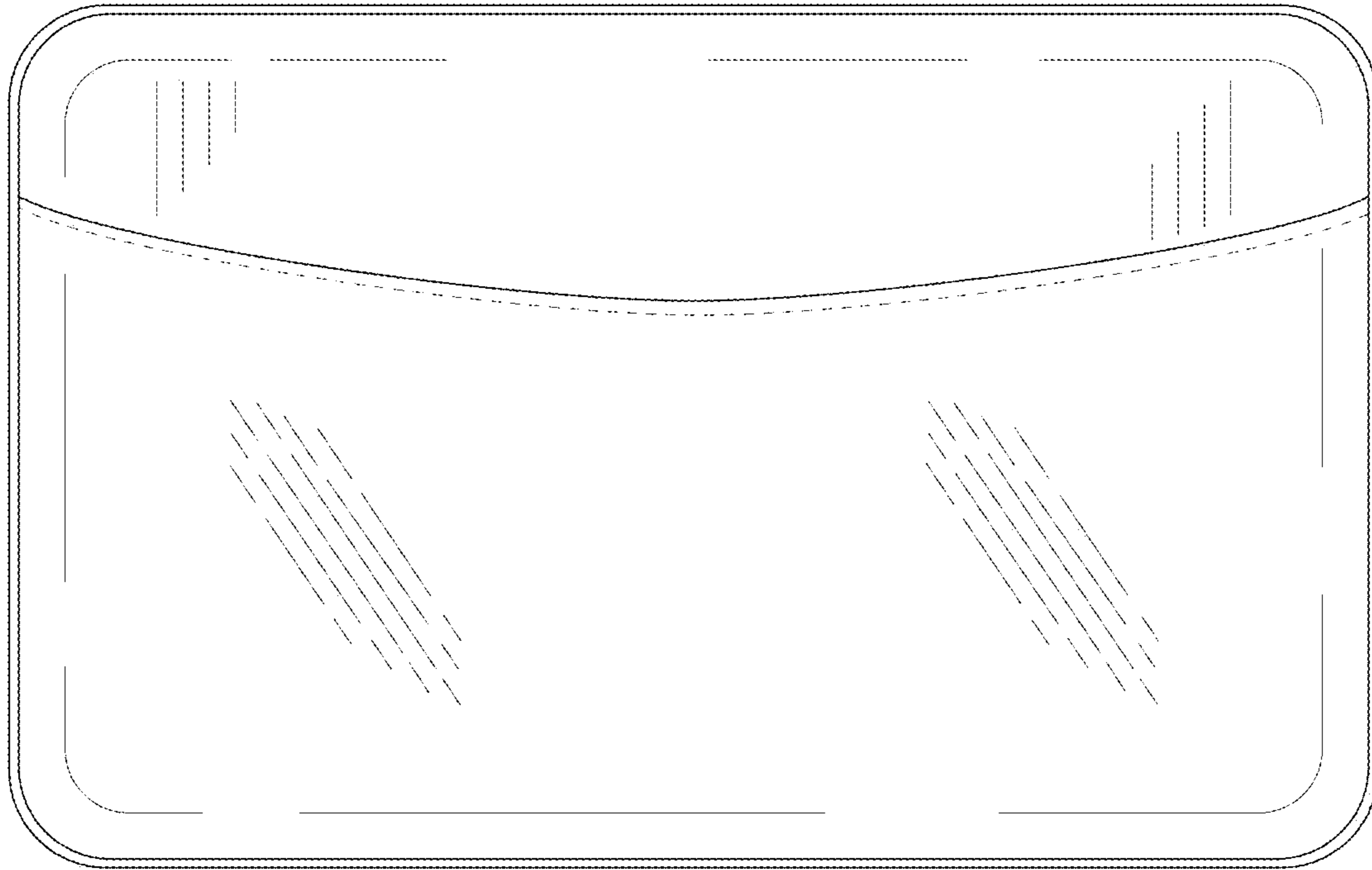

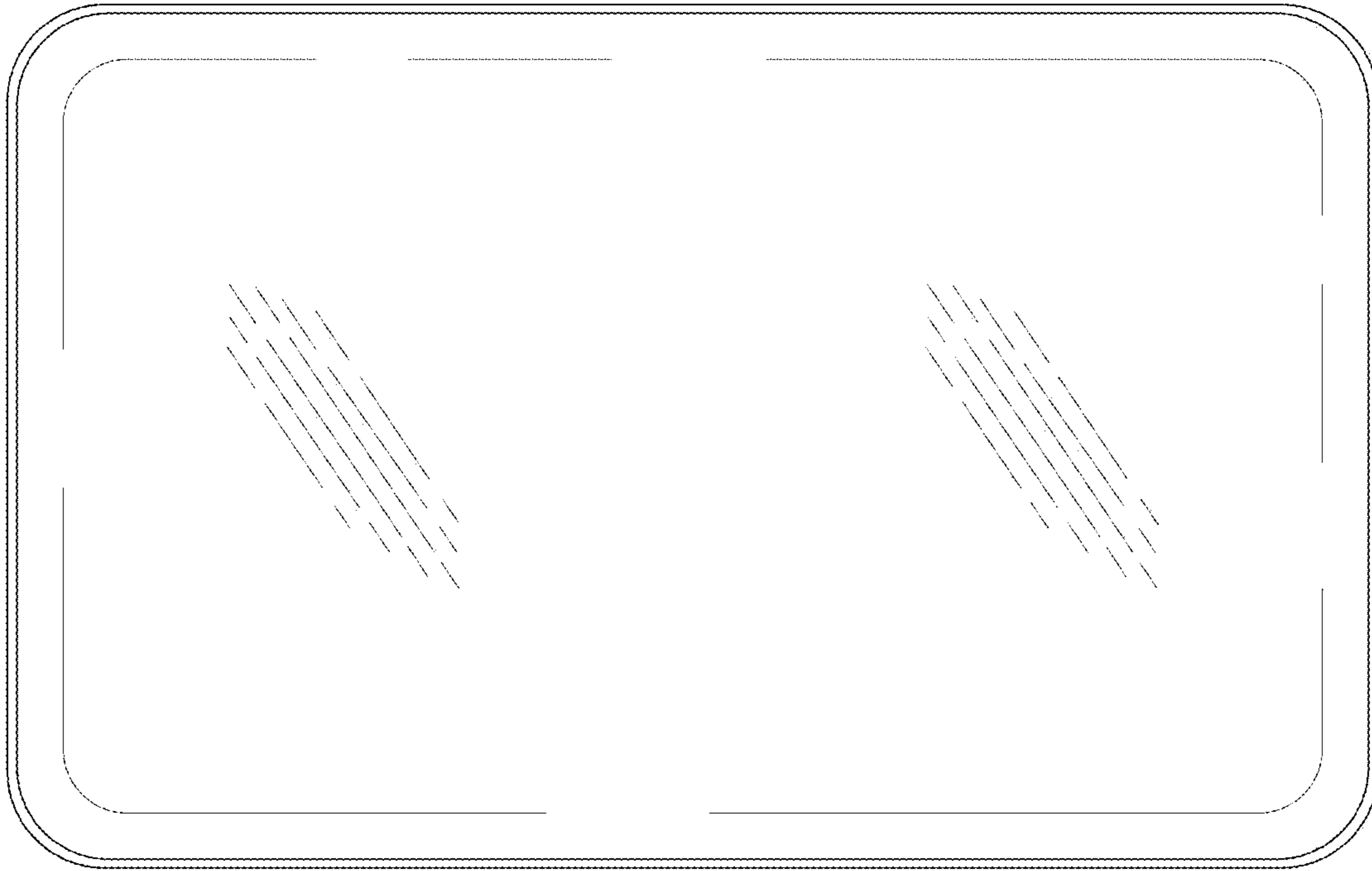

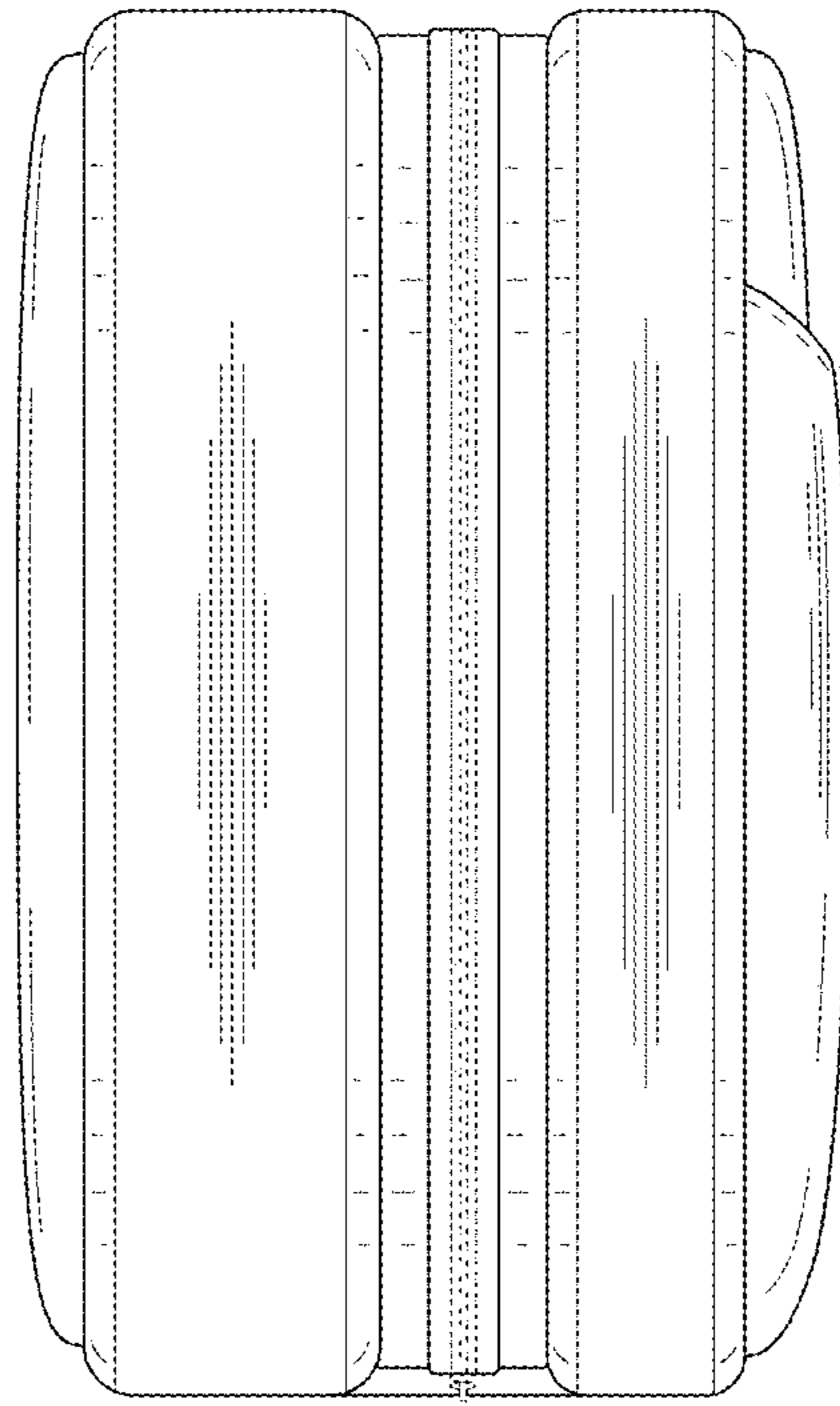

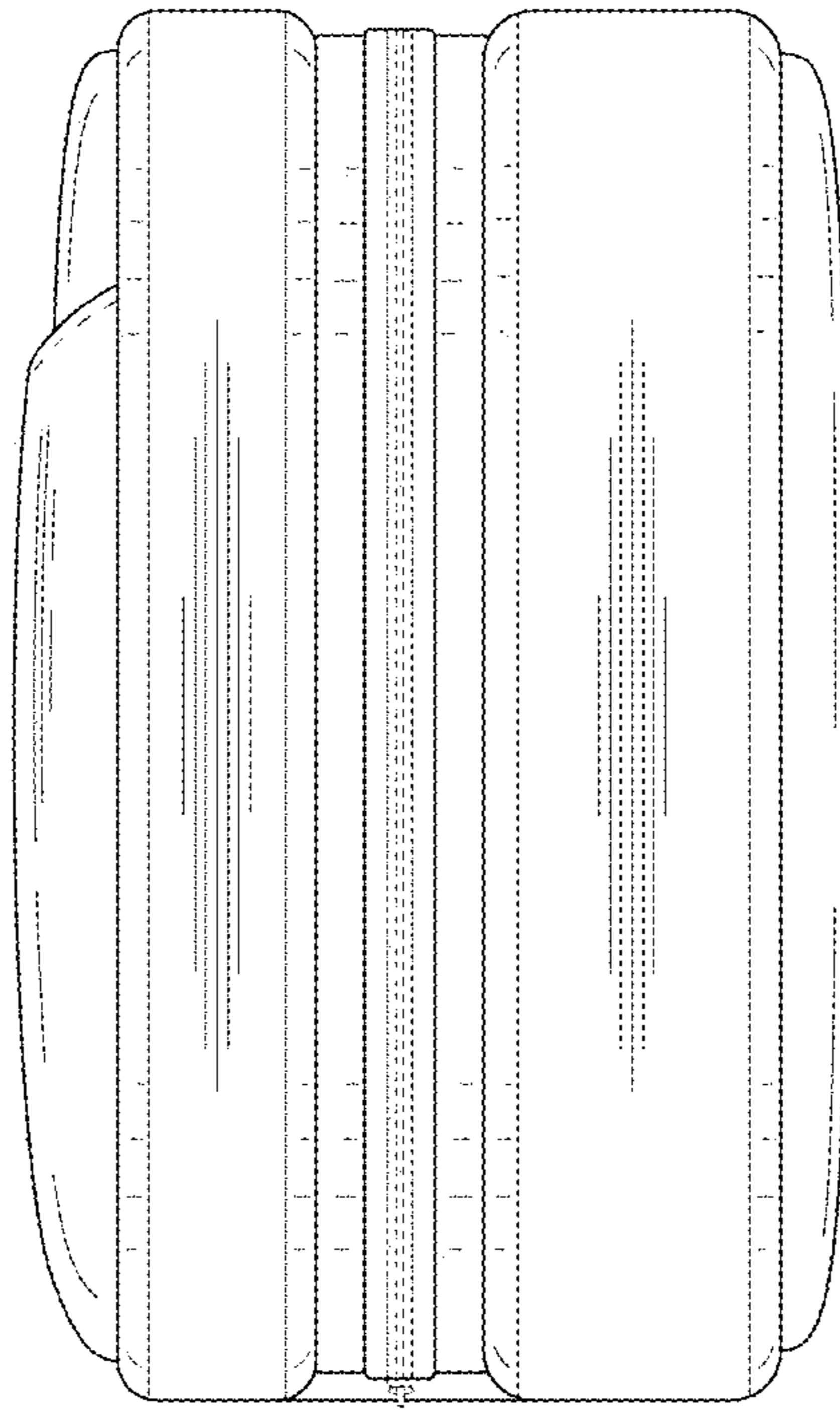

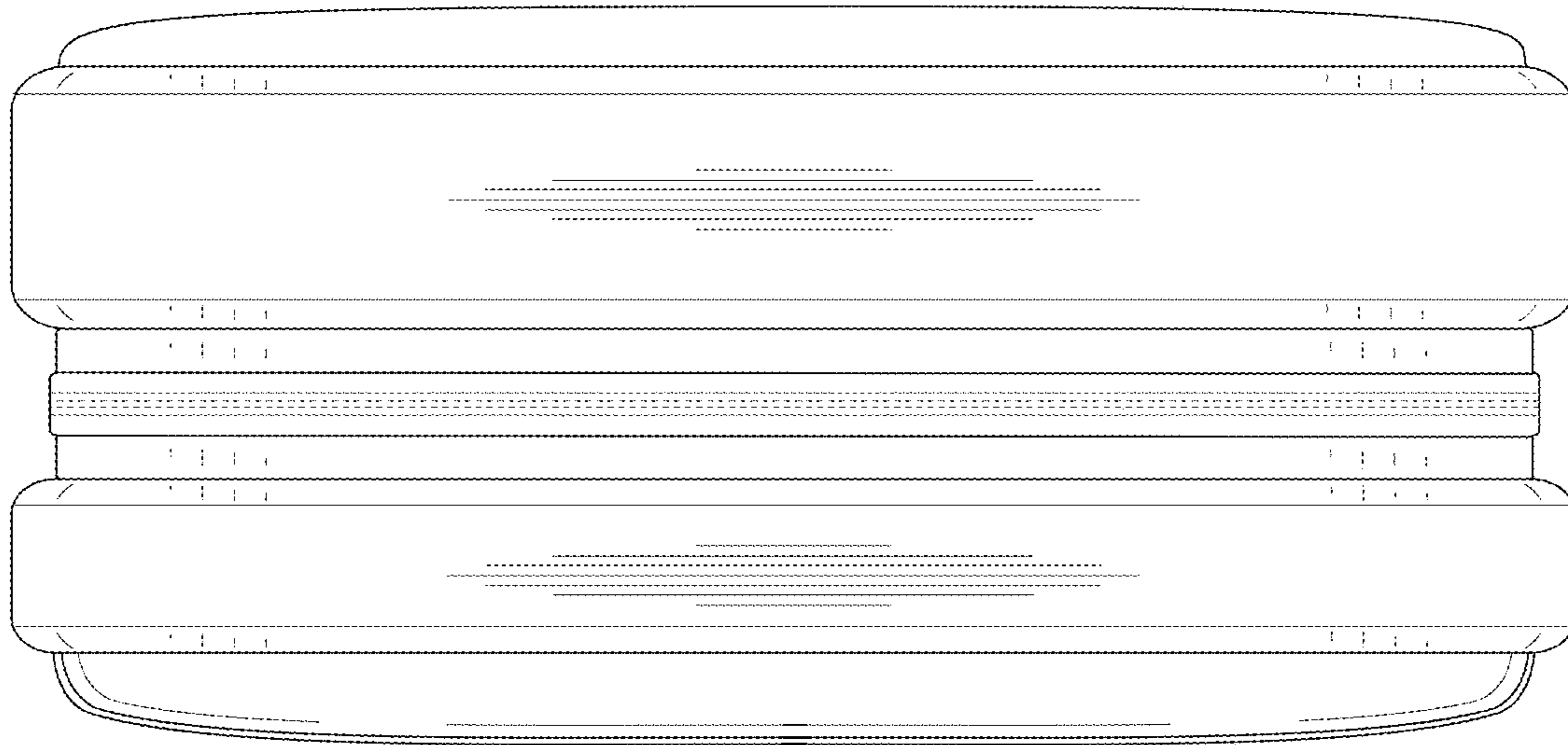

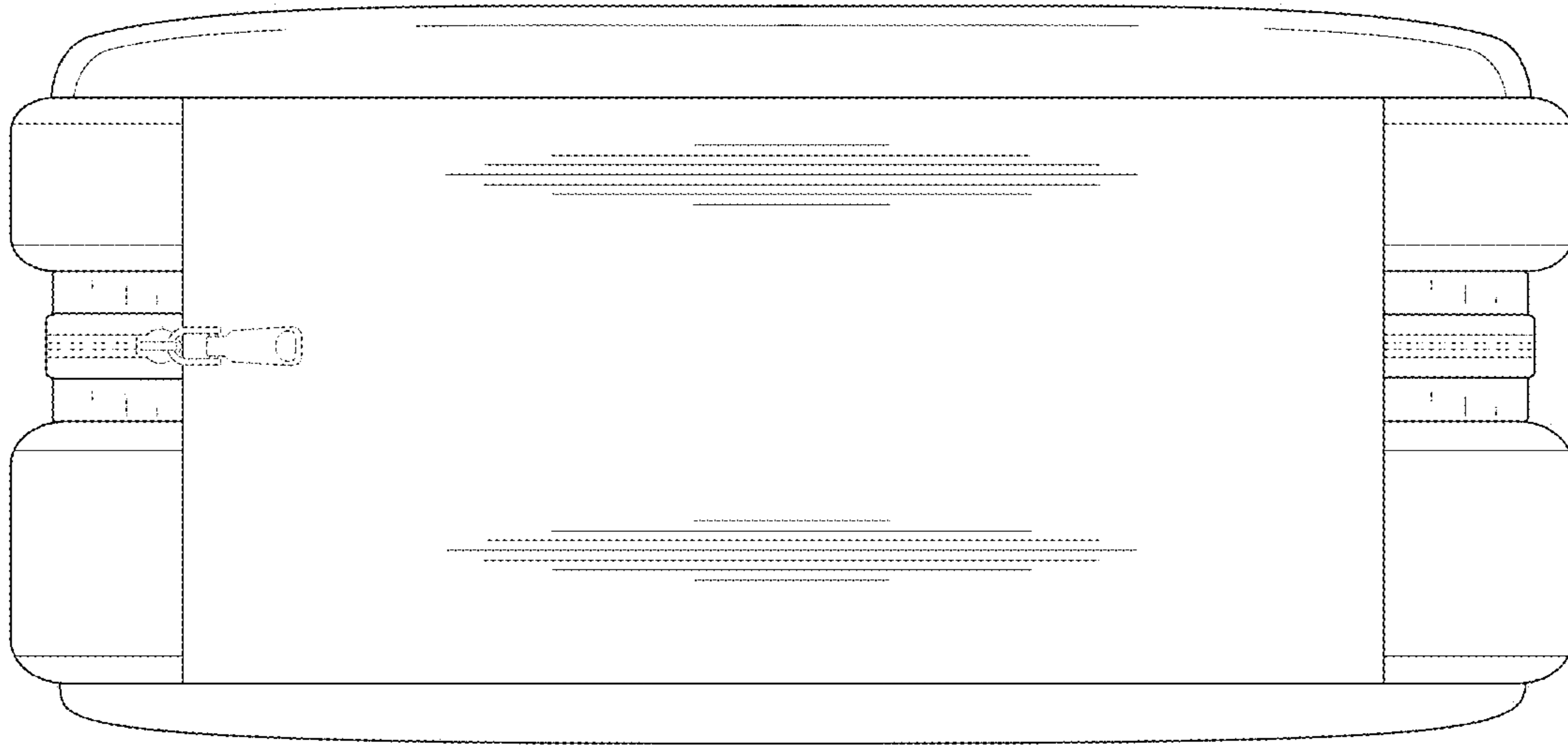

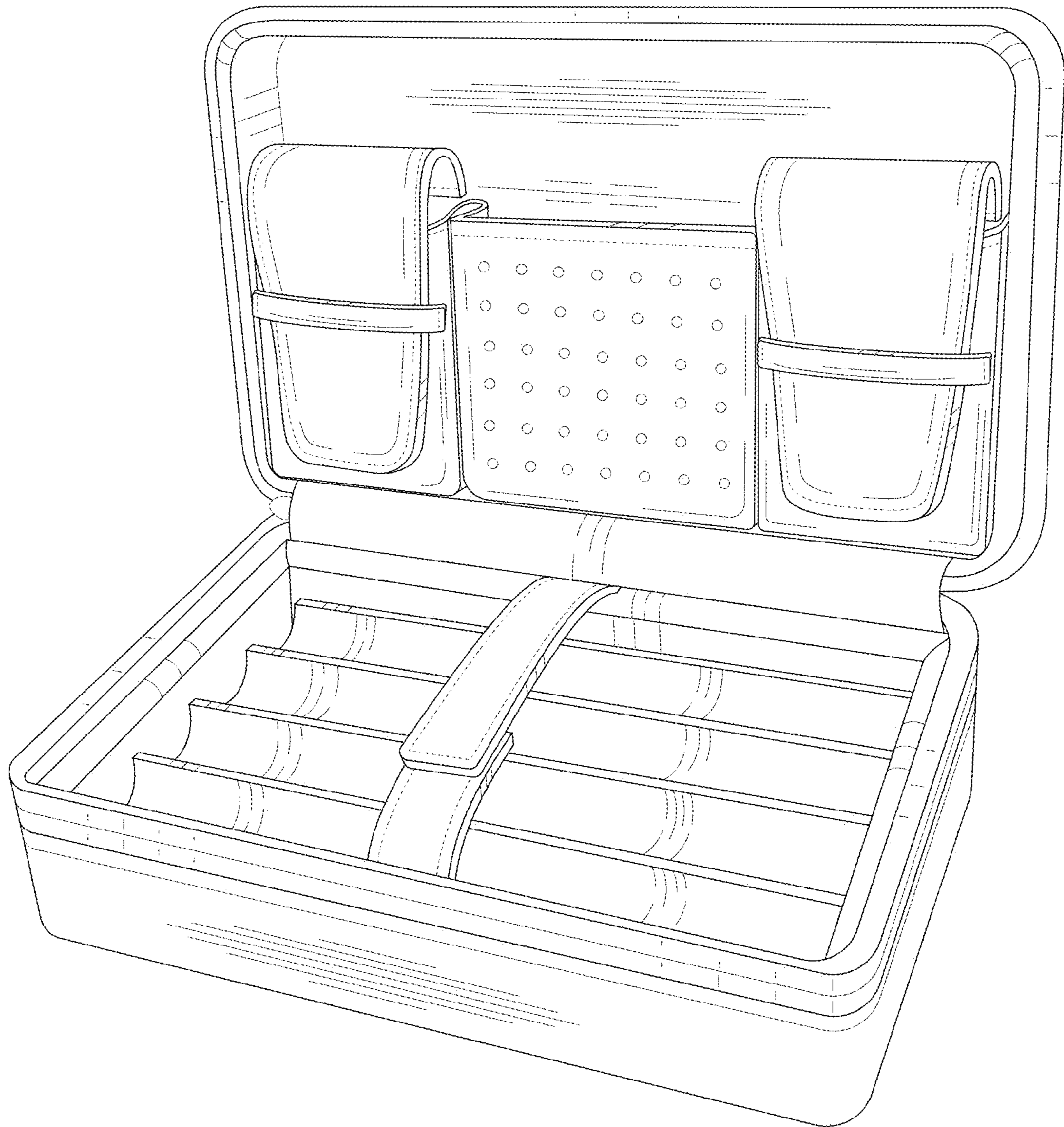
