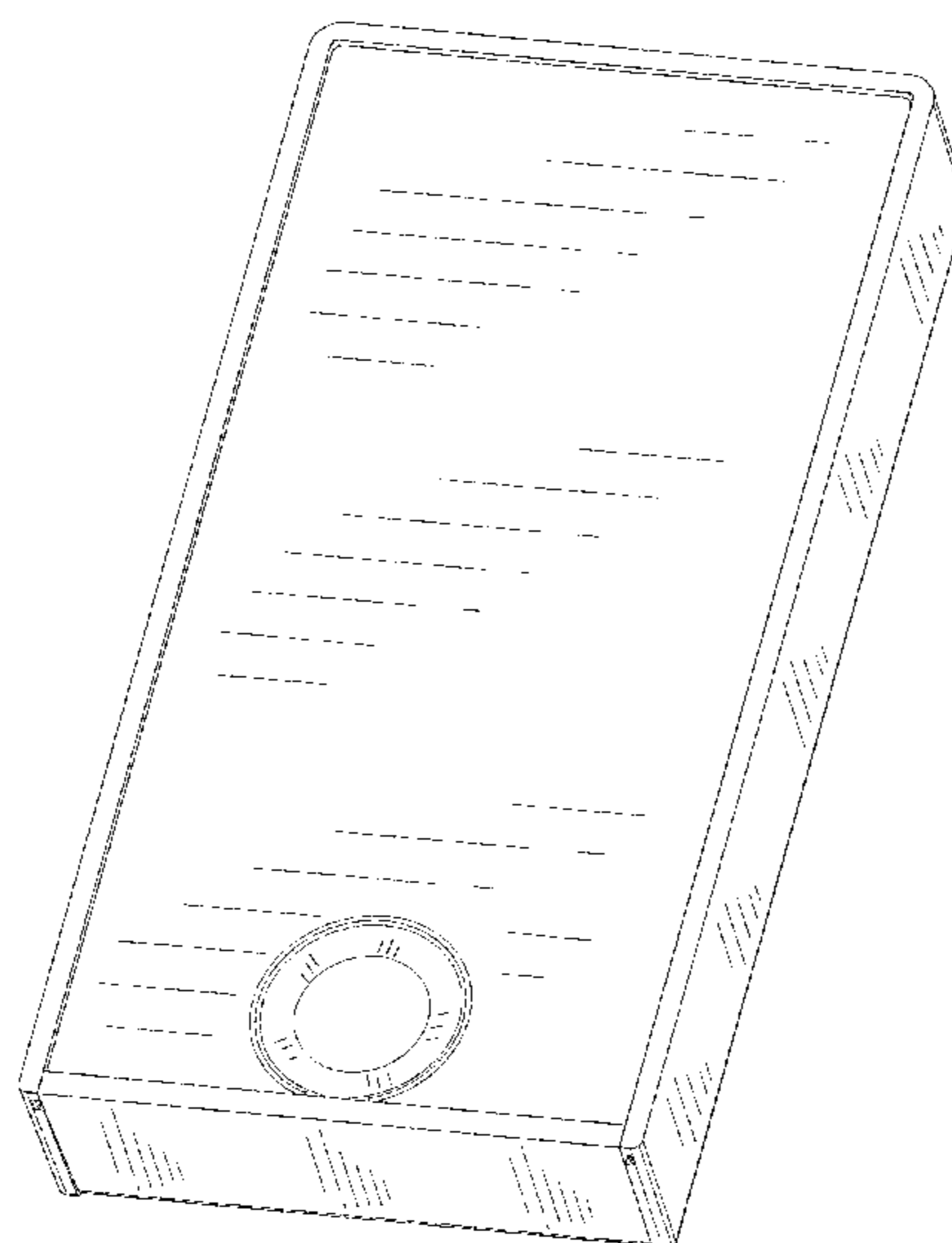
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of an eyelash box showing my new design;
FIG. 2 is another perspective view thereof;
FIG. 3 is a perspective view of the eyelash box where the eyelash box is in a first configuration of use;

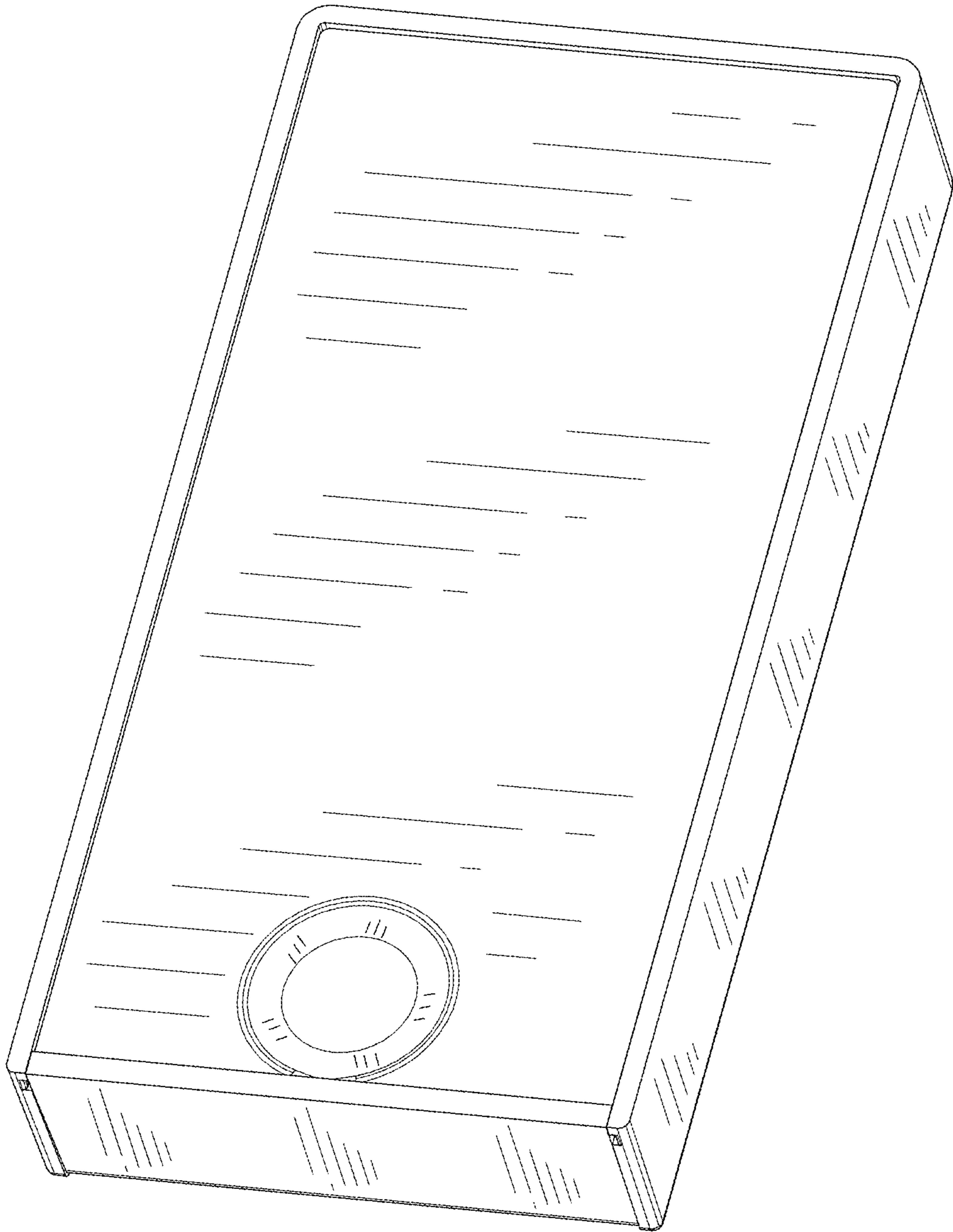

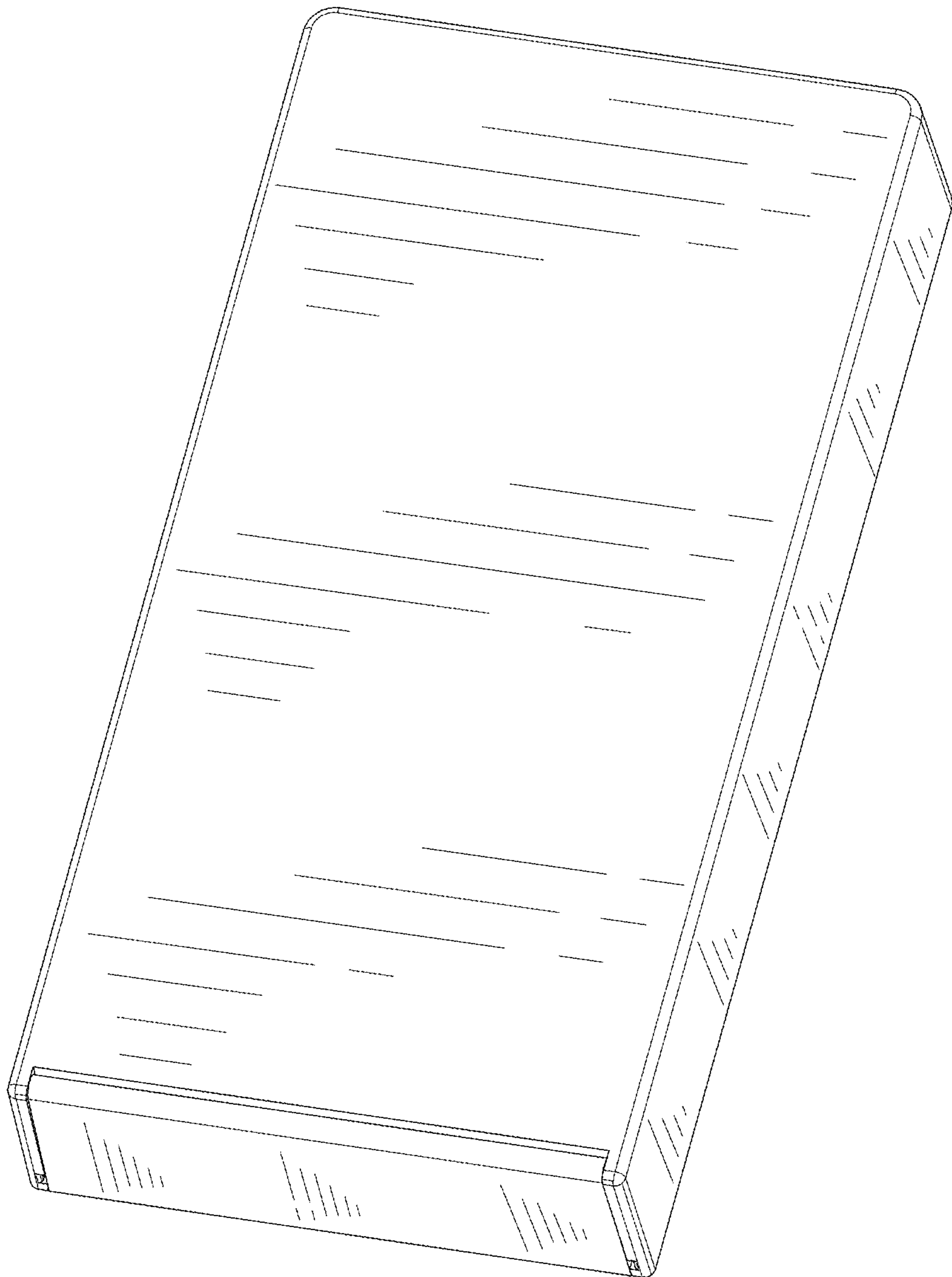

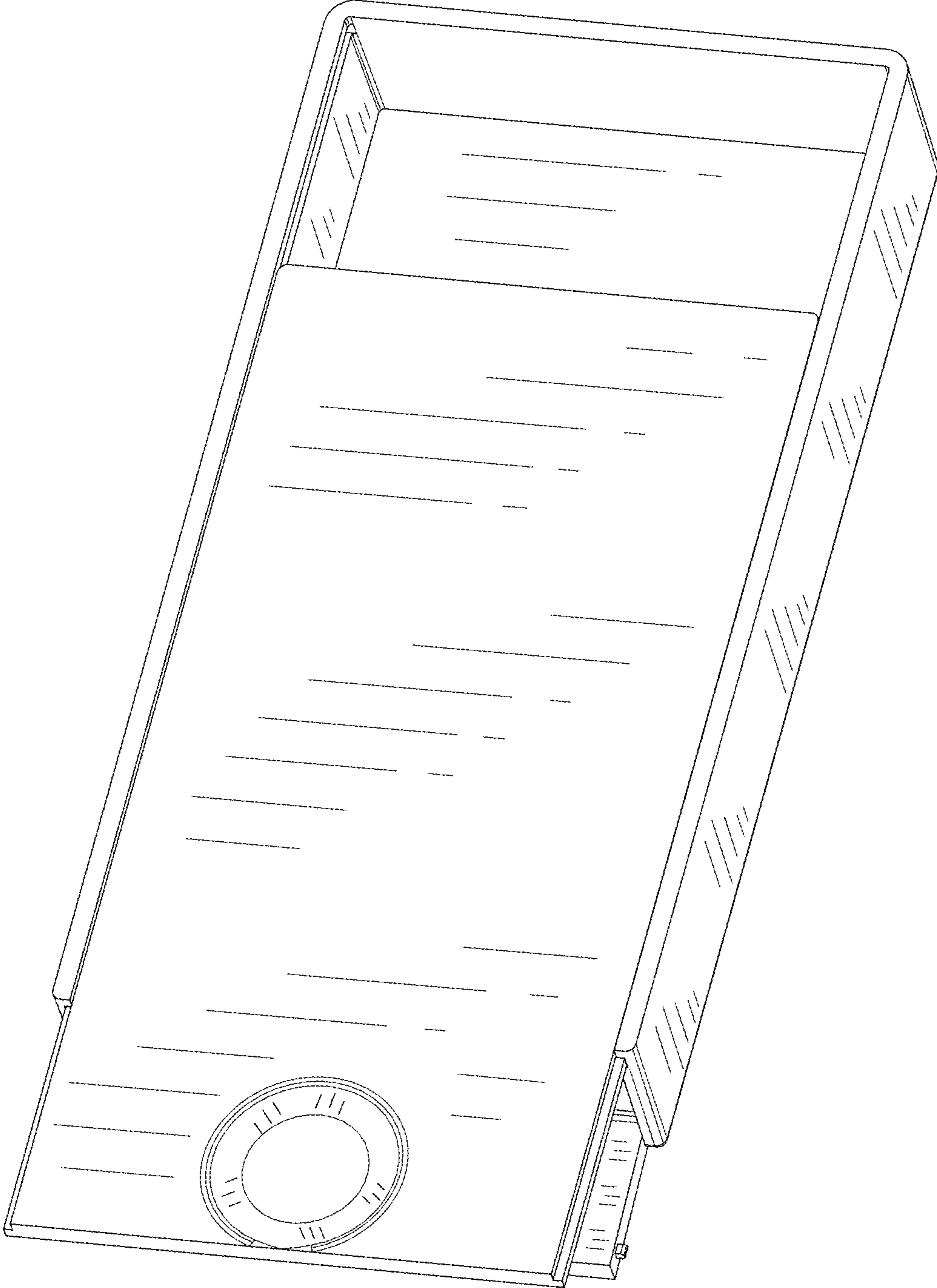

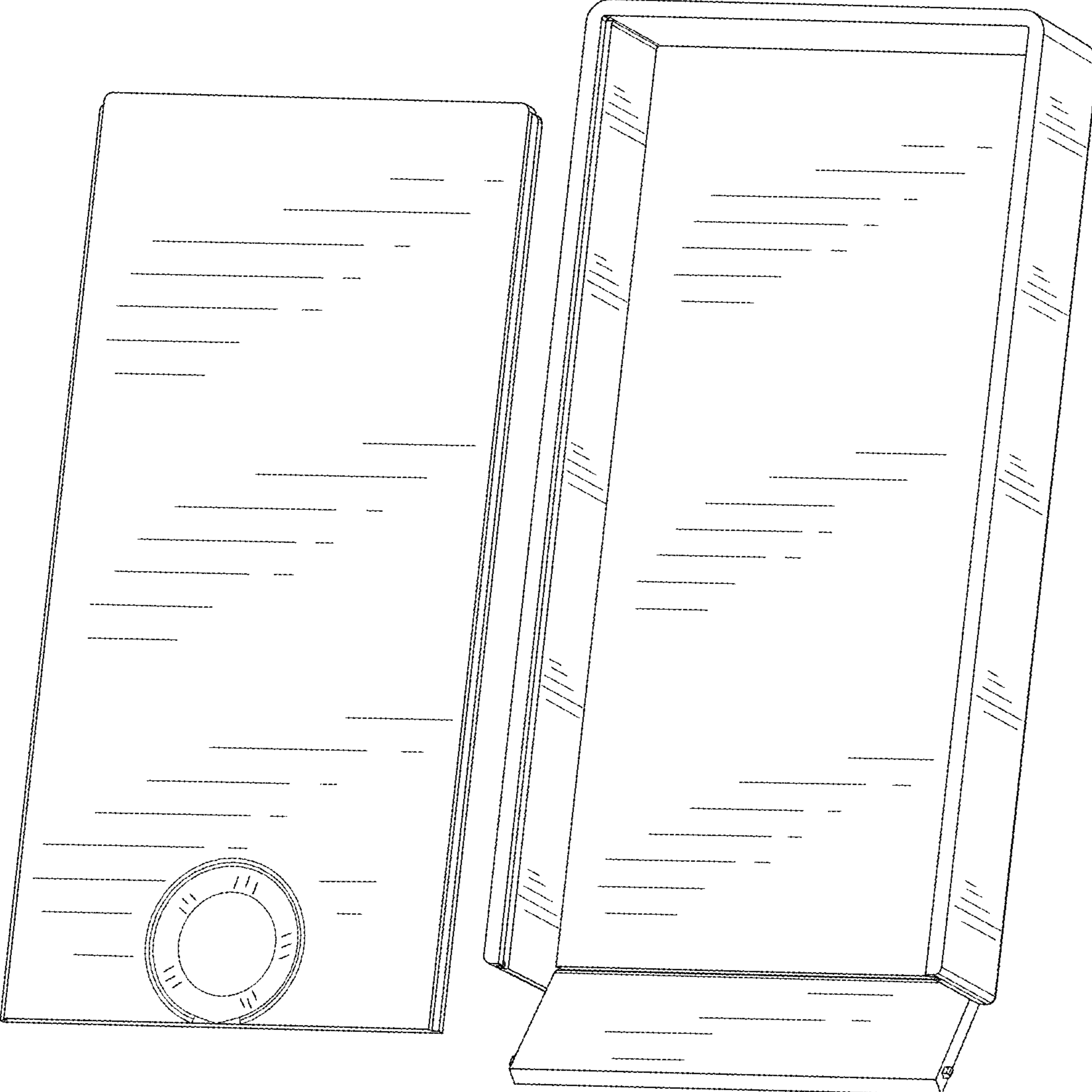

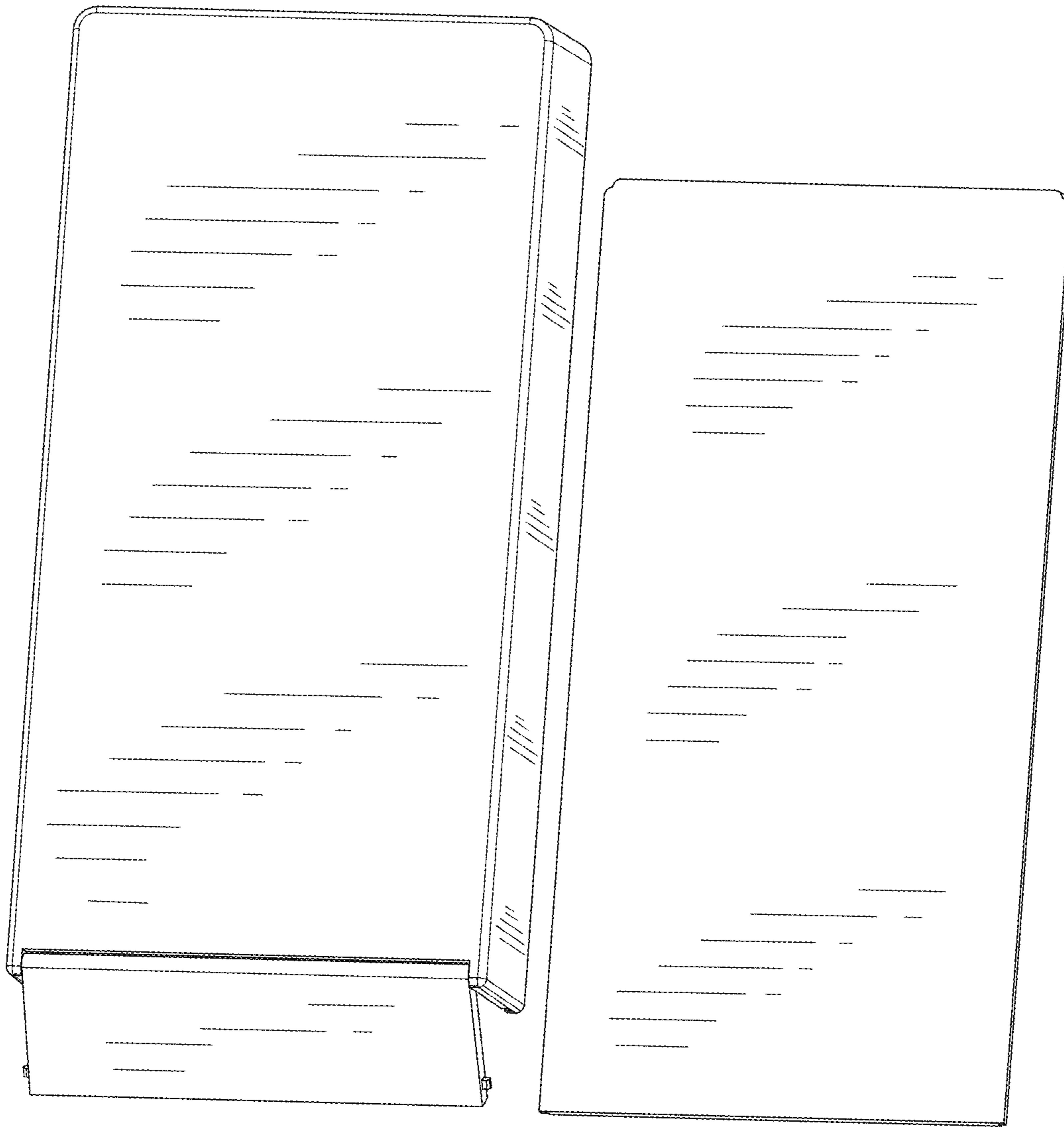

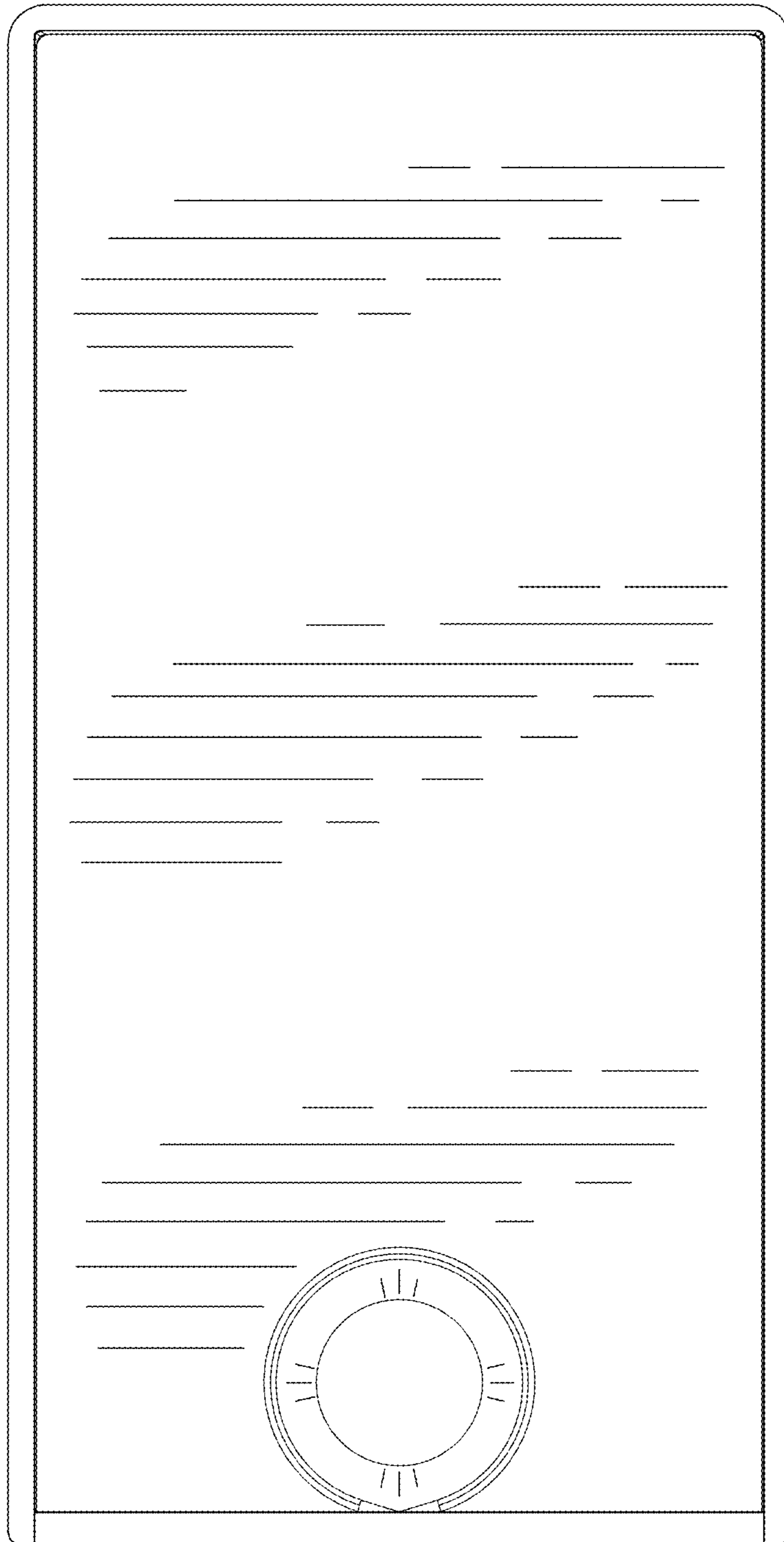

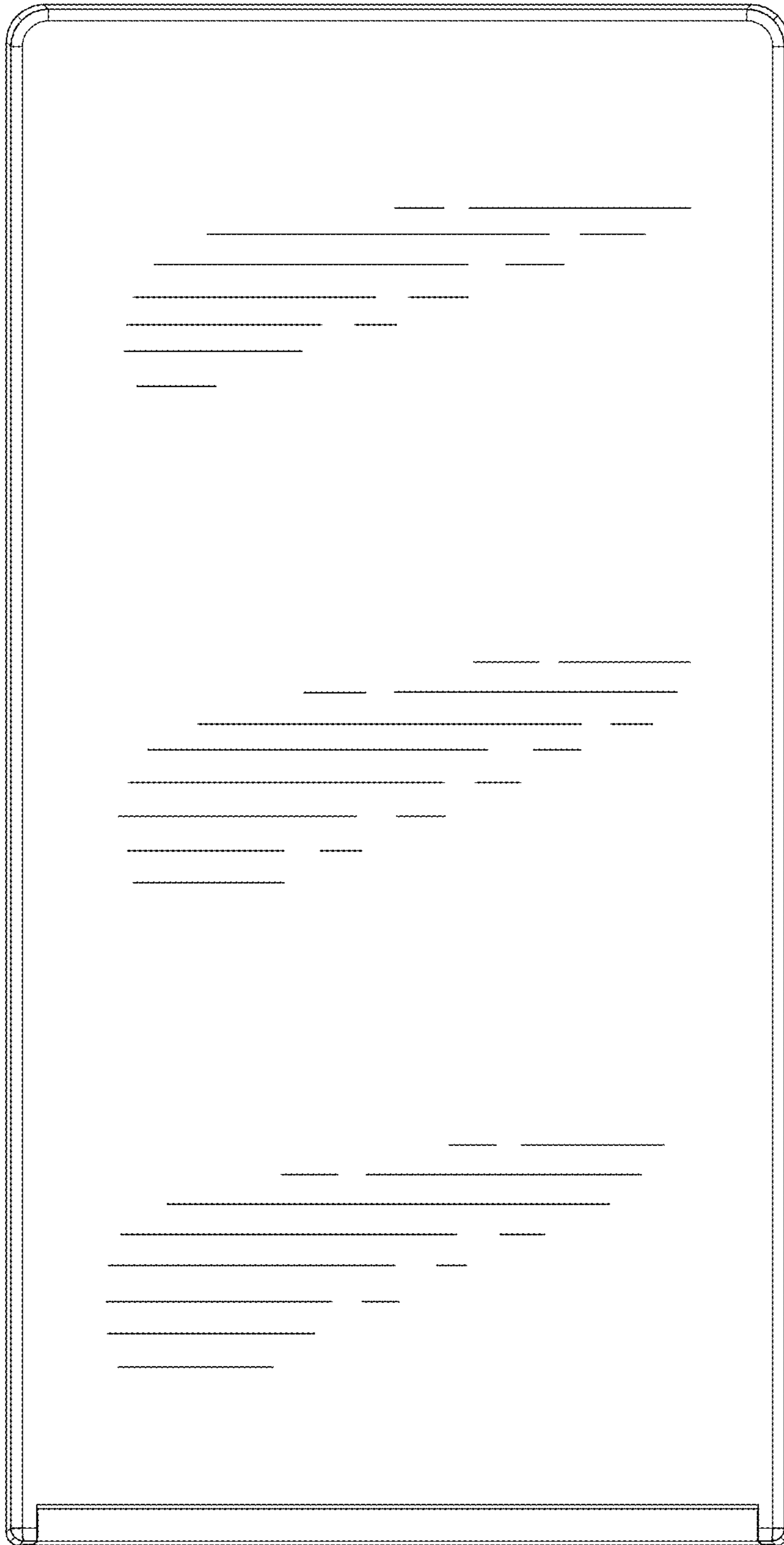

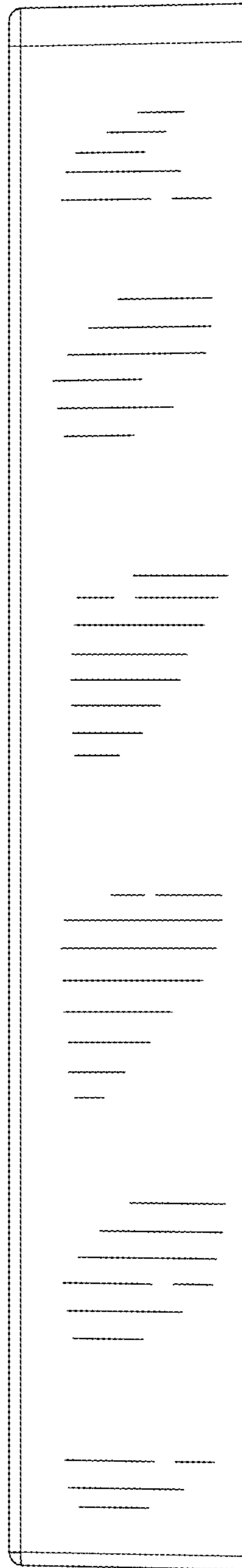

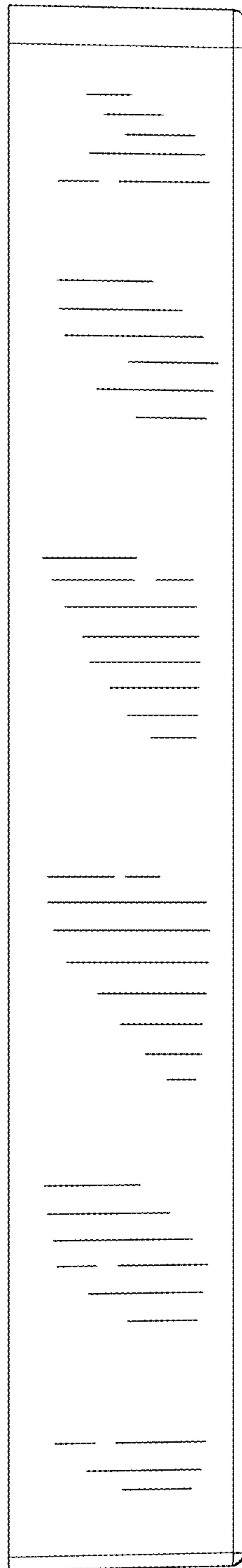

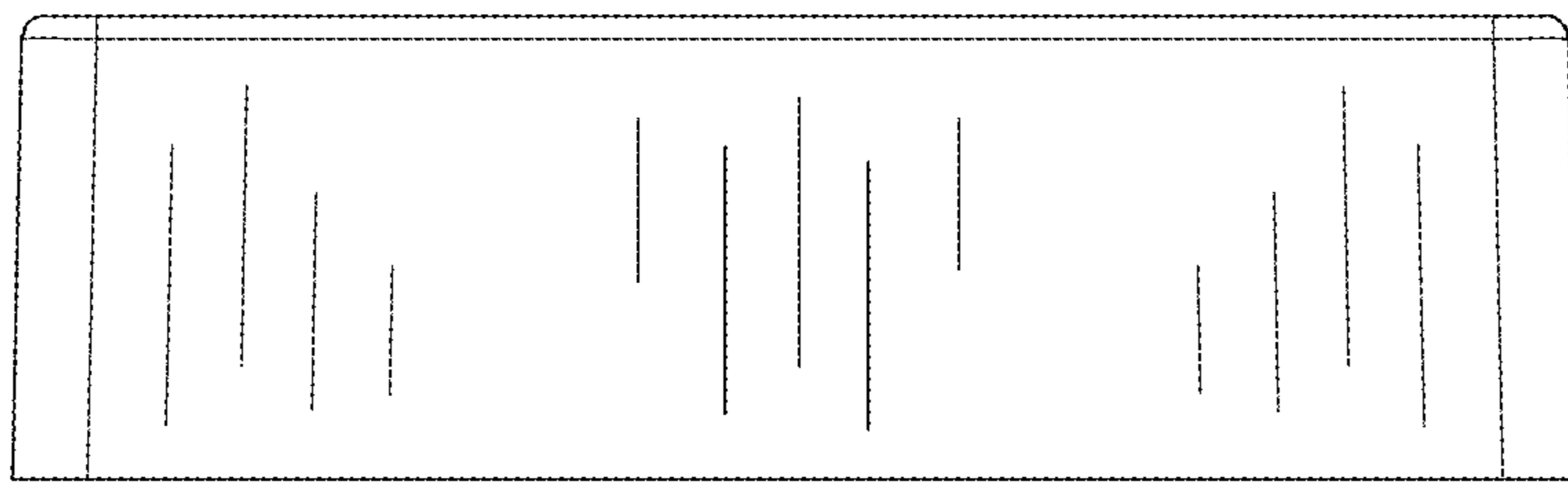

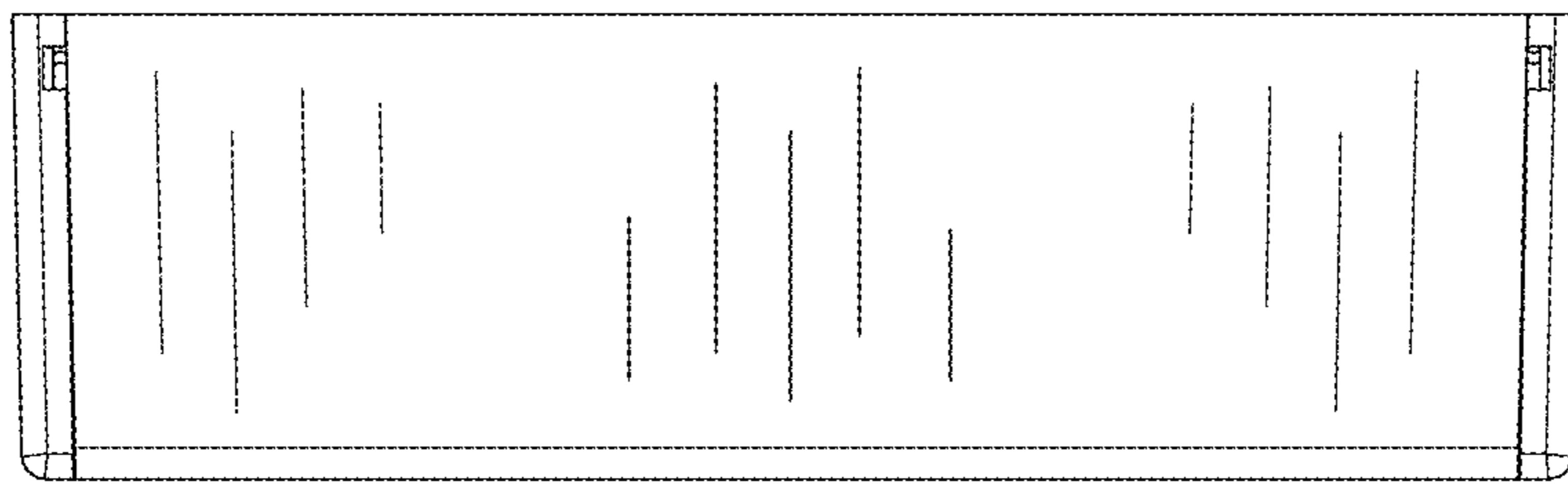
