(57) **CLAIM**

The ornamental design for a face mask, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a face mask showing my new design worn on a user face;
FIG. 2 is a left-side elevational view thereof;
FIG. 3 is another perspective view thereof;
FIG. 4 is a left-side elevational view thereof showing my new design removed from the user face;
FIG. 5 is a right-side elevational view thereof;
FIG. 6 is a front elevational view thereof;
FIG. 7 is a rear elevational view thereof;
FIG. 8 is a top plan view thereof;
FIG. 9 is a bottom plan view thereof;
FIG. 10 is a left-side elevational view thereof wherein the face mask is turned inside-out;
FIG. 11 is a cross-sectional view taken along line 11-11 in FIG. 3;
FIG. 12 is another cross-sectional view thereof with the back in an open state;
FIG. 13 is a second embodiment perspective view of the face mask shown in FIG. 1;
FIG. 14 is a left-side elevational view of FIG. 13;
FIG. 15 is another perspective view of FIG. 13;
FIG. 16 is a left-side elevational view of FIG. 13 showing my new design removed from the user face;
FIG. 17 is a right-side elevational view of FIG. 13;
FIG. 18 is a front elevational view of FIG. 13;
FIG. 19 is a rear elevational view of FIG. 13;
FIG. 20 is a top plan view of FIG. 13;
FIG. 21 is a bottom plan view of FIG. 13;
FIG. 22 is a left-side elevational view of FIG. 13 with the face mask turned inside-out showing the internal back pocket and the internal front second layer;
FIG. 23 is a cross-sectional view taken along line 11-11 in FIG. 15; and,

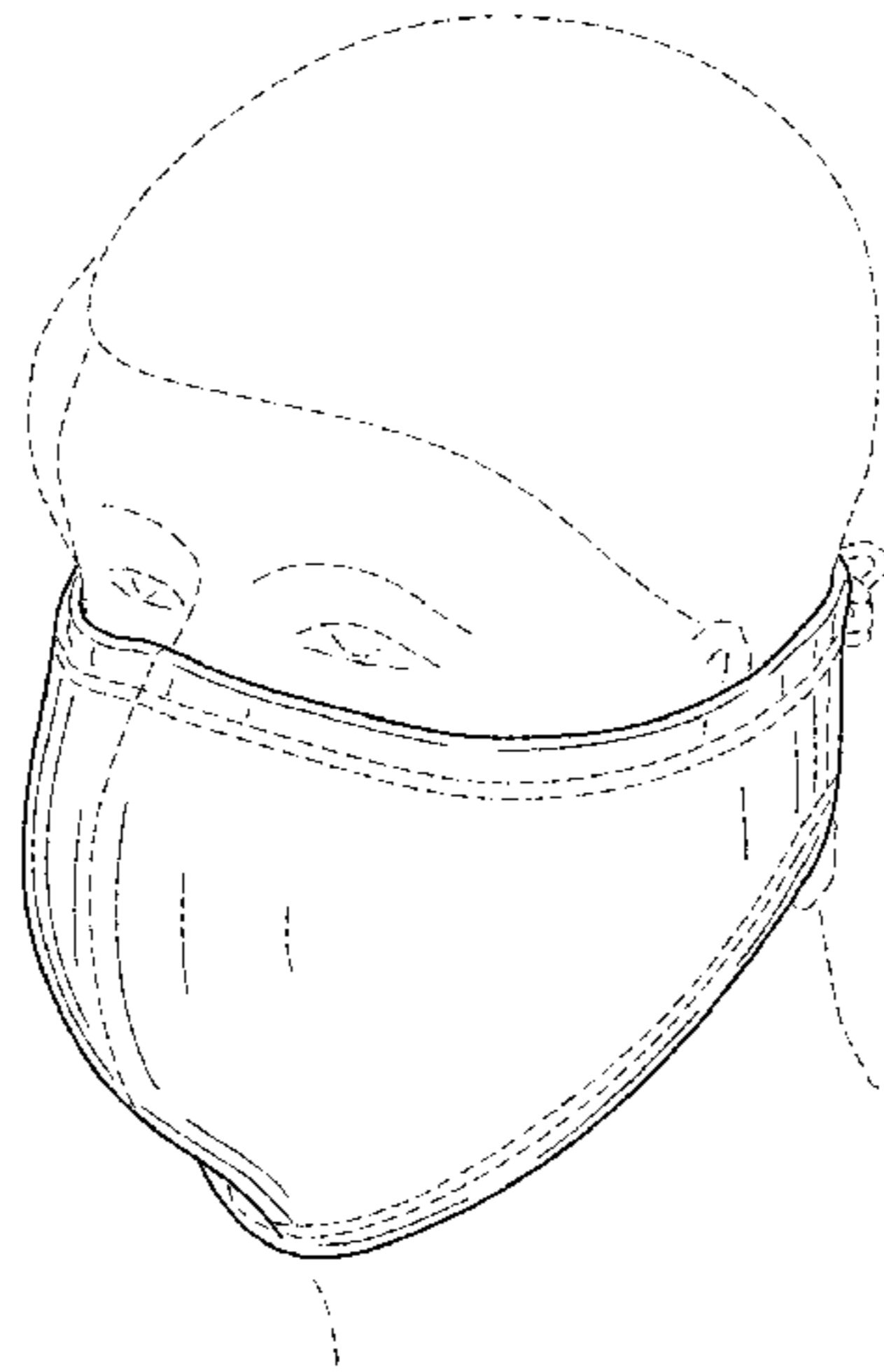


FIG. 24 is another cross-sectional view thereof with the back pocket in an open state.

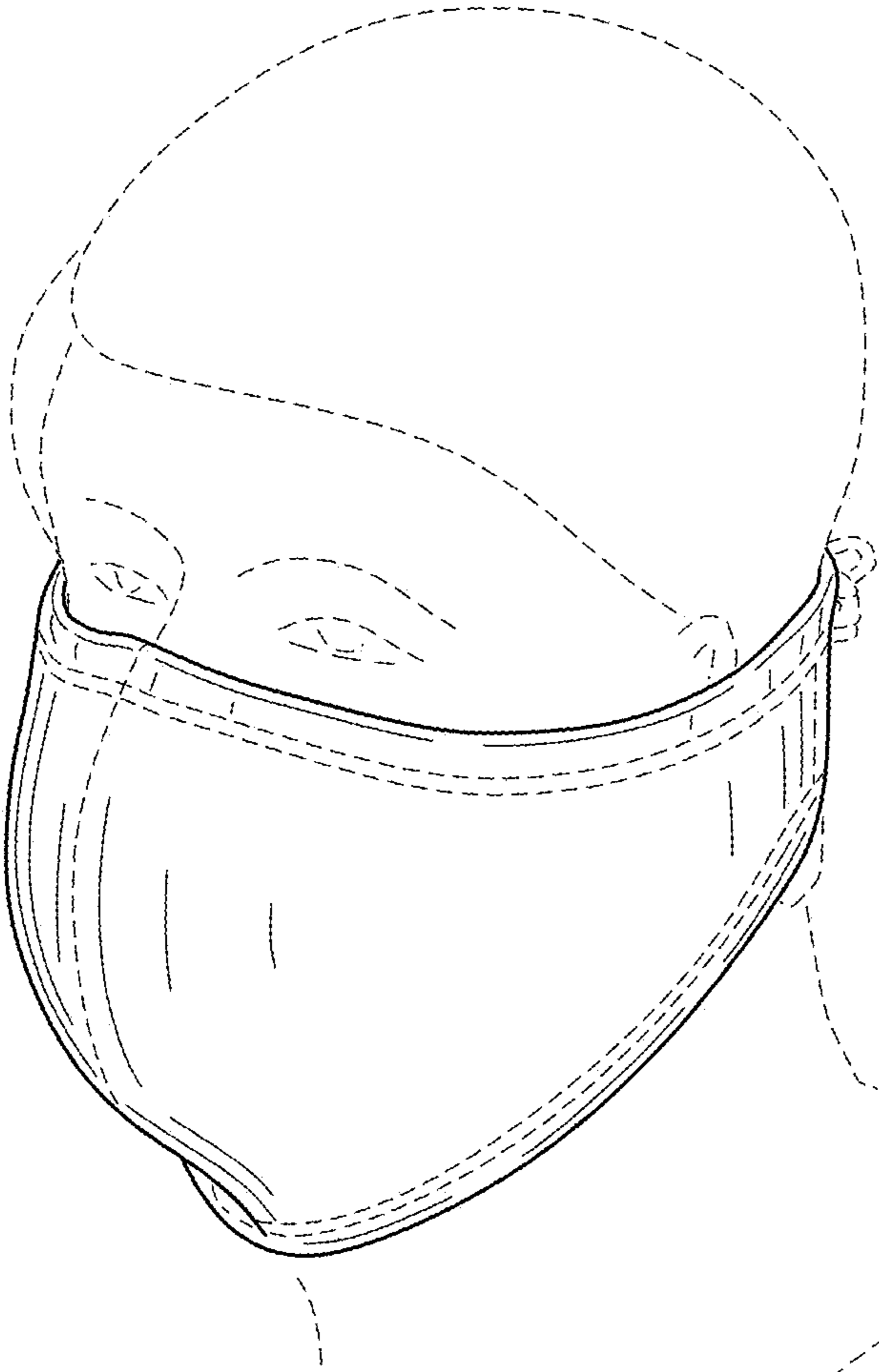

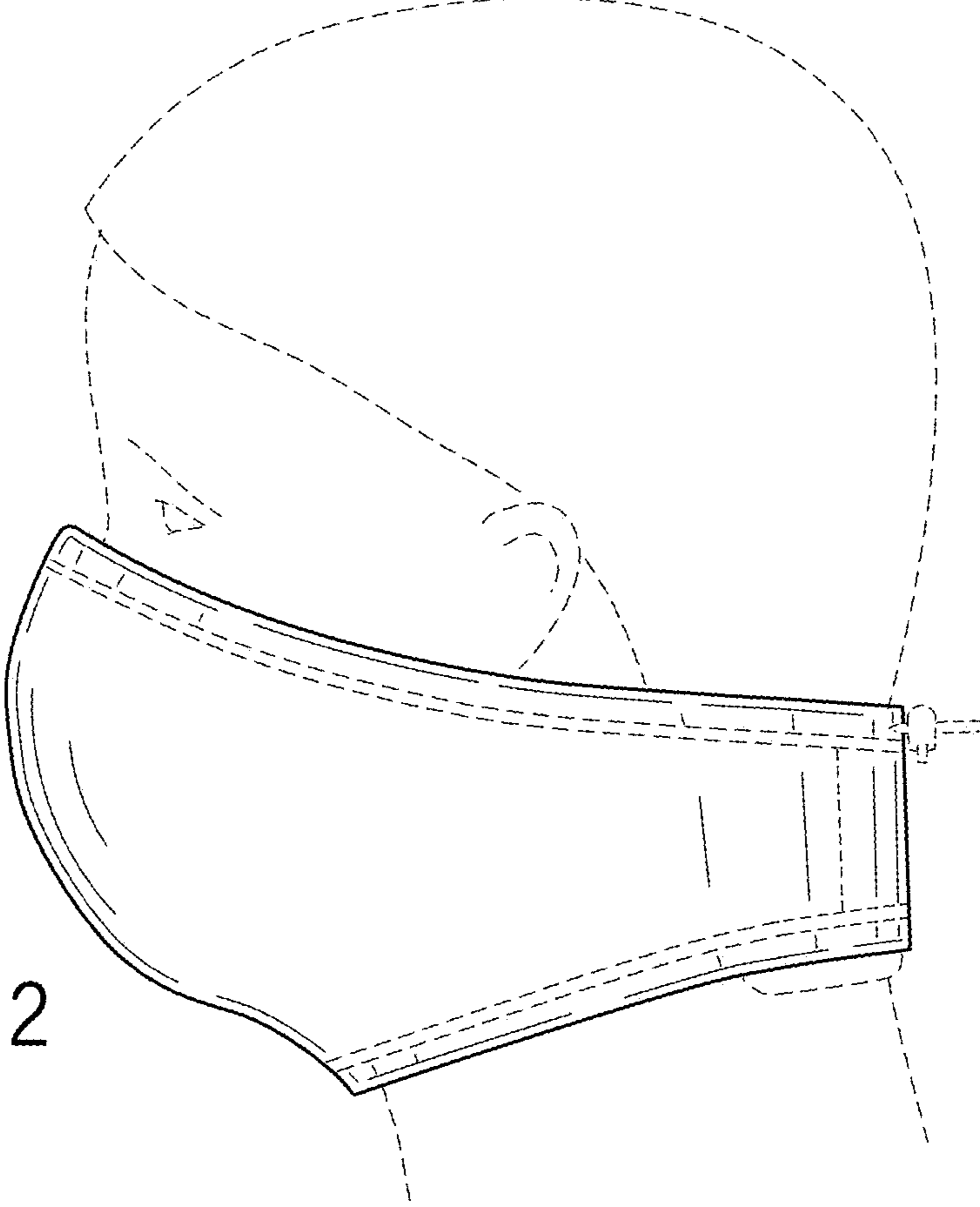

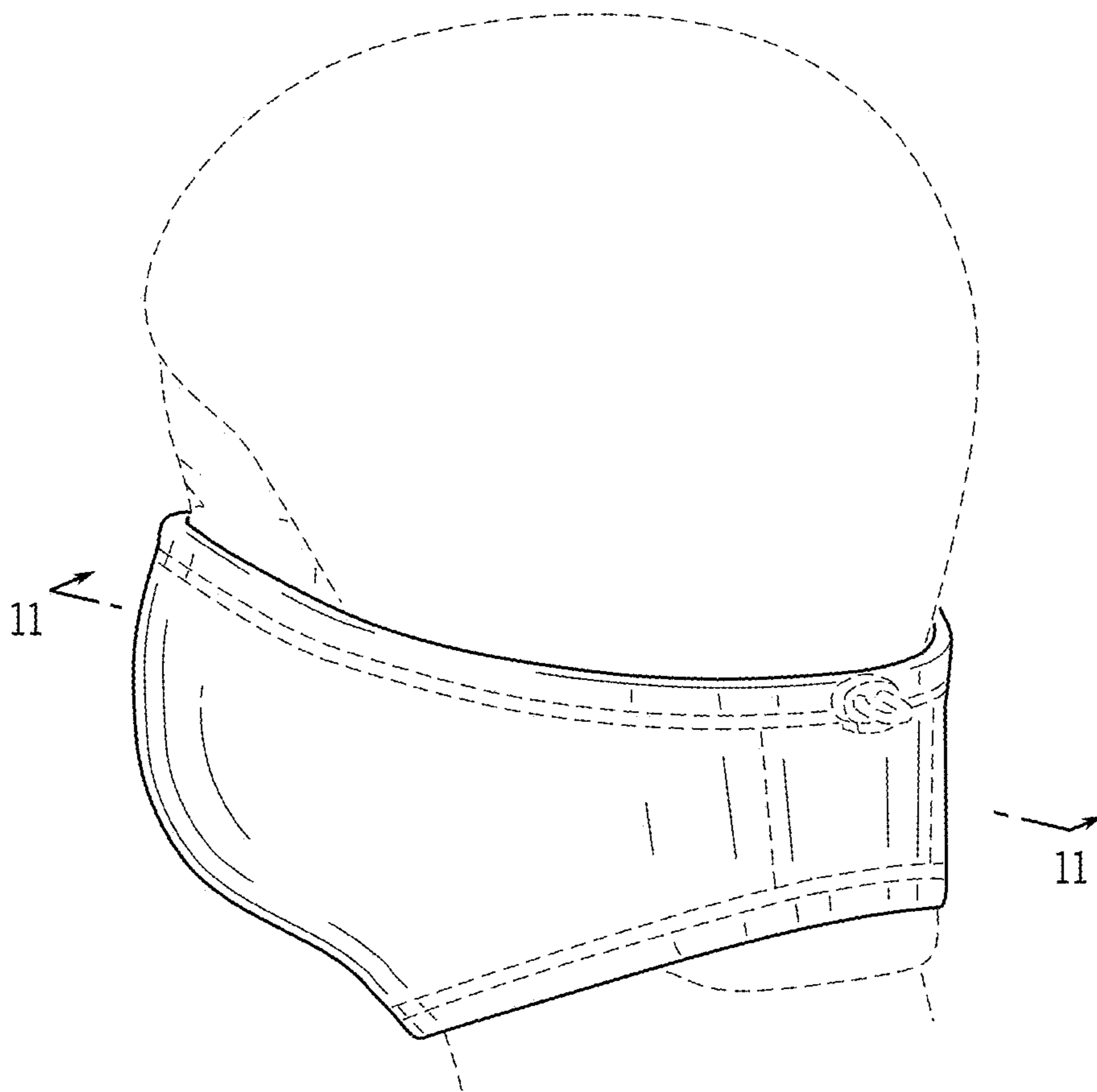

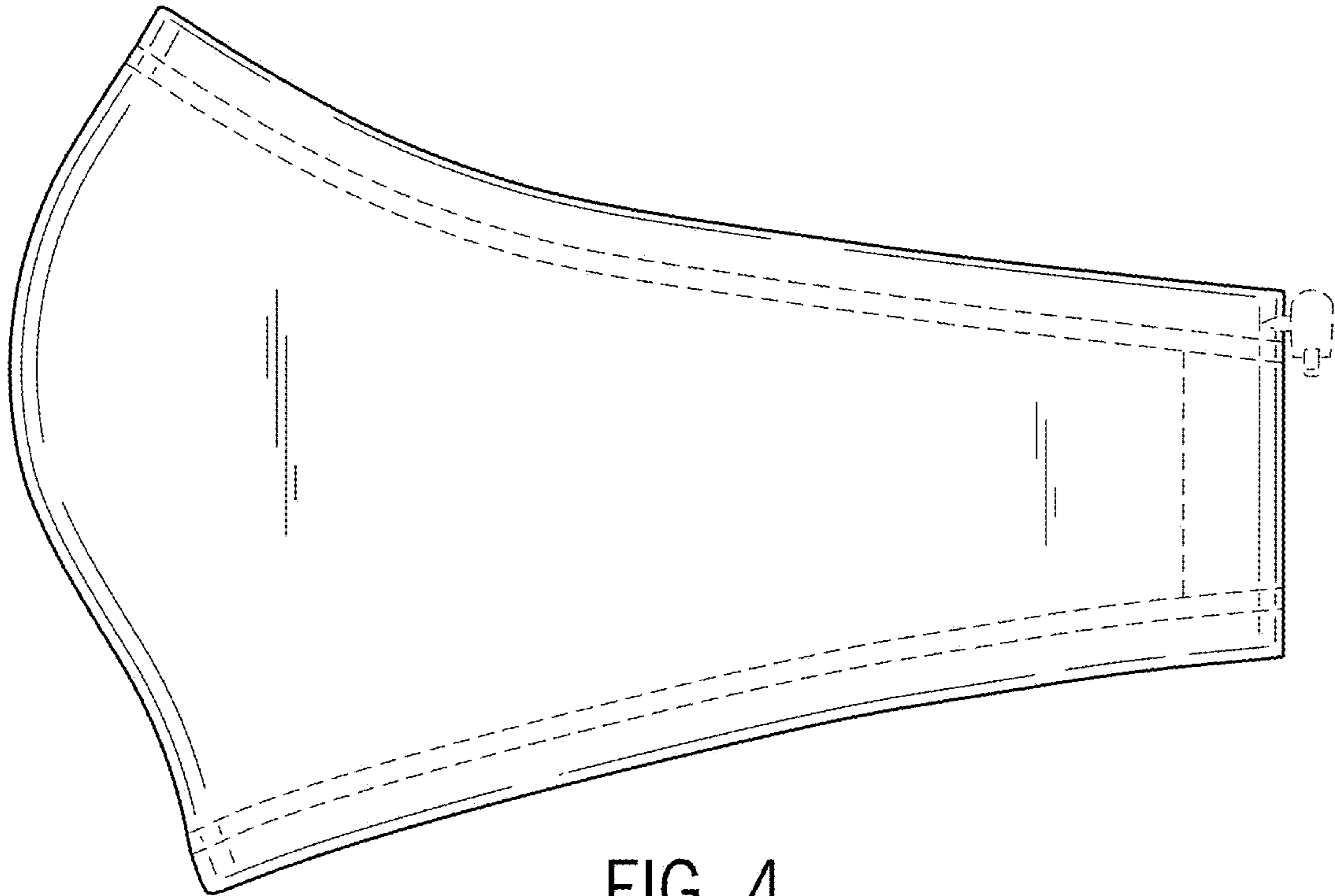

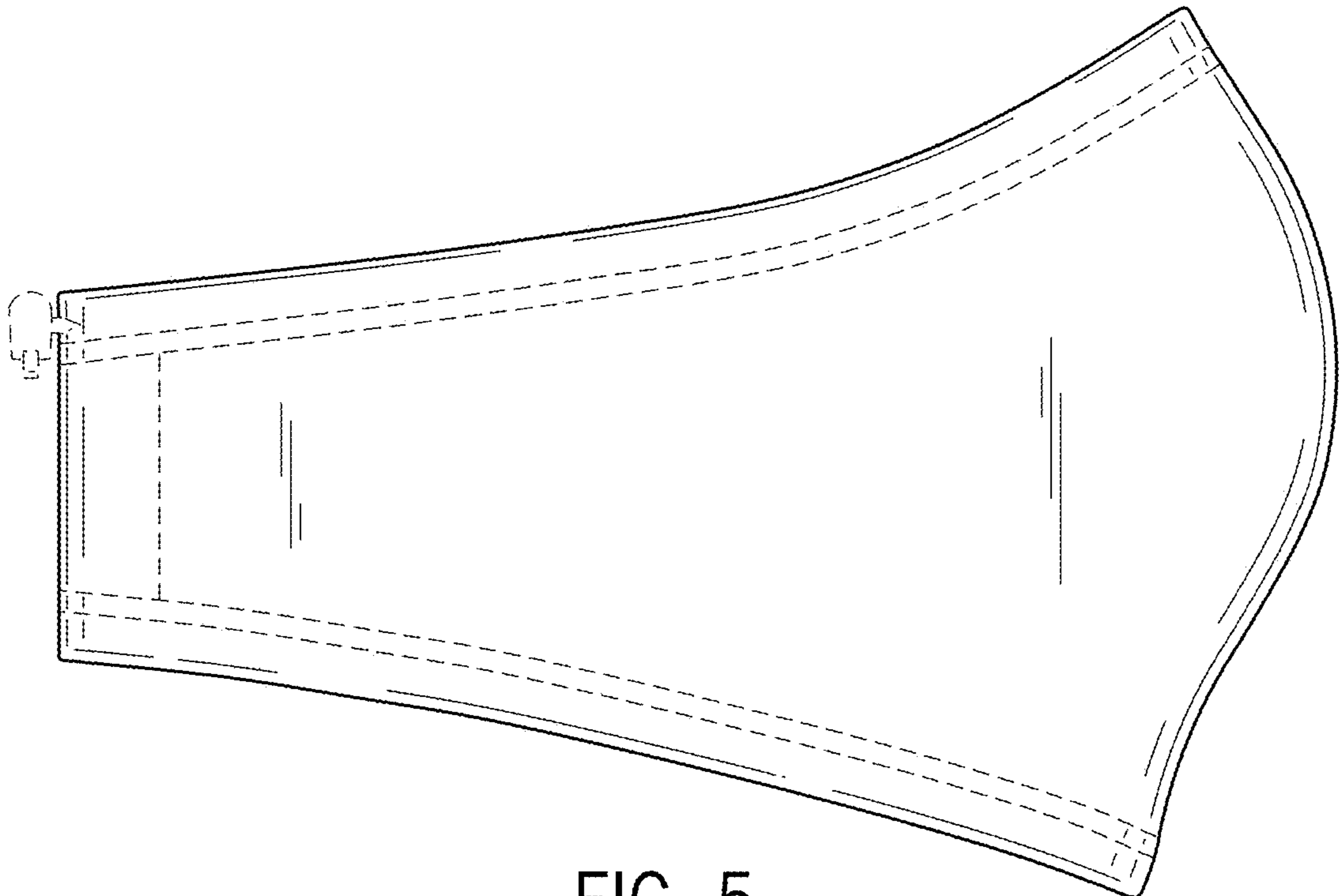

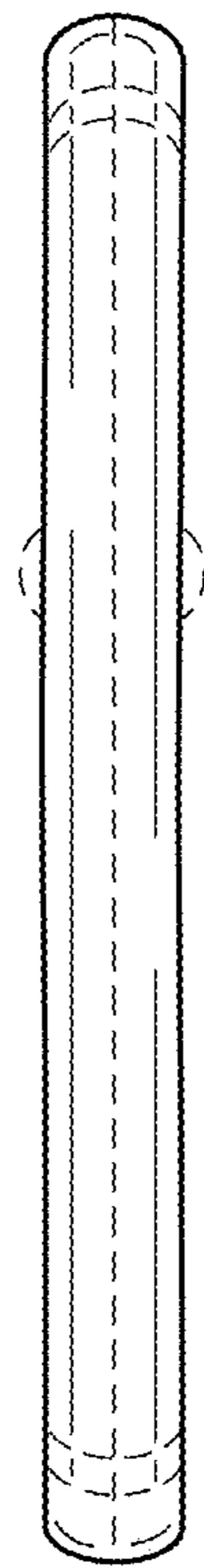

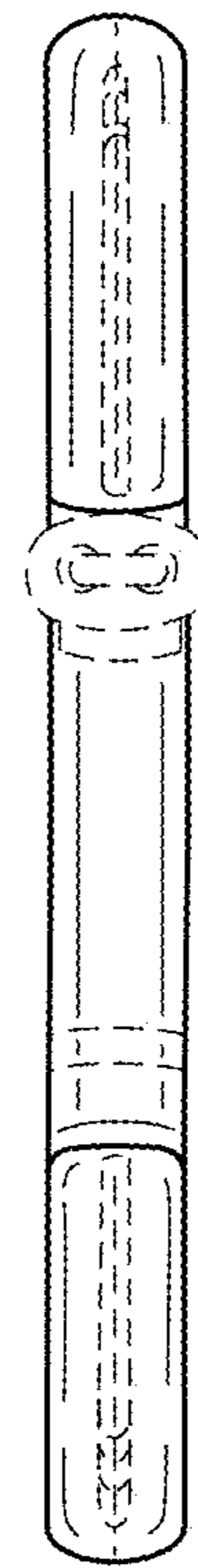

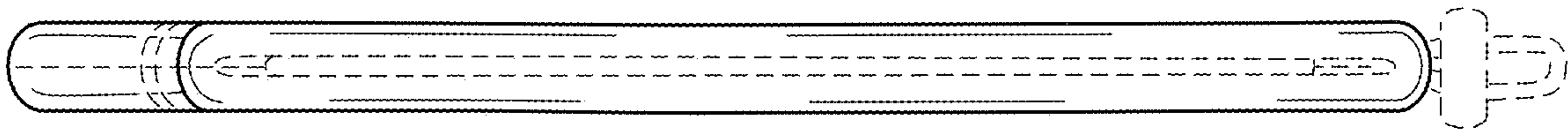

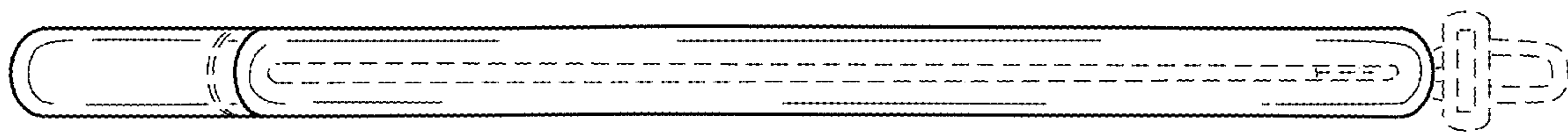

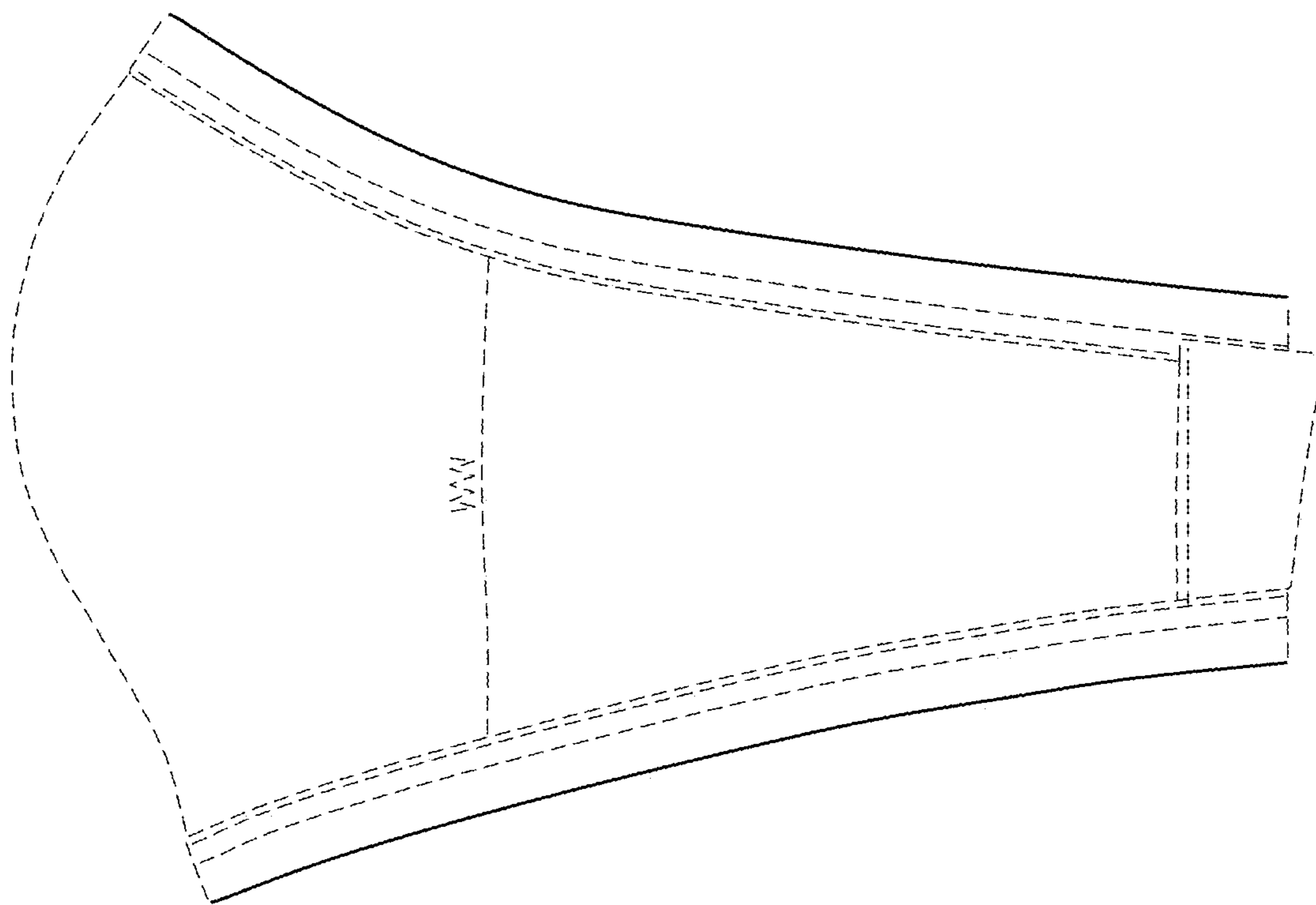

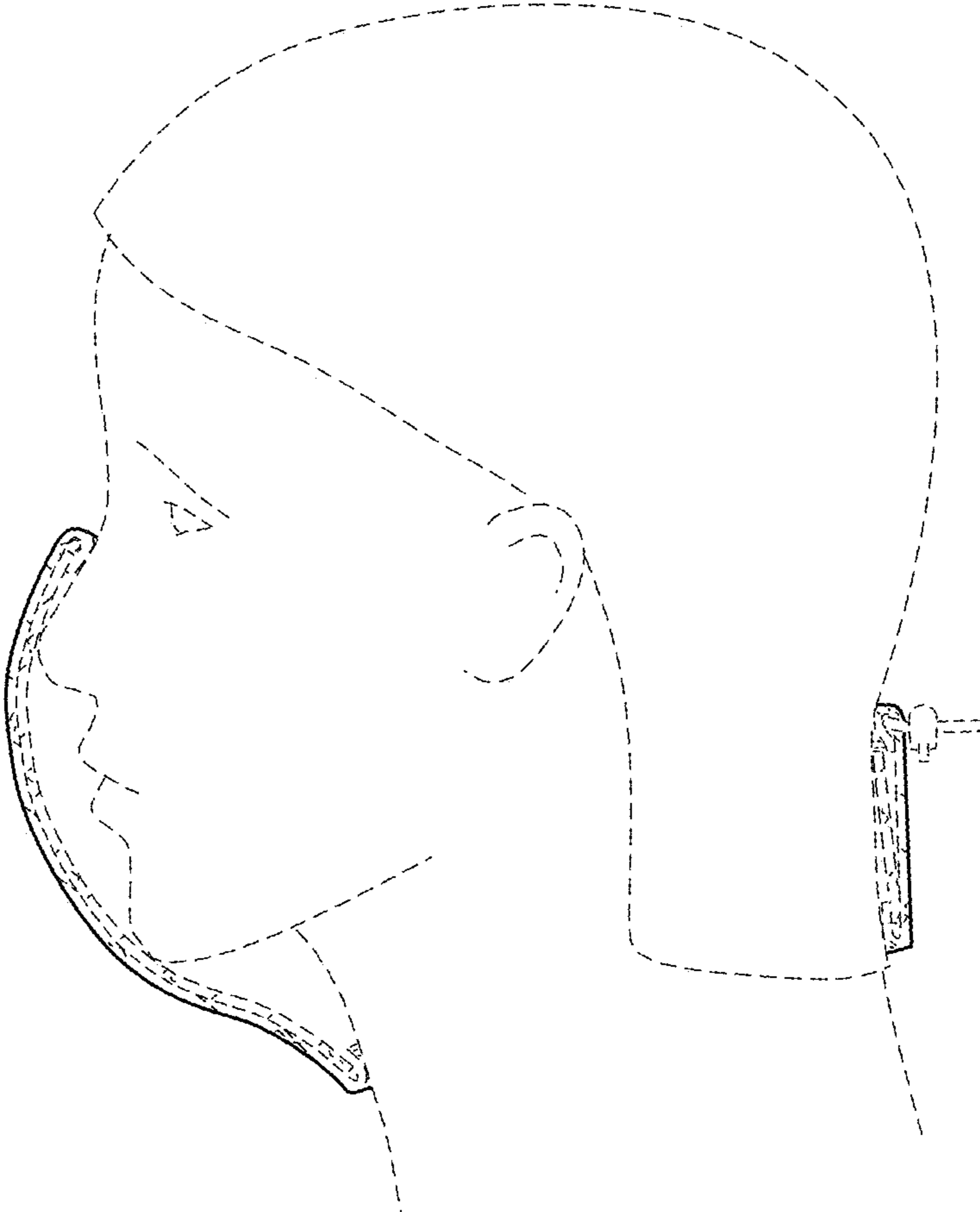

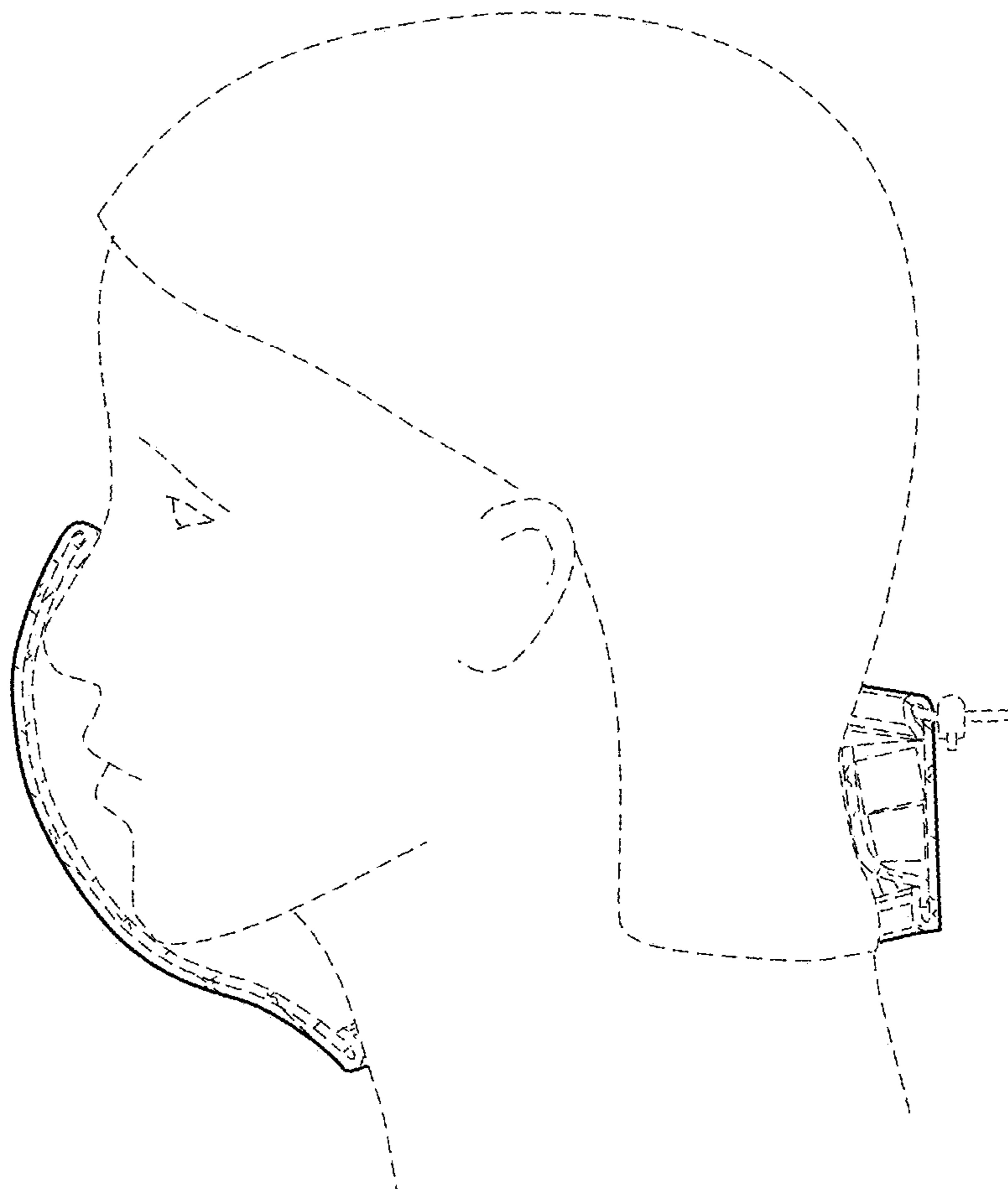

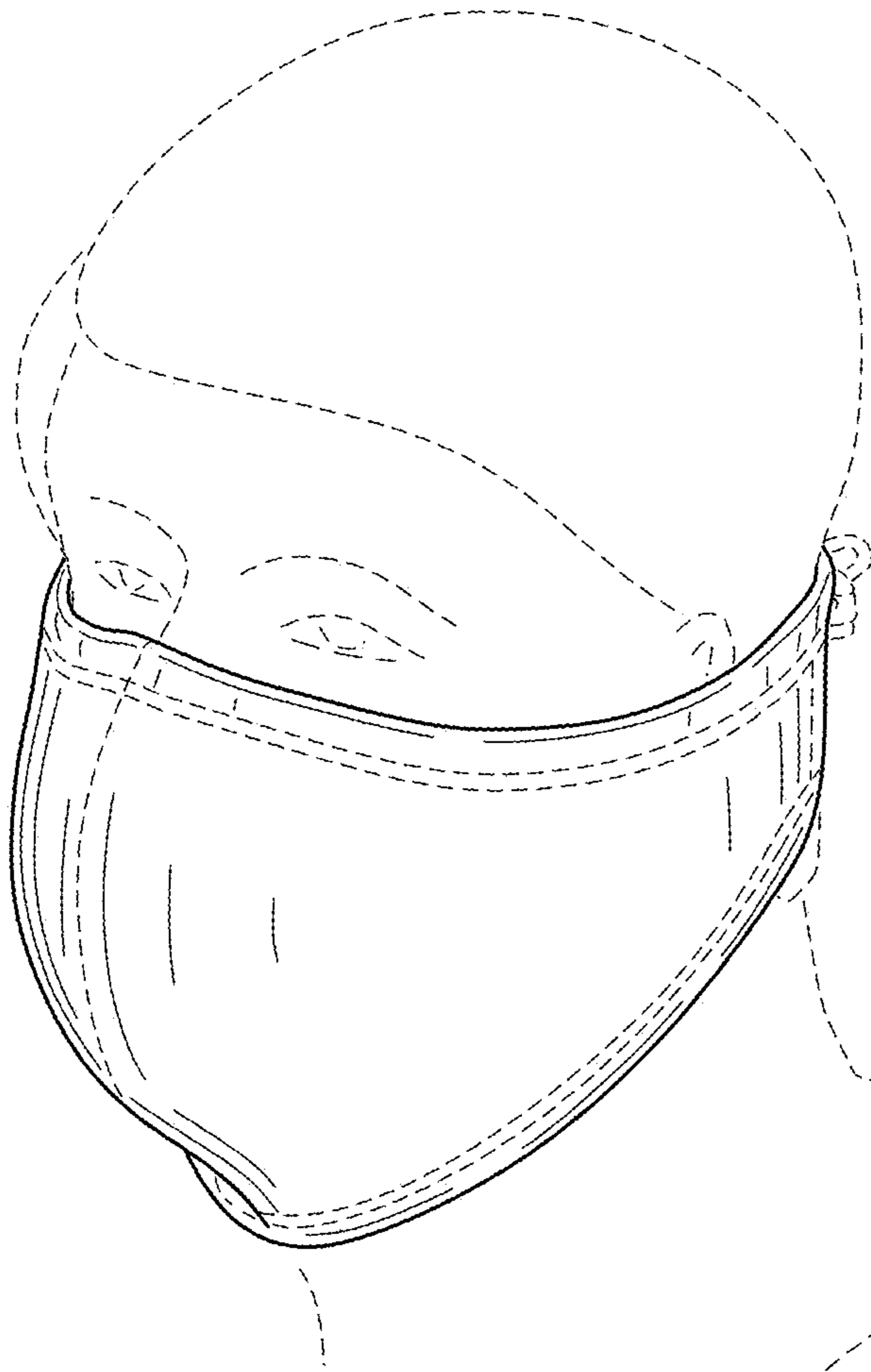

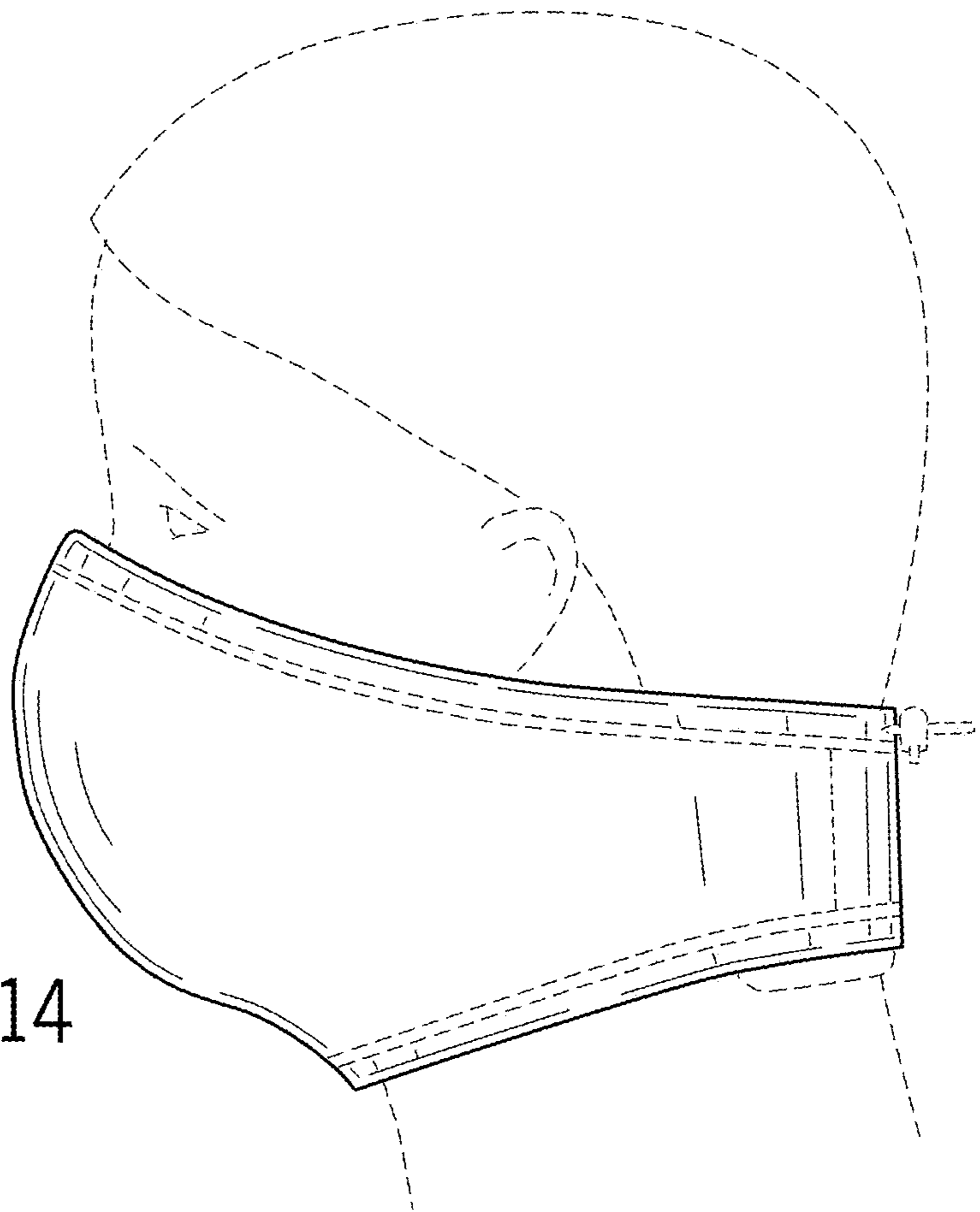

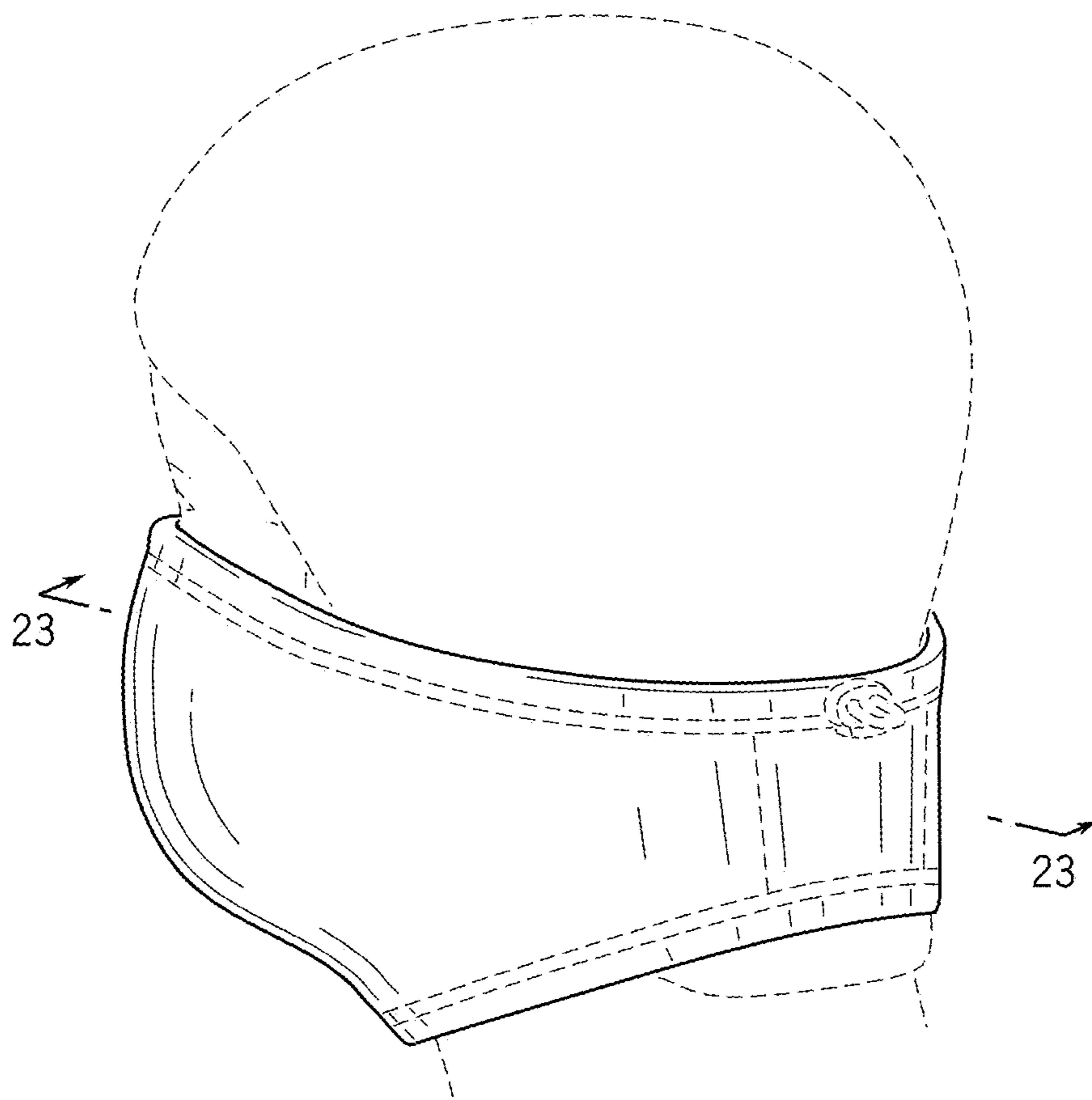

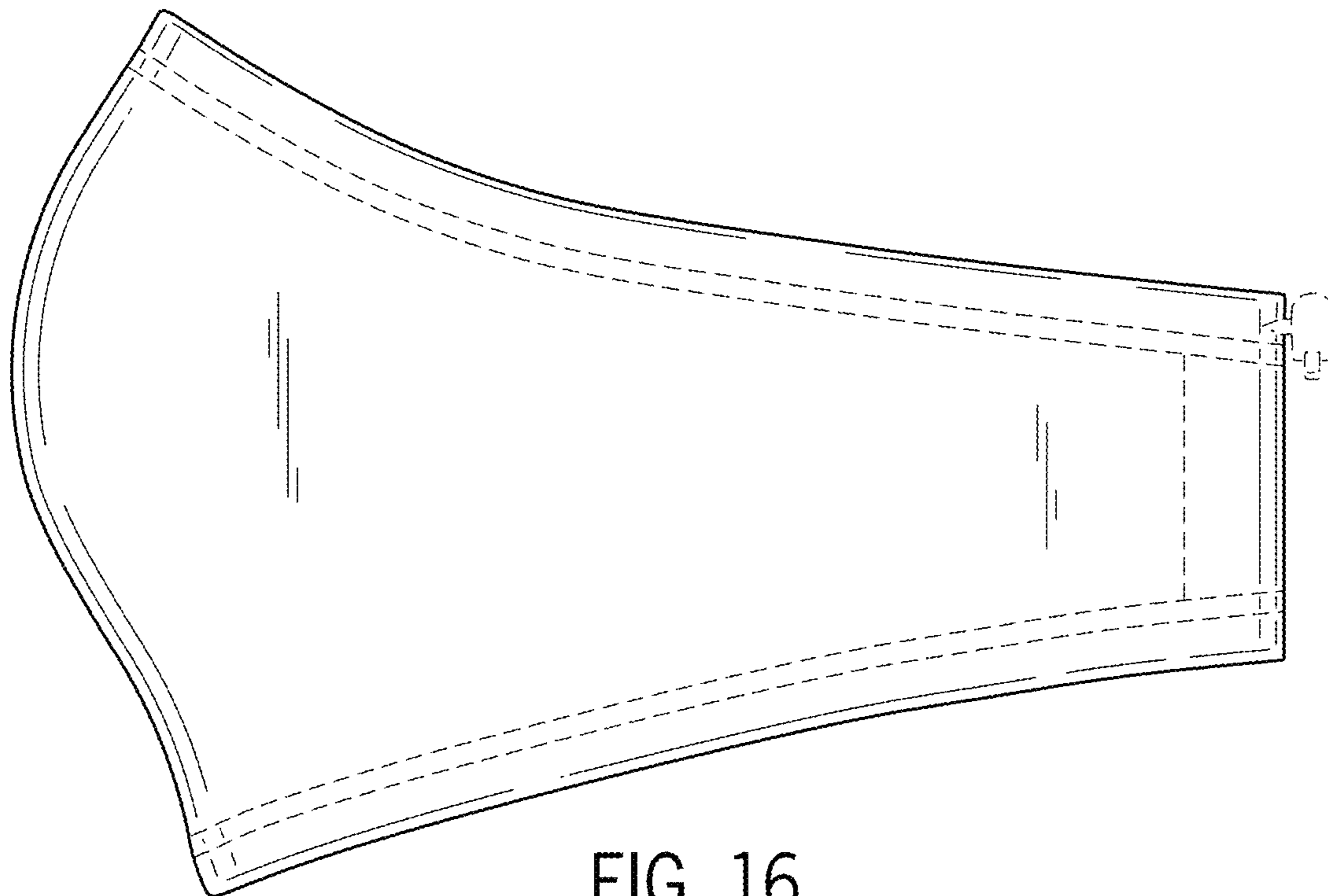

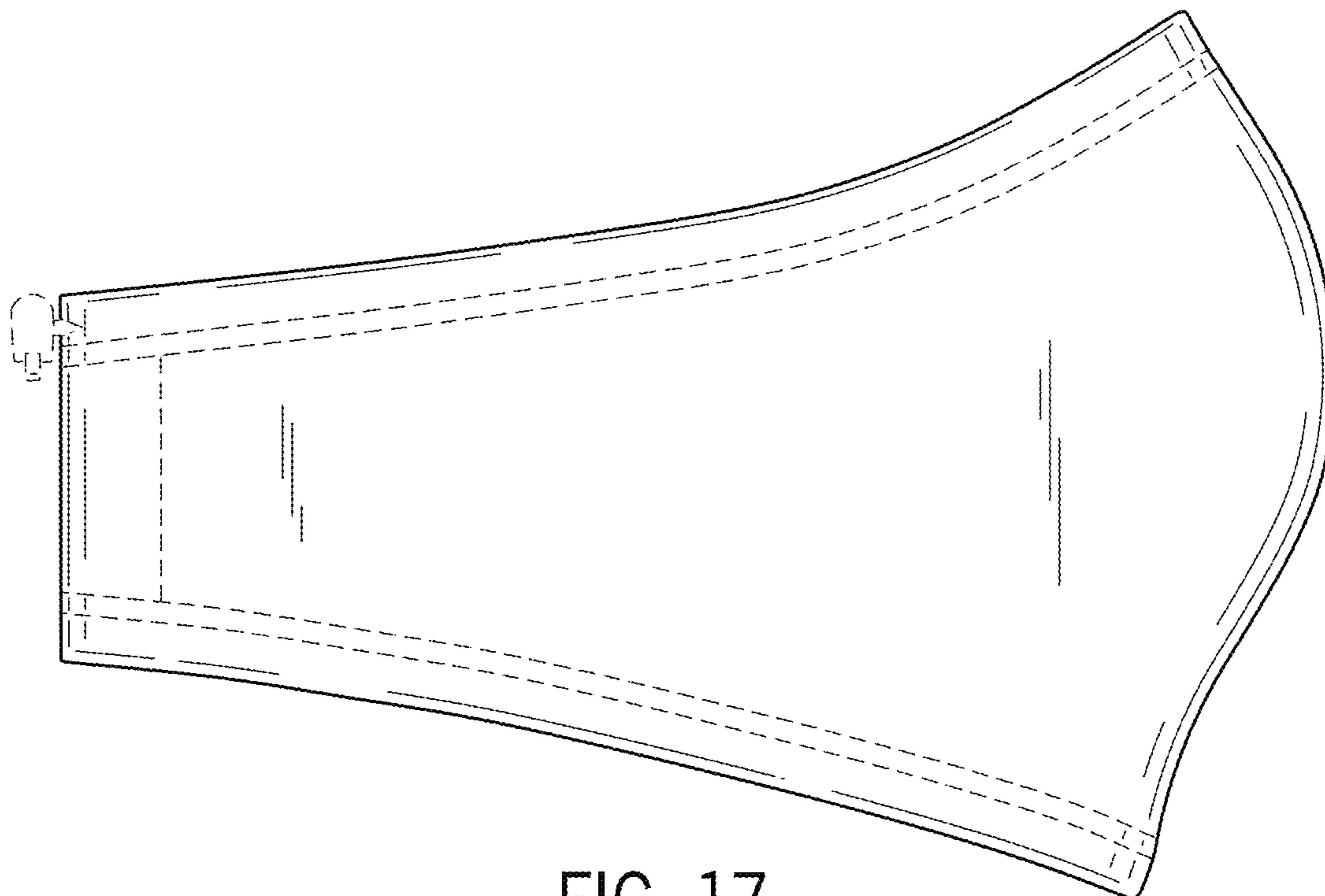

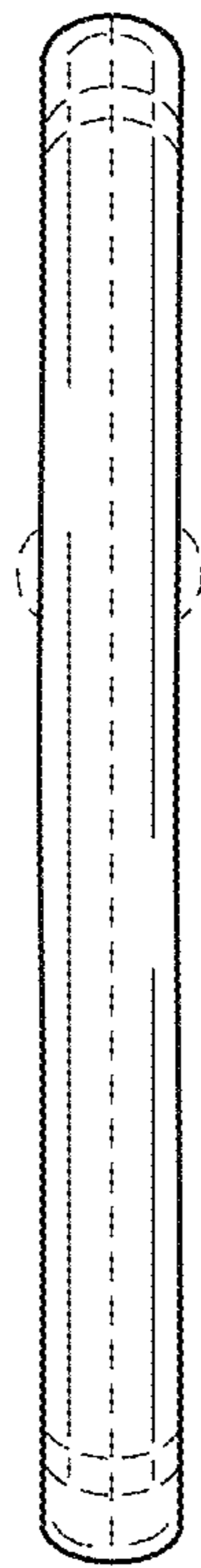

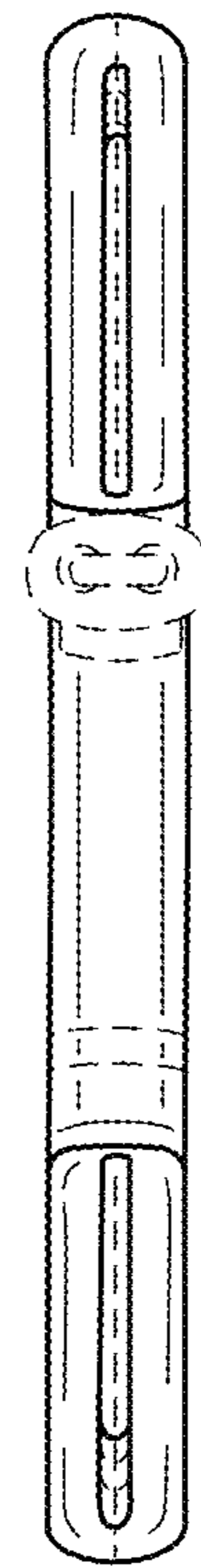

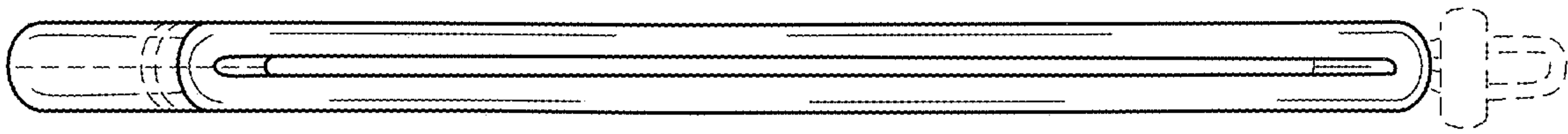

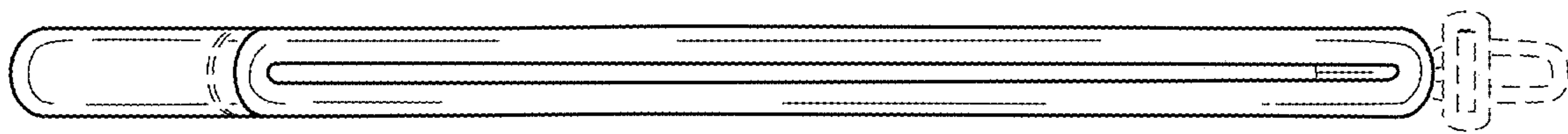

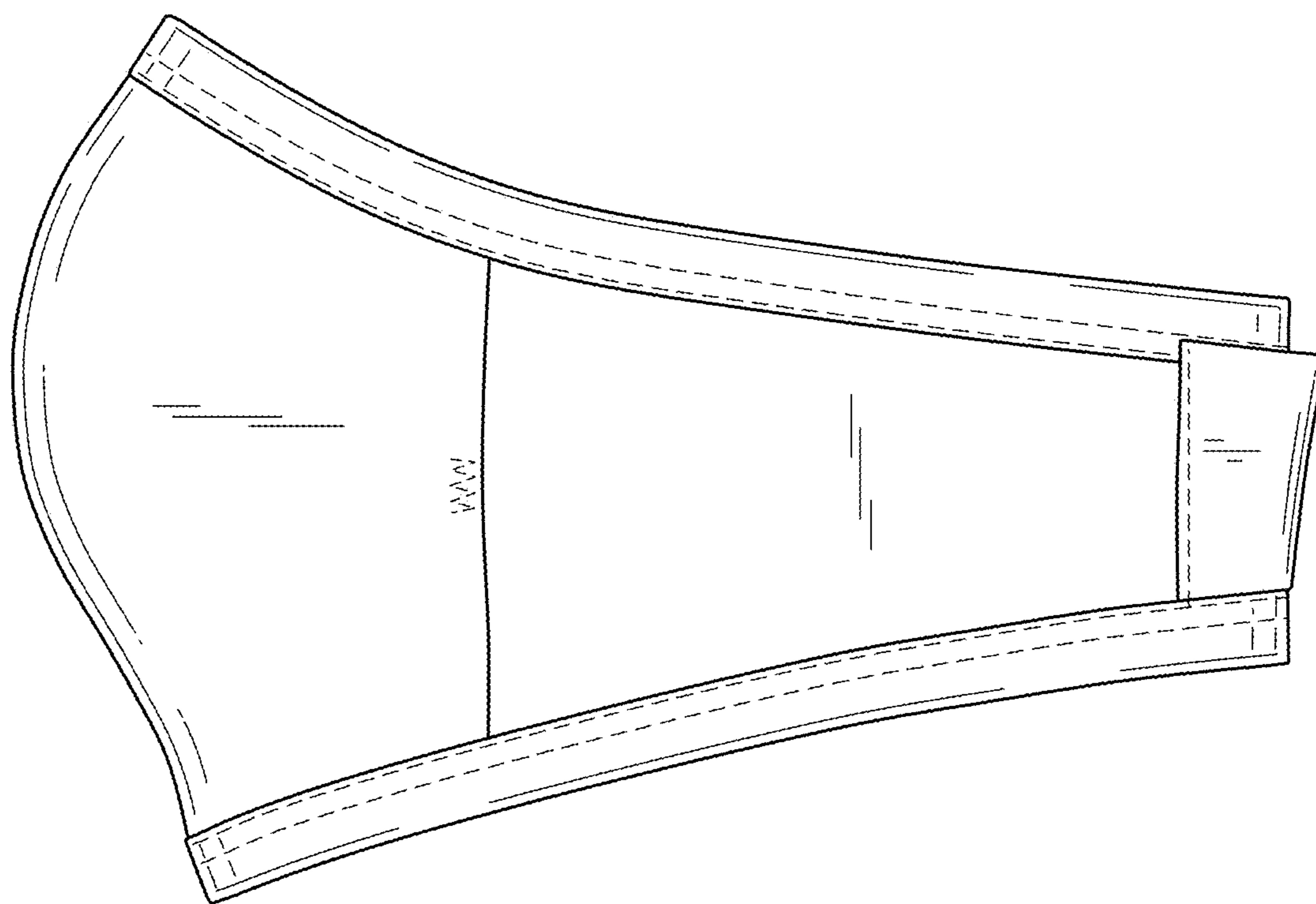

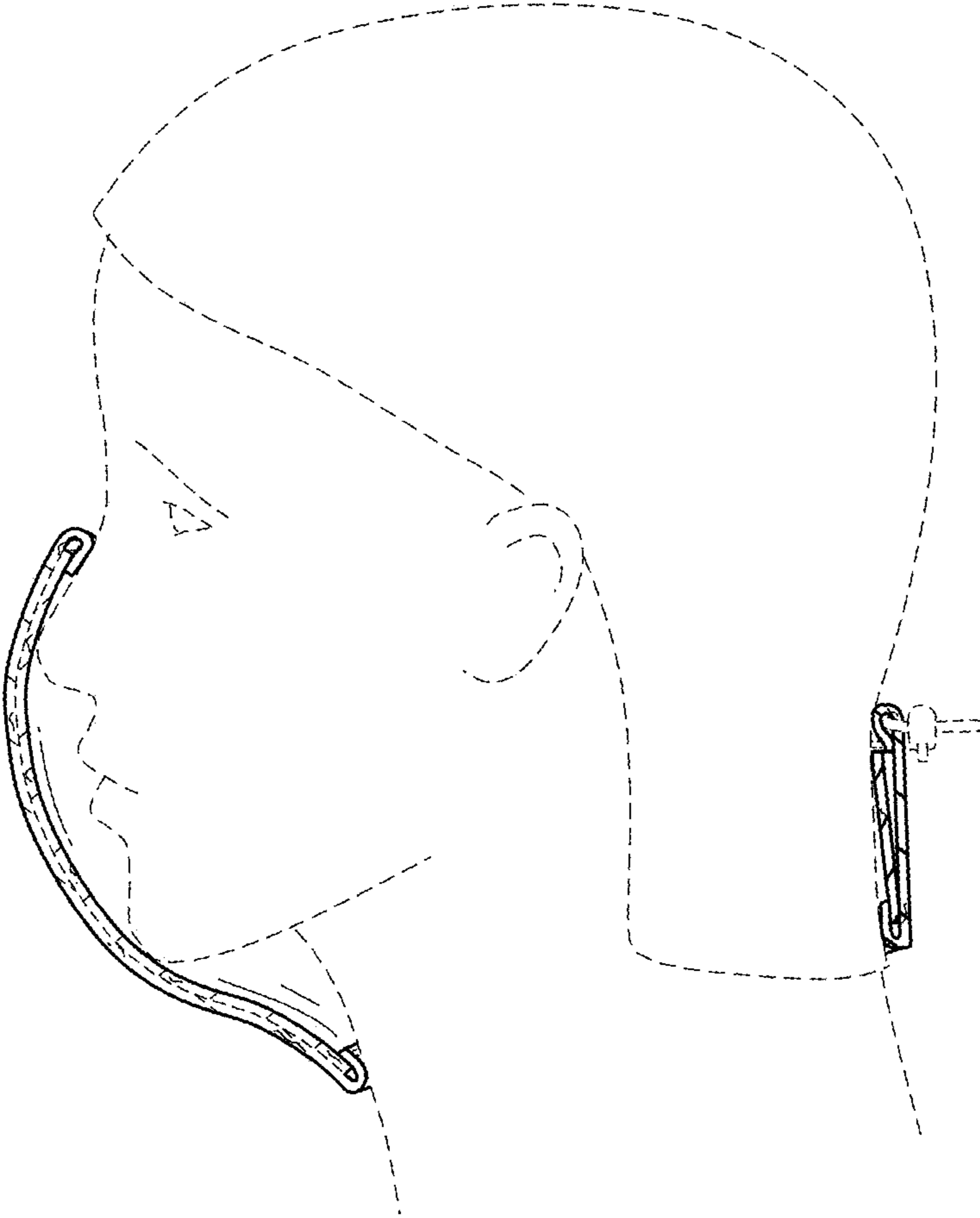

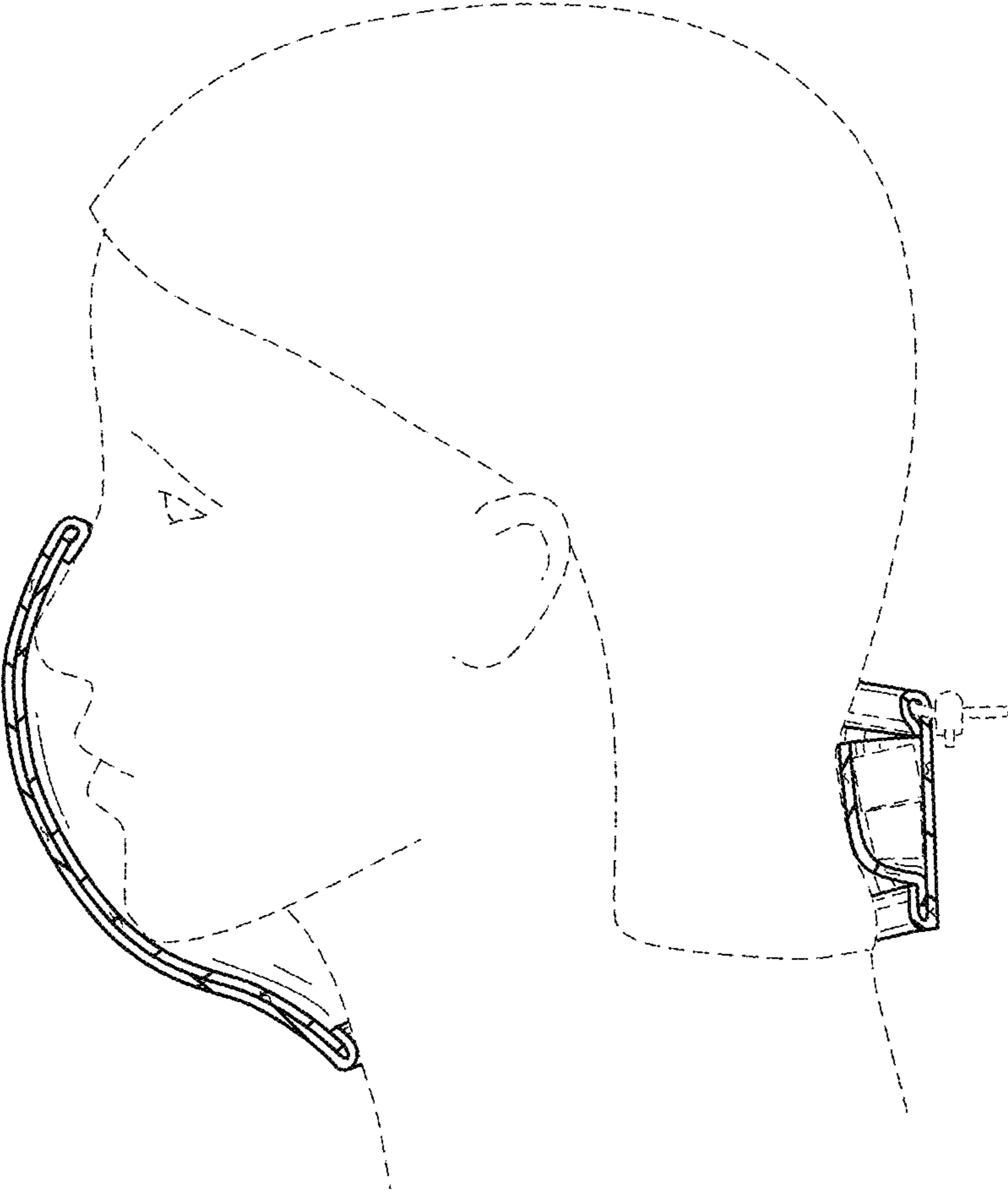
