(57) **CLAIM**

The ornamental design for a seat belt buckle for racing vehicles, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a seat belt buckle for racing vehicles showing my design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

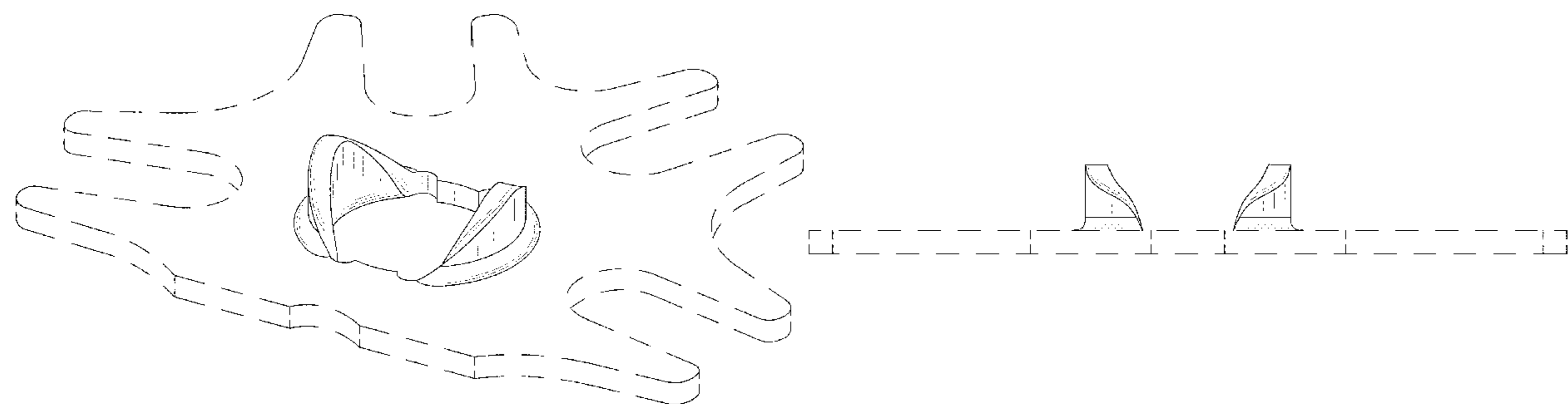
The broken lines shown in the drawings depict portions of the seat belt buckle for racing vehicles that form no part of the claimed design.

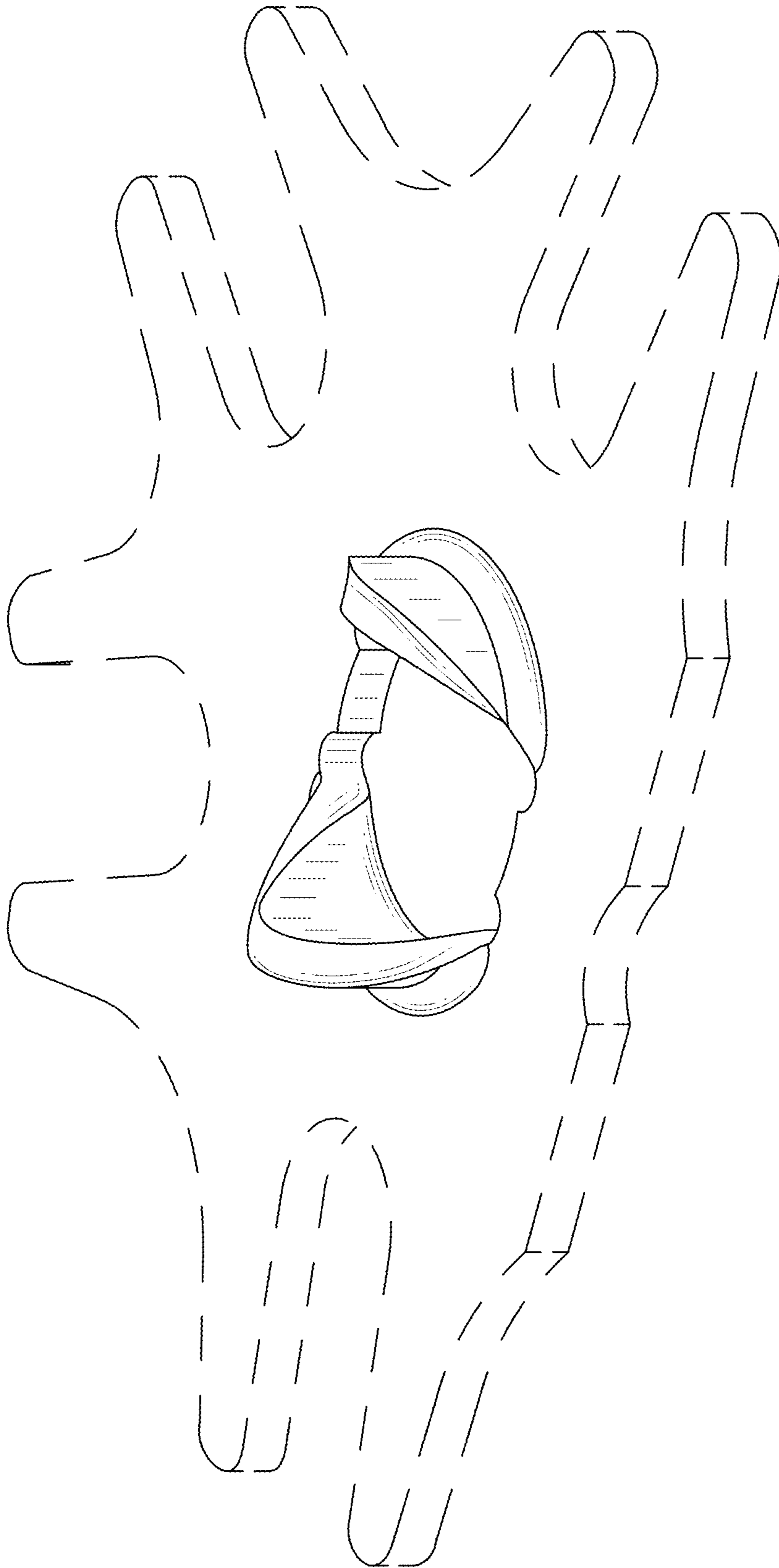

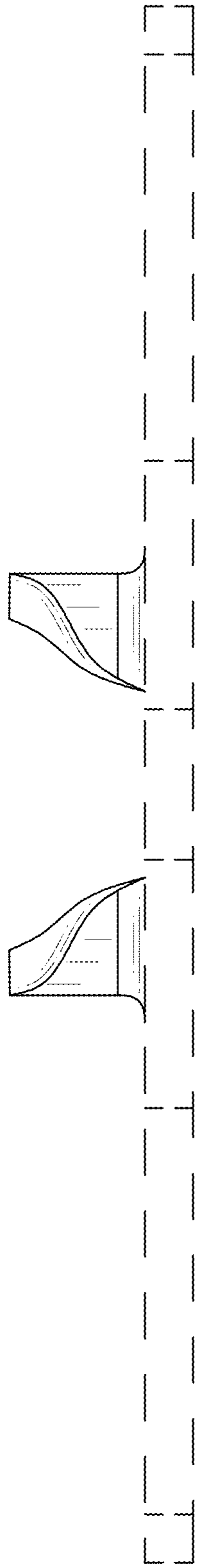

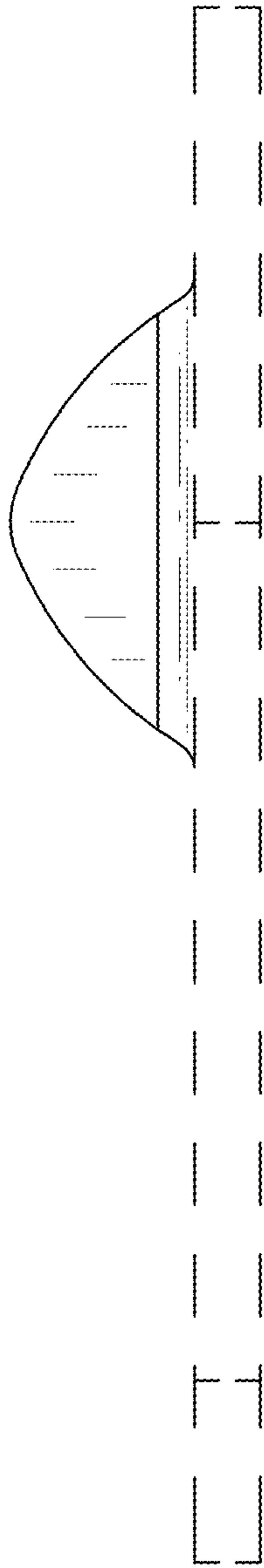

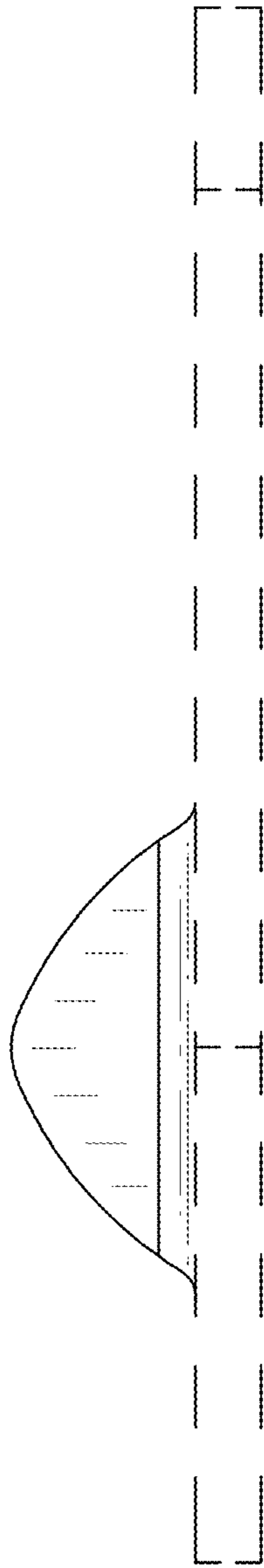

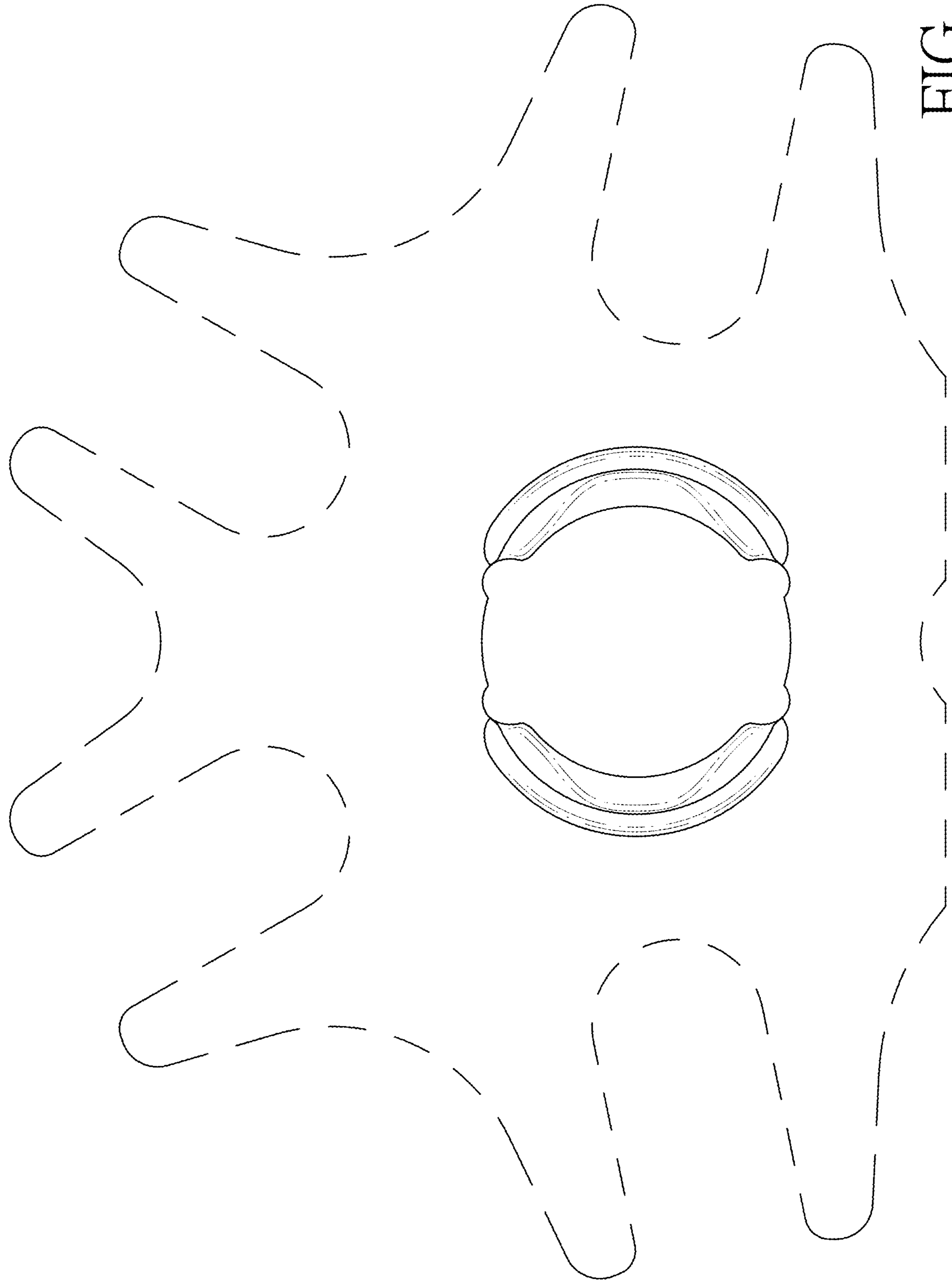

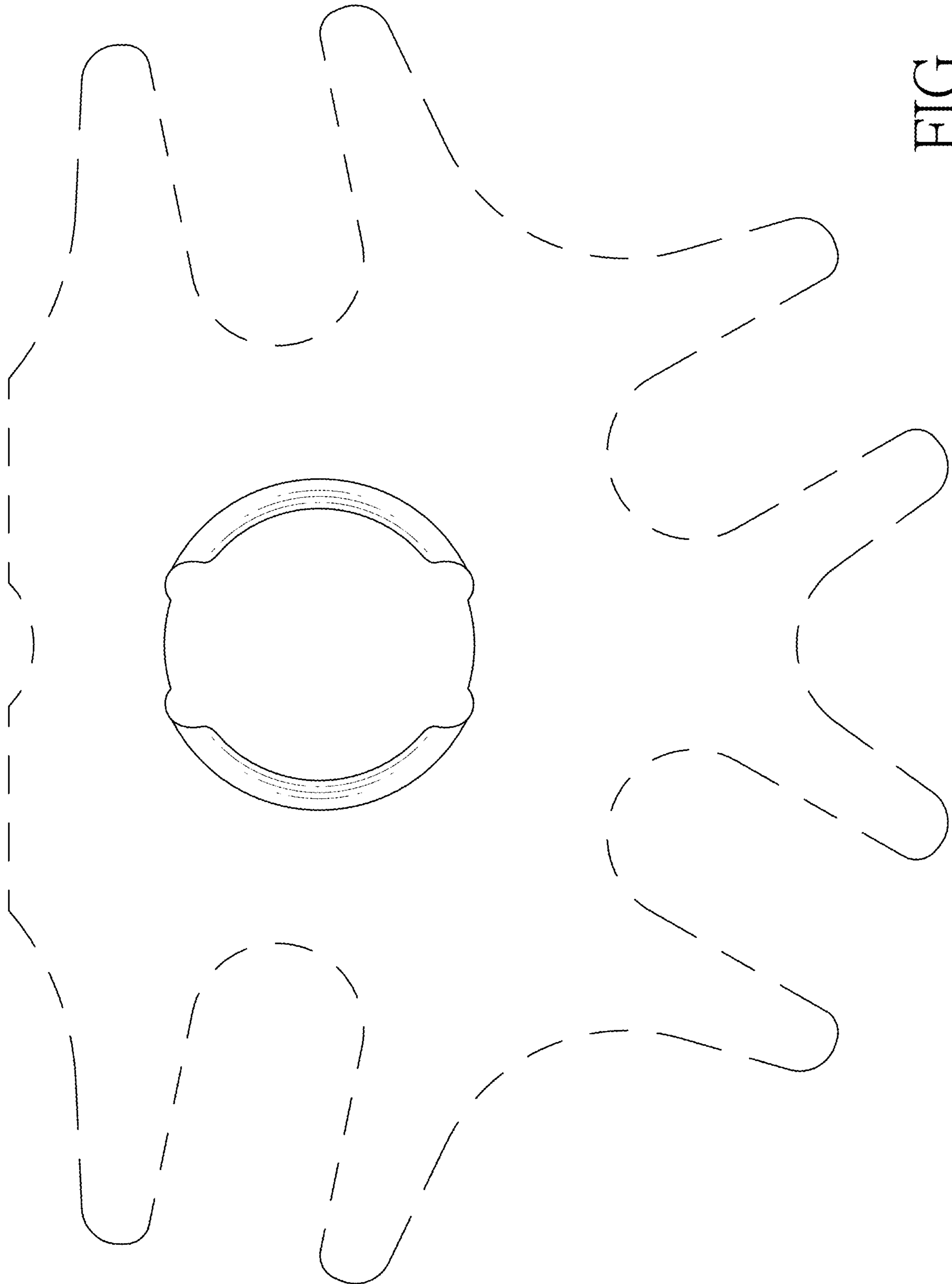
