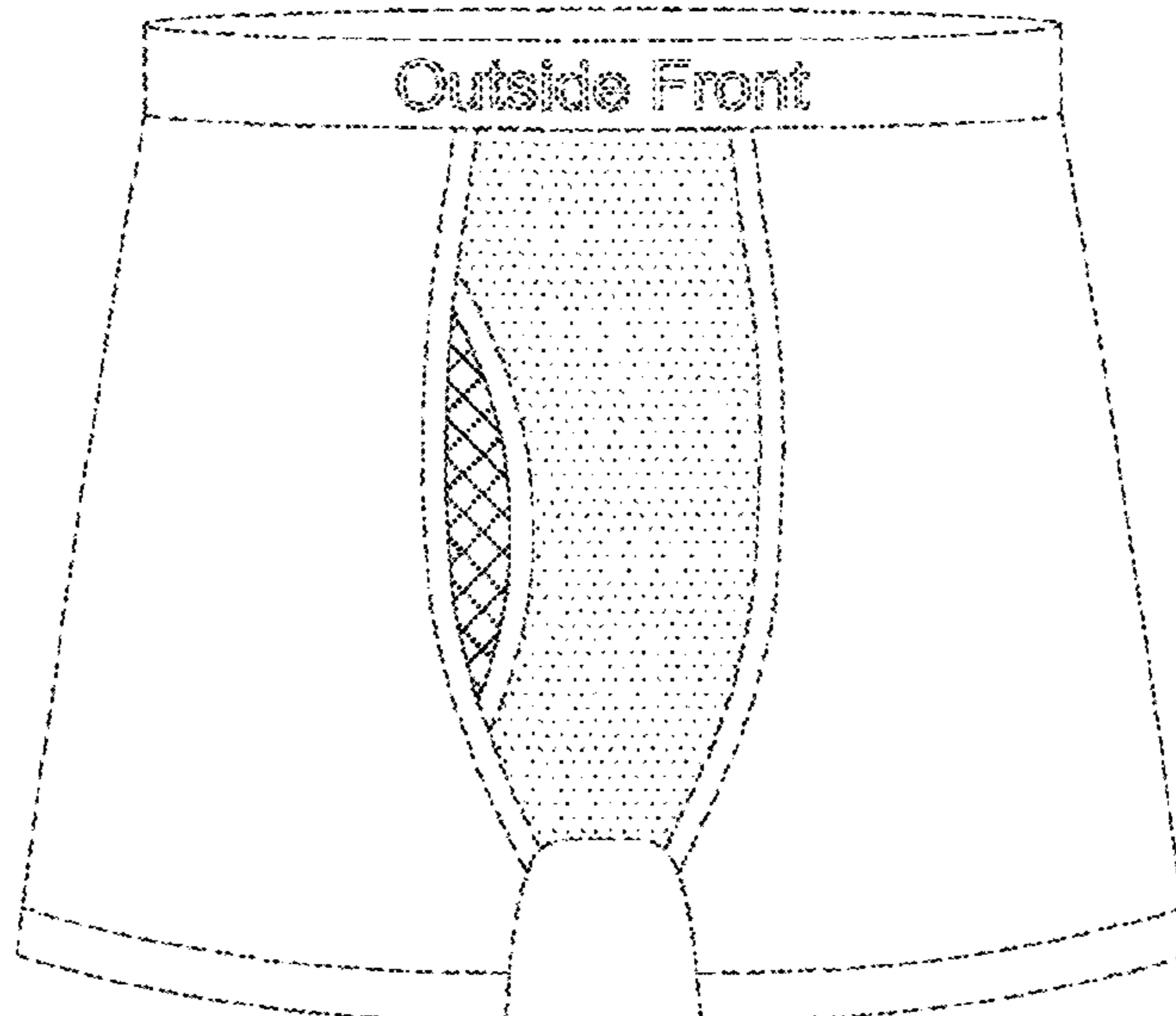
(57) **CLAIM**

The ornamental design for underwear, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front exterior view of underwear in accordance with the present invention shown in a first embodiment. FIG. 2 is a front interior view thereof. FIG. 3 is a rear exterior view thereof. FIG. 4 is a rear interior view thereof. FIG. 5 is a front exterior view of underwear in accordance with the present invention shown in a second embodiment. FIG. 6 is a front interior view thereof. FIG. 7 is a rear exterior view thereof; and, FIG. 8 is a rear interior view thereof. The broken lines shown in the drawings depict portions of the underwear that form no part of the claimed design. 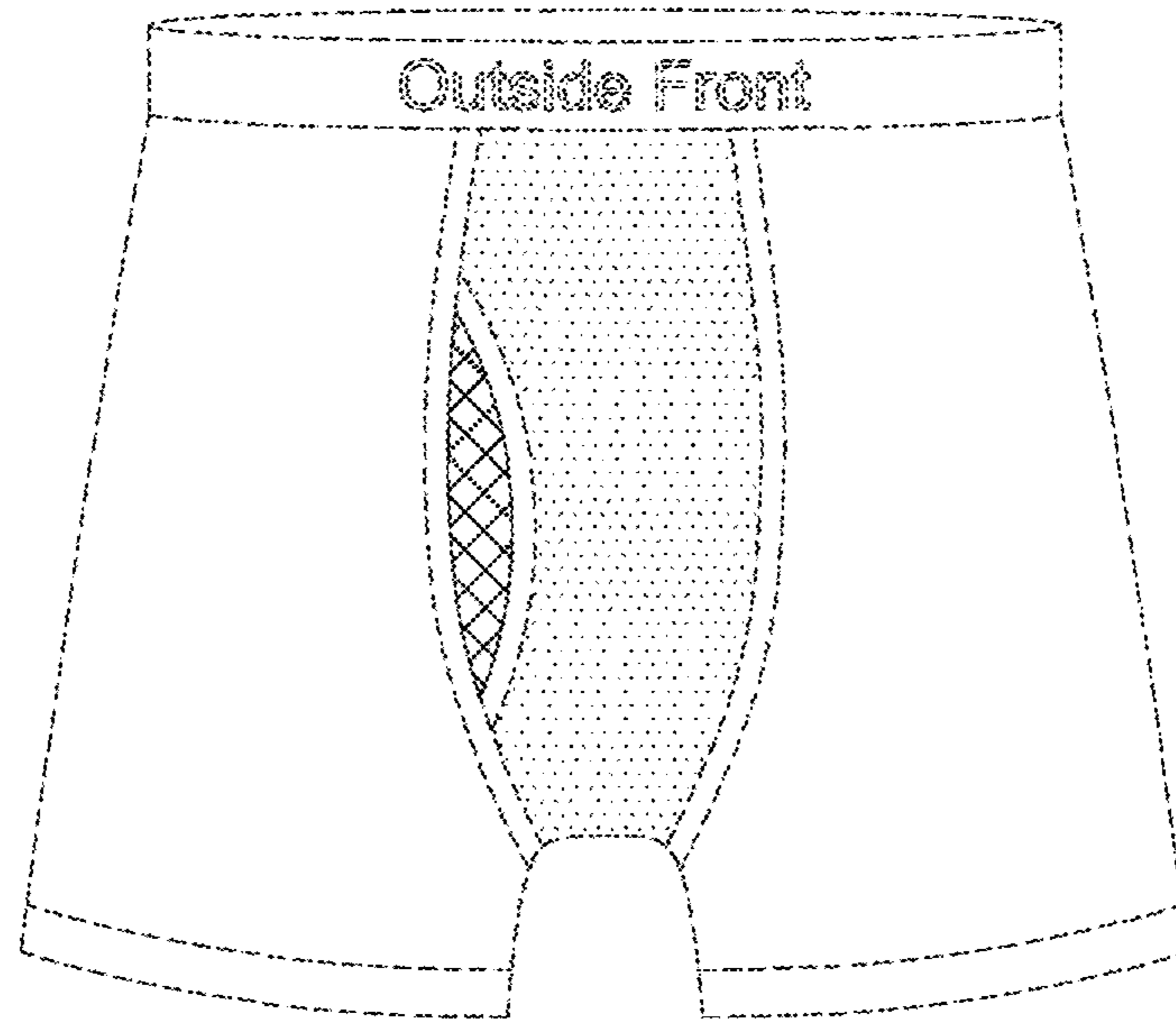

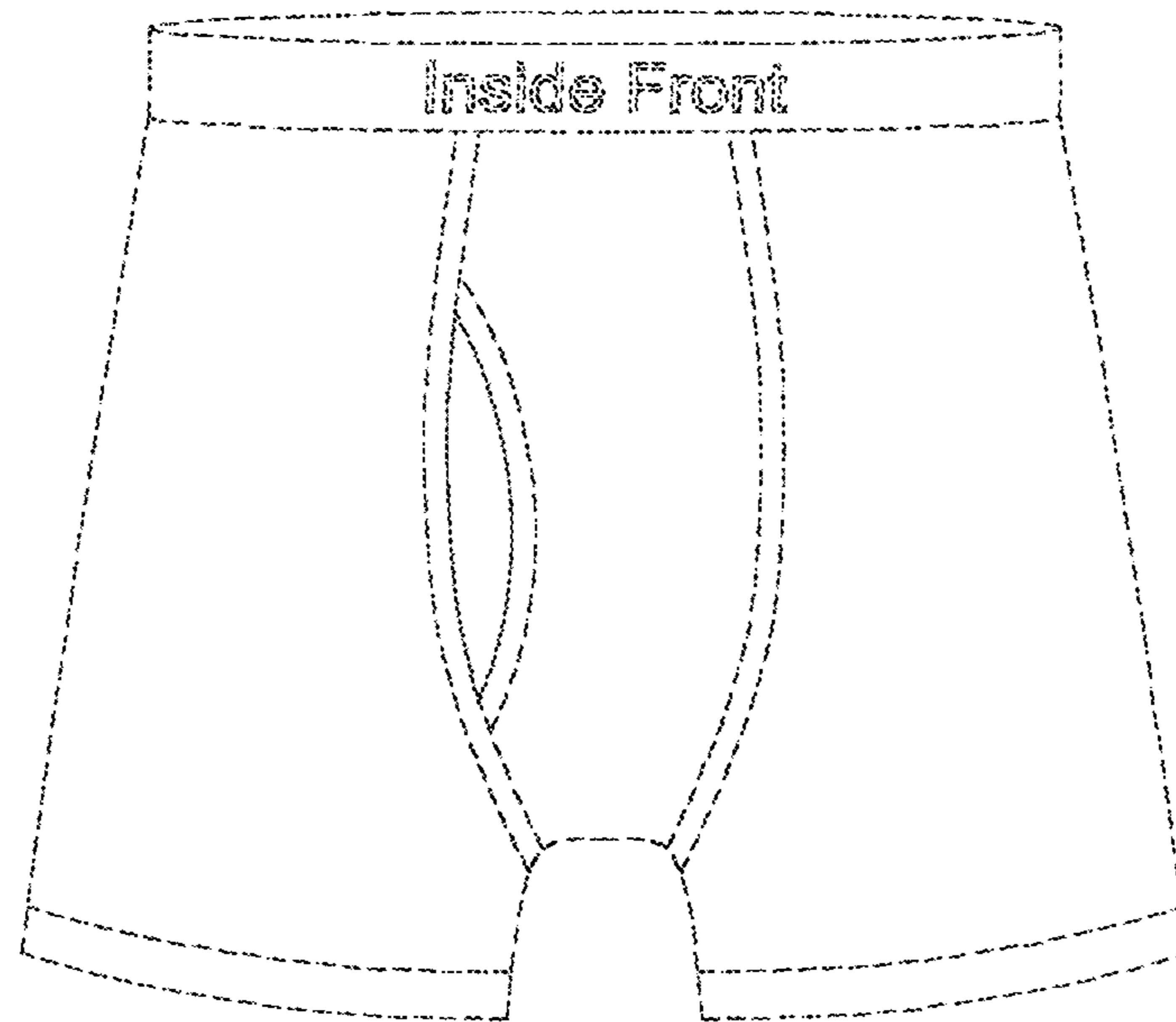

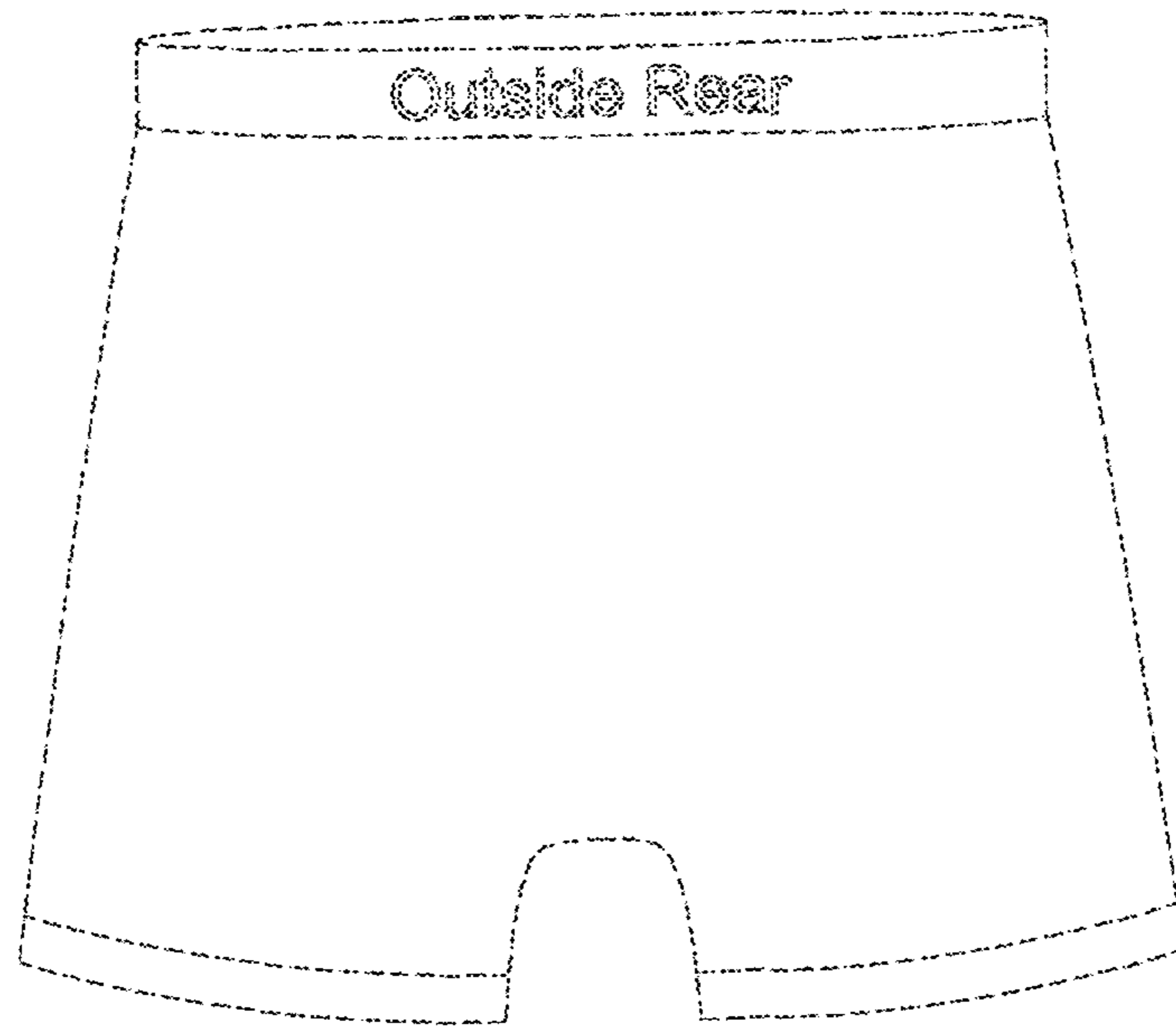

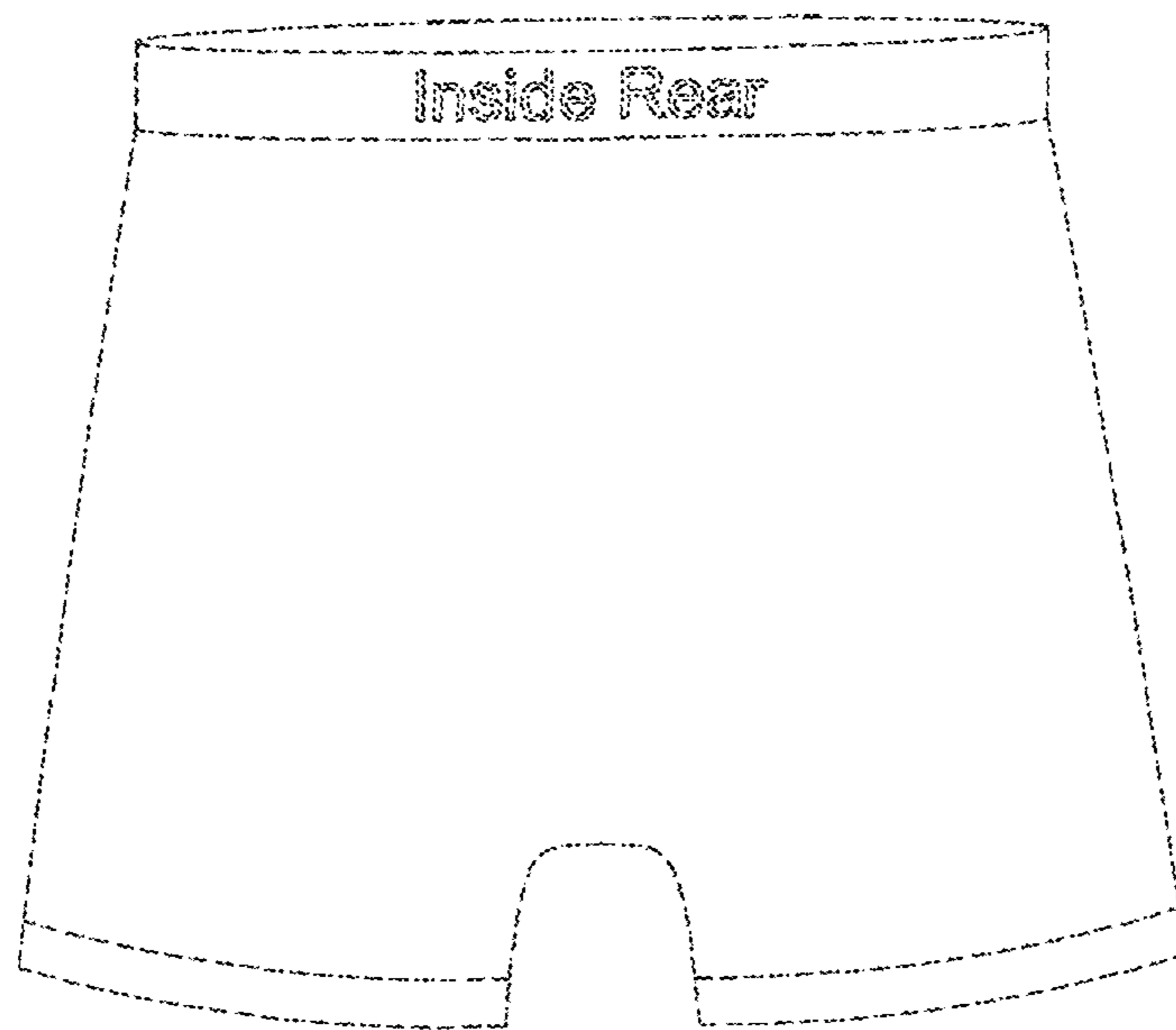

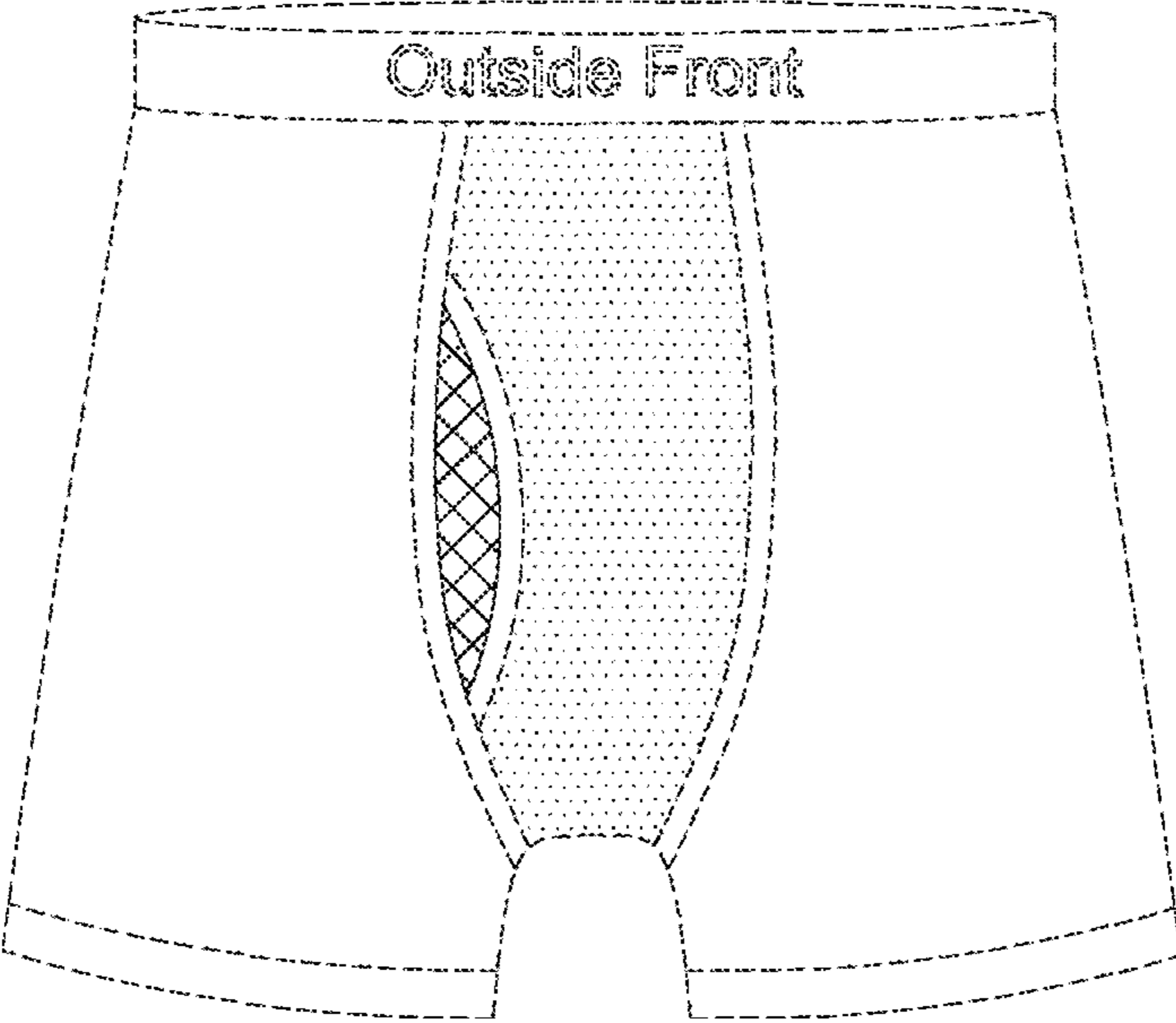

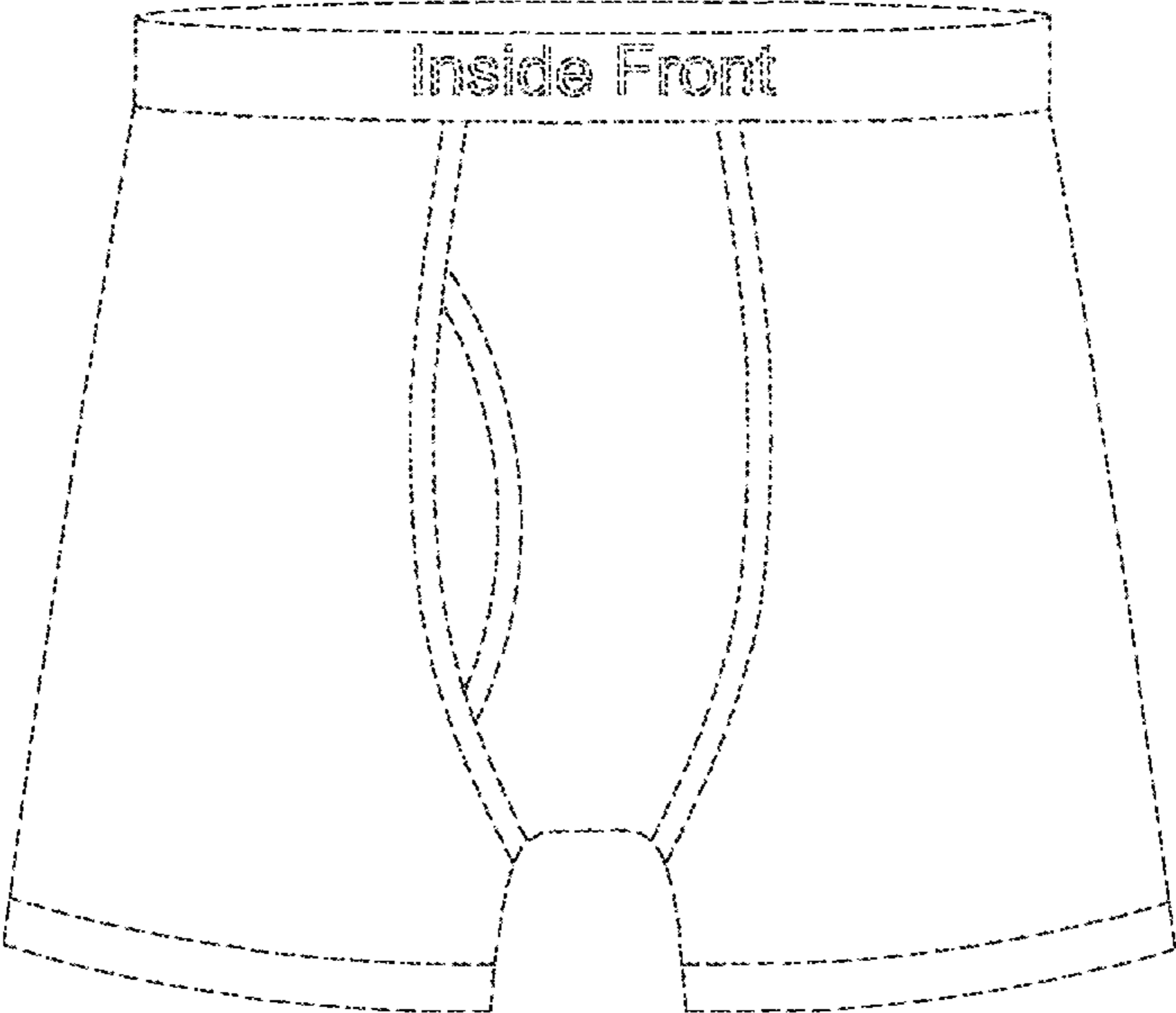

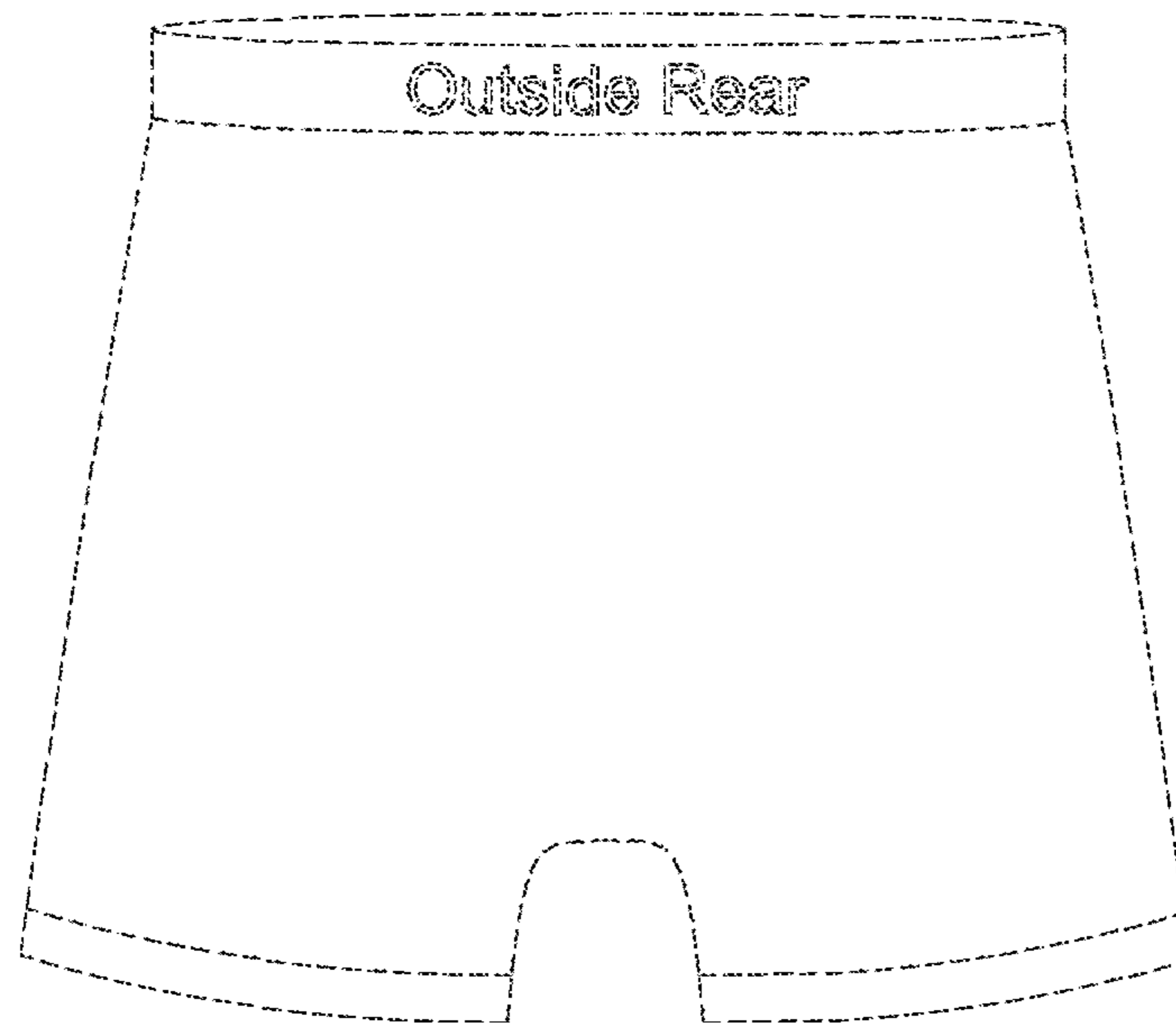

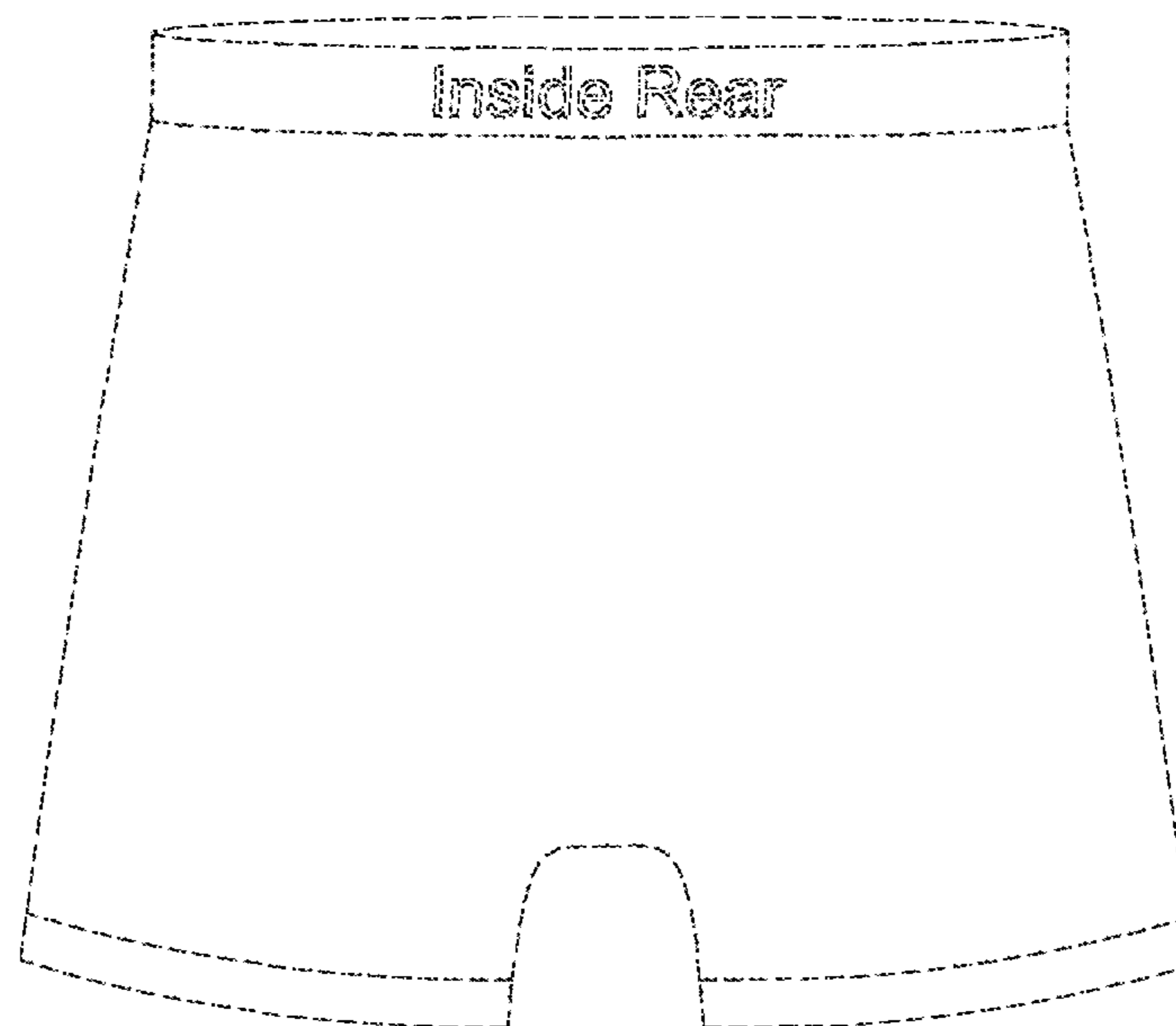
