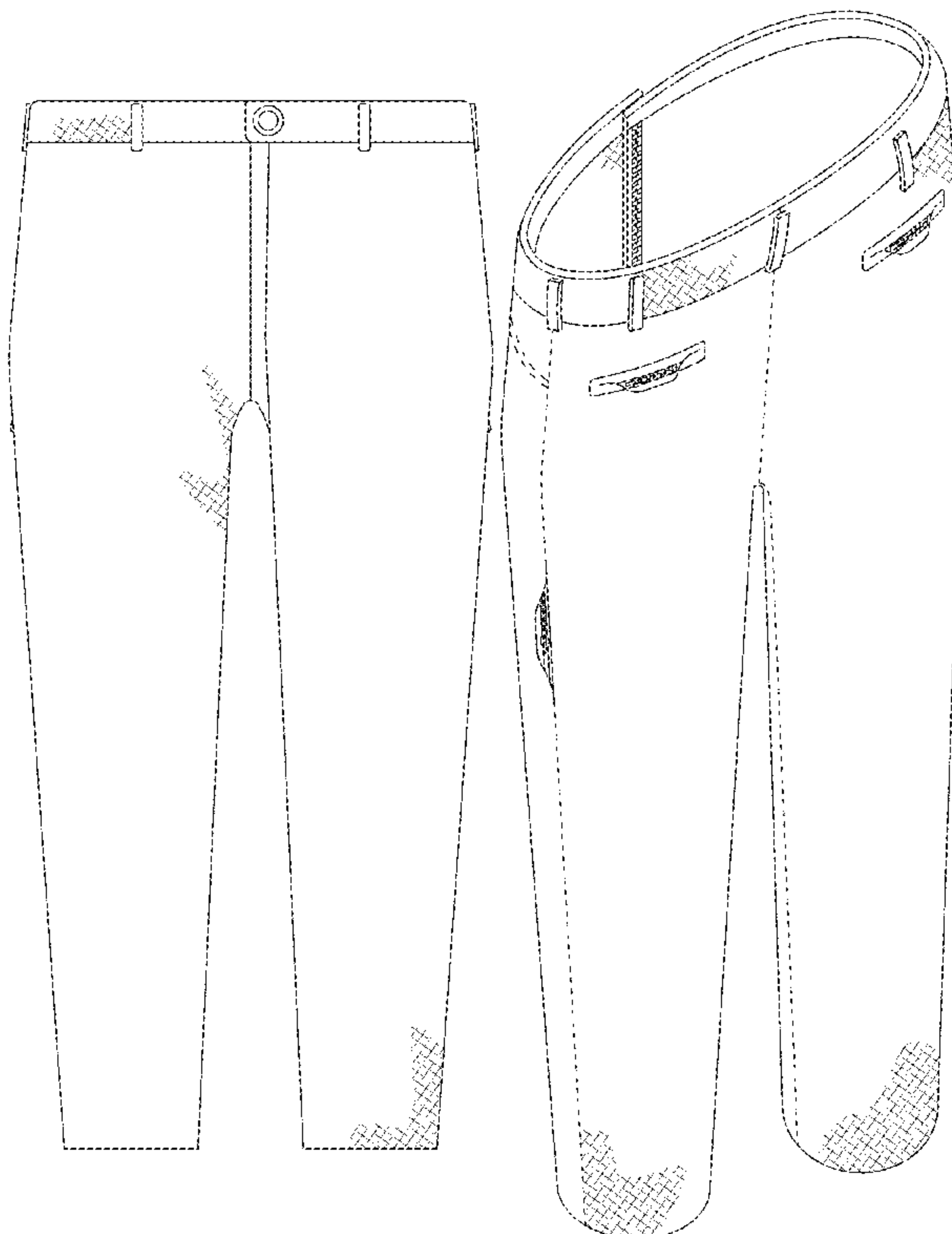
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is the perspective view of a pants with pockets;

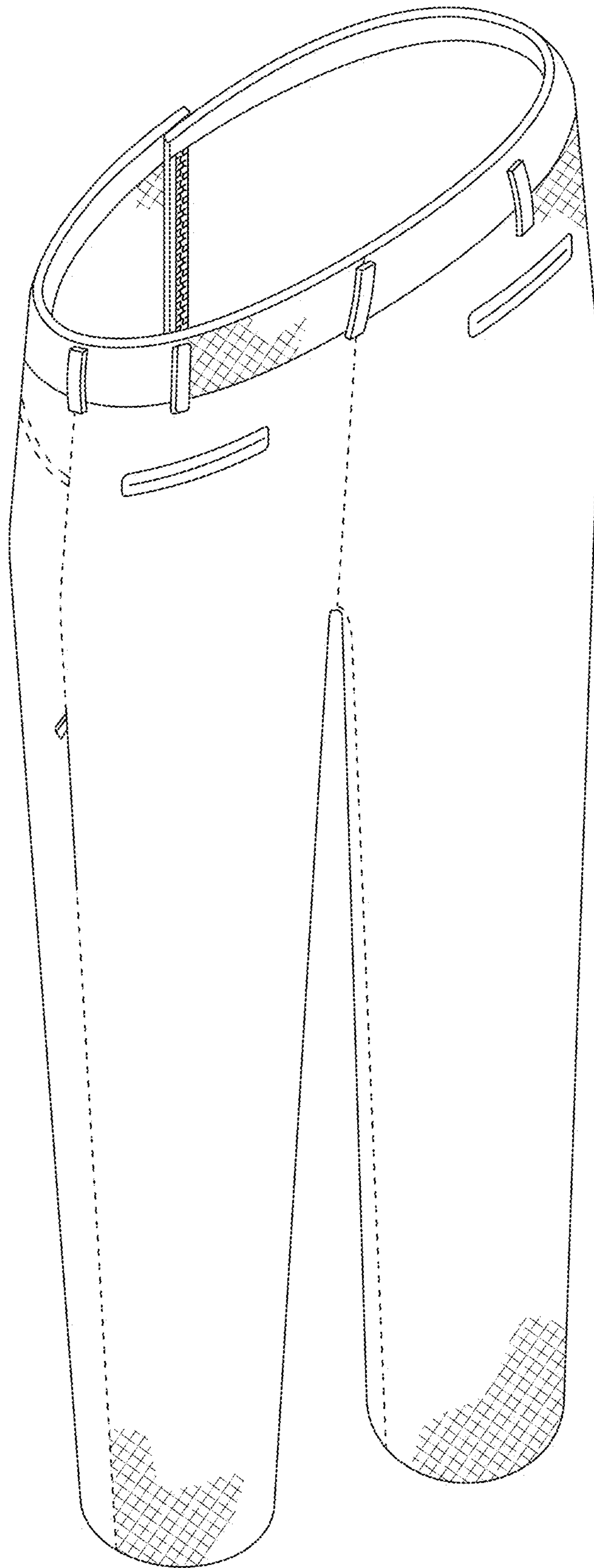

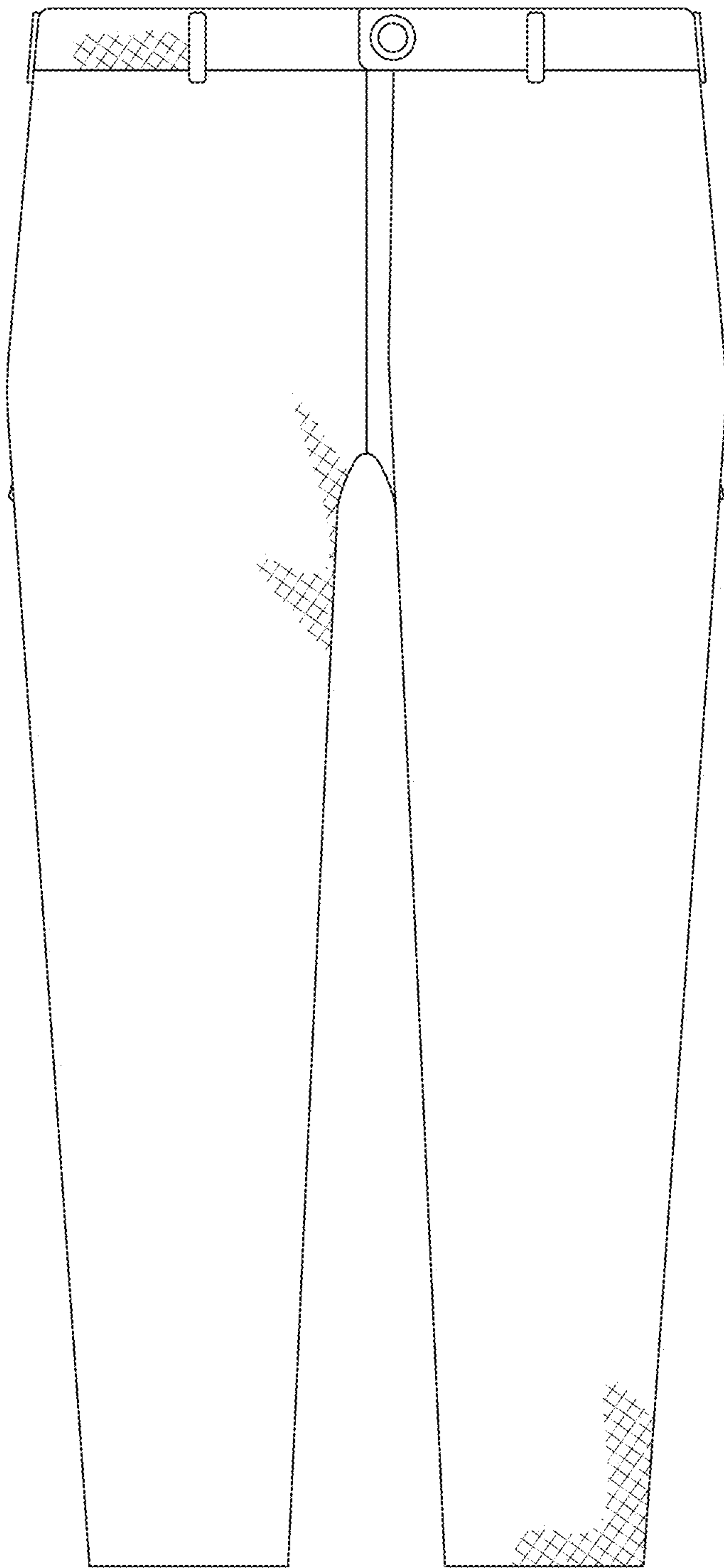

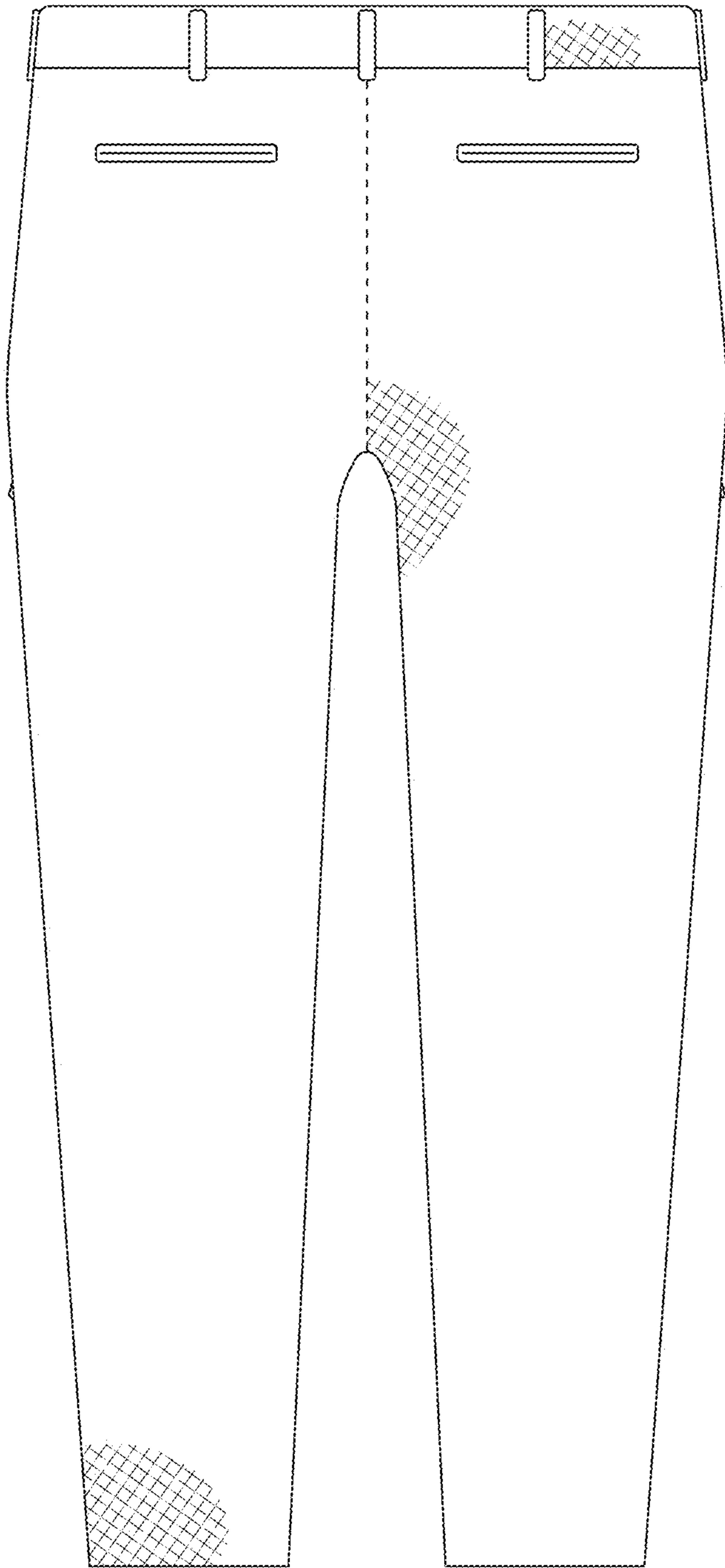

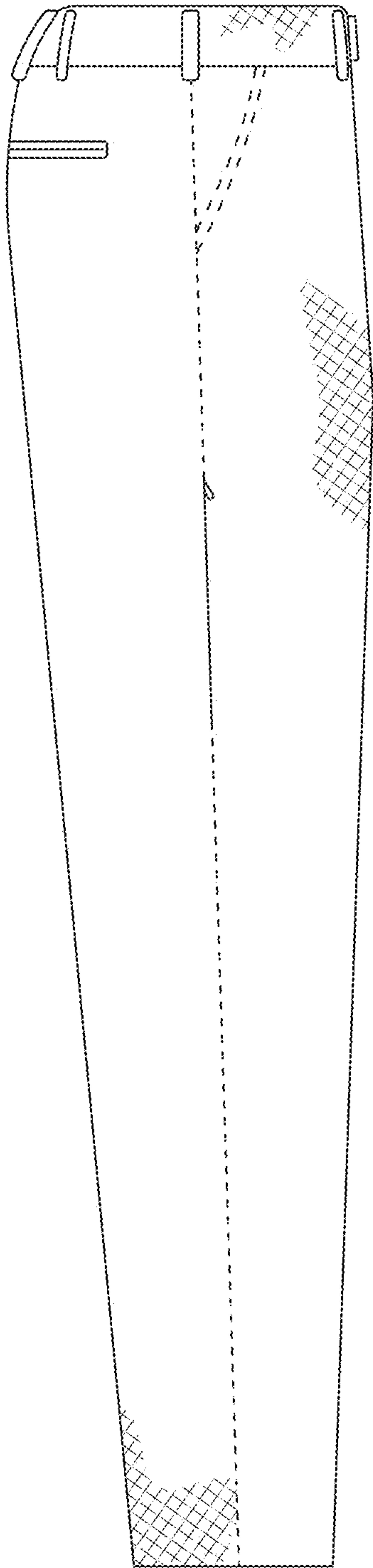

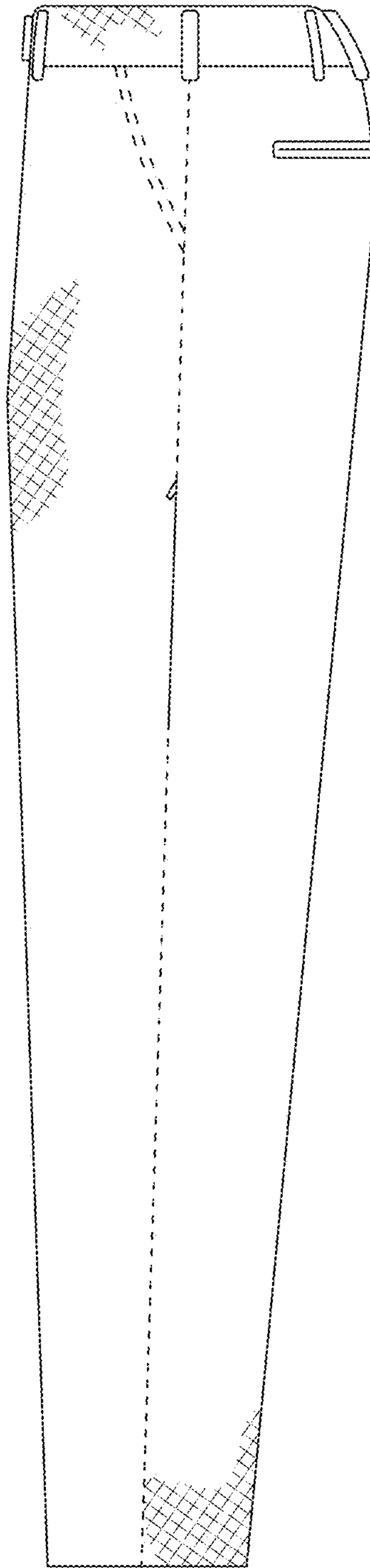

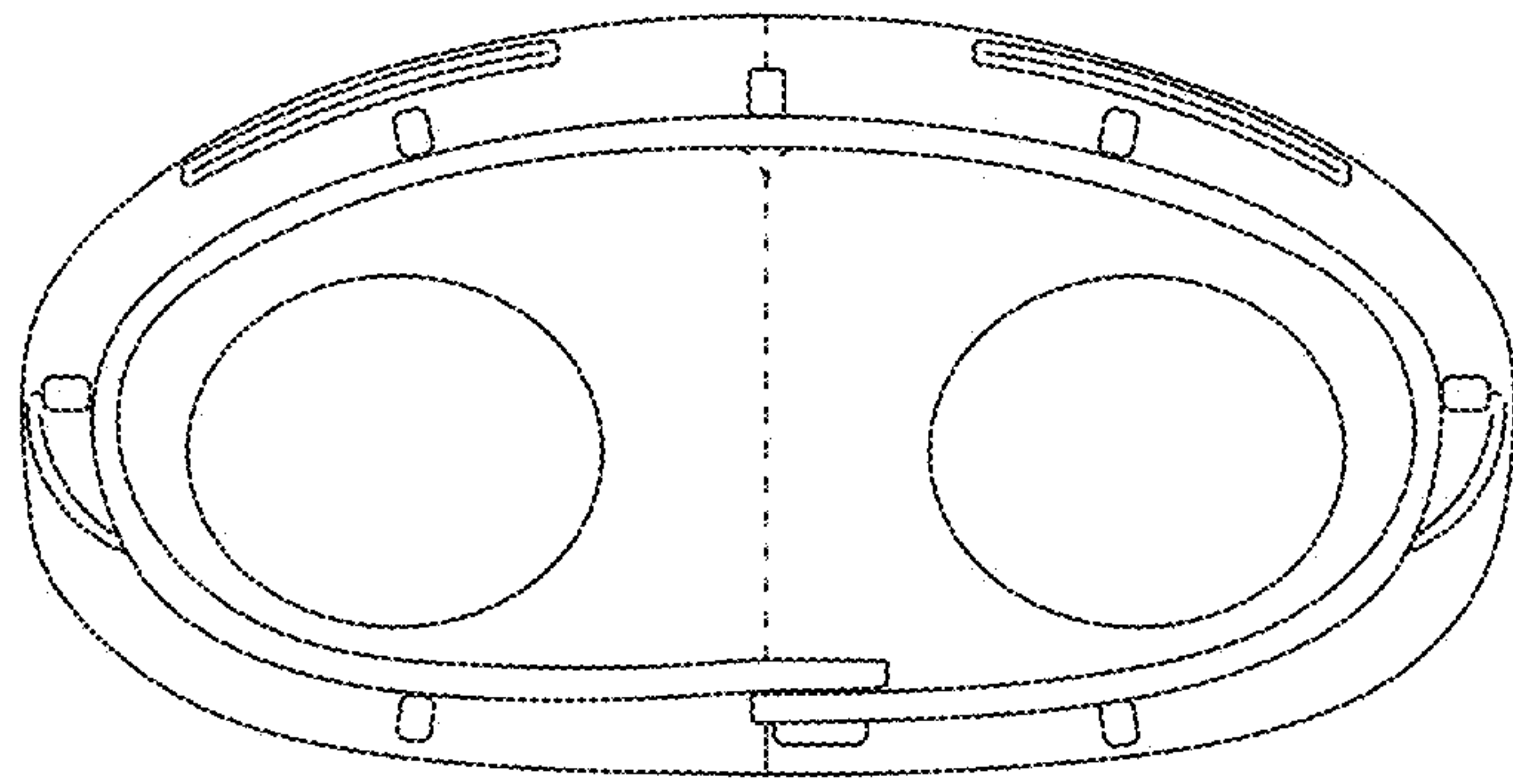

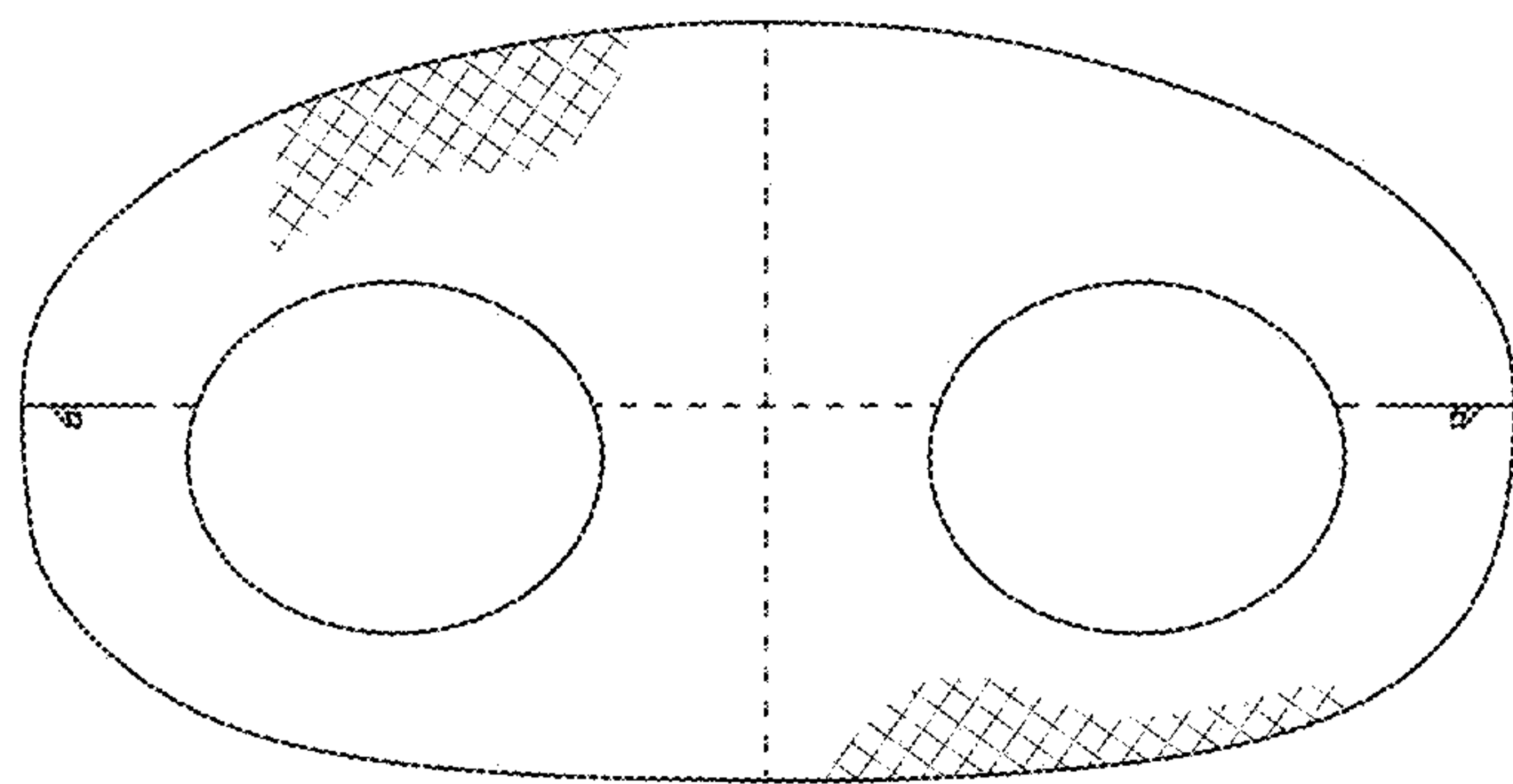

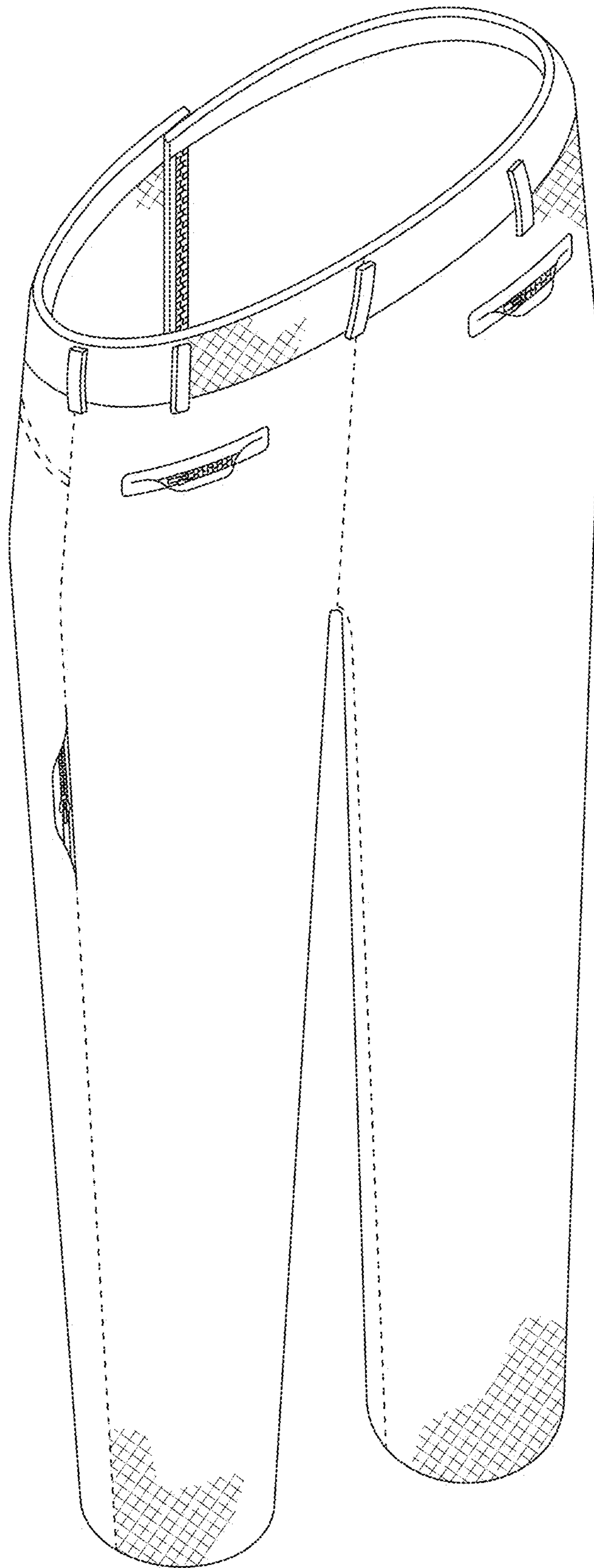
