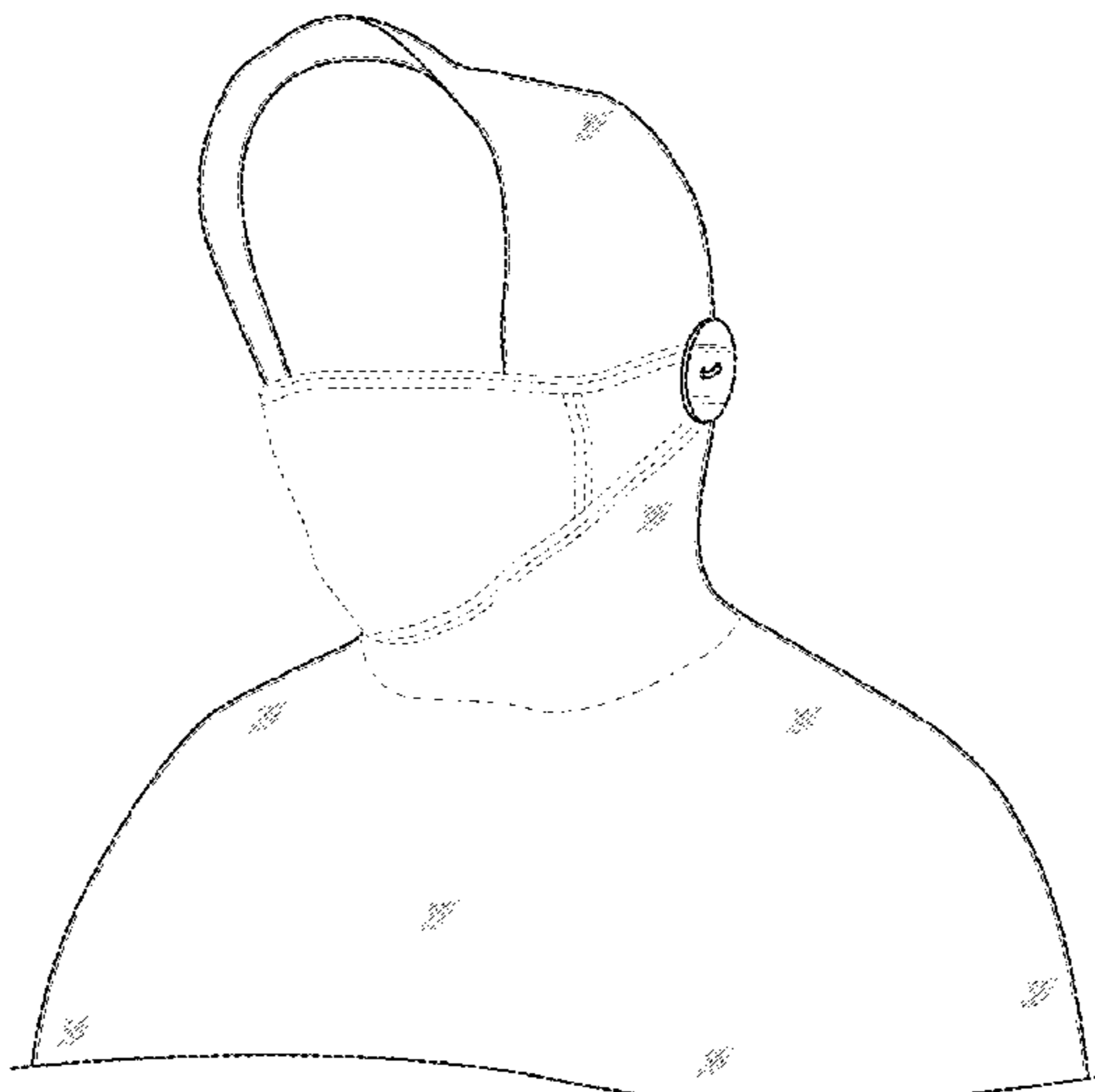
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the front left of the hoodie in accordance with my design;
FIG. 2 is an elevation view of the front of the hoodie;
FIG. 3 is an elevation view of the back of the hoodie;
FIG. 4 is an elevation view of the left side of the hoodie;
FIG. 5 is an elevation view of the right side of the hoodie;

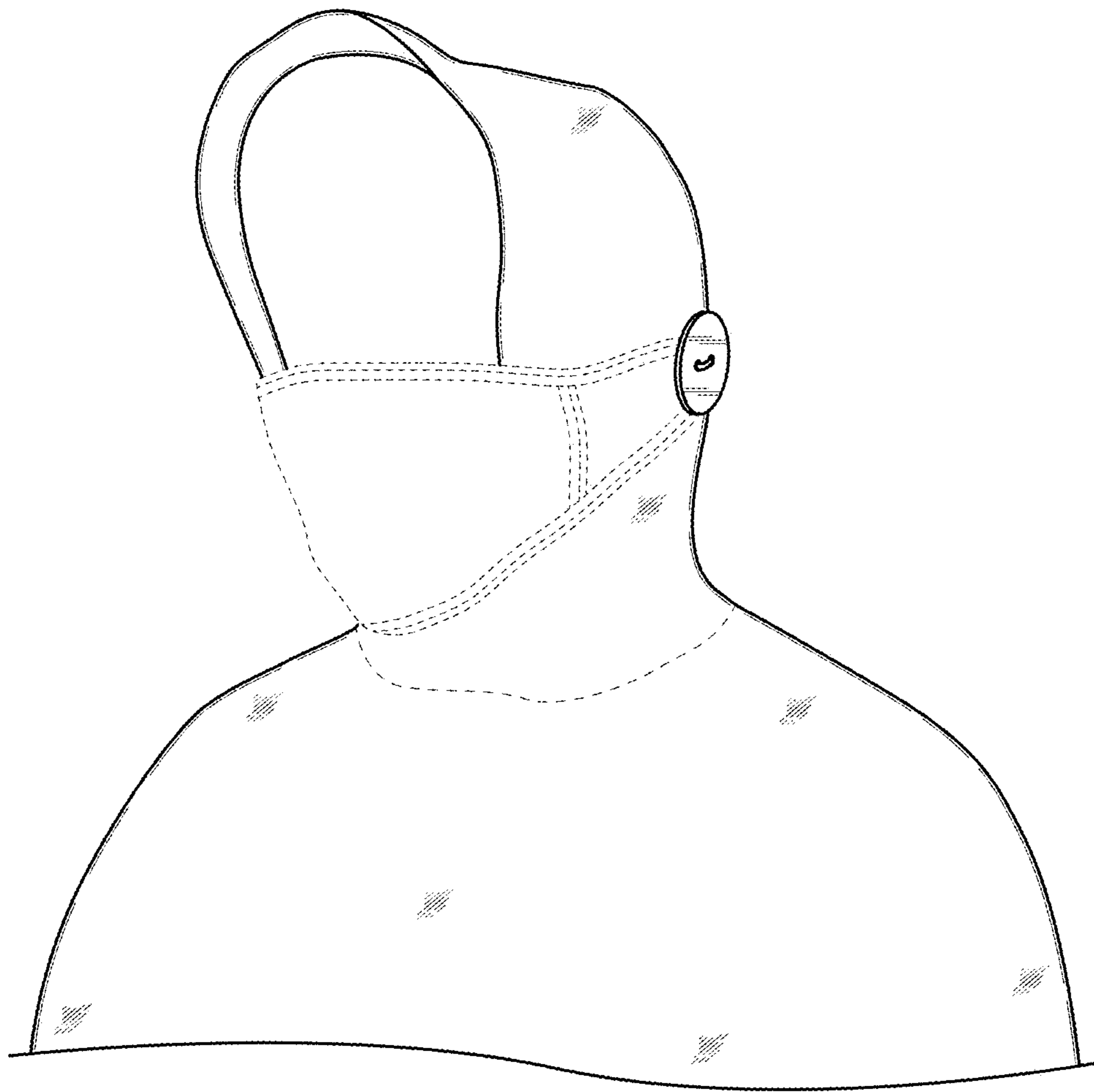

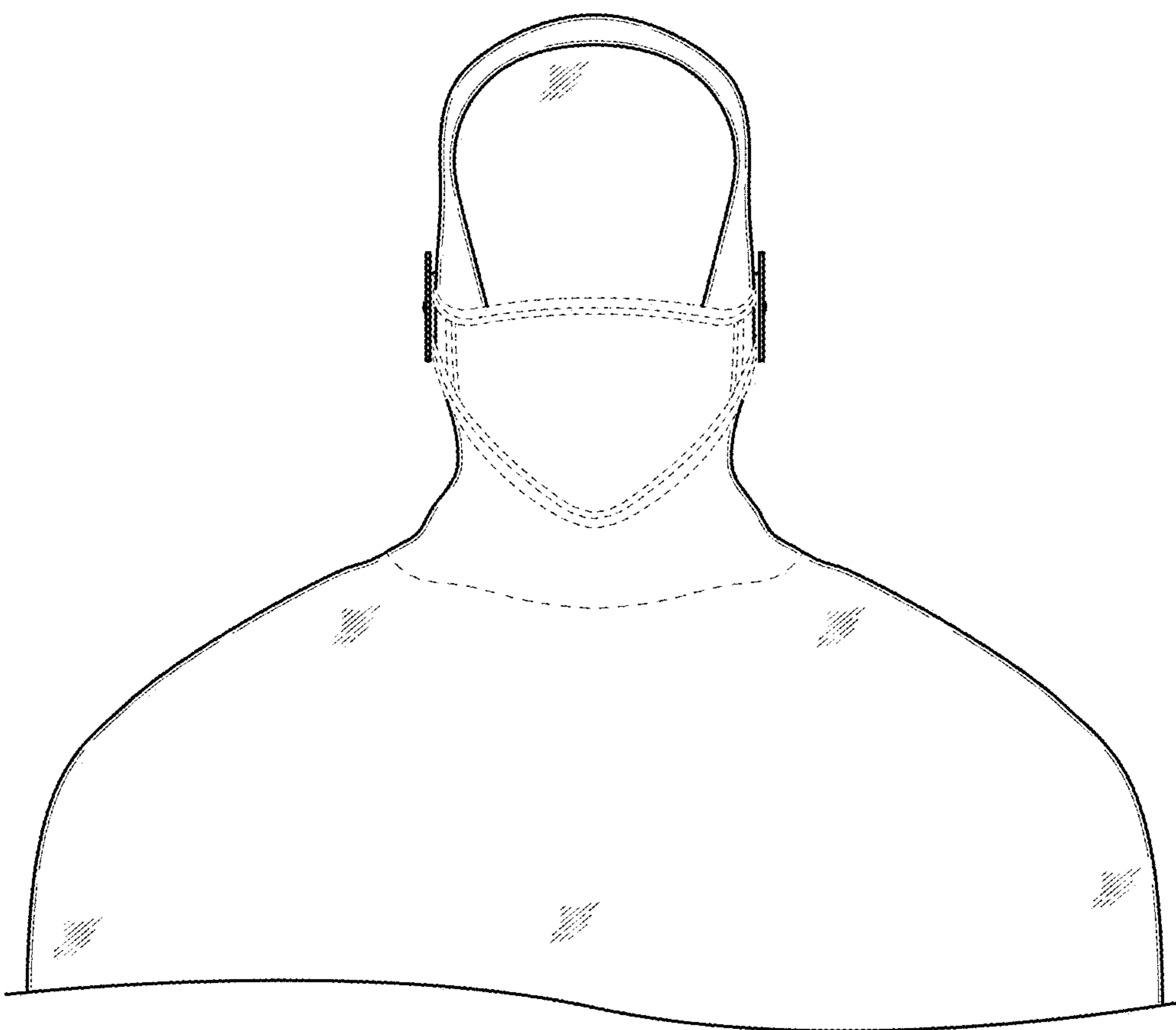

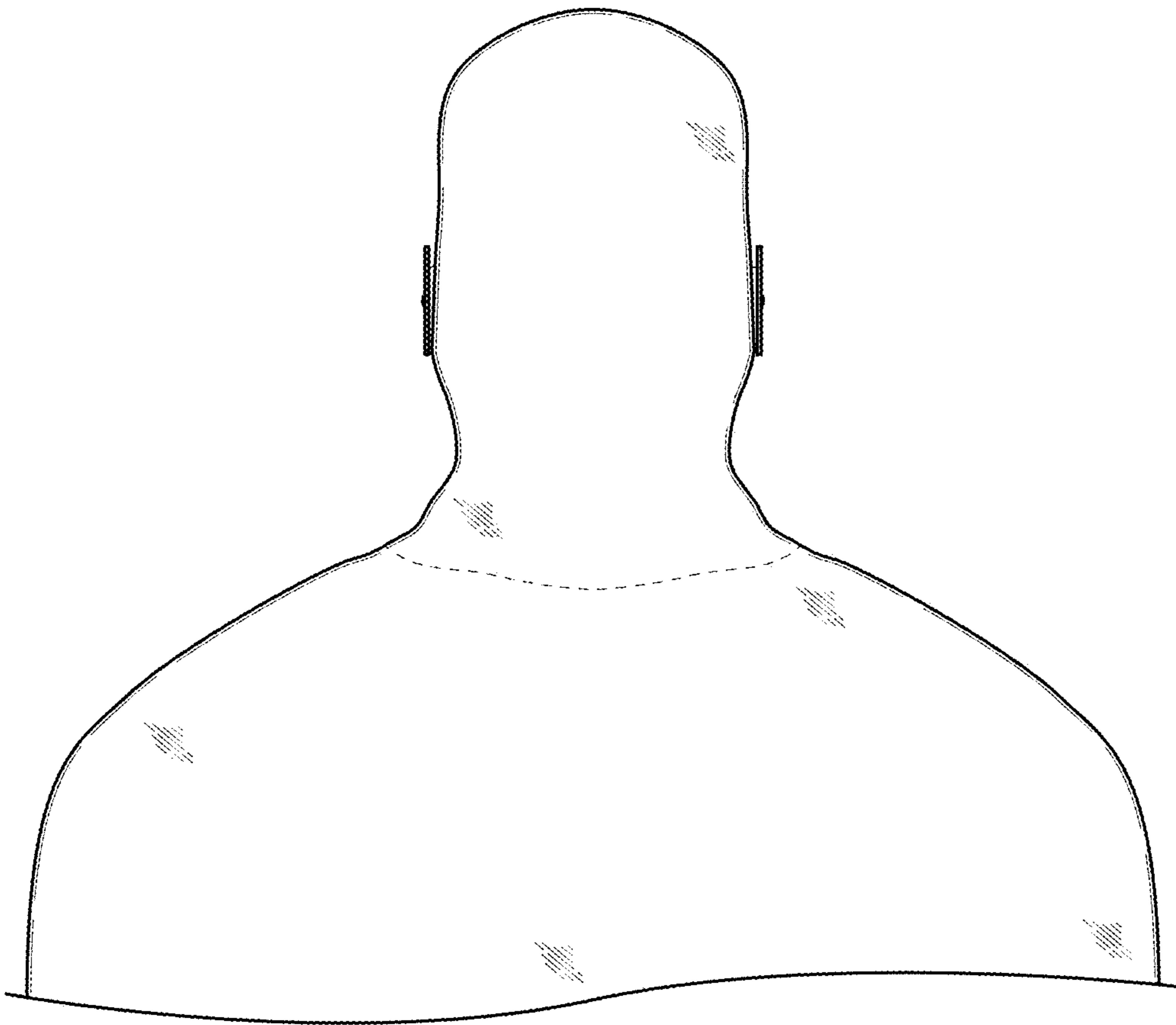

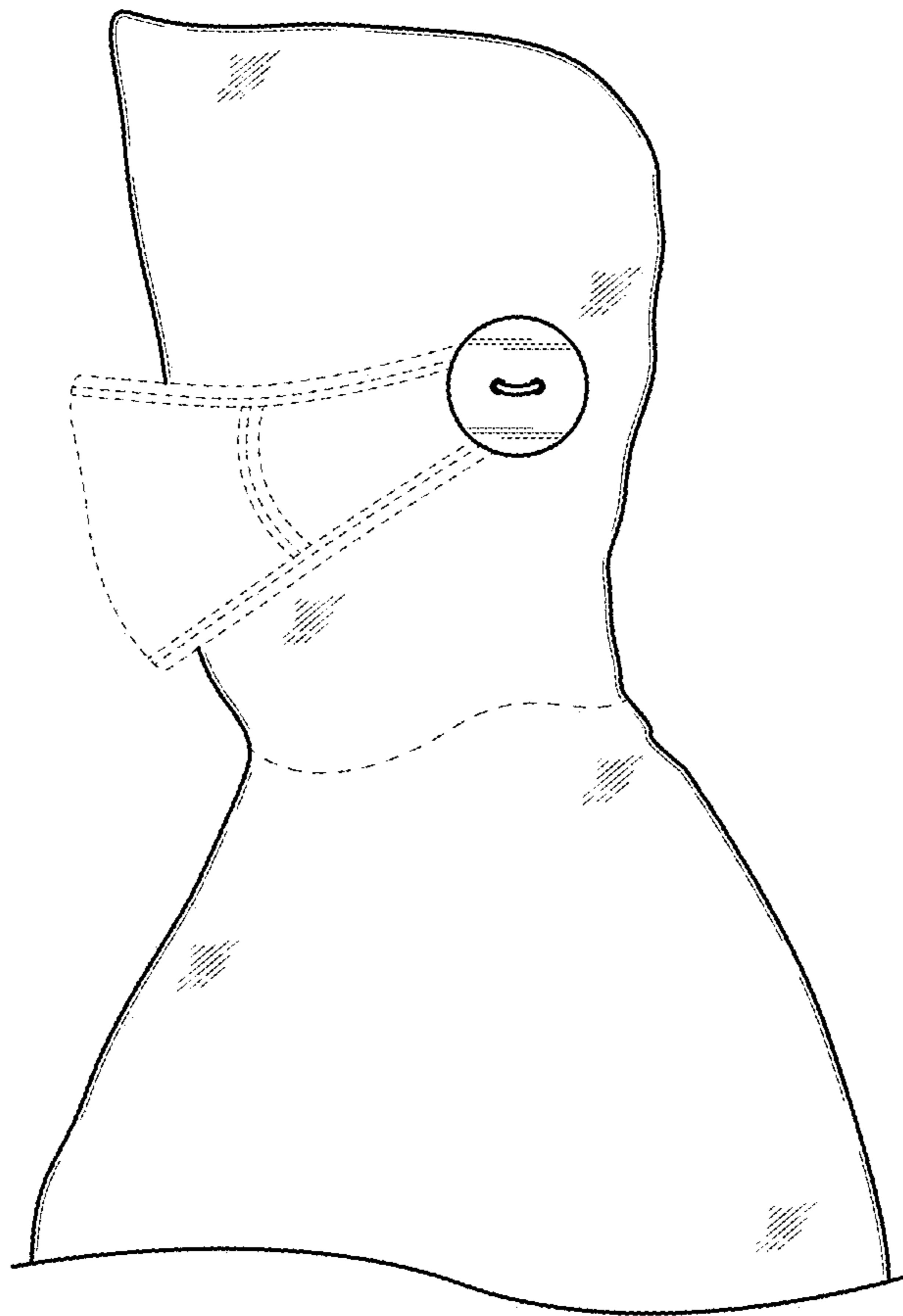

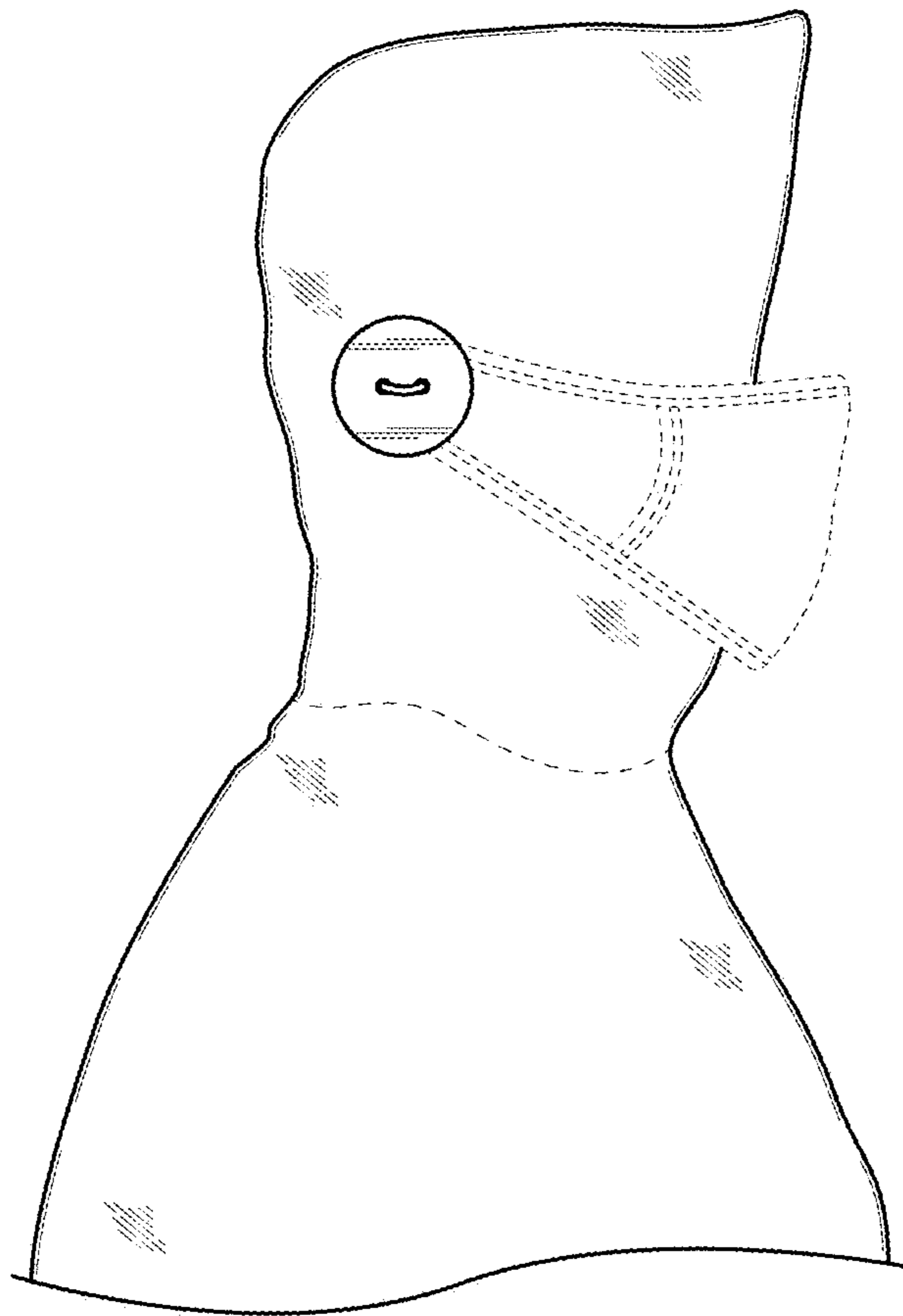

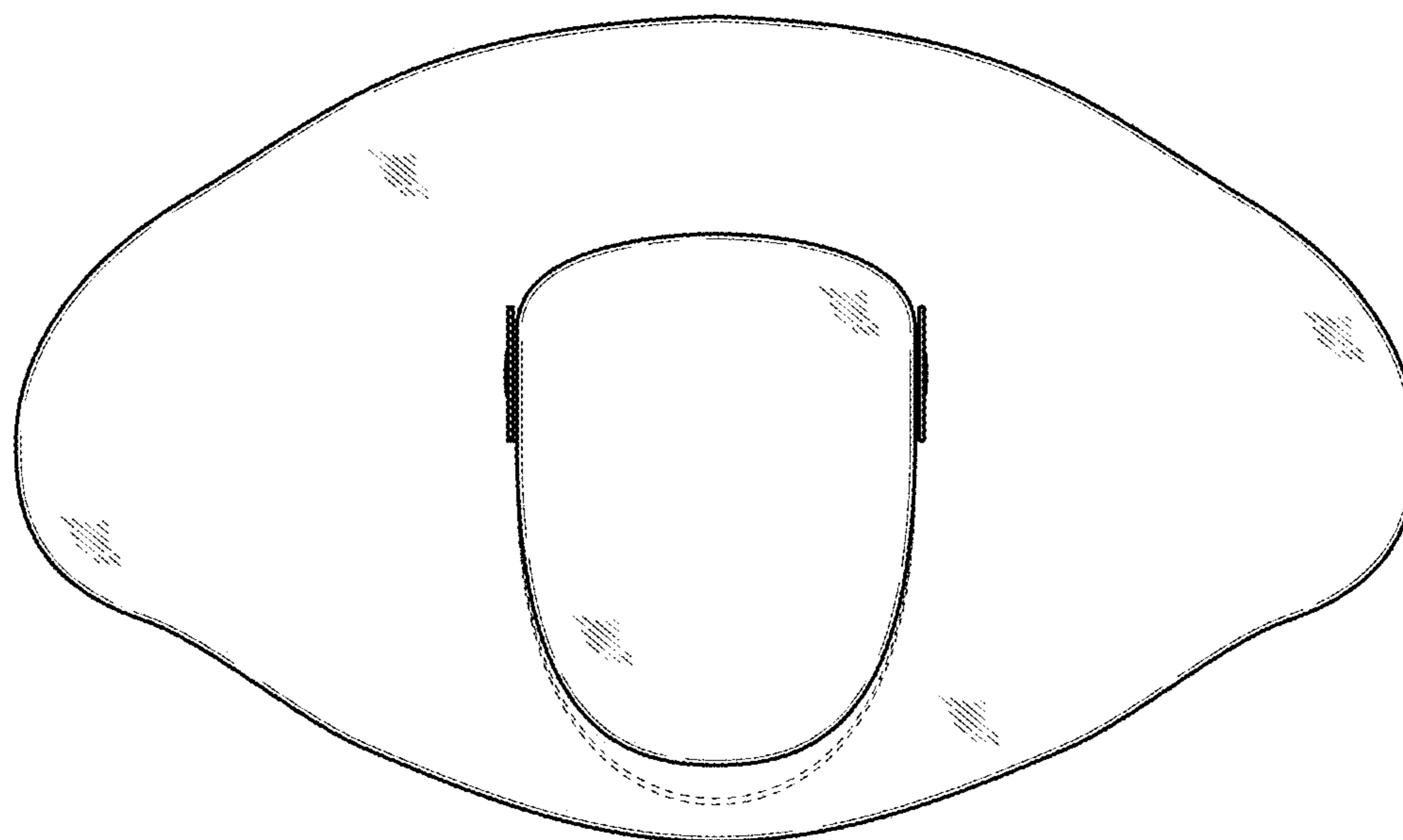
