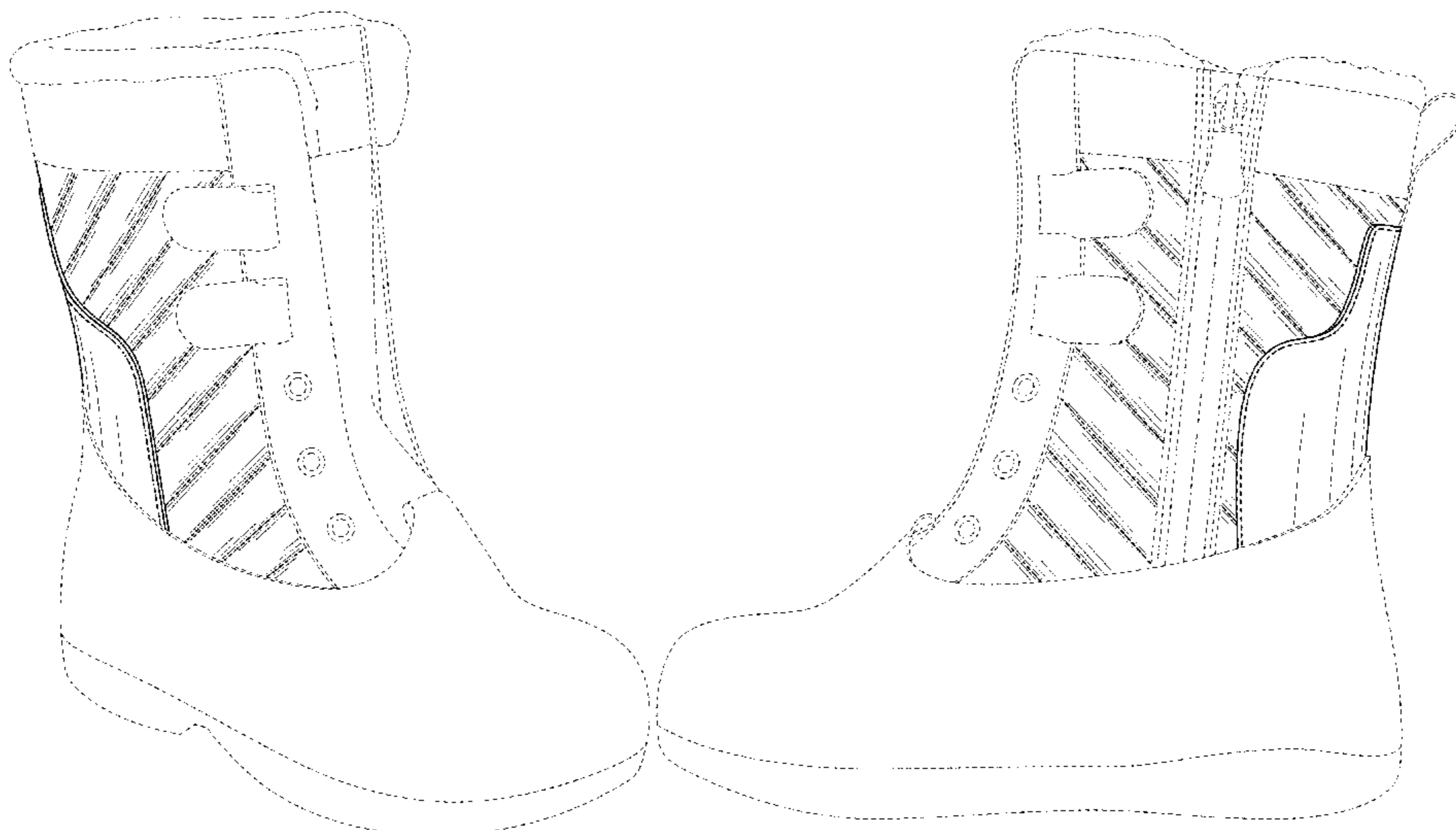
(57) **CLAIM**

The ornamental design for a footwear, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top and right side perspective view of an embodiment of a footwear according to the new design; FIG. 2 is a front side elevation view thereof; FIG. 3 is a back side elevation view thereof; FIG. 4 is a right side elevation view thereof; FIG. 5 is a left side elevation view thereof; and, FIG. 6 is a top plan view thereof. The bold broken lines in the drawings represent stitching and are part of the claimed design. The non-bold broken lines in the drawings show portions that form no part of the claimed design.

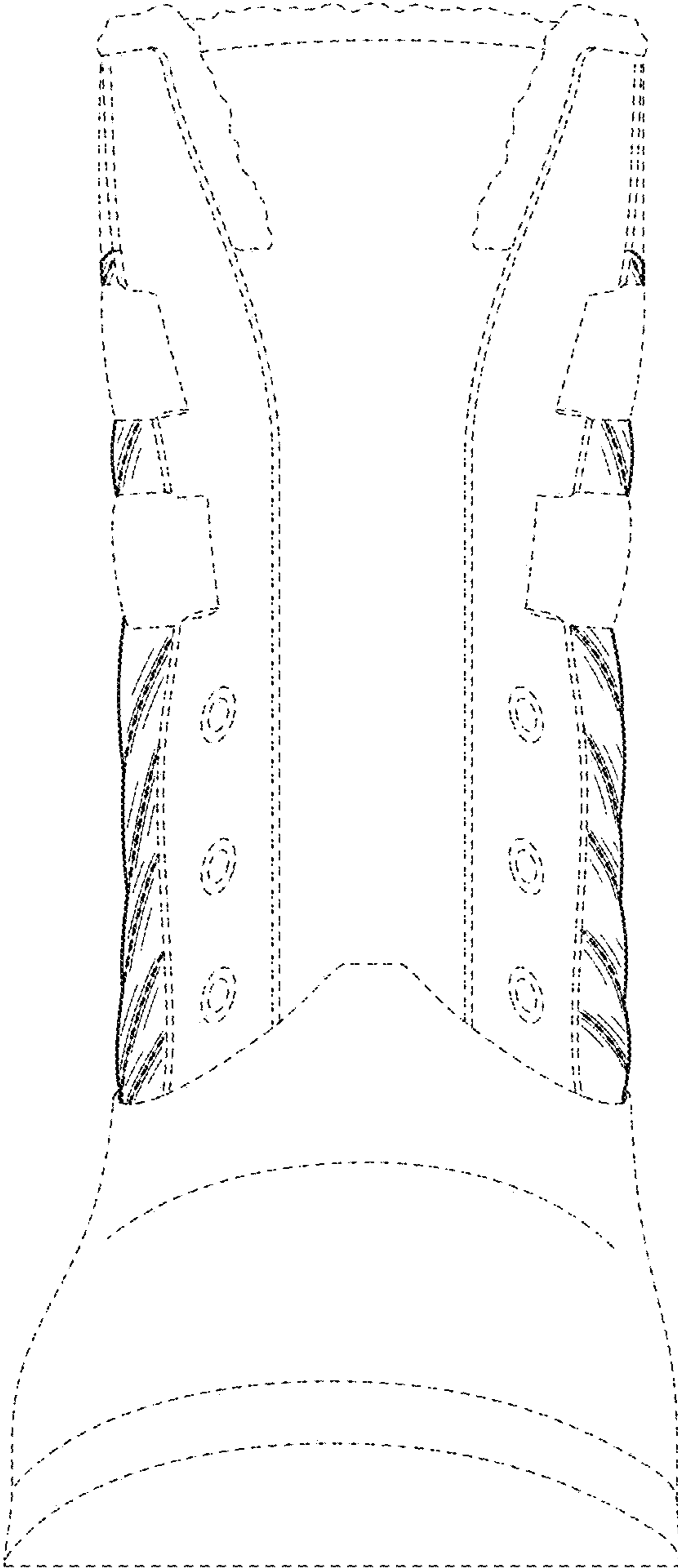

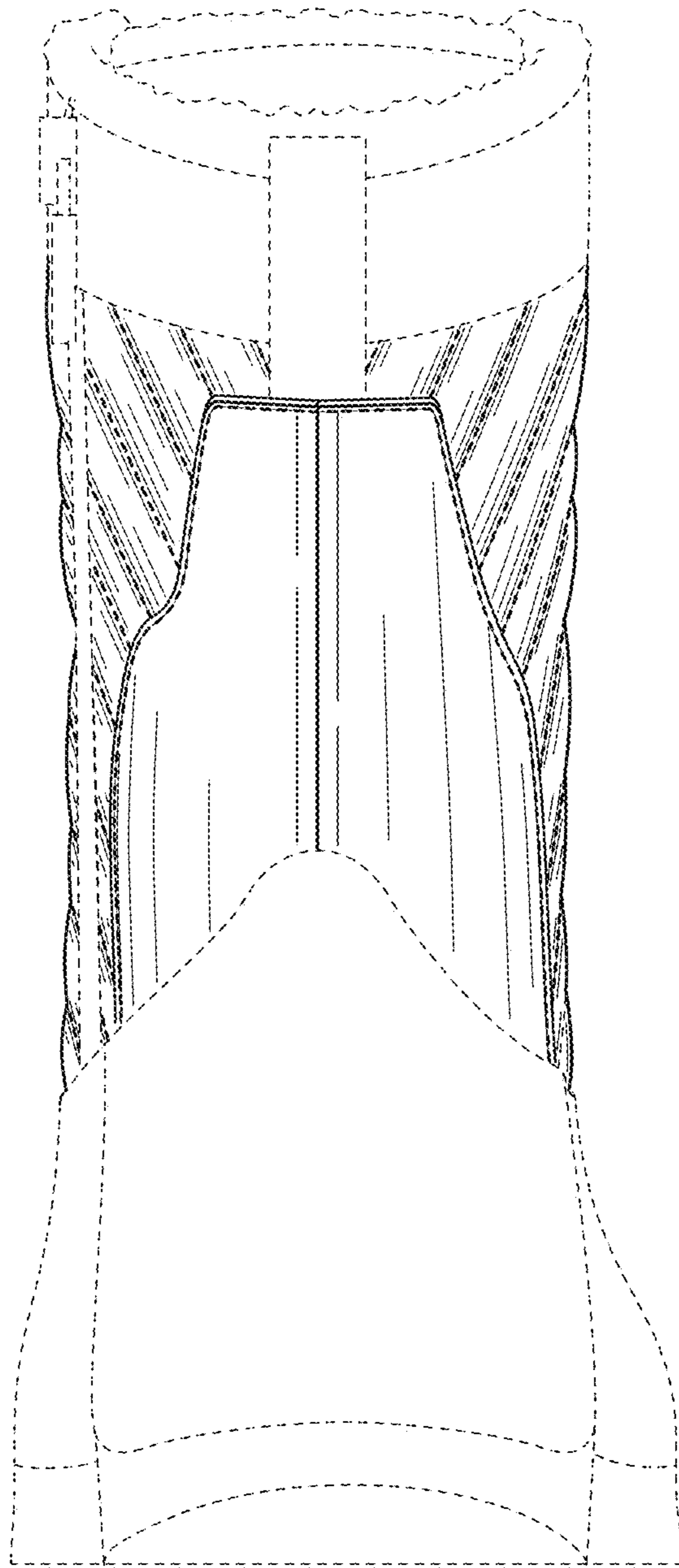

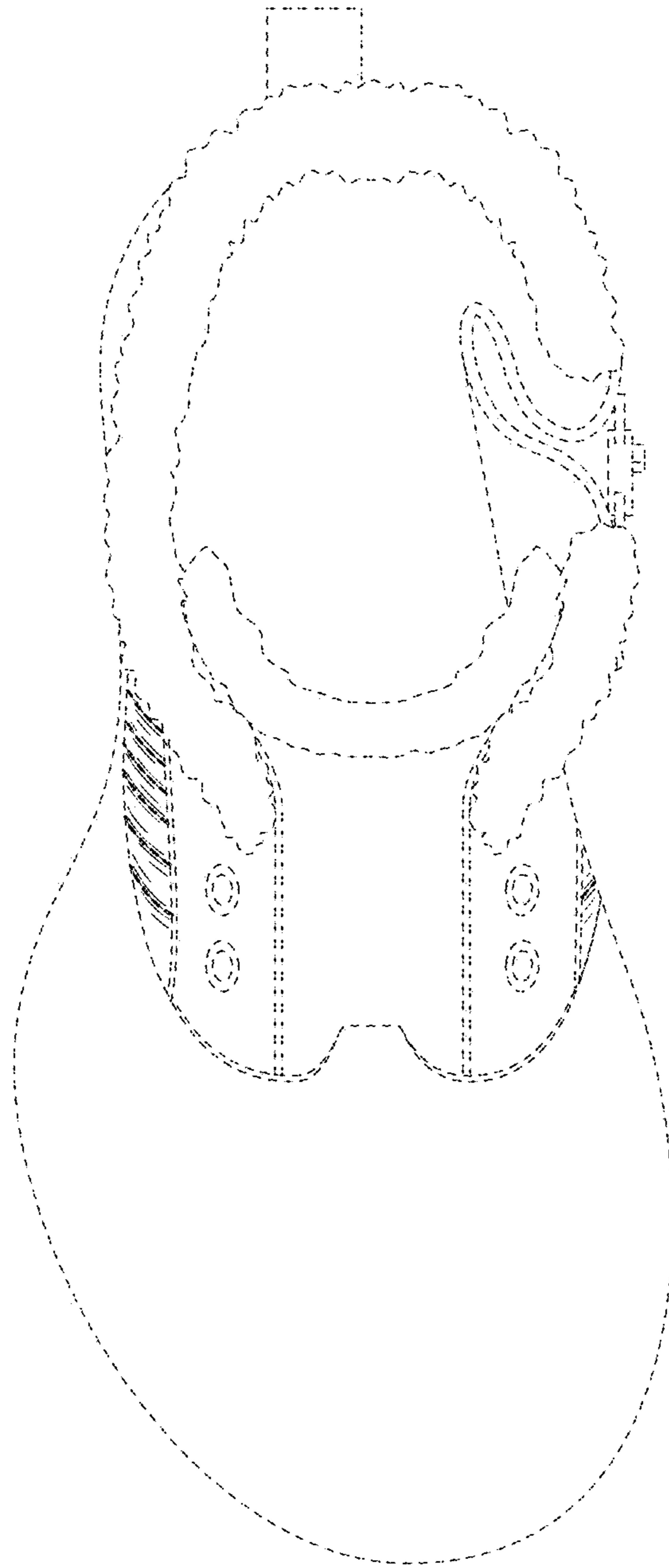
