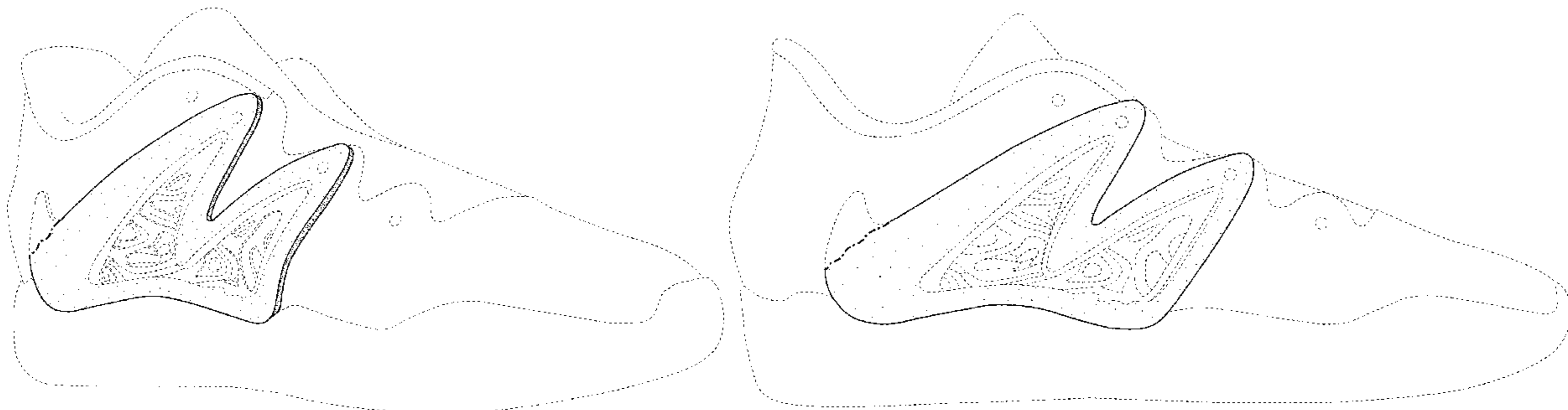
(57) **CLAIM**

I claim the ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe, showing my new design;  
FIG. 2 is a left side view thereof;  
FIG. 3 is a rear perspective view thereof; and,  
FIG. 4 is a top view thereof.  
The dot-dash broken lines in the drawings define the bounds of the claimed design and form no part thereof. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

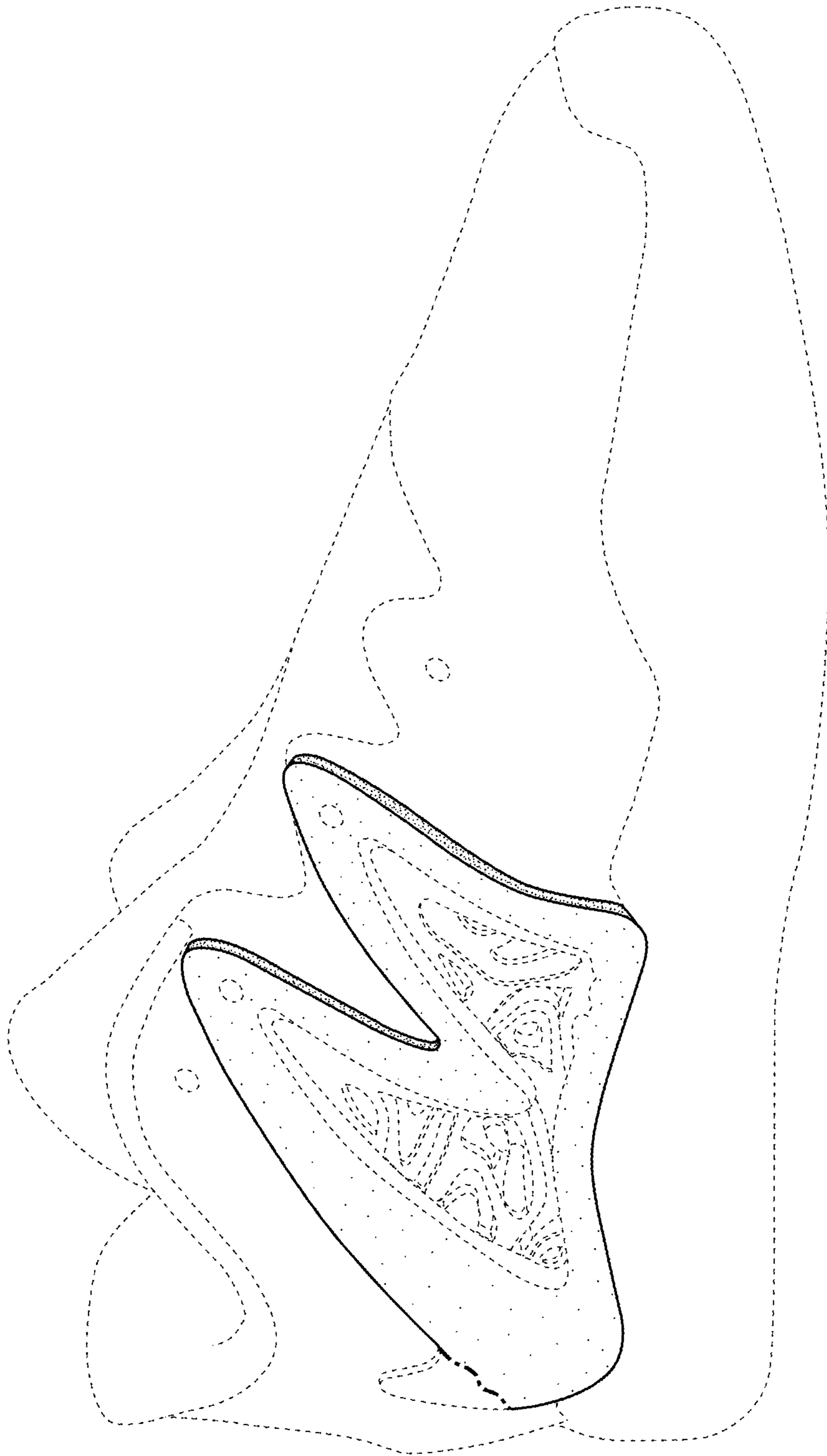

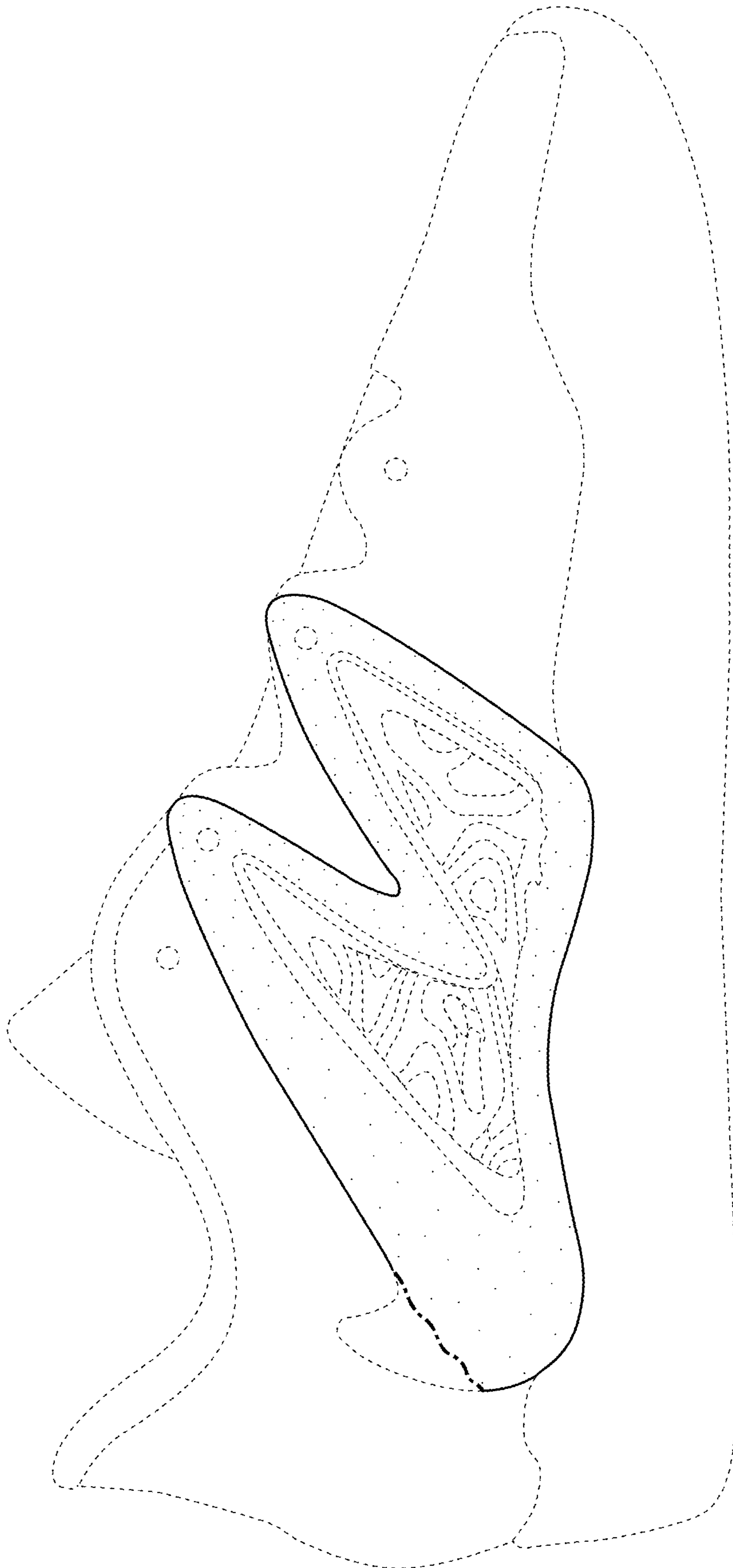

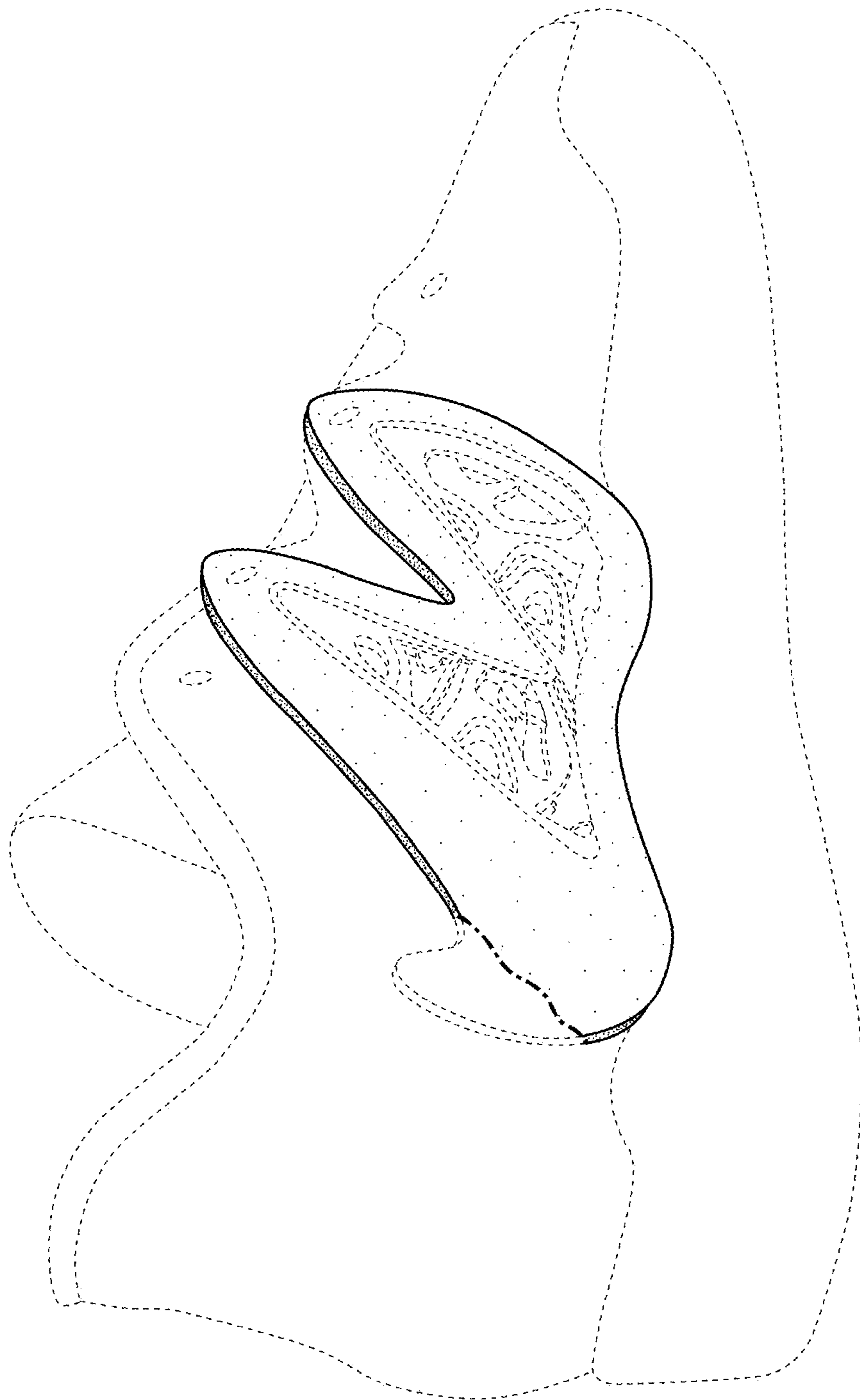

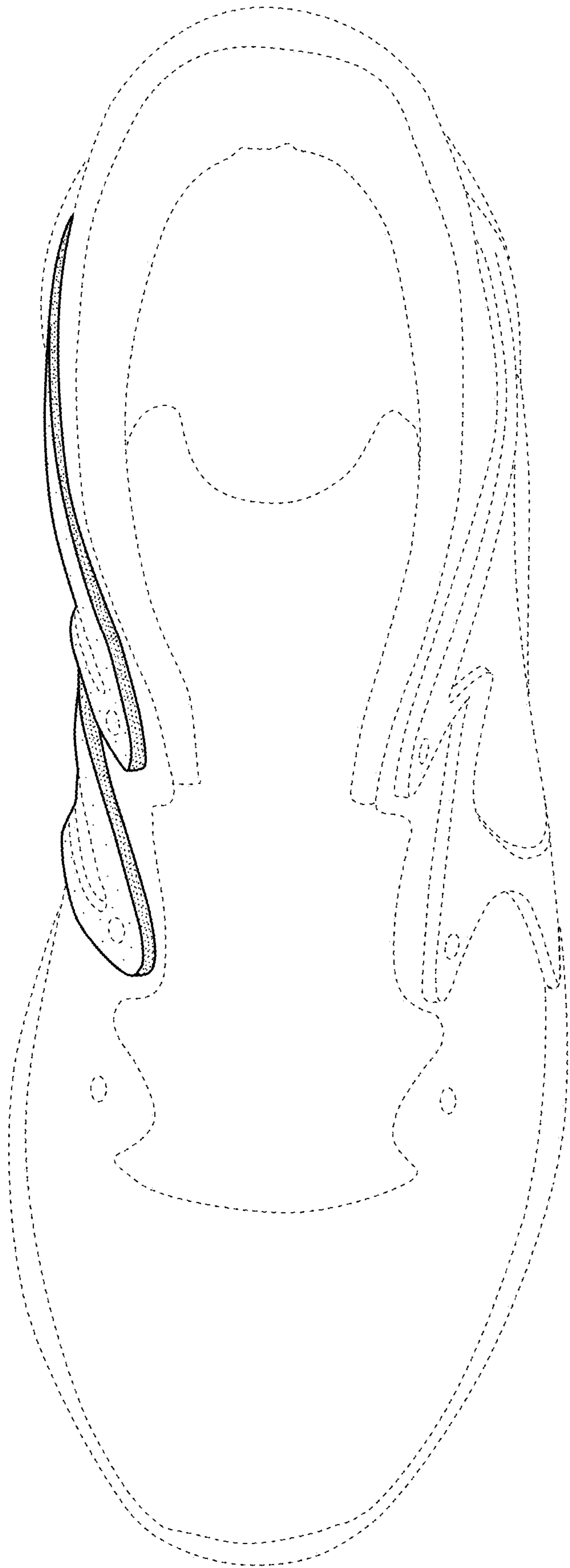
