The ornamental design for a hat and socks clip, as shown and described.

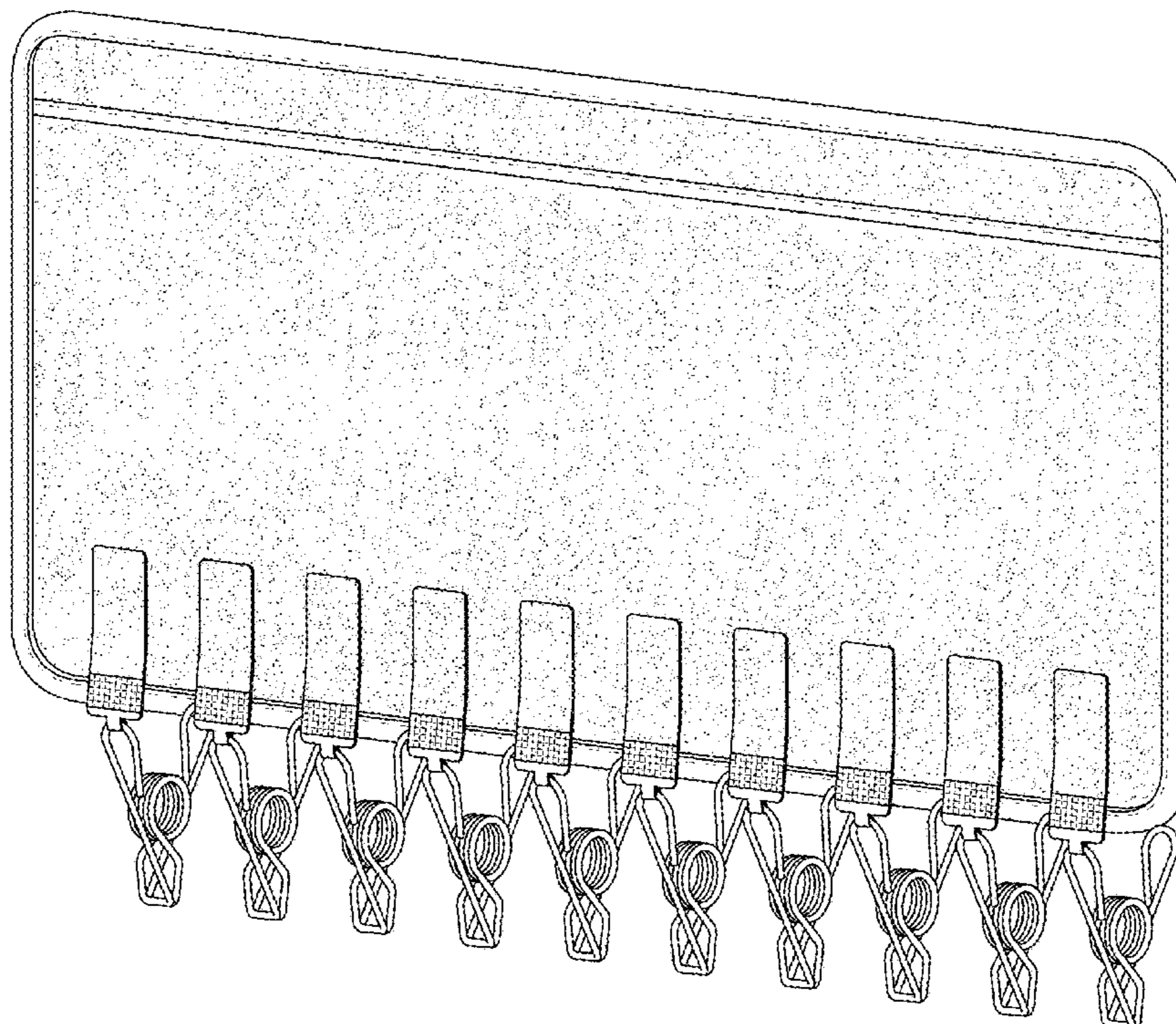
DESCRIPTION

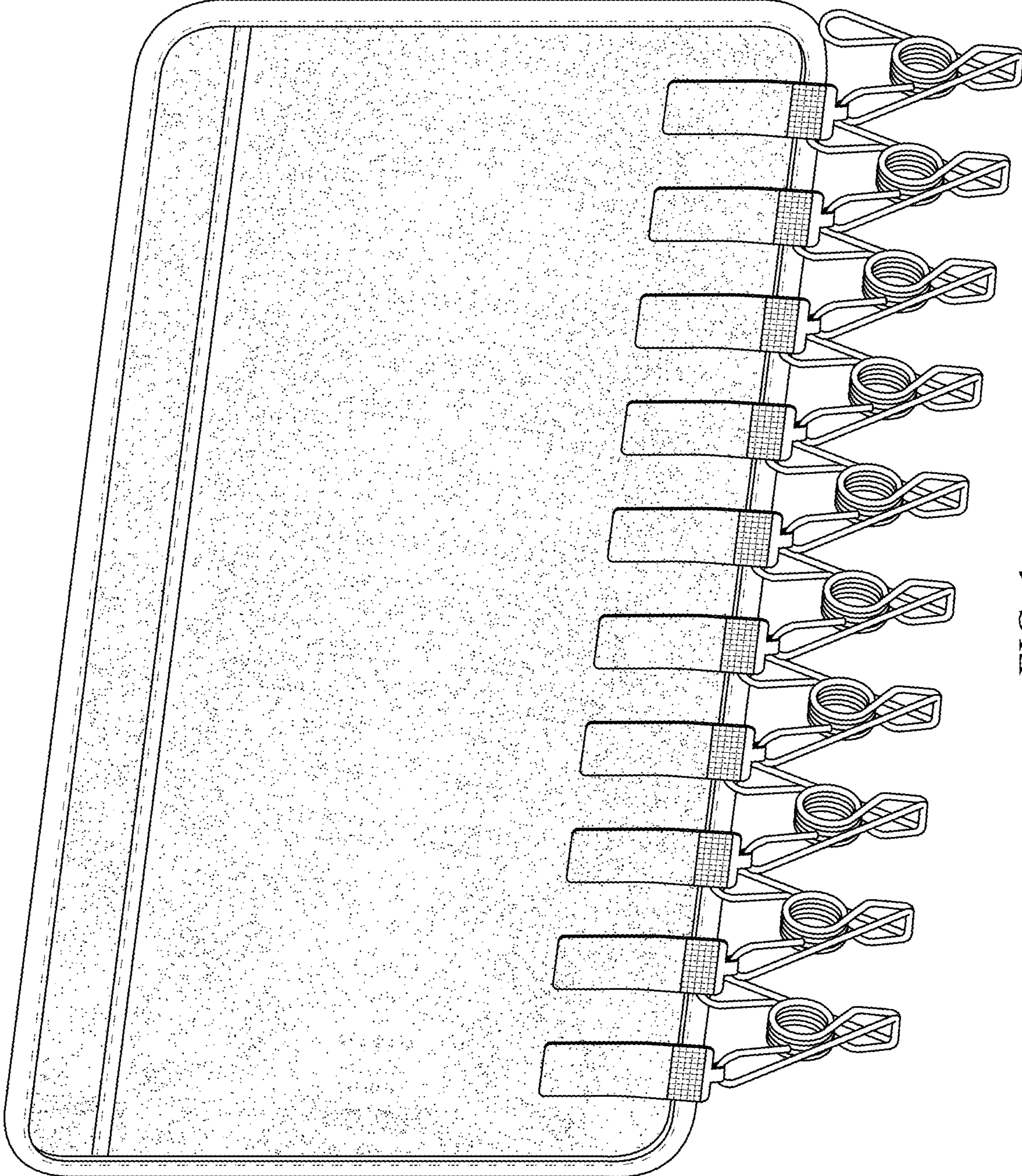

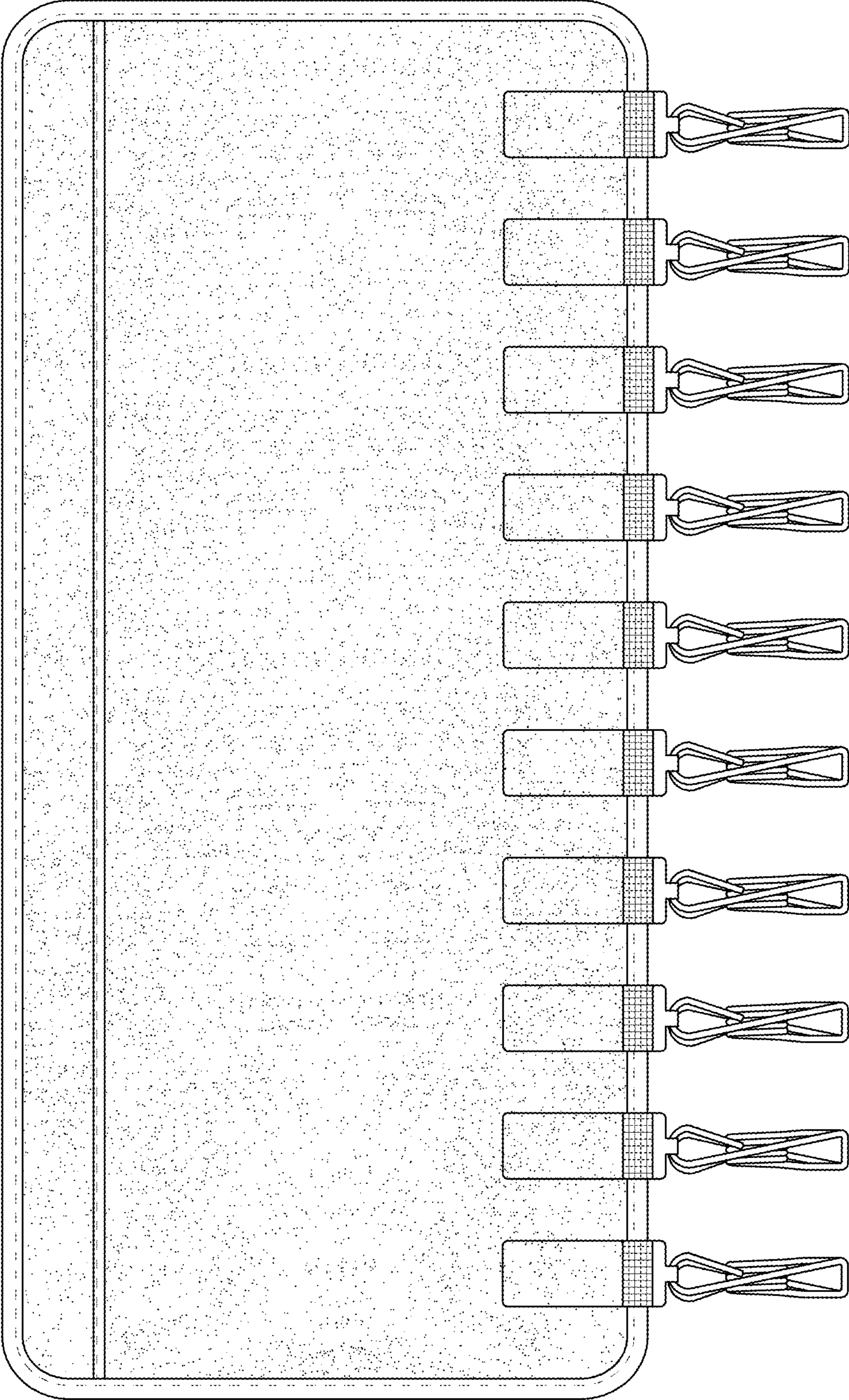

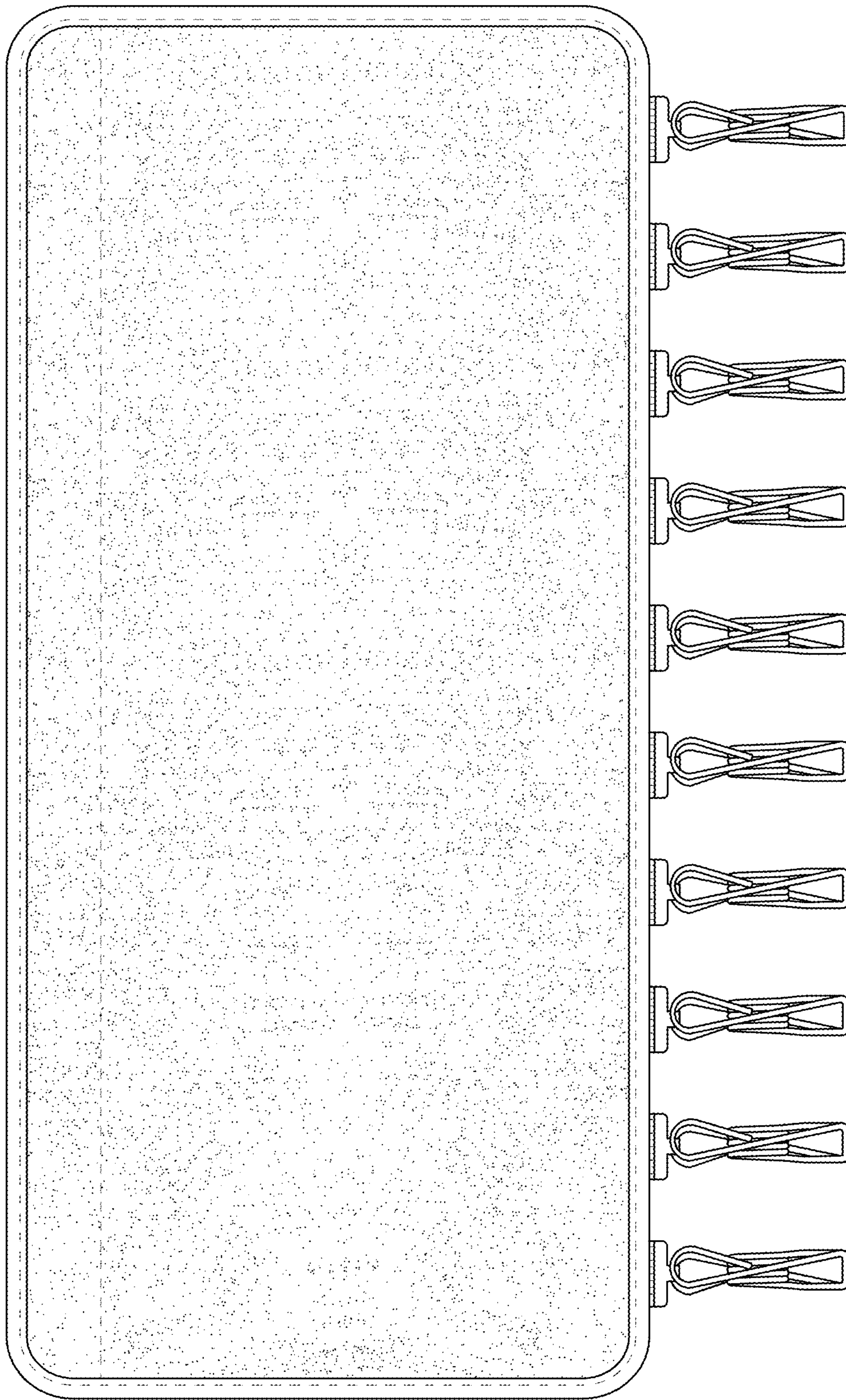

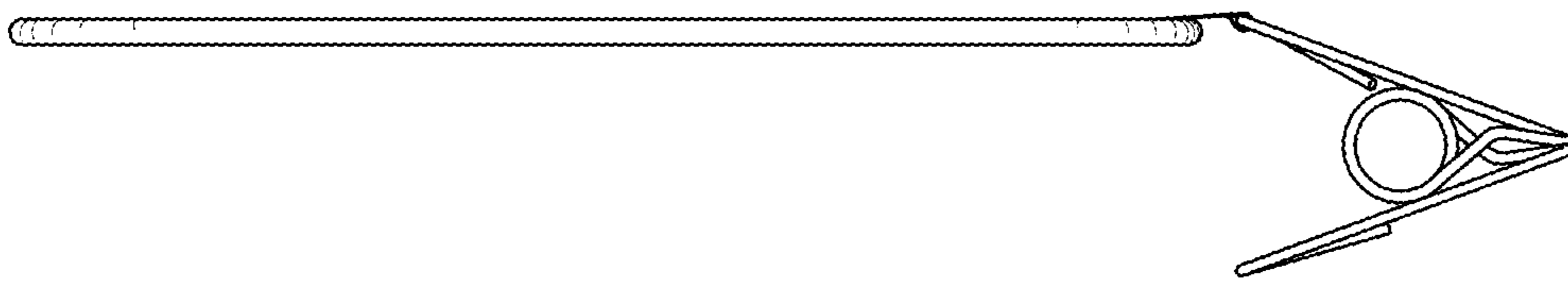

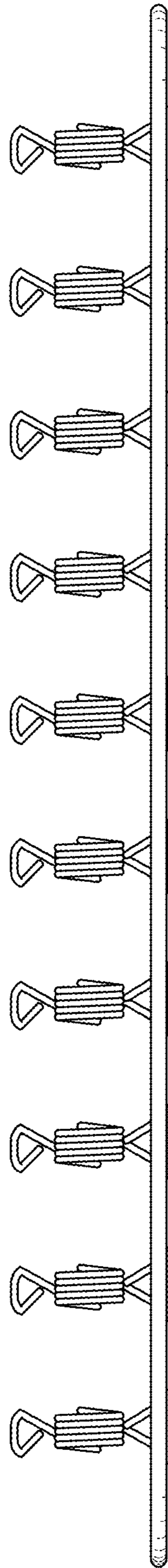

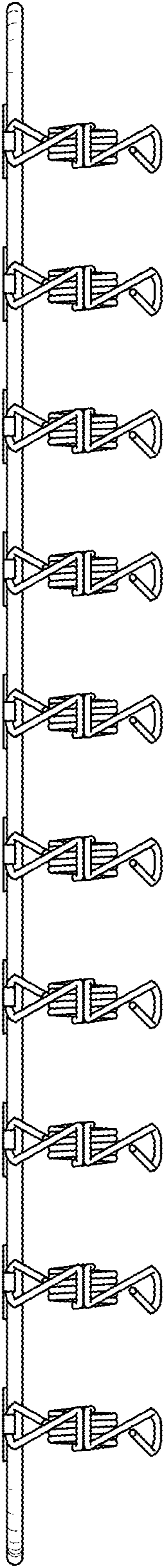
