FIG. 2 is a front elevational view, the rear elevational view being a mirror image thereof.

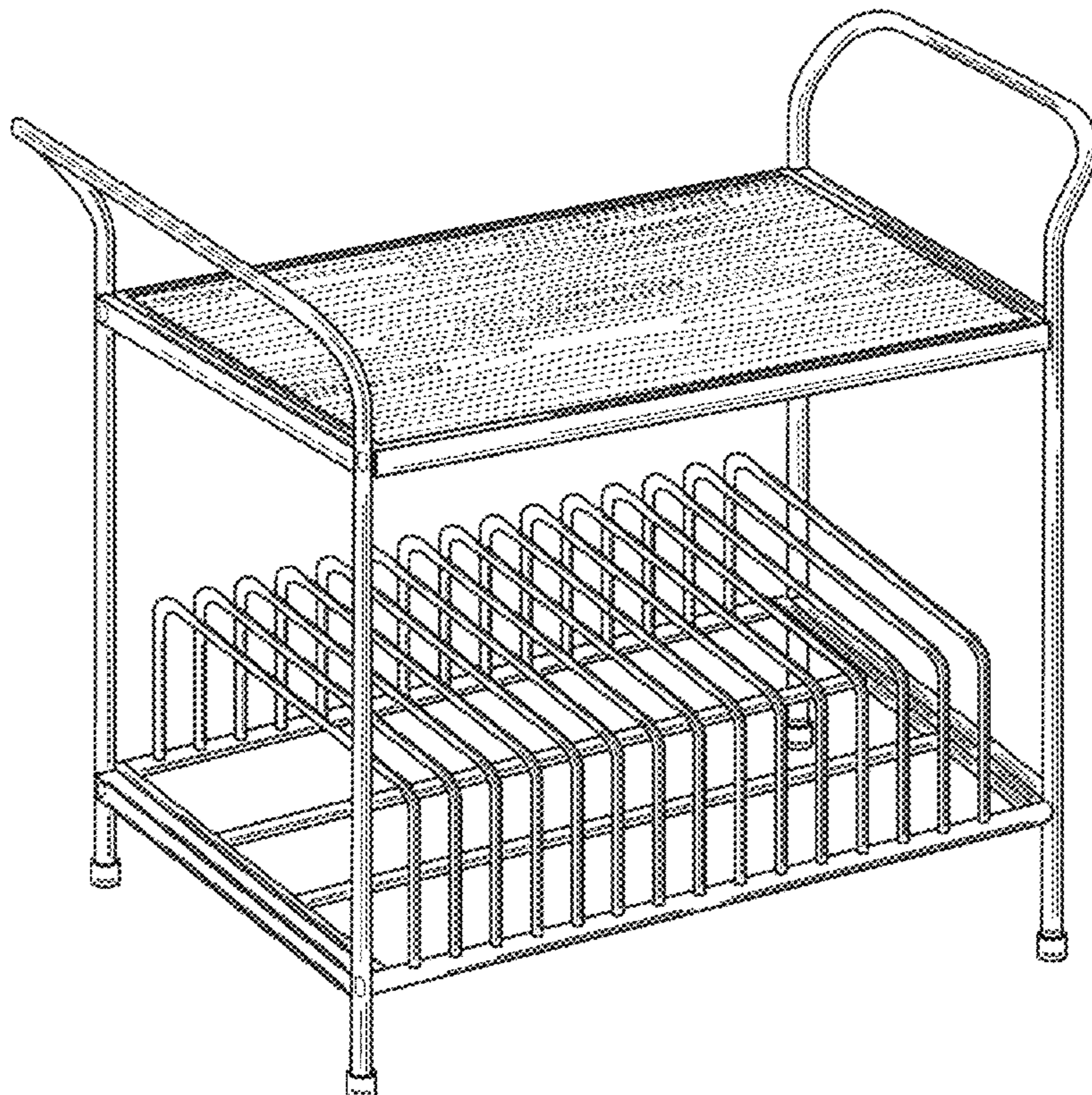
FIG. 3 is a top plan view thereof.

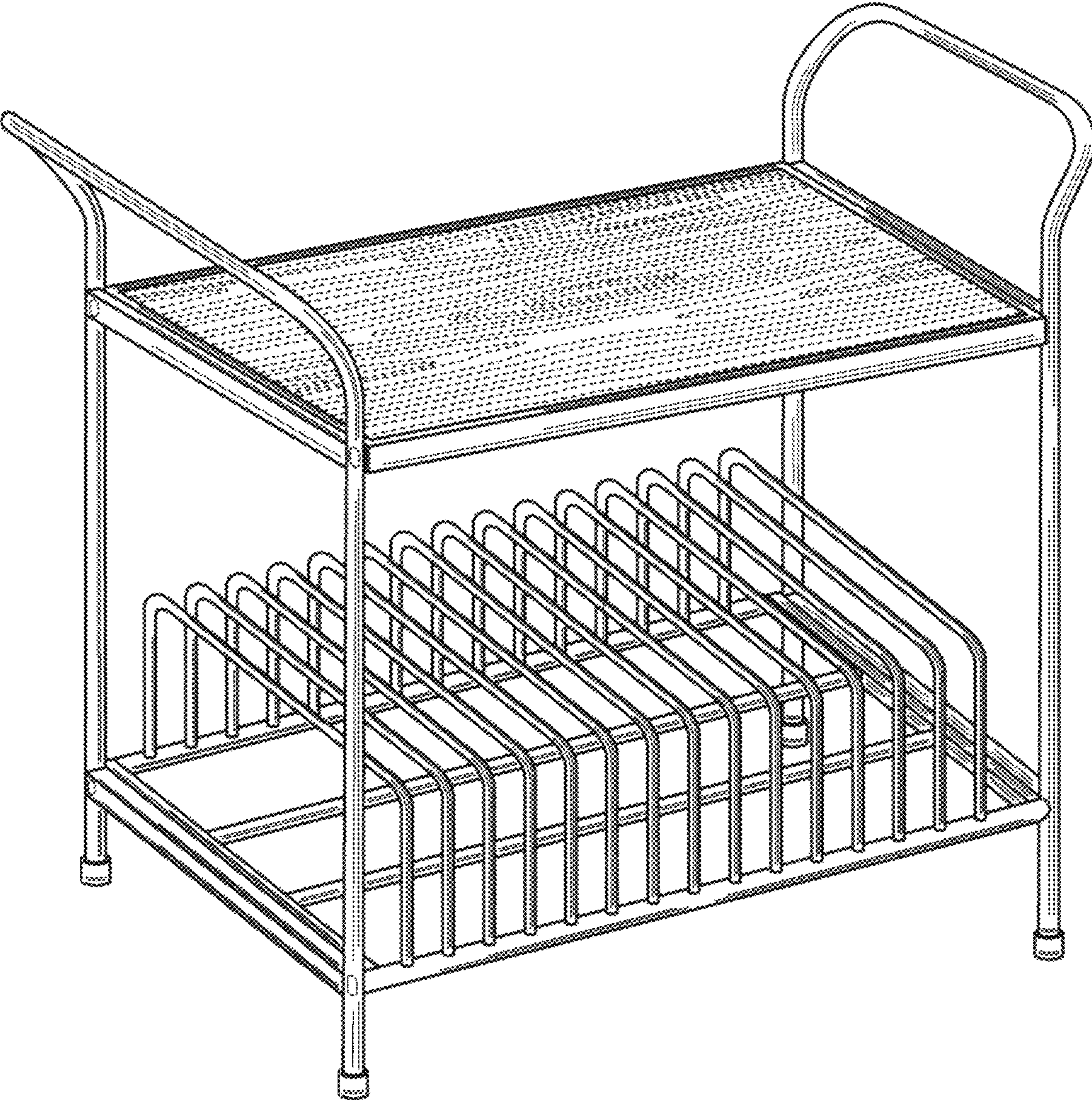

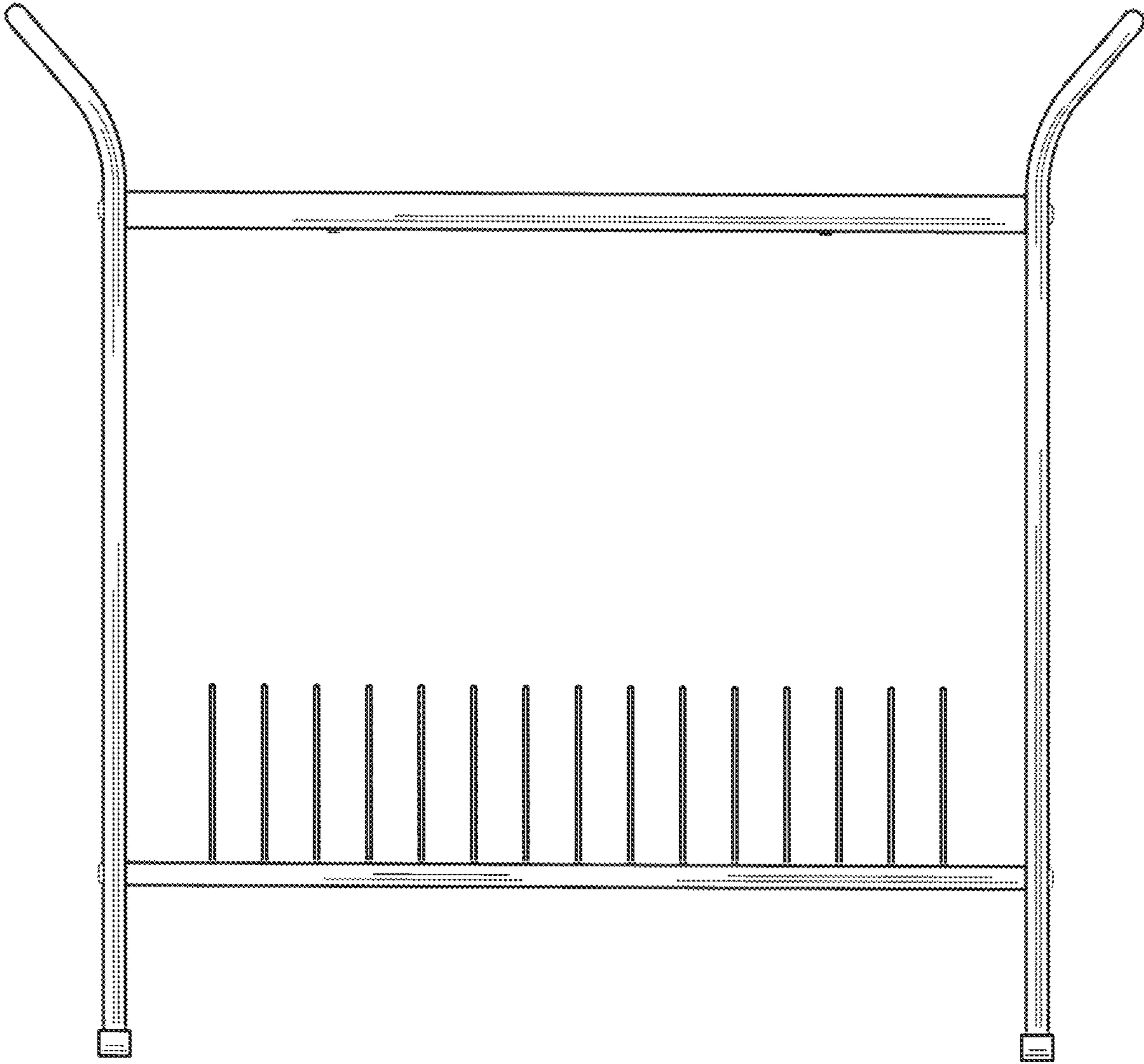

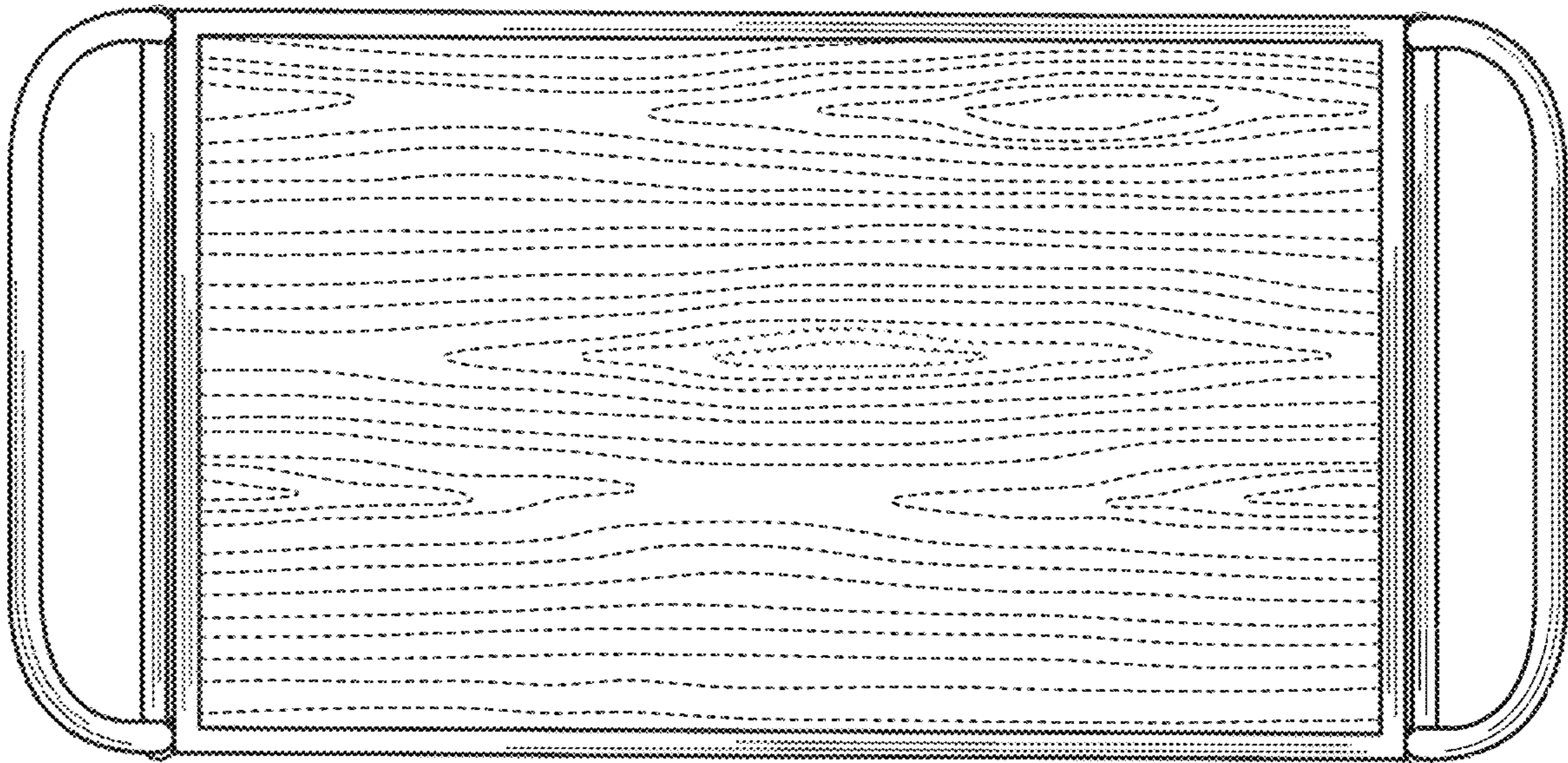

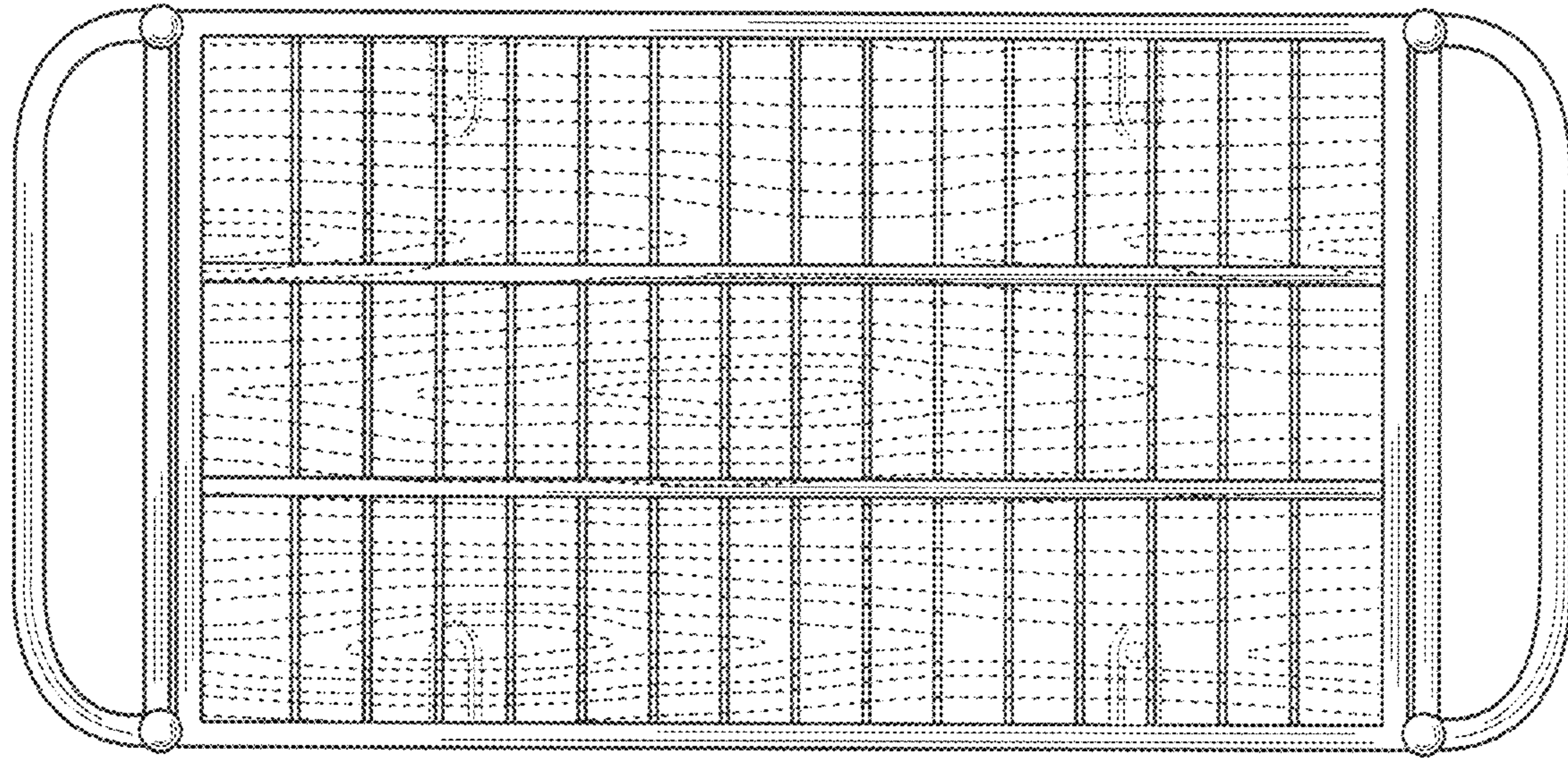

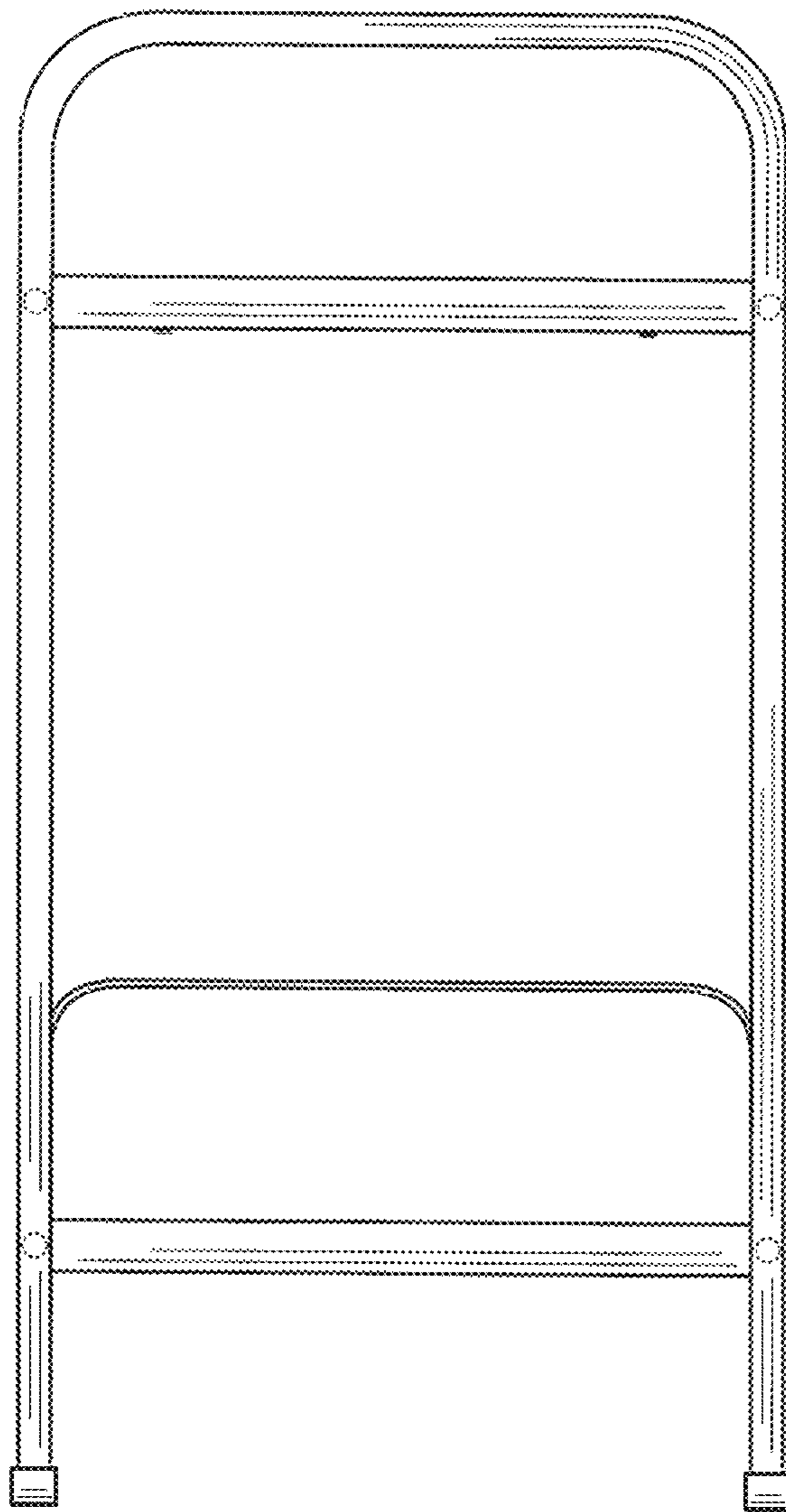
