FIG. 15 is a right side elevational view thereof;

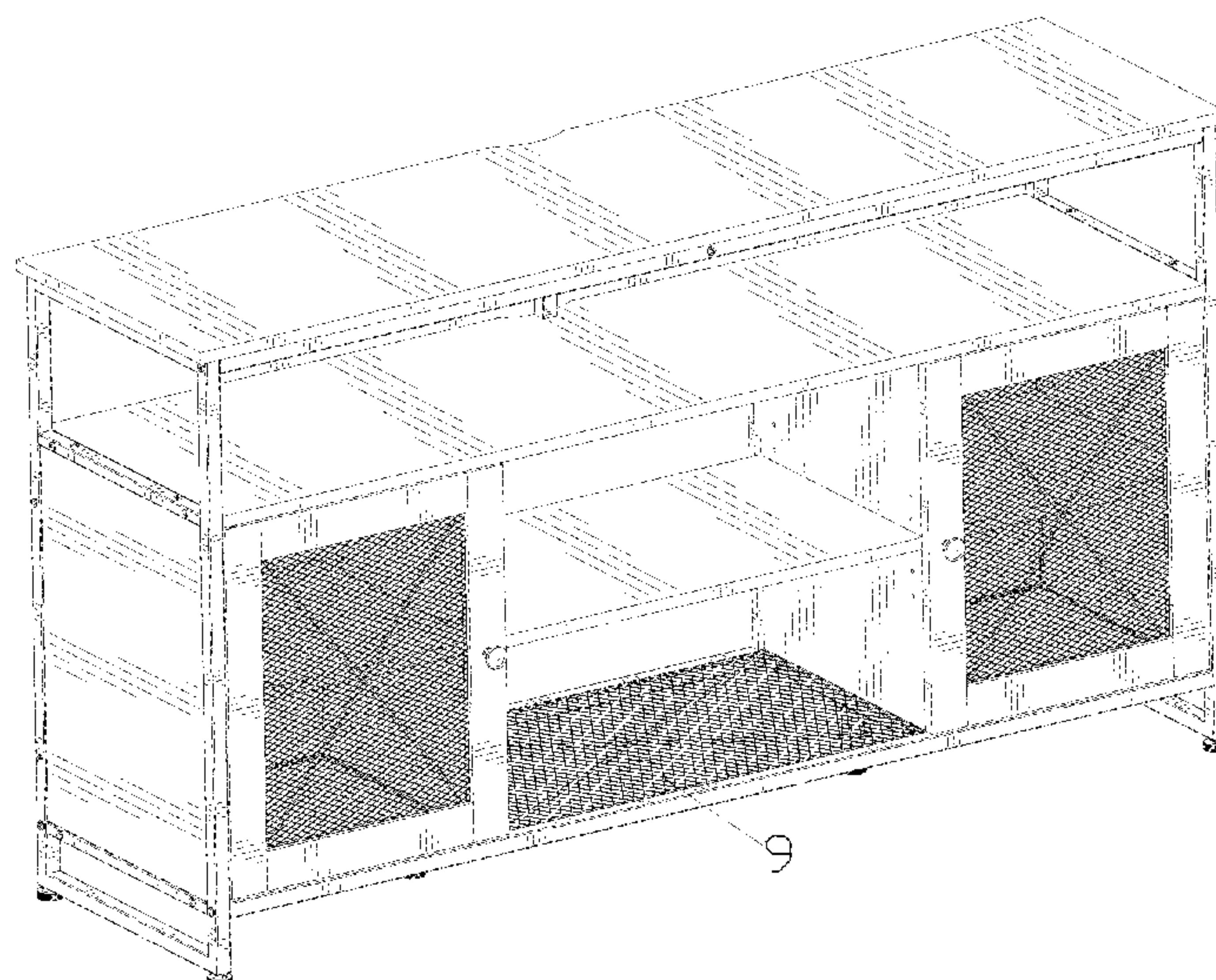
FIG. 16 is a top plan view thereof;

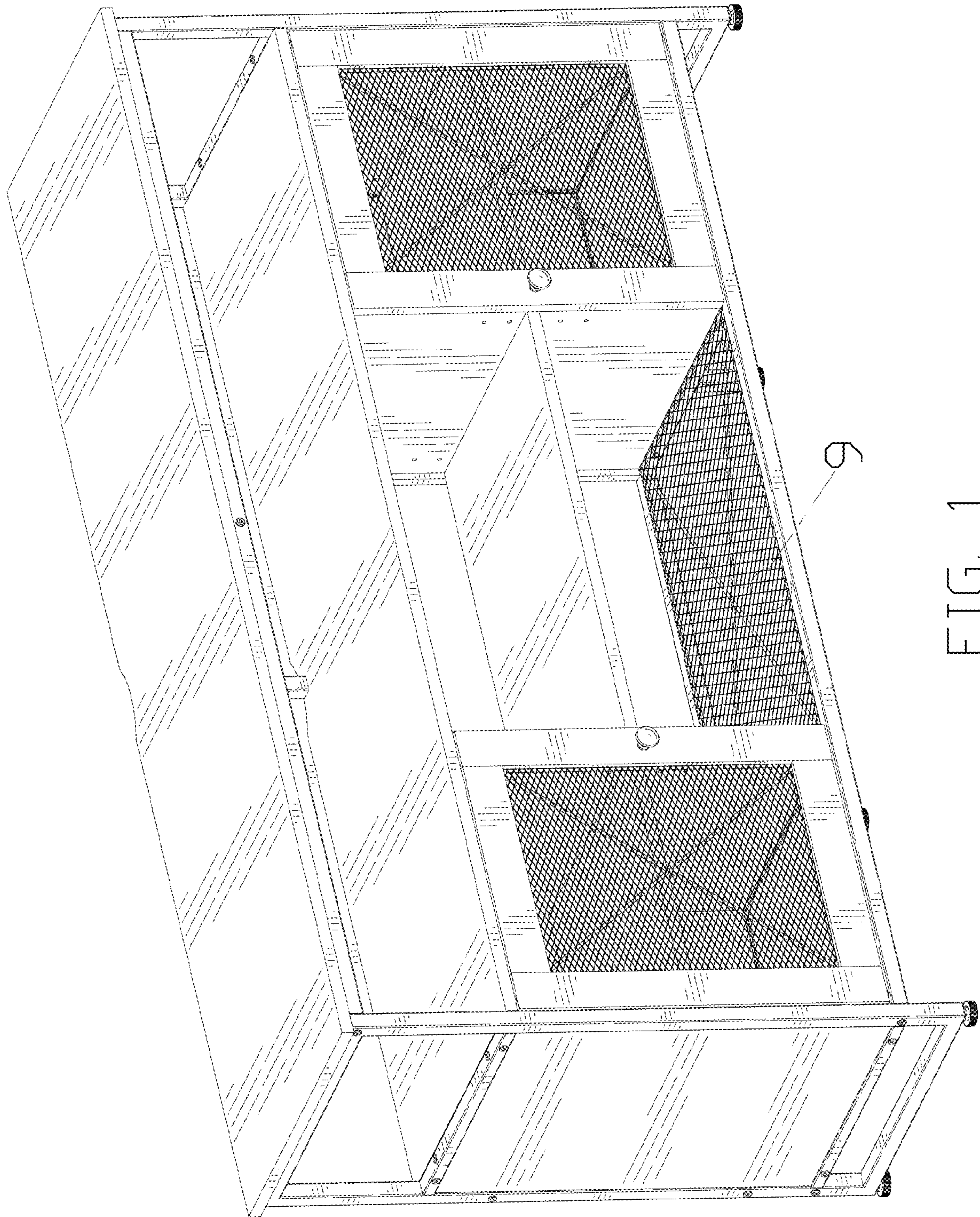

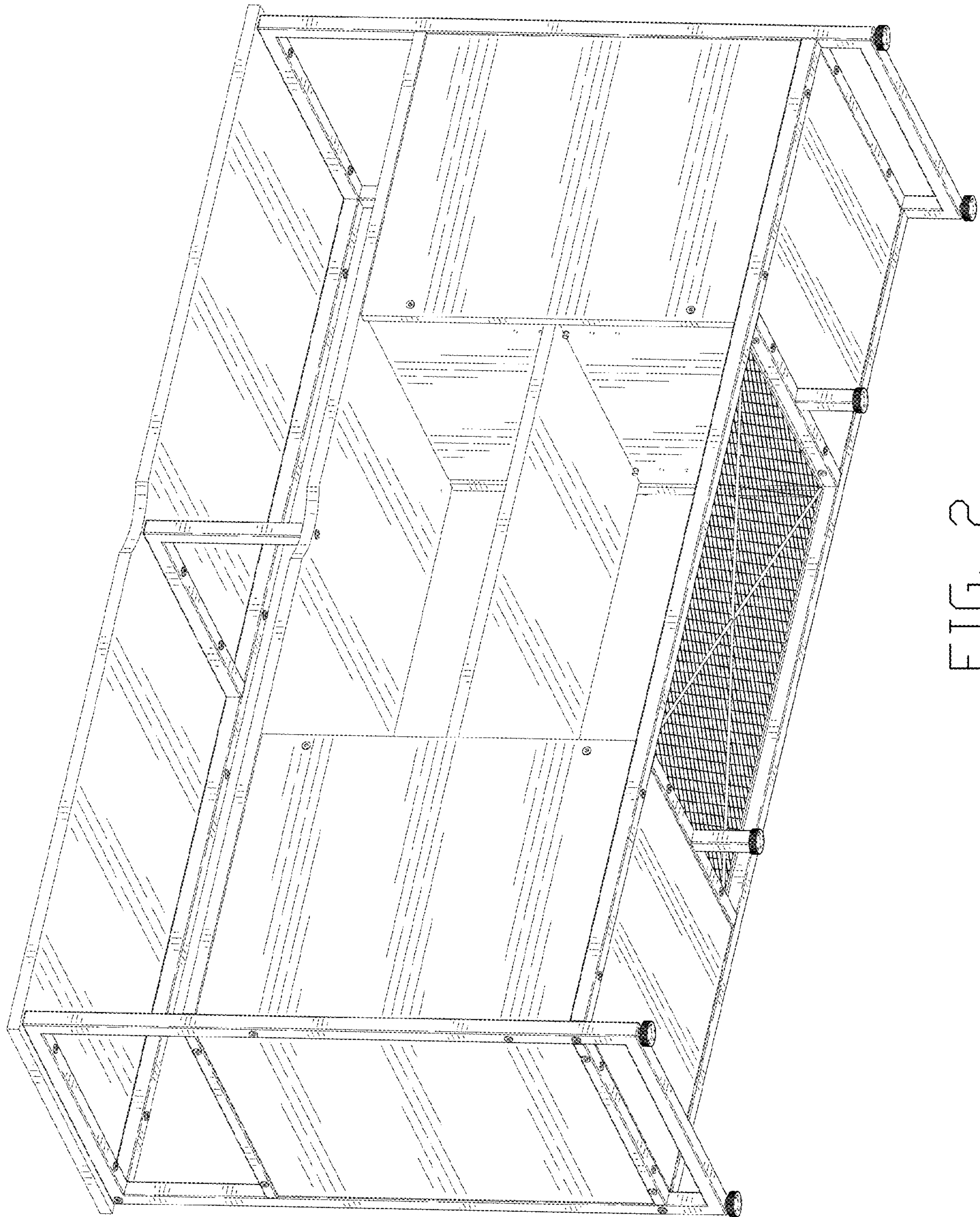

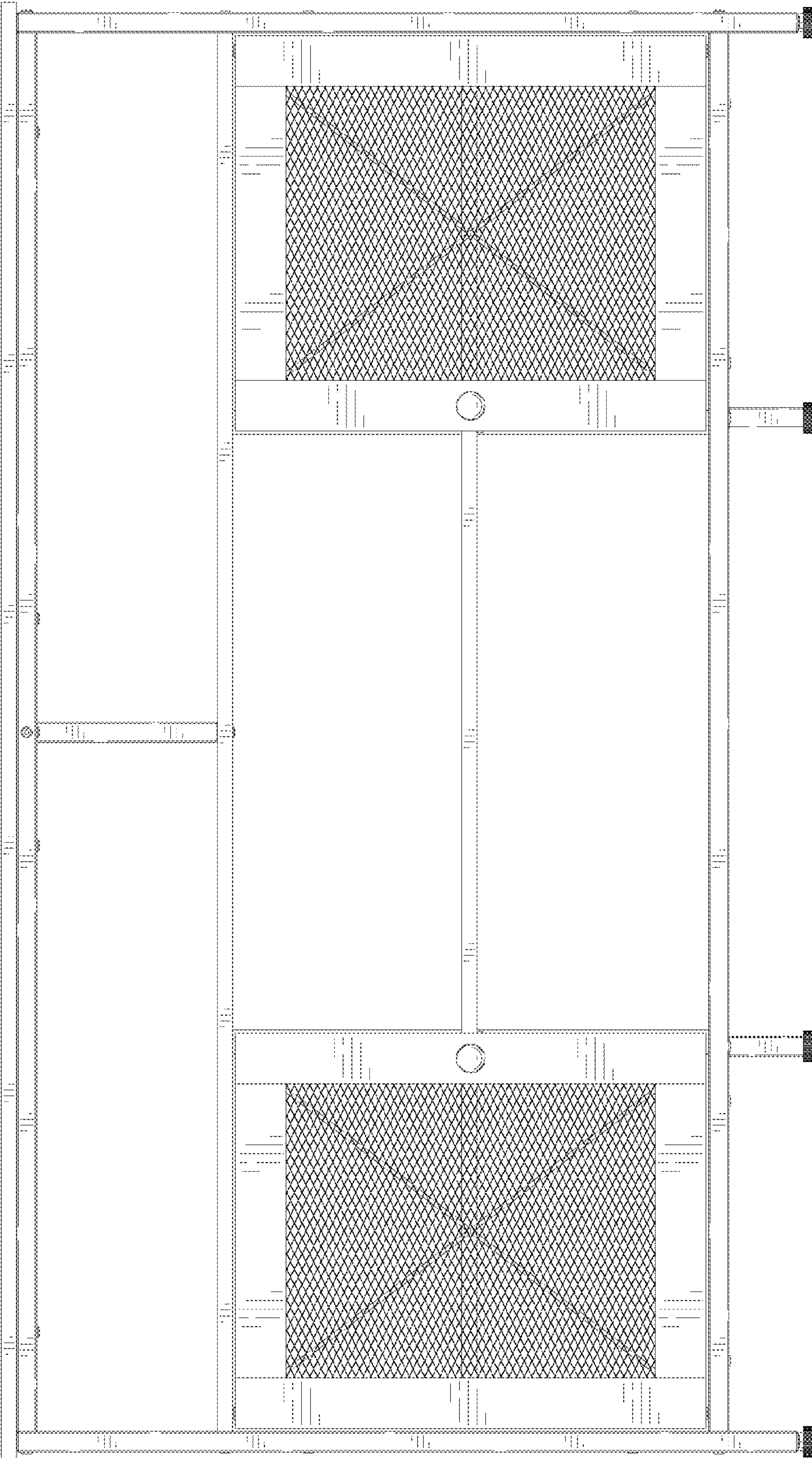

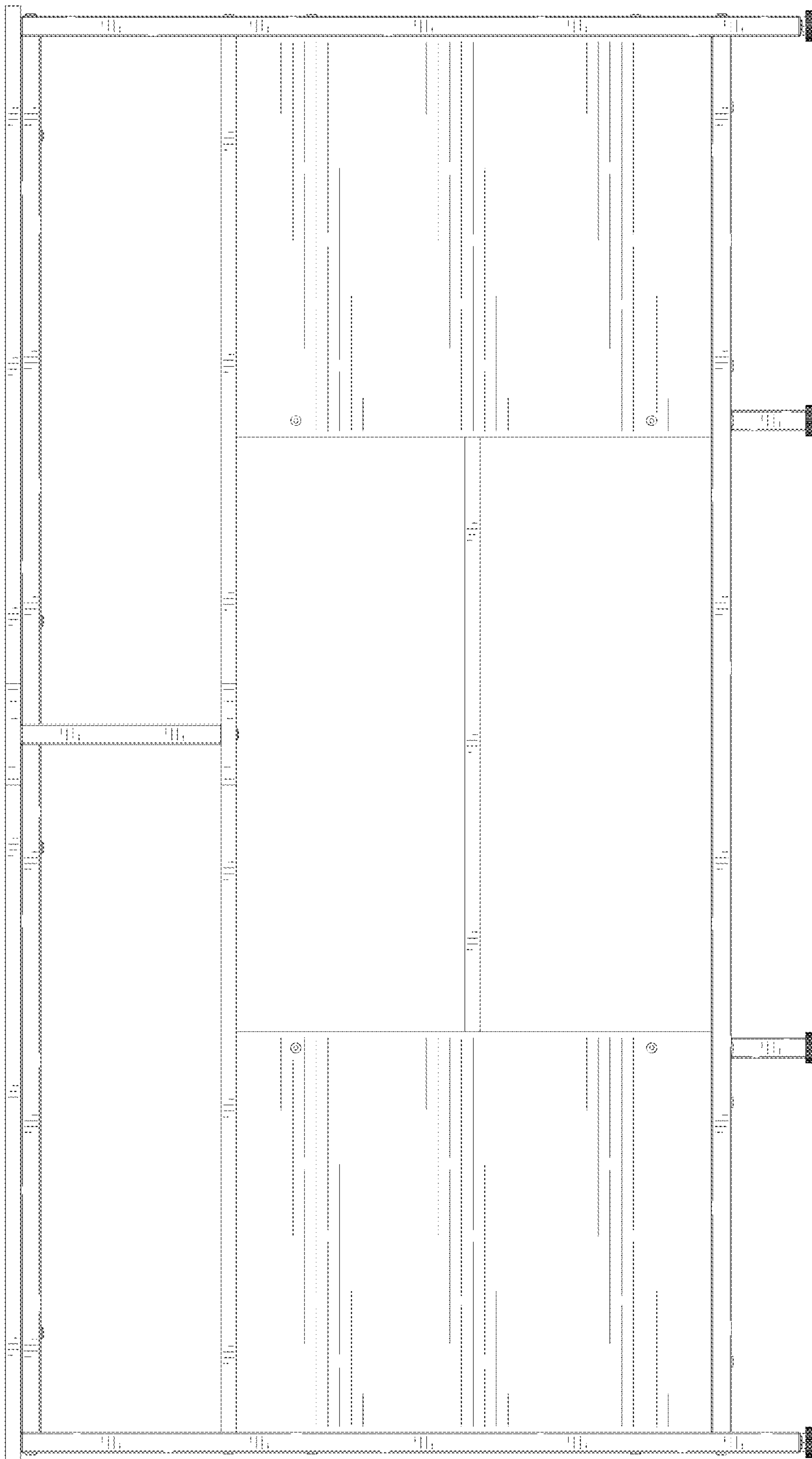

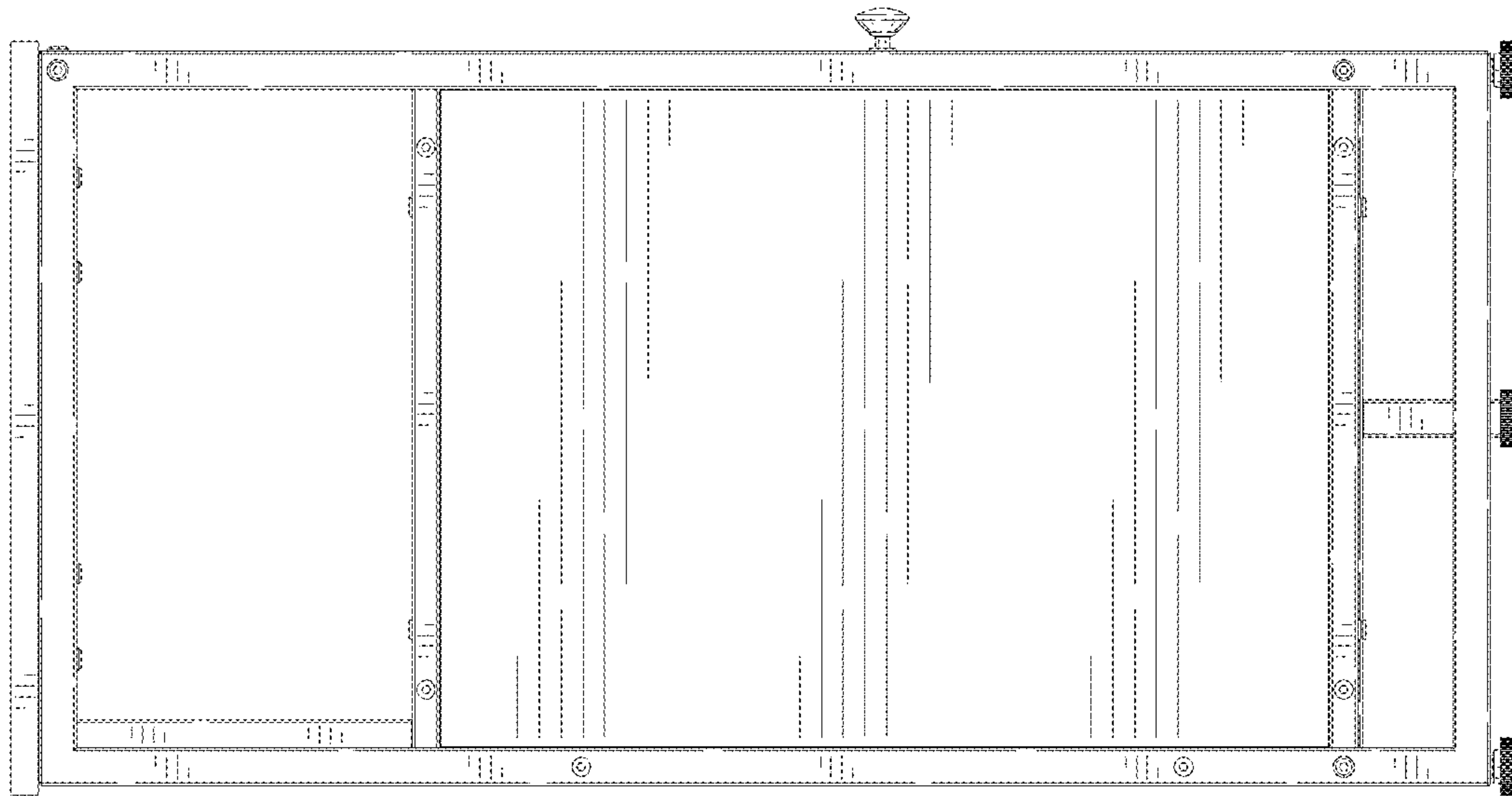

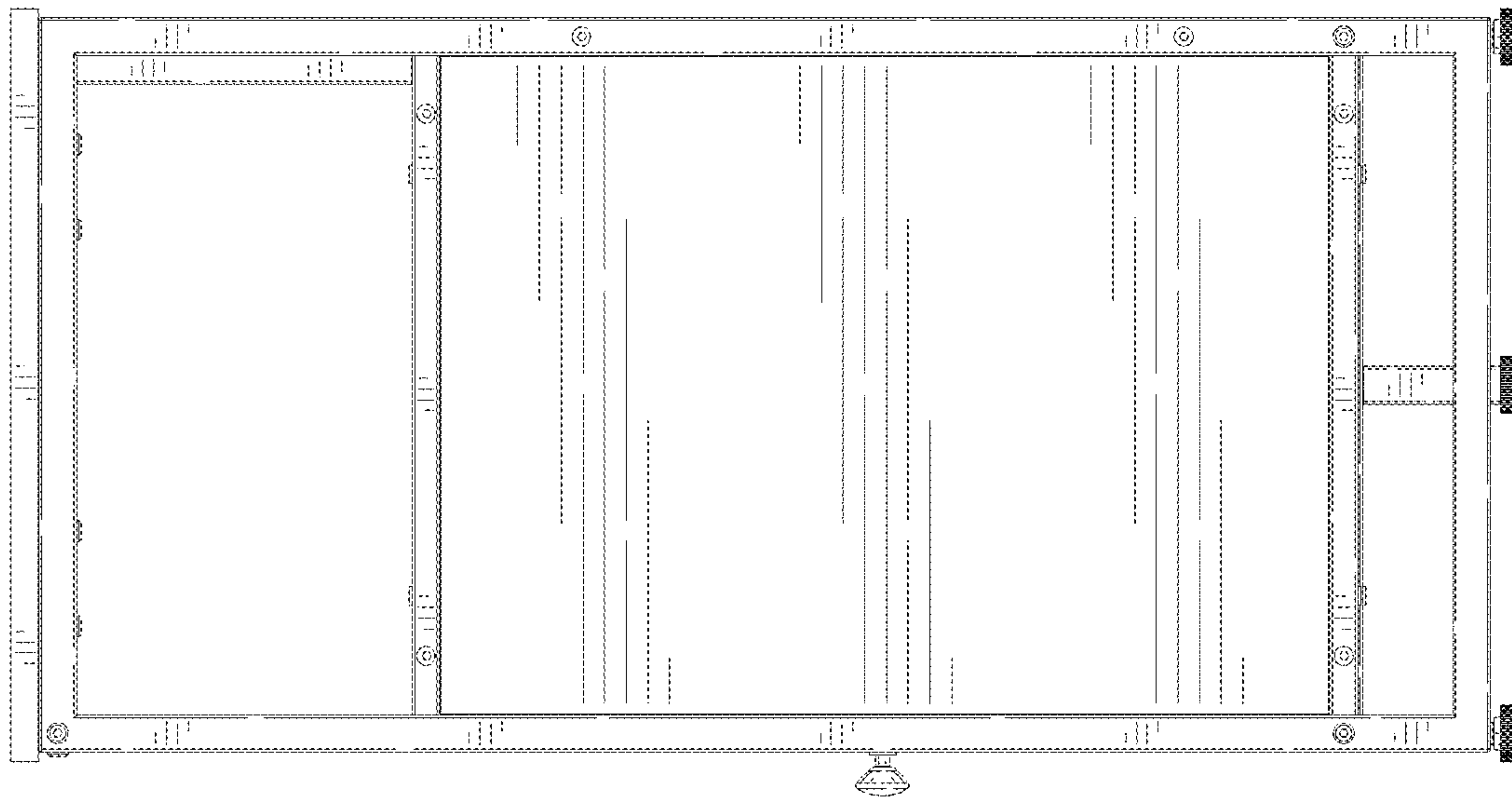

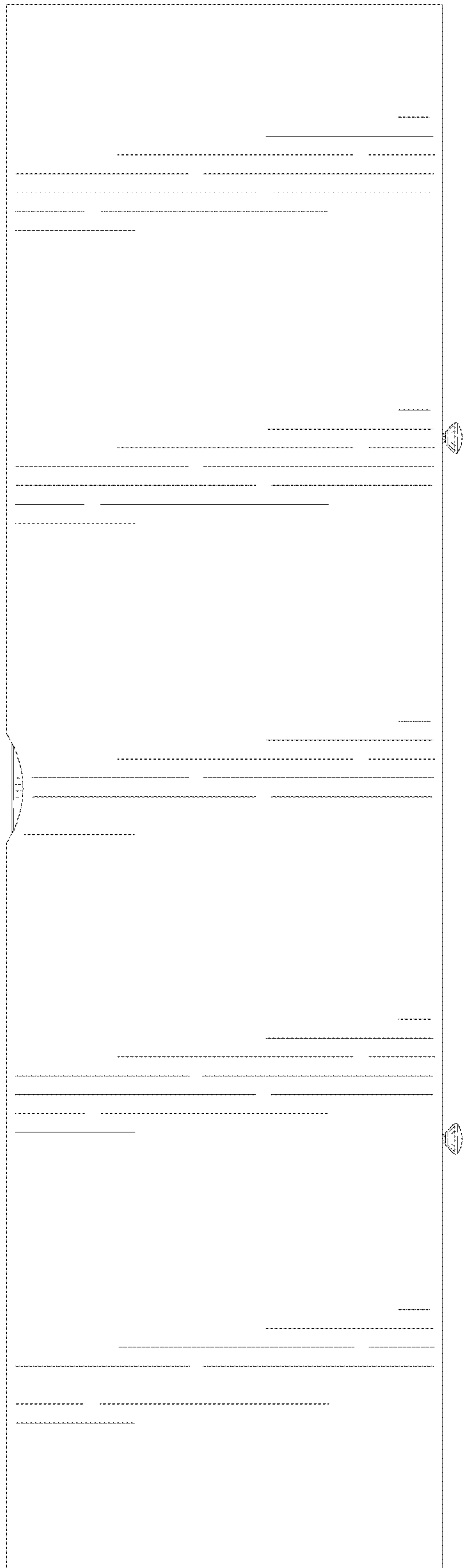

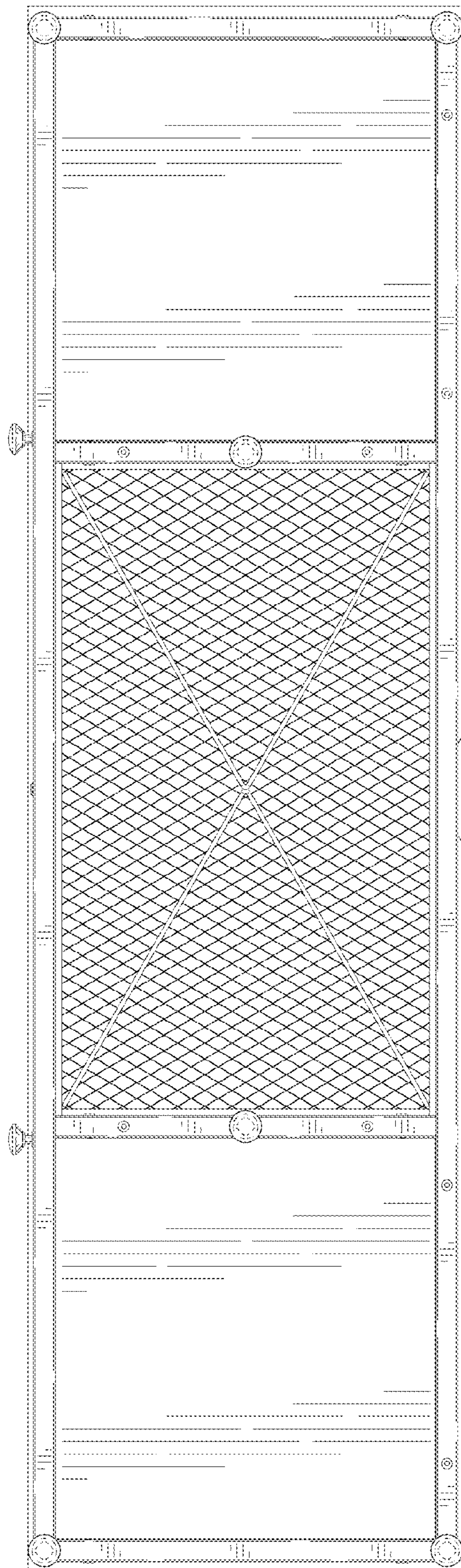

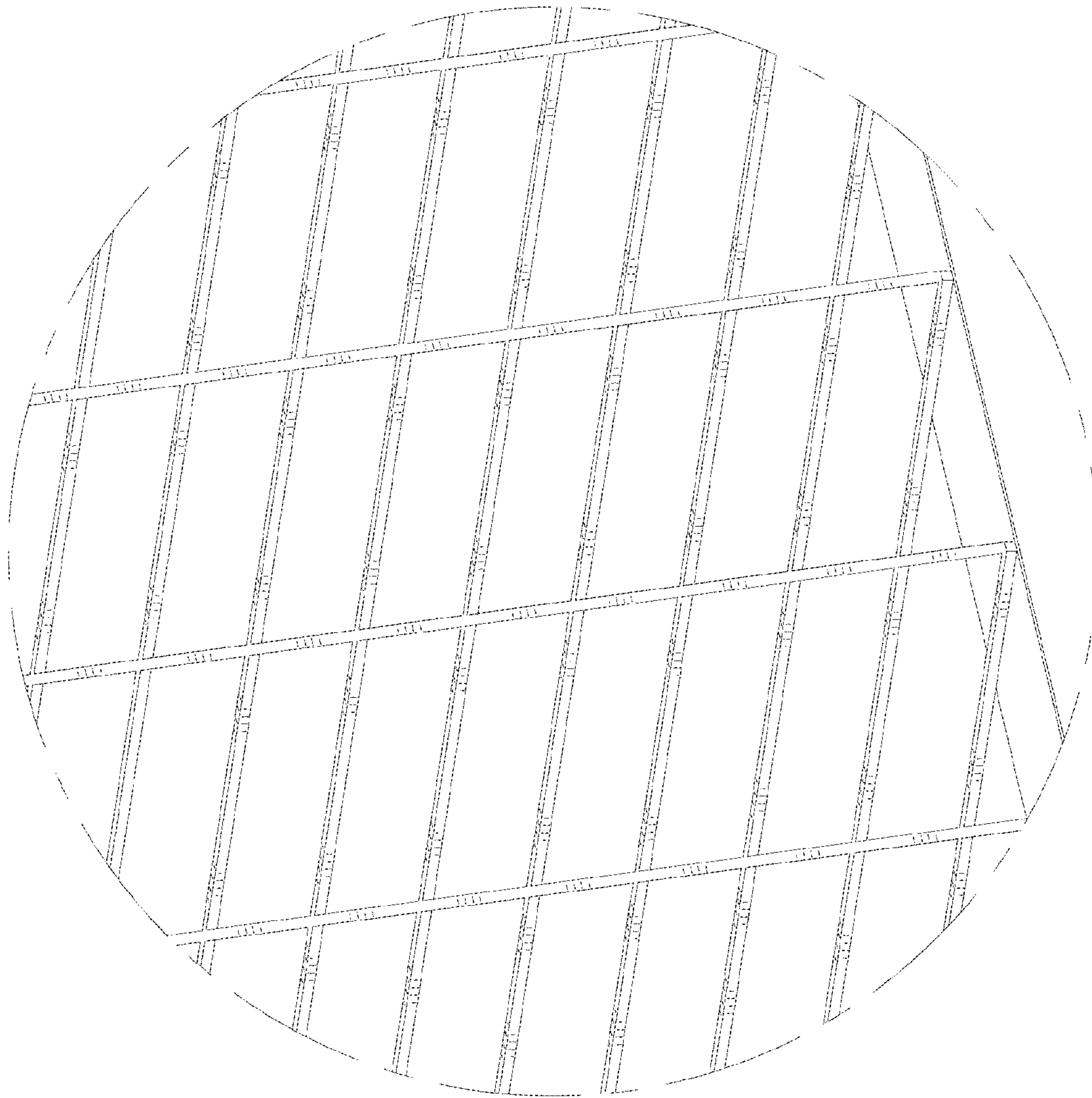

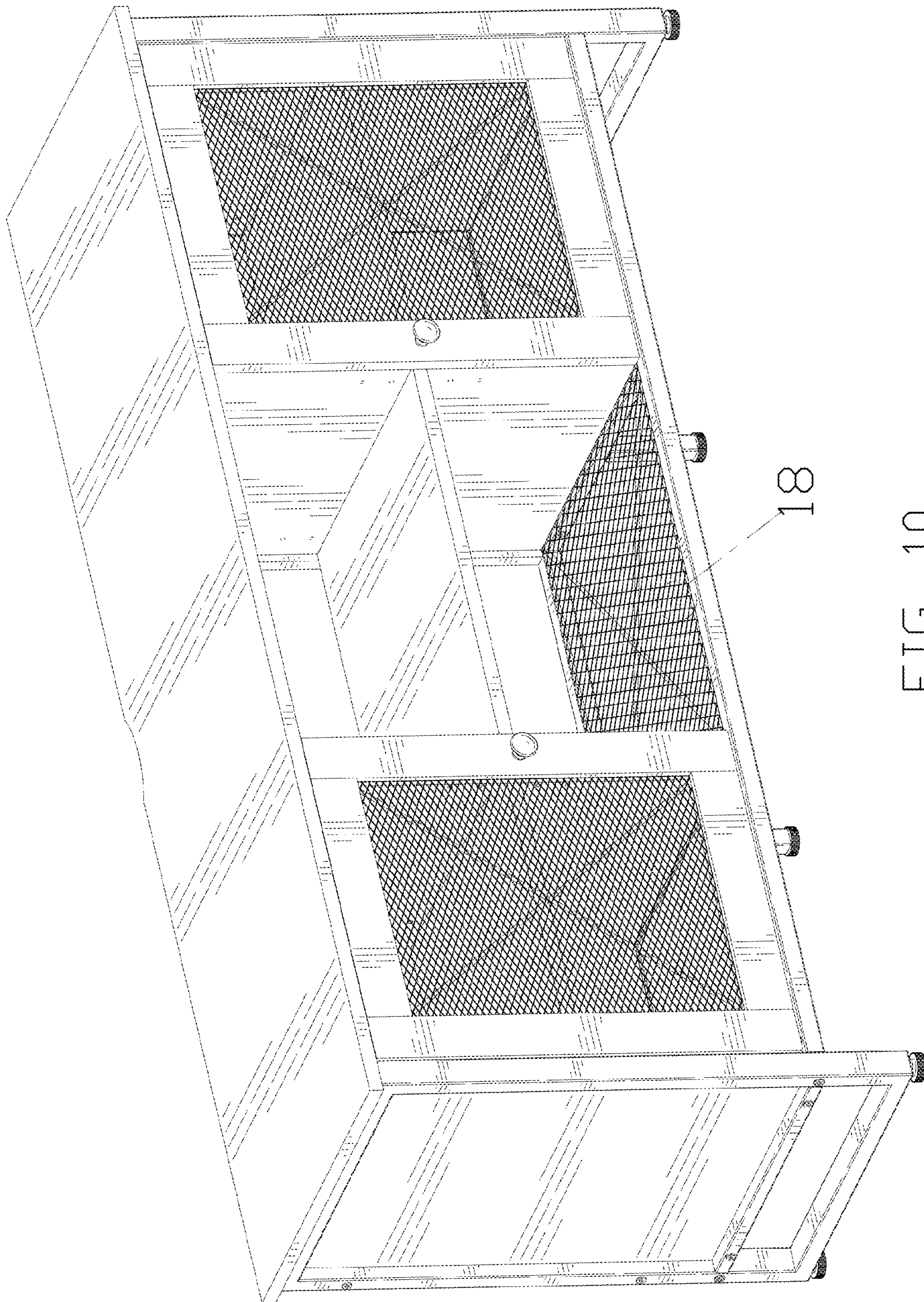

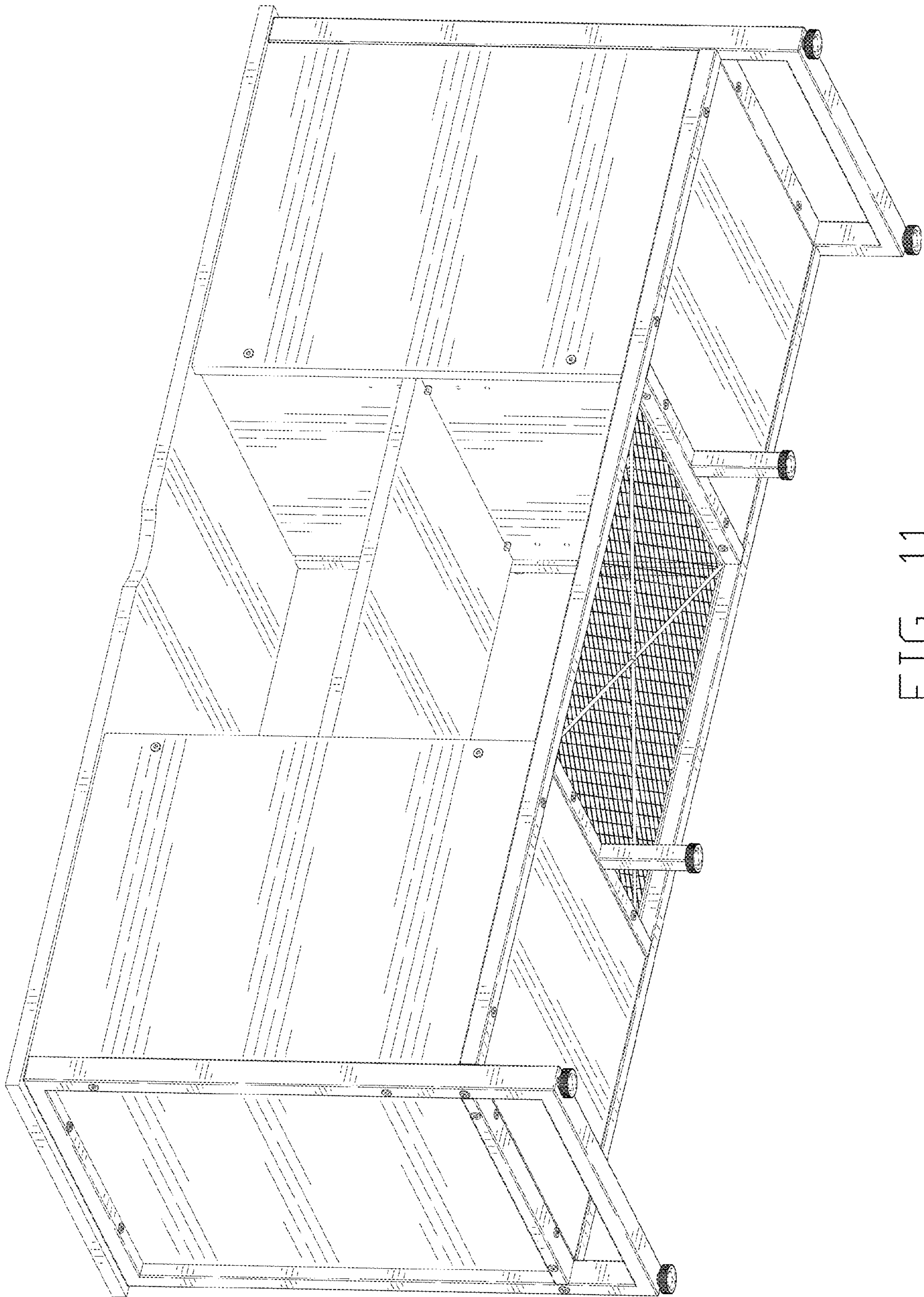

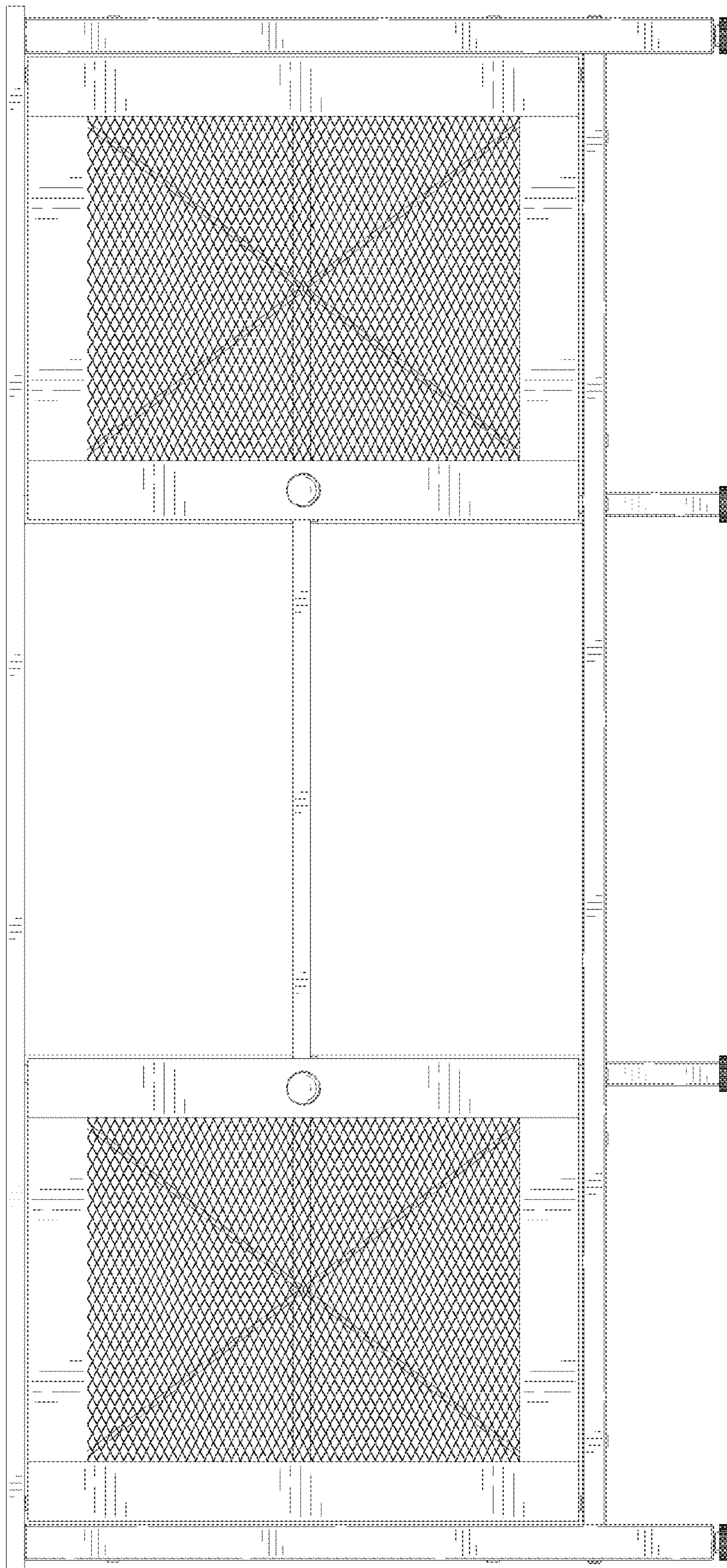

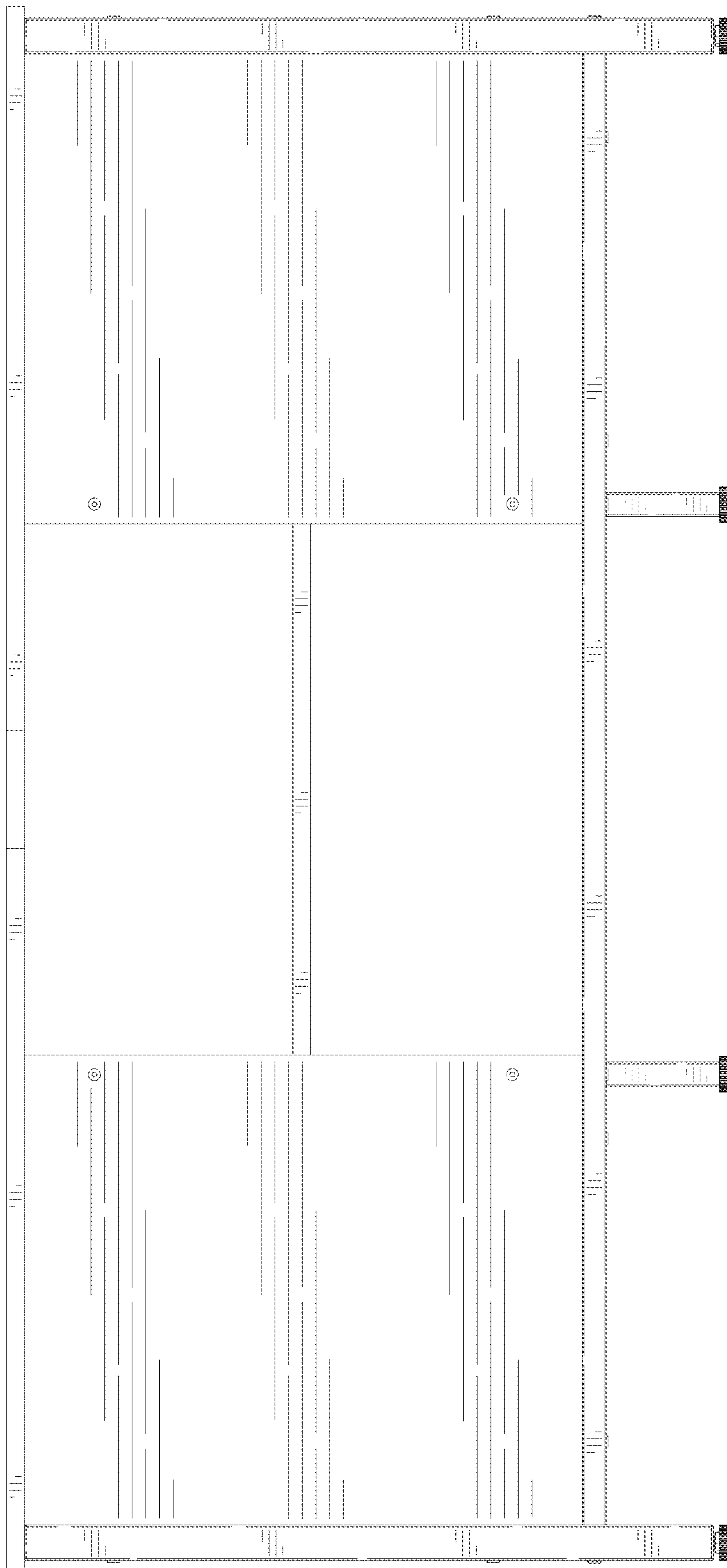

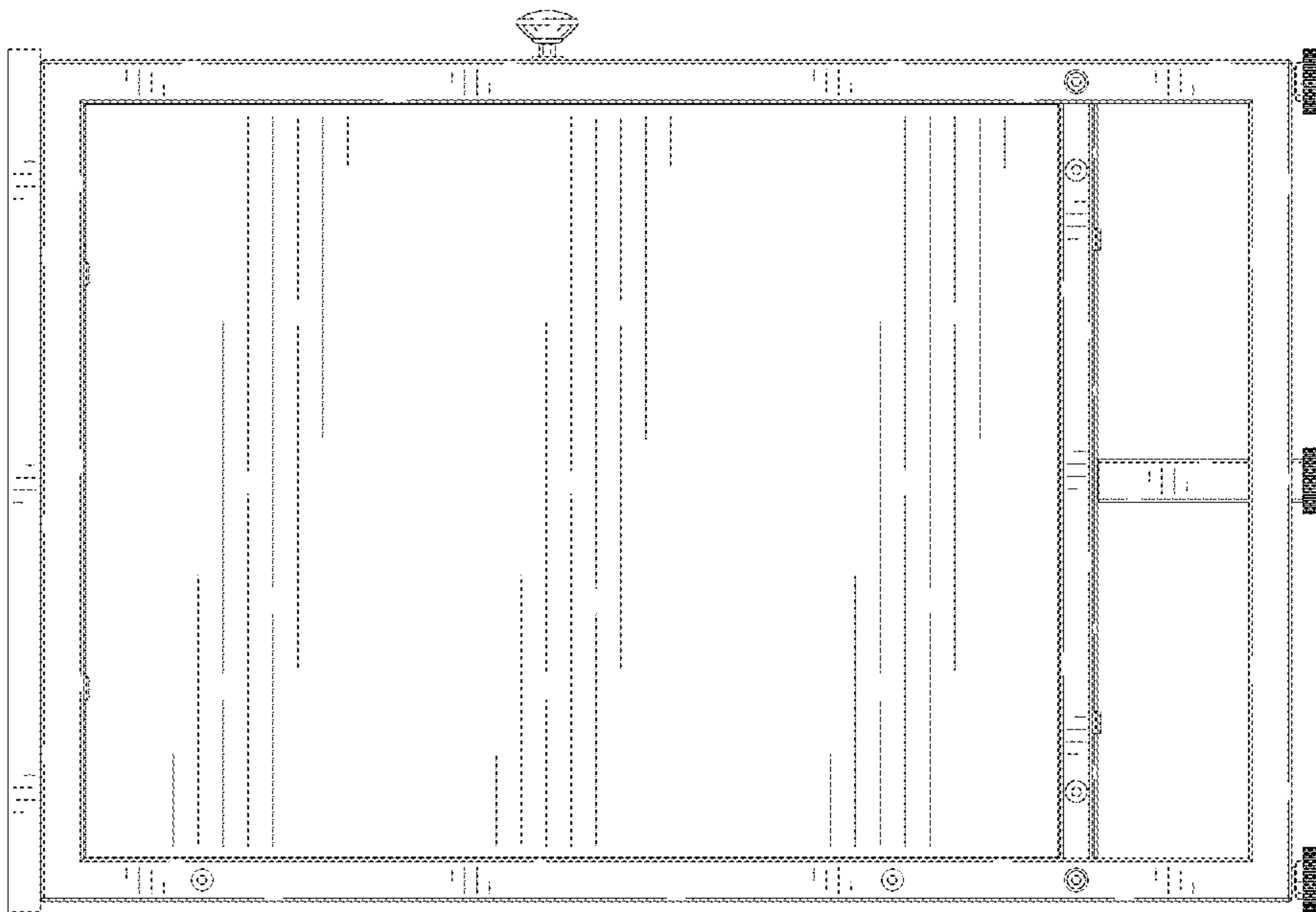

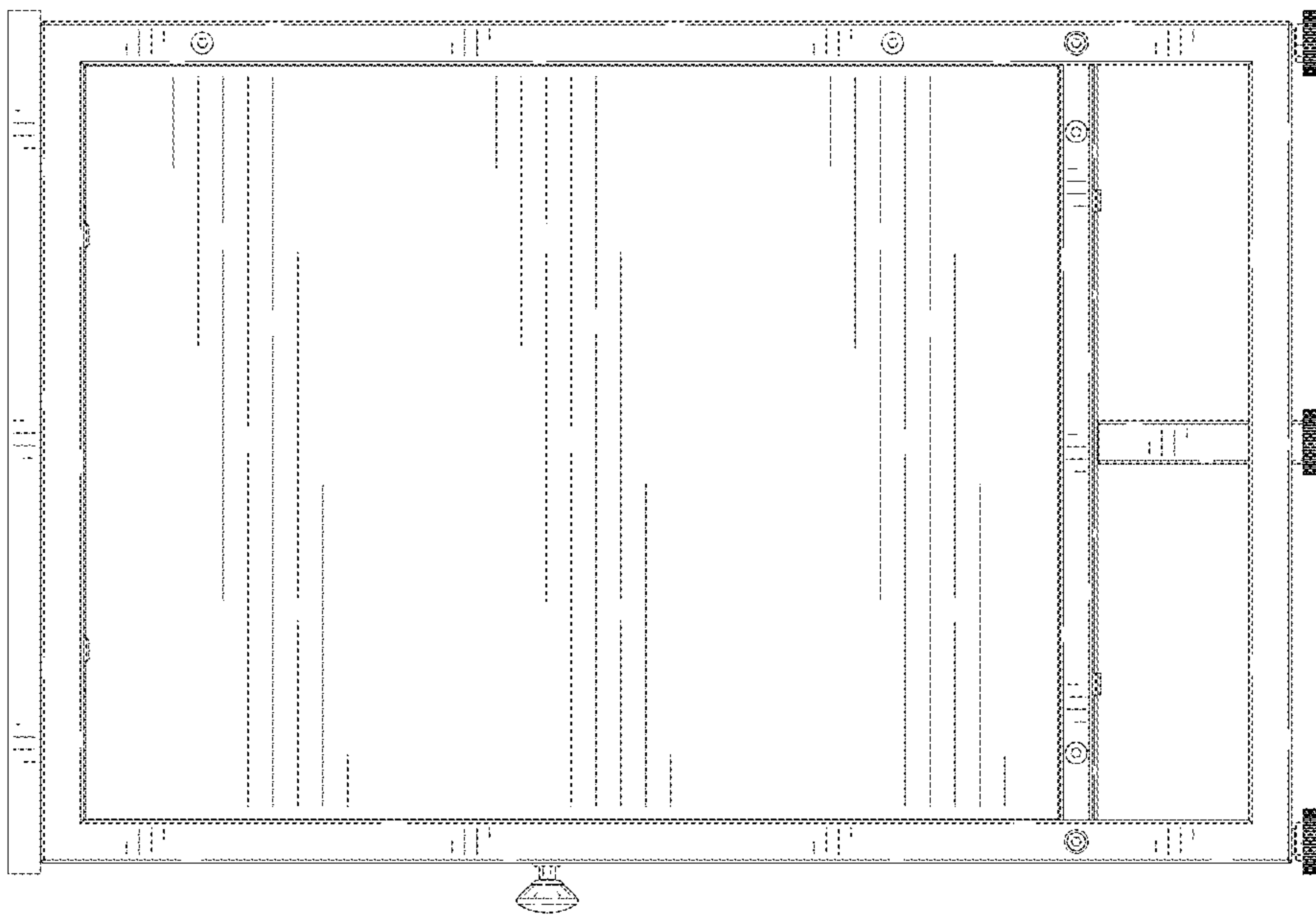

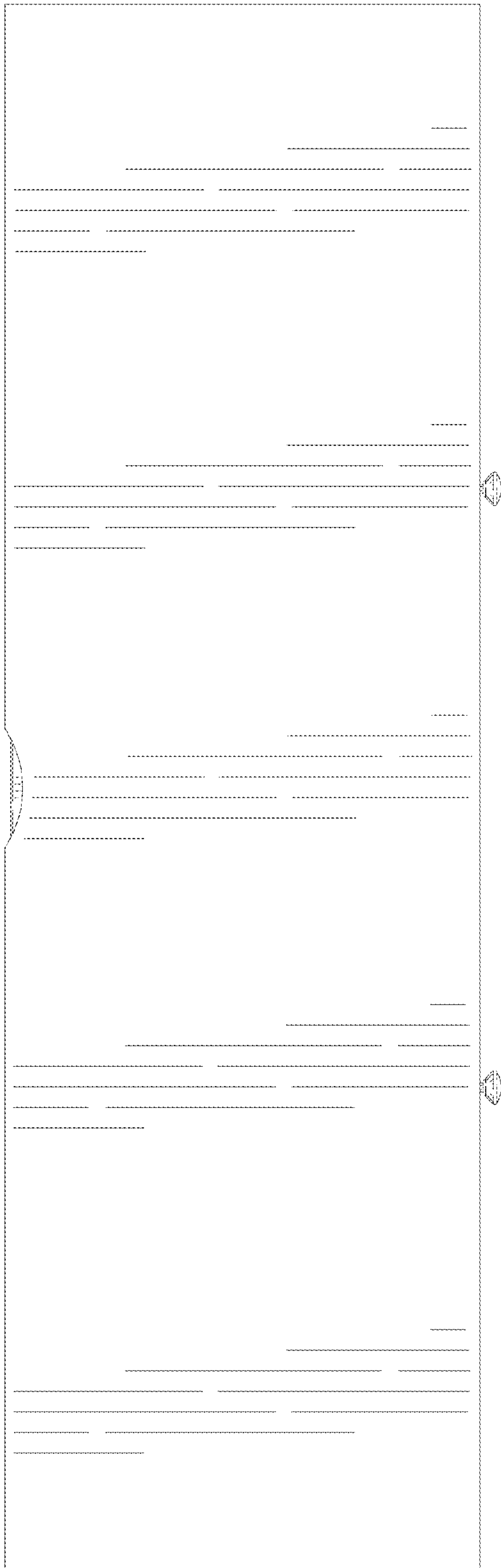

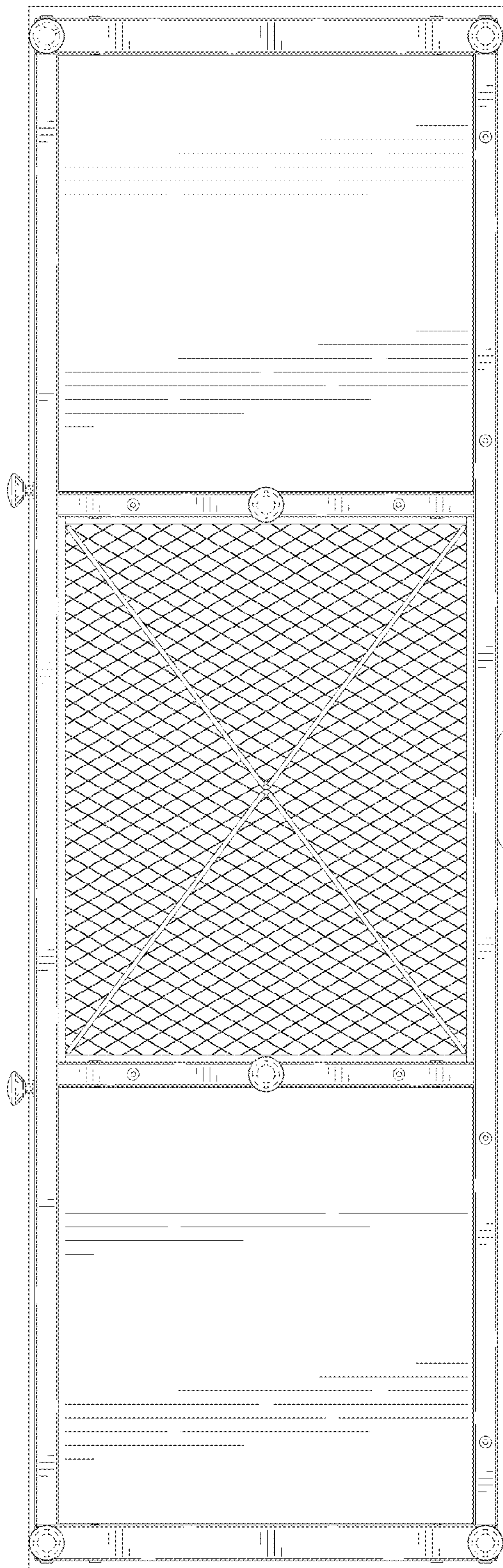

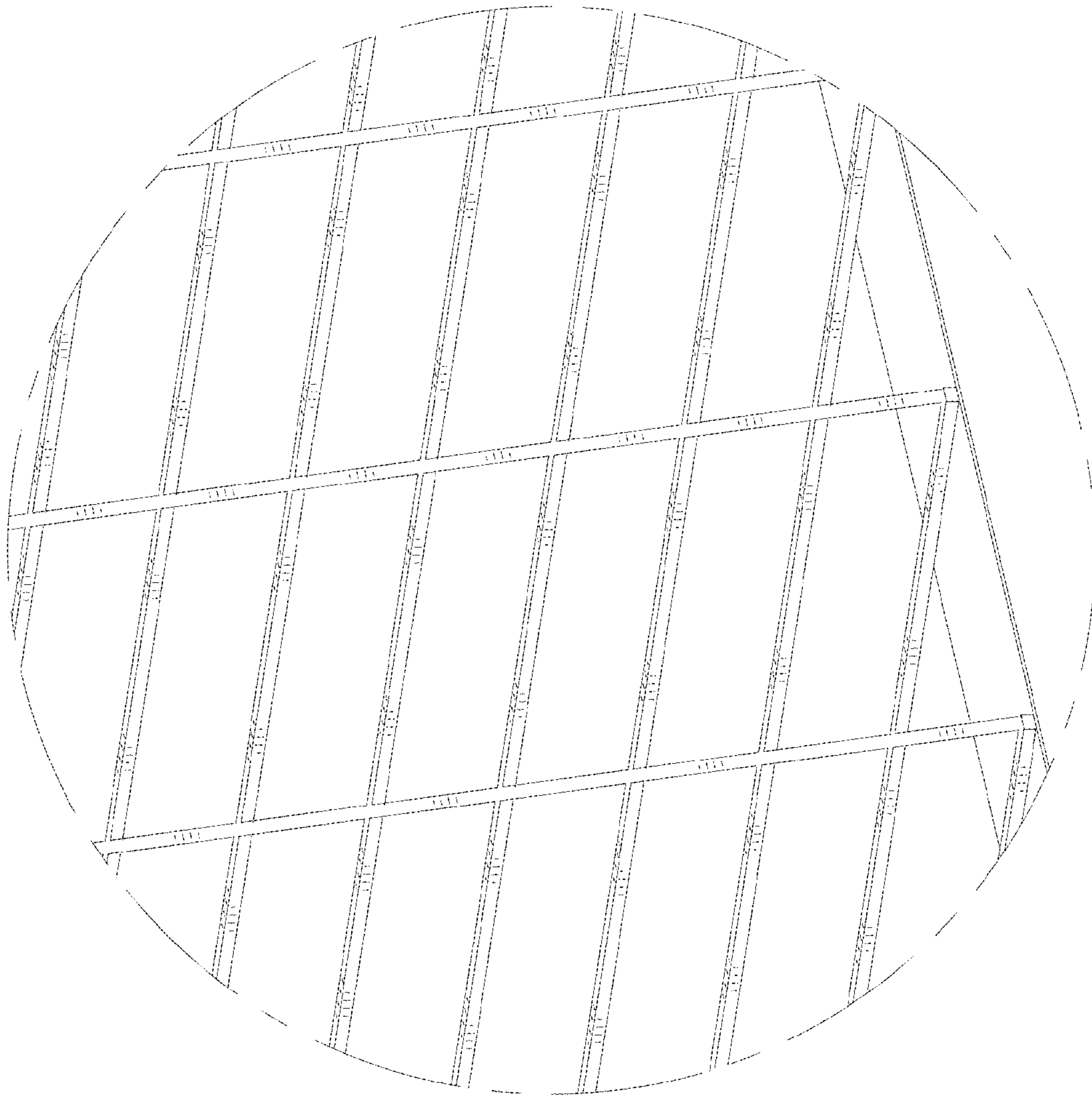
