The ornamental design for a storage cabinet for food ingredient, as shown and described.

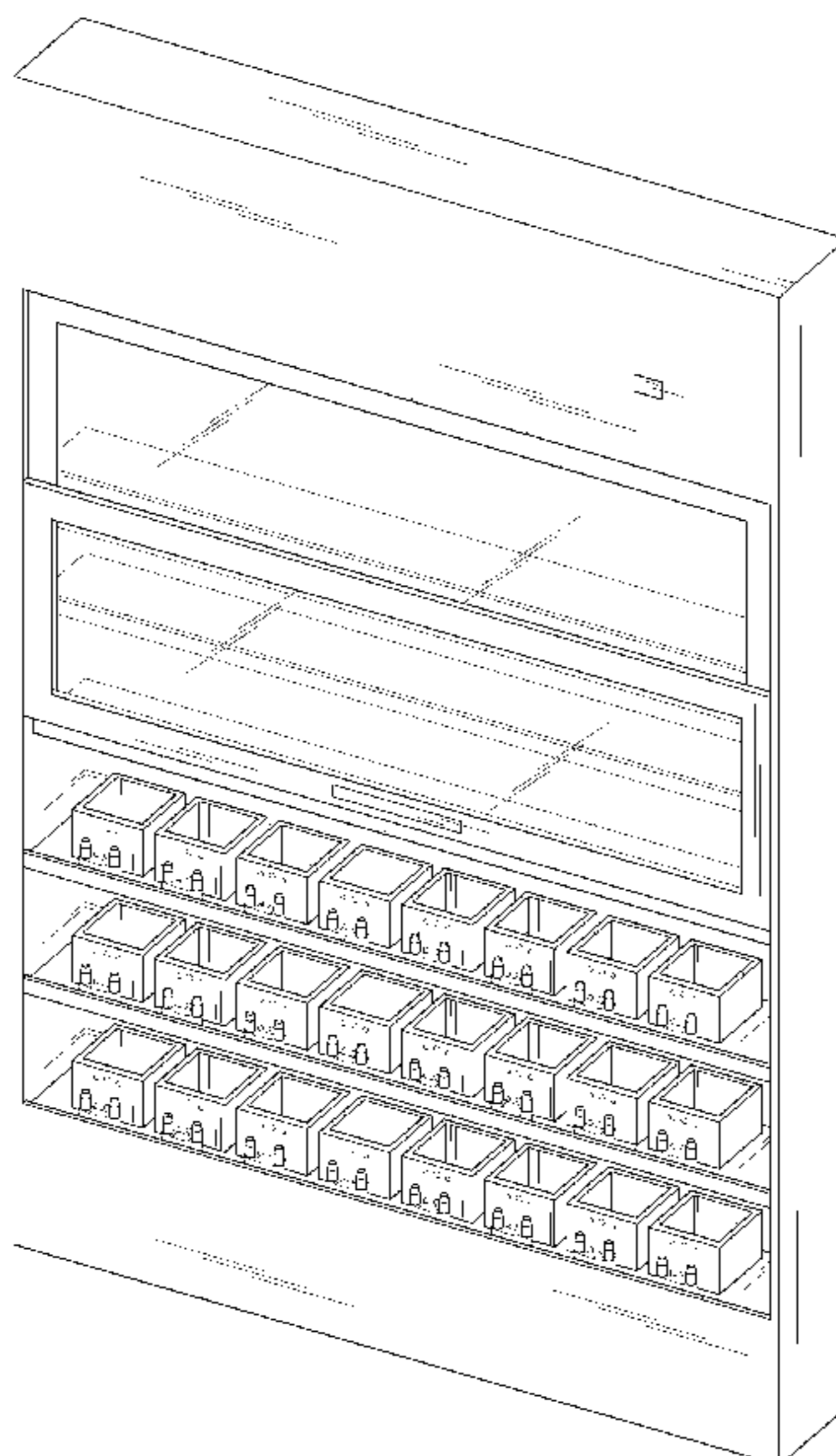
**DESCRIPTION**

The broken lines depict portions of the storage cabinet for food ingredient that form no part of the claimed design. The oblique shading lines denote a transparent surface. 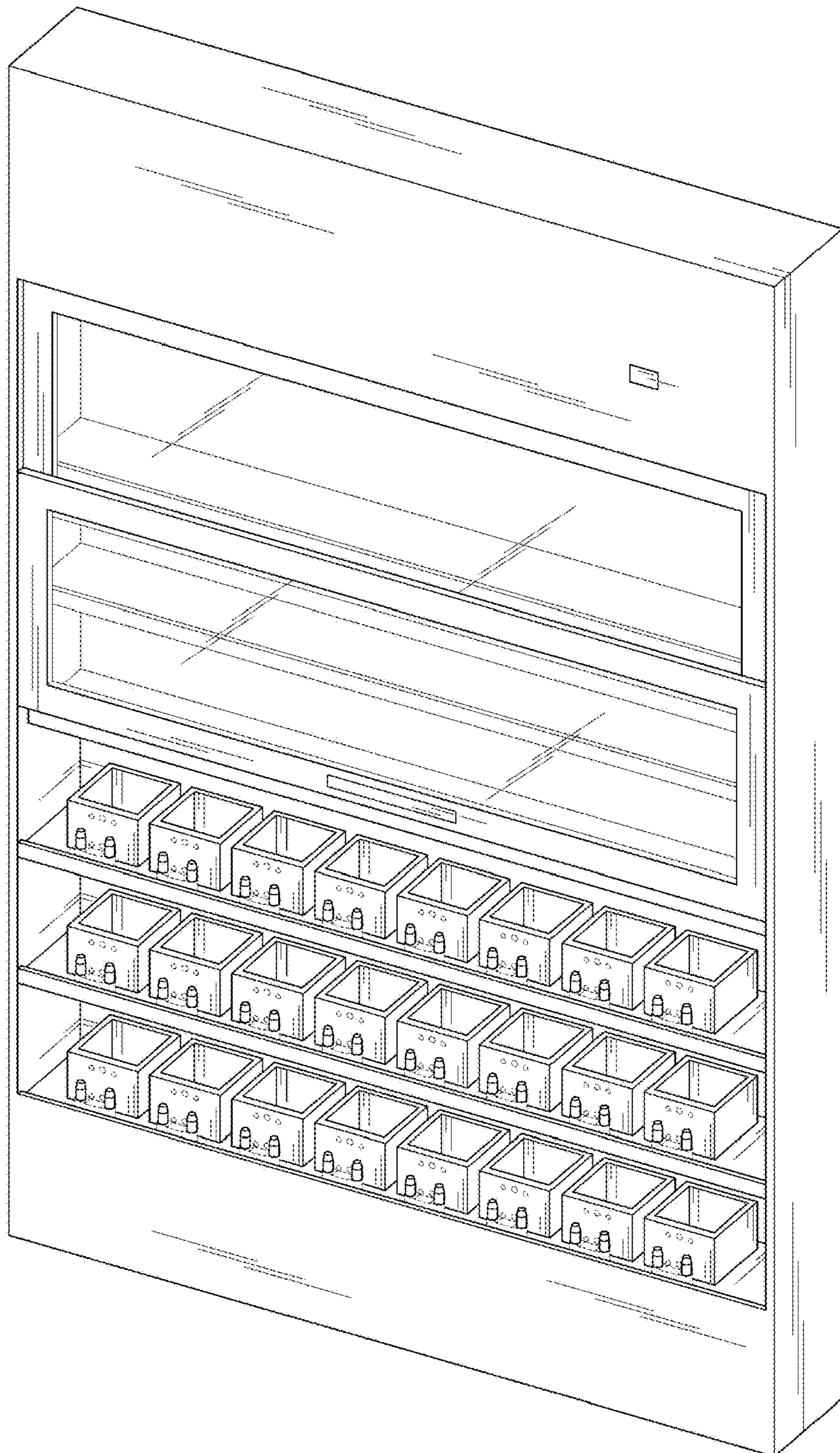

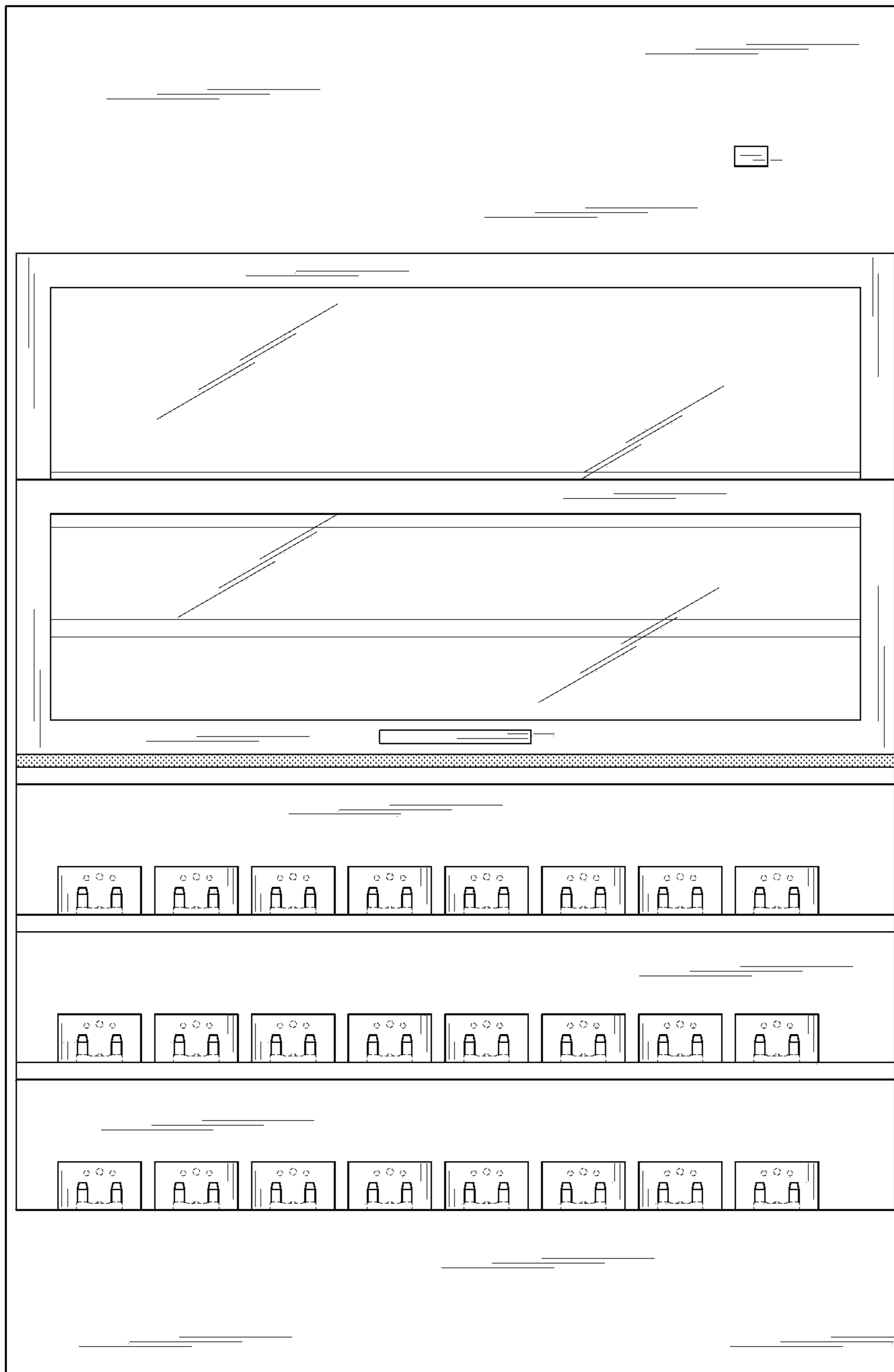

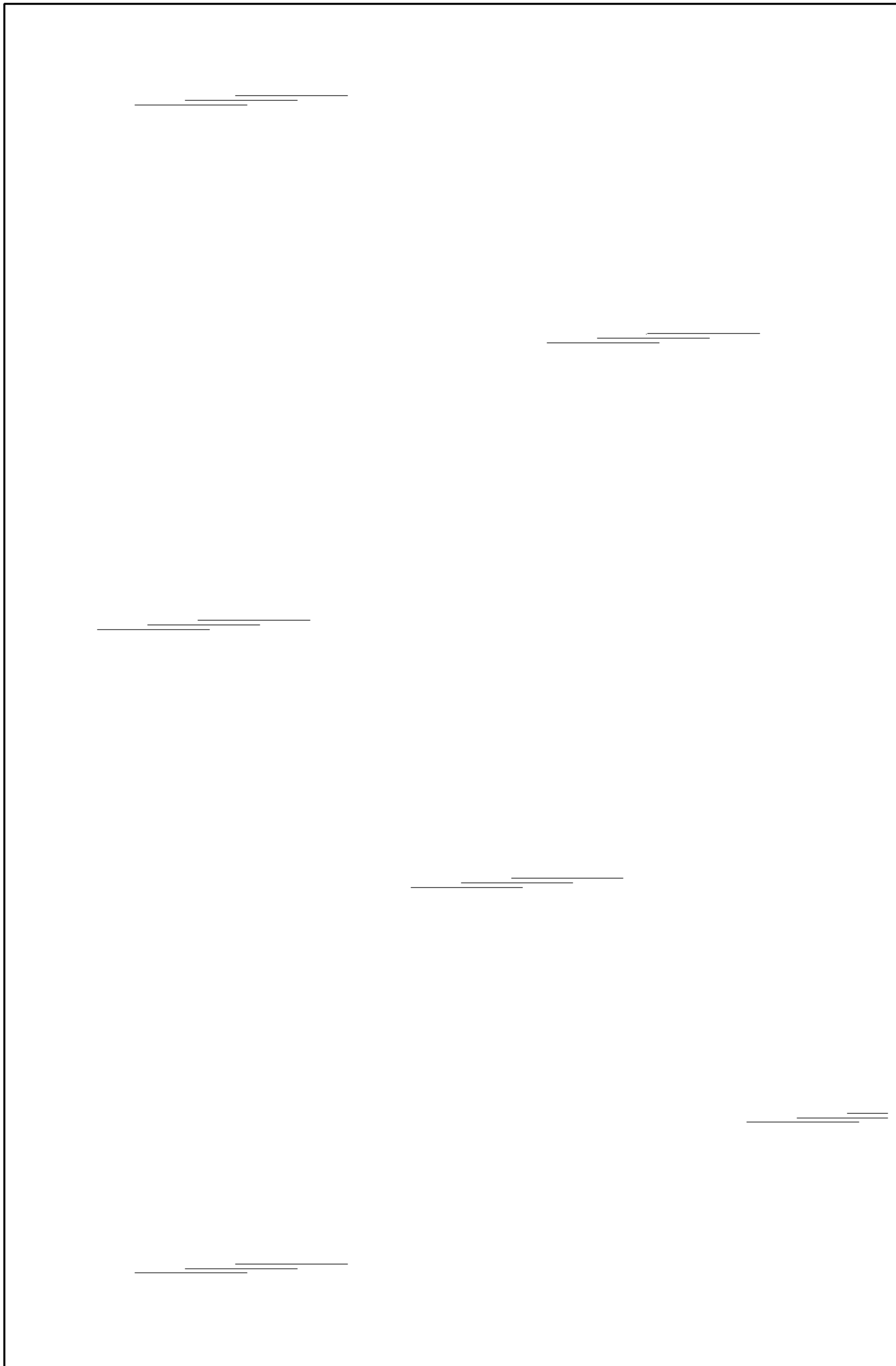

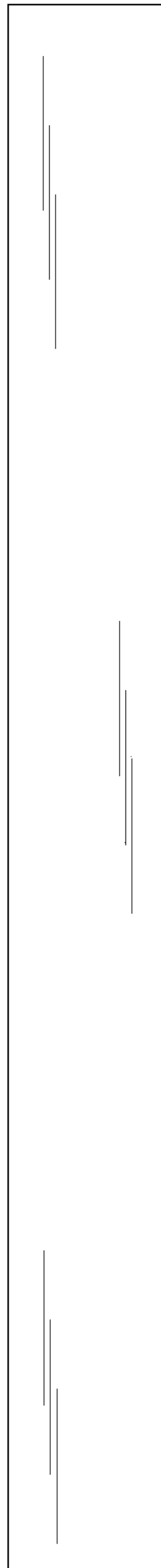

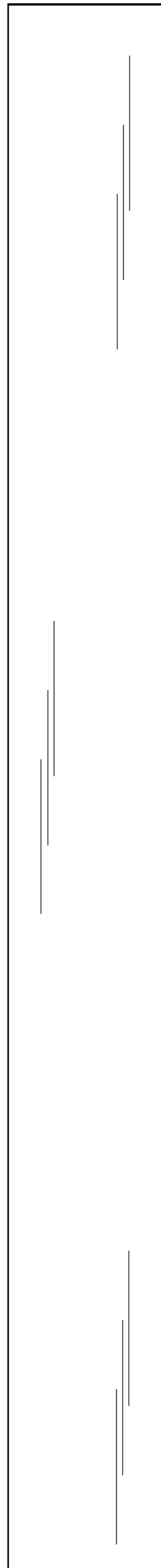

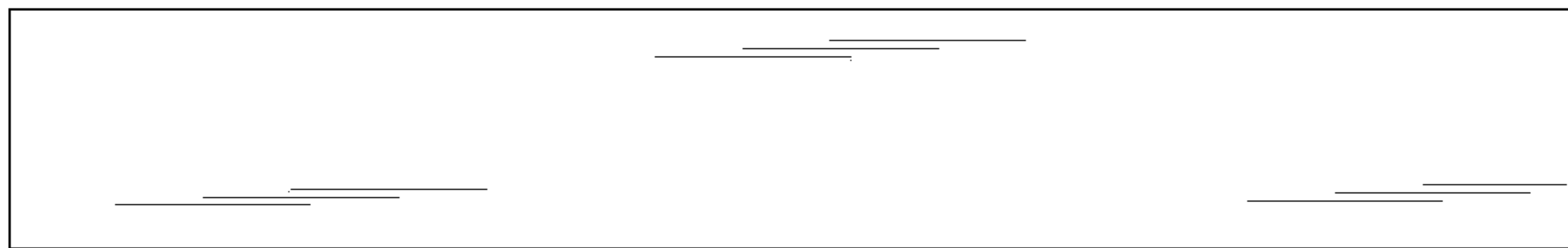
