(57) **CLAIM**

The ornamental design for a cooler box, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a left side elevational view thereof;
FIG. 7 is a right side elevational view thereof;
FIG. 8 is a top, rear, left side perspective view of the cooler box with the strap stored on the side;
FIG. 9 is a top, rear, left side perspective view of the cooler box in a folded configuration; and,
FIG. 10 is a bottom, right side perspective view of the cooler box in an open configuration with the lid and the bottom unzipped.

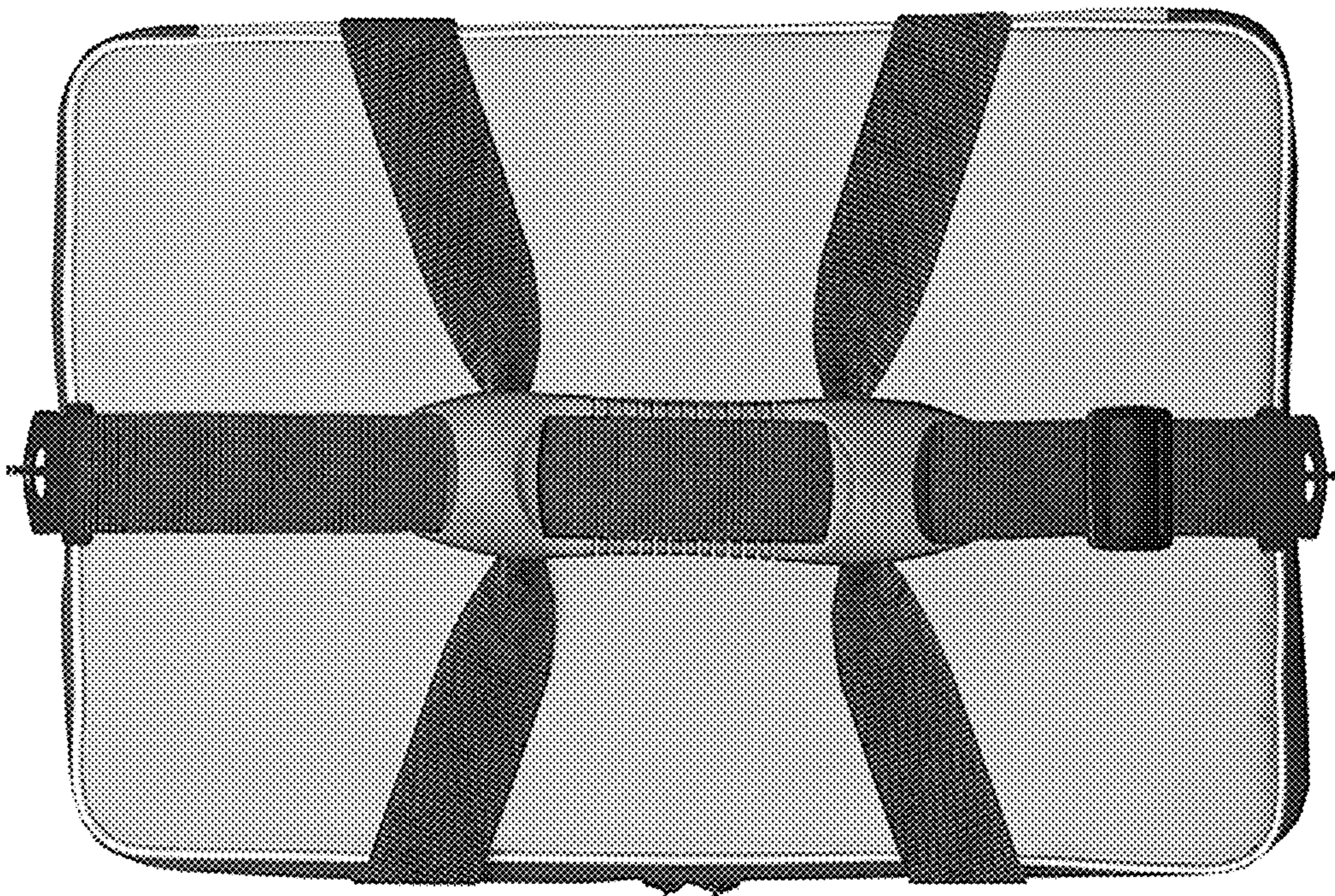

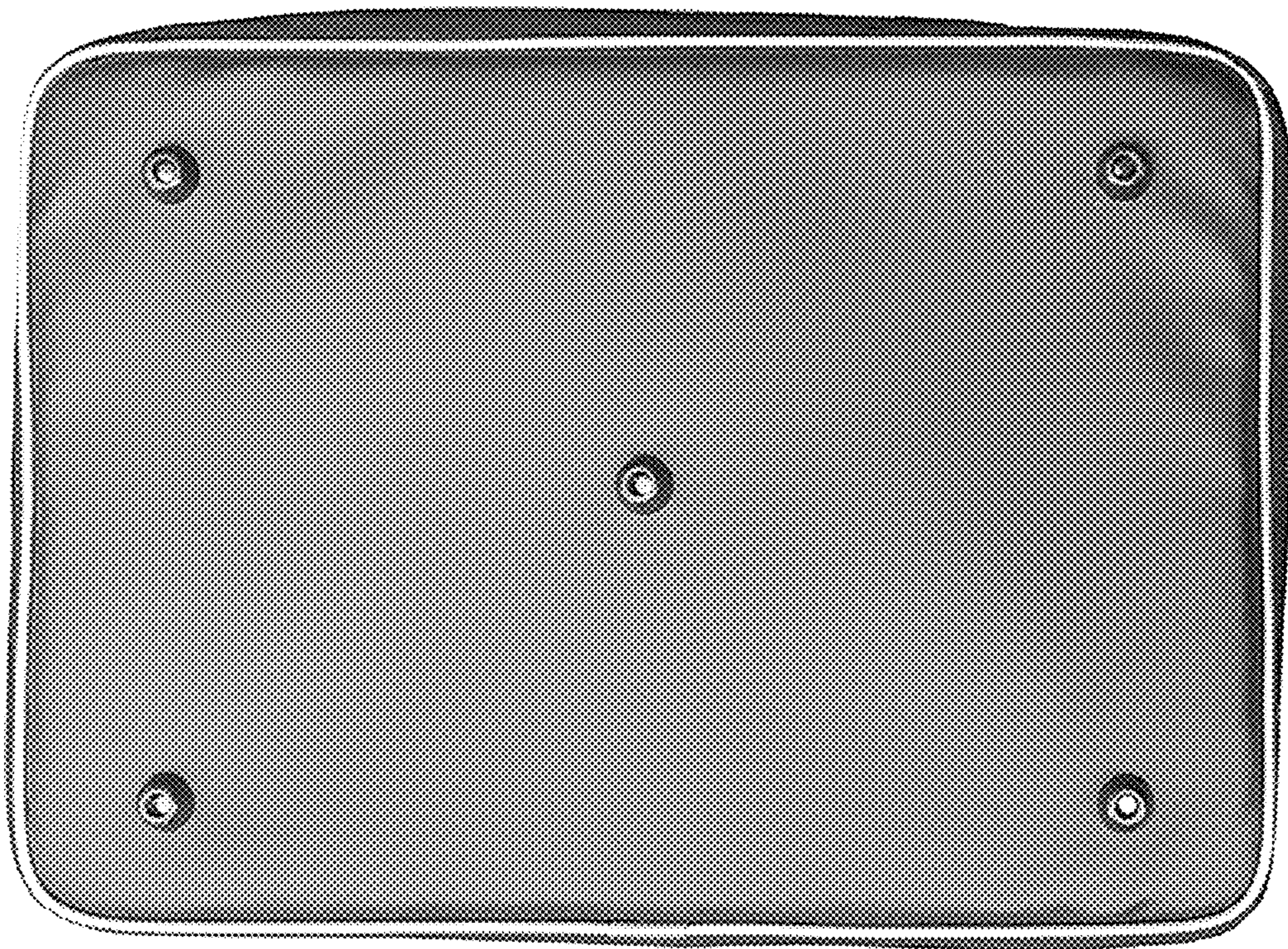
