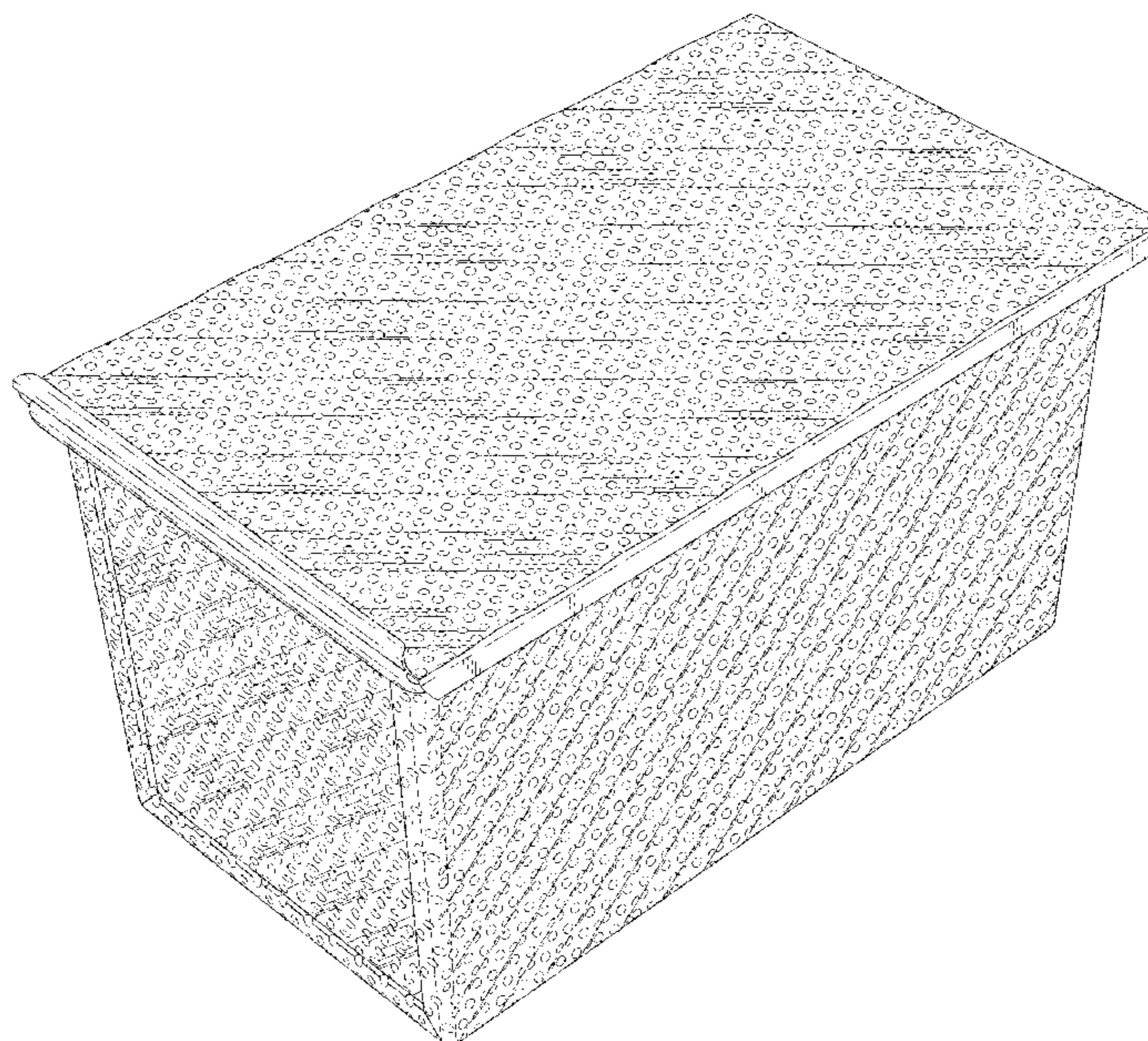
(57) **CLAIM**

I claim the ornamental design for a toast box, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a toast box showing my new design;  
FIG. 2 is another perspective view of the toast box in an open position;  
FIG. 3 is another perspective view of the toast box in an open position;  
FIG. 4 is a left-side view of the toast box as shown in FIG. 1;

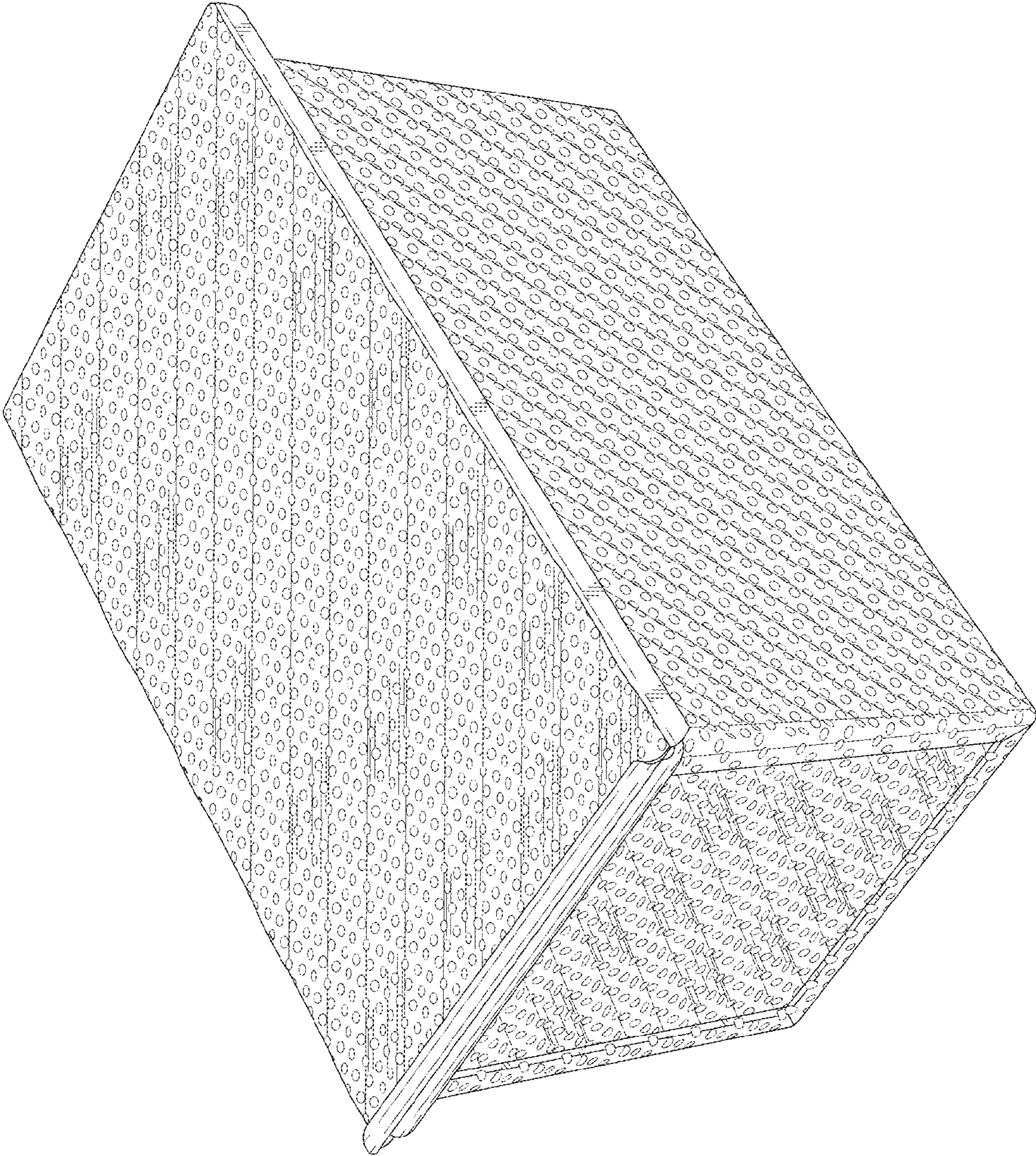

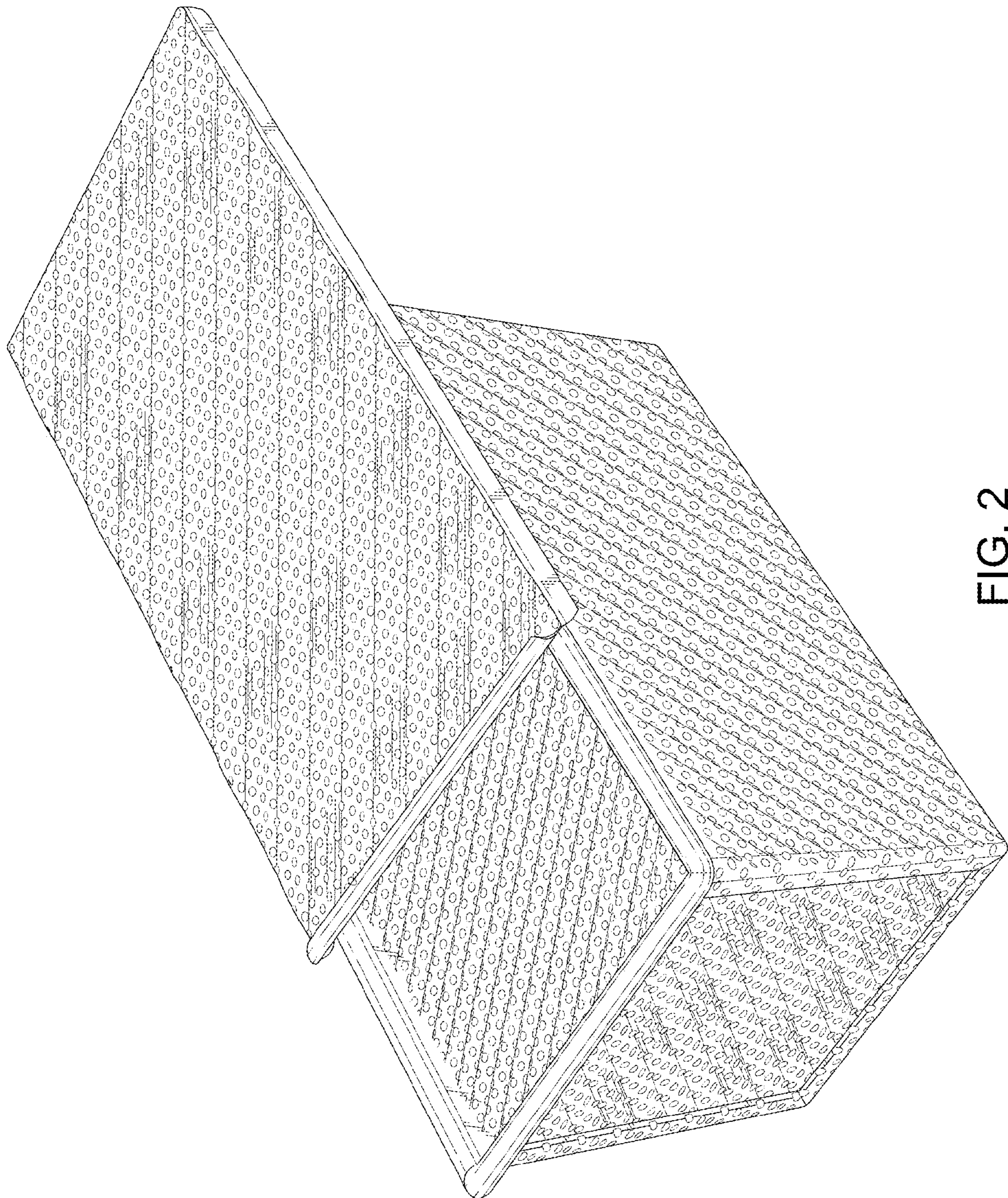

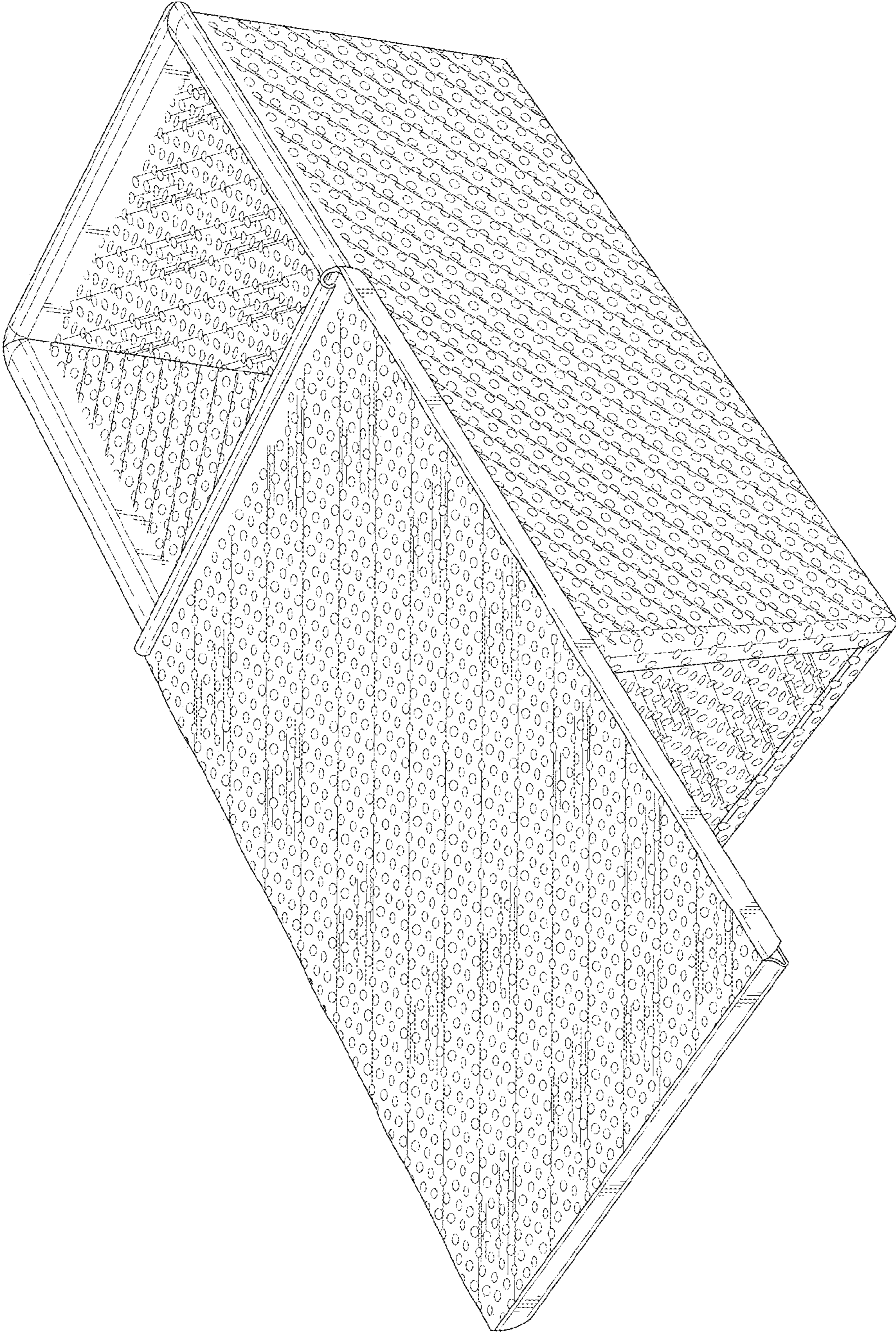

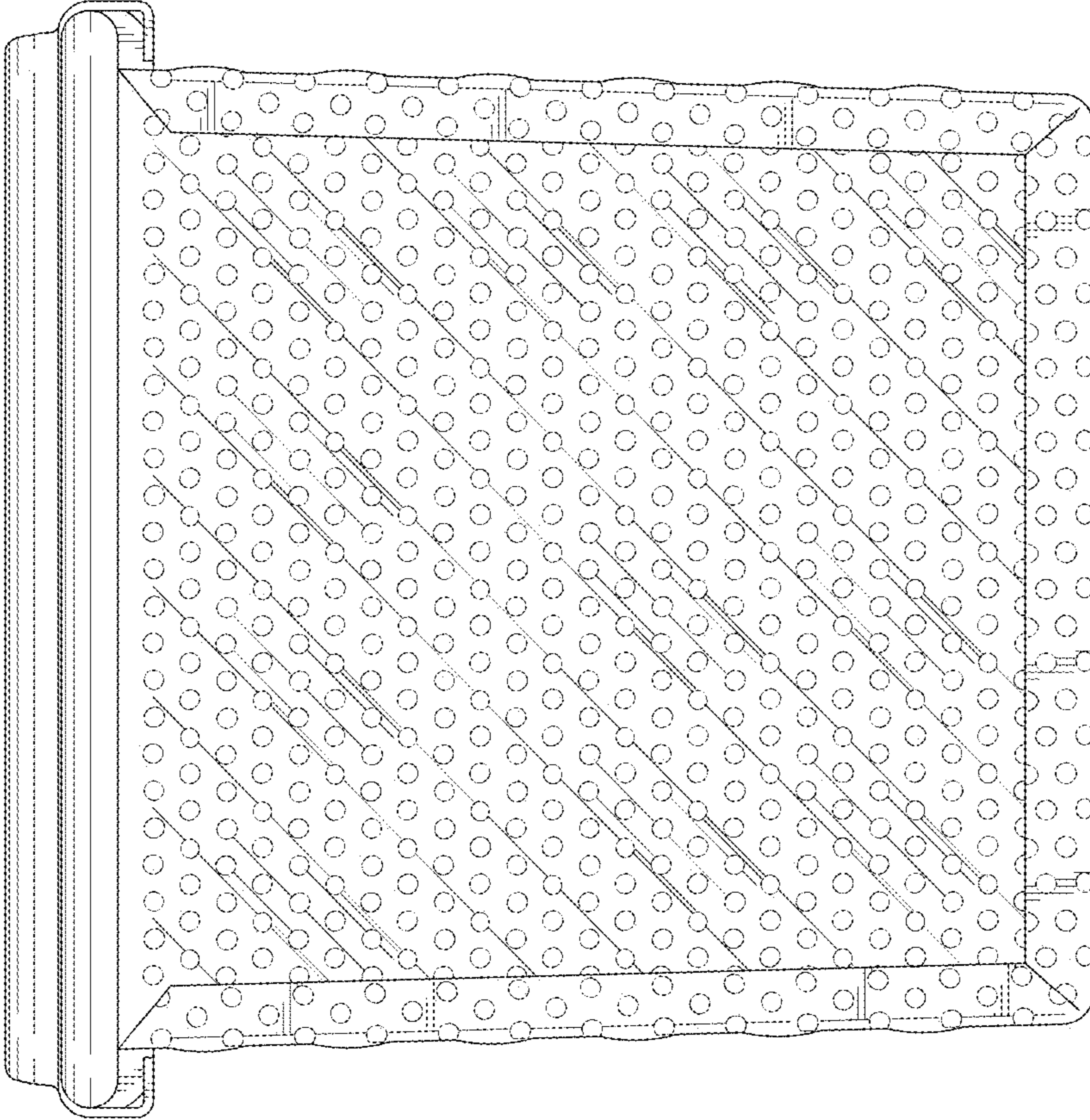

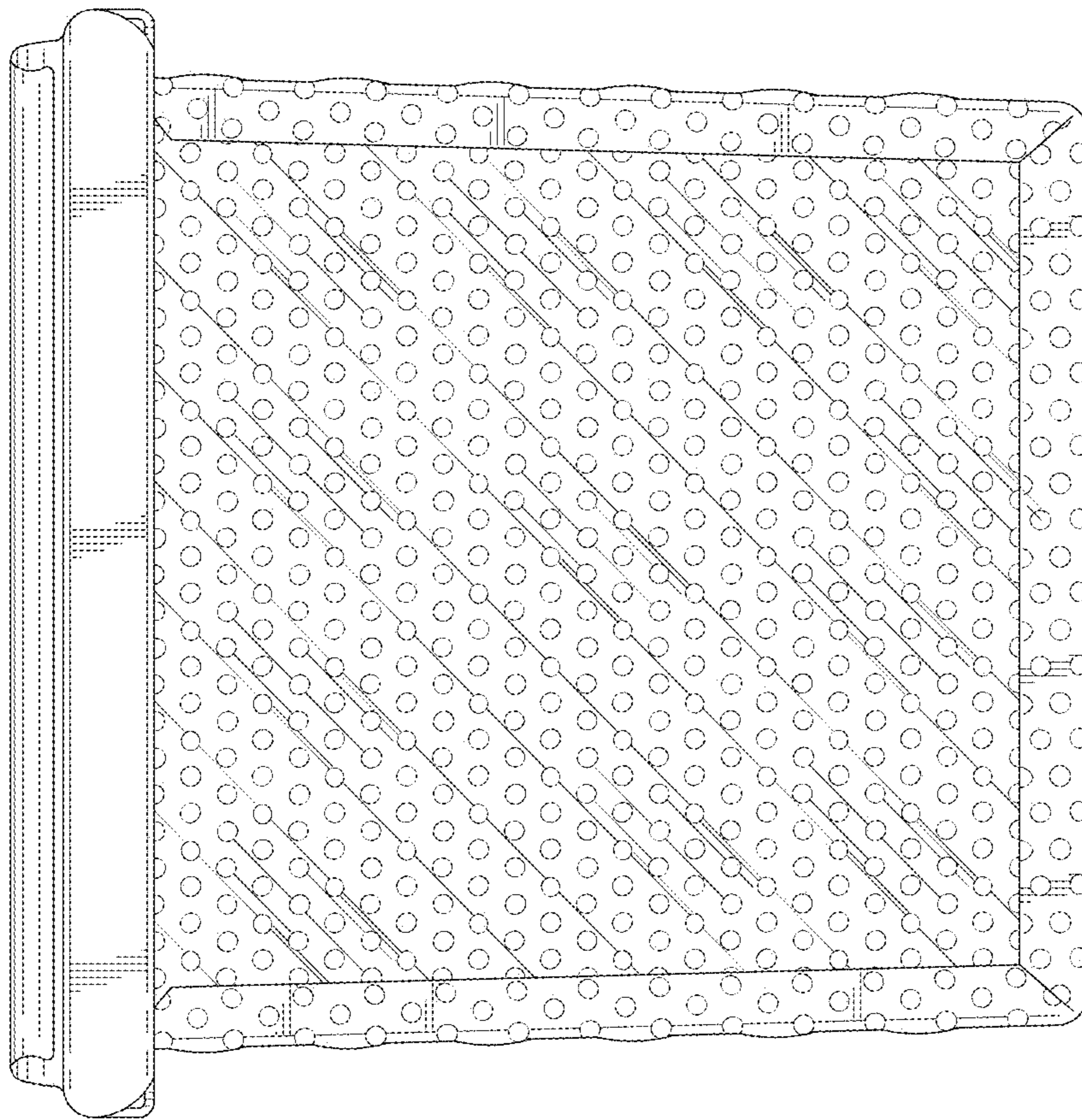

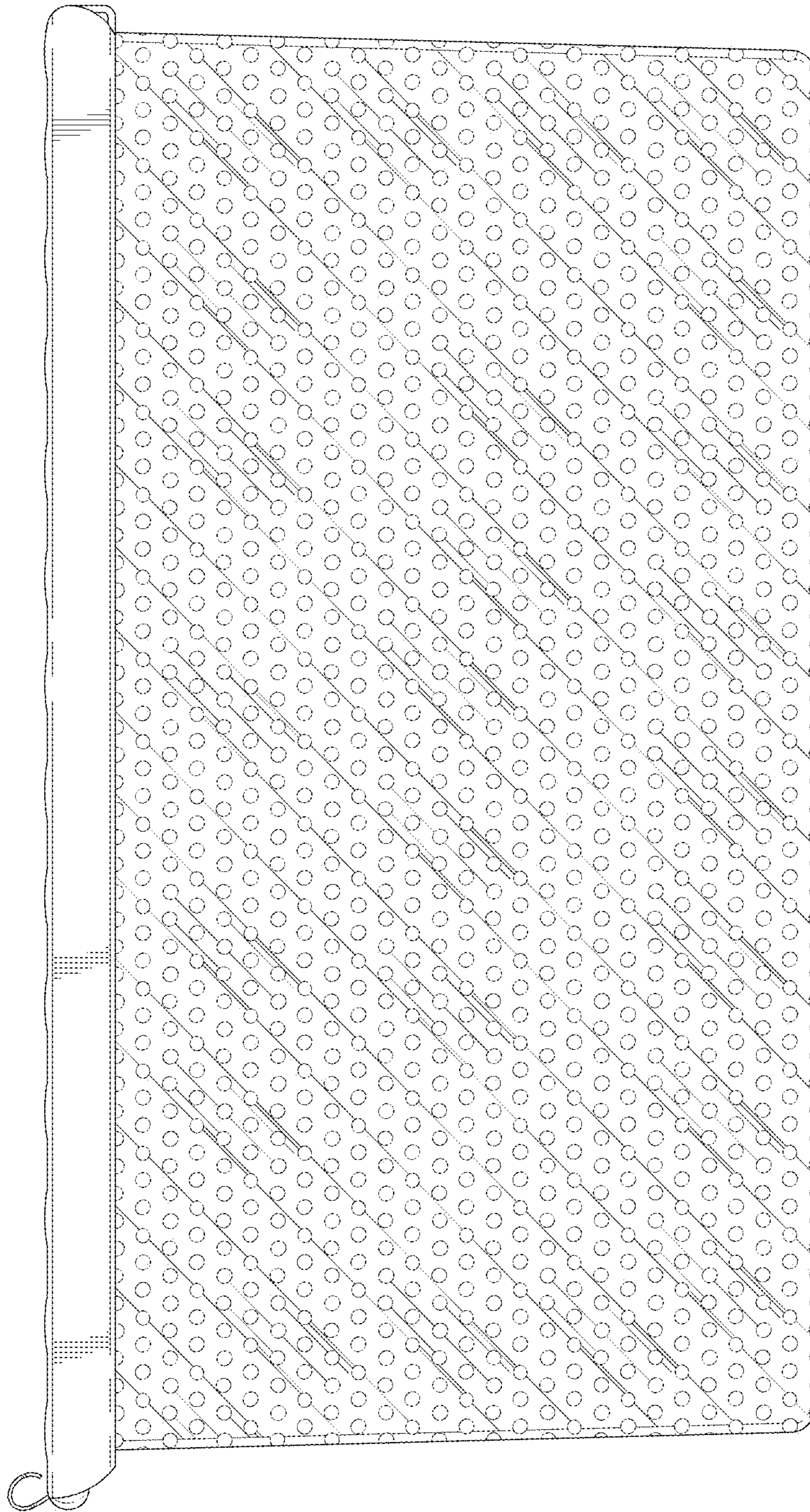

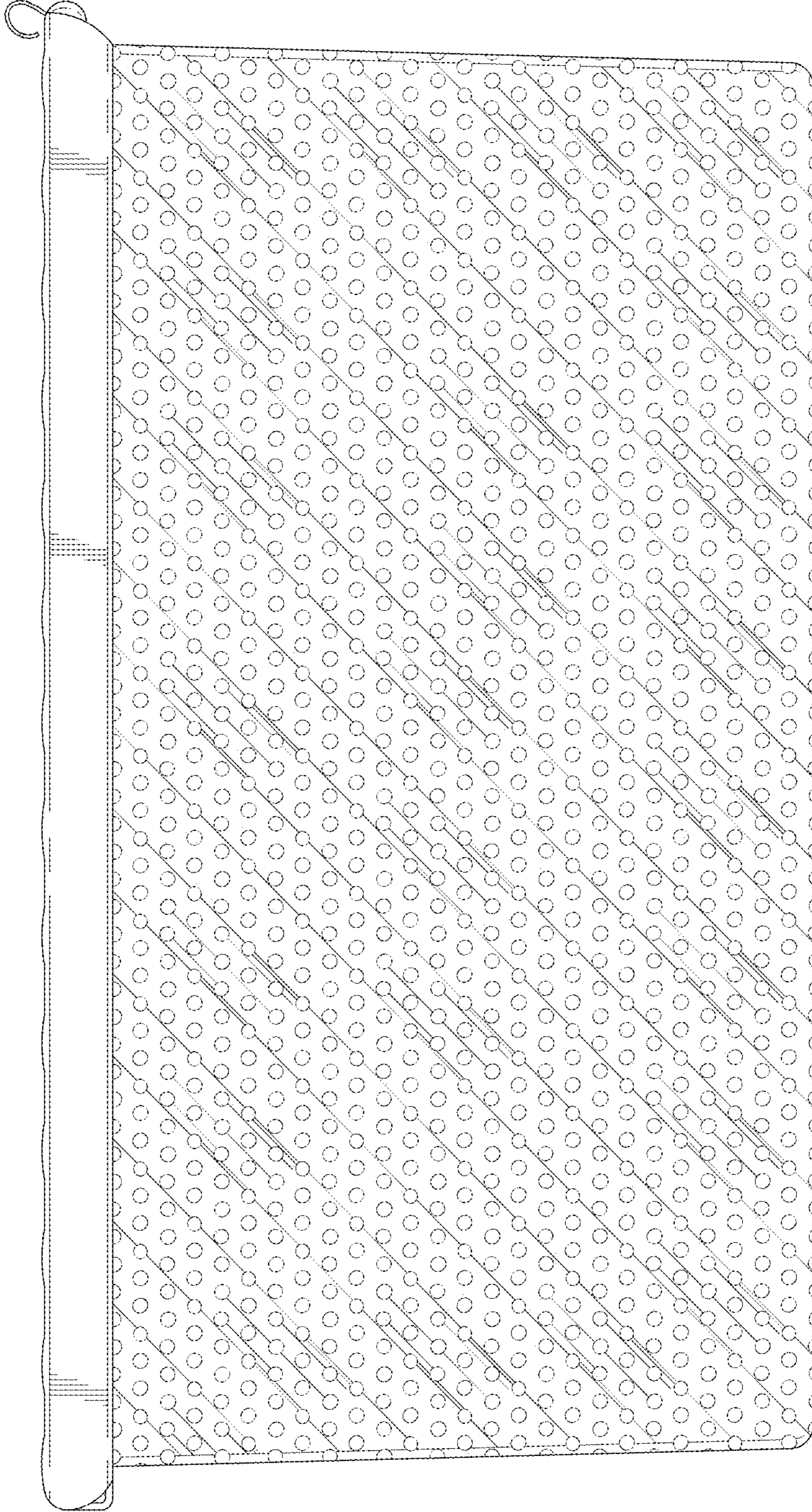

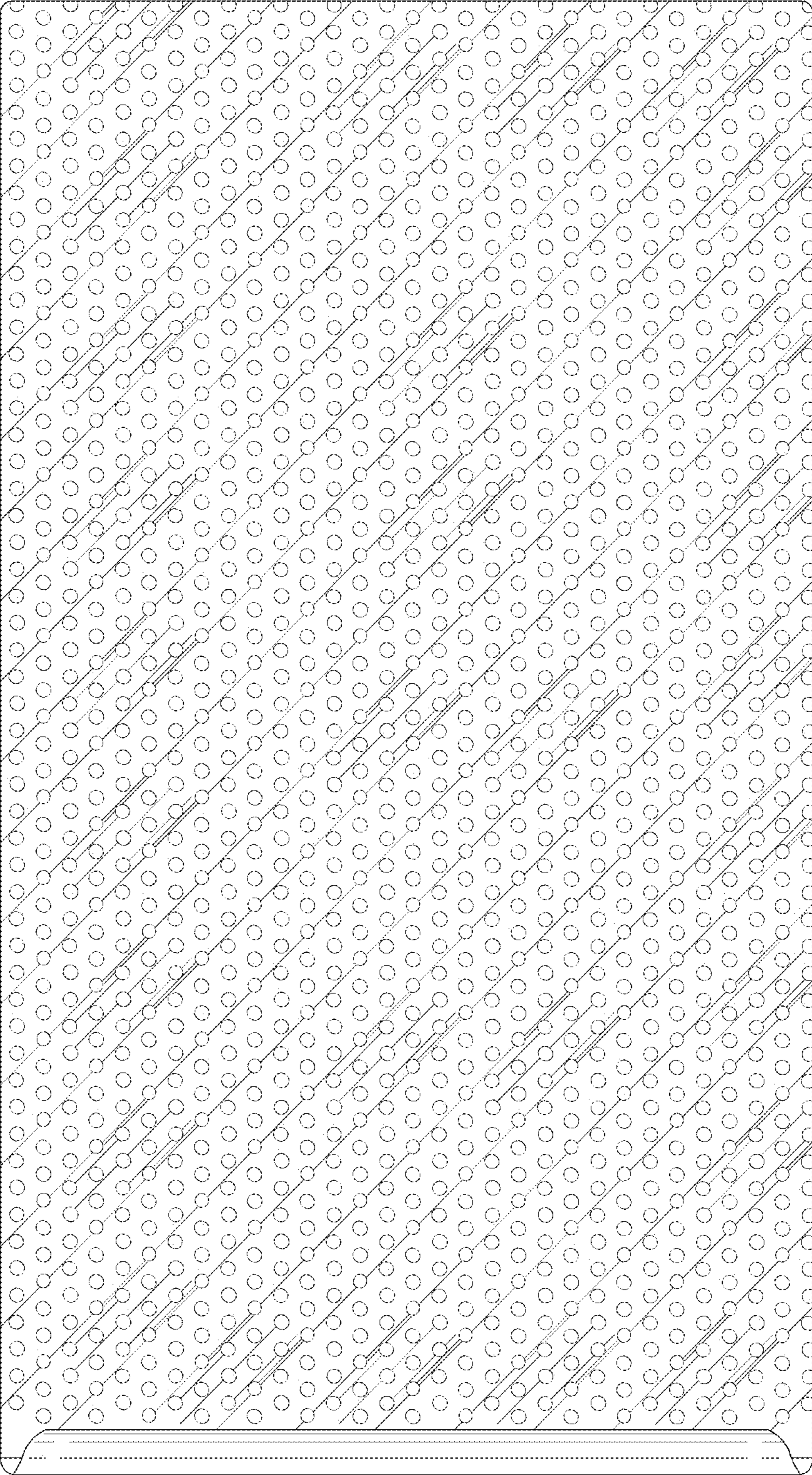
