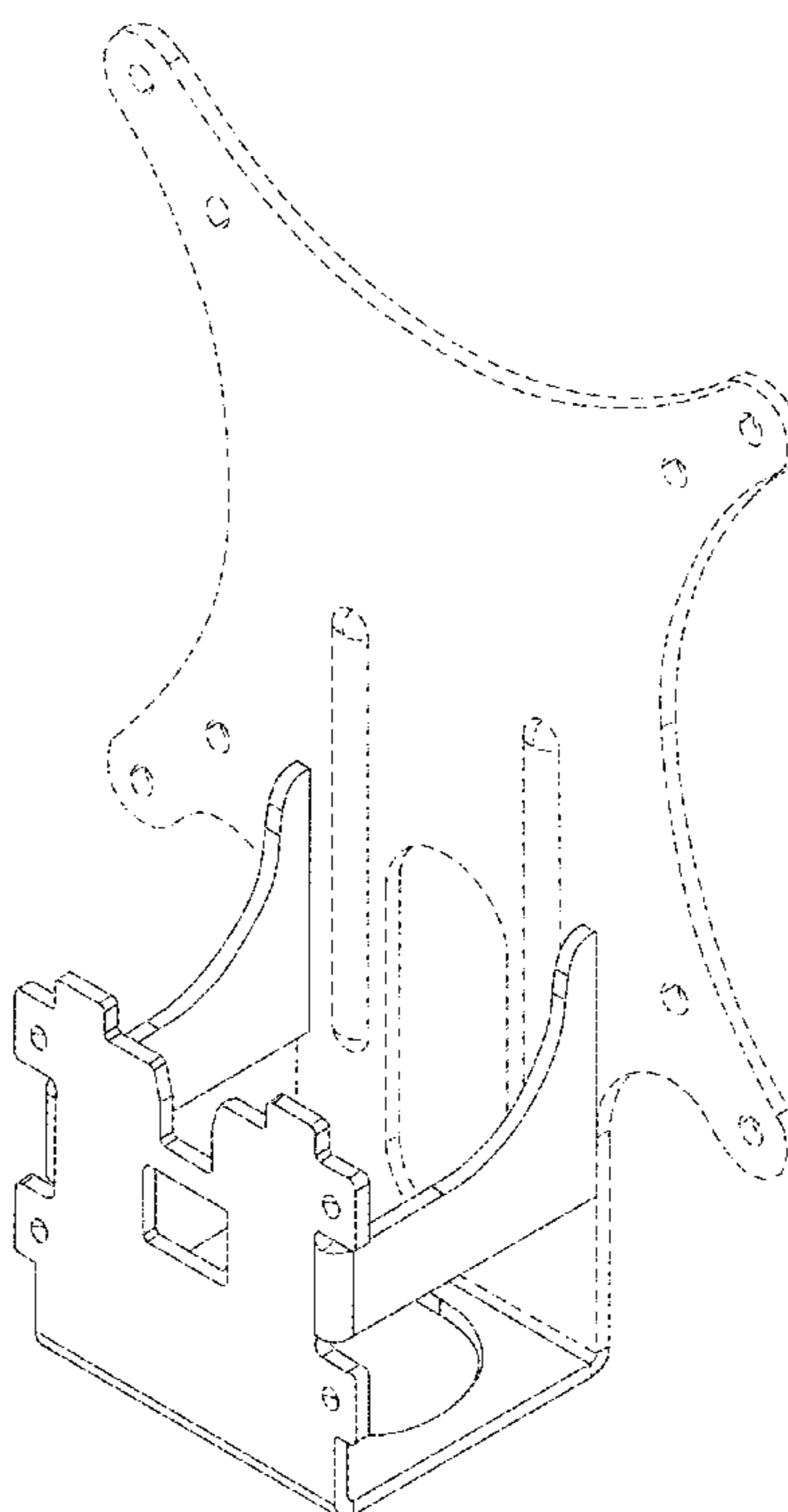
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a first isometric view of a display mount.

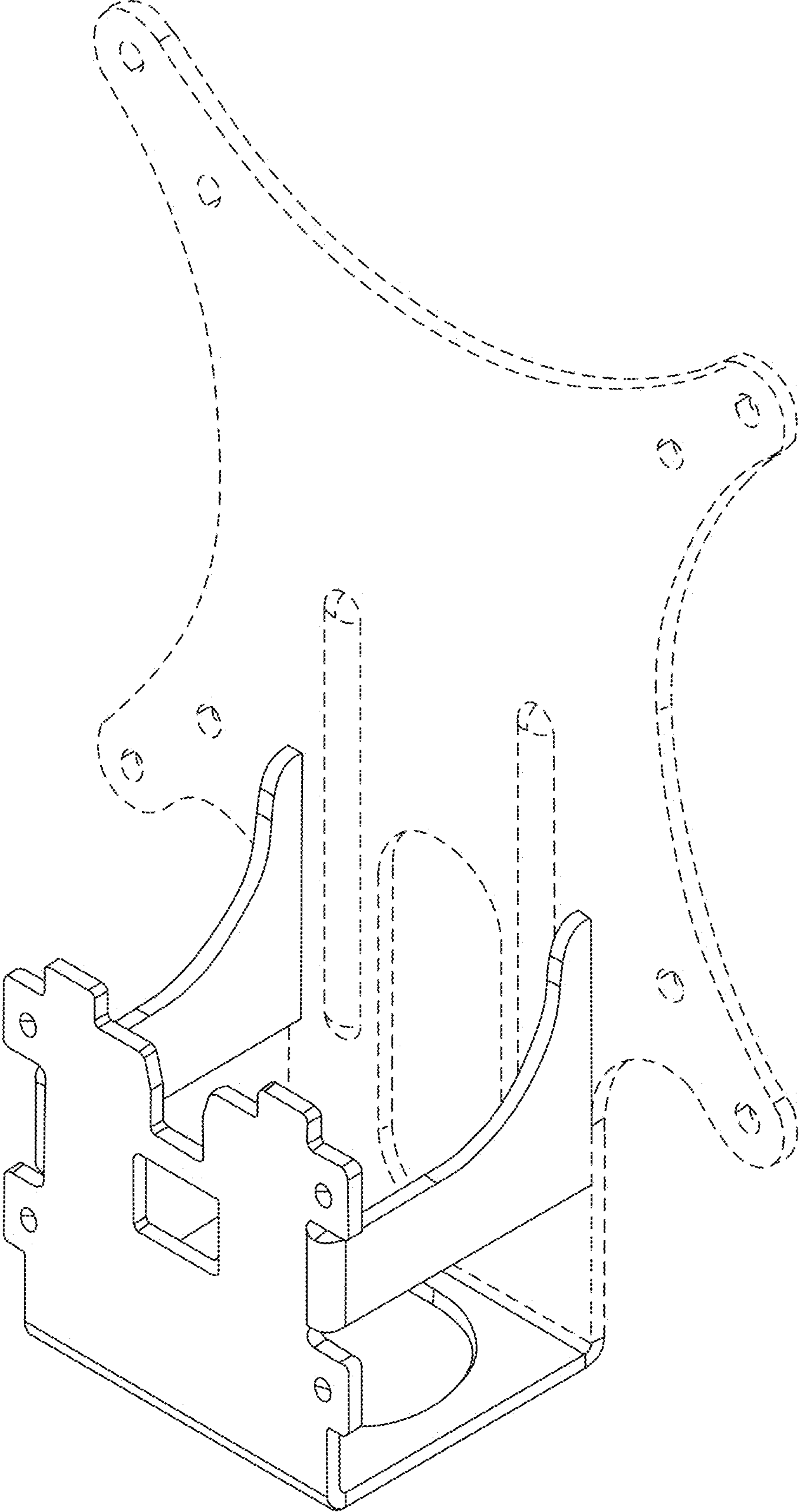

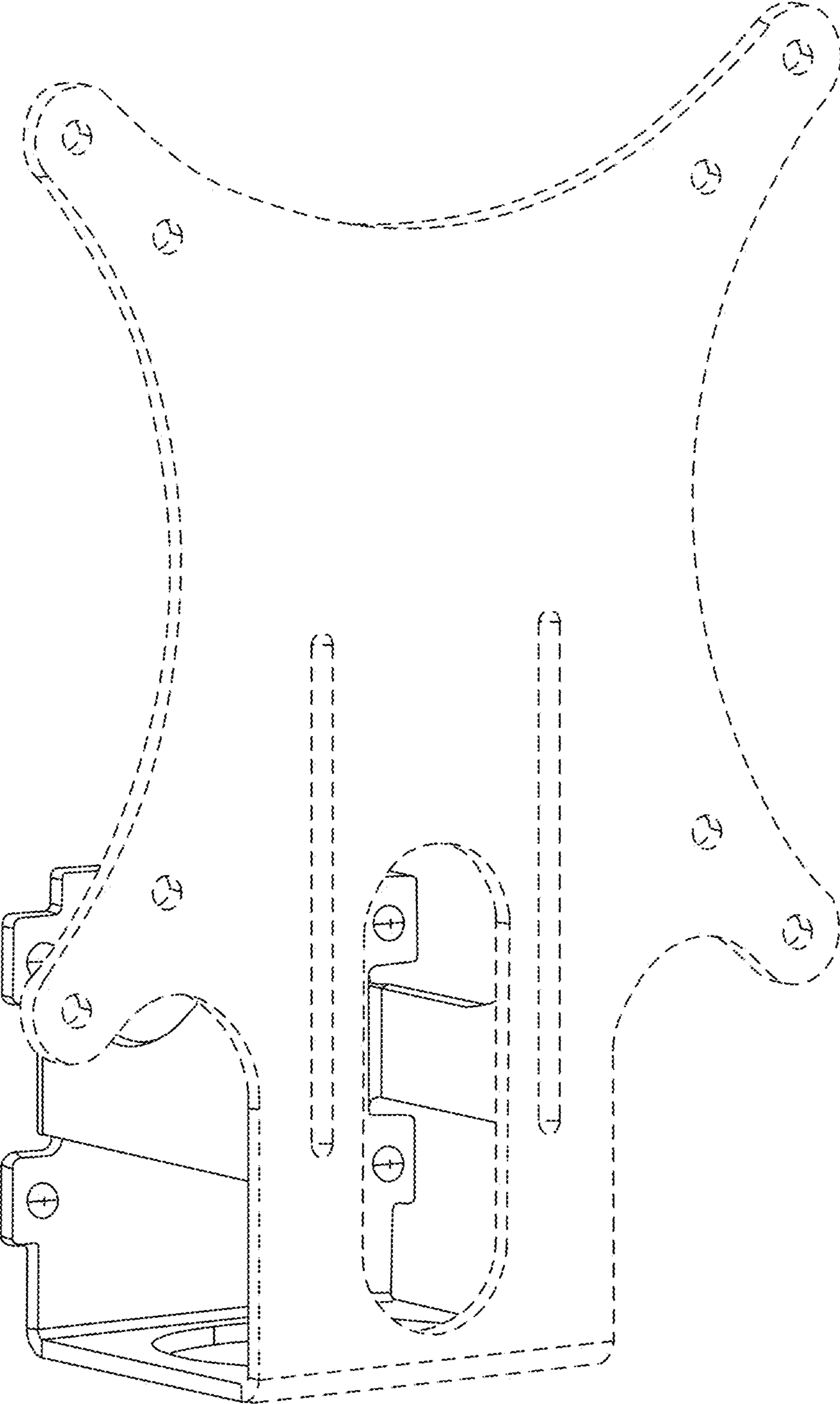

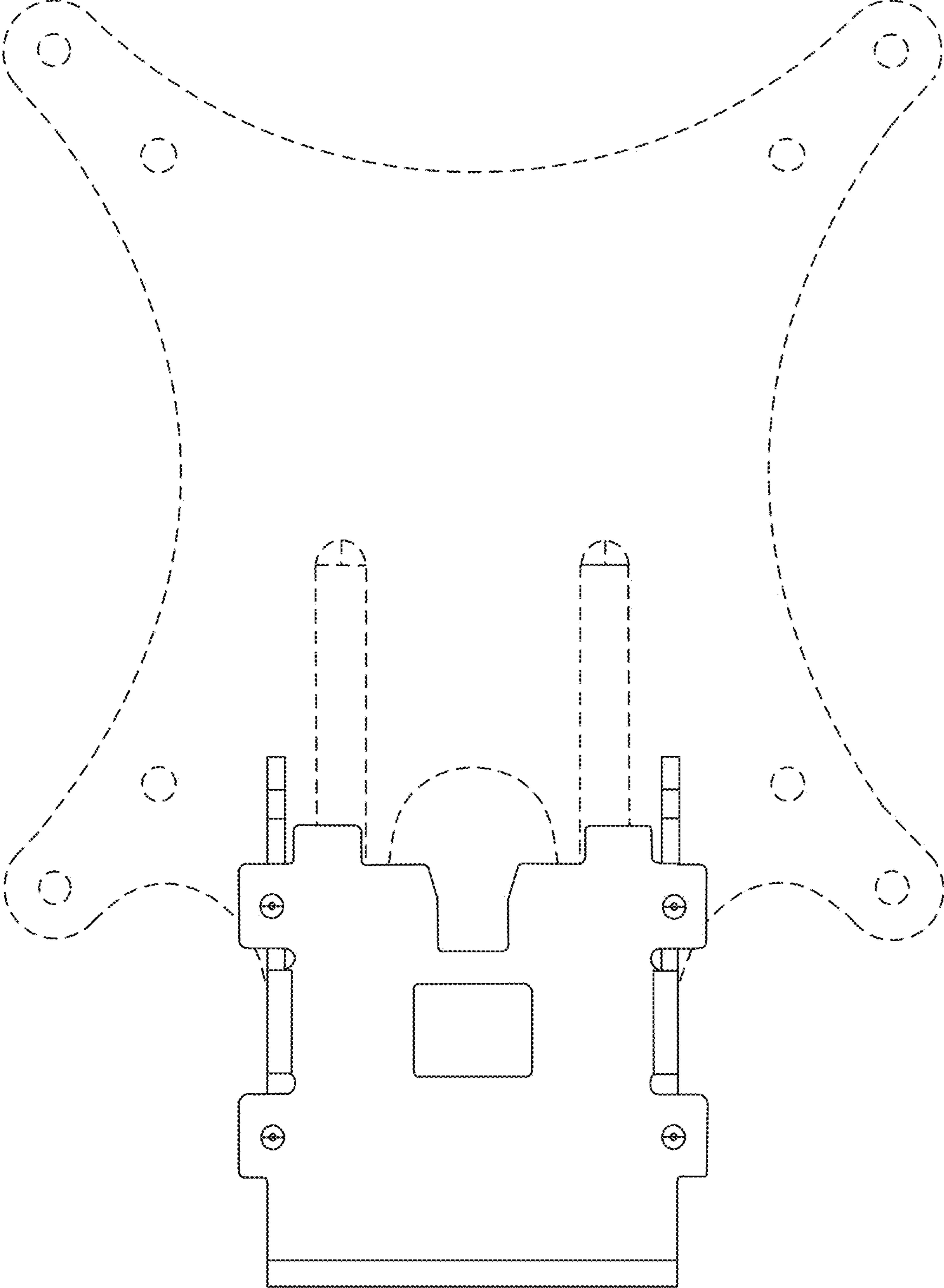

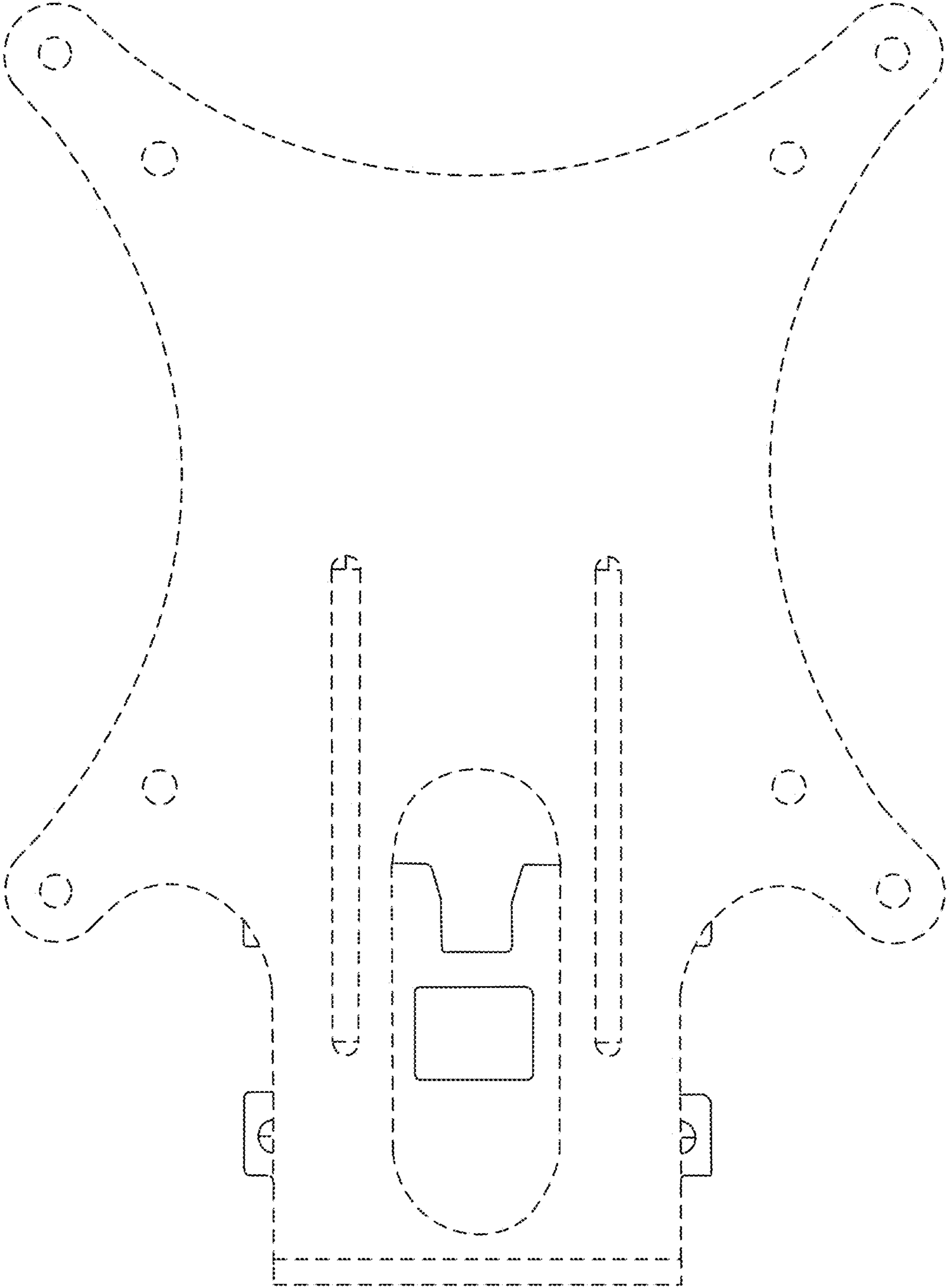

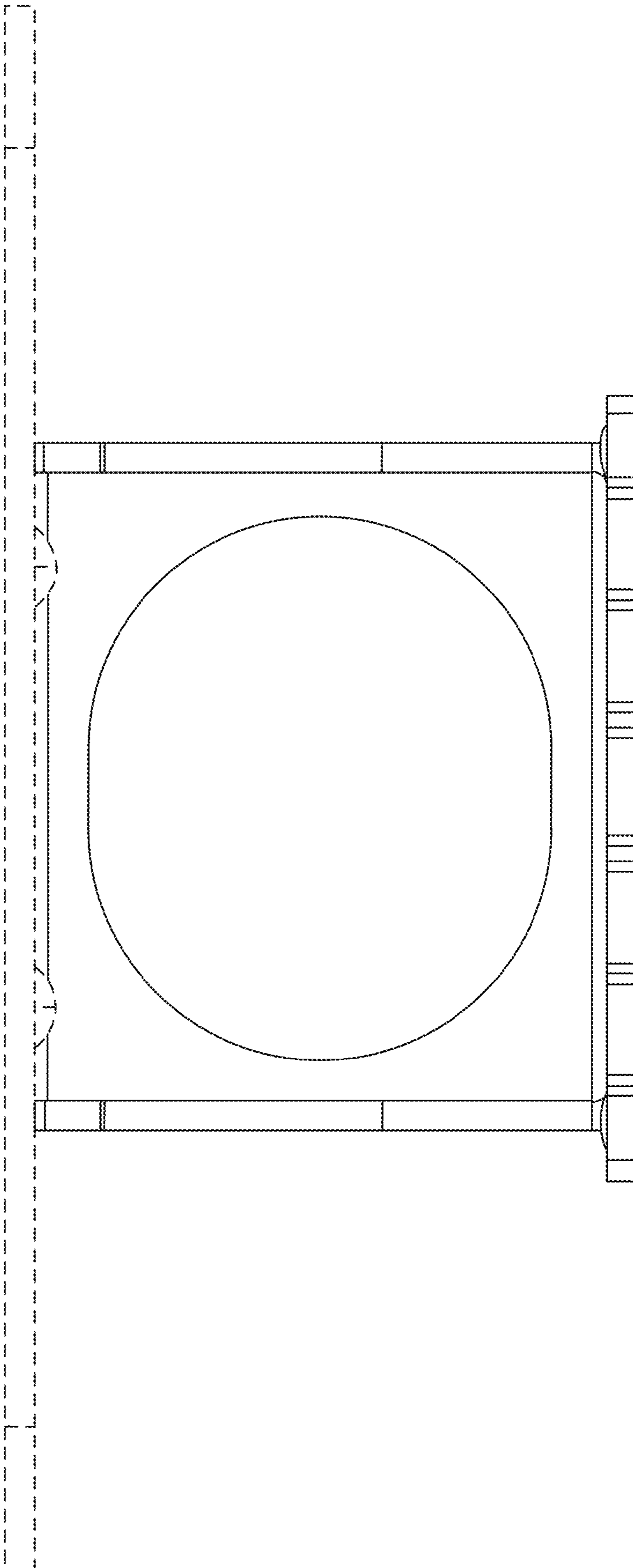

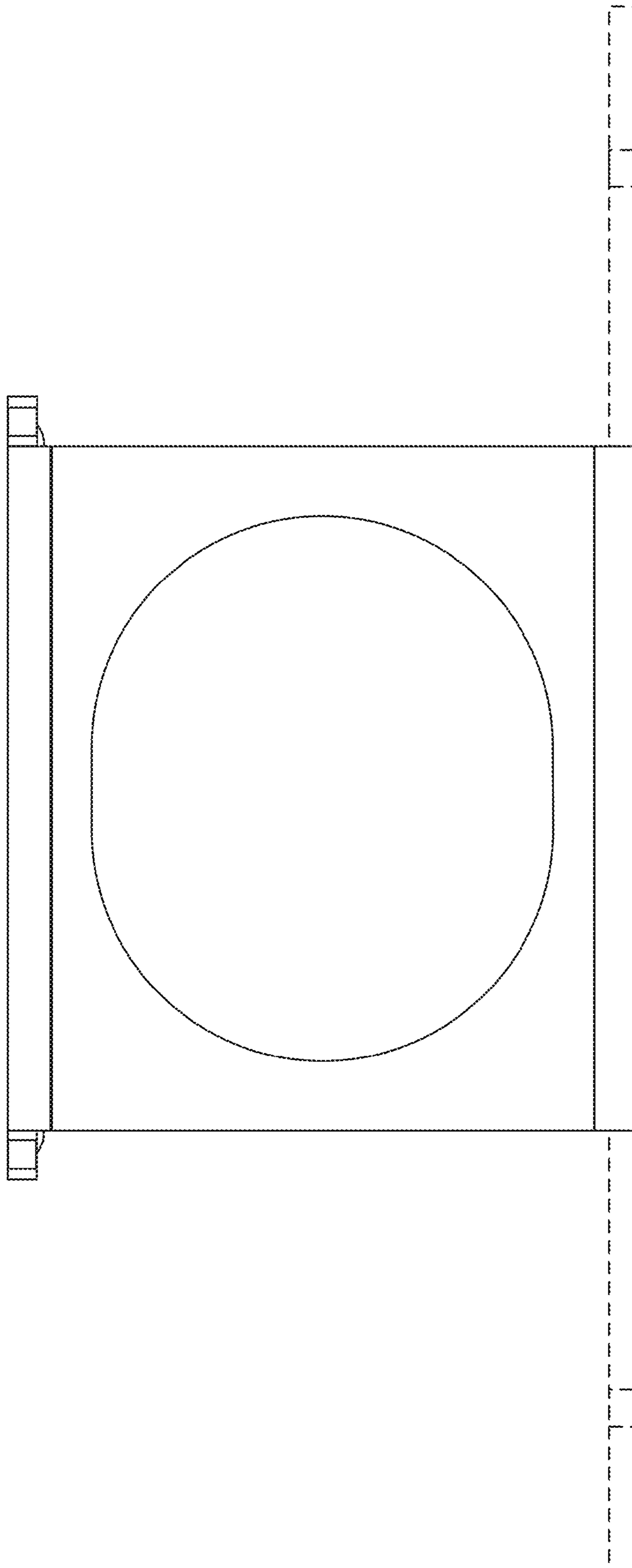

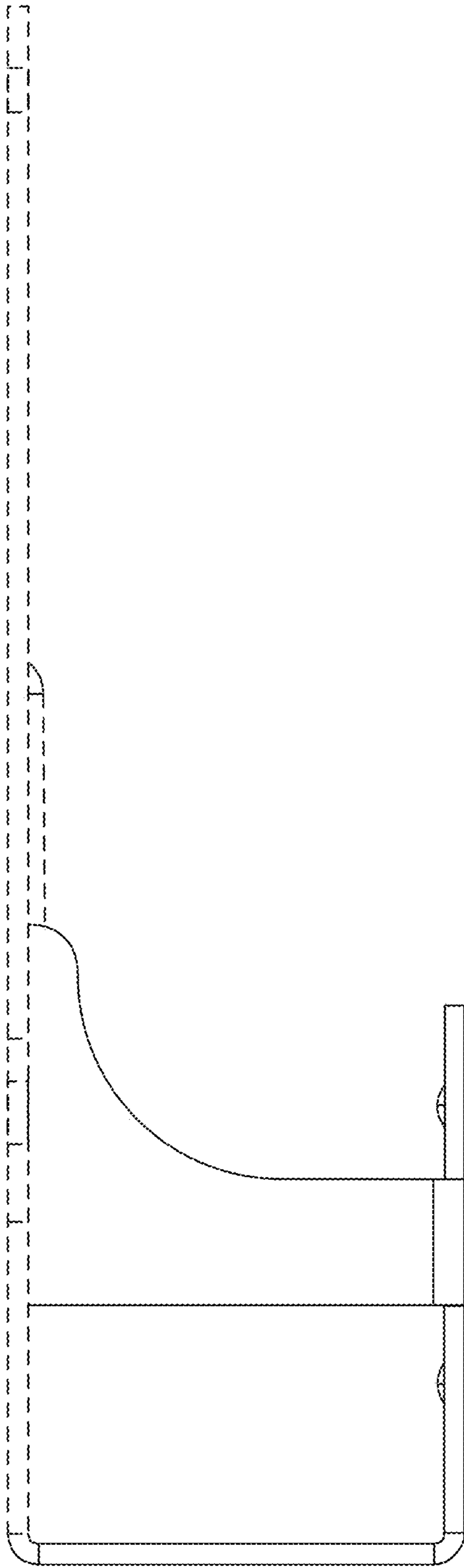

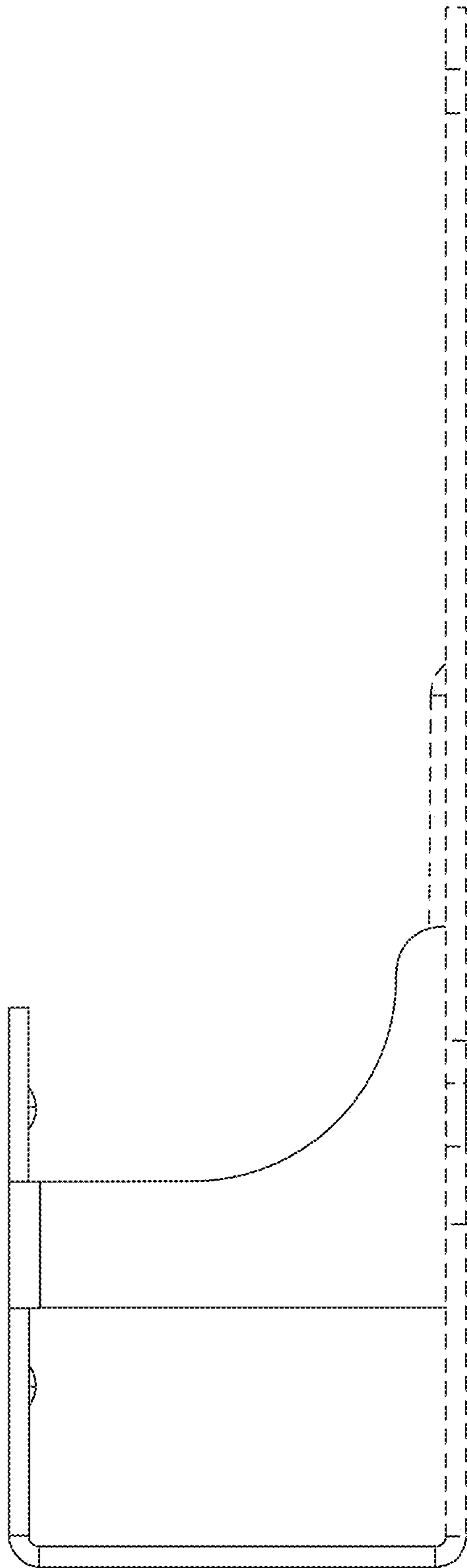
