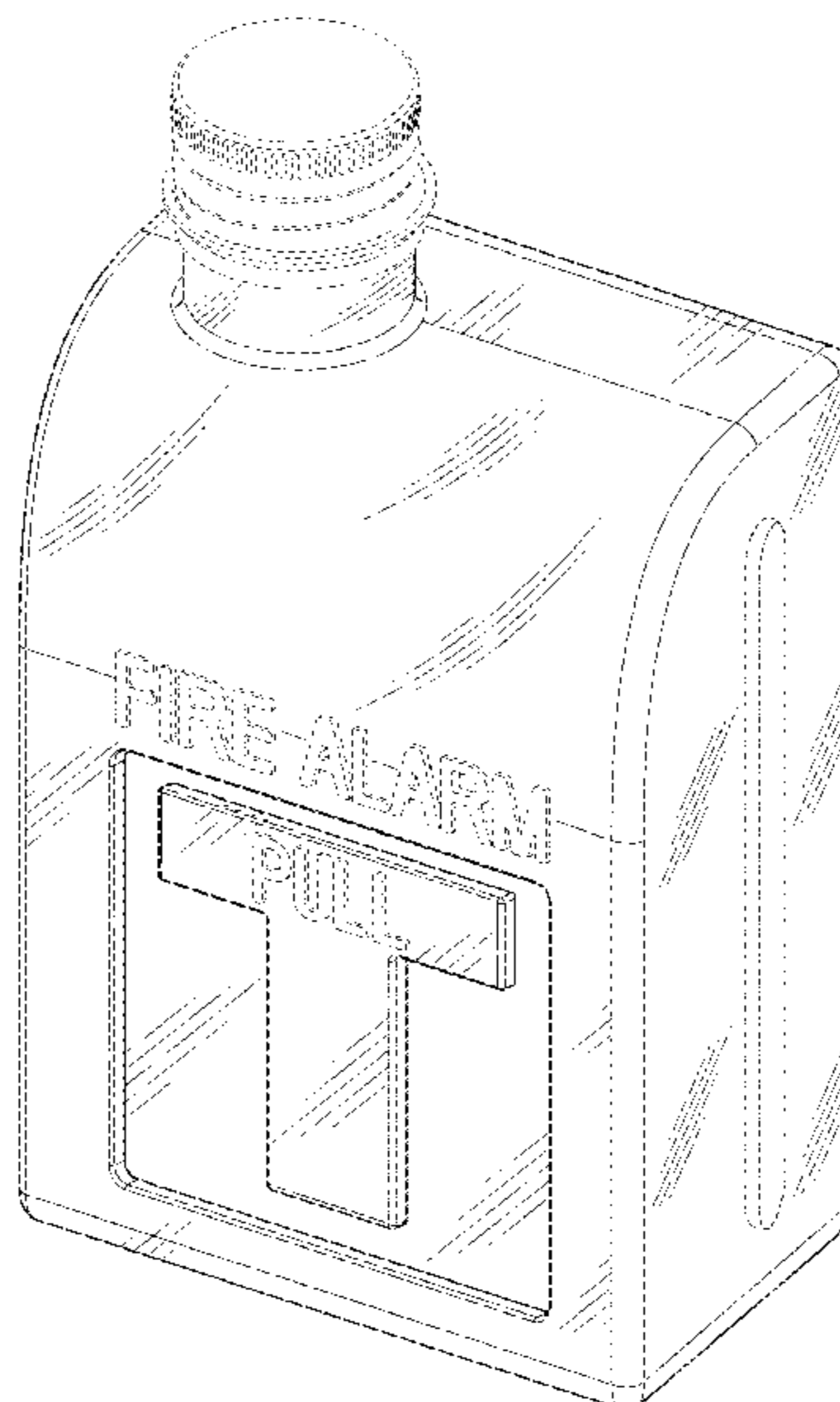
(57) **CLAIM**

I claim the ornamental design for a bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, perspective view of a bottle showing my new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a left side view thereof;  
FIG. 4 is a right side view thereof;  
FIG. 5 is a rear view thereof;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a bottom plan view thereof.

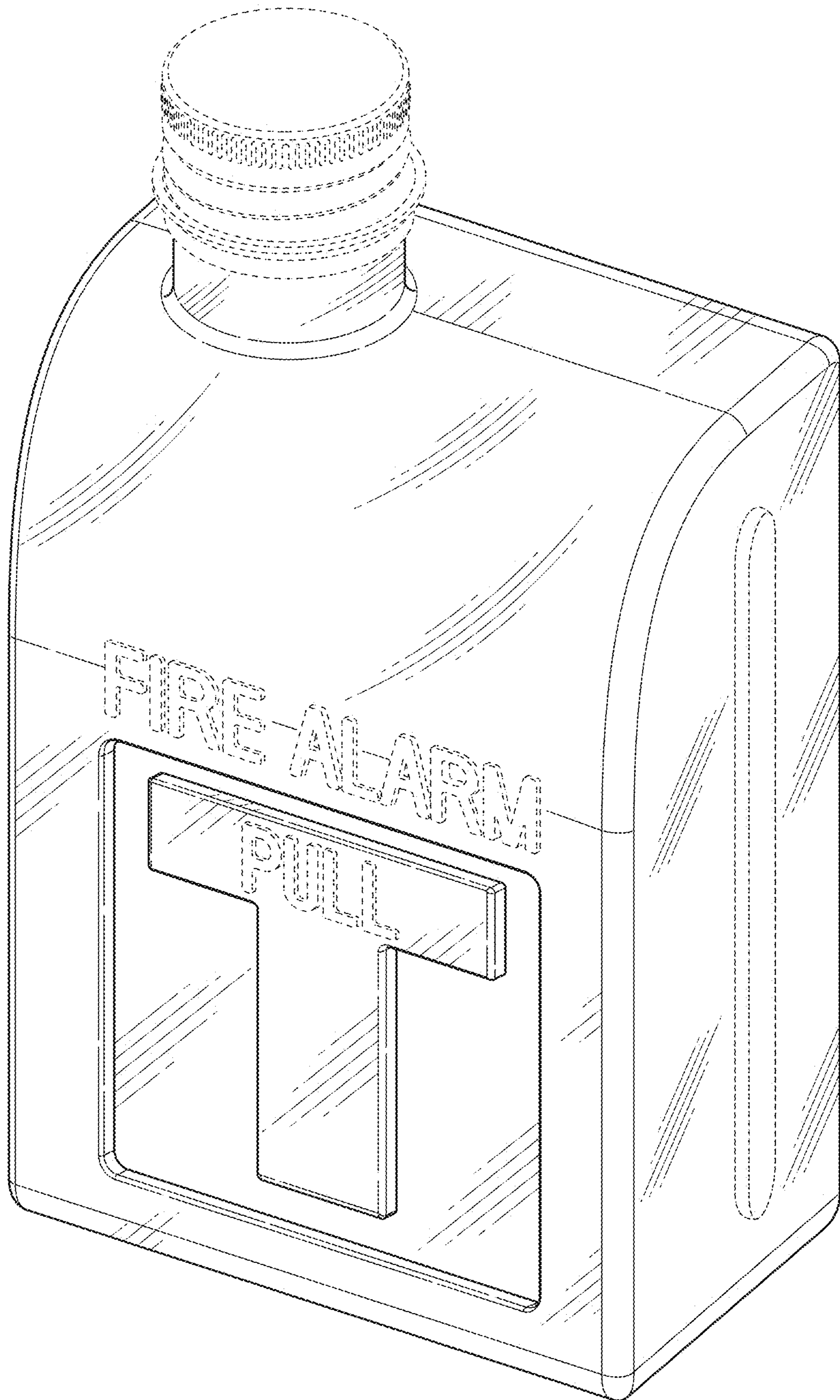

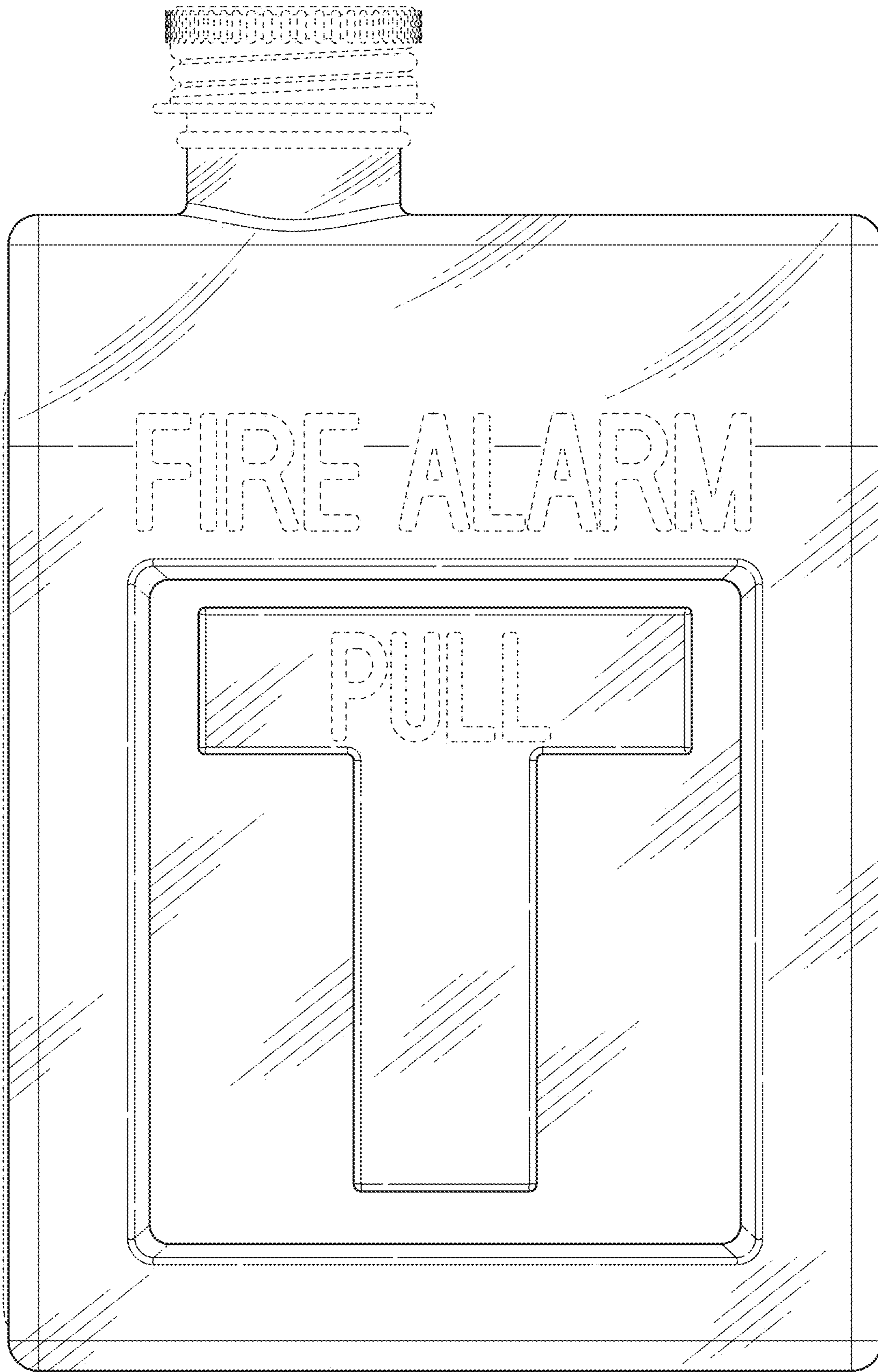

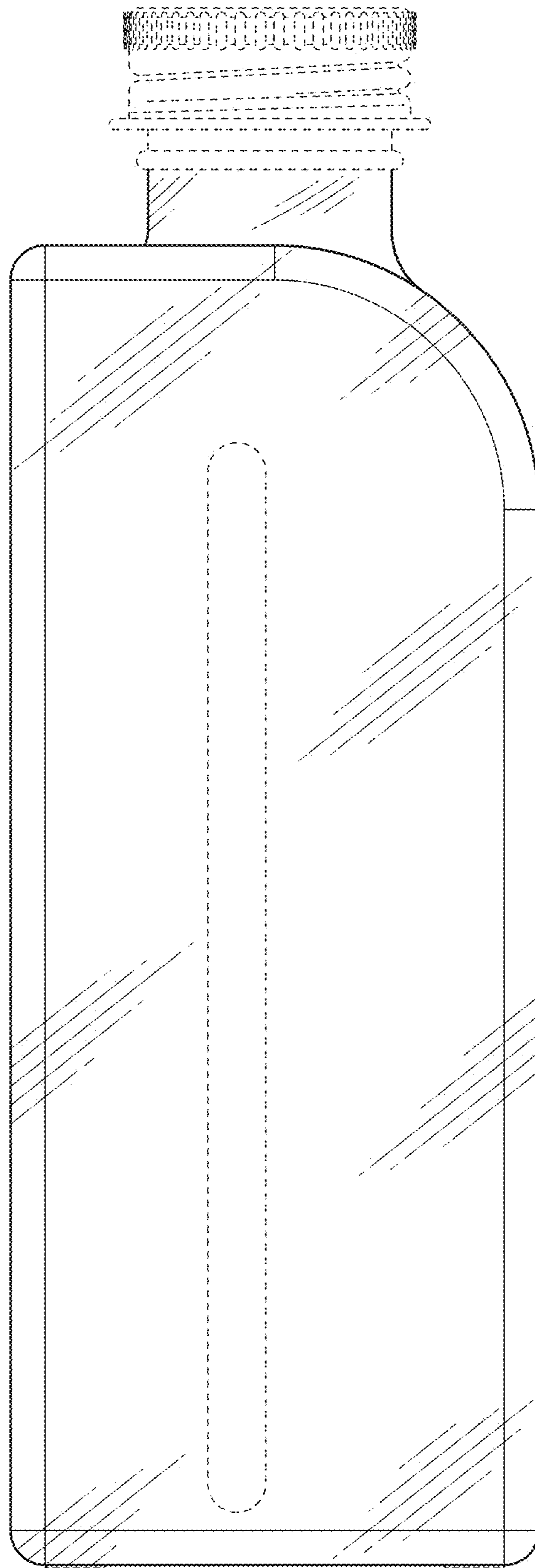

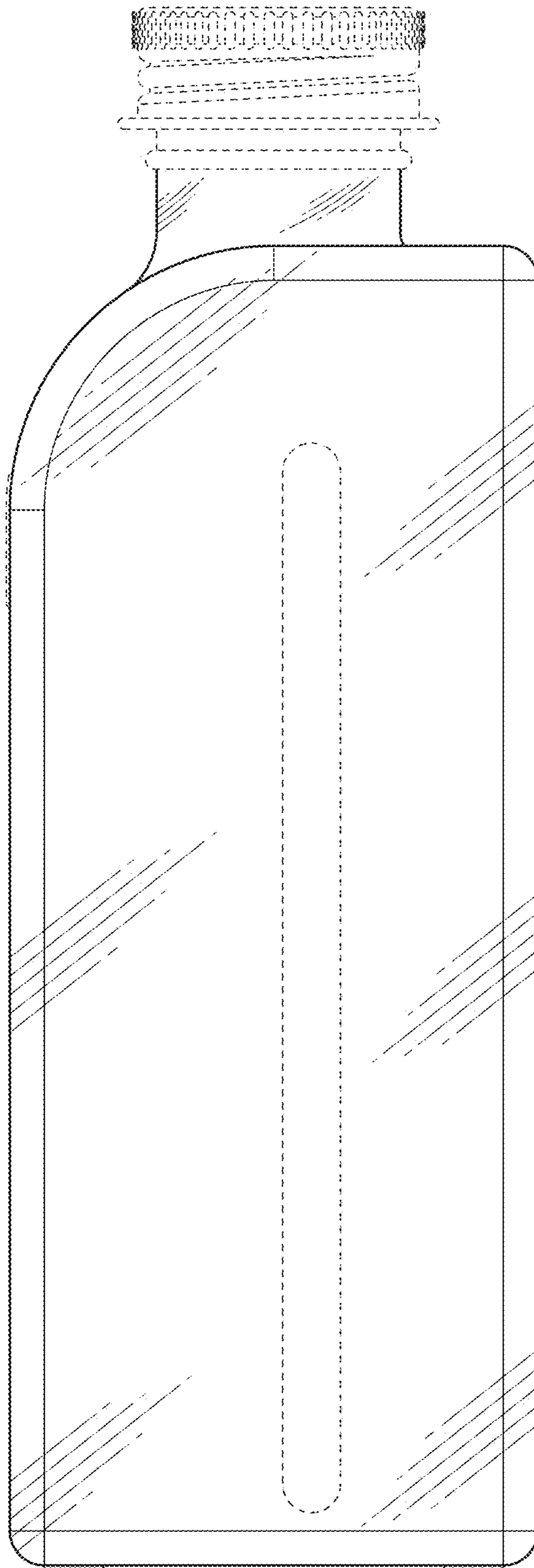

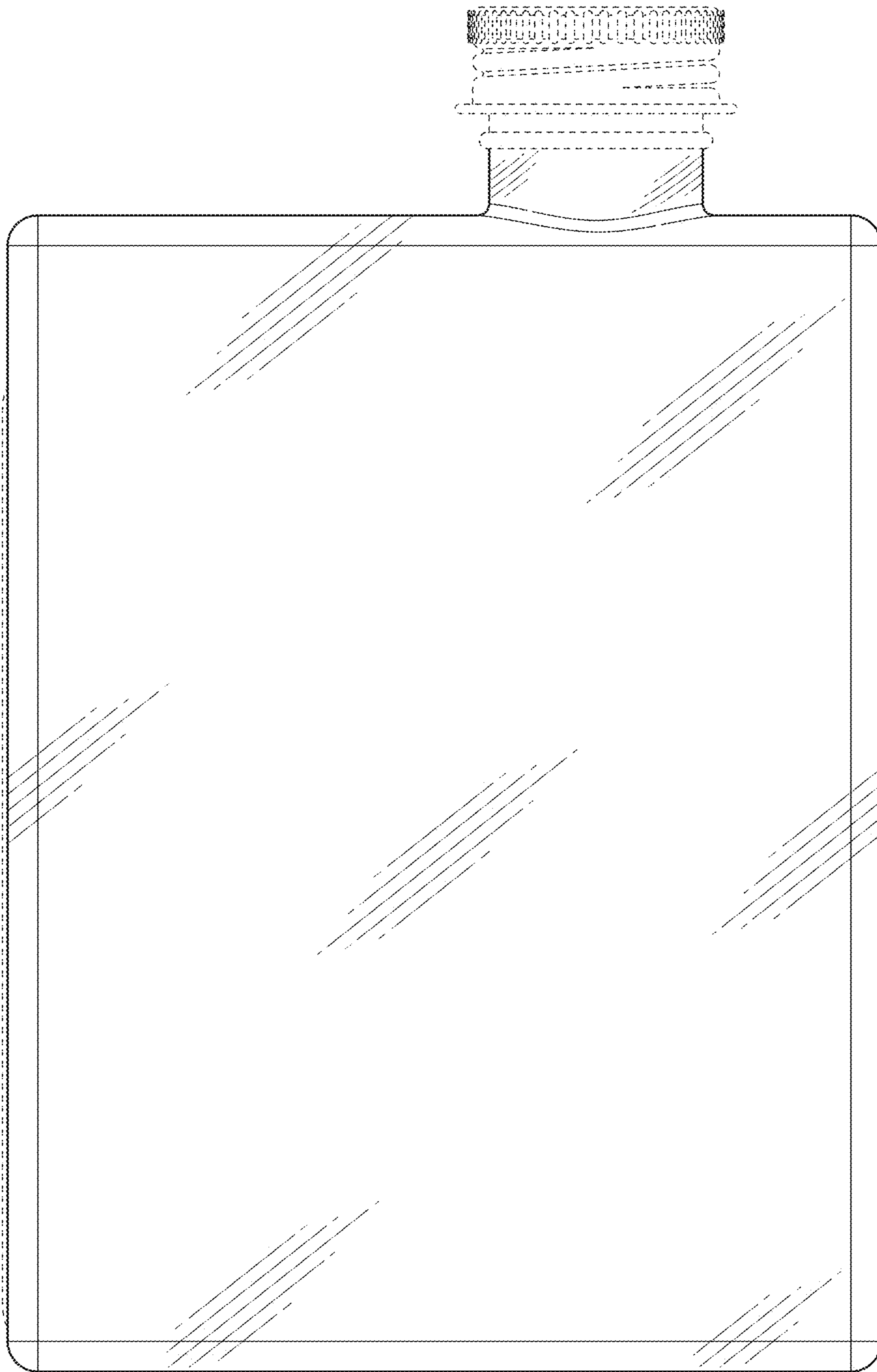

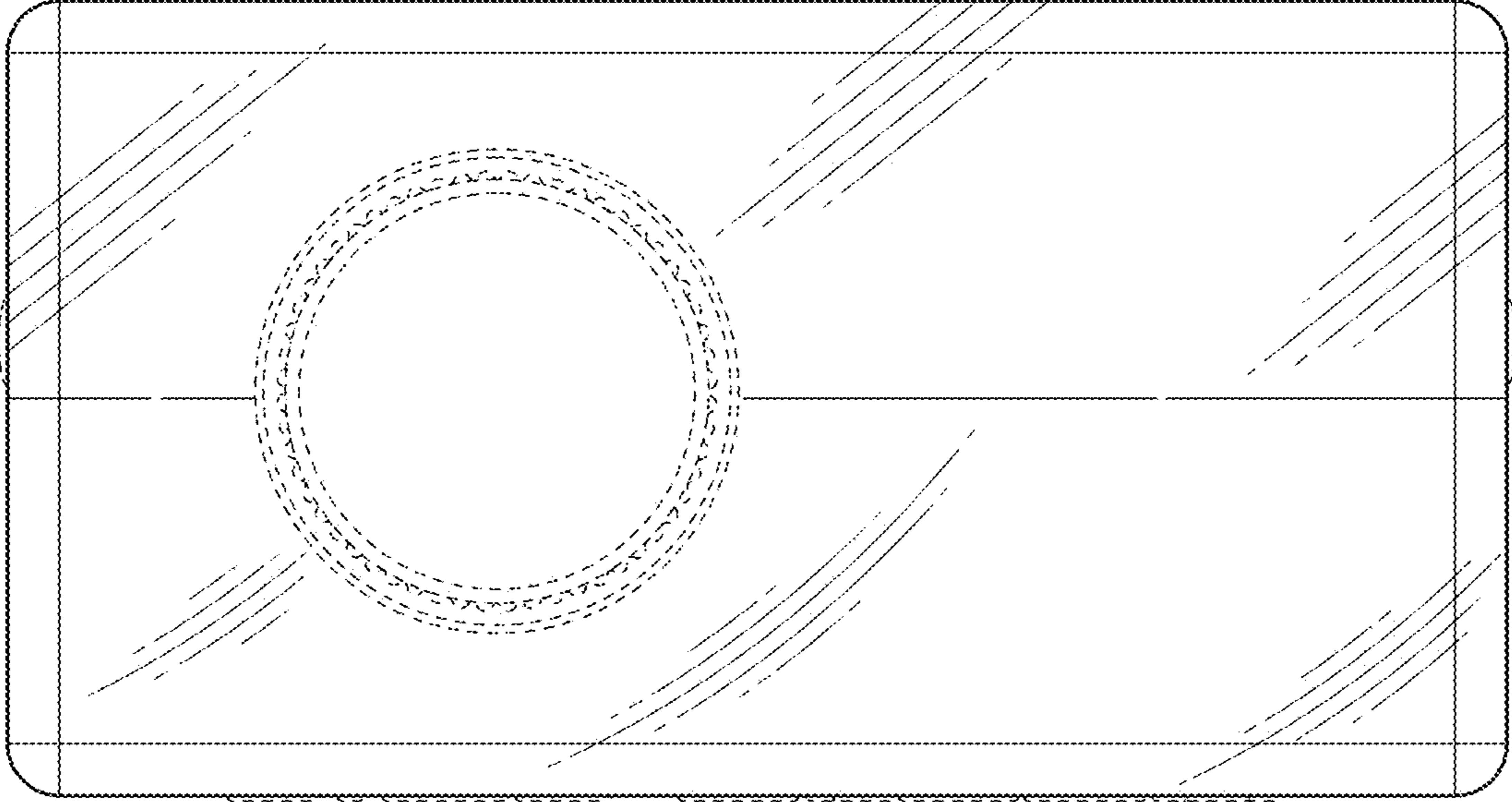

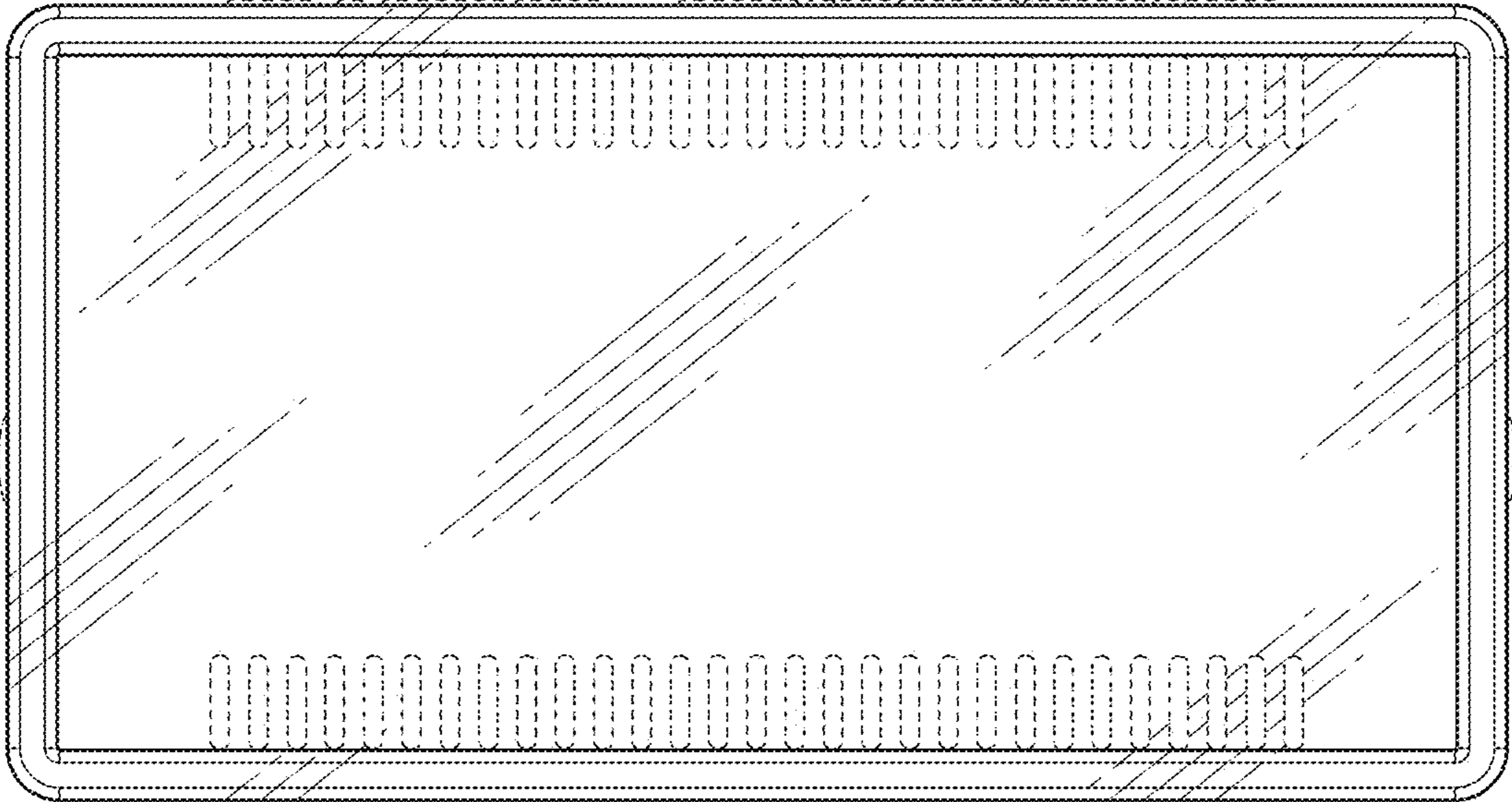
