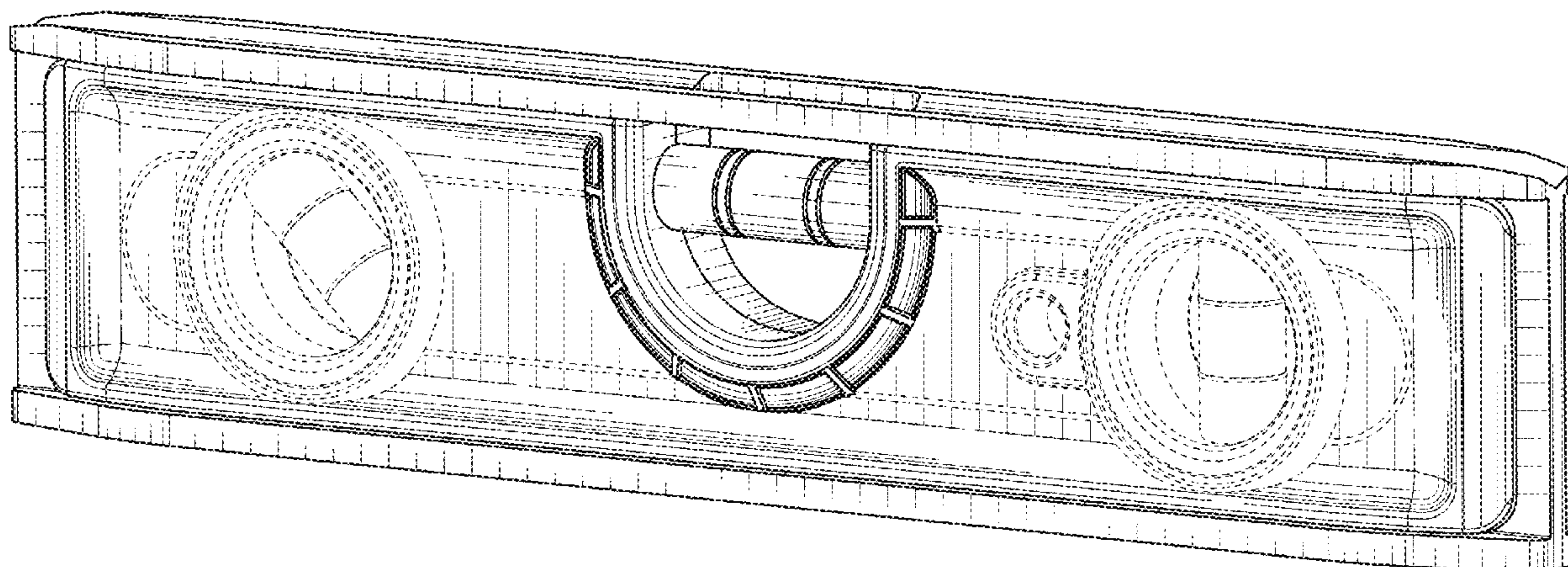
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a leveling device in accordance with my invention;

FIG. 4 is a left side view of the leveling device of FIG. 1;
FIG. 5 is a right side view of the leveling device of FIG. 1;

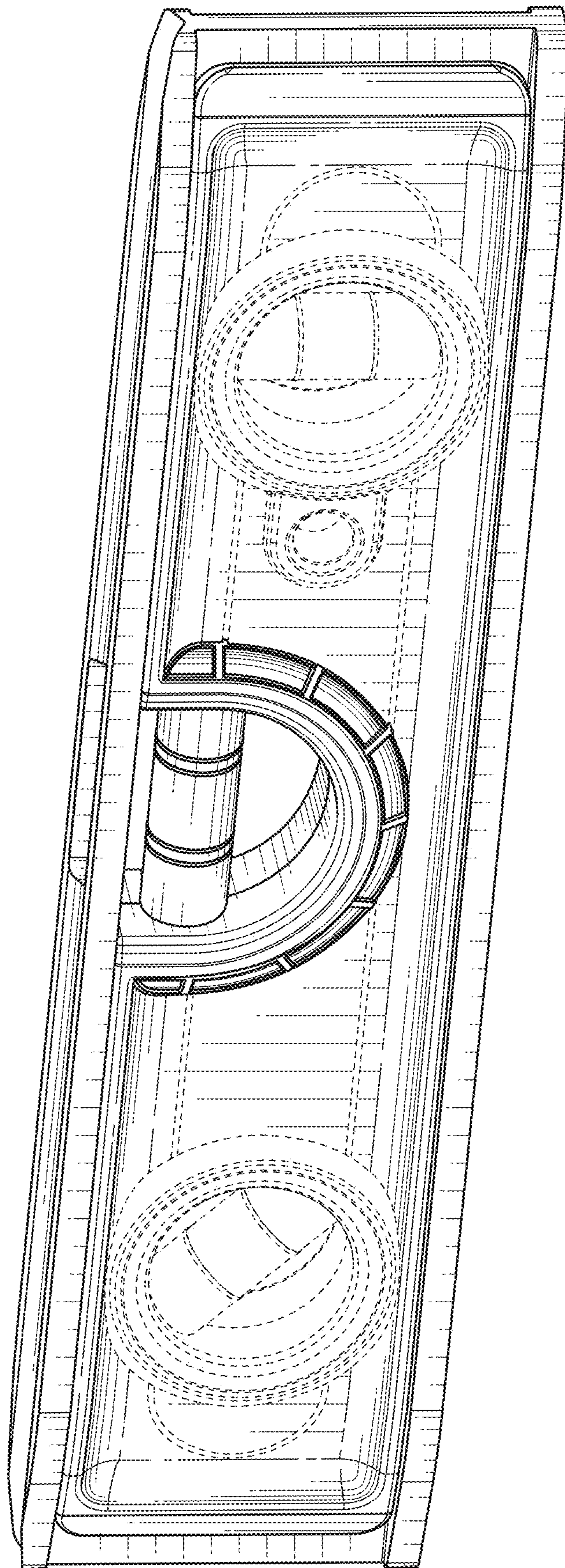

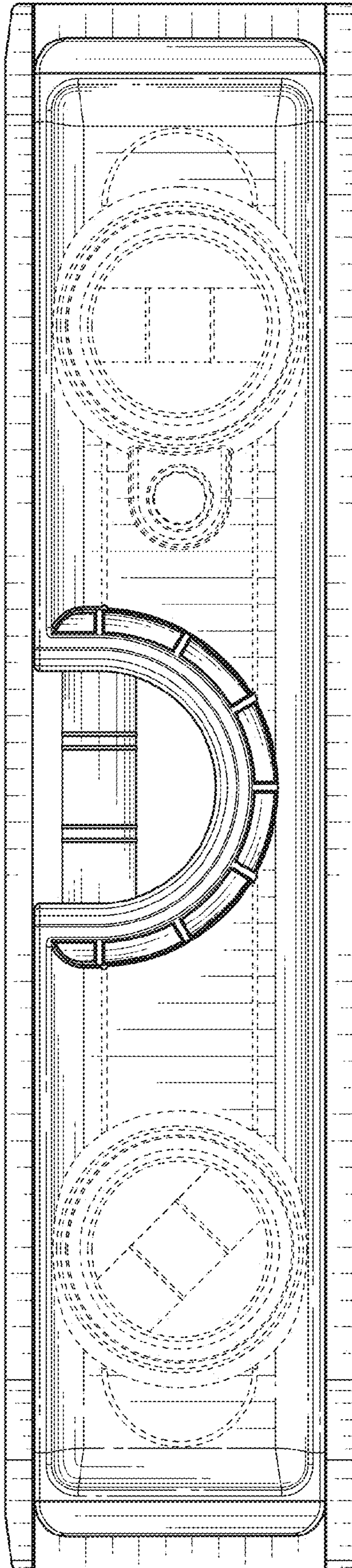

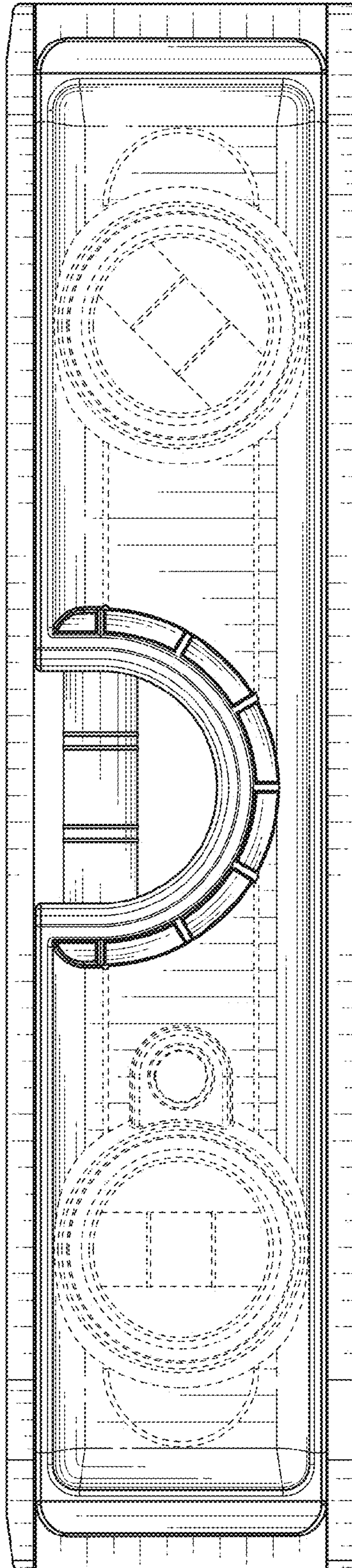

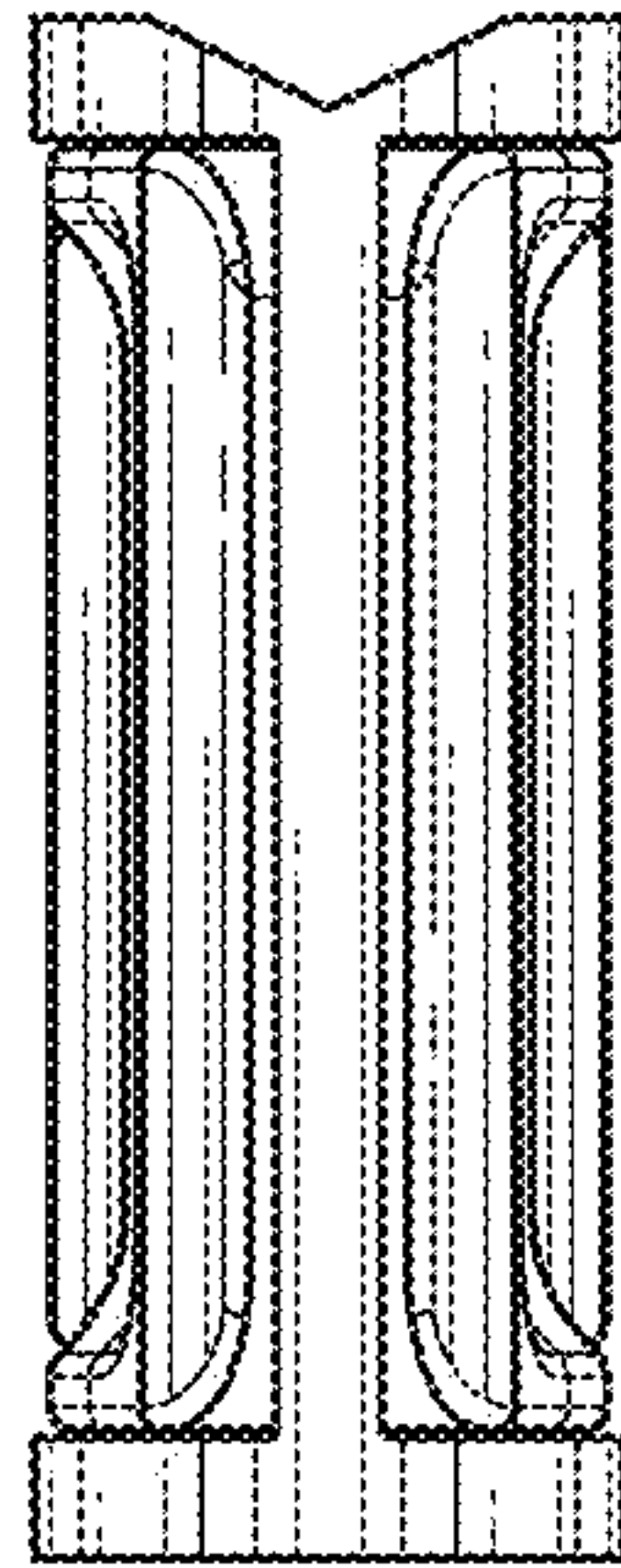

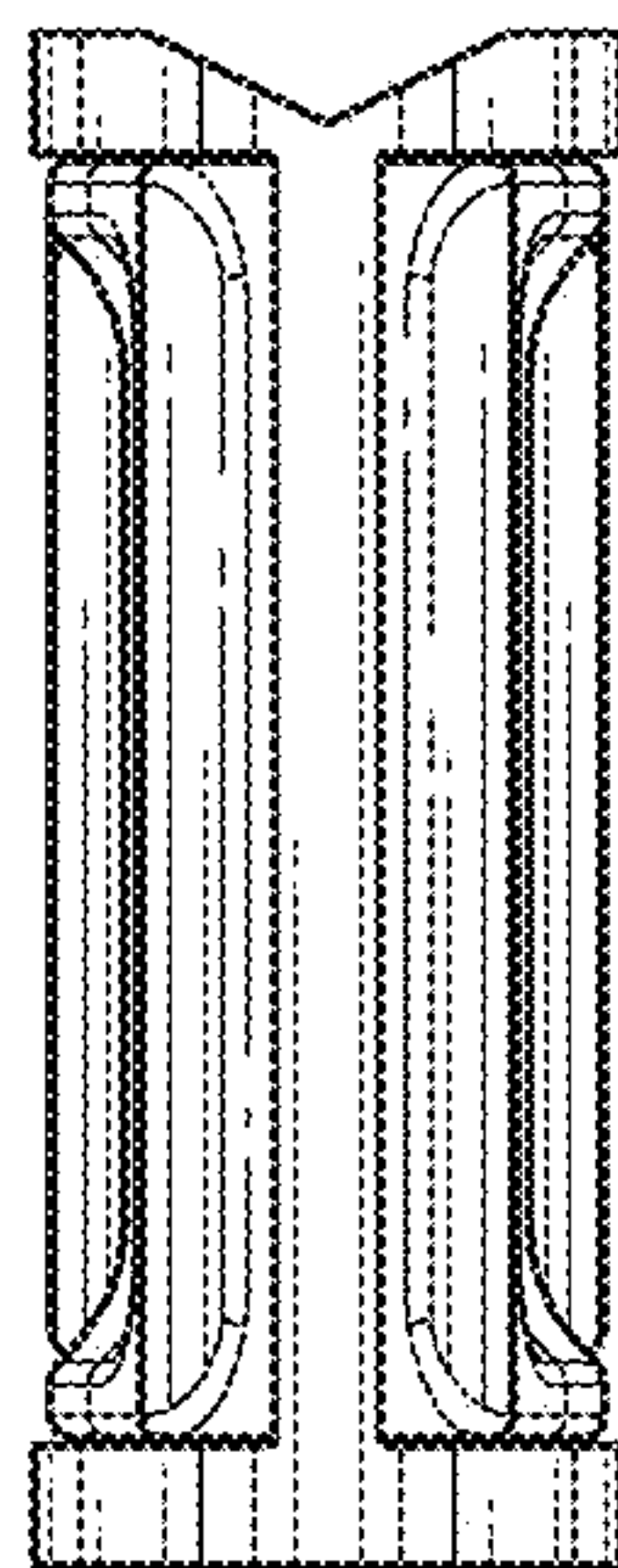

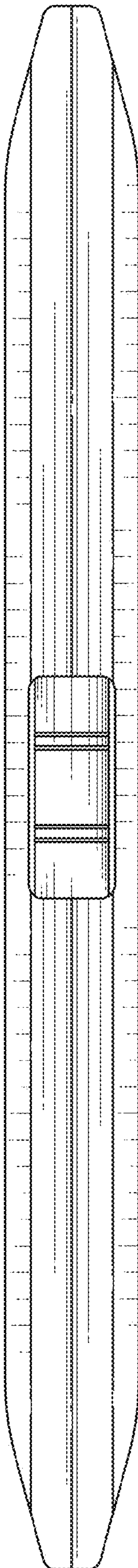

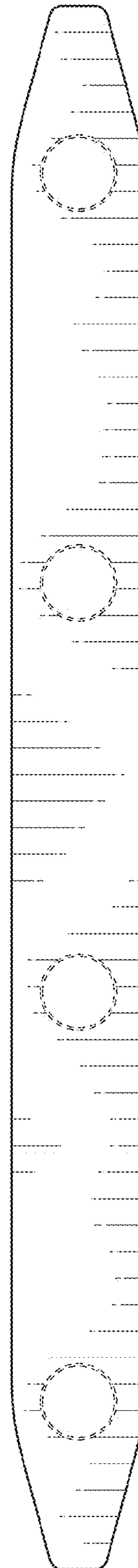
