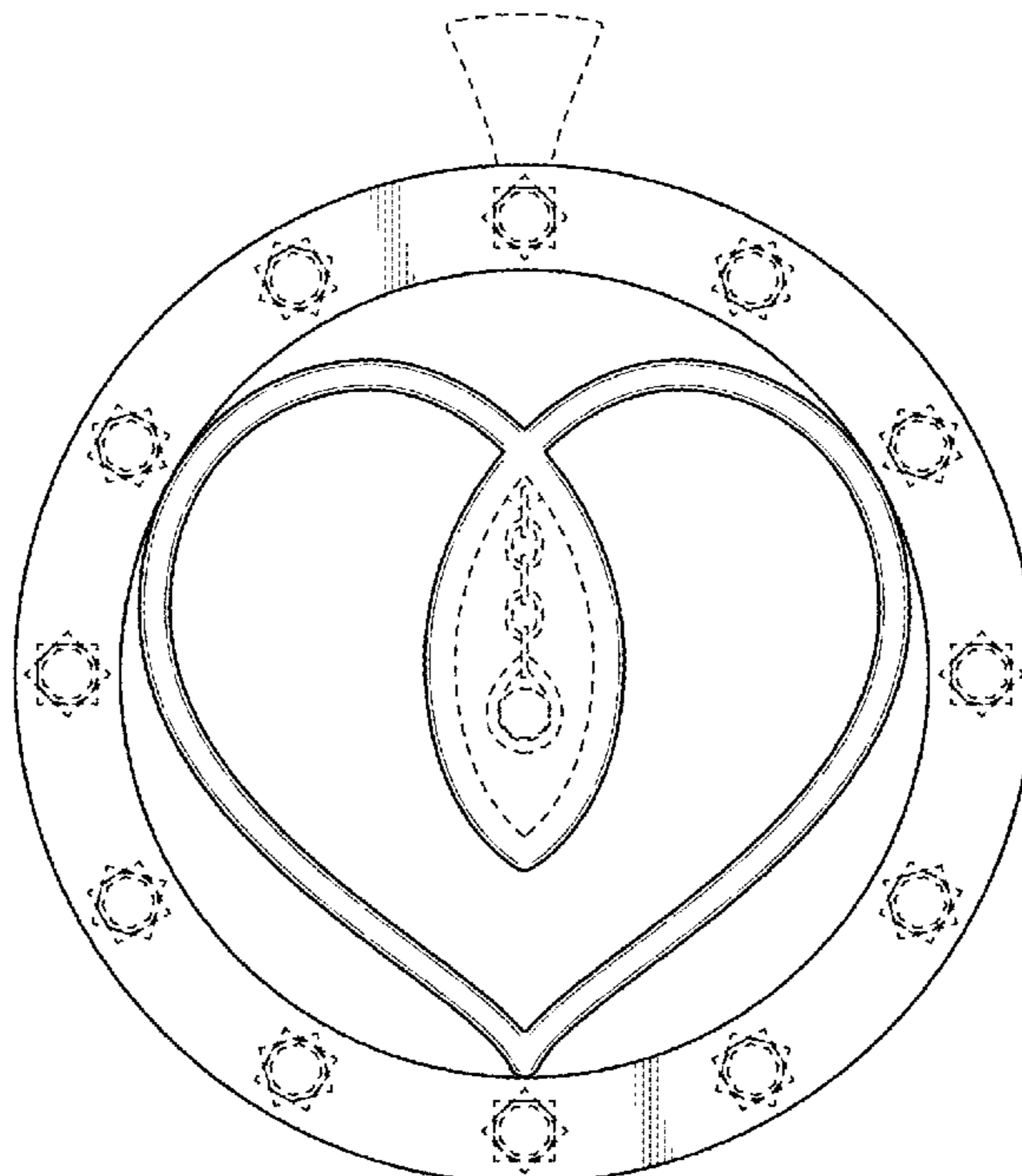
(57) **CLAIM**

The ornamental design for a pendant, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view from above, to the front and the left side of the new design for a pendant;

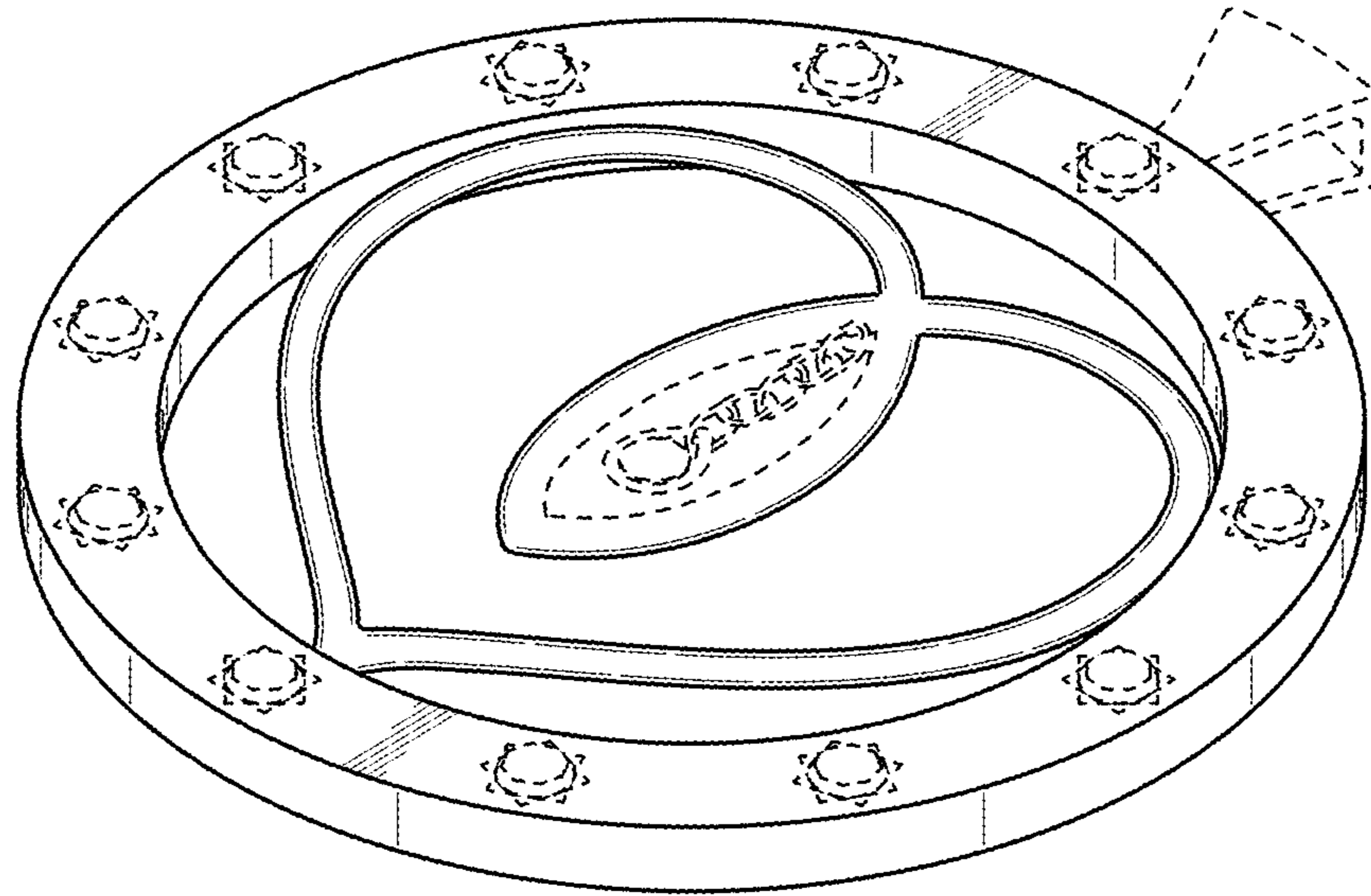

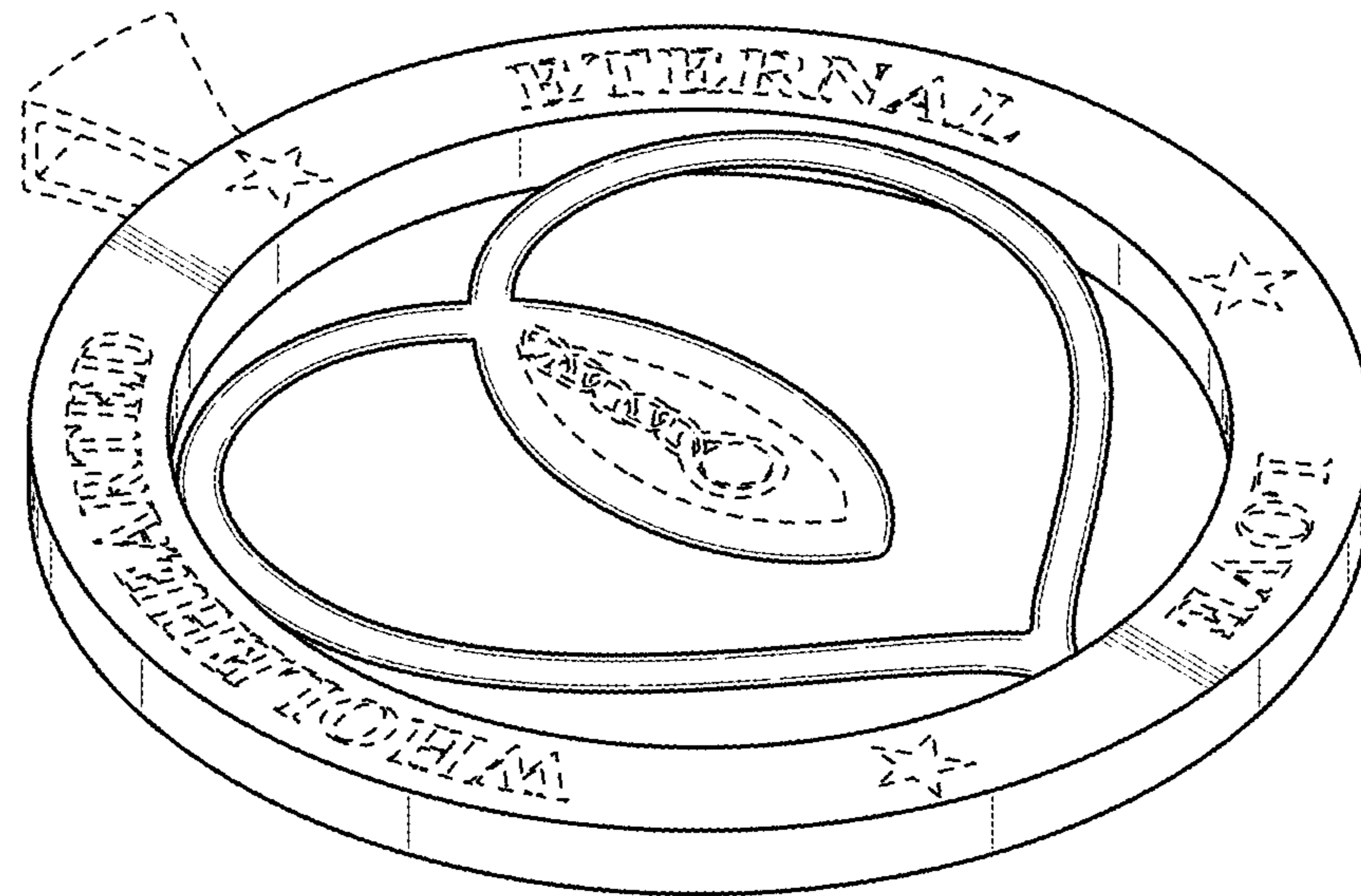

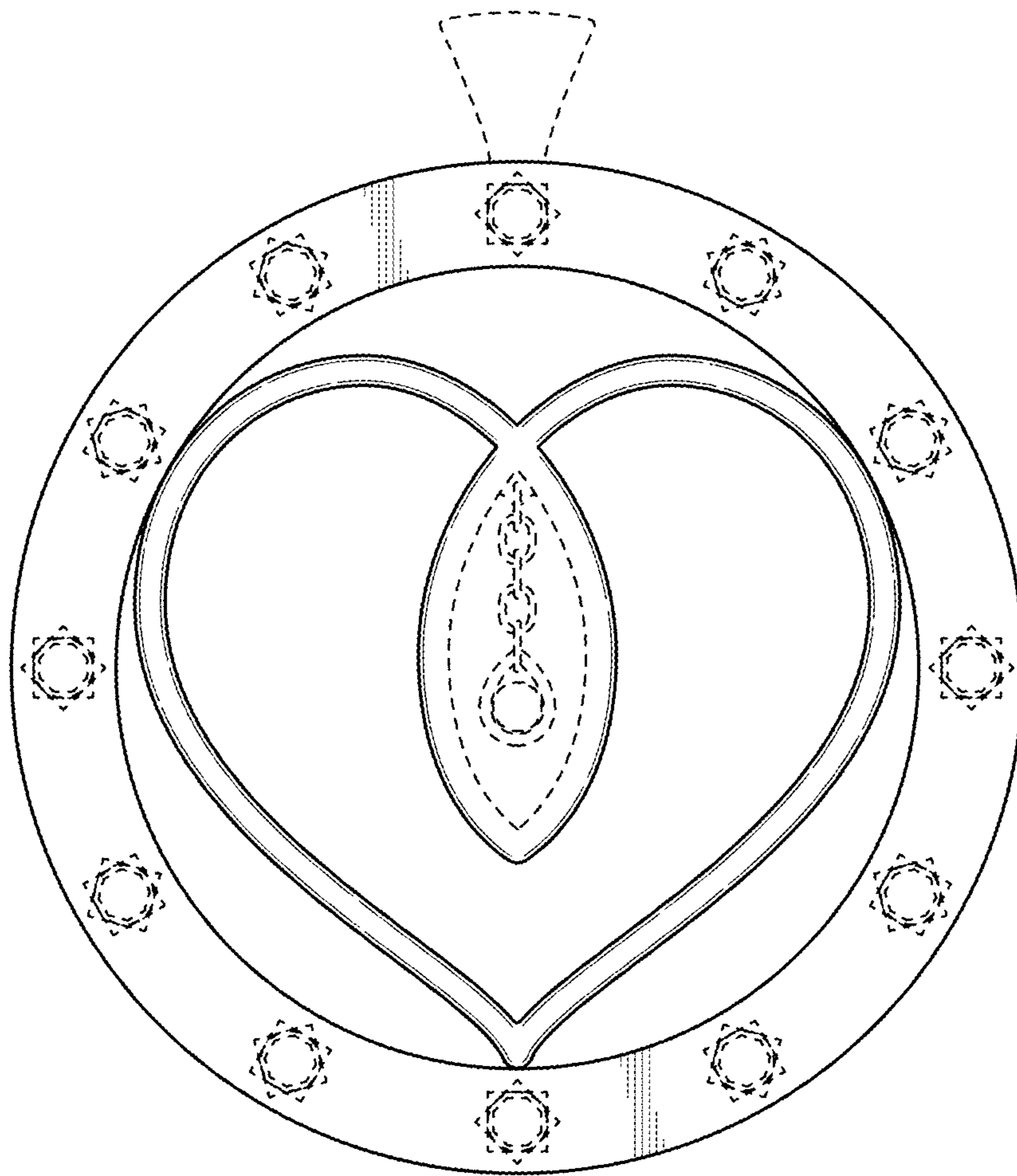

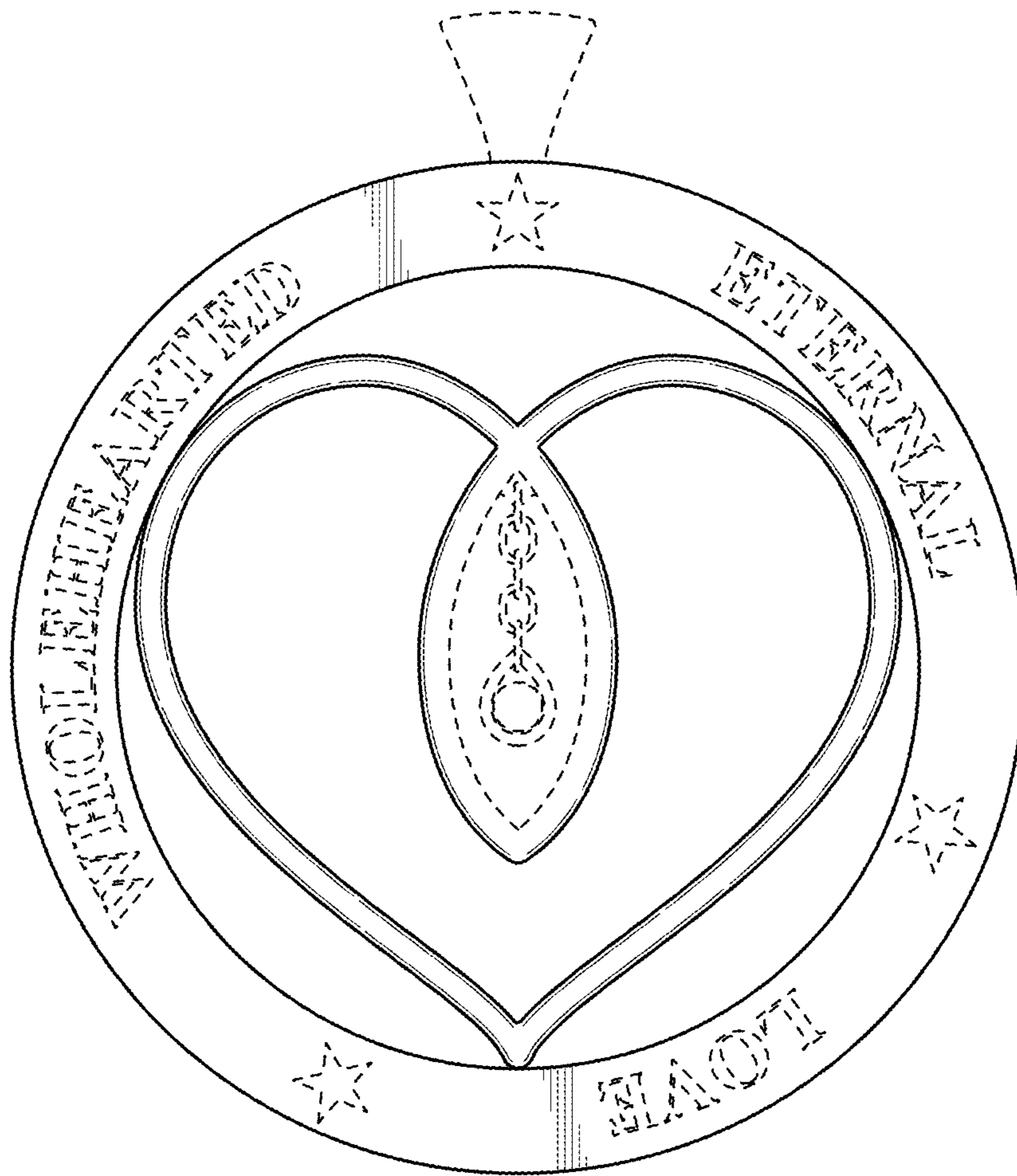
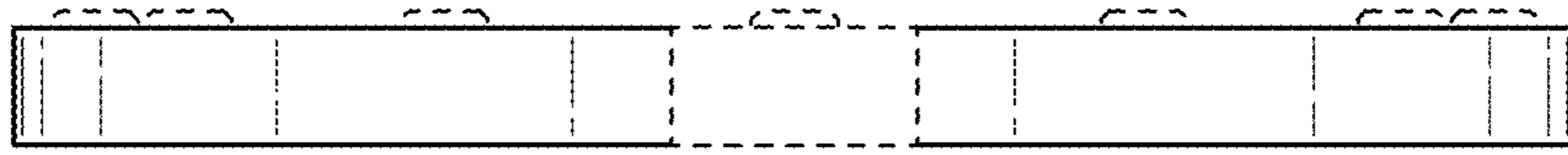


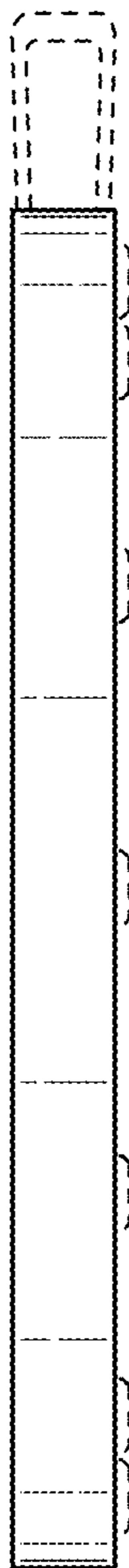
