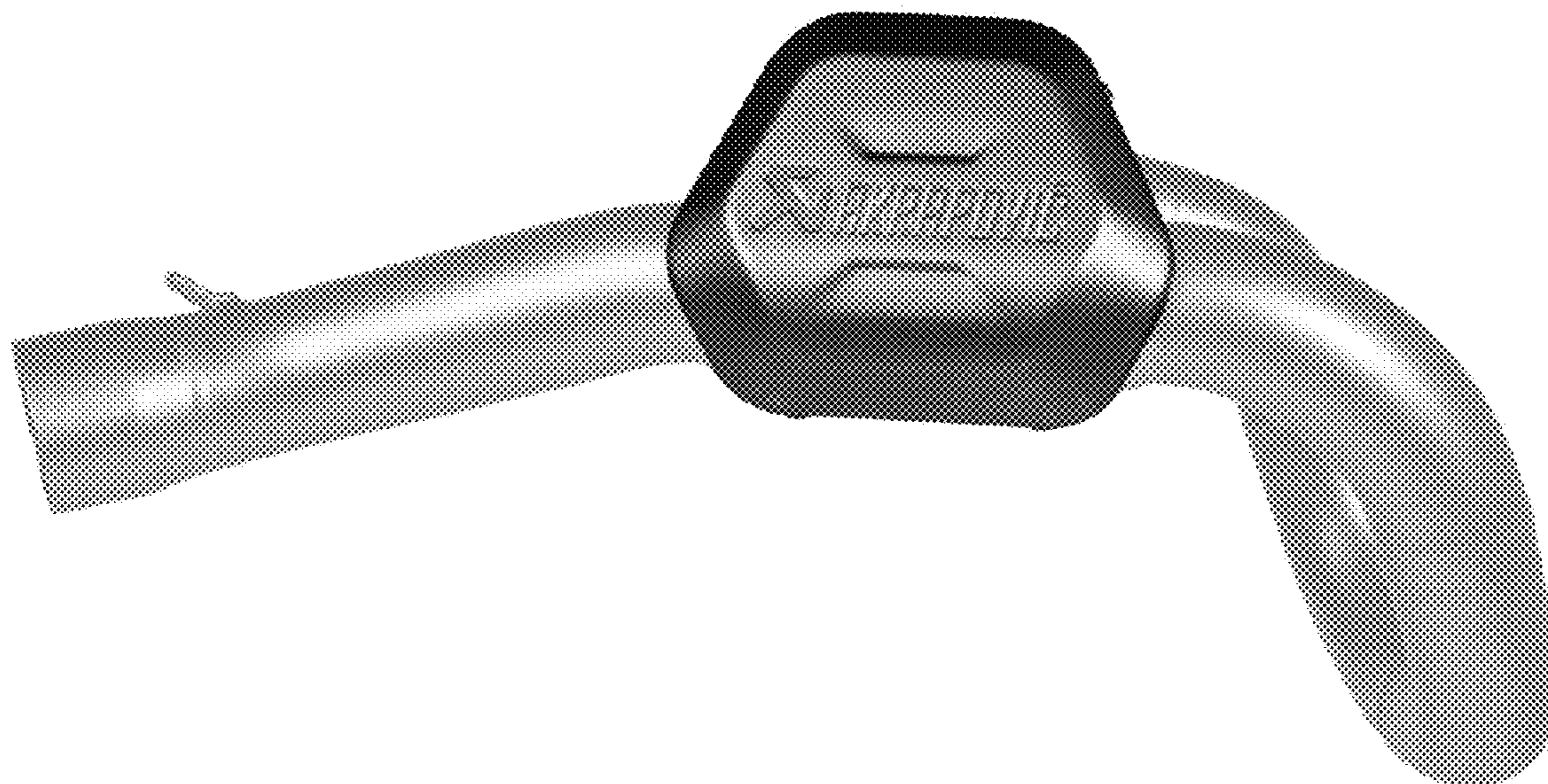

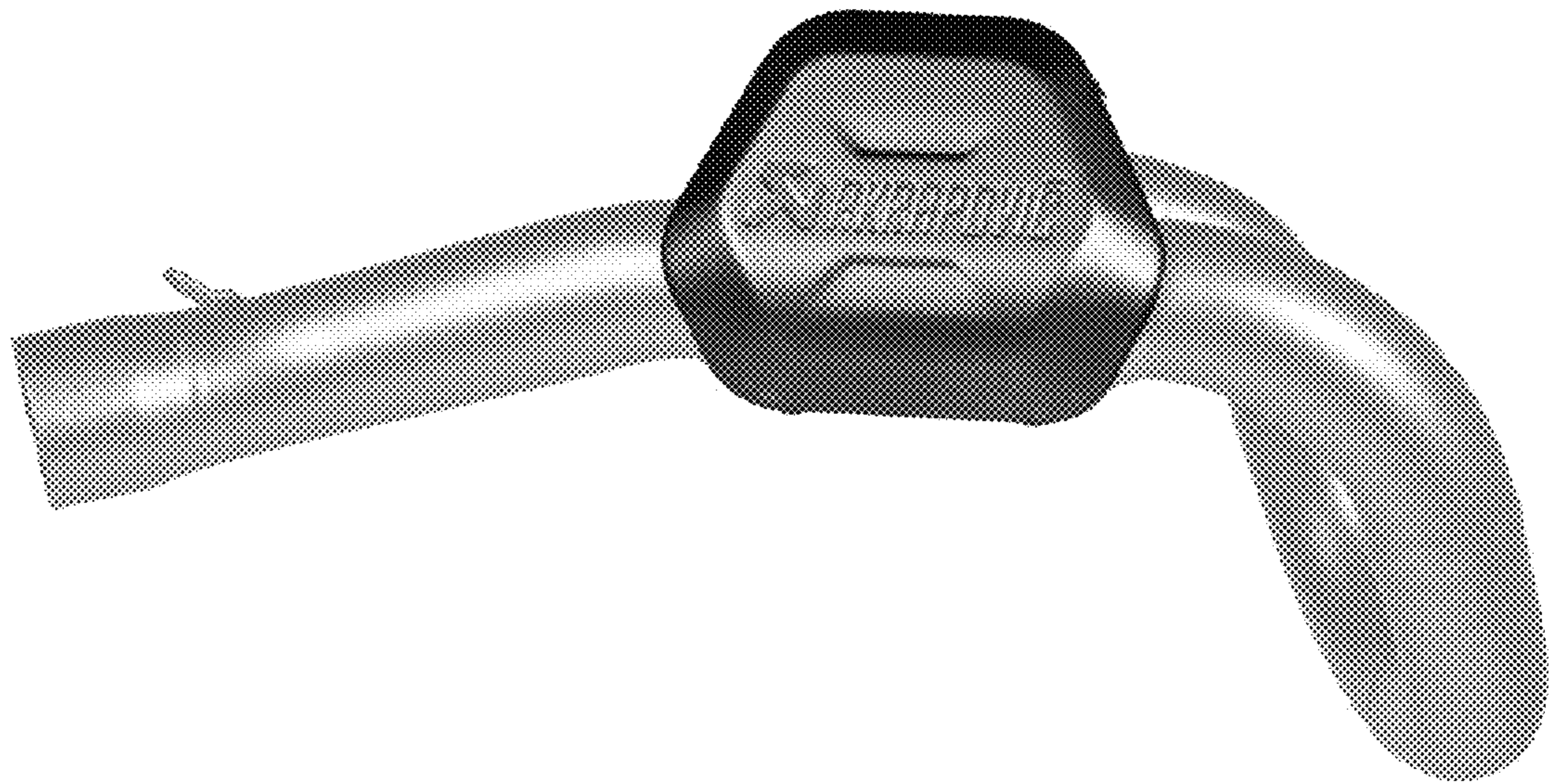

In the reproductions, the exhaust pipe portions of the article shown in reduced contrast form no part of the claimed design.

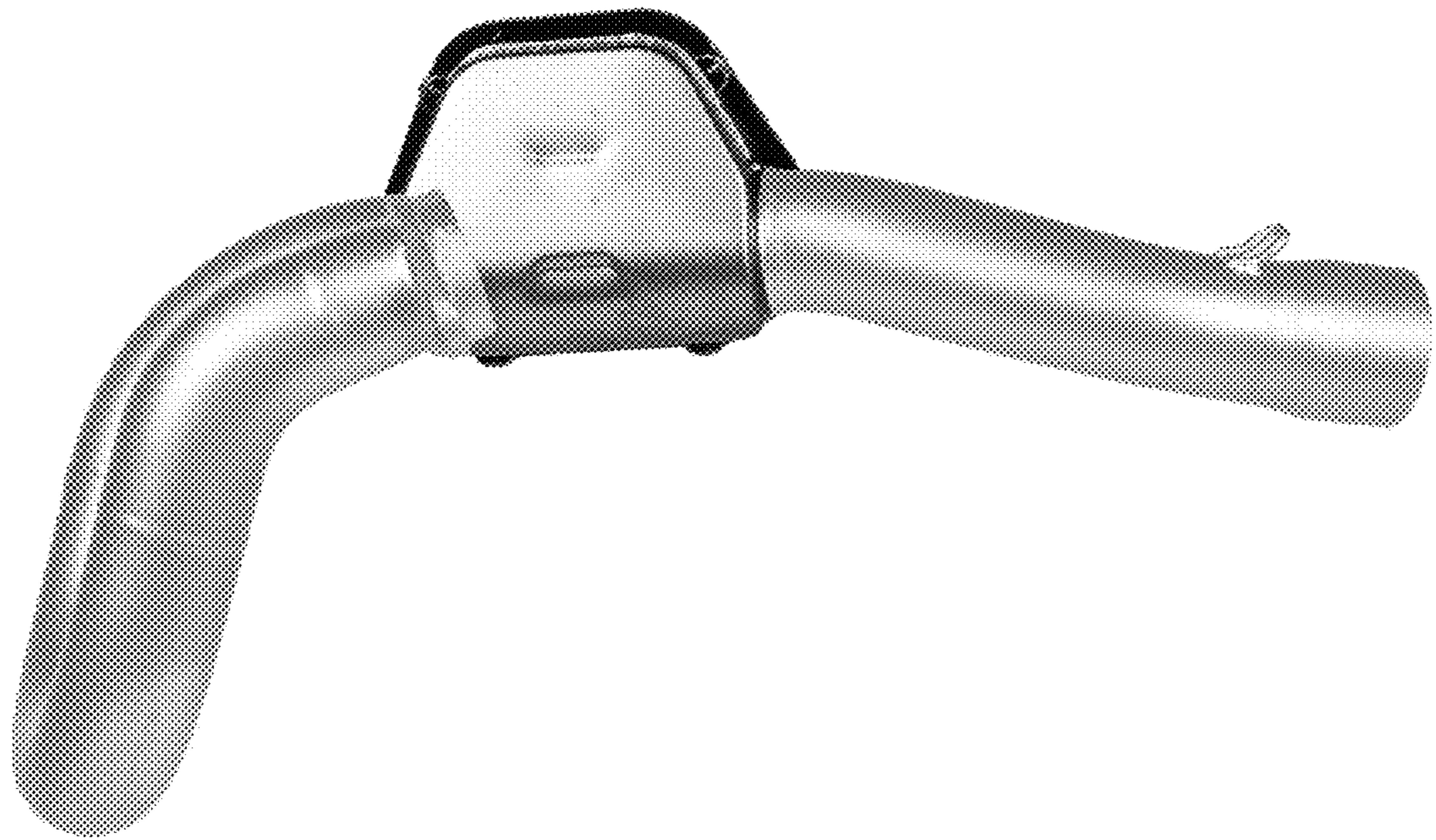

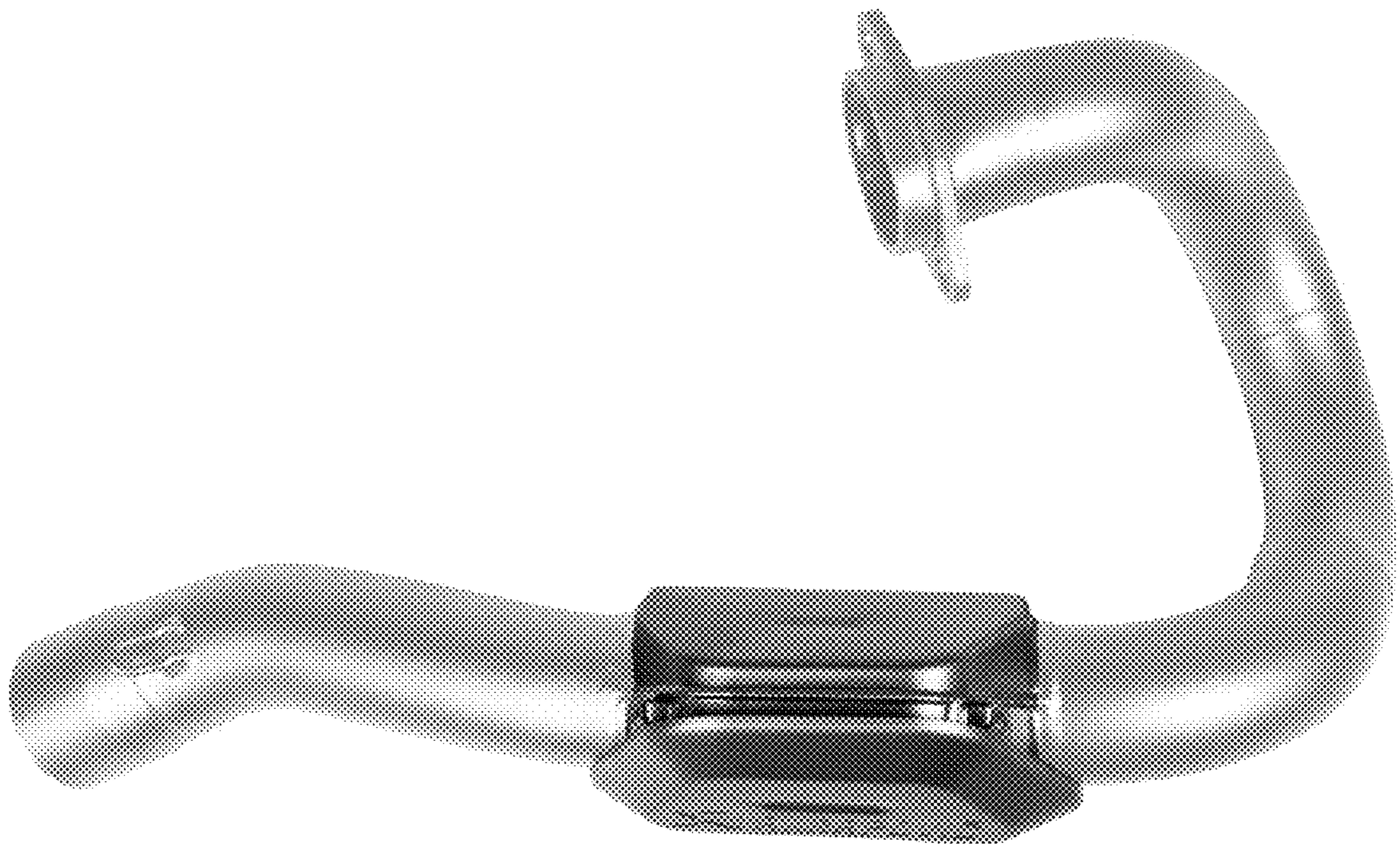

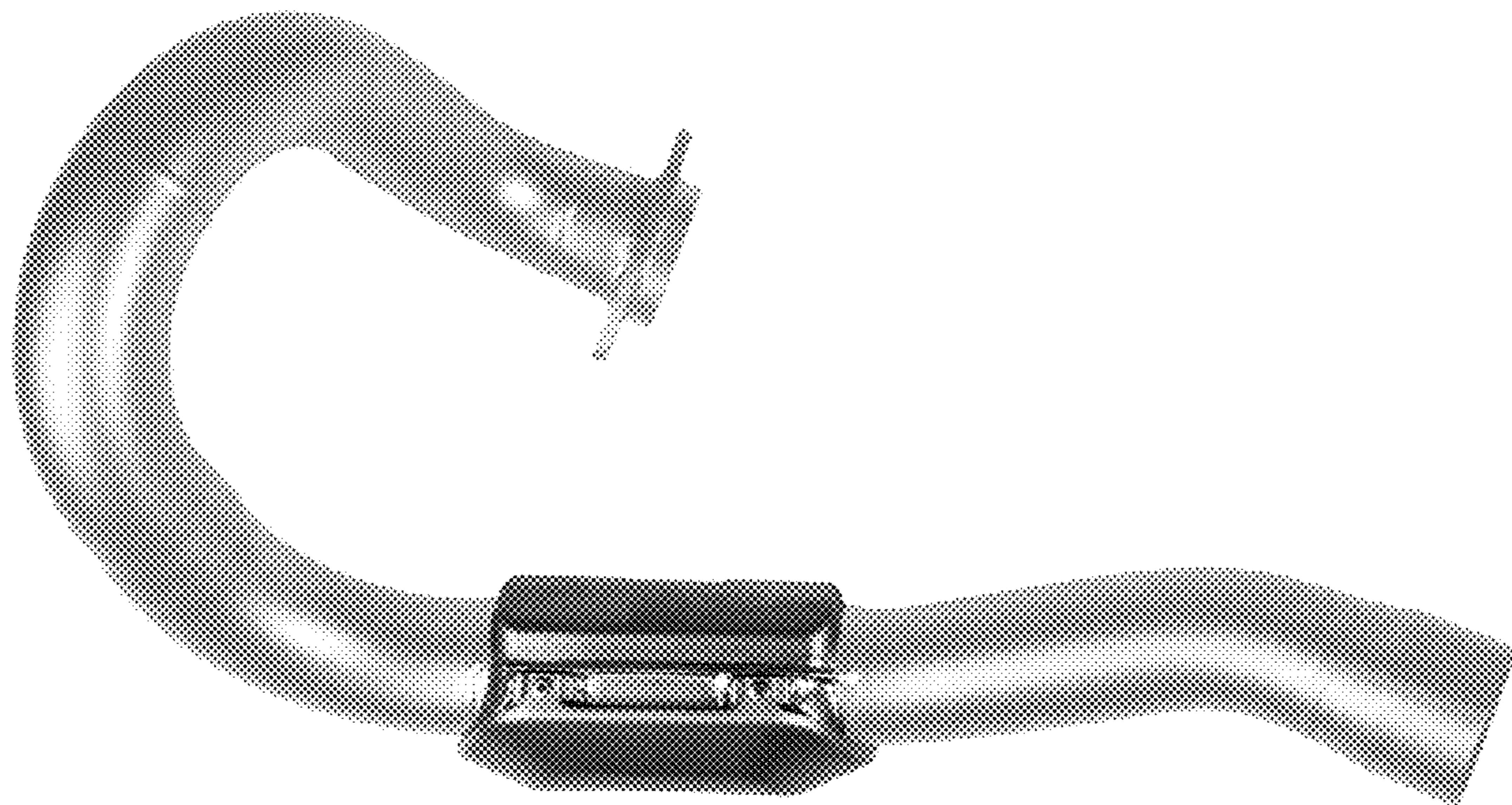

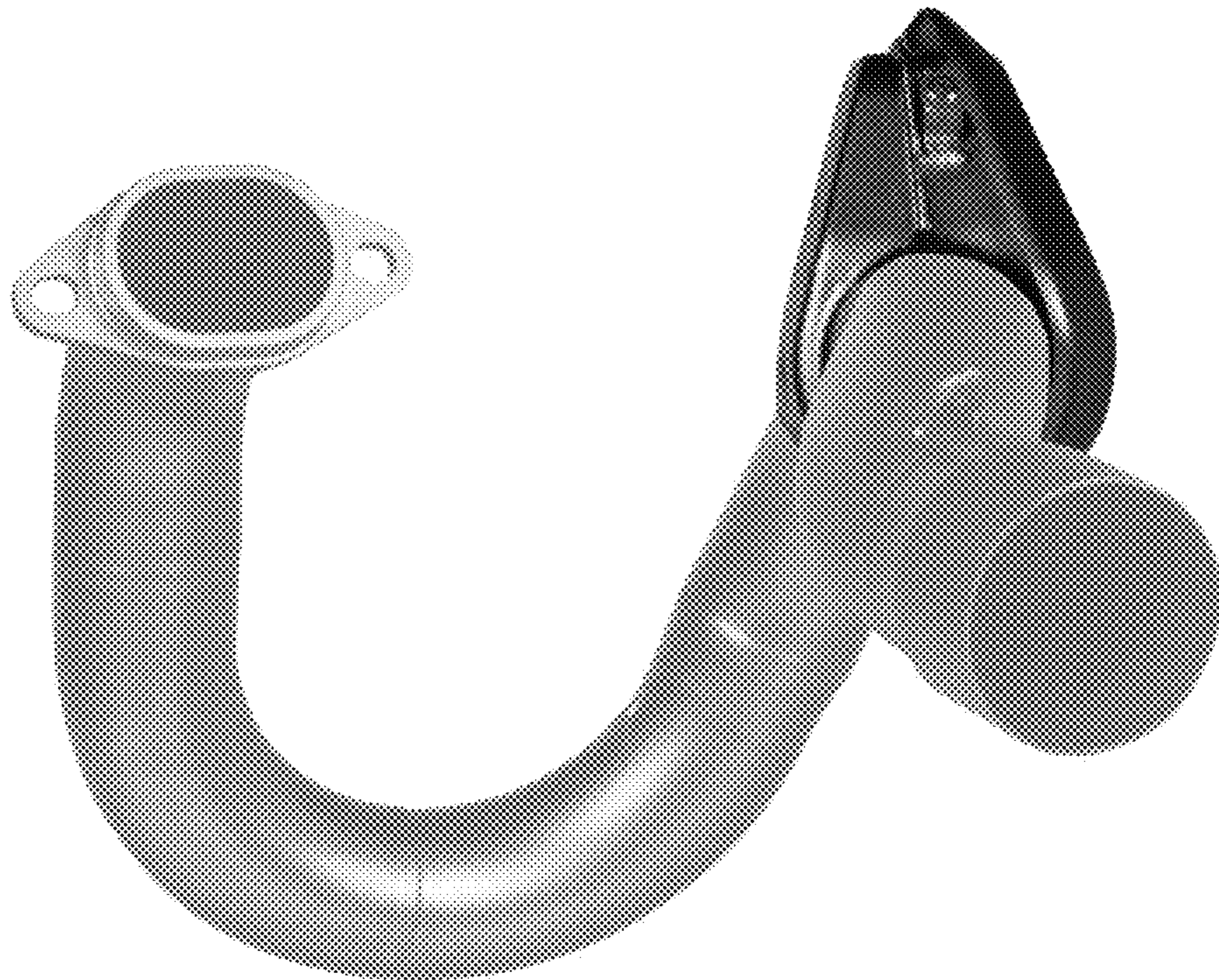
