(57) **CLAIM**

The ornamental design for a sound effects board, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of a sound effects board, showing my new design;

FIG. 2 is a bottom view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a left side elevational view thereof;

FIG. 7 is a top view thereof showing a first display state of the sound effects board;

FIG. 8 is a top view thereof showing a second display state of the sound effects board;

FIG. 9 is an enlarged perspective view of the knob of the sound effects board in FIG. 1, shown separately to illustrate aspects of the design that are not visible when combined;

FIG. 10 is an enlarged top plan view of the knob of the sound effects board, shown separately to illustrate aspects of the design that are not visible when combined, shown in an alternate configuration;

FIG. 11 is an enlarged top plan view of the knob of the sound effects board, shown by a first alternative configuration;







































































