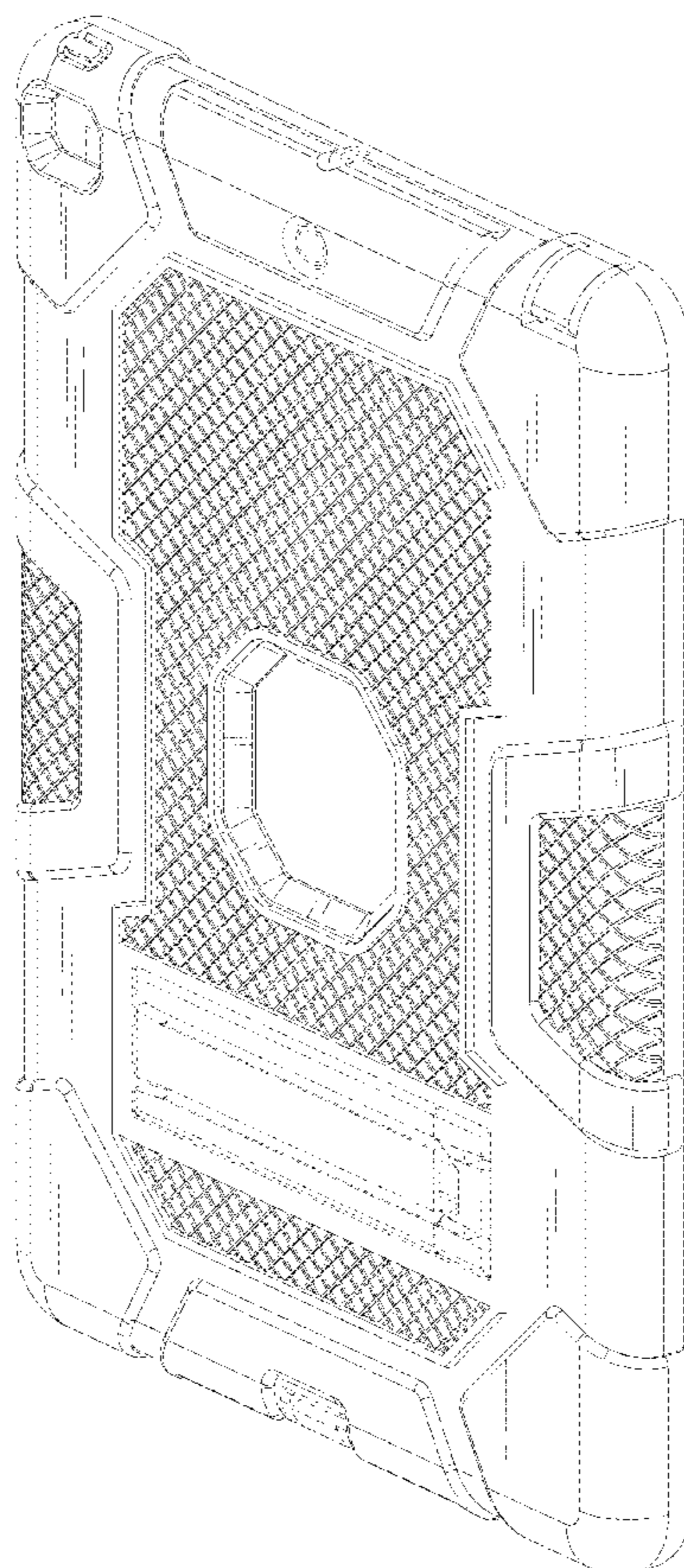
(57) **CLAIM**

The ornamental design for a tablet case, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and right side perspective view of a tablet case showing my new design; FIG. 2 is a back elevation view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a right side elevation view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. The broken lines shown in the drawings depict portions of the tablet case in which the design is embodied that form no part of the claimed design.

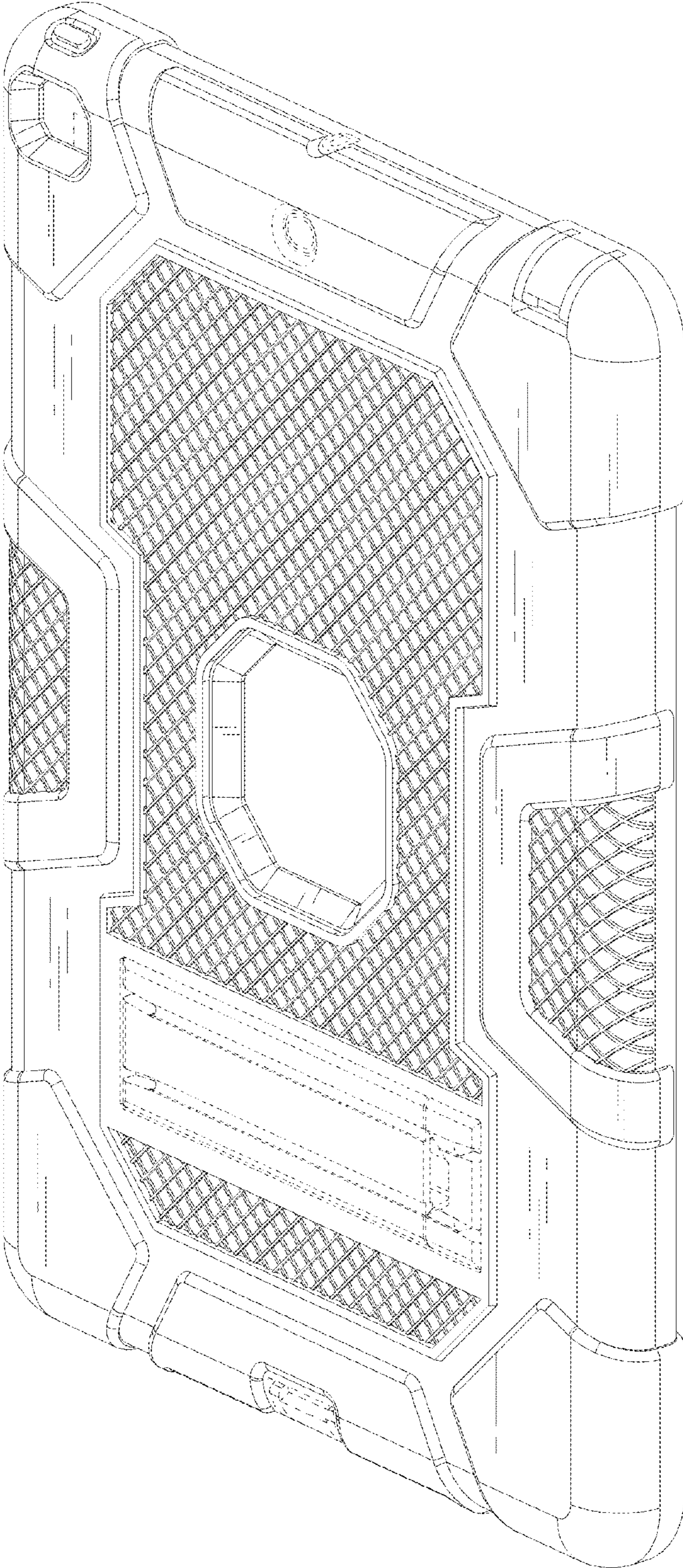

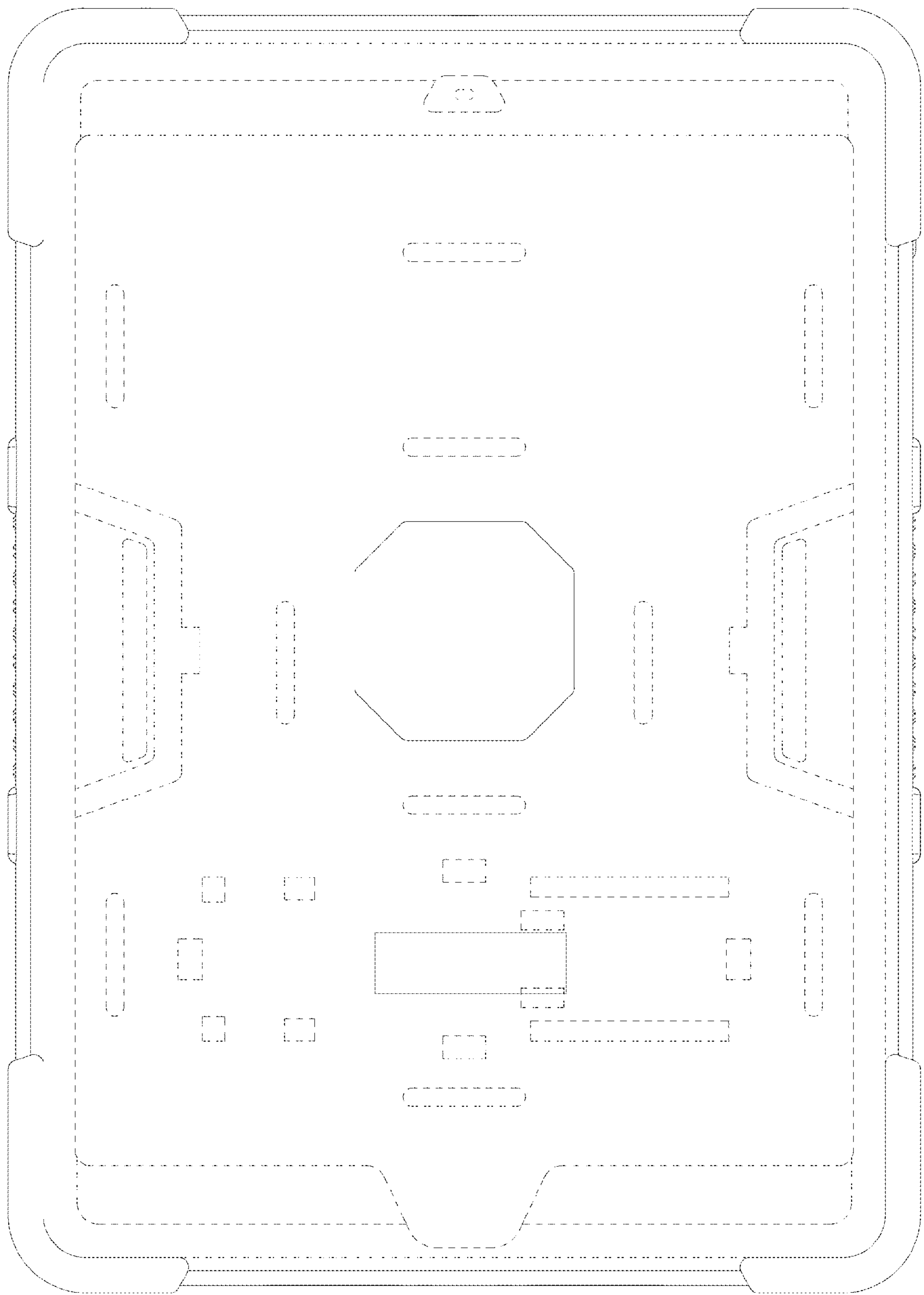

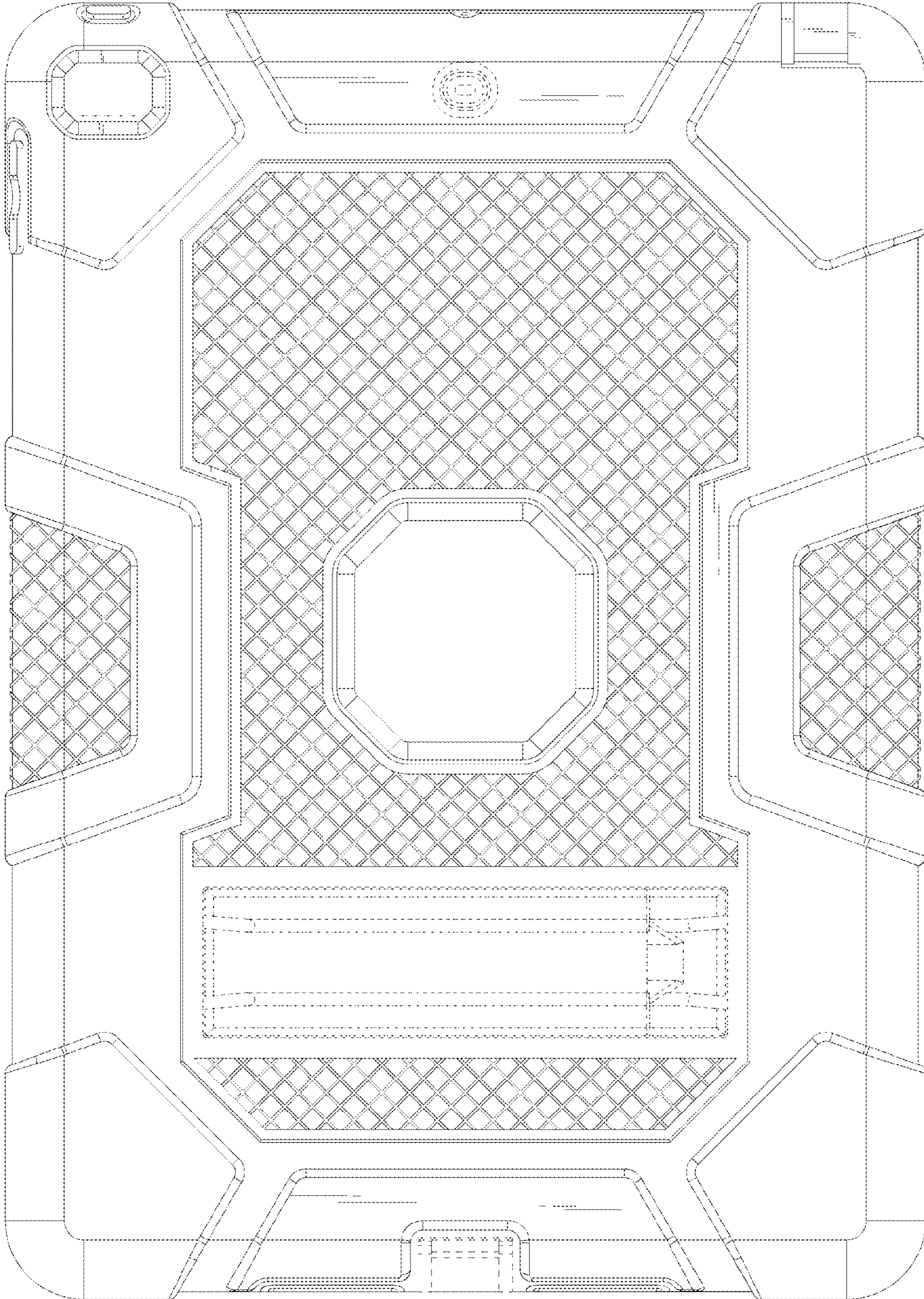

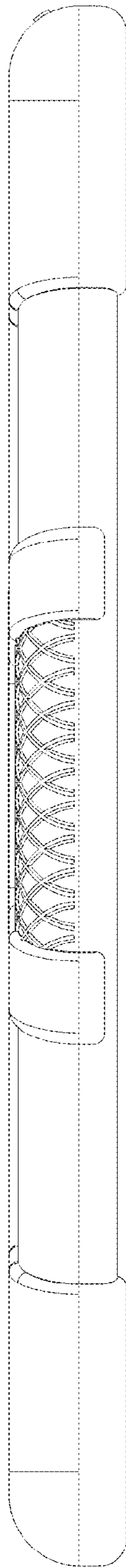

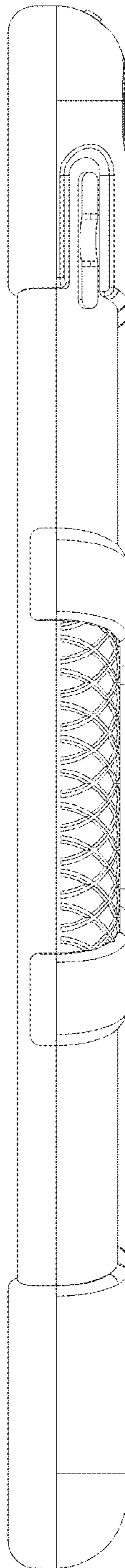

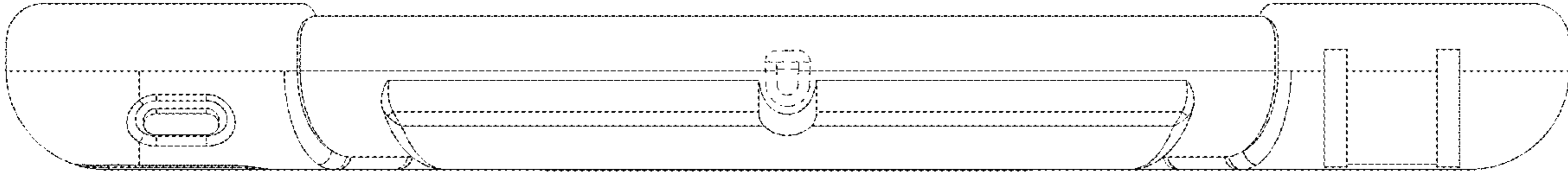

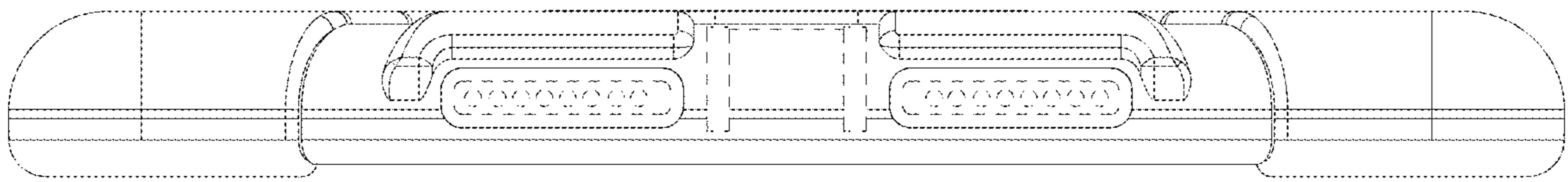
