FIG. 6 is a second image thereof;

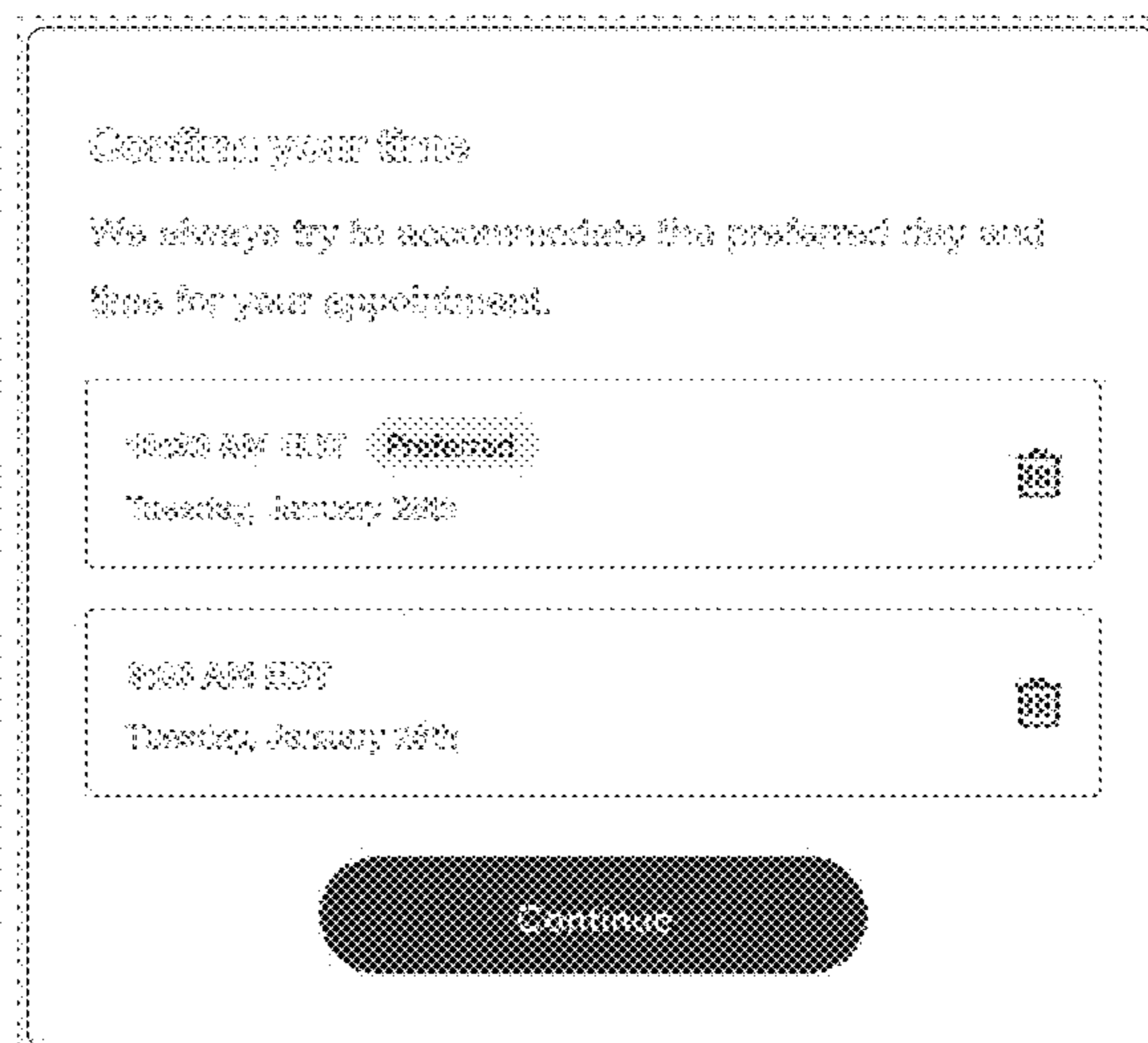
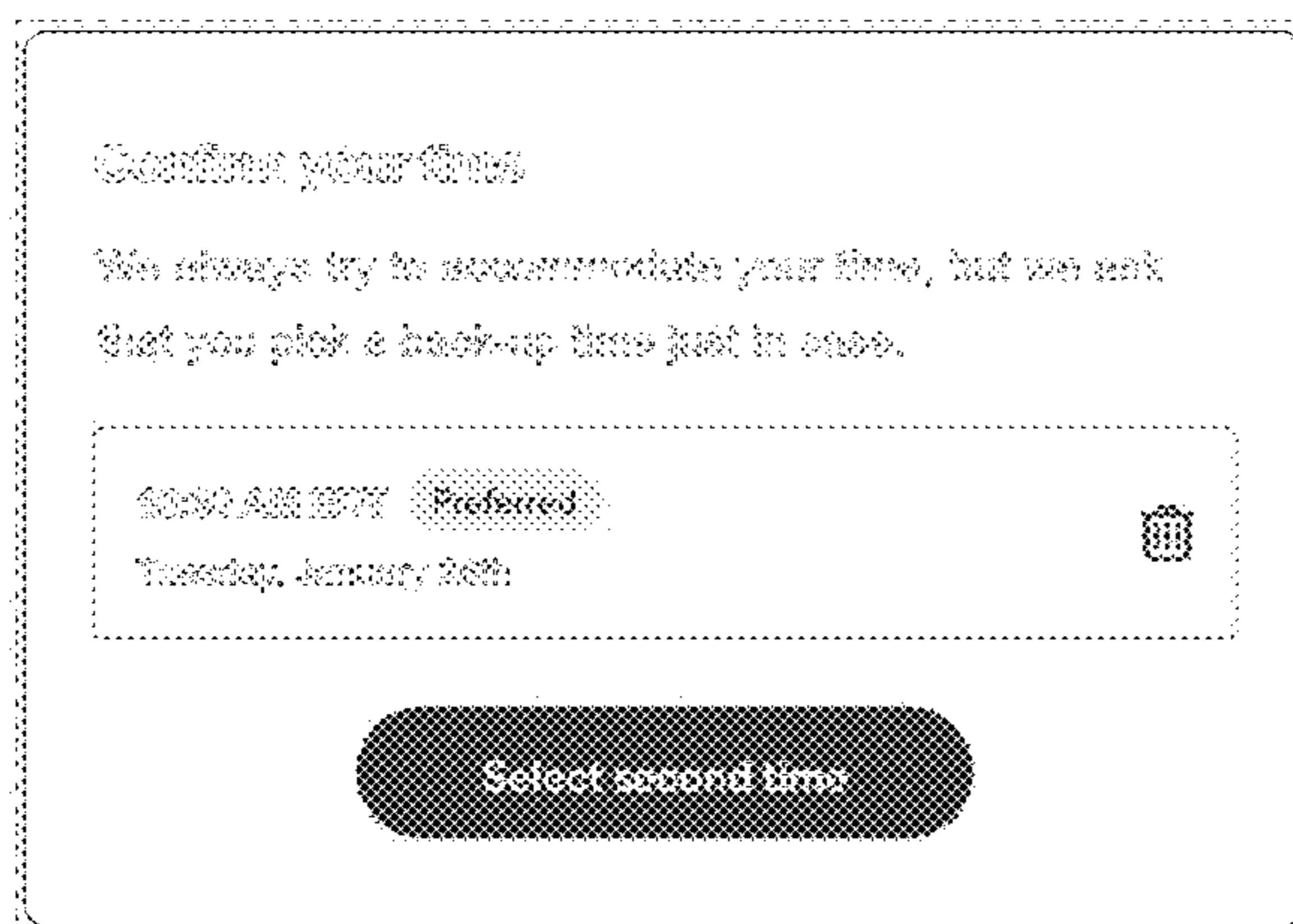
FIG. 7 is a fourth embodiment of a display screen or portion thereof with animated graphical user interface showing a first image of the claimed design; and,

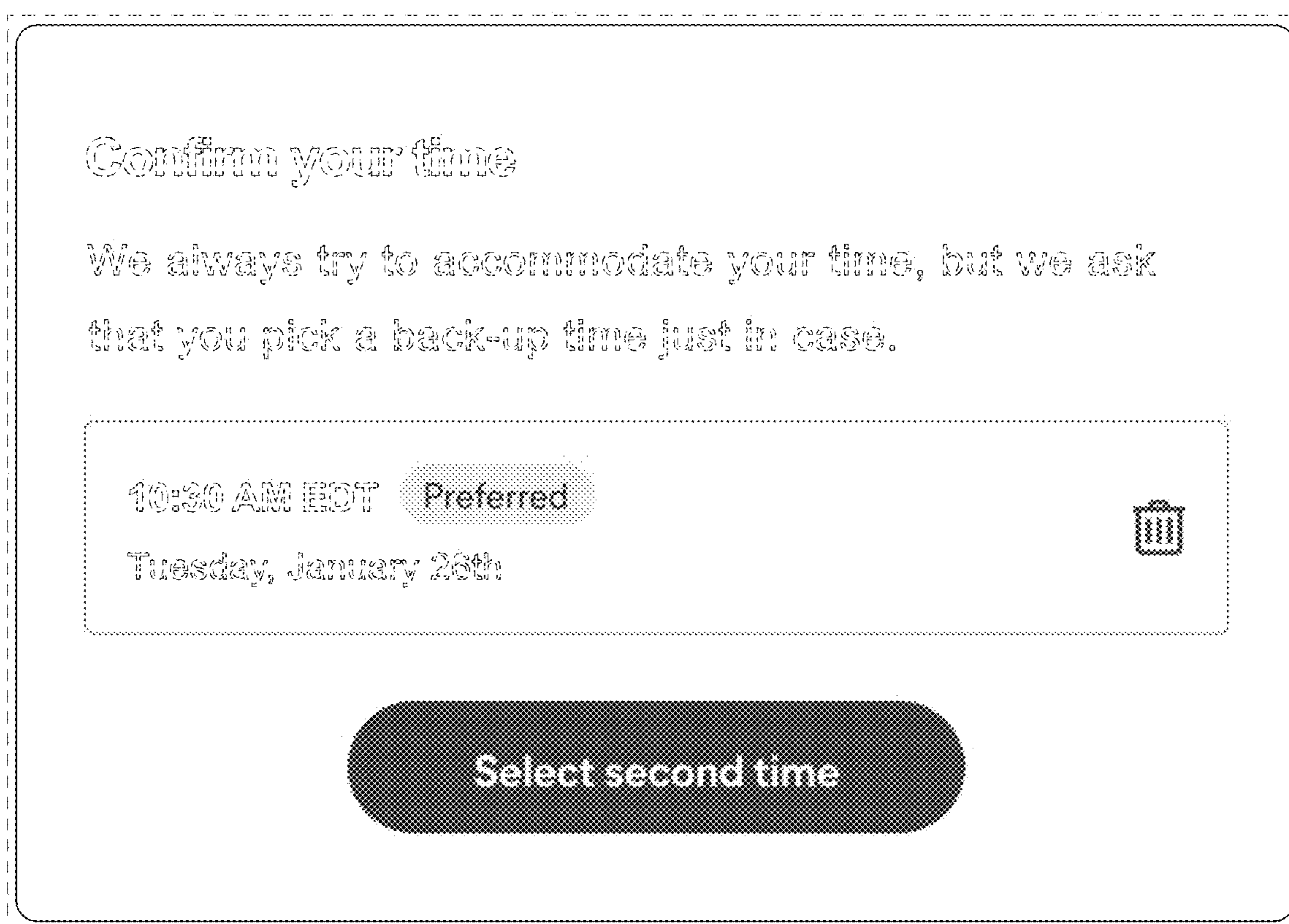

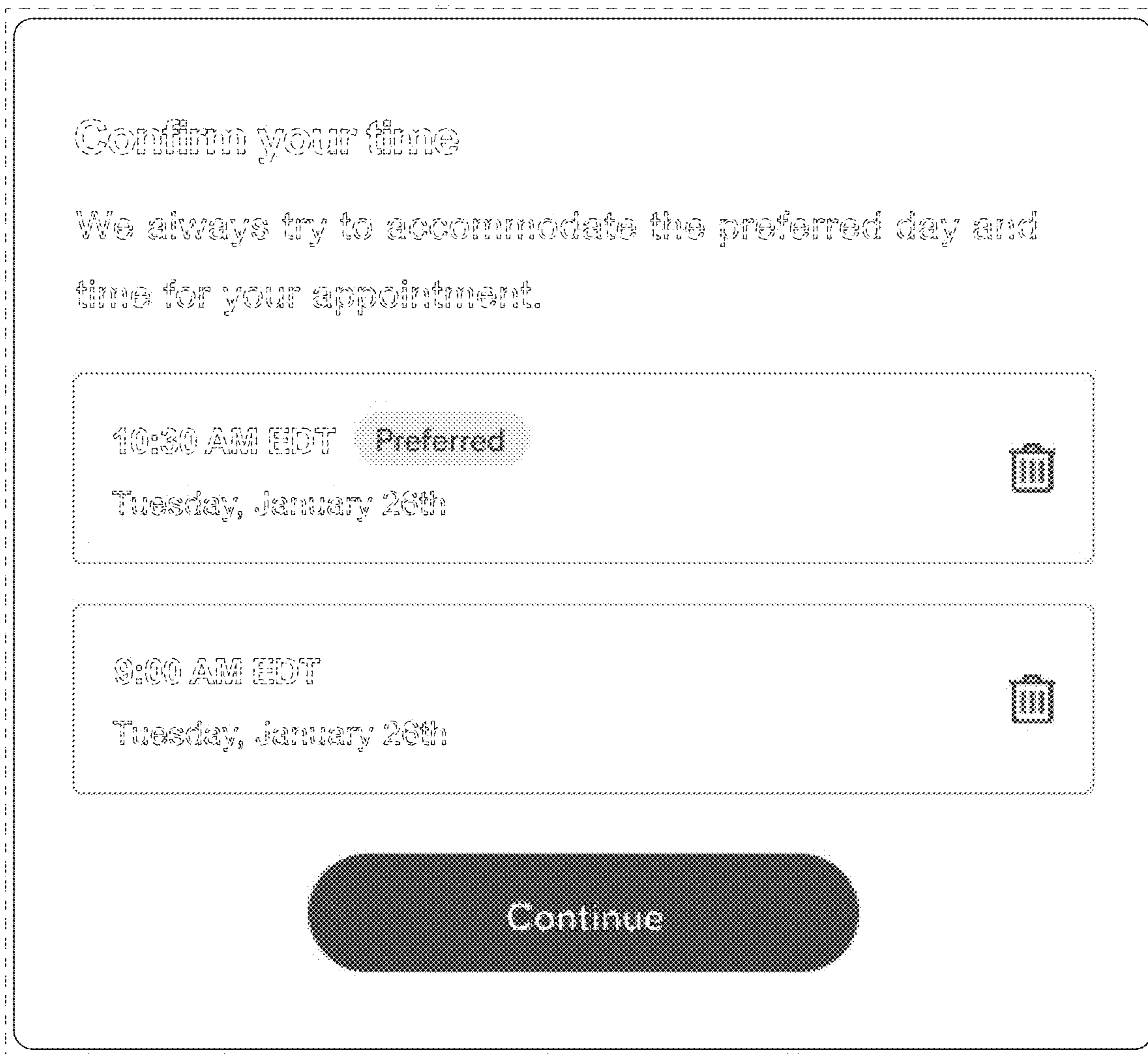

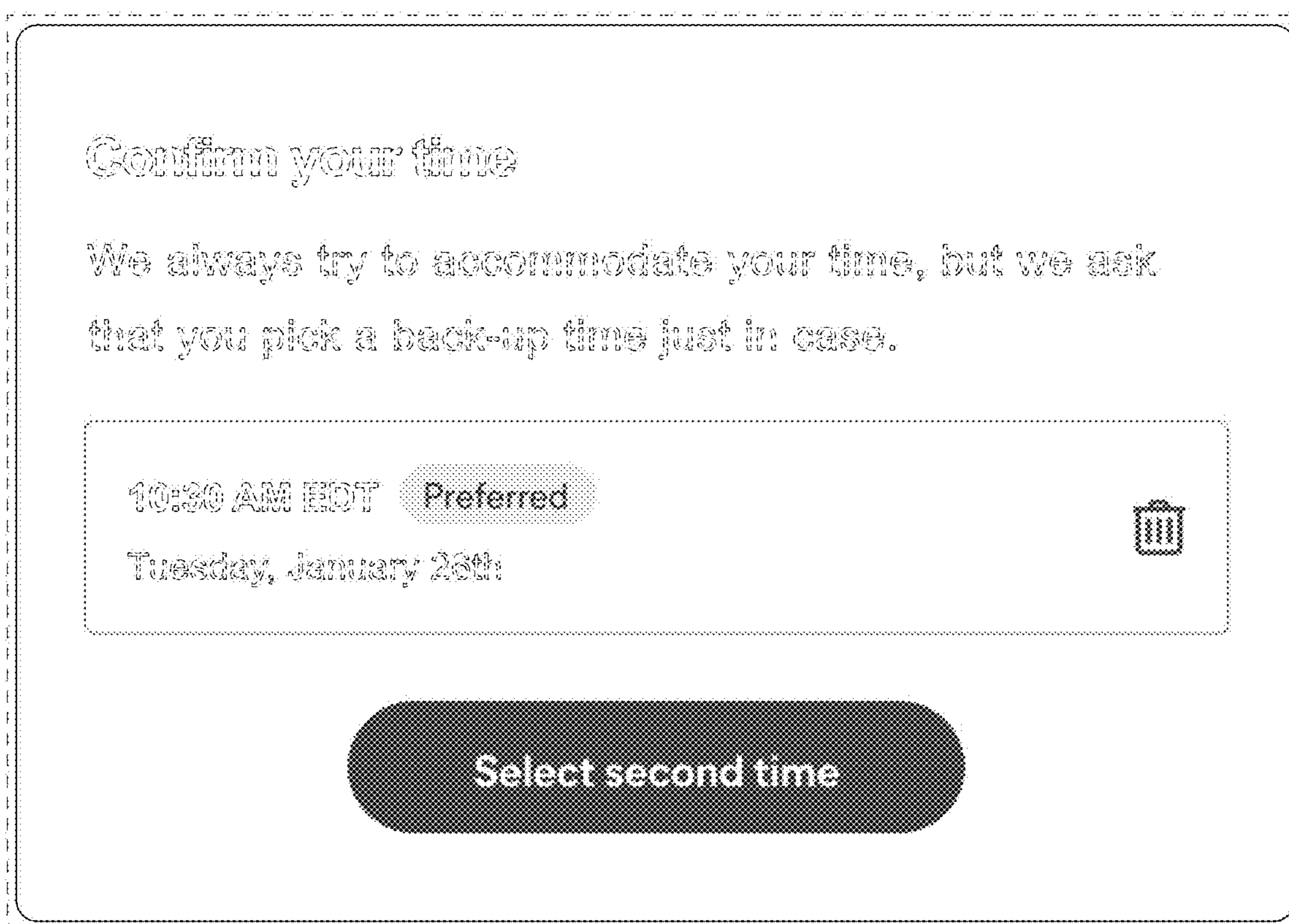

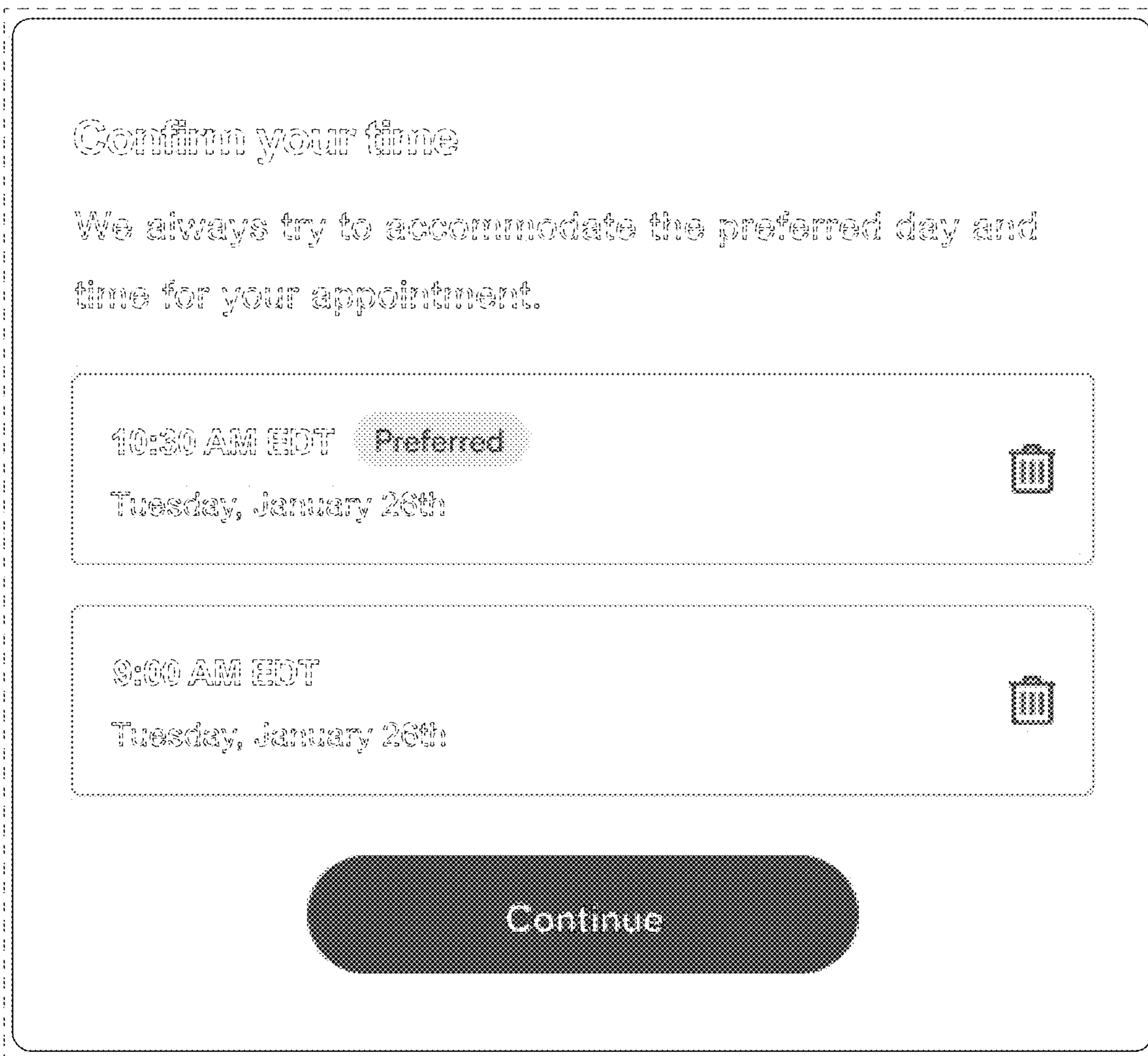

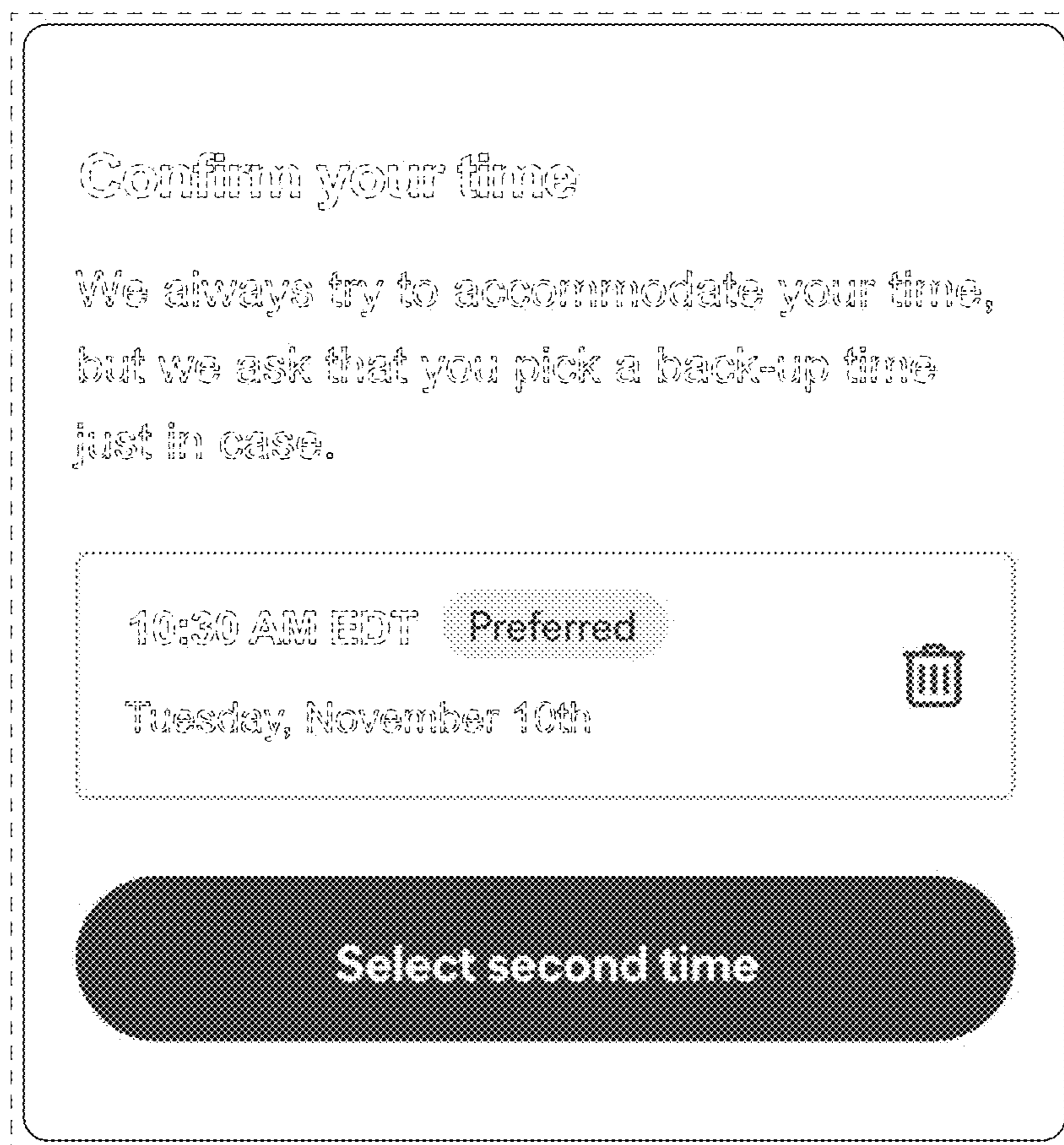

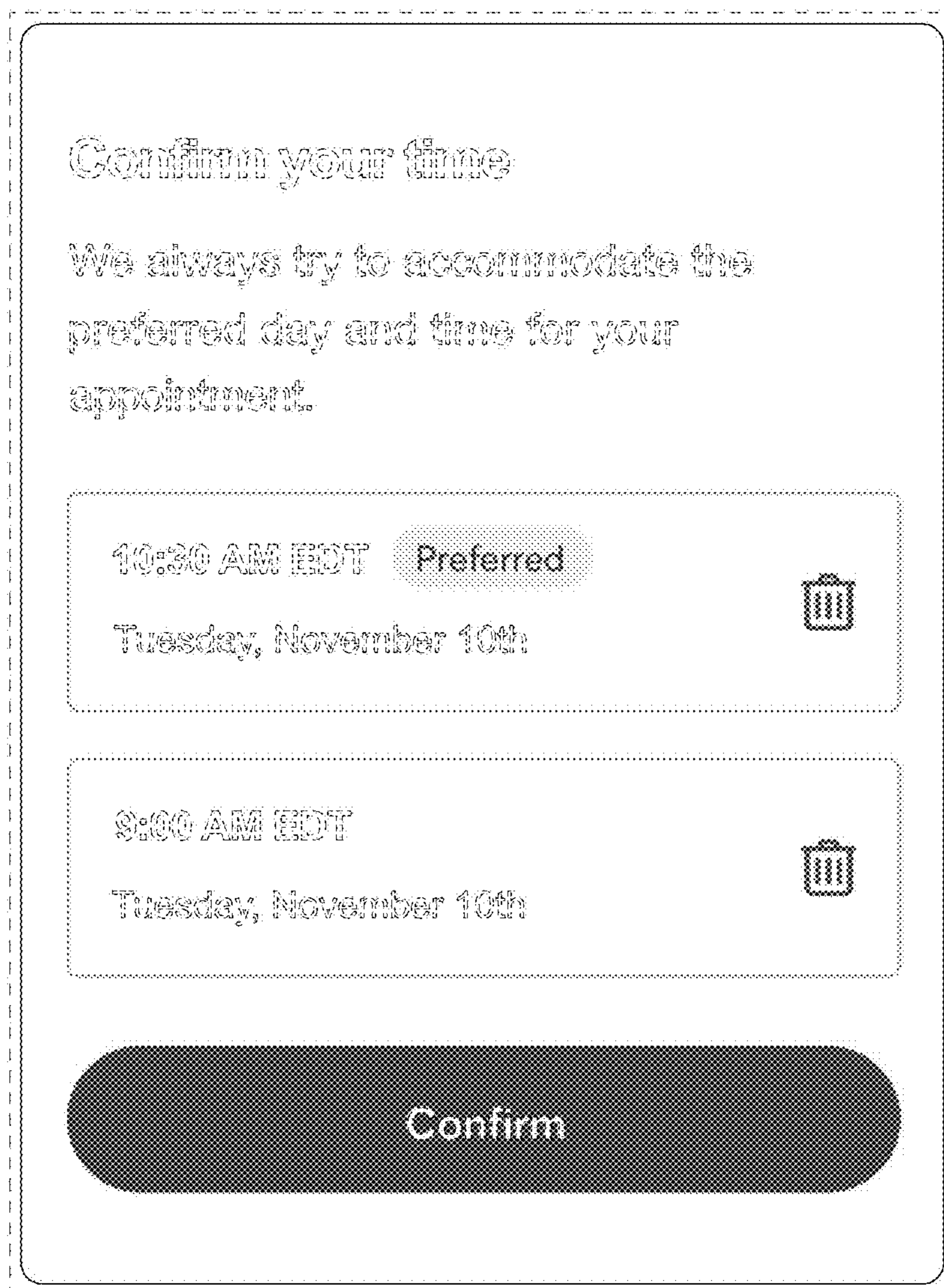

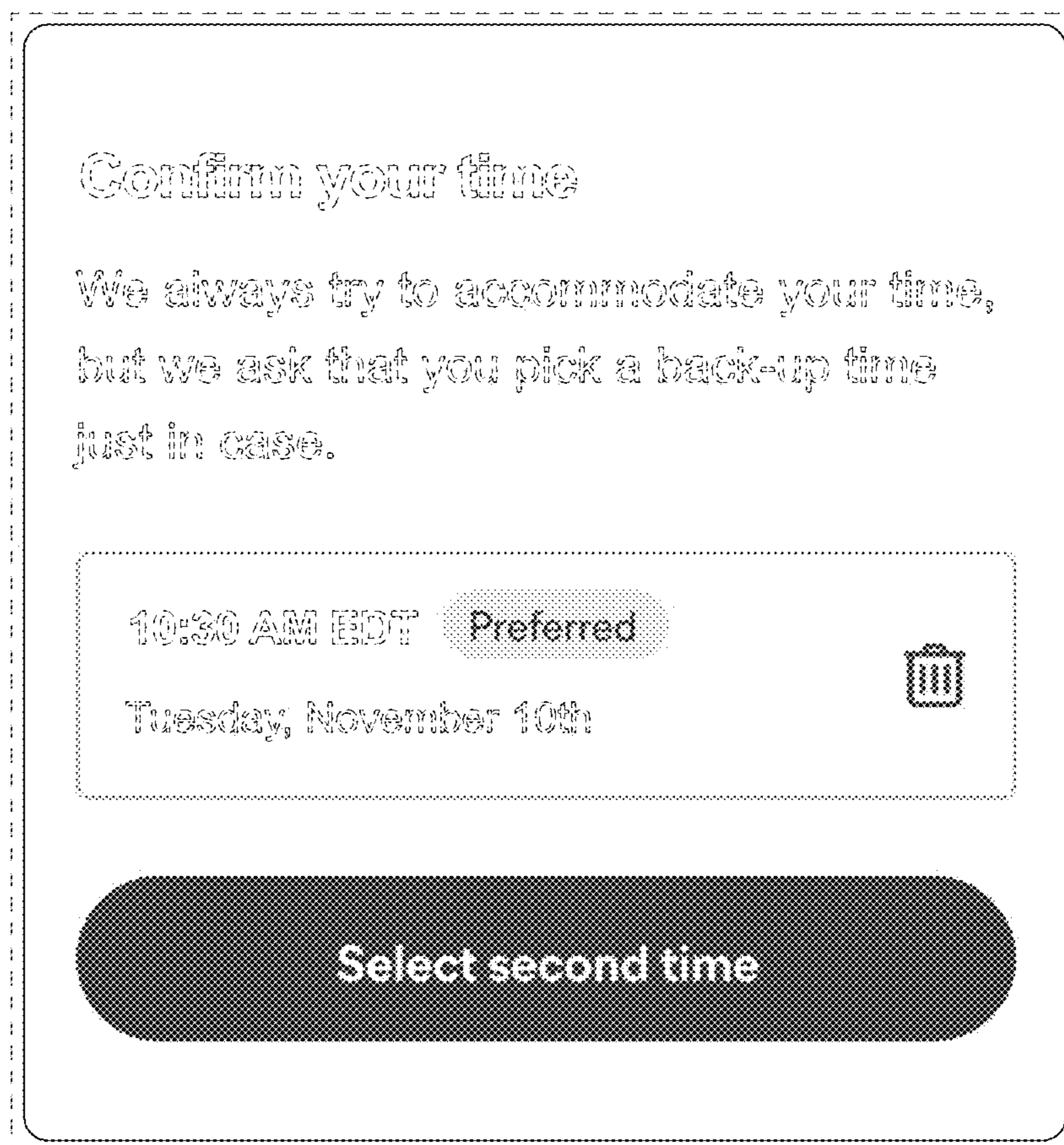

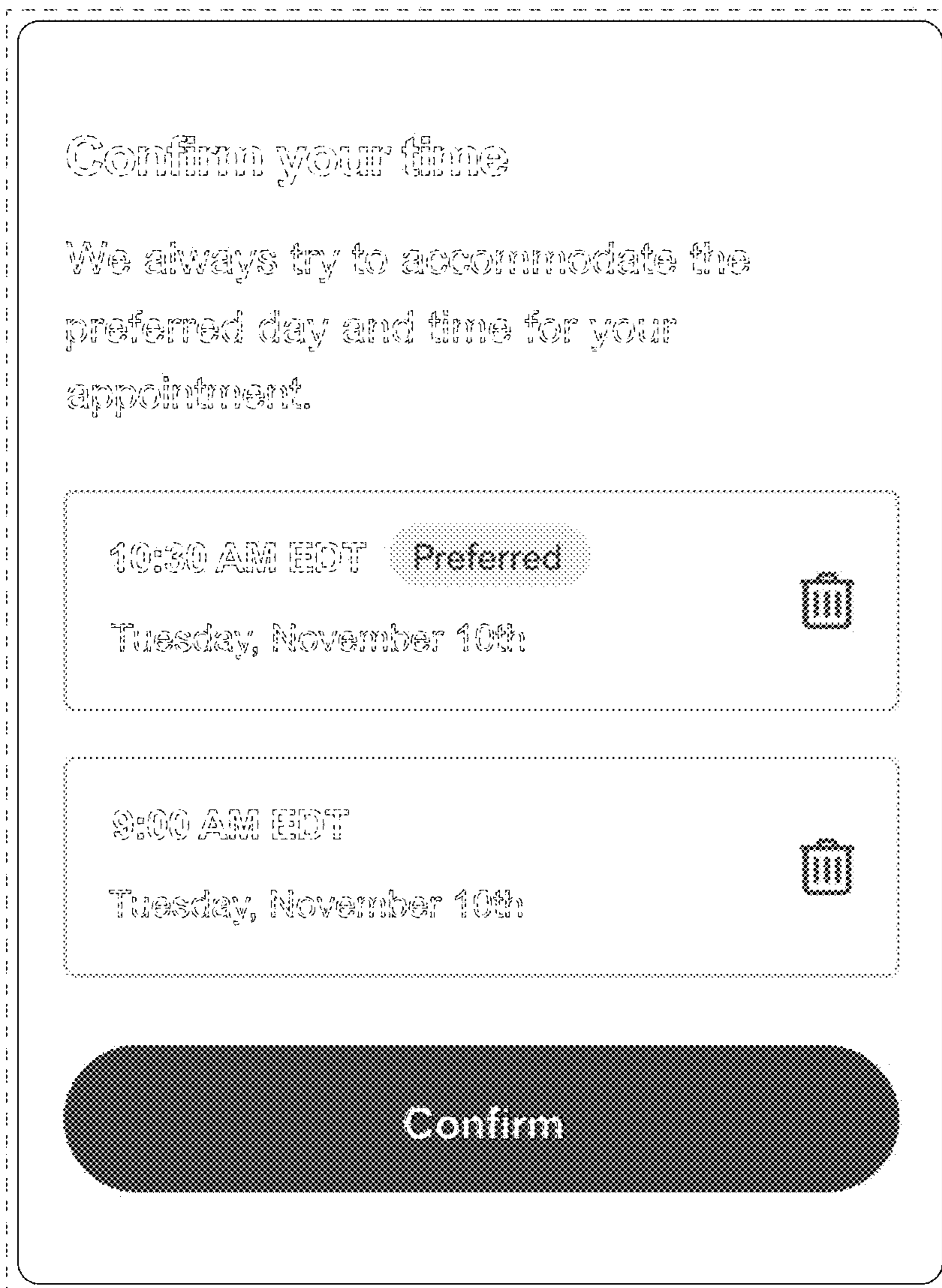
