**DESCRIPTION**

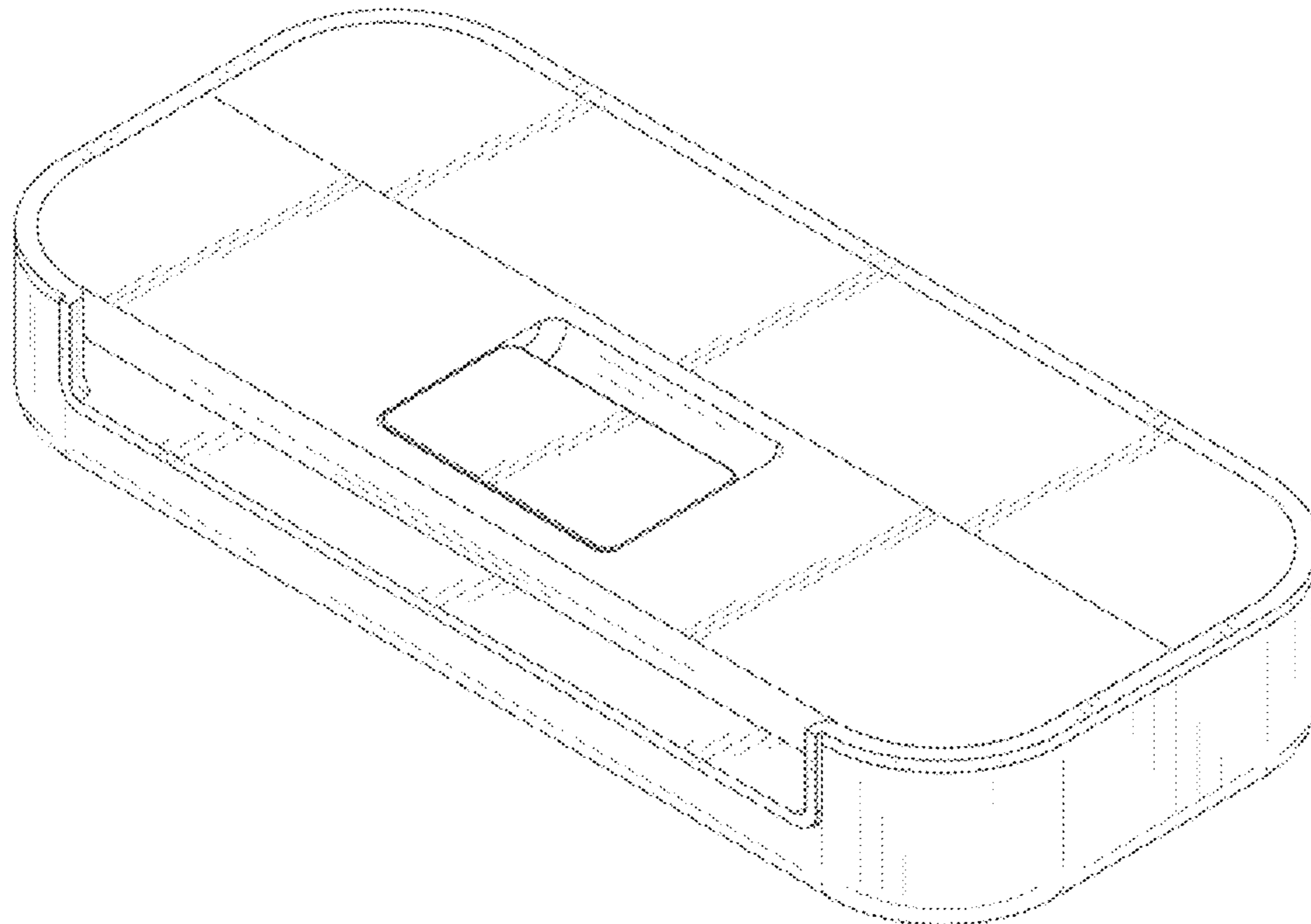
FIG. 1 is a front perspective view of a vacuum machine, showing my new design;

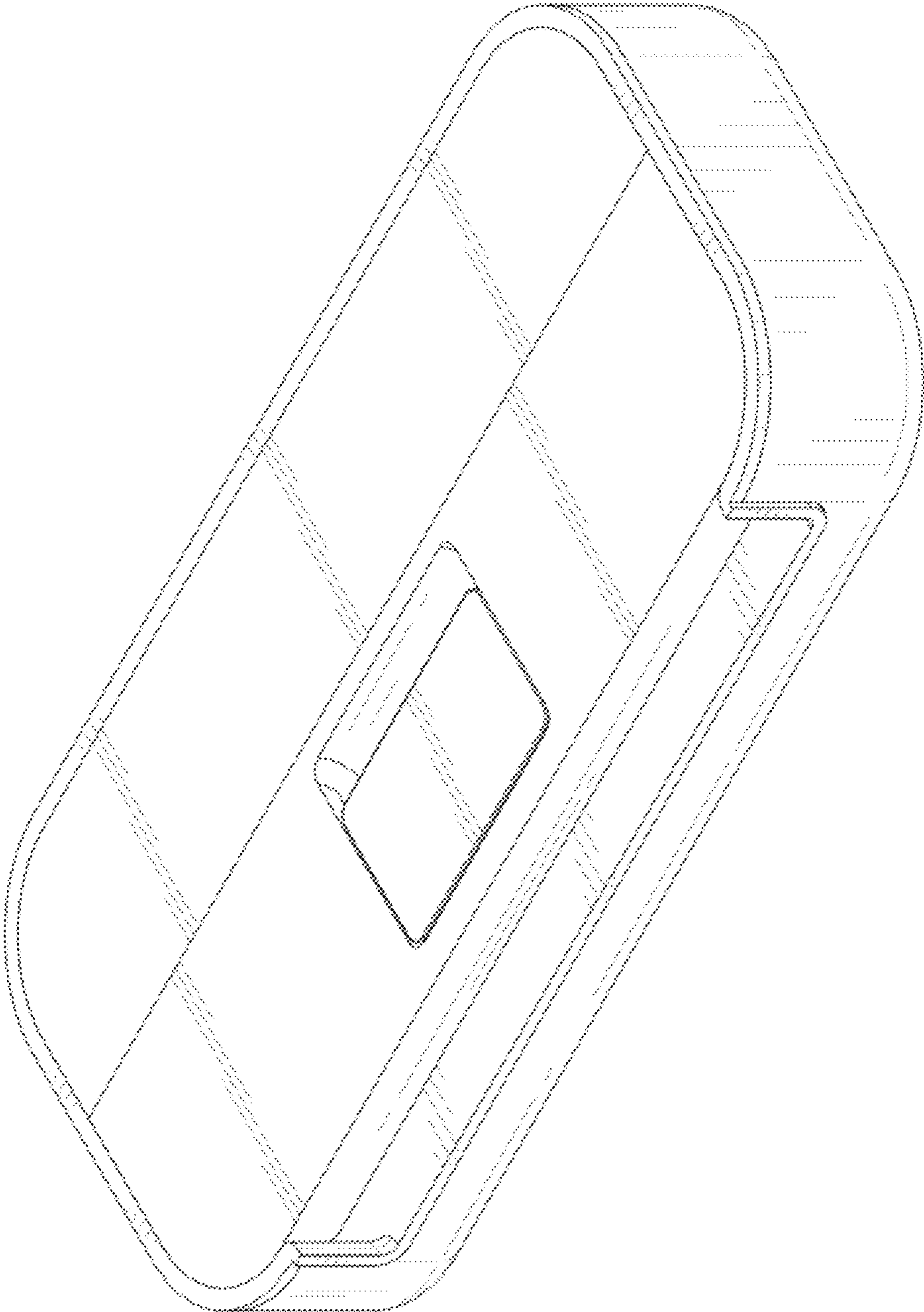
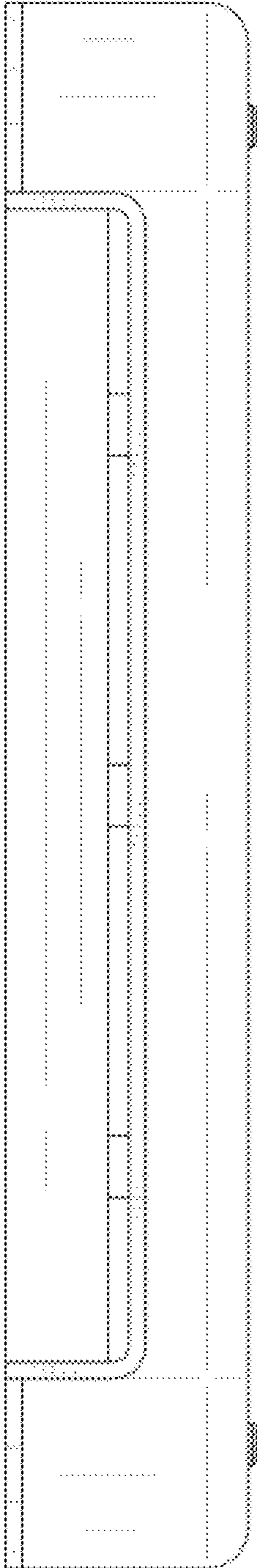

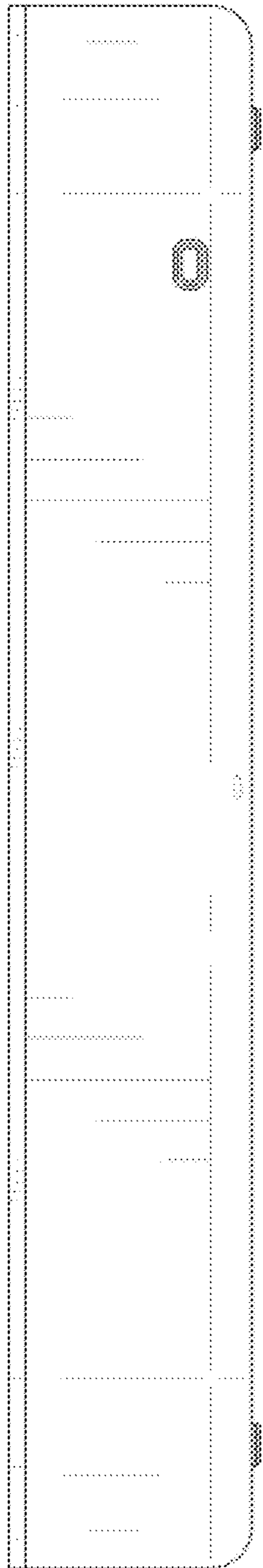

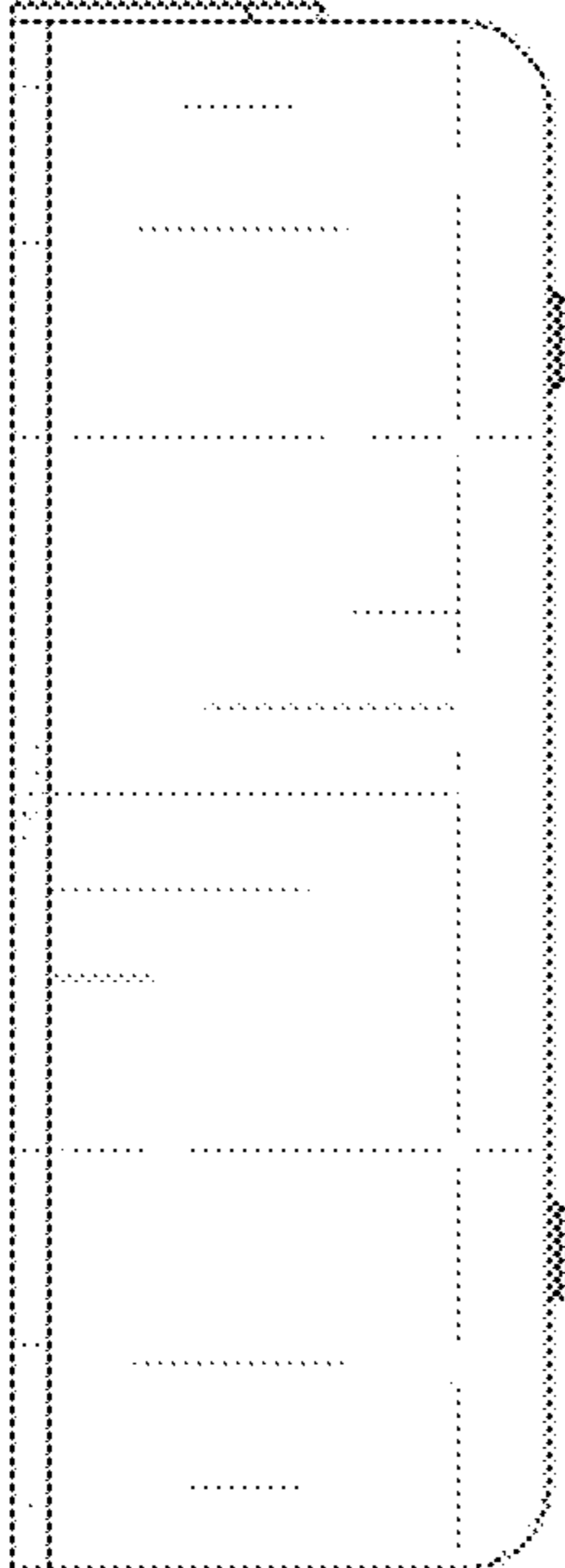

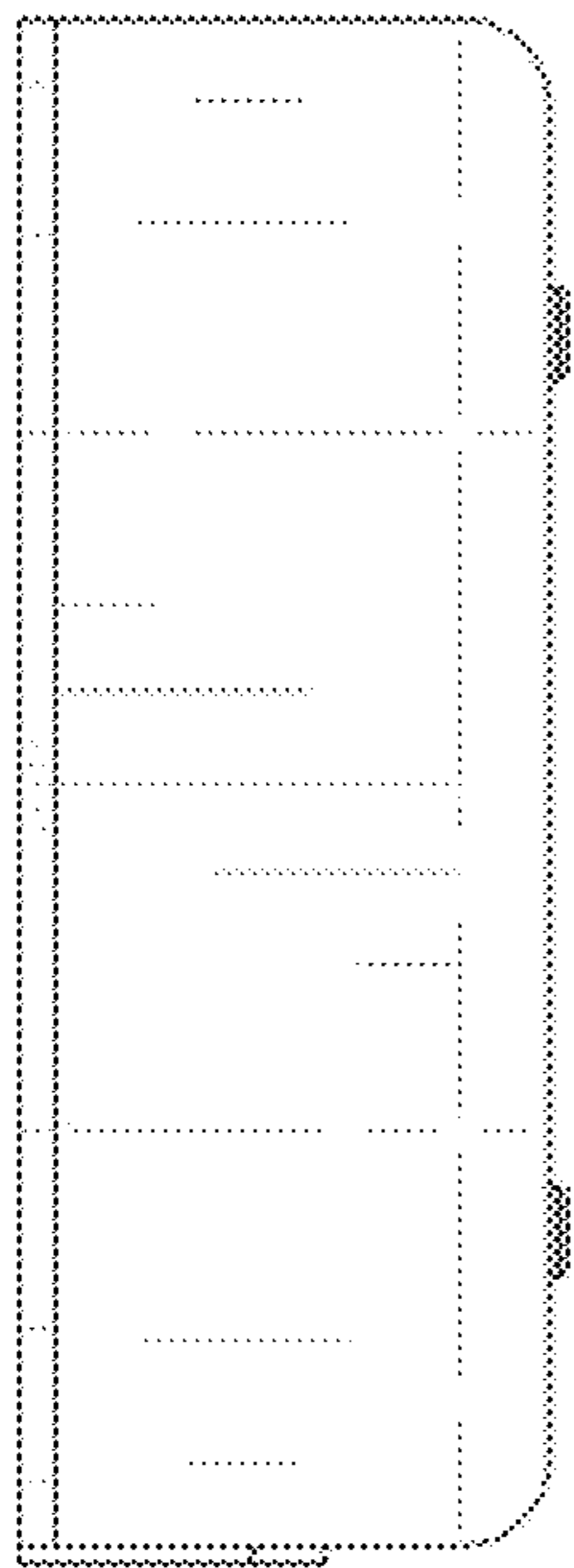

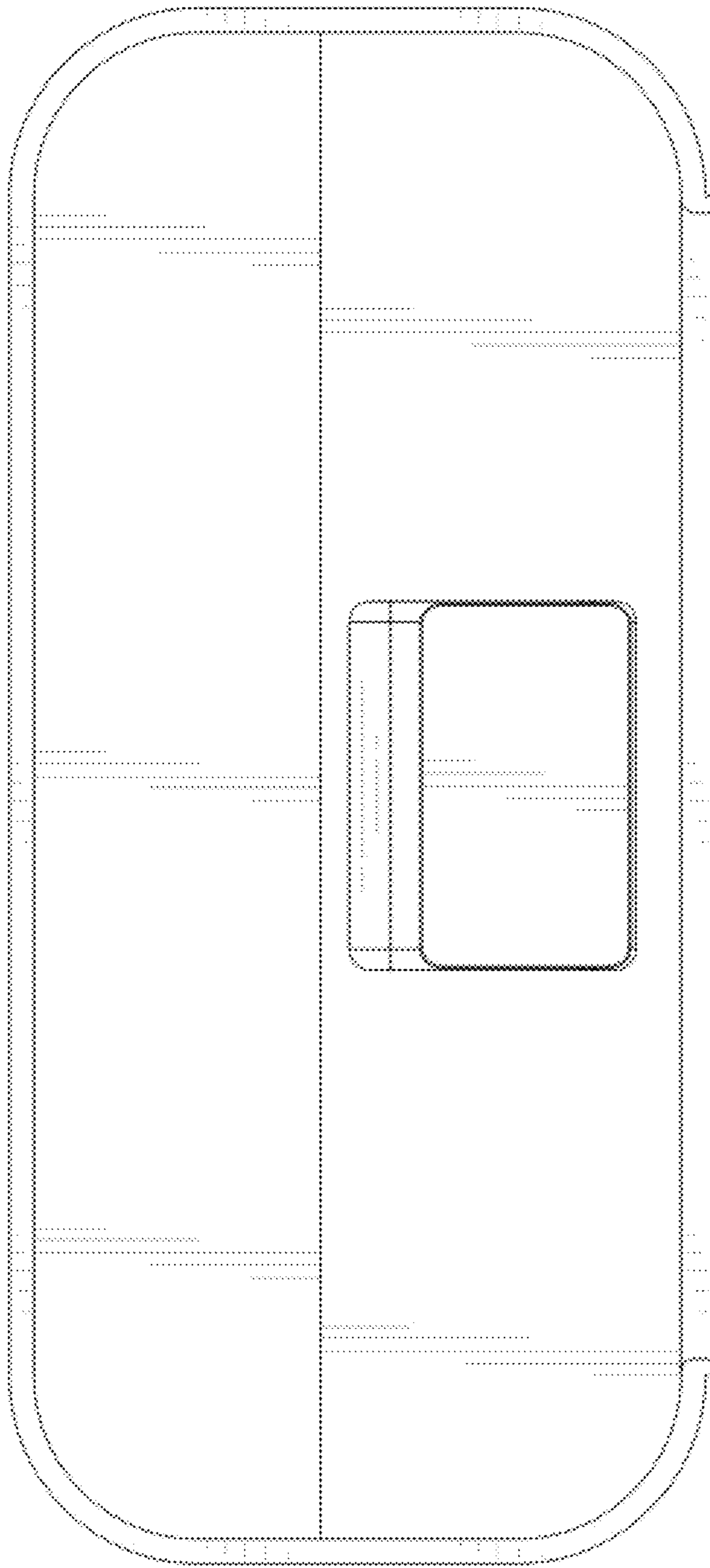

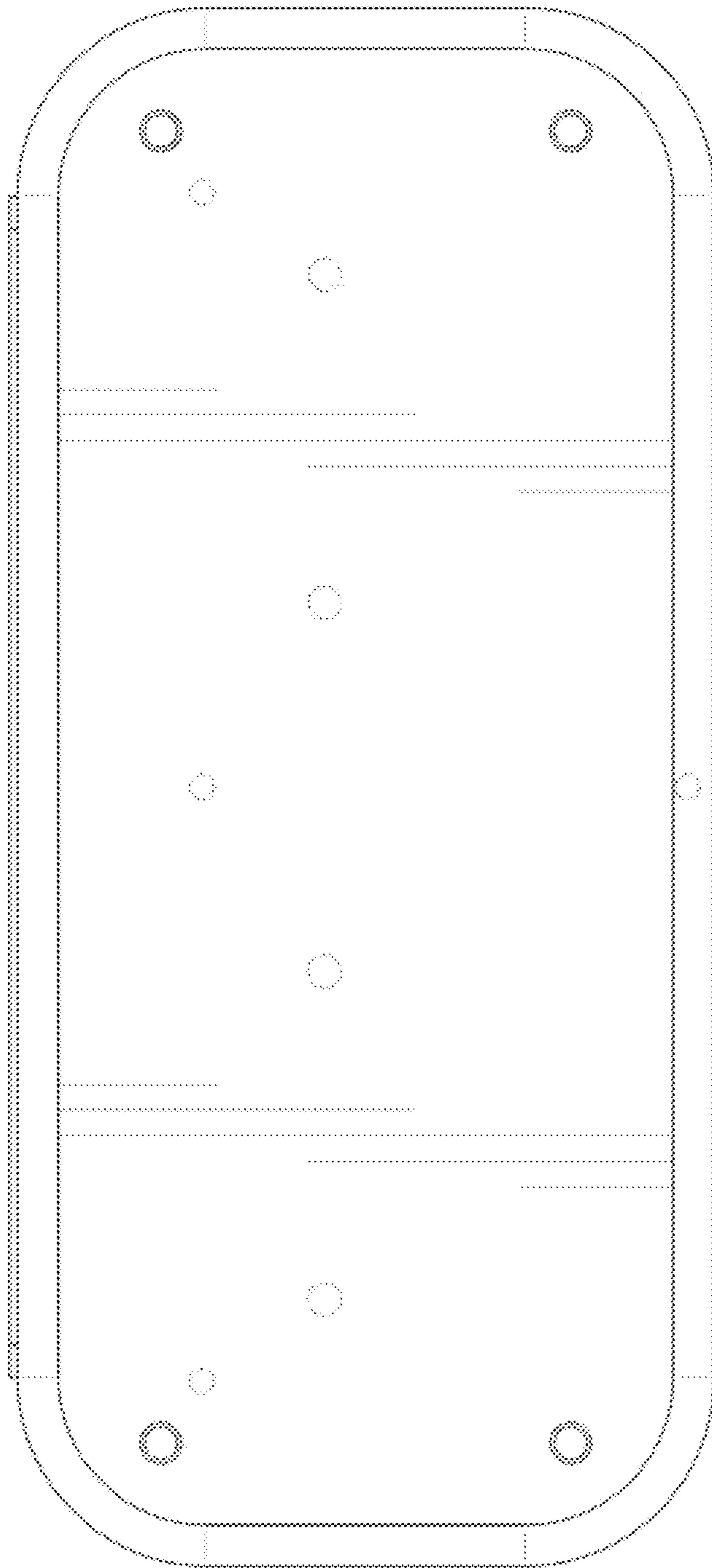
