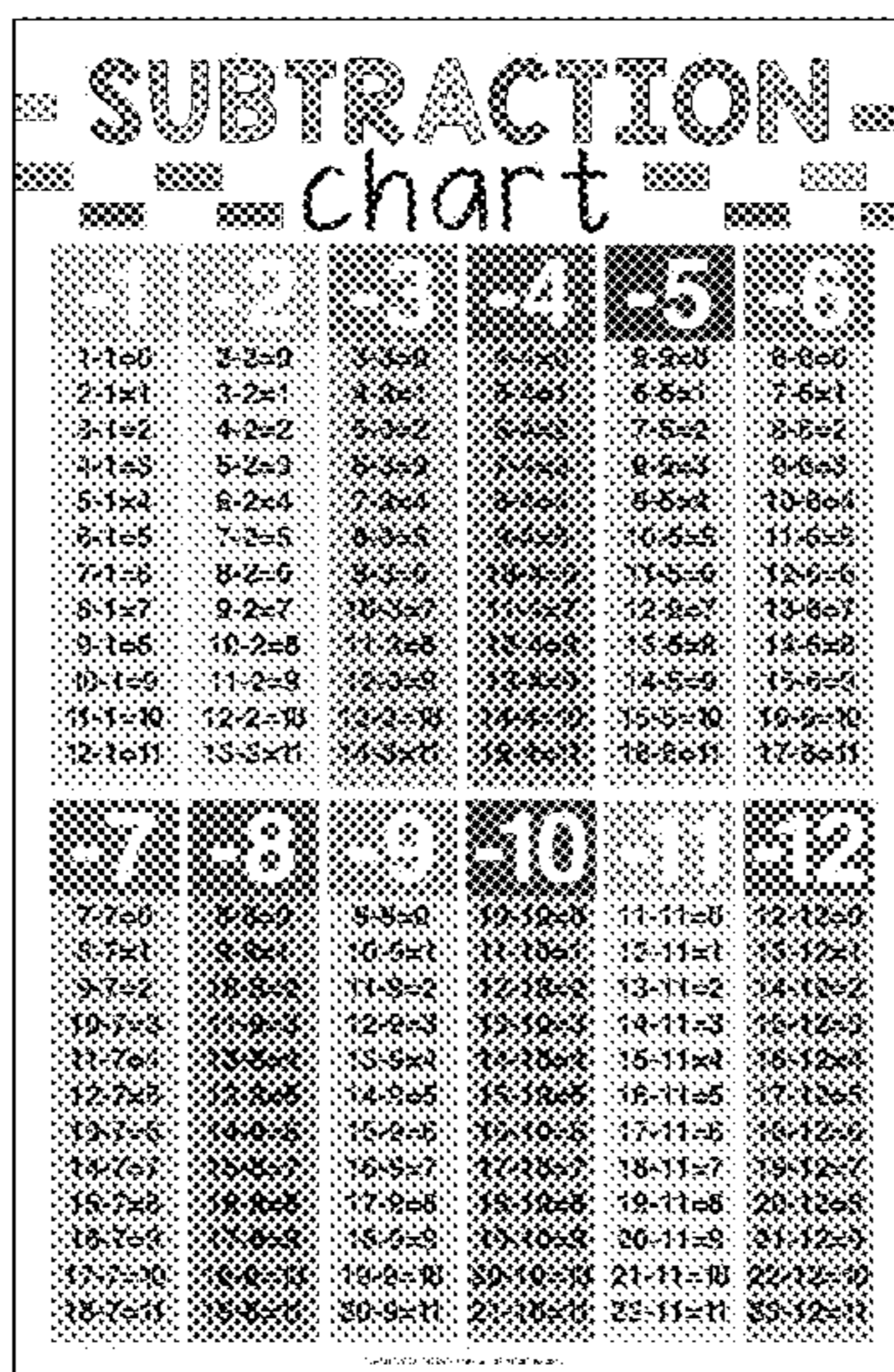
The ornamental design for an educational poster, as shown and described.
