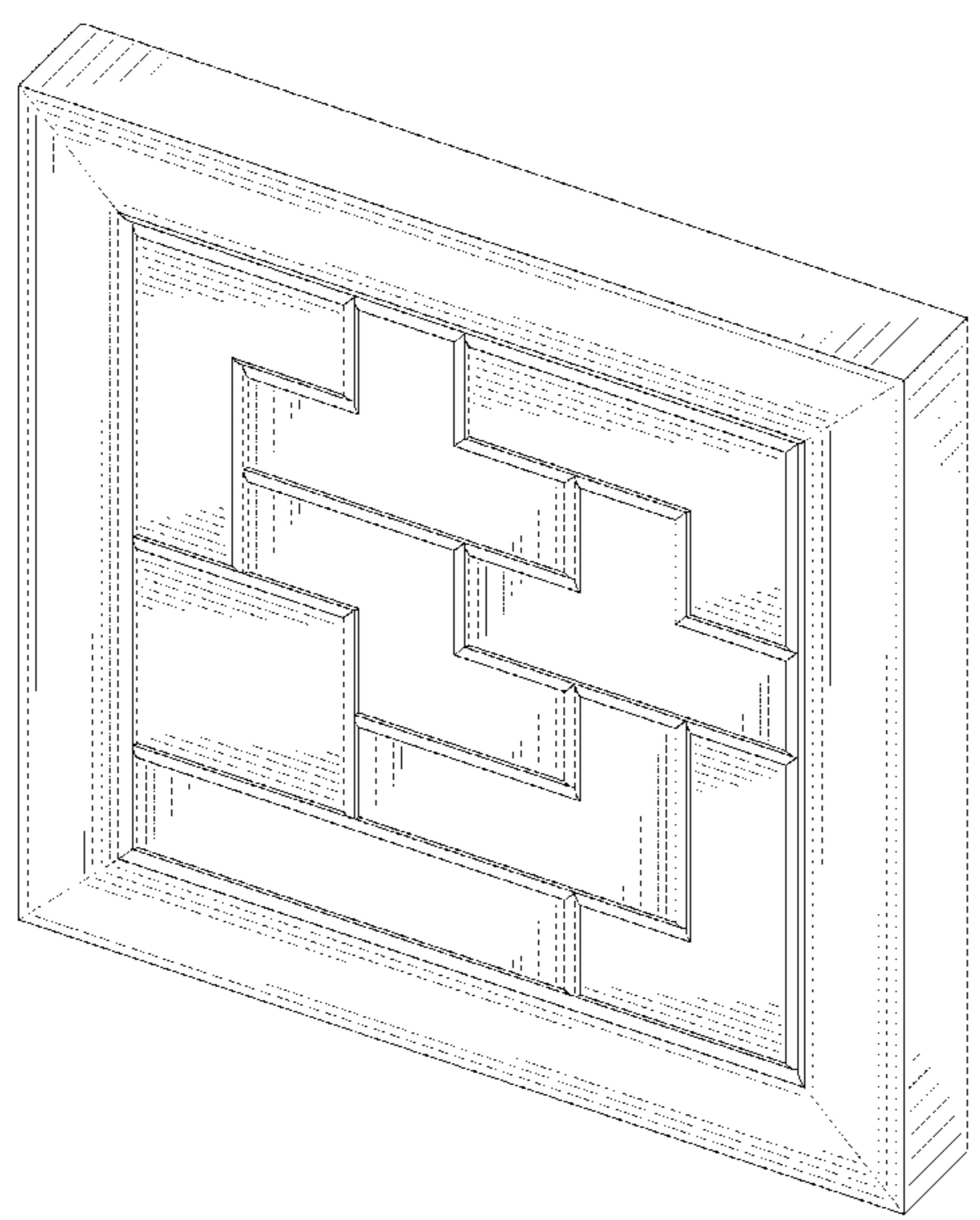
(57) **CLAIM**

The ornamental design for a puzzle toy, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a puzzle toy showing my new design;
FIG. 2 is rear perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a top plan view thereof; and,
FIG. 8 is a bottom plan view thereof.
The broken lines in FIGS. 1 and 3 depict details of the puzzle toy that form no part of the claimed design.

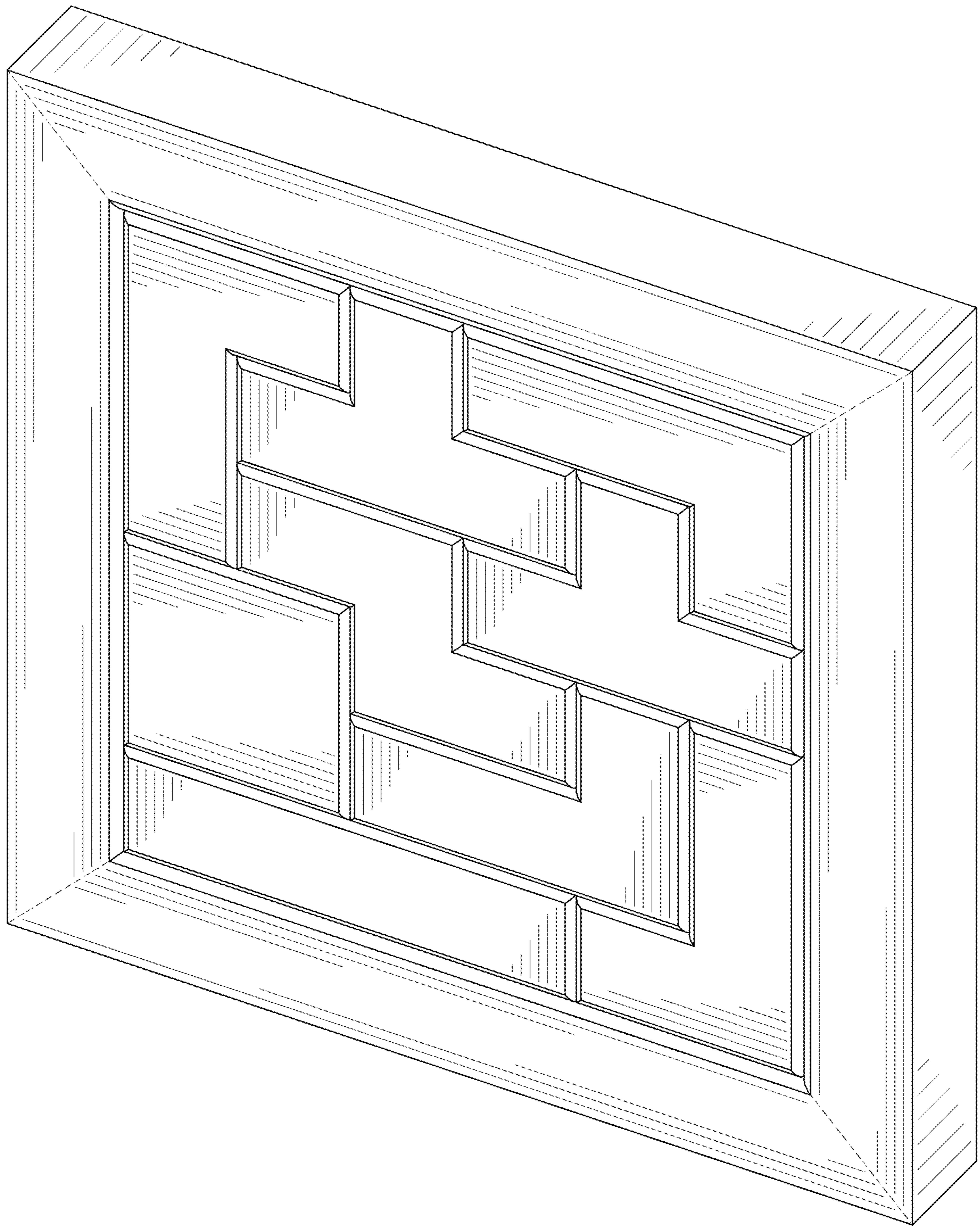

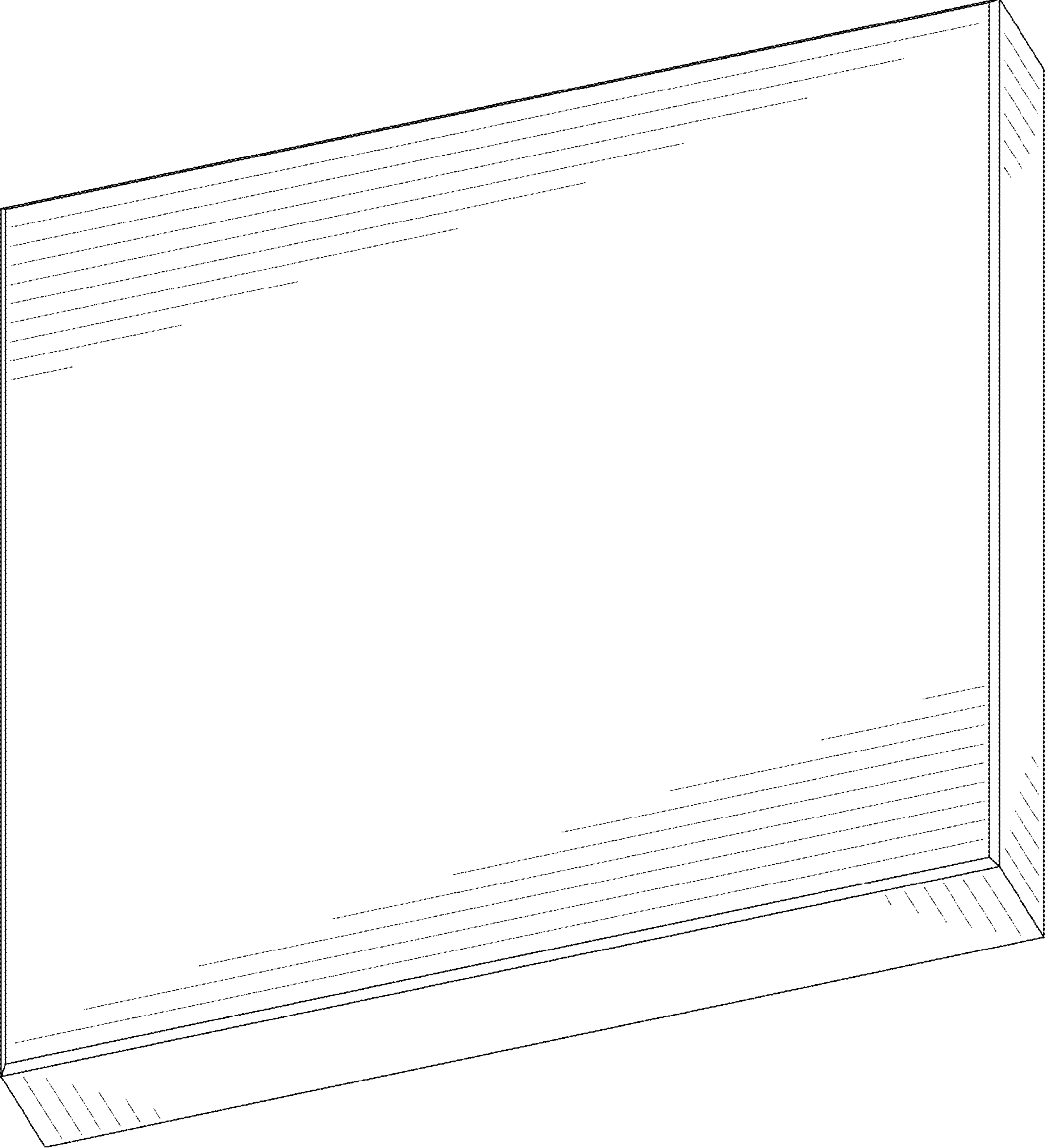

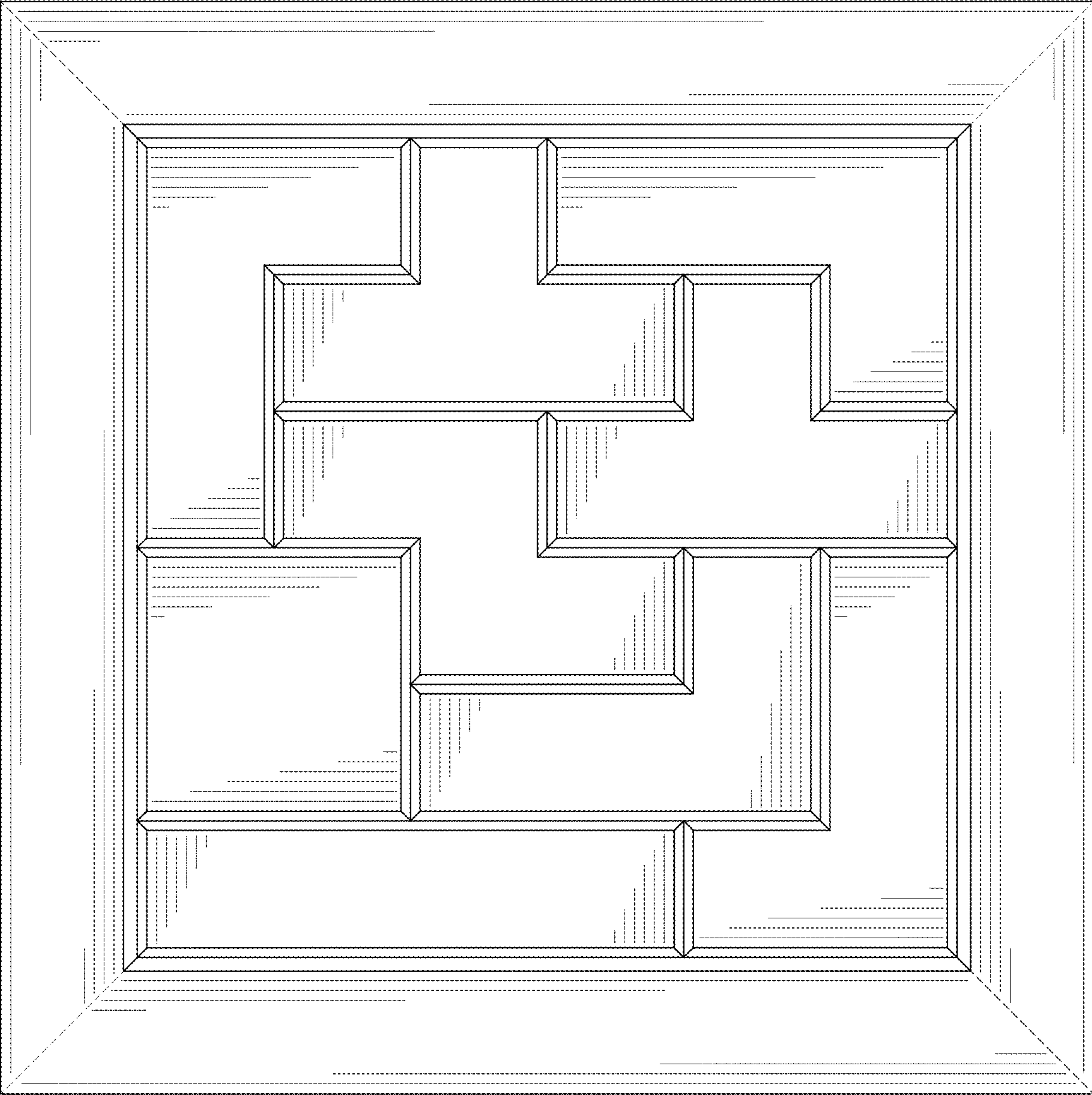

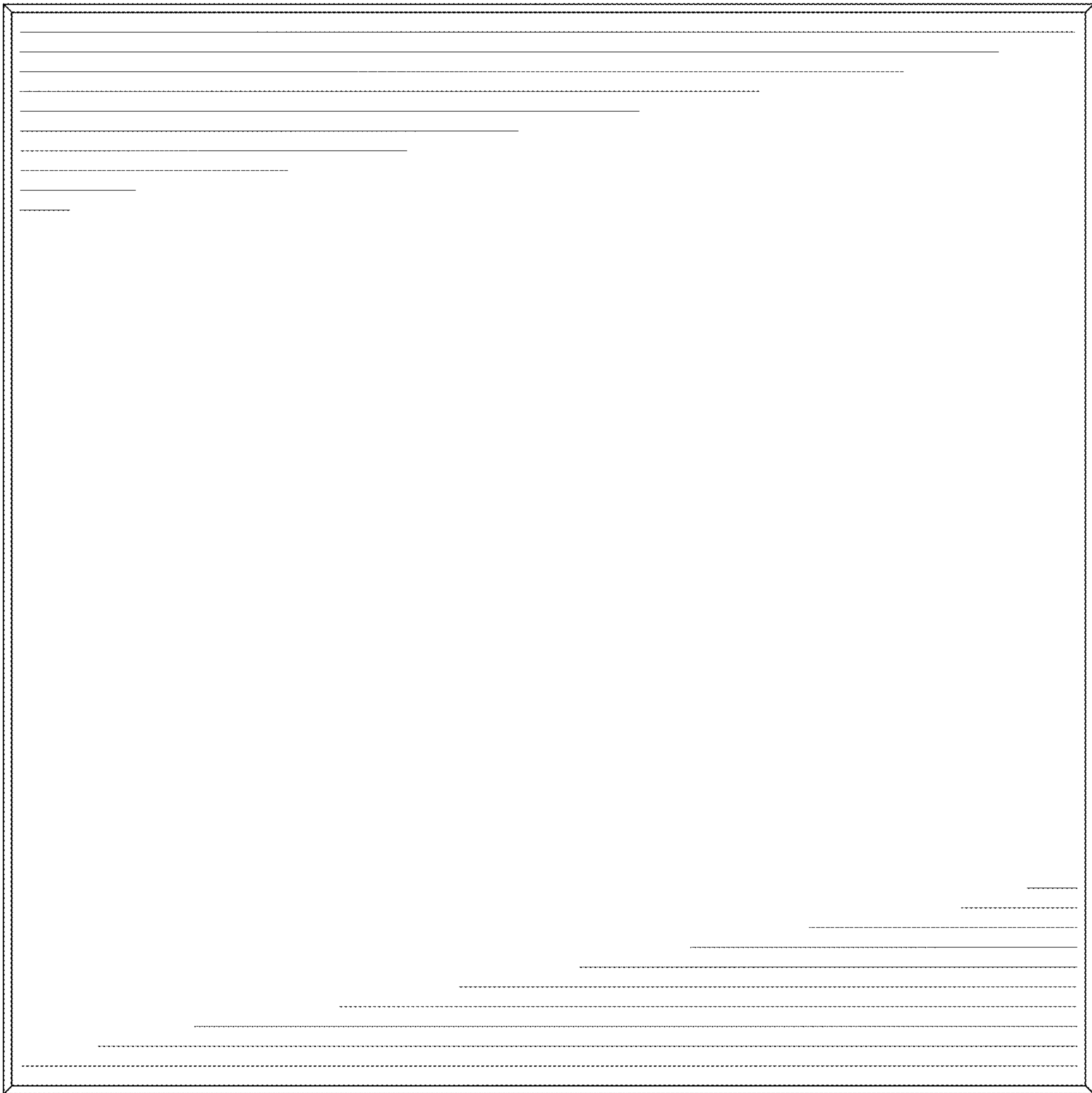

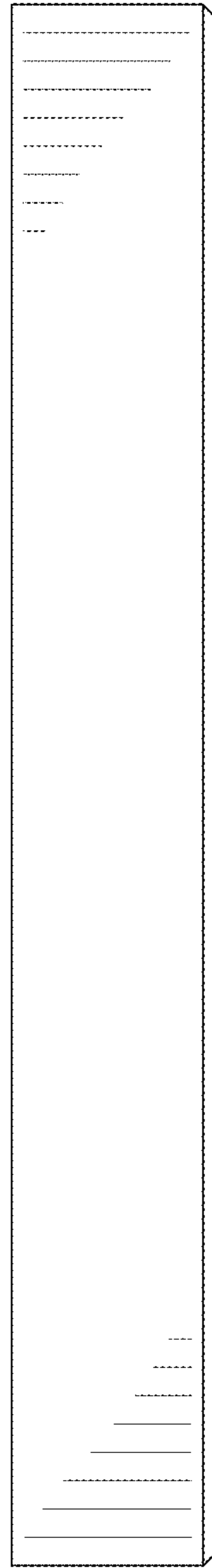

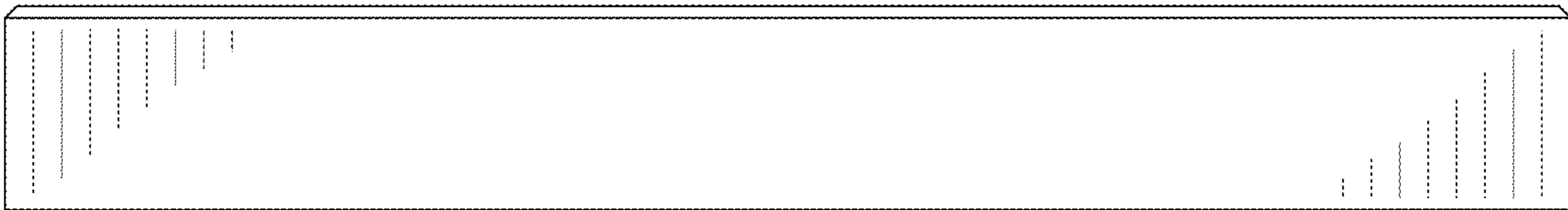

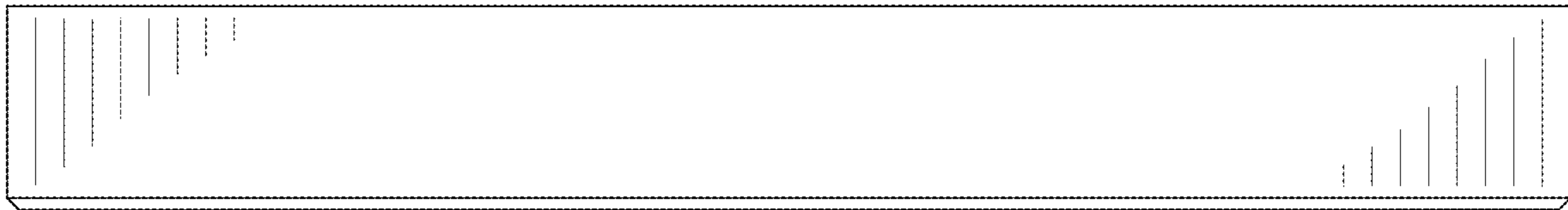
