The broken lines in FIGS. 8 and 9 depict environmental structures of an ice skate and form no part of the claimed invention.

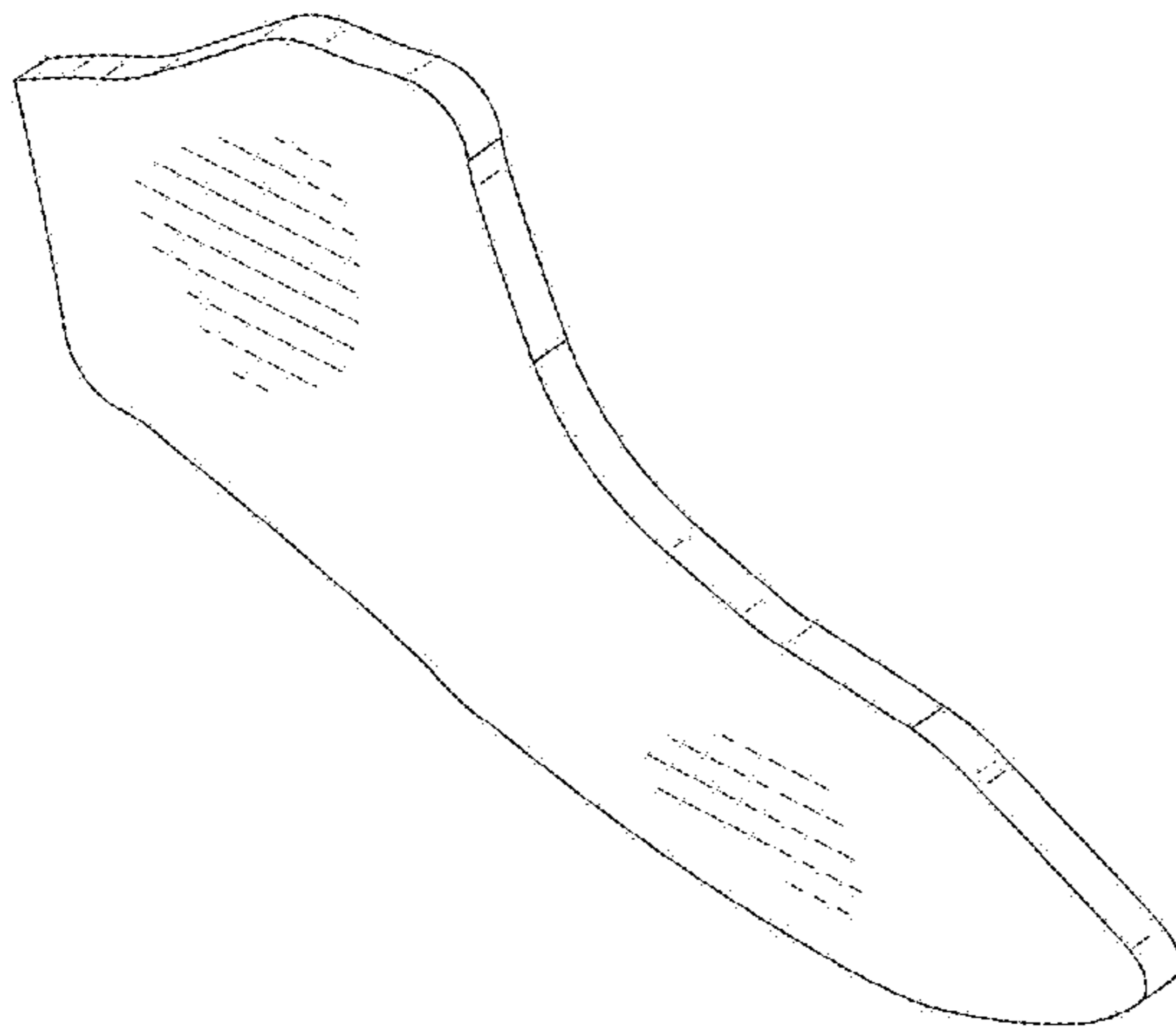

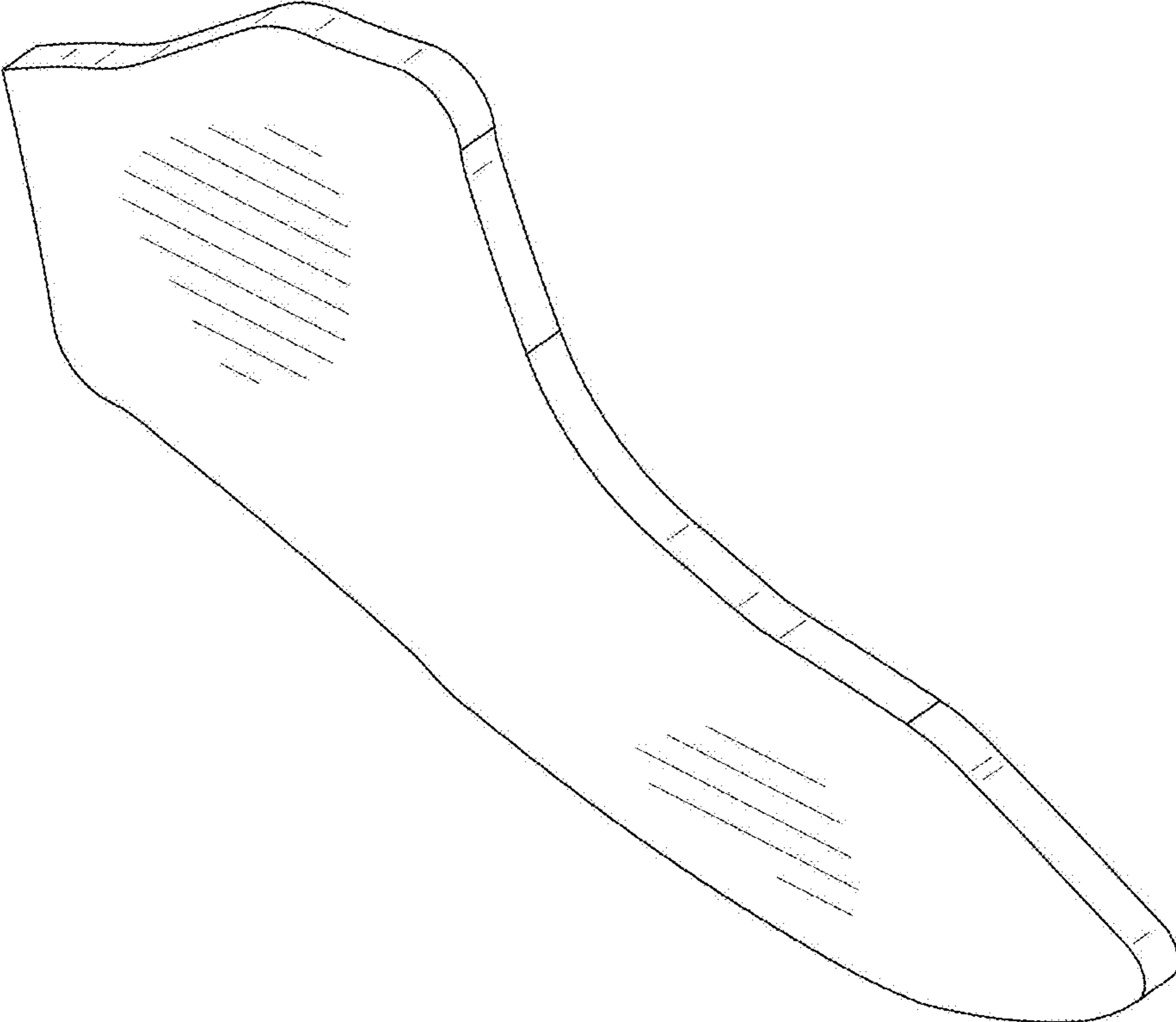

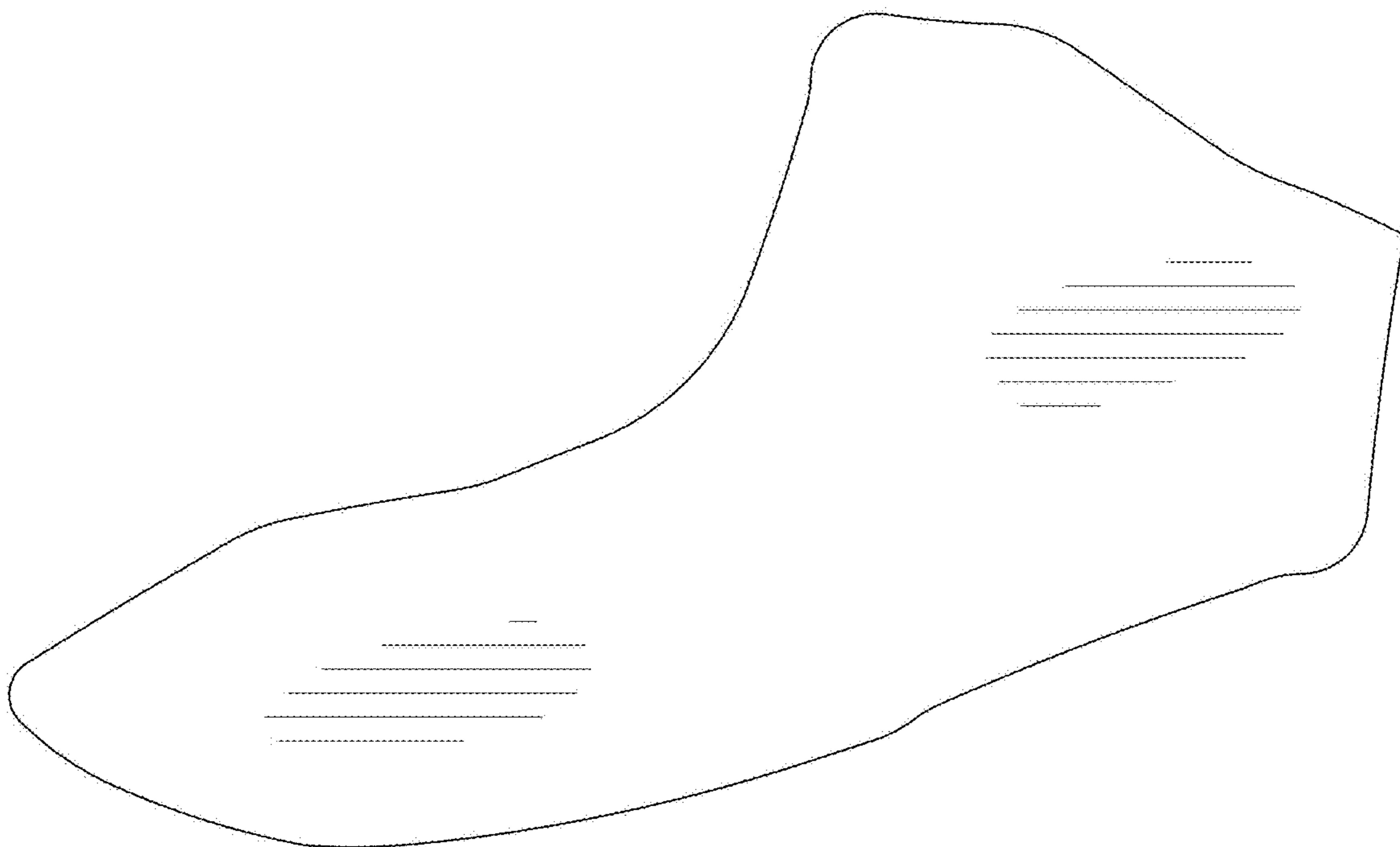

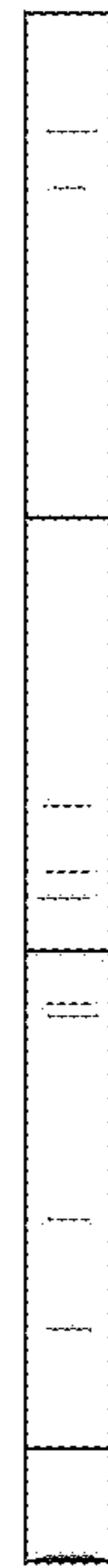

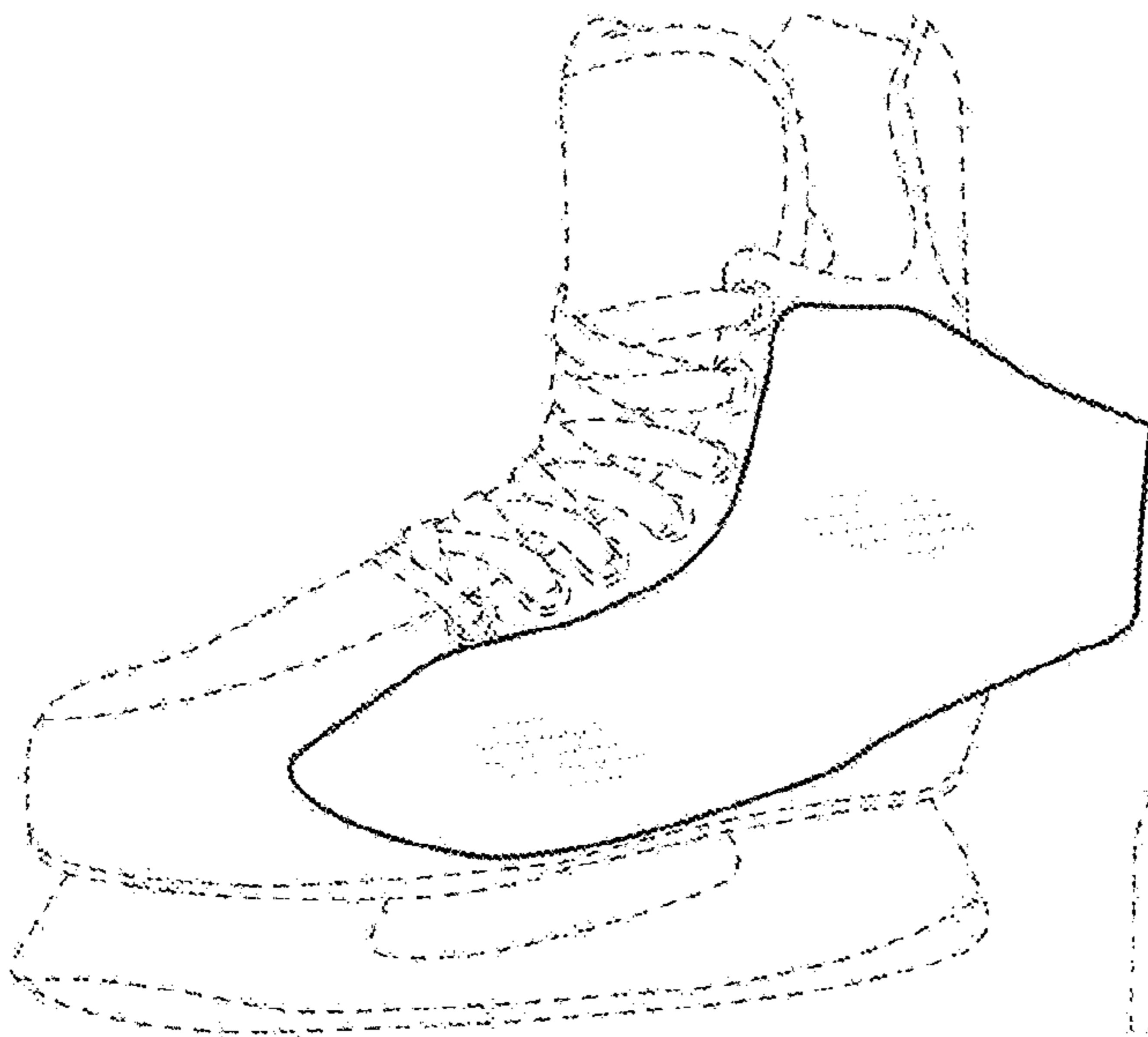

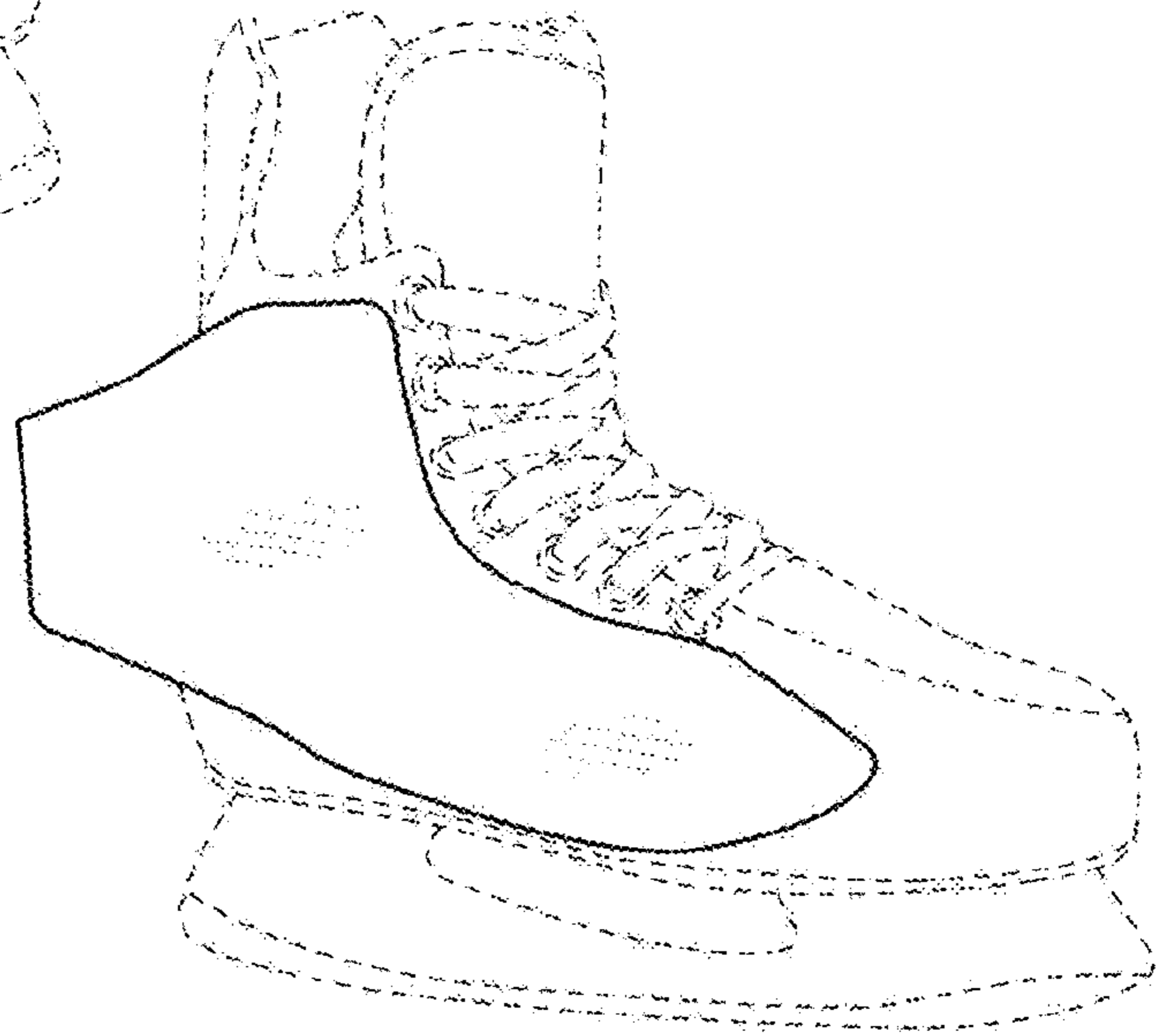
