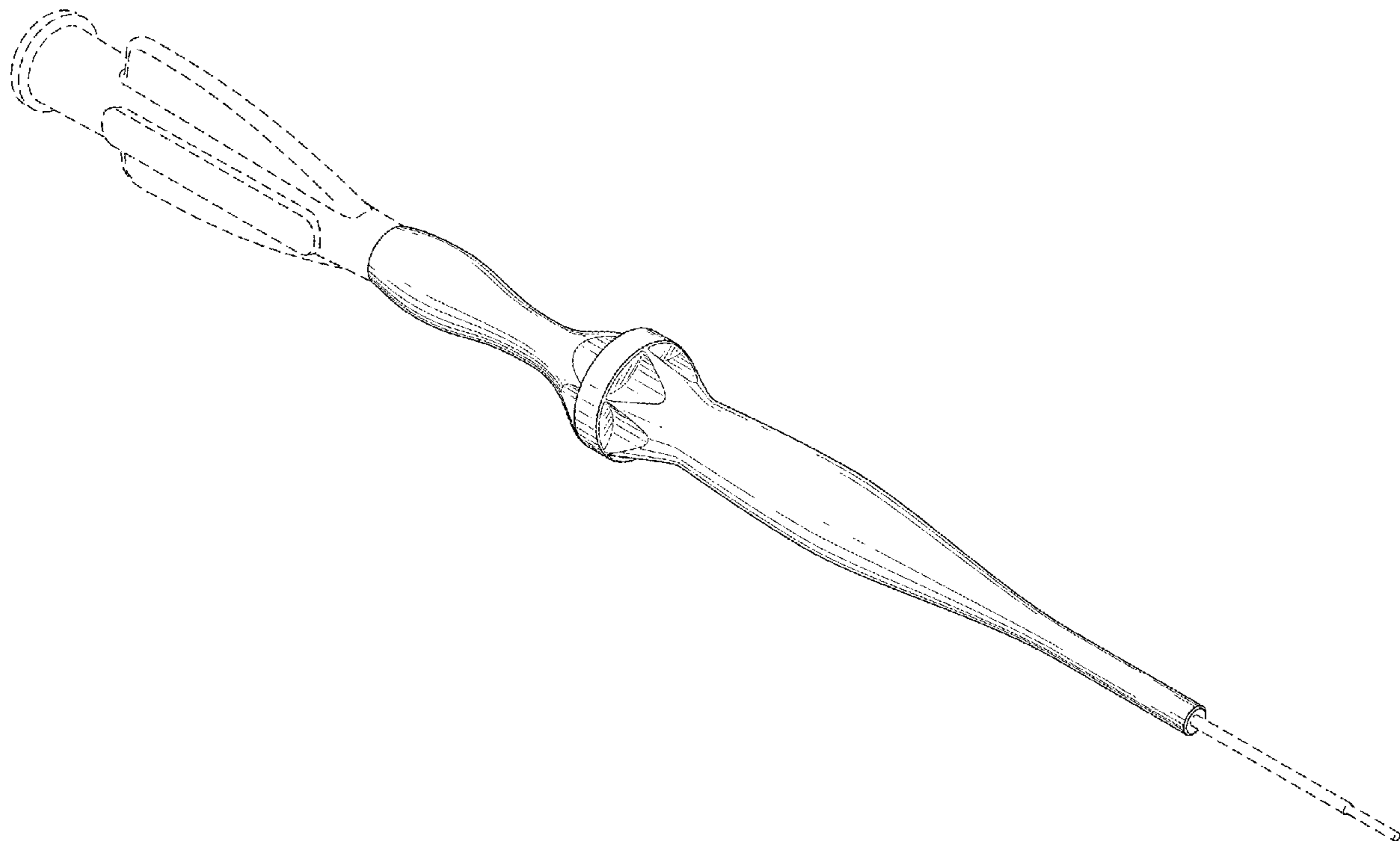
(57) **CLAIM**

The ornamental design of a strain relief for torqueing, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a strain relief for torqueing in accordance with the present invention;  
FIG. 2 is a front view thereof or a rear view thereof;  
FIG. 3 is a left side view thereof, or a right side view thereof;  
FIG. 4 is top view thereof; and,  
FIG. 5 is a bottom view thereof.  
The broken lines in the drawings represent portions of the strain relief for torqueing that form no part of the claimed design.

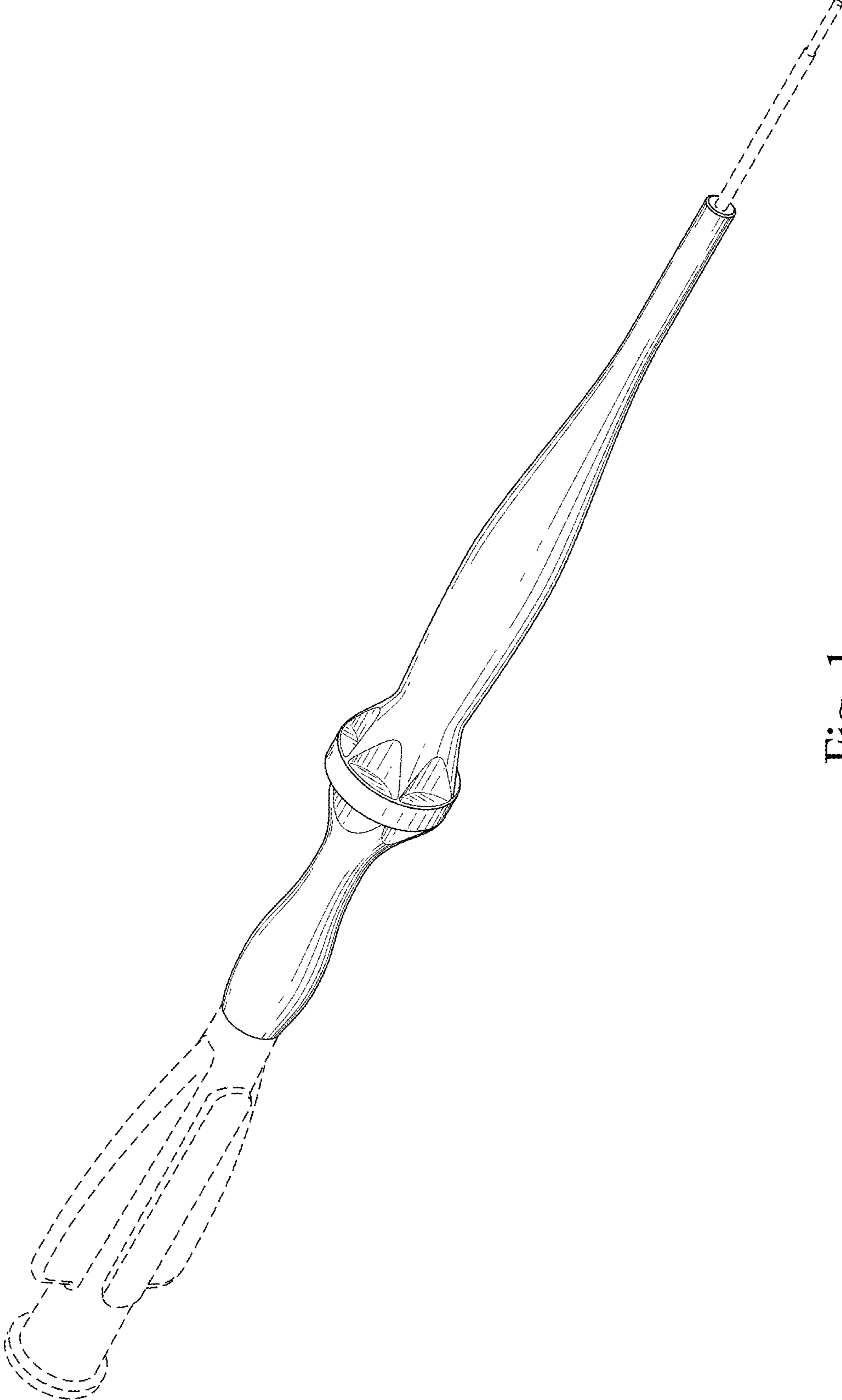

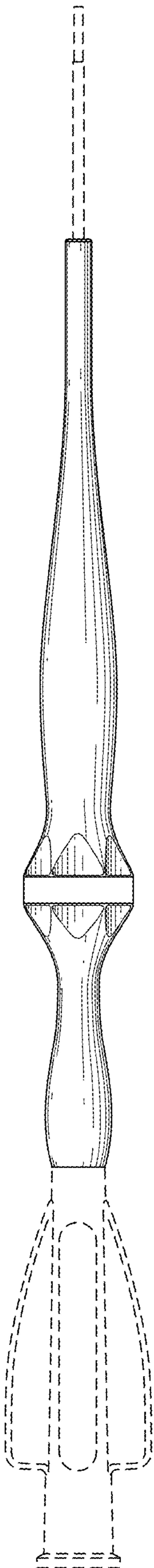

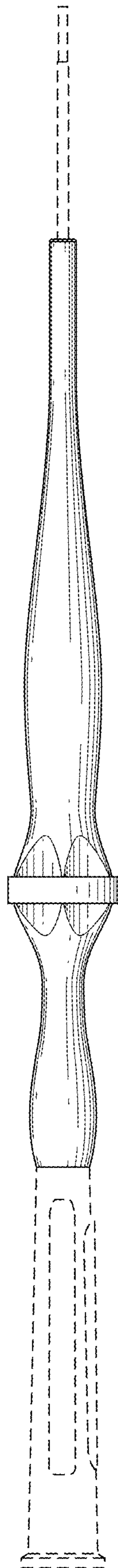

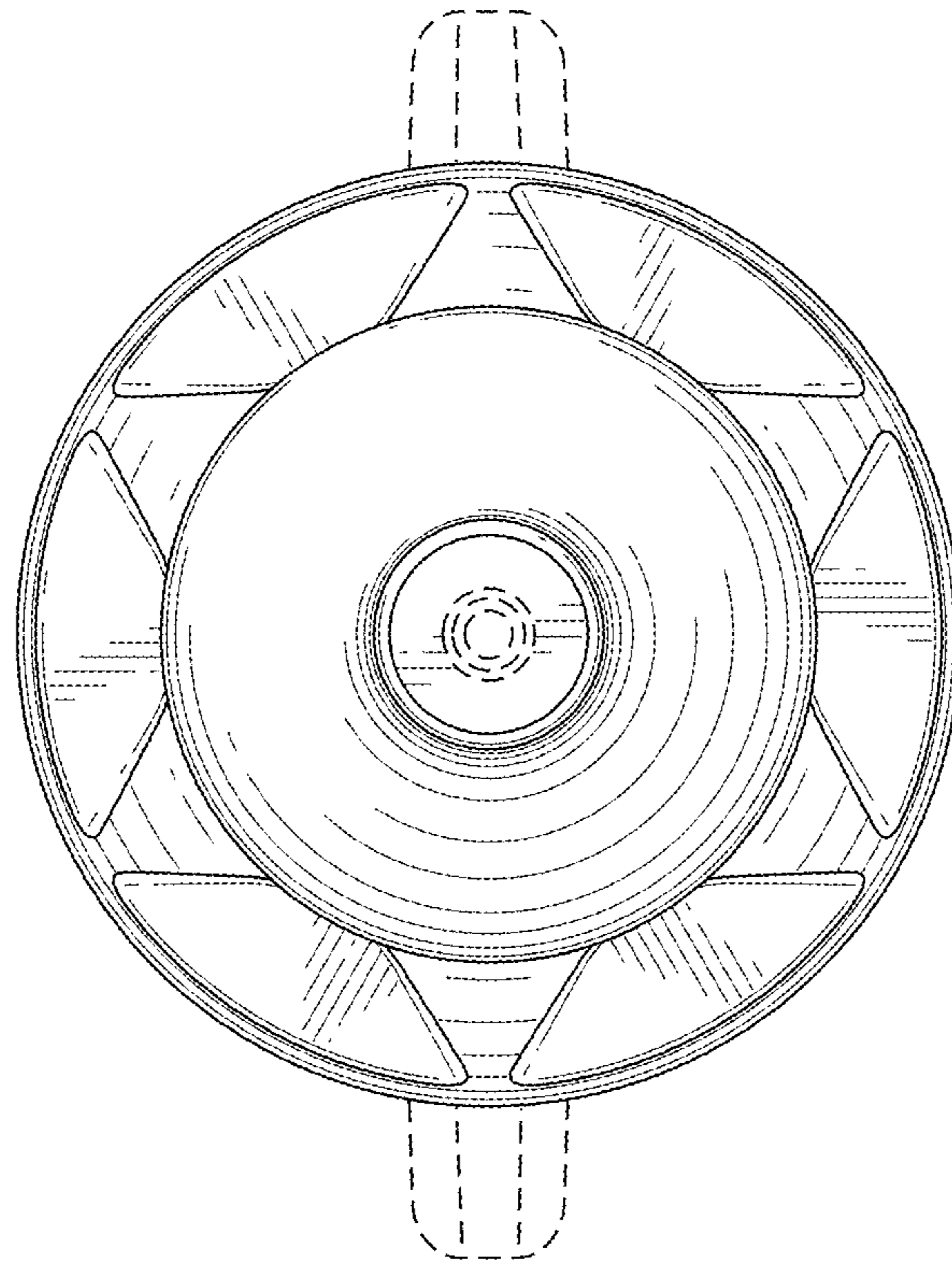

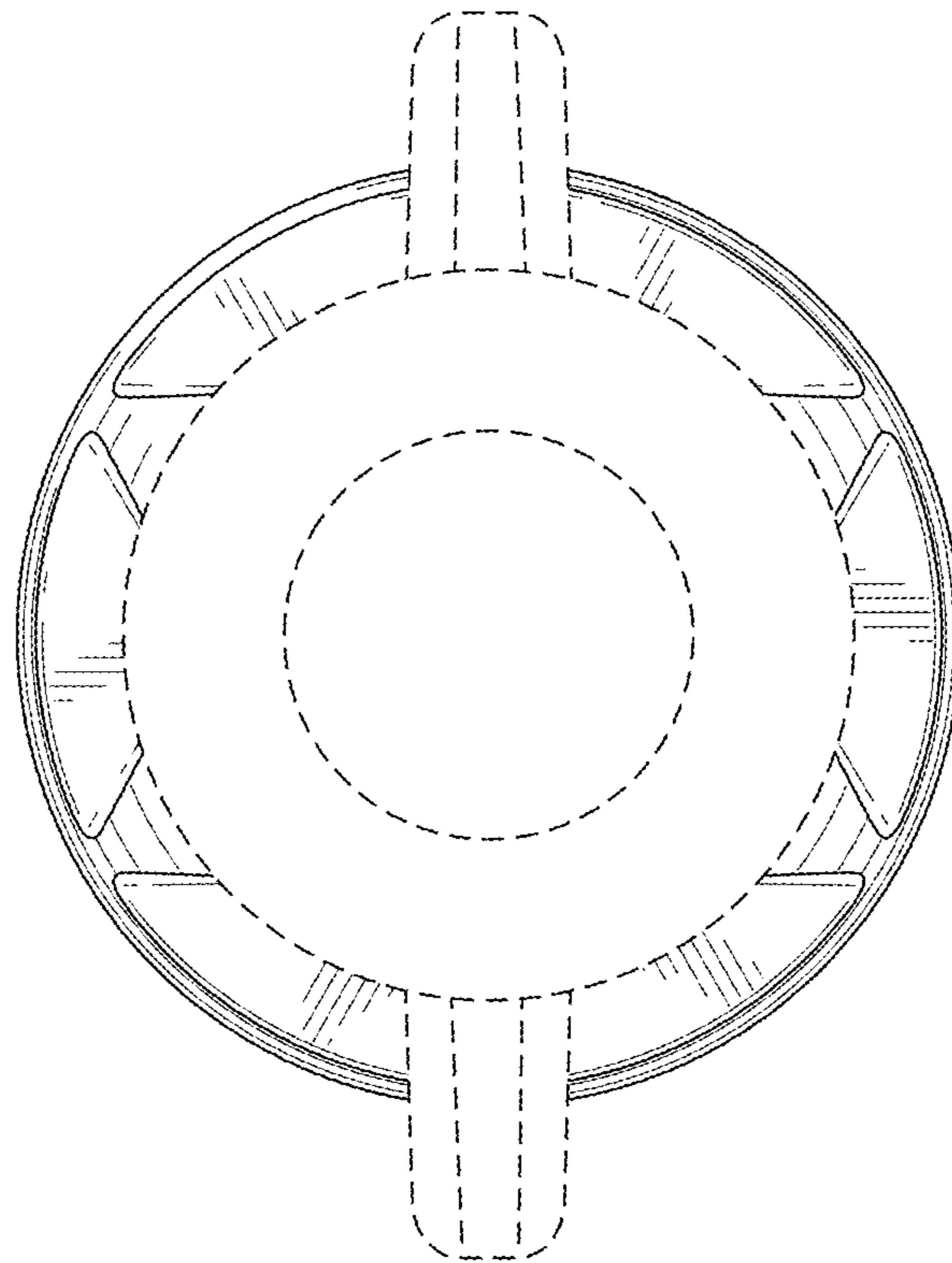
