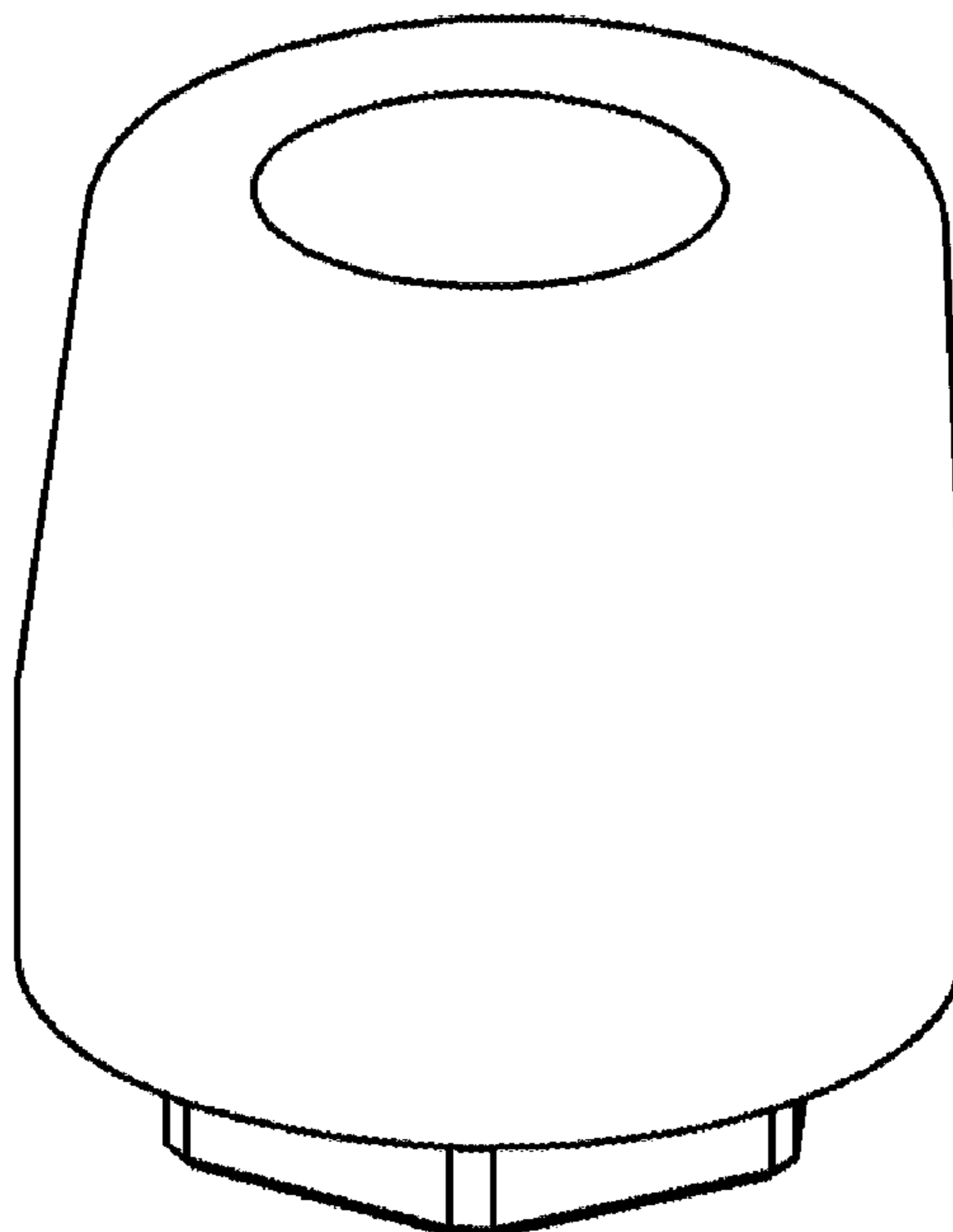
(57) **CLAIM**

The ornamental design for a healing scan body for dental implants, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a healing scan body for dental implants showing the new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a back elevation view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top plan view thereof;

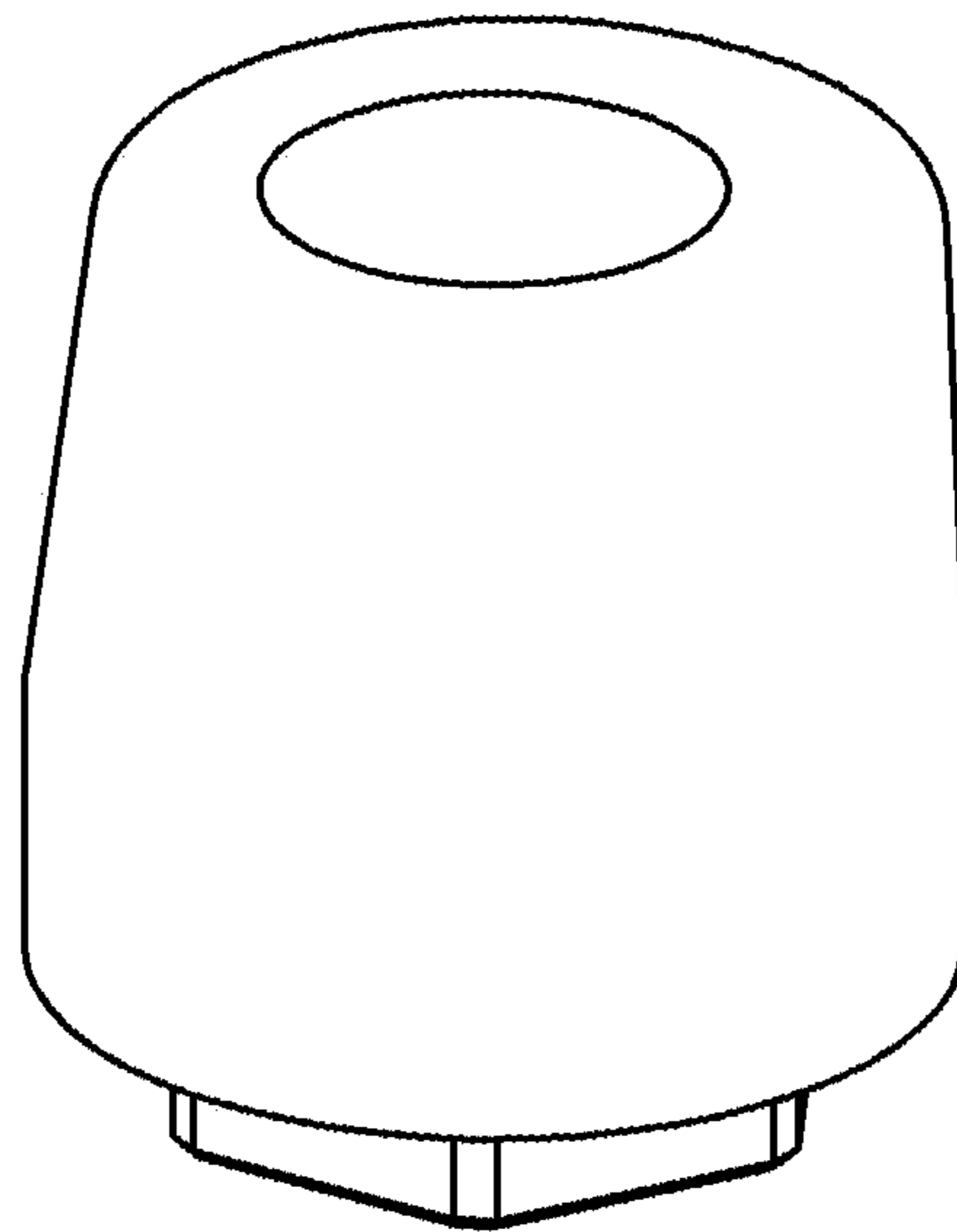

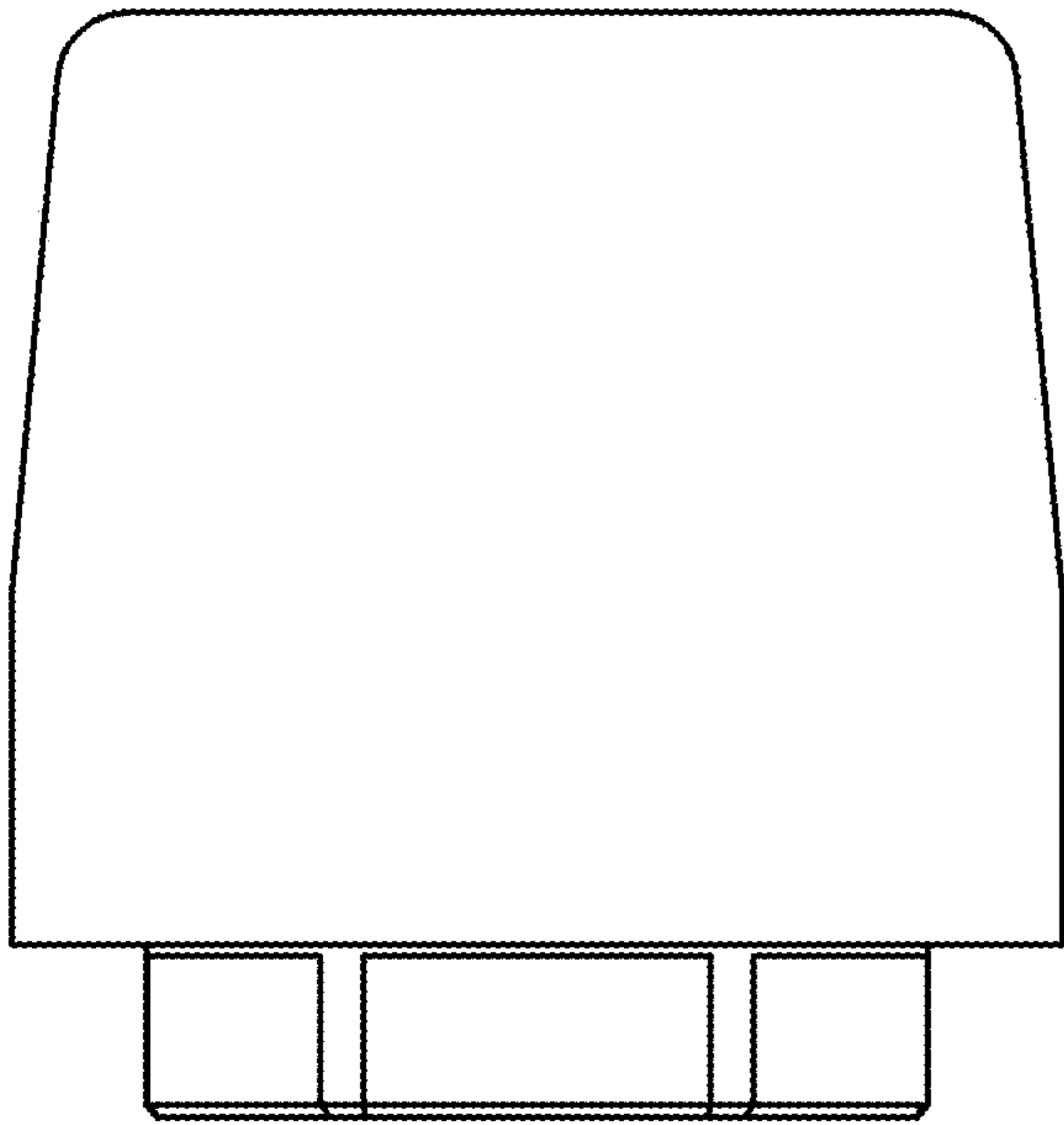

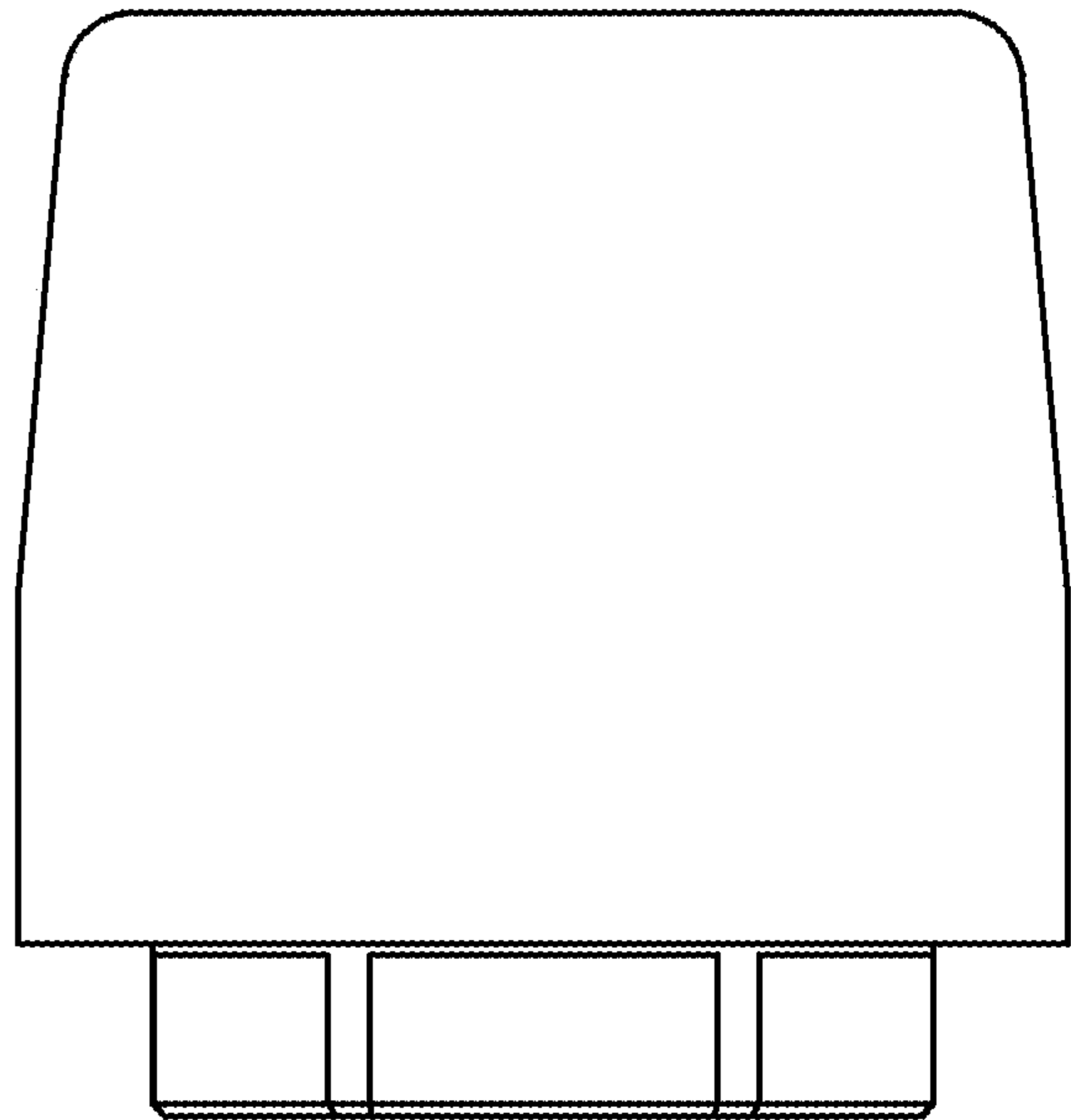

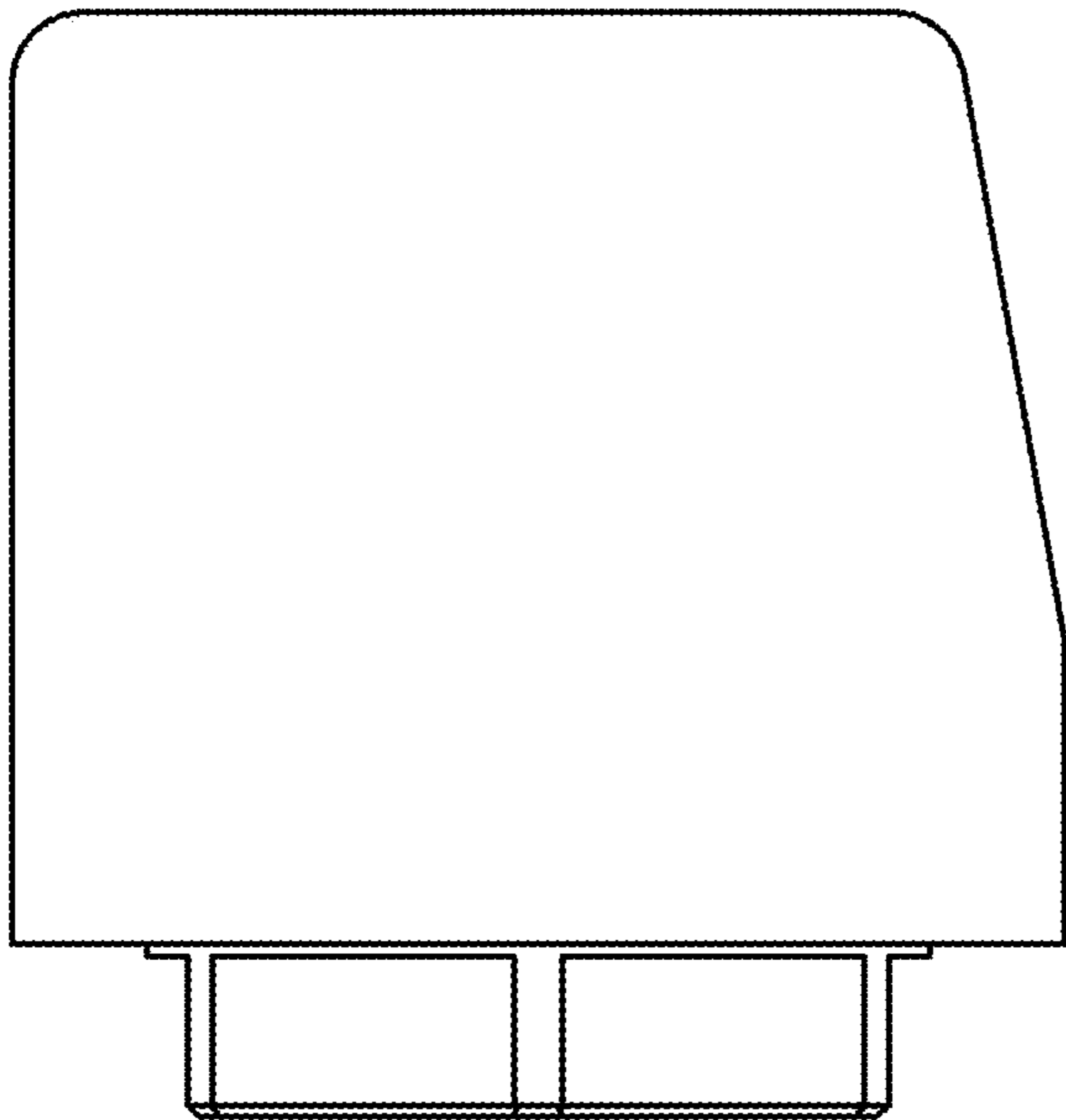

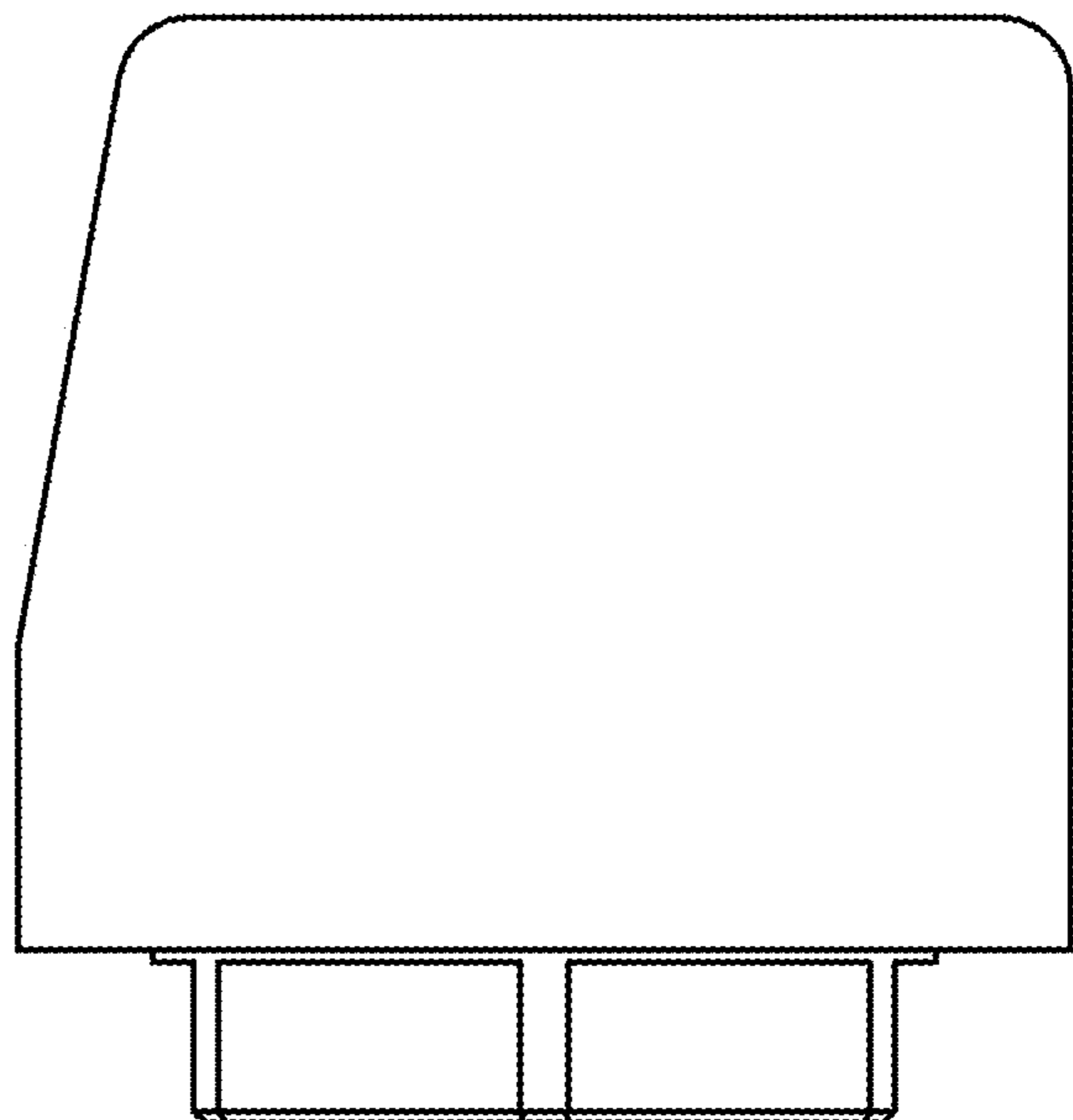

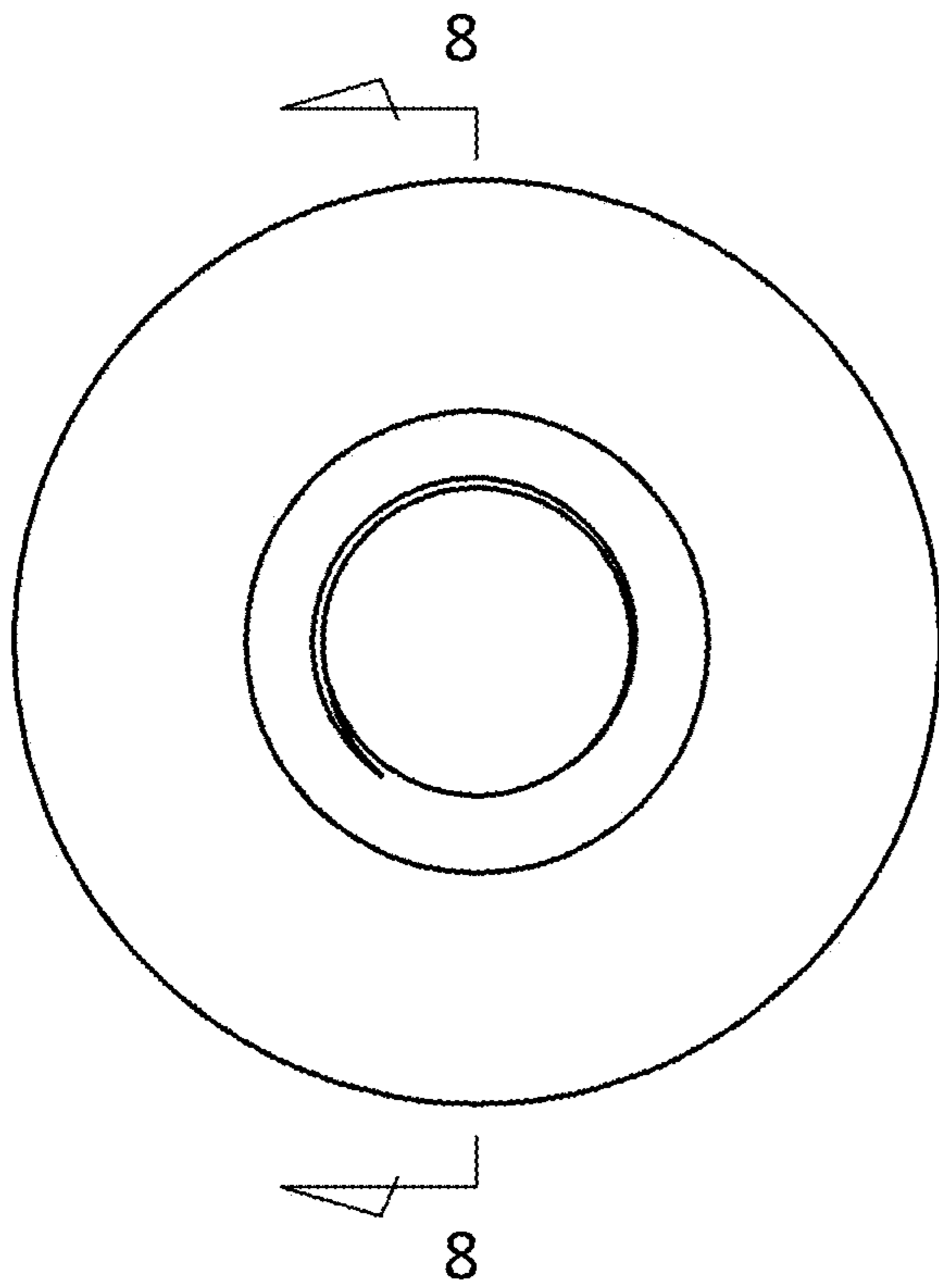

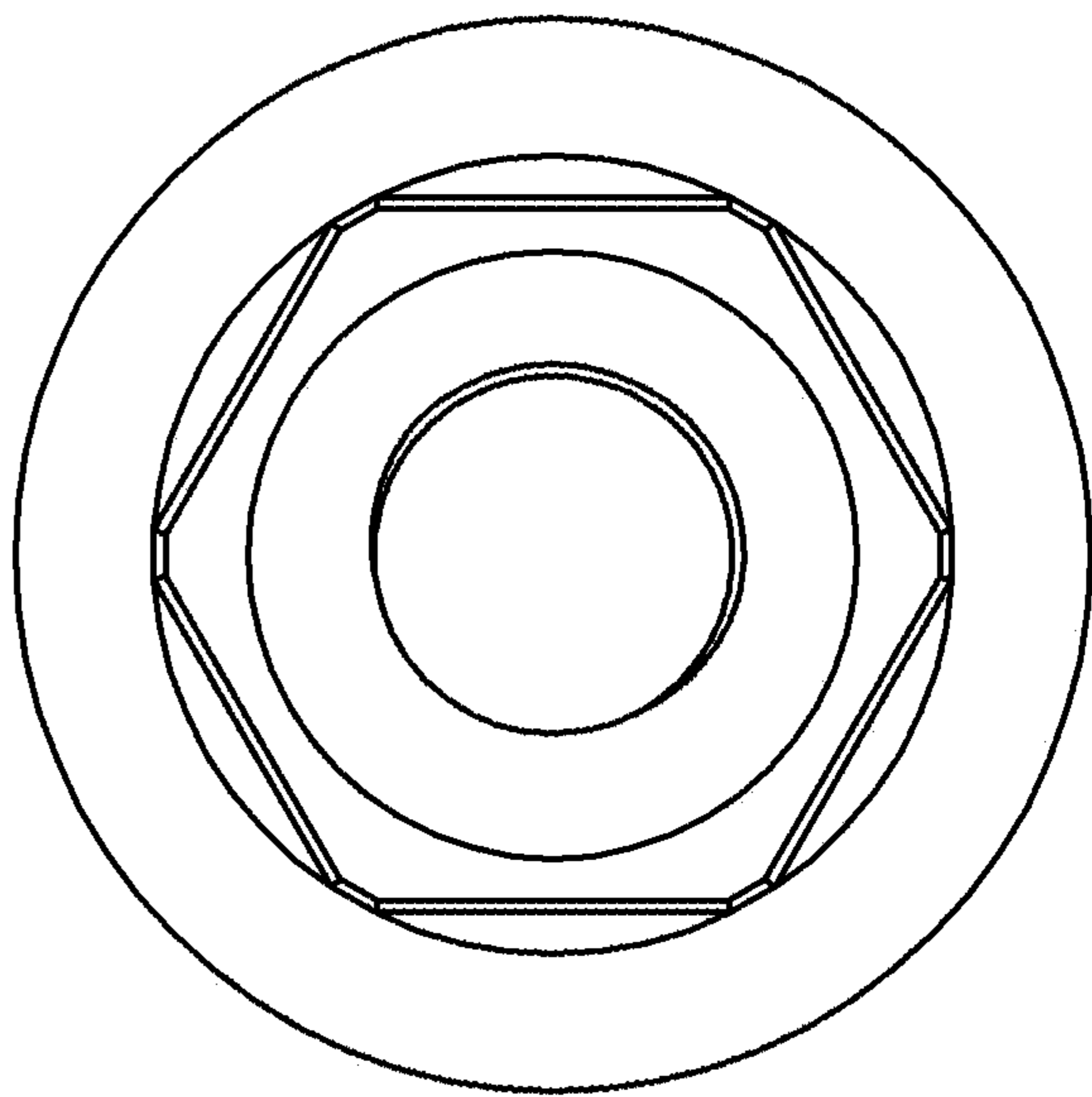

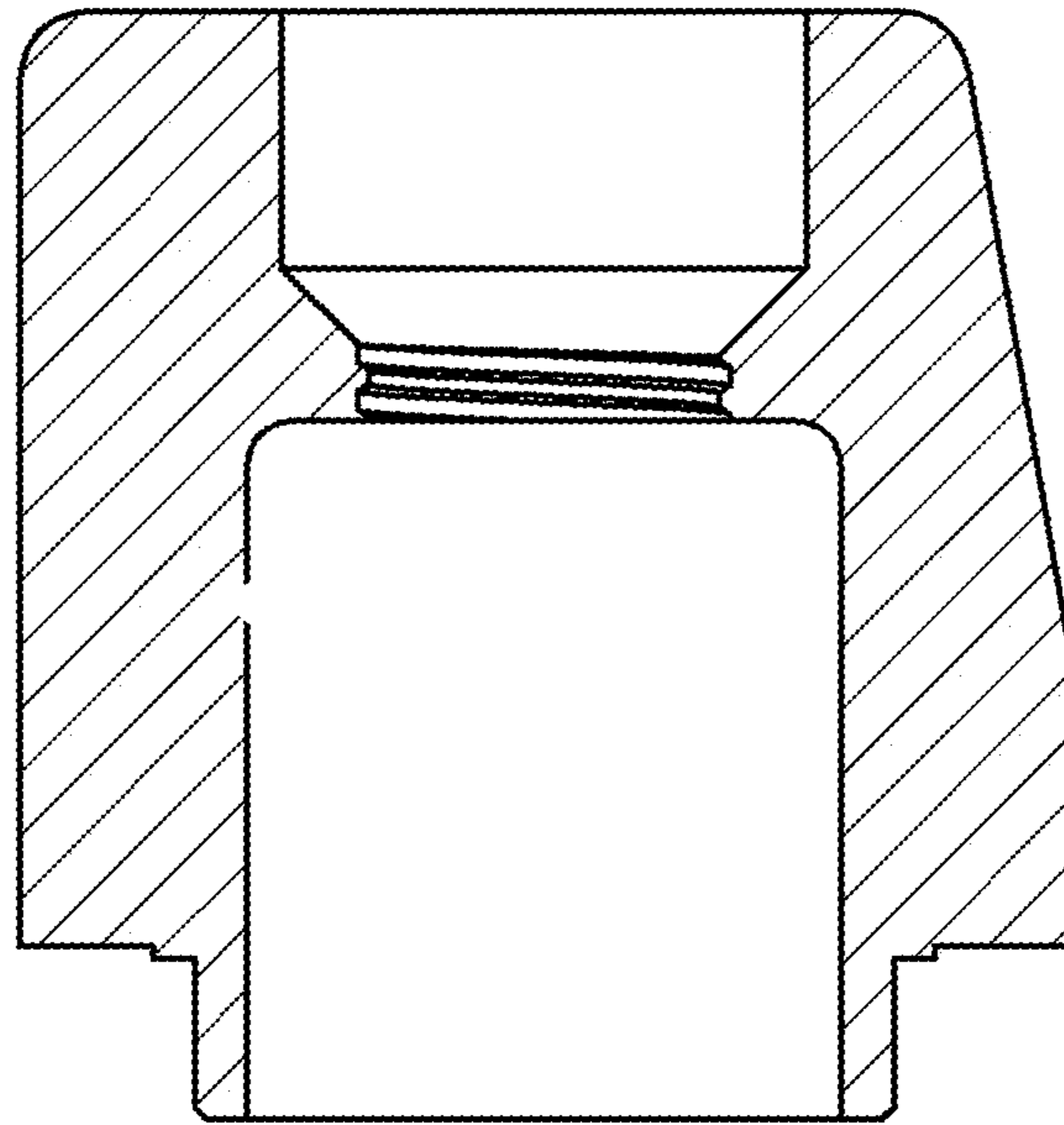
