(57) **CLAIM**

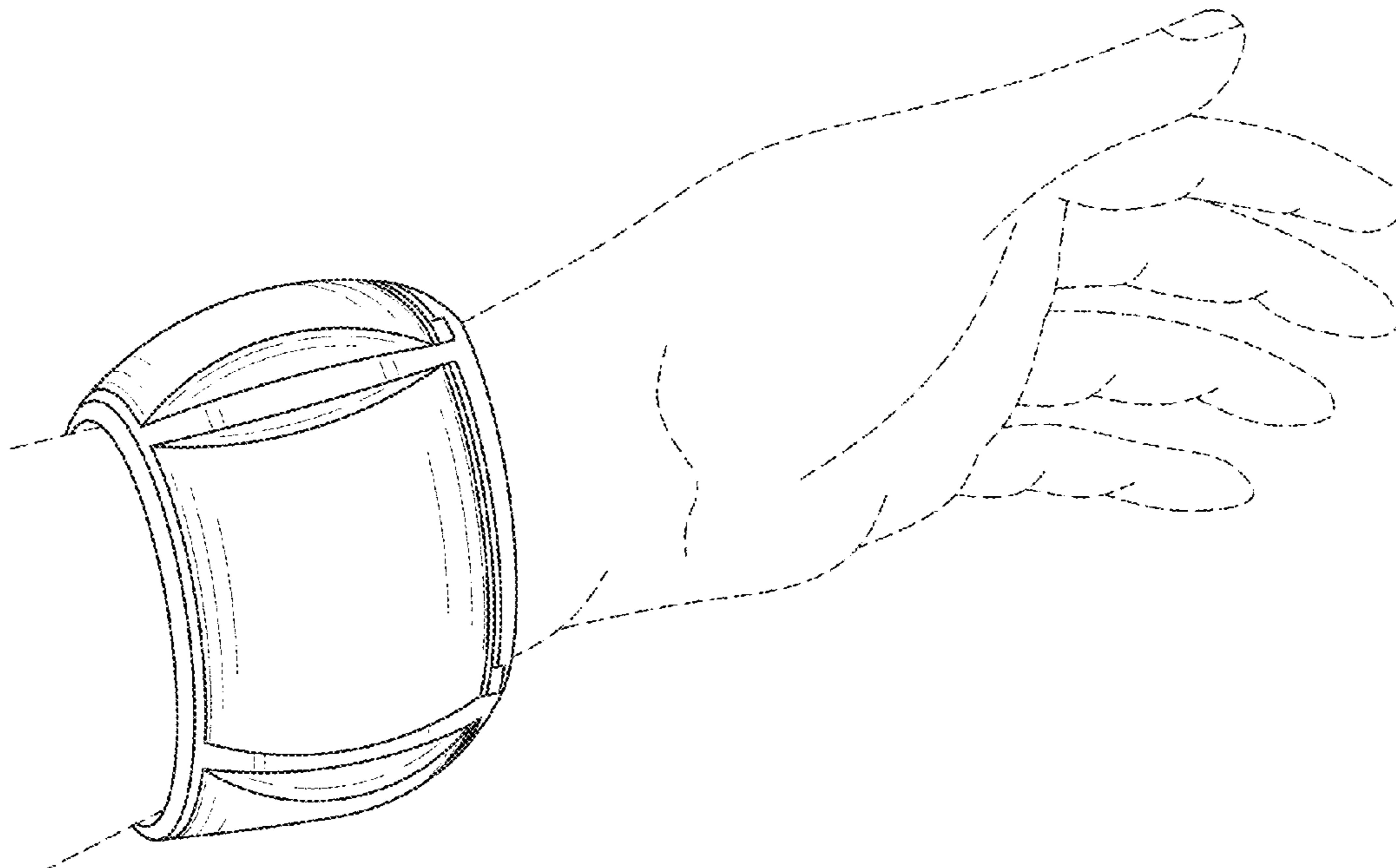
The ornamental design for a body temperature cooling device, as shown and described.

DESCRIPTION

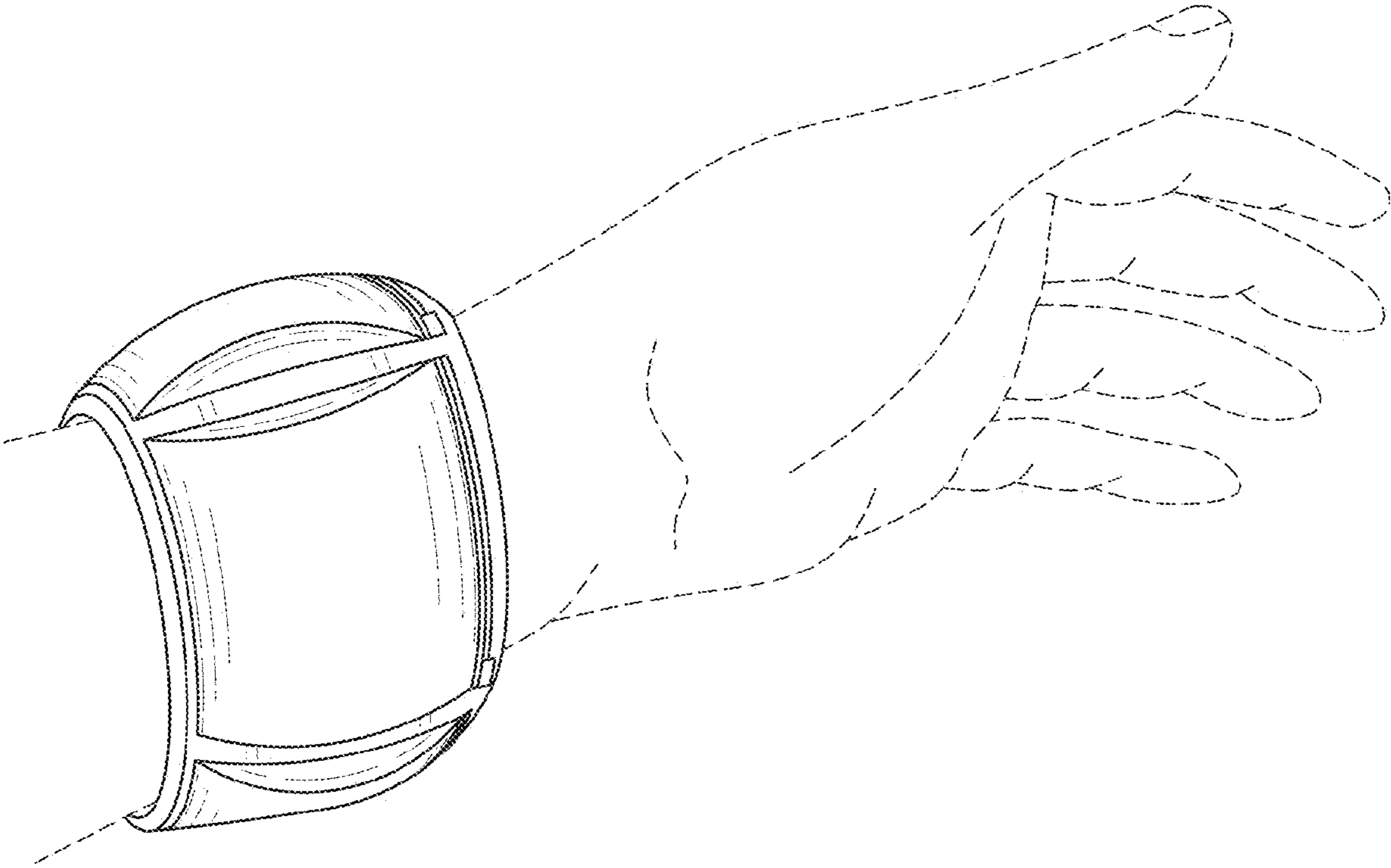

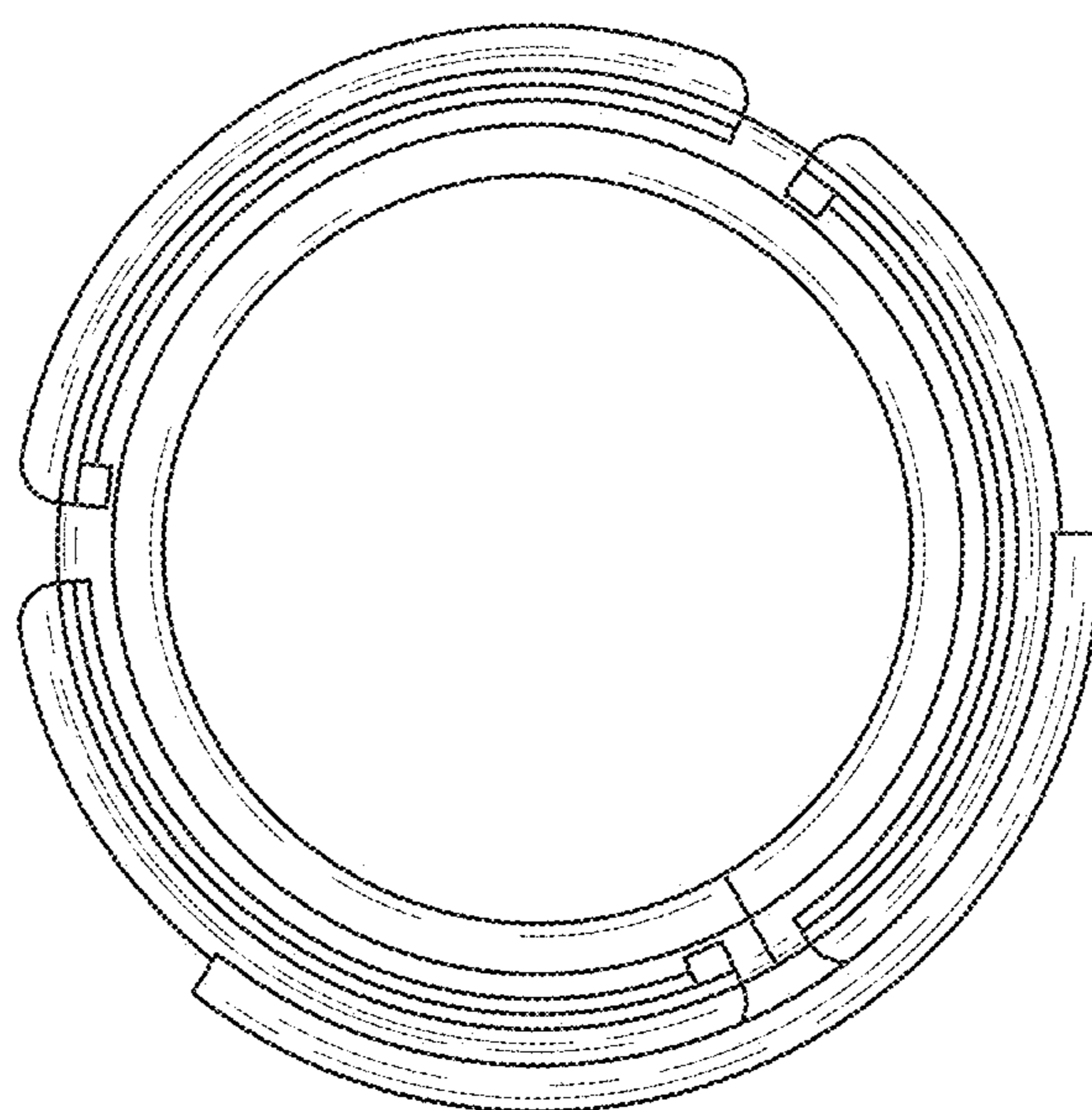

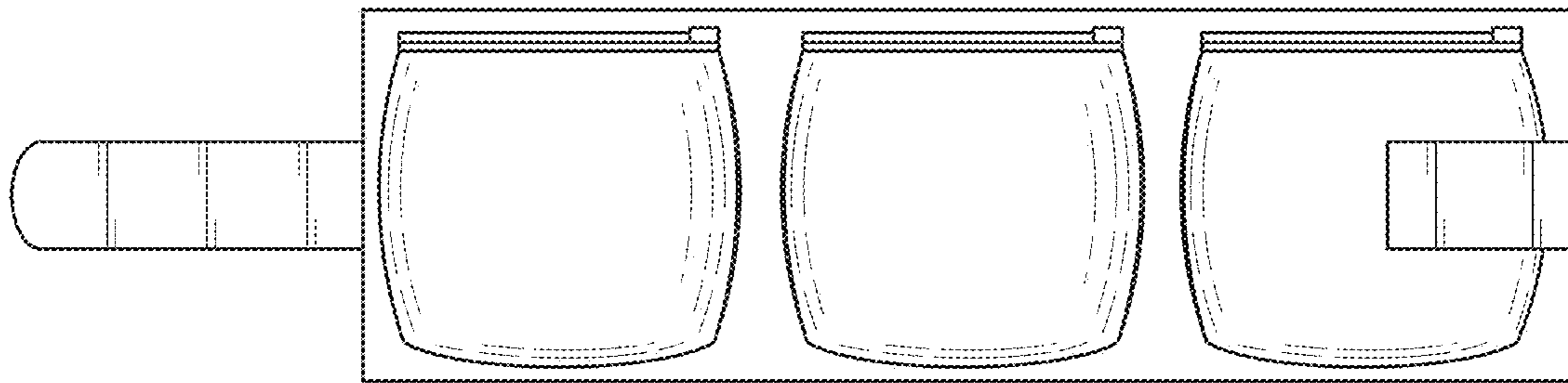

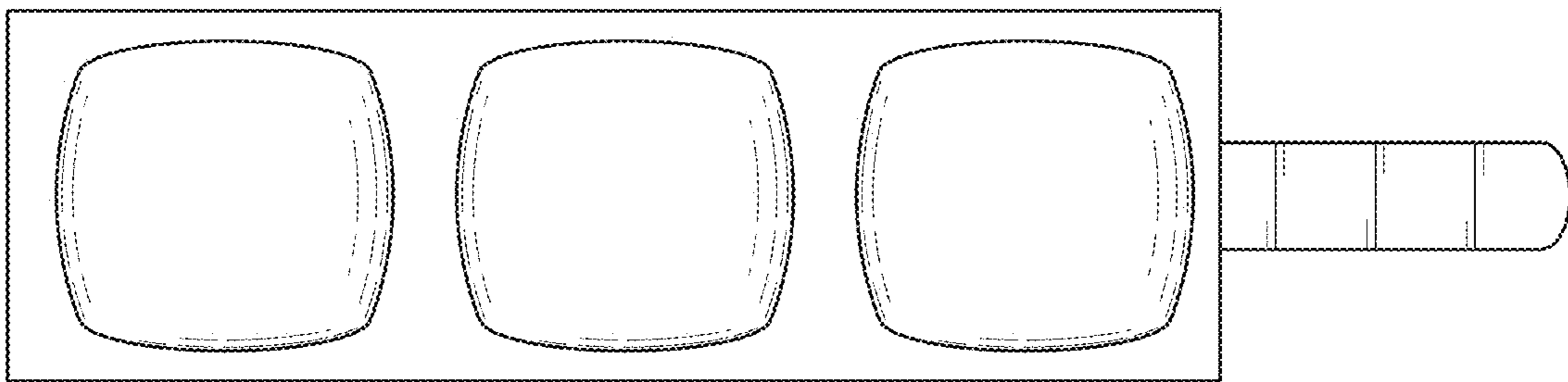

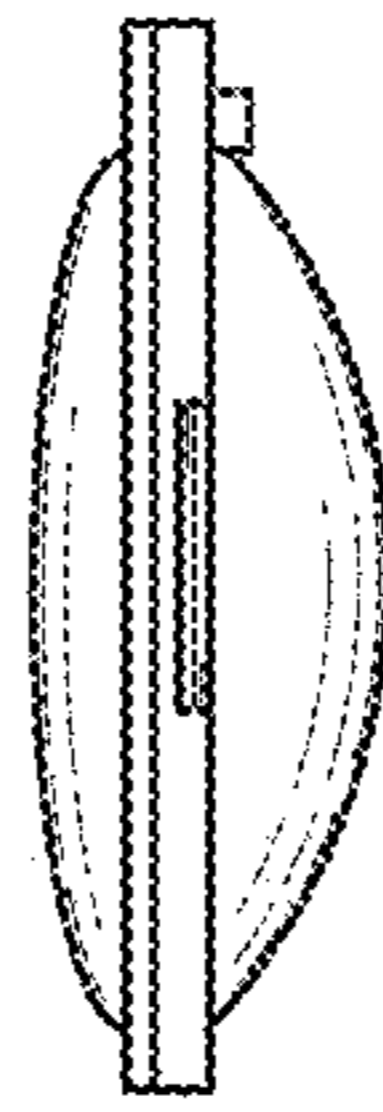

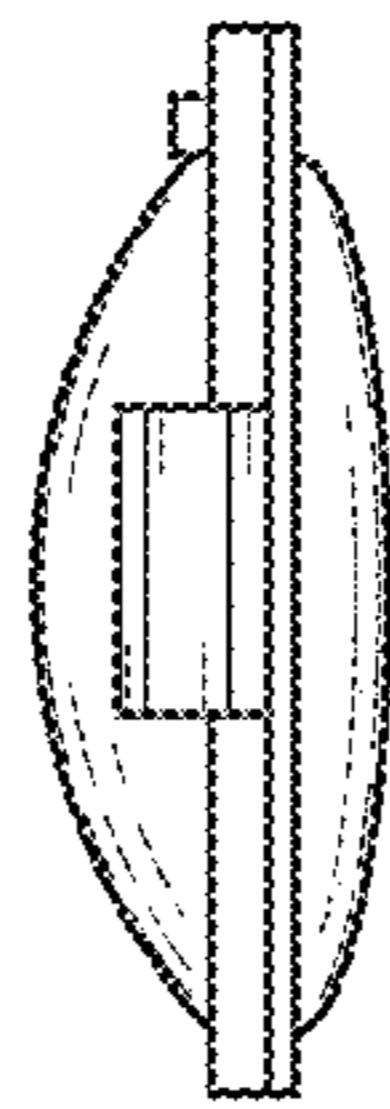

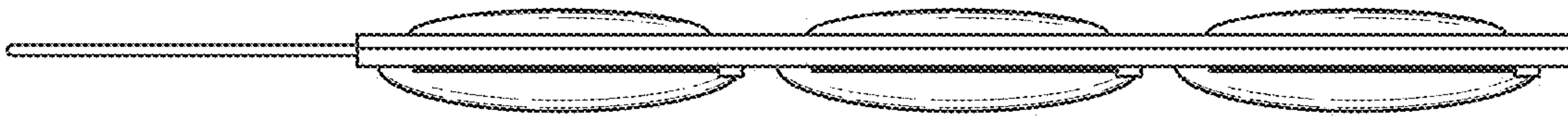

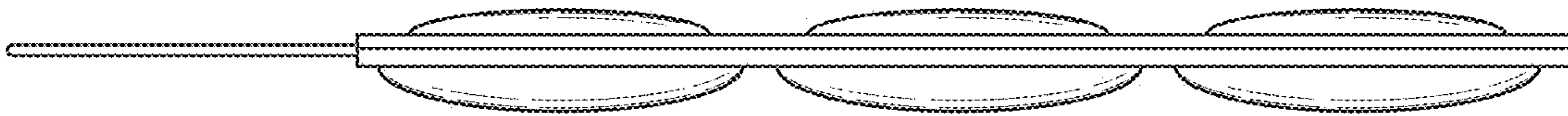
