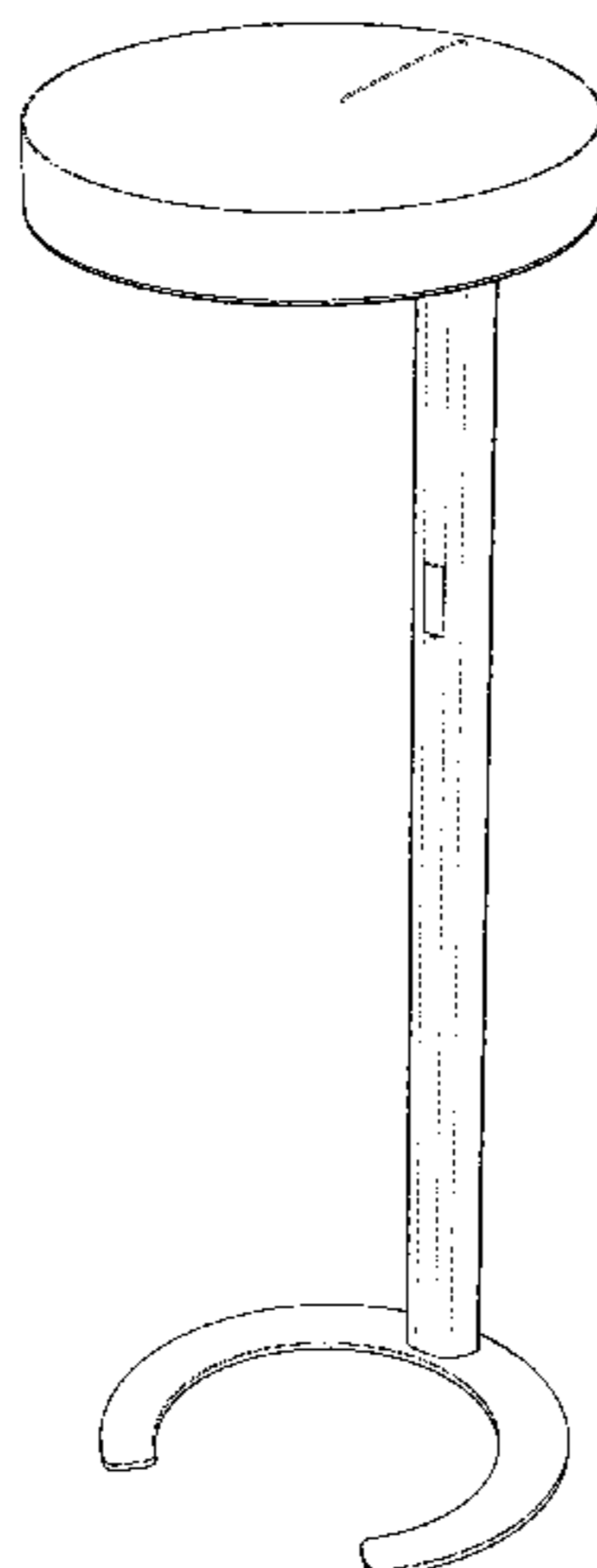

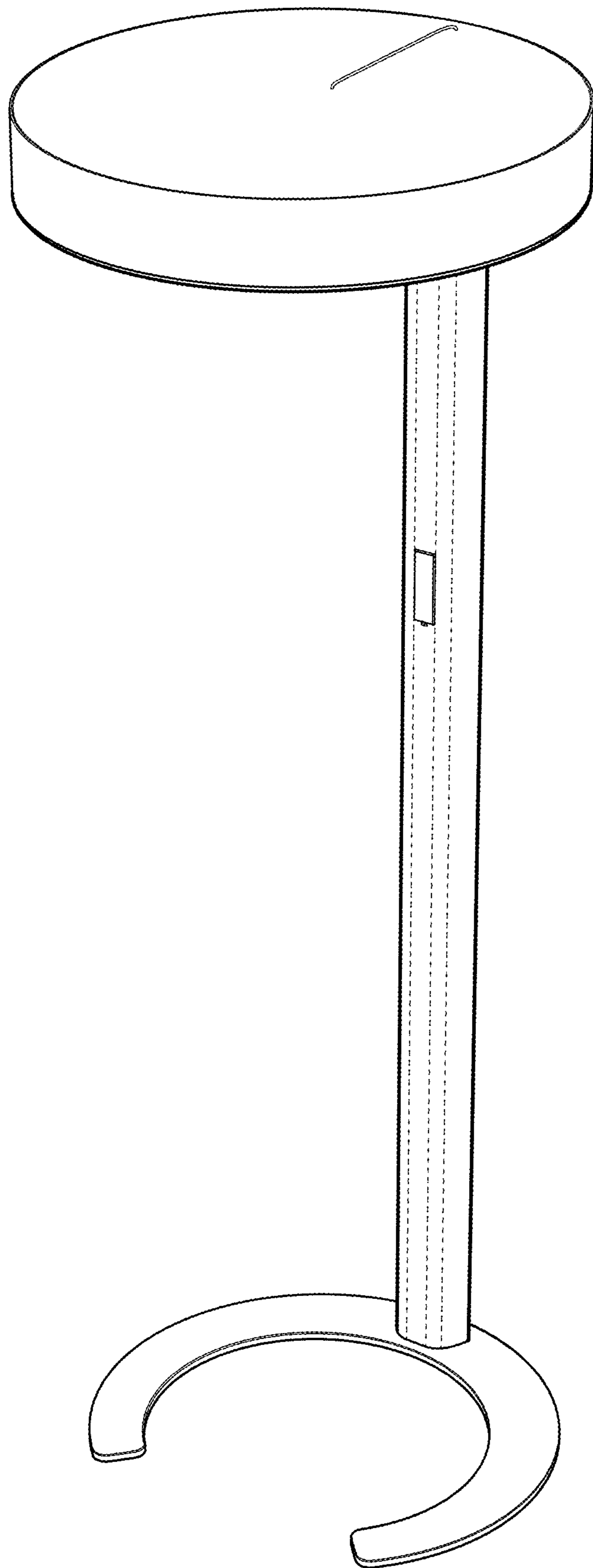

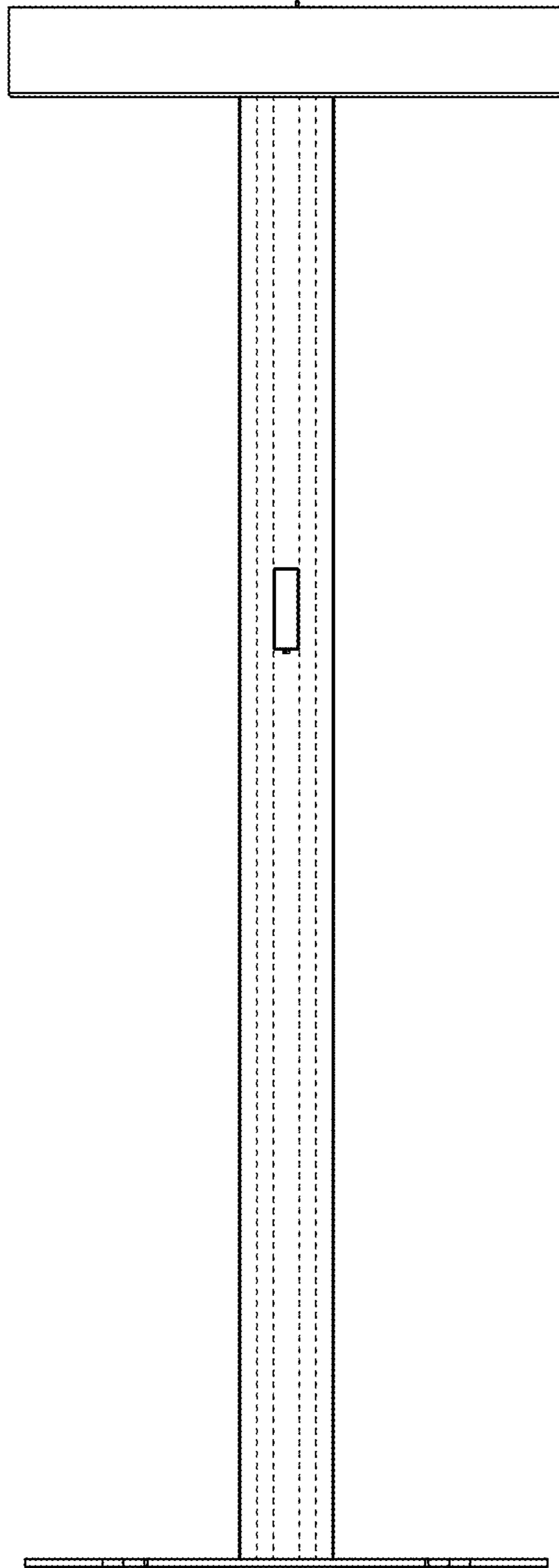


The broken lines in the figures represent portions of the standing lamp that form no part of the claimed design.

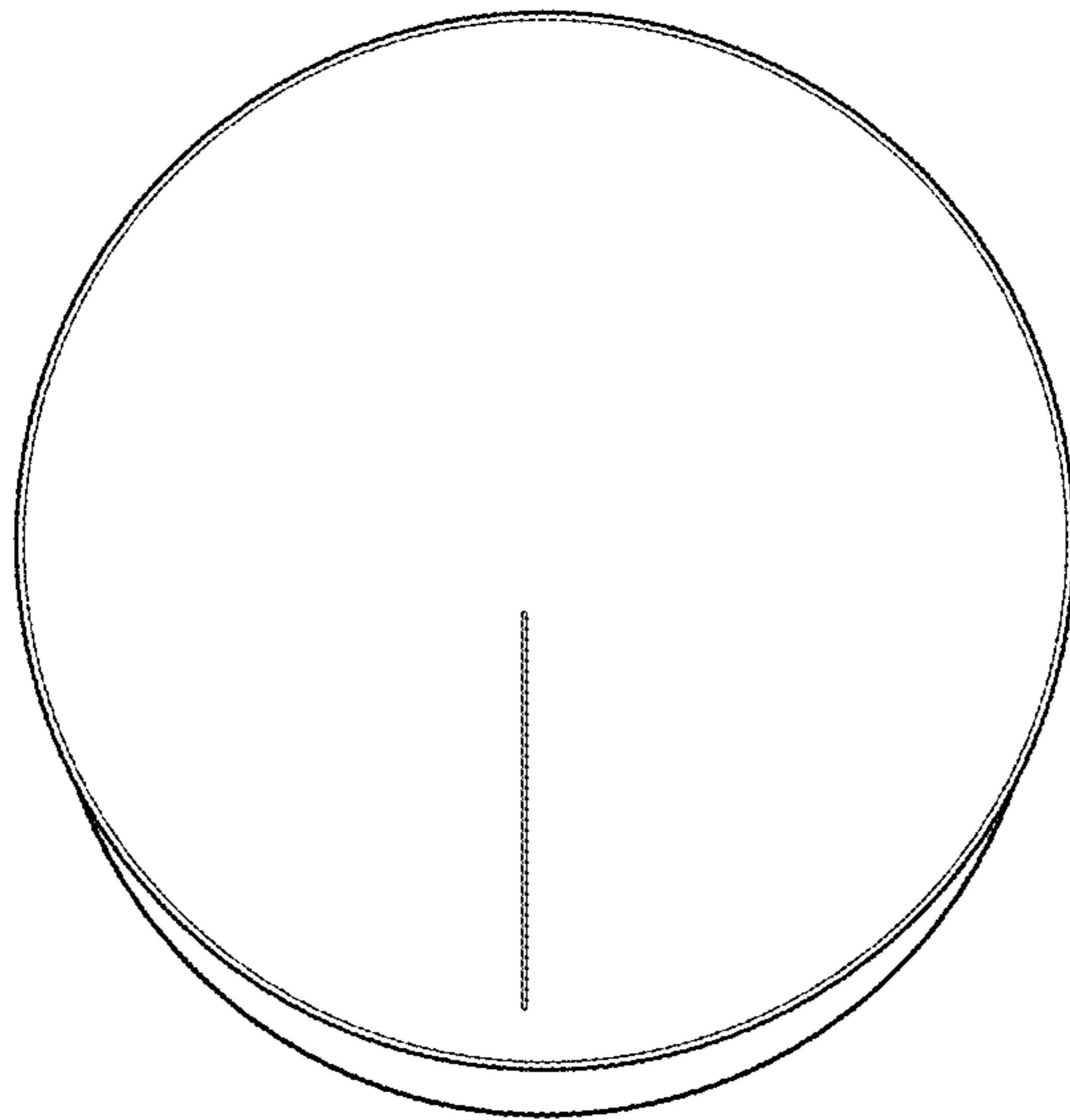

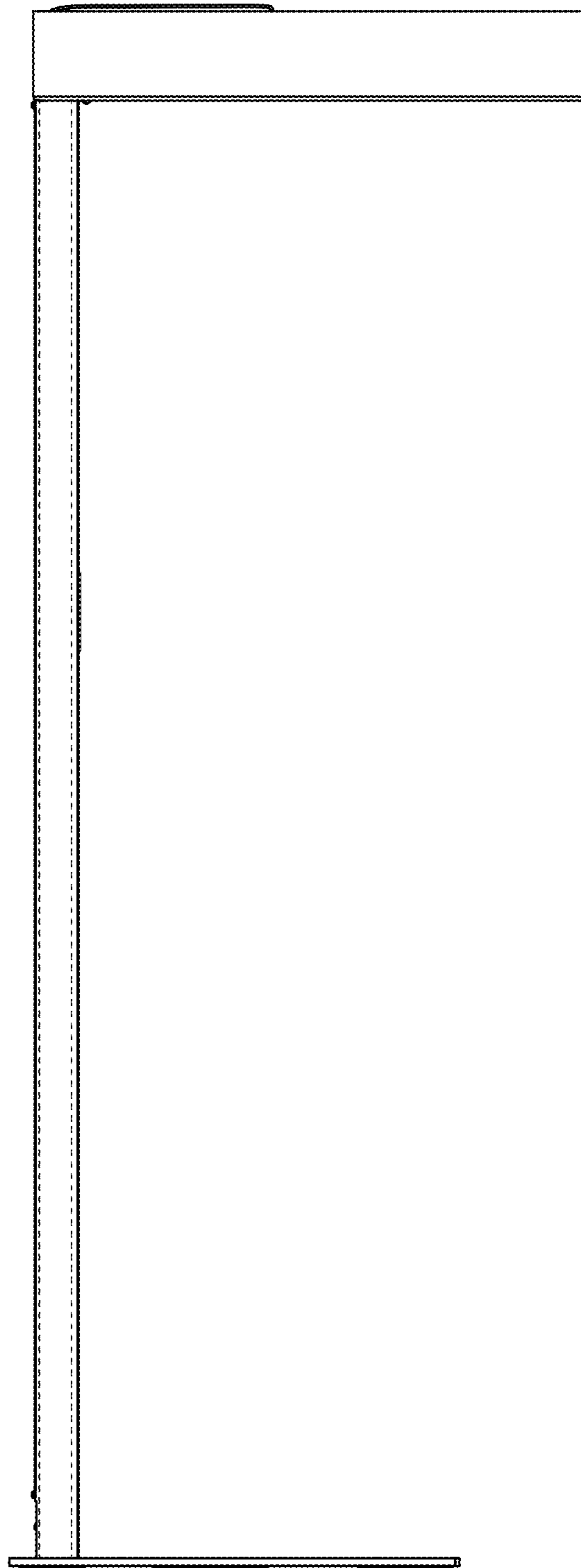

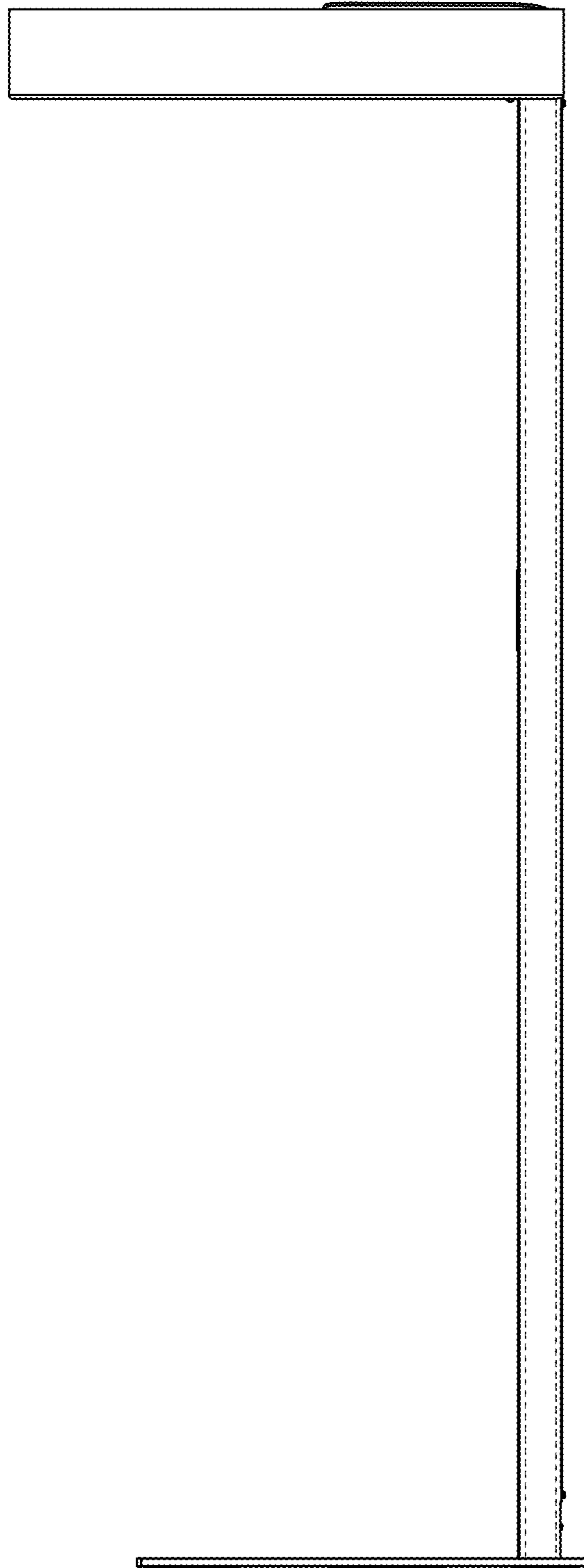

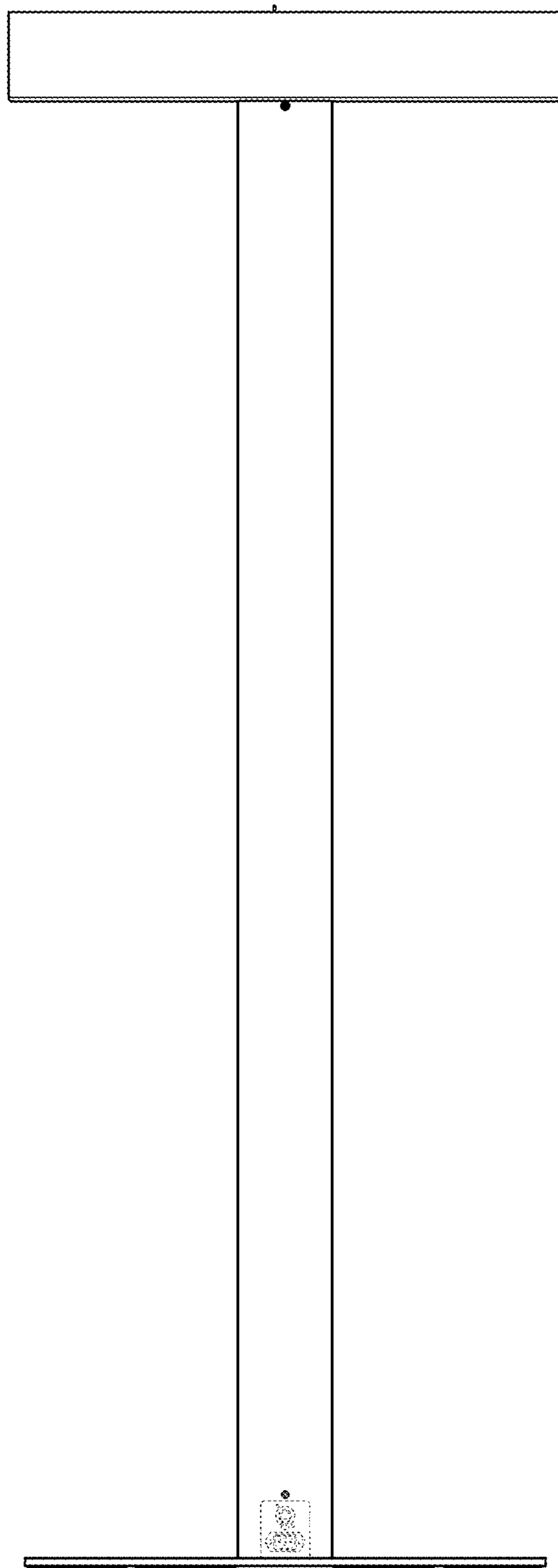

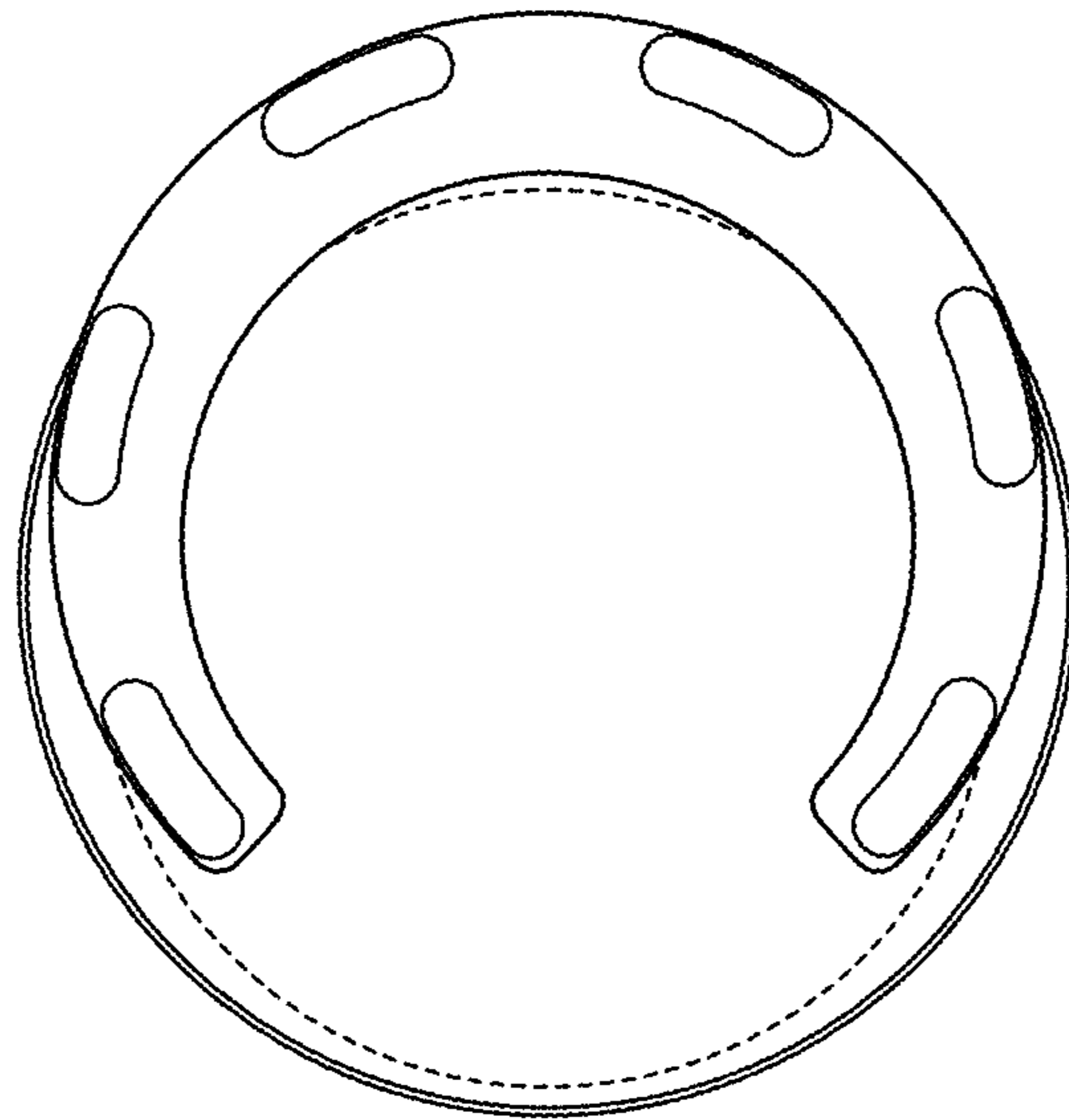
