**DESCRIPTION**

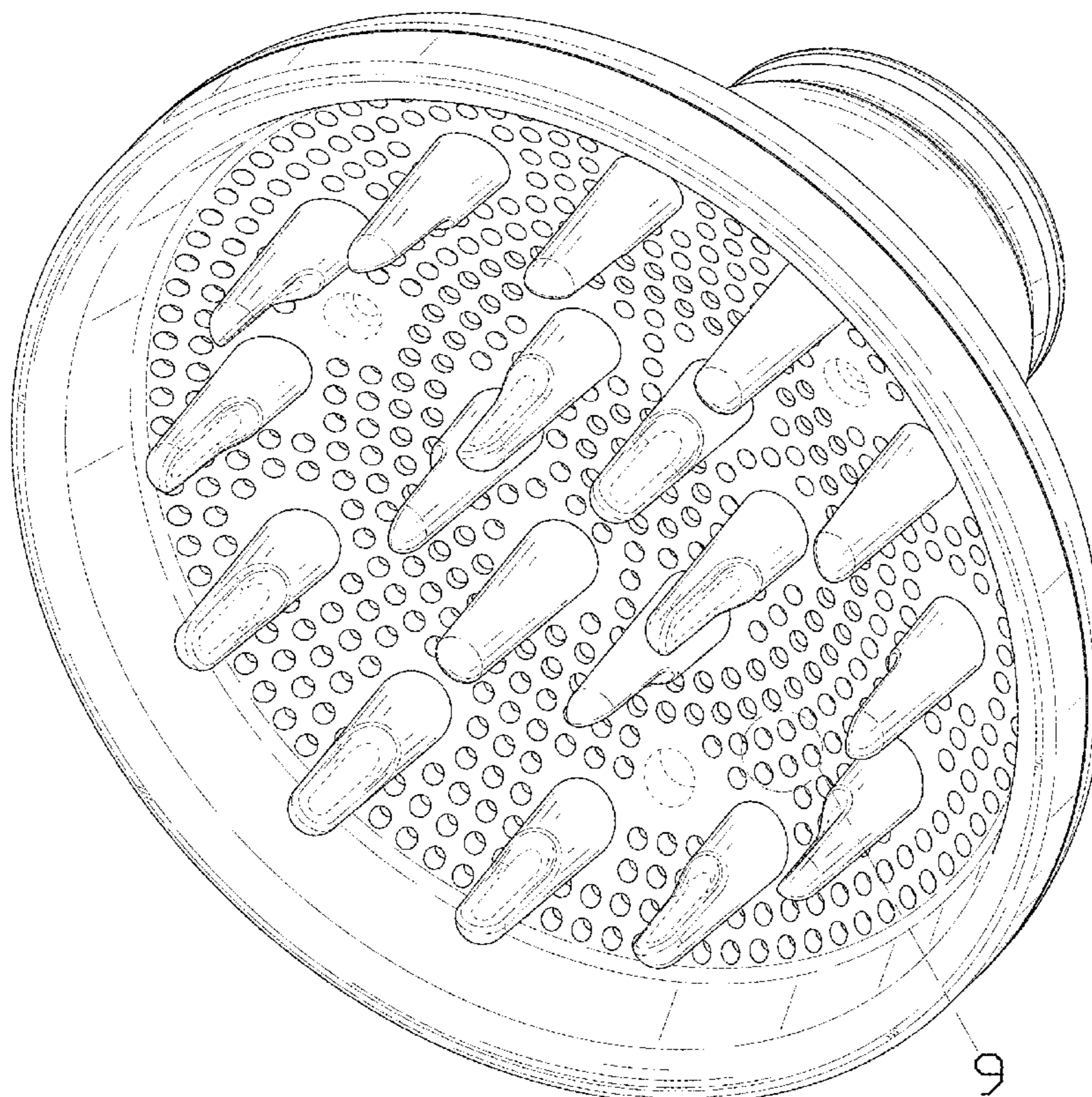
FIG. 1 is a perspective view of a hair dryer diffuser showing my new design;

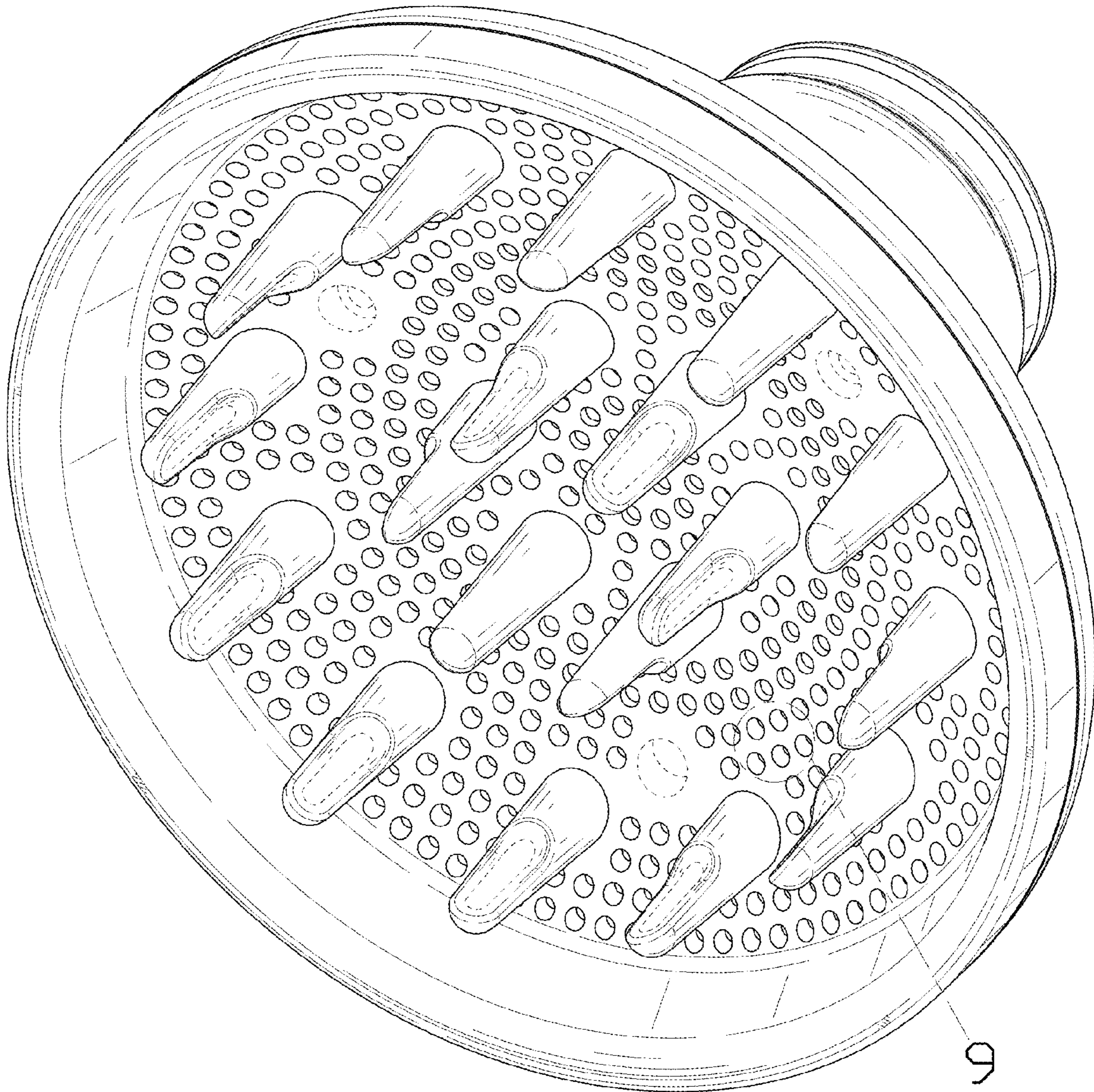

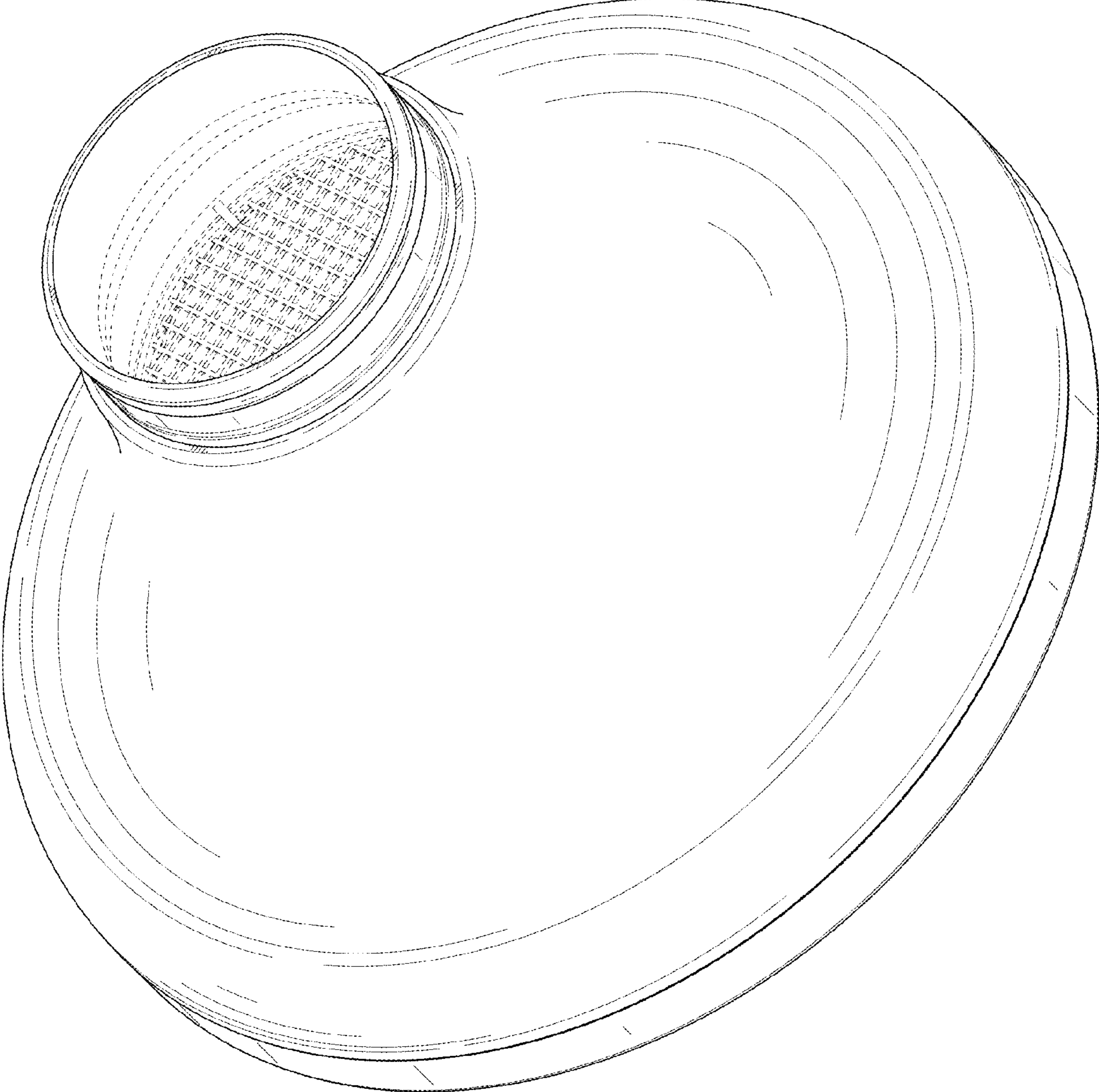

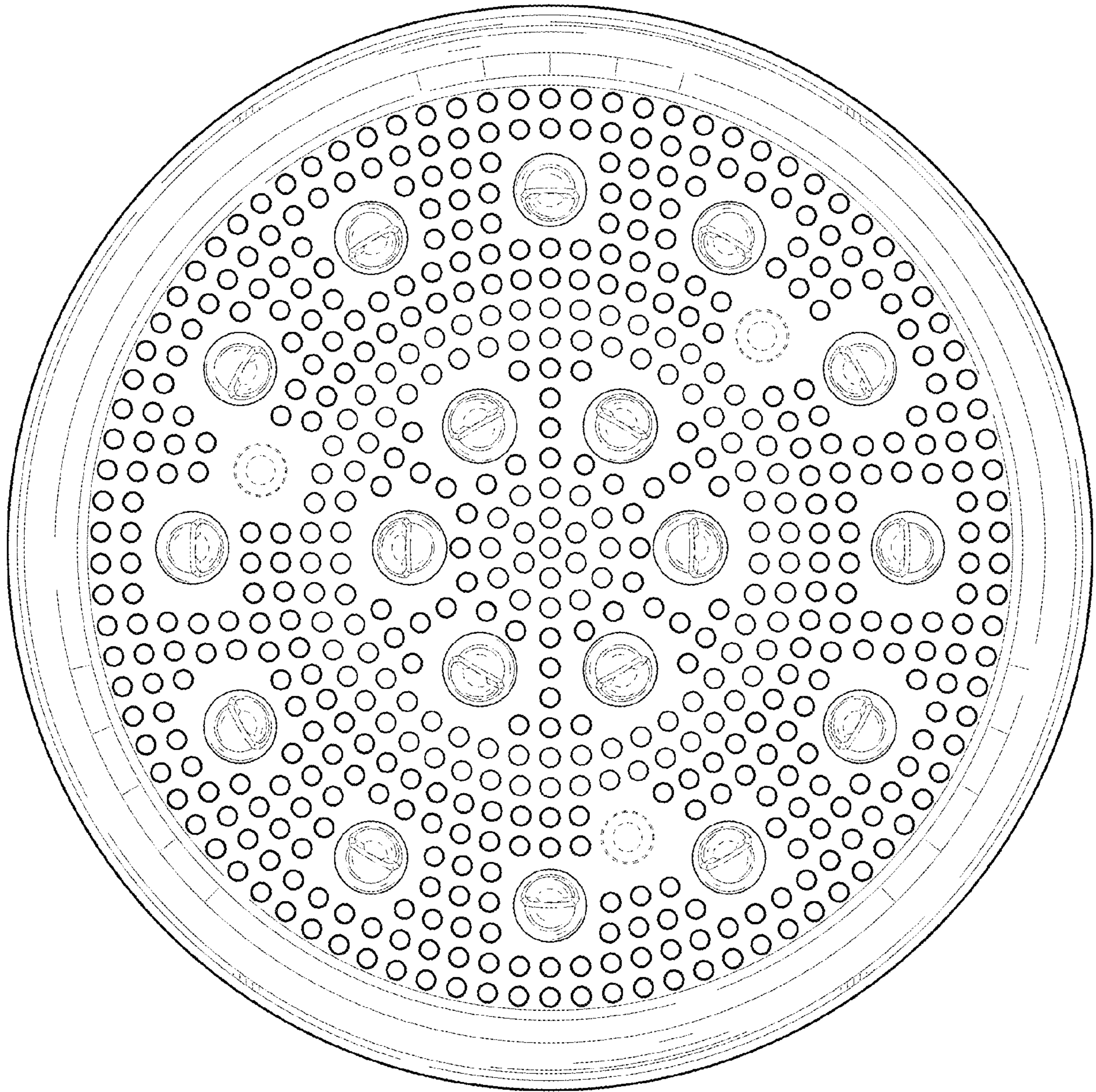

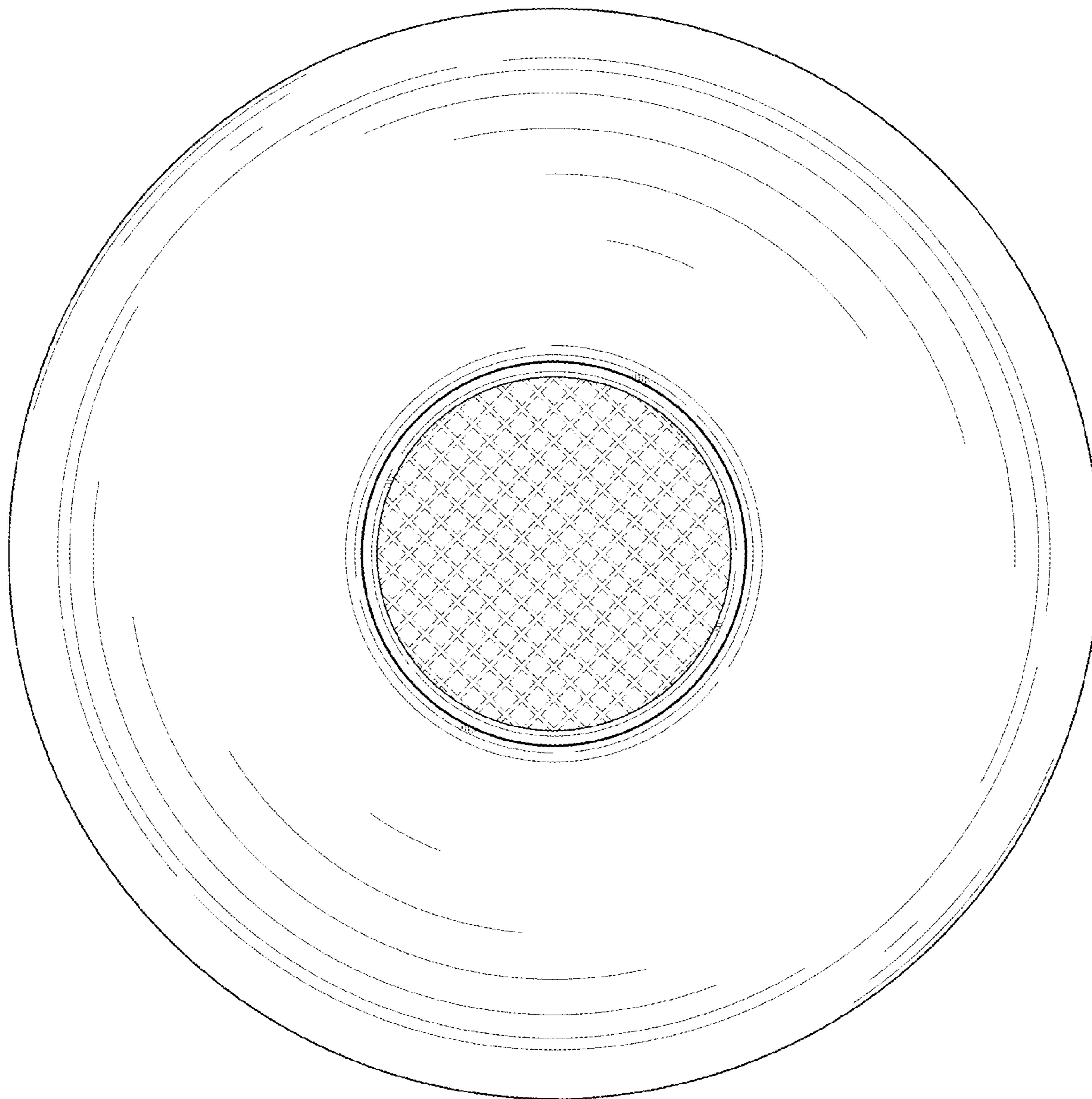

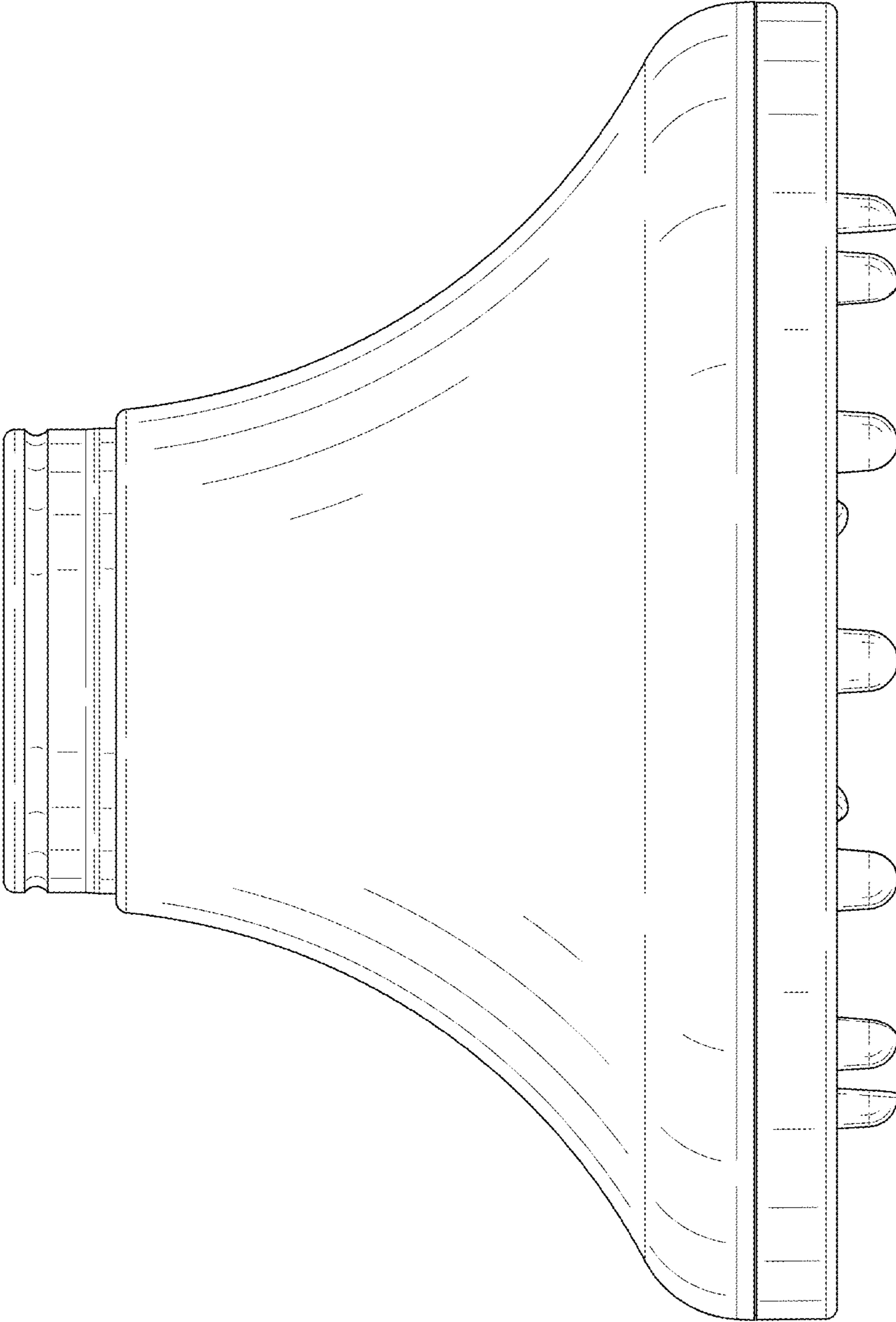

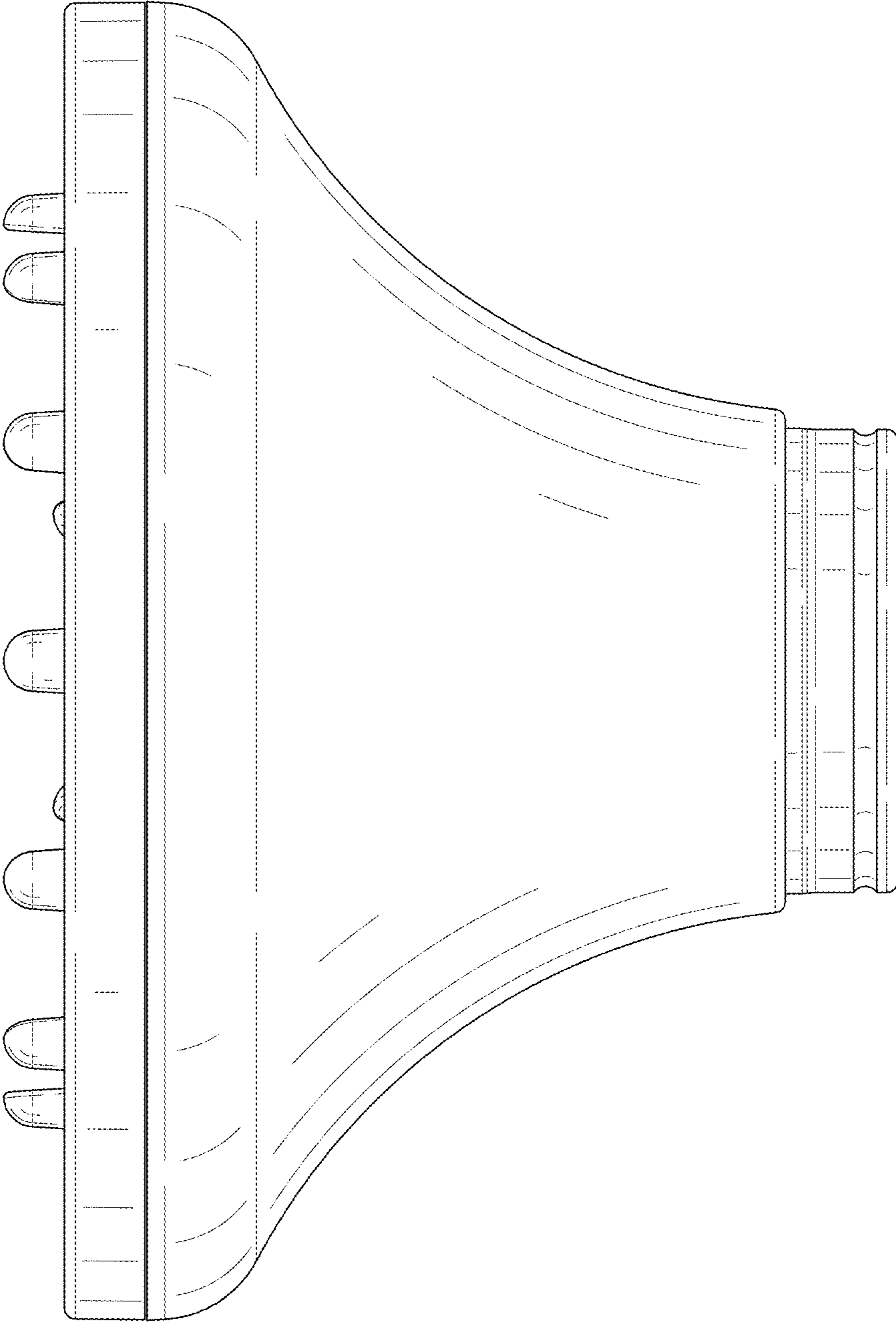

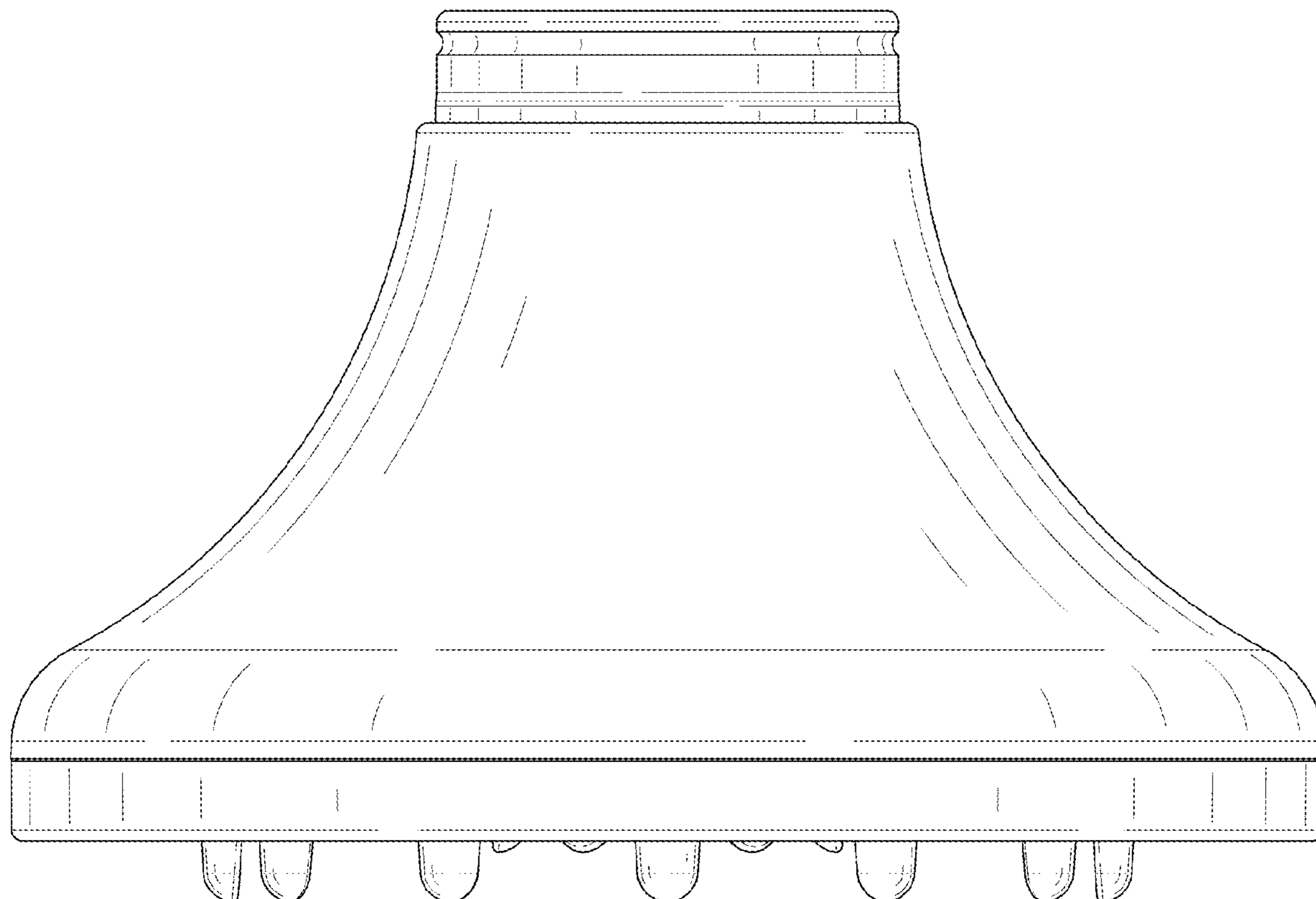

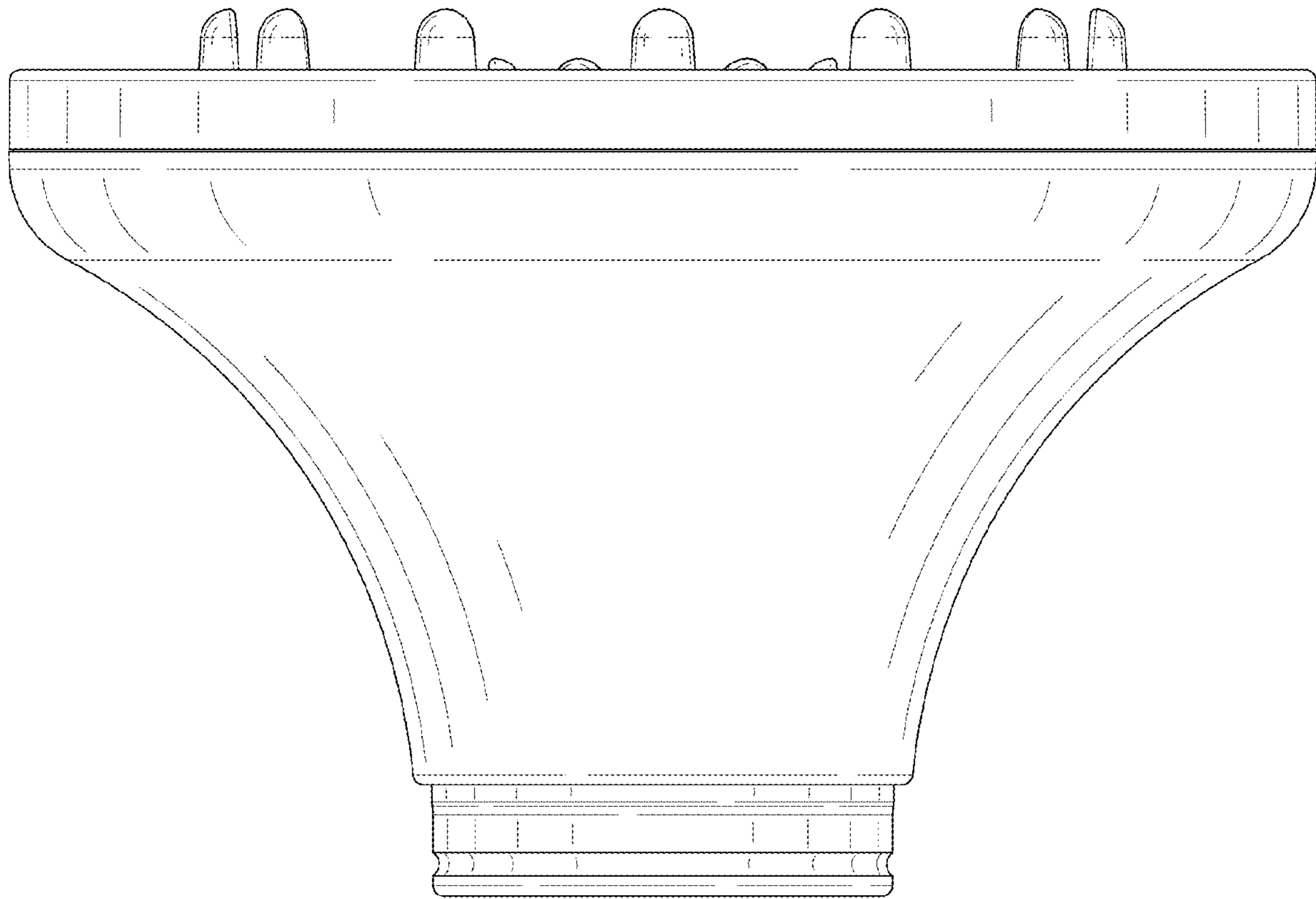

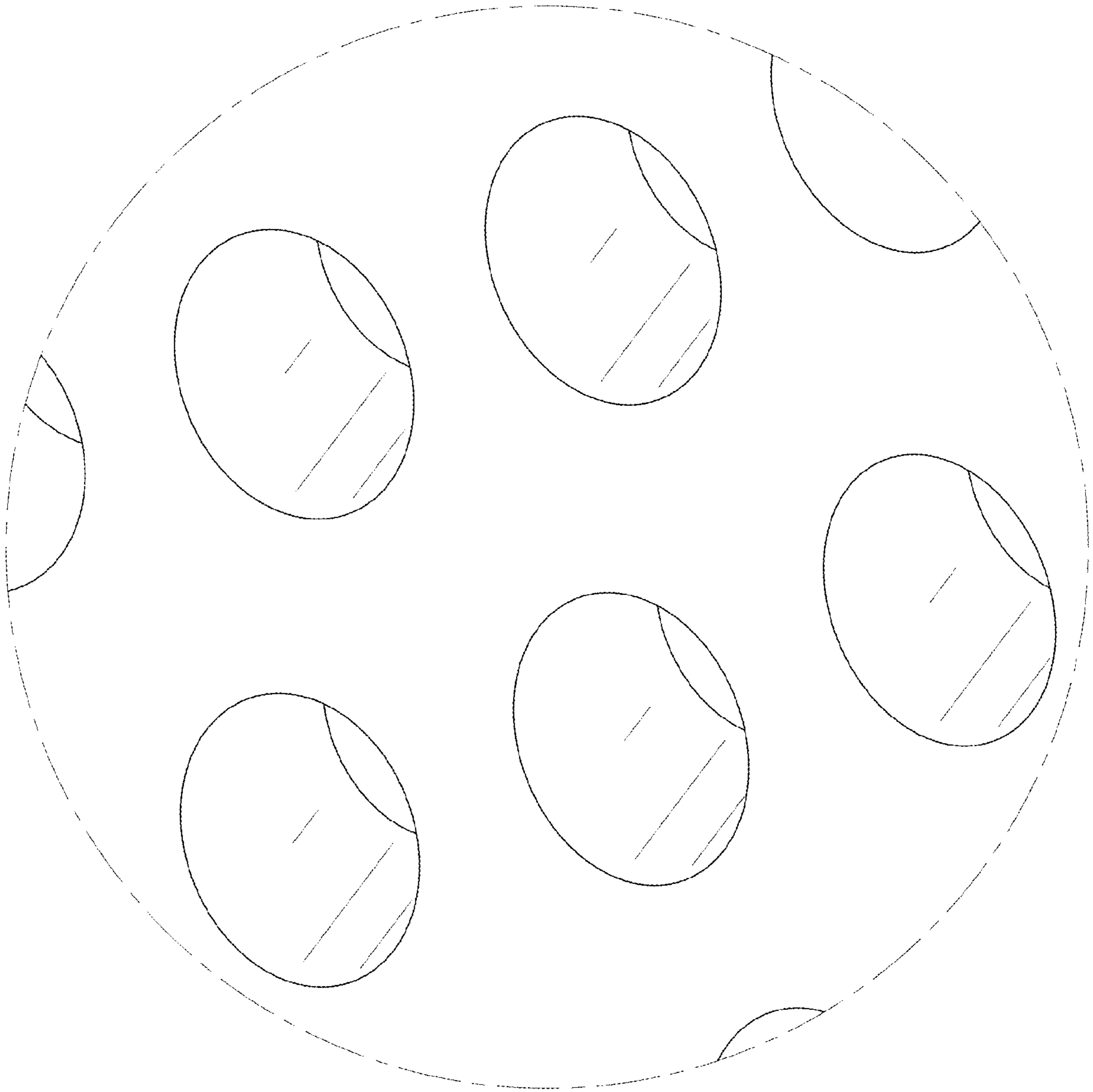
