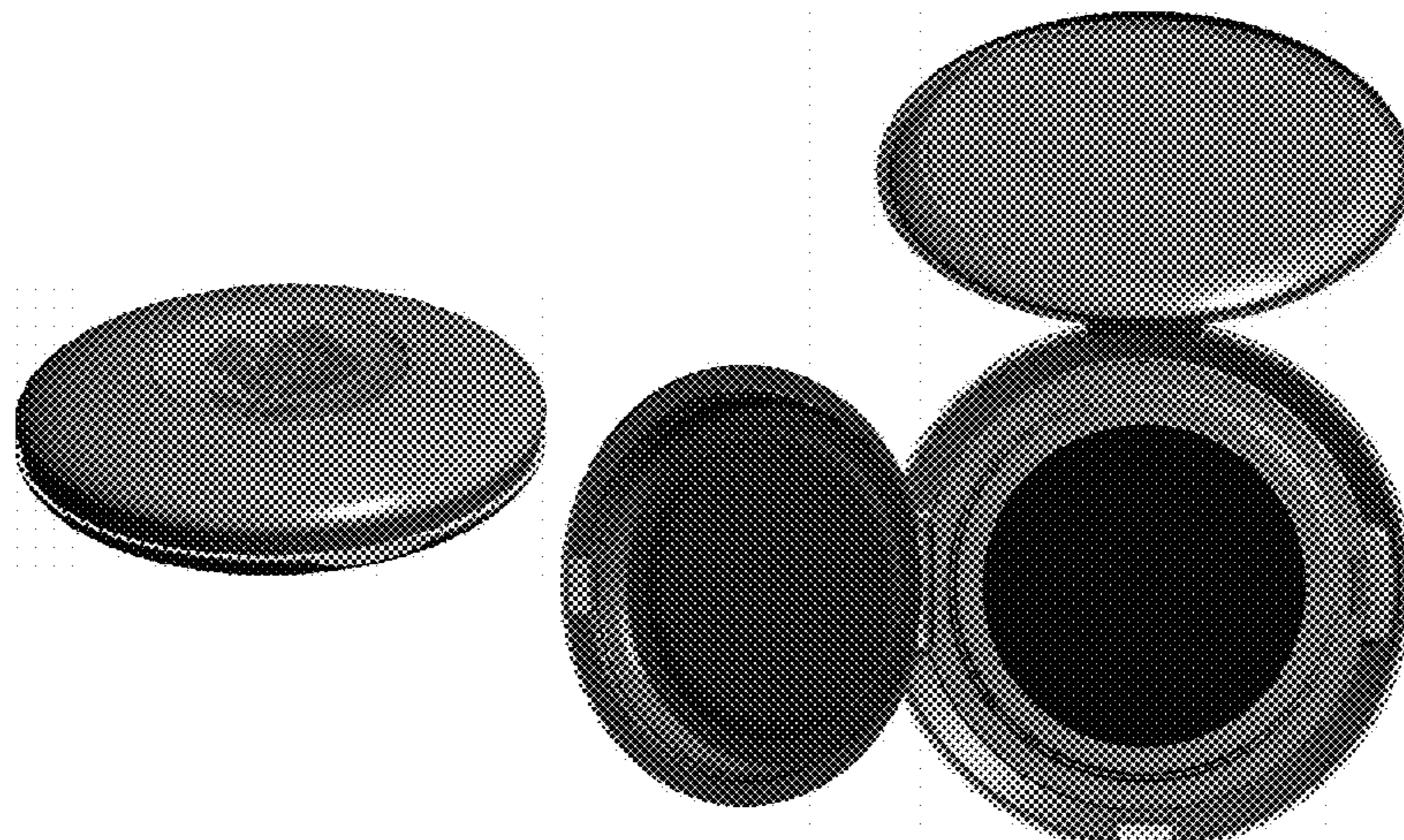


FIG. 1 is a front left perspective view from above of a blush compact with its outer casing closed.

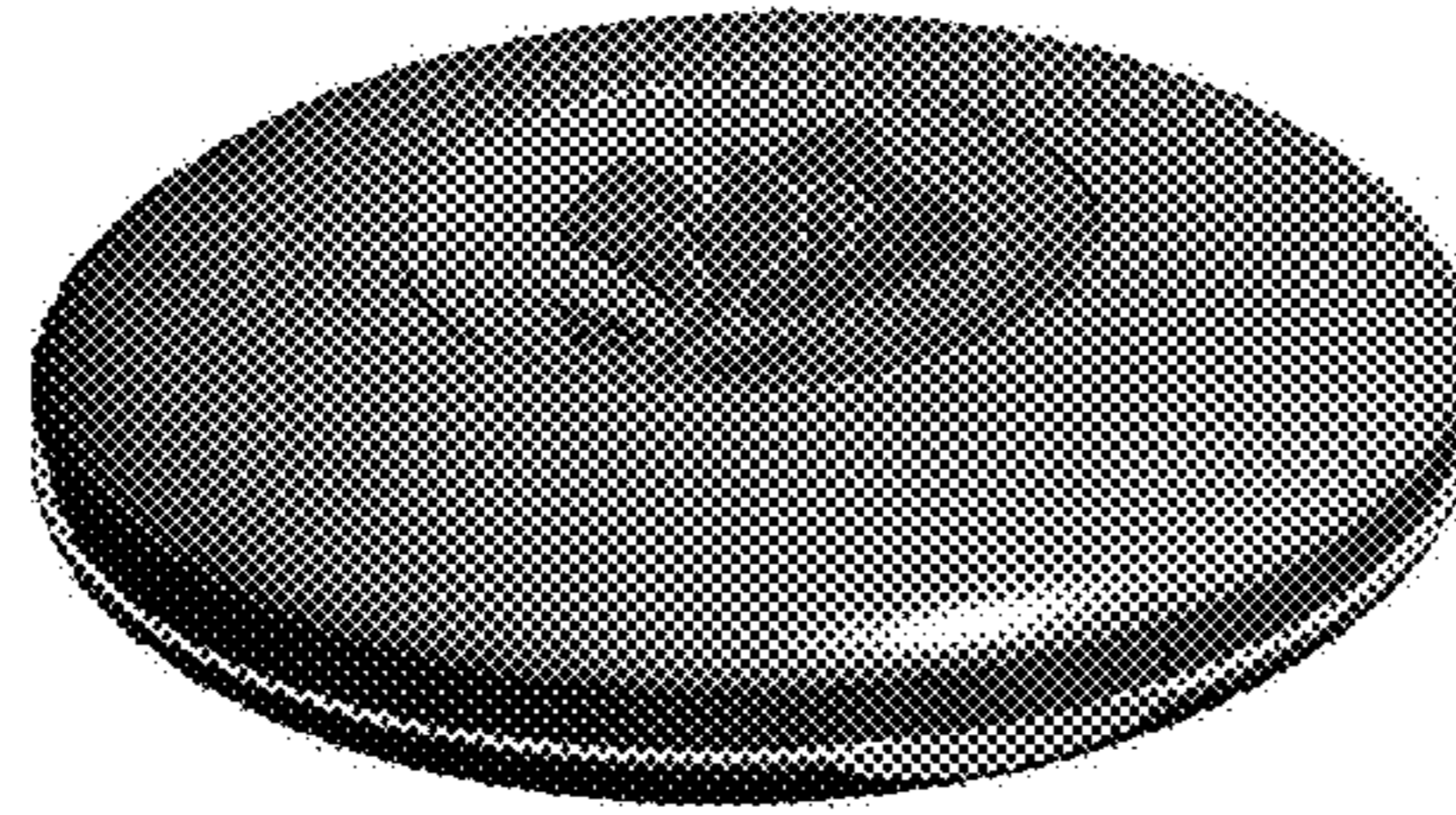

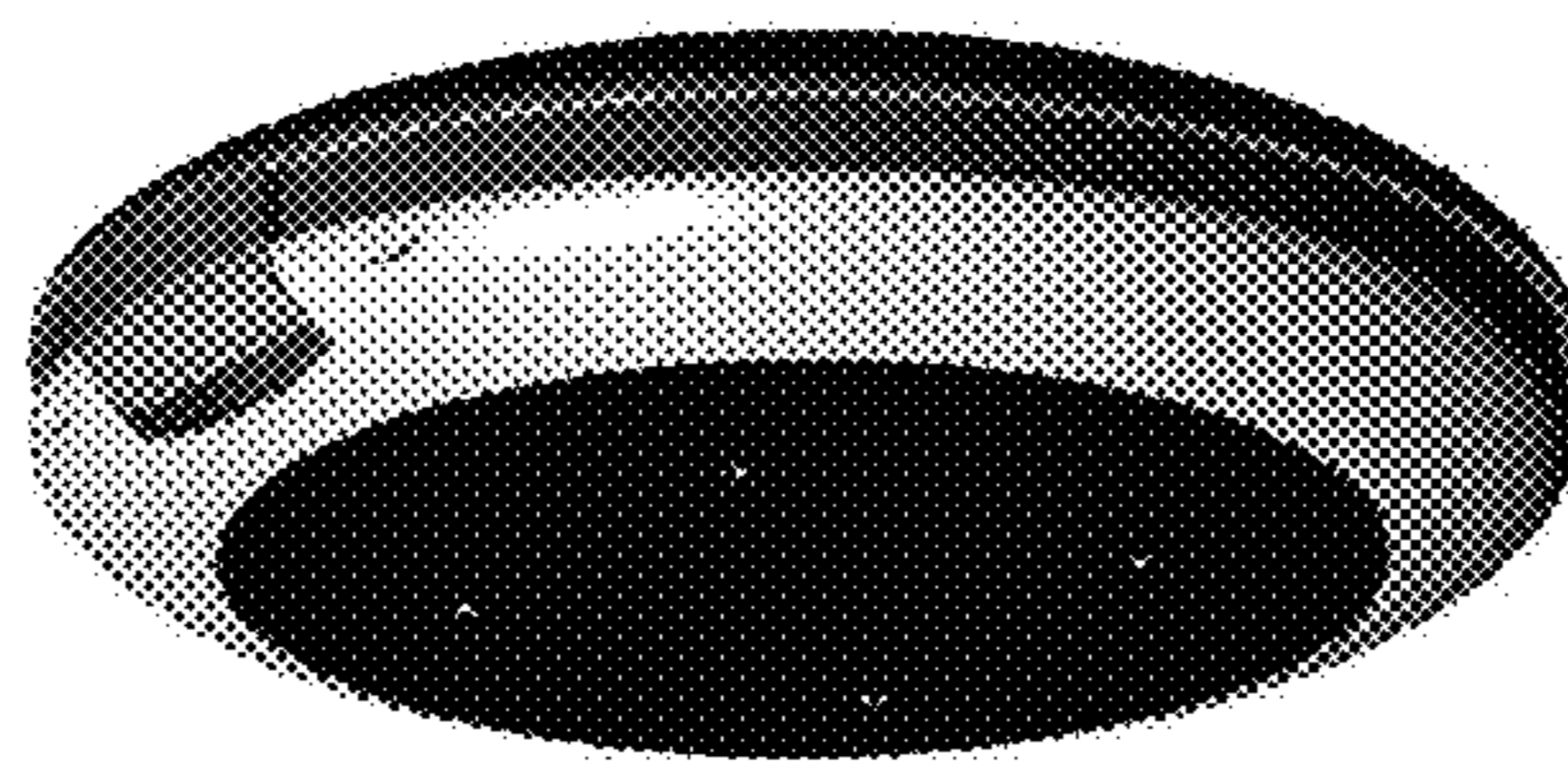

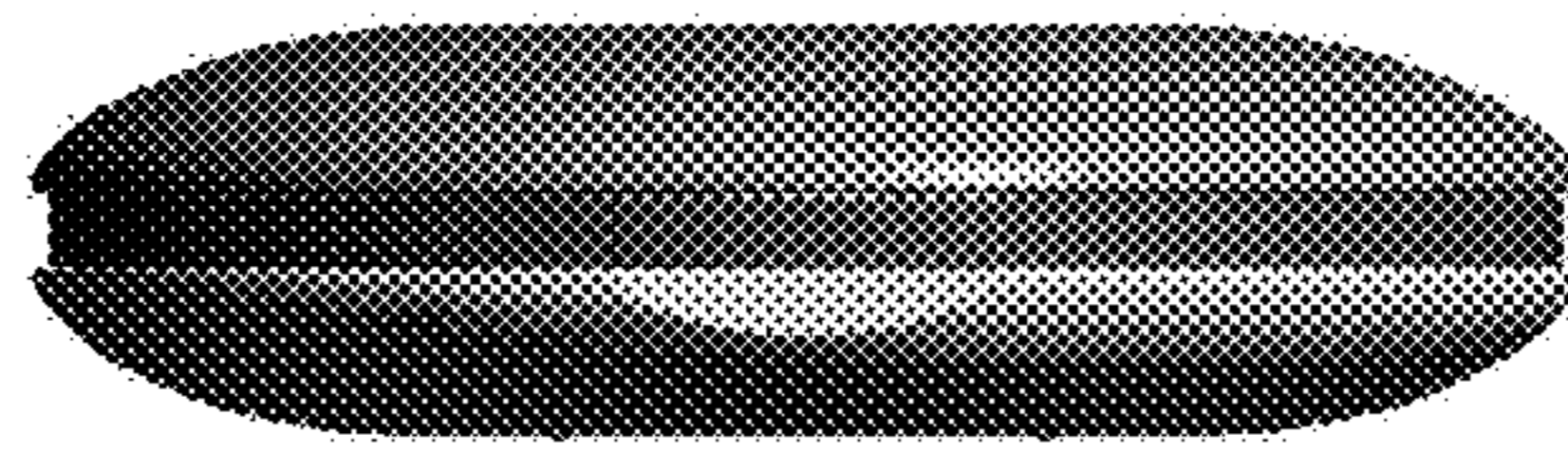

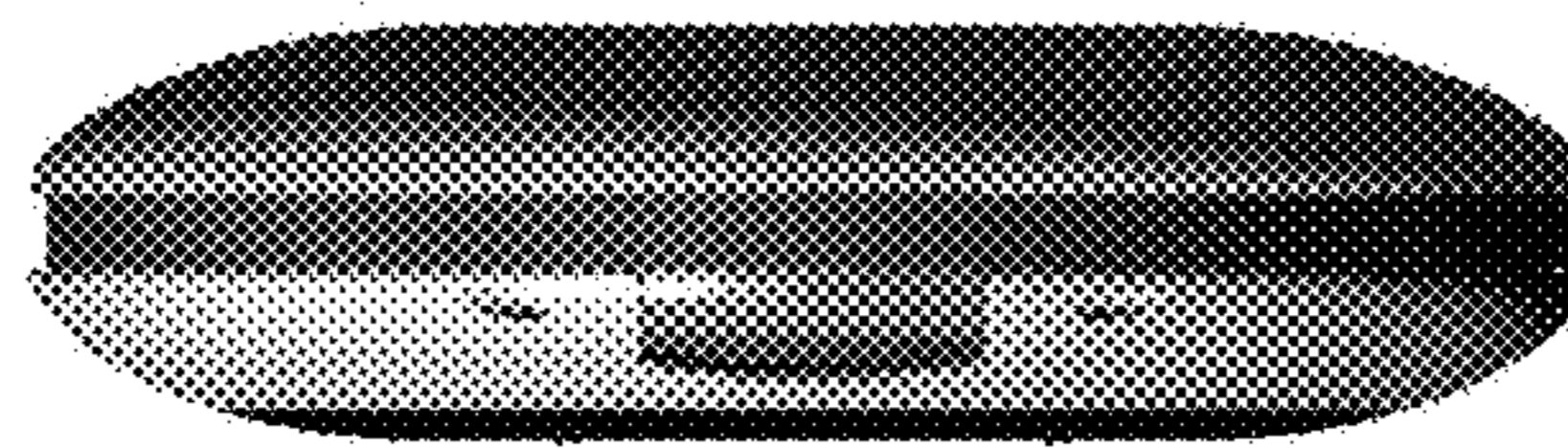

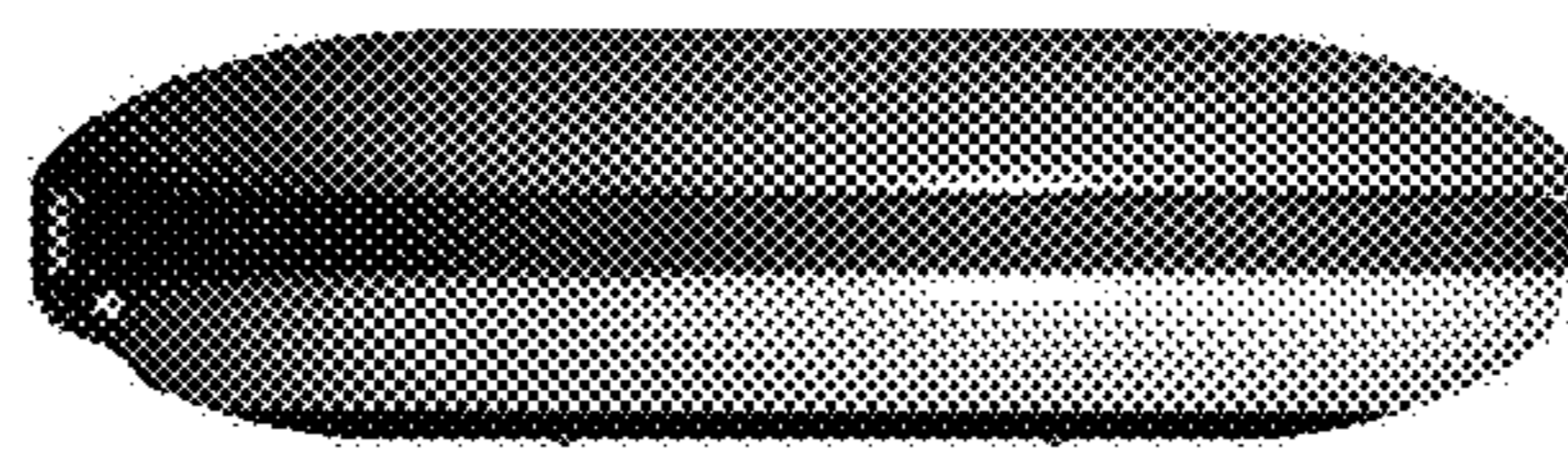

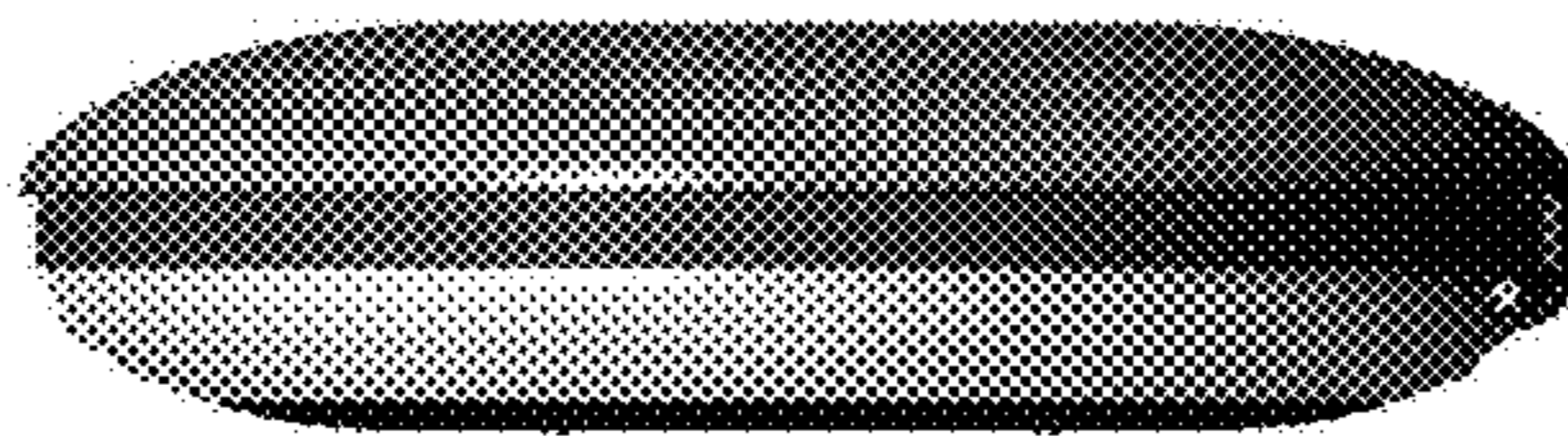

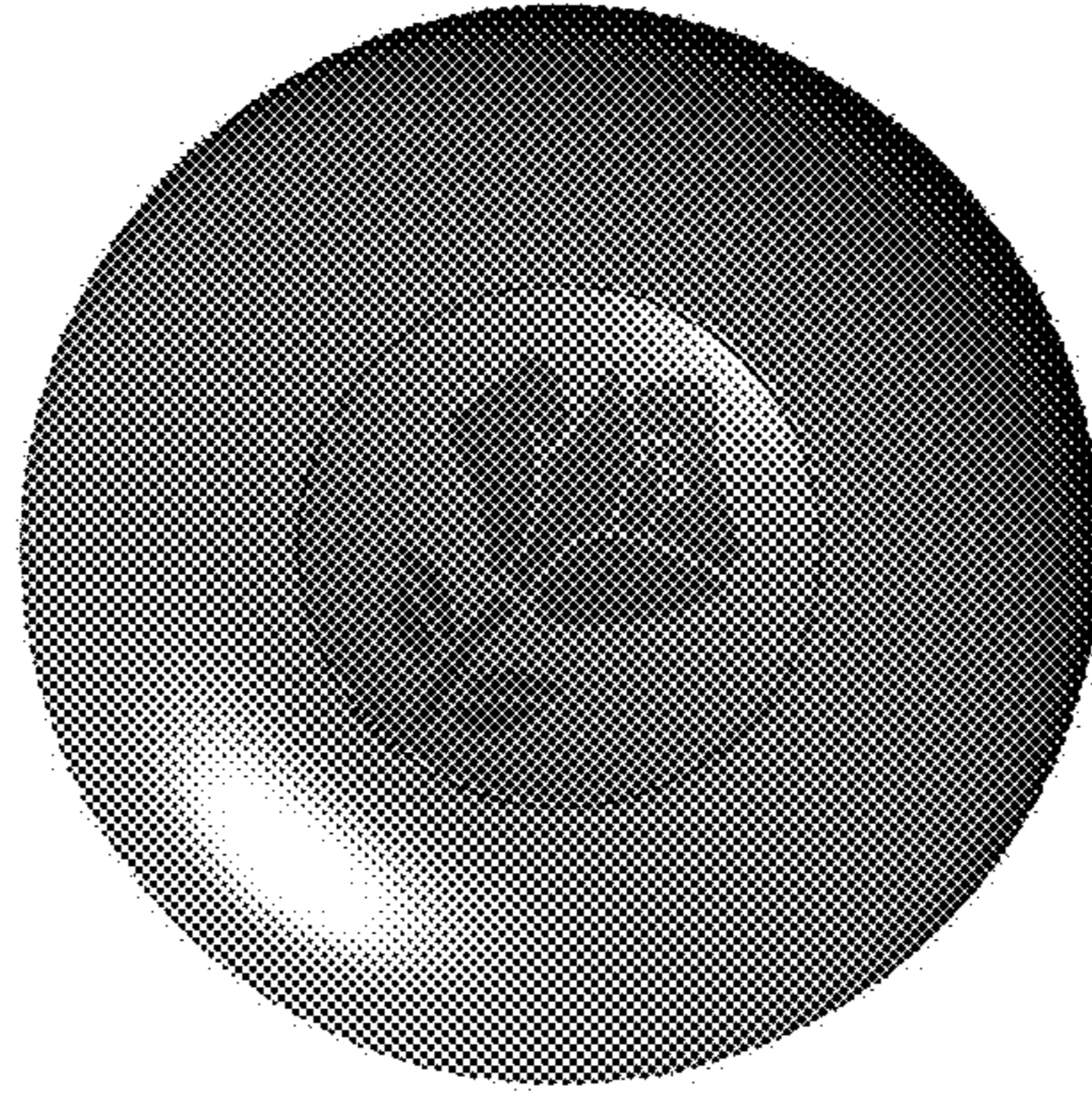

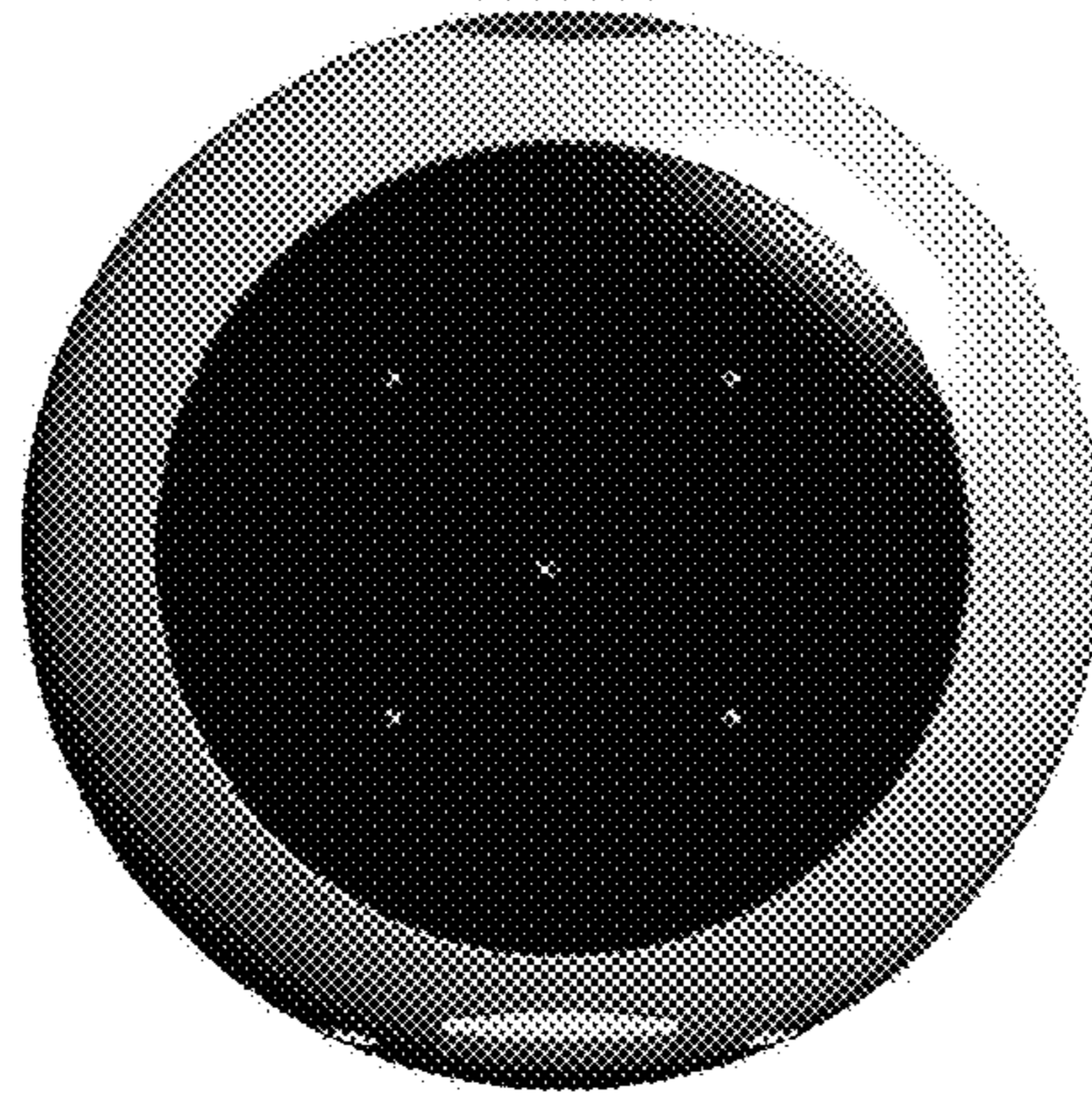

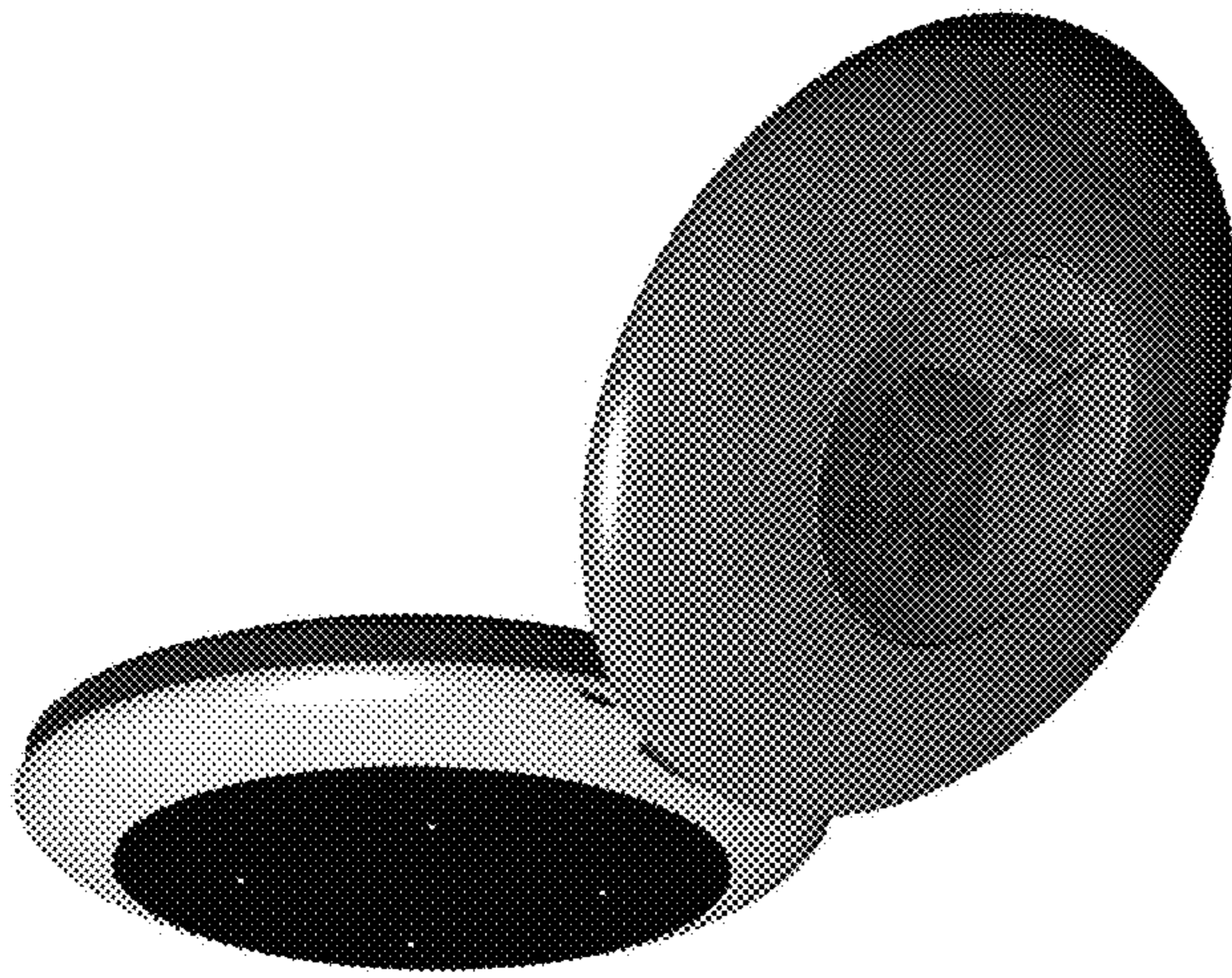

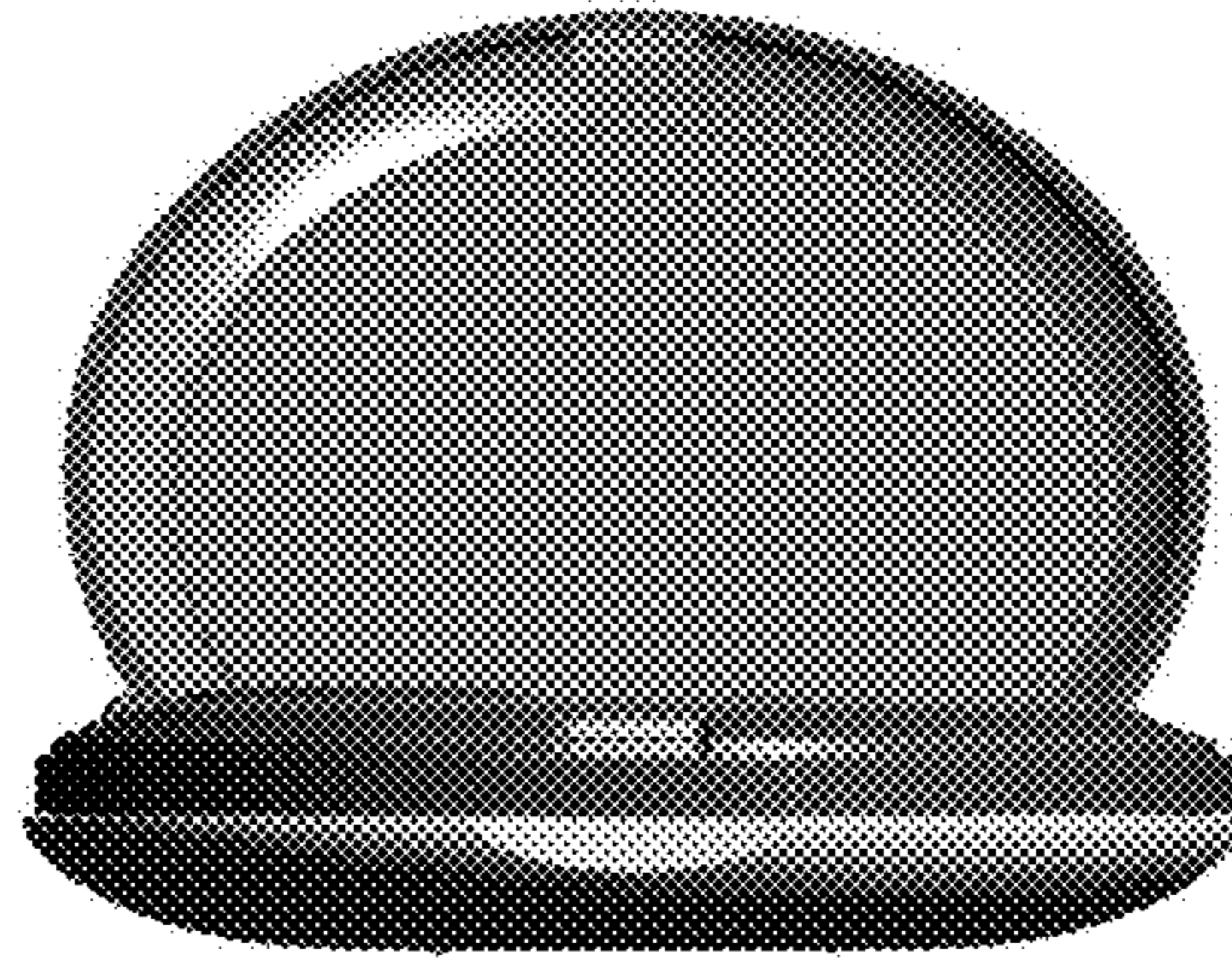

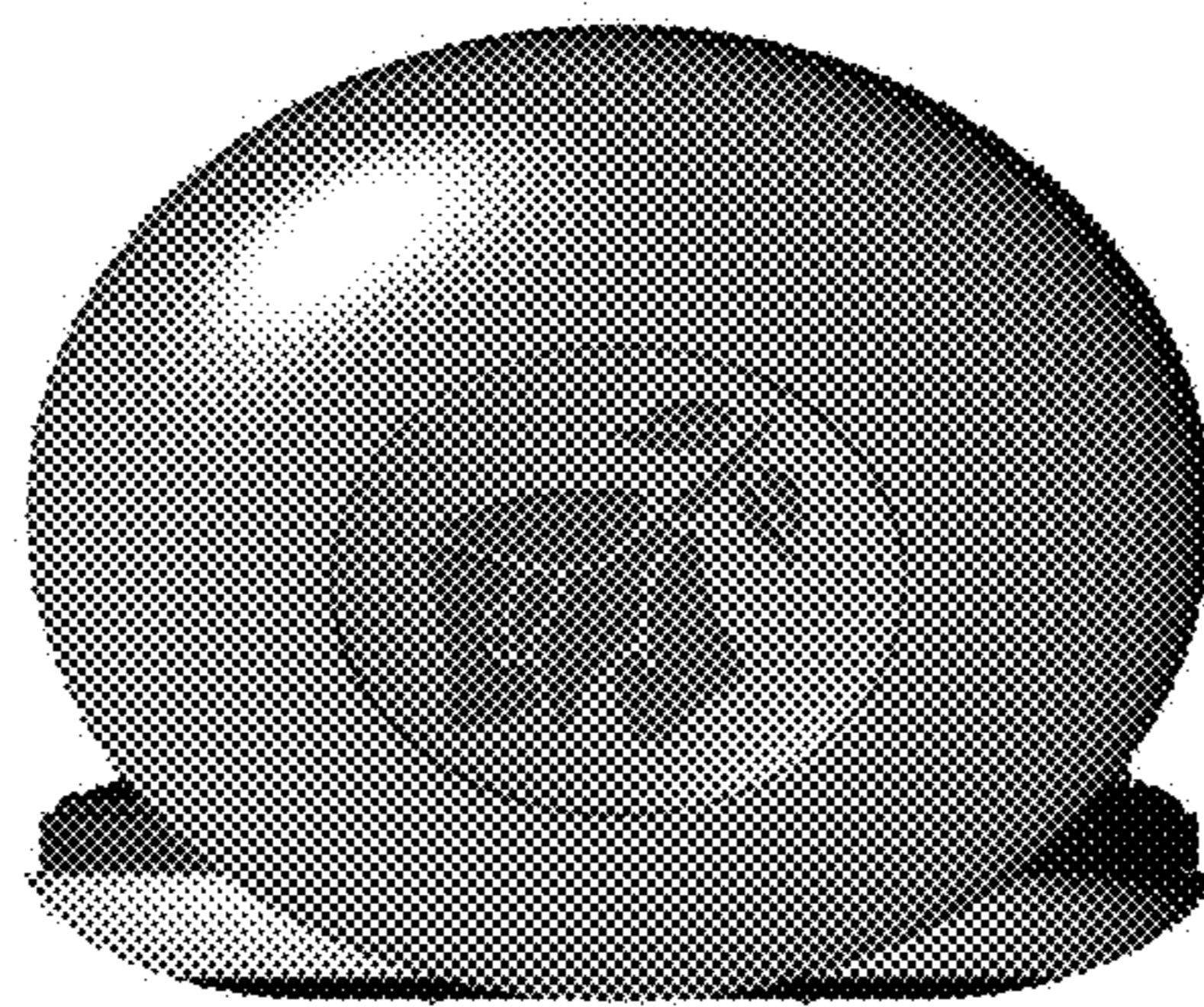

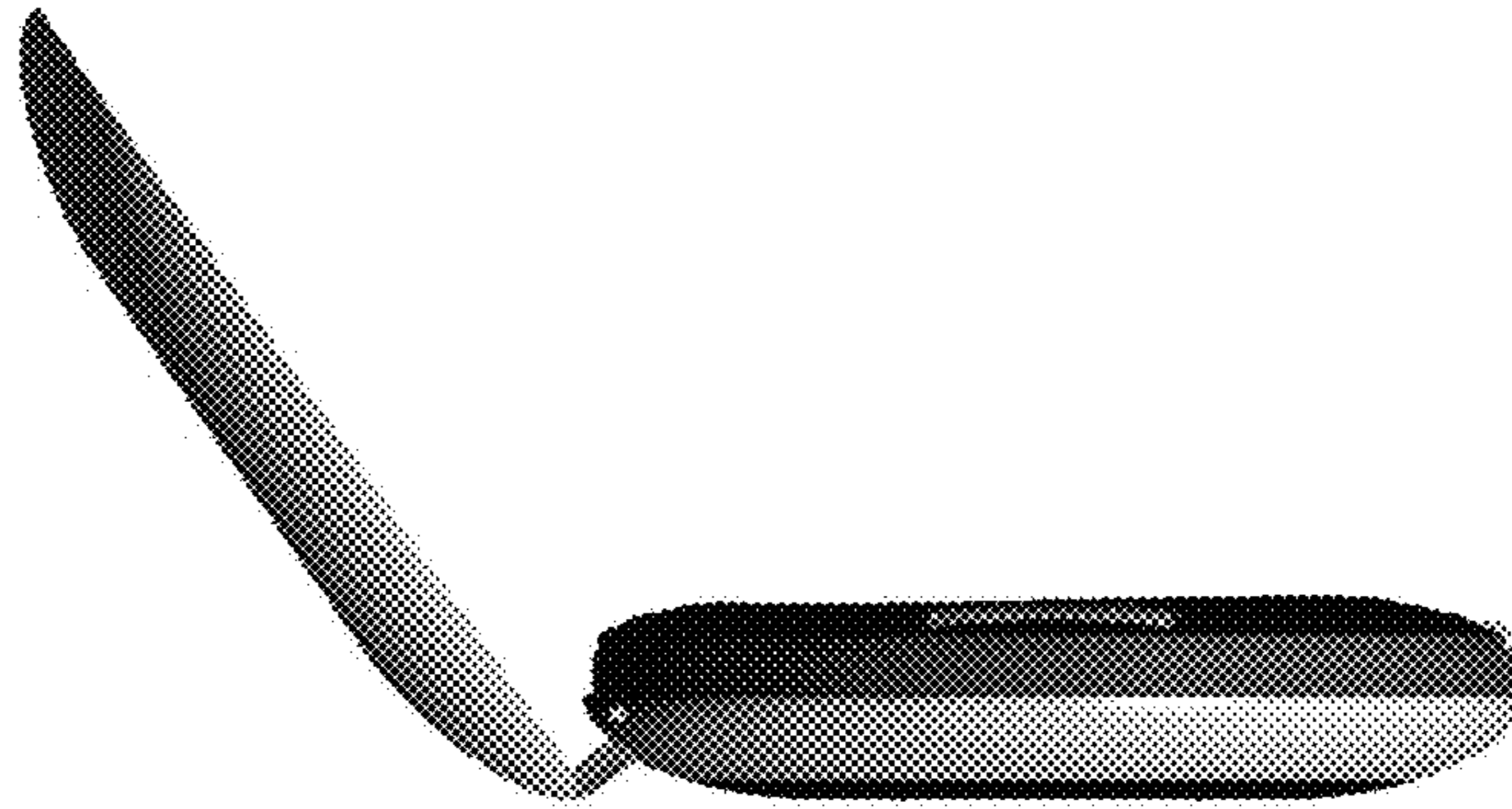

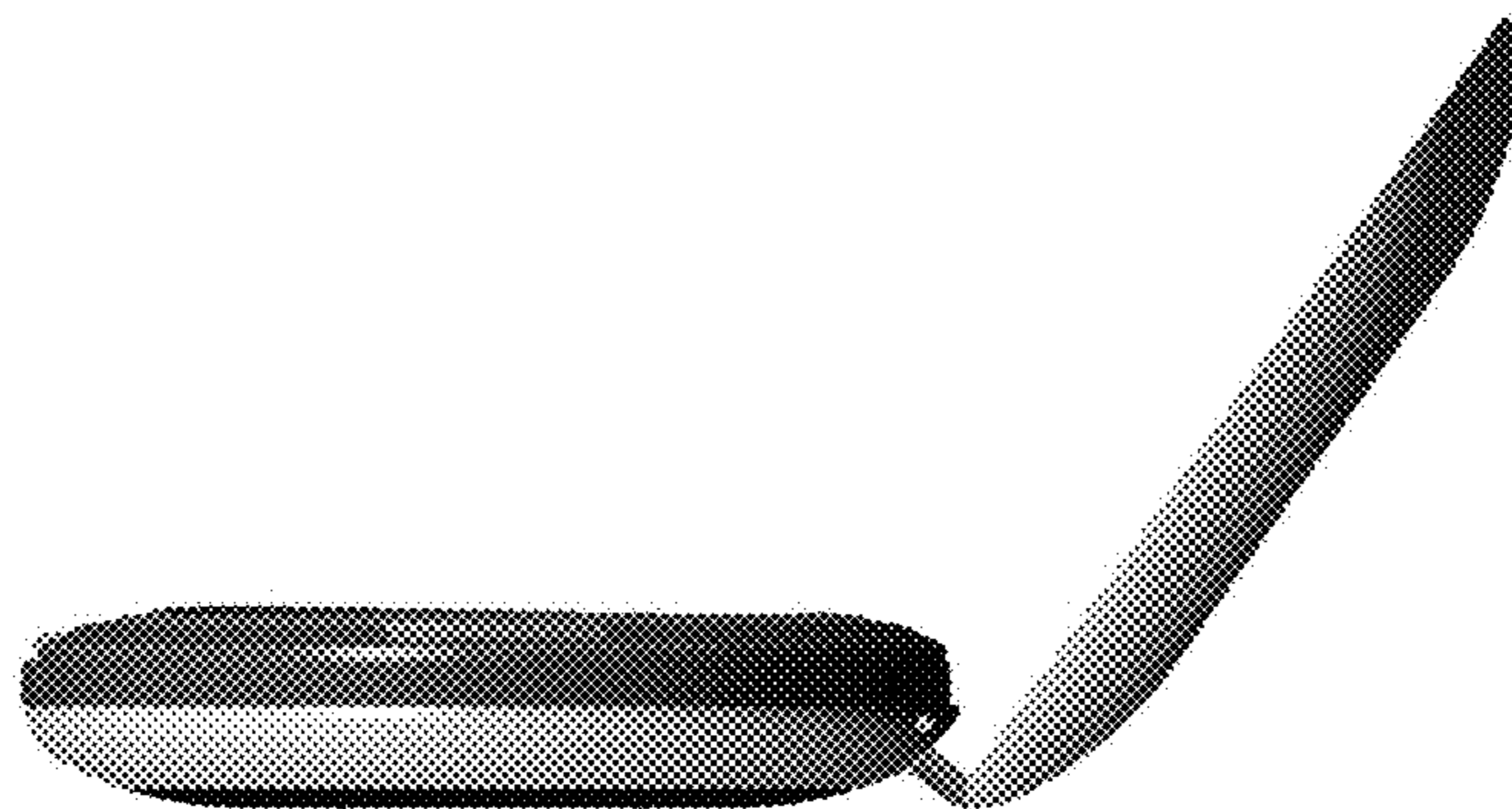

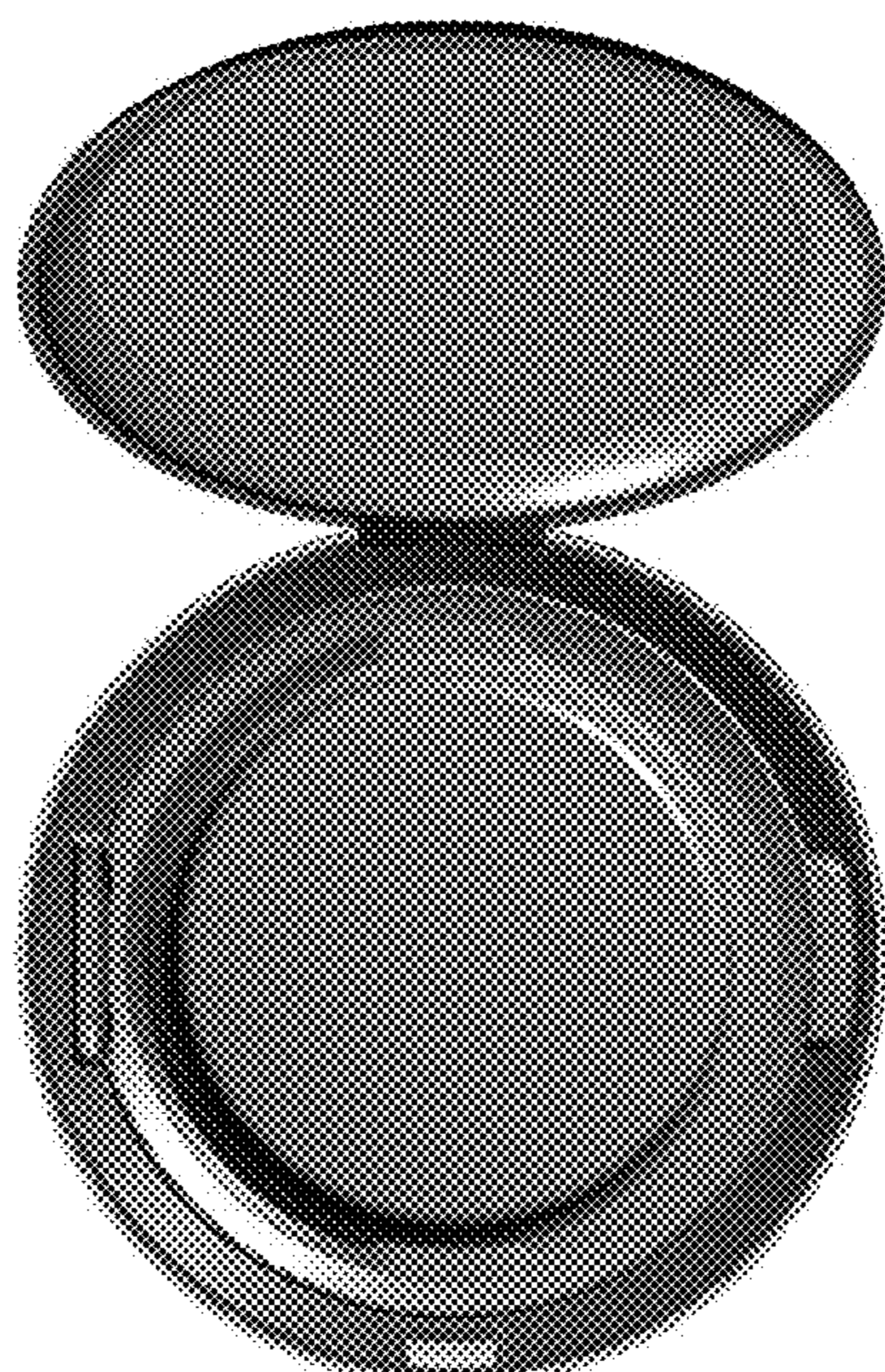

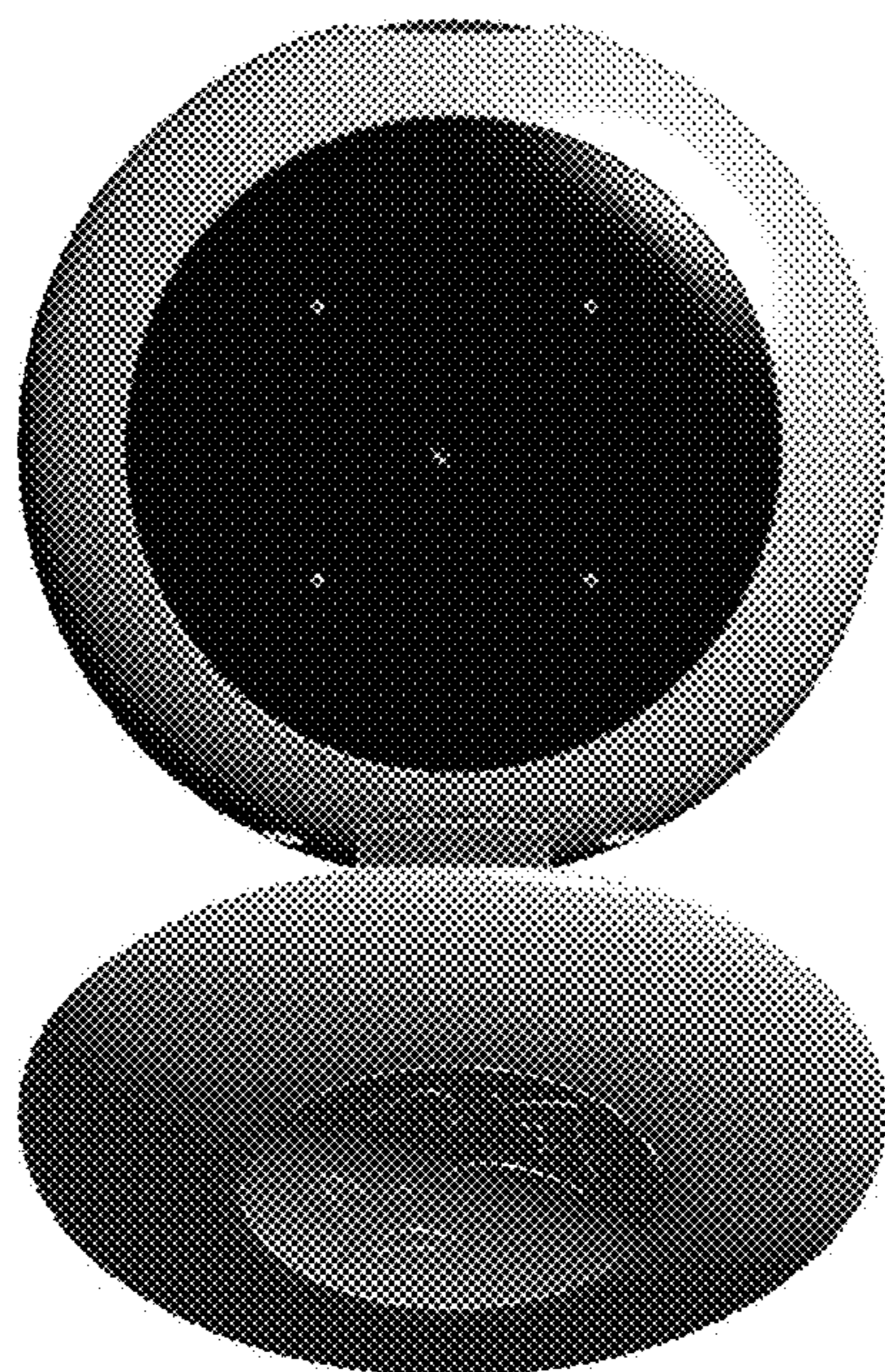

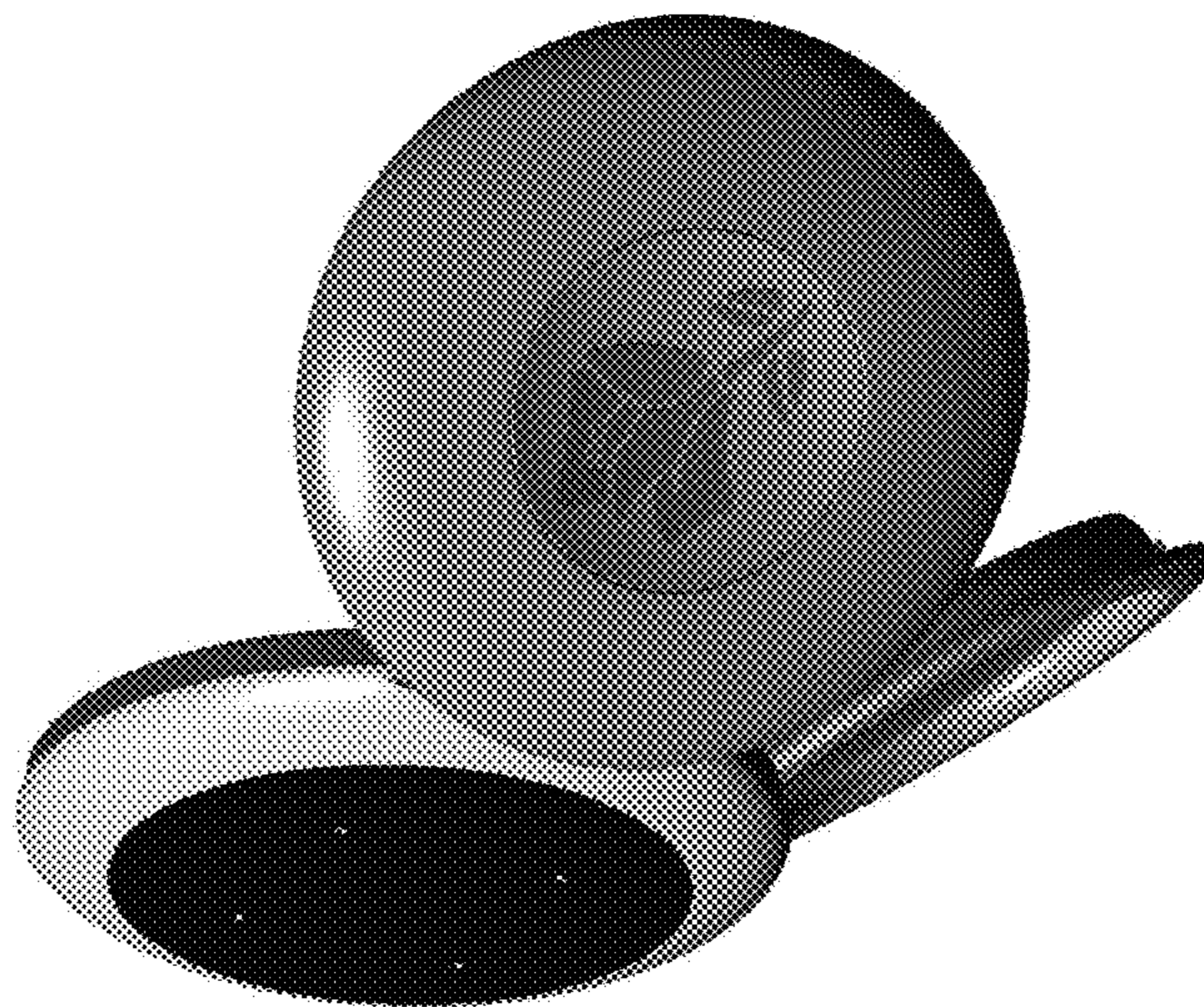

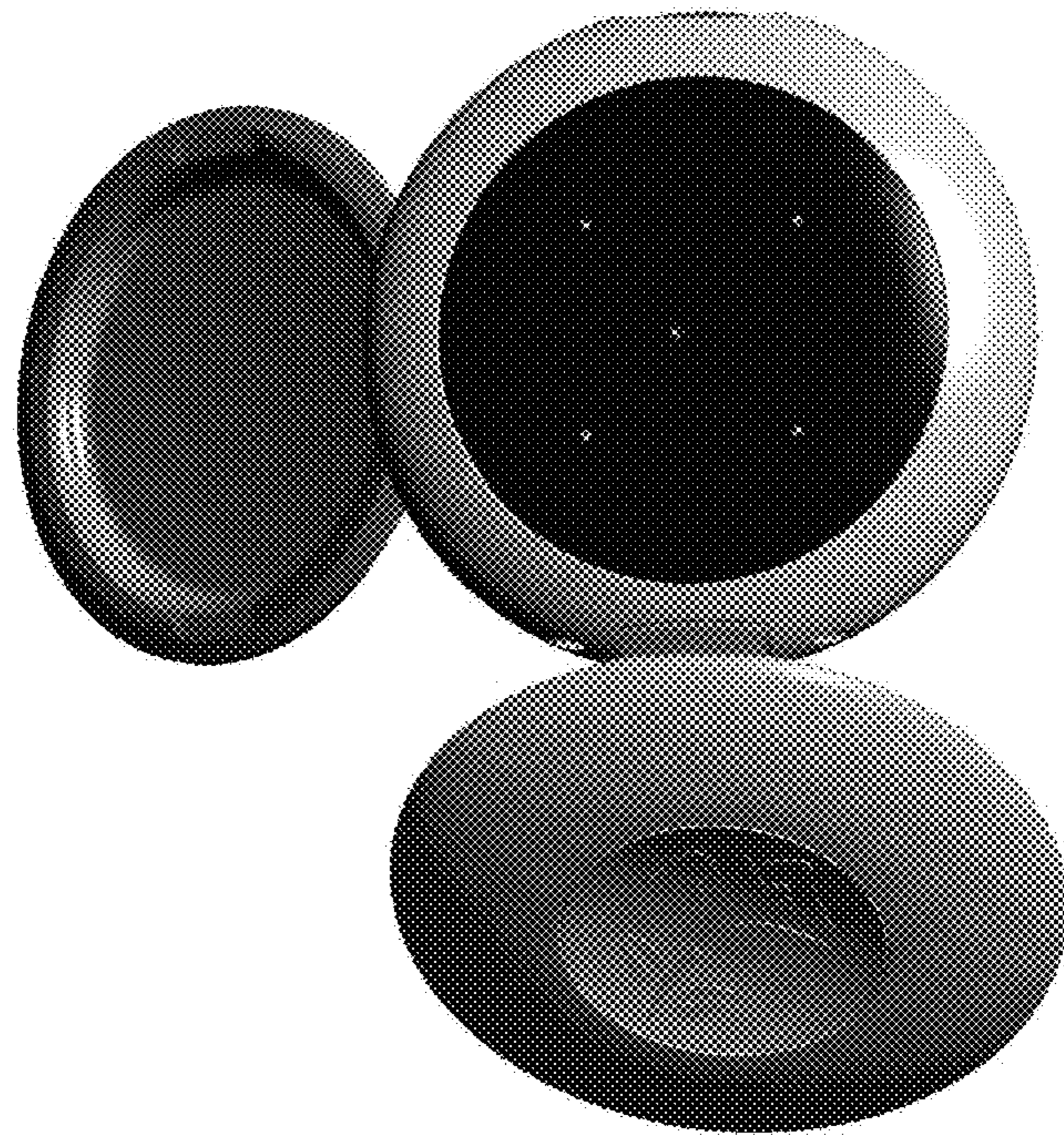

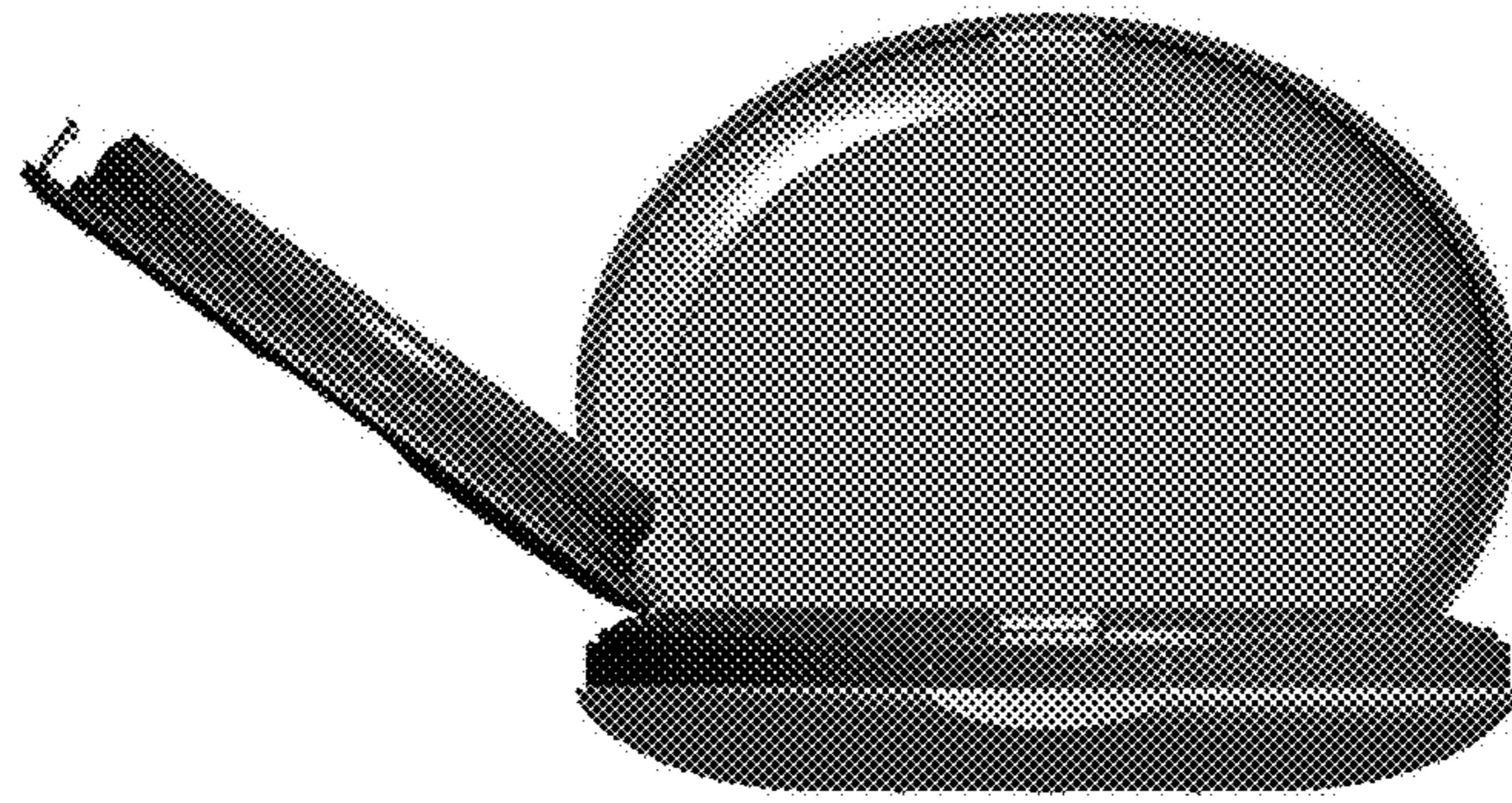

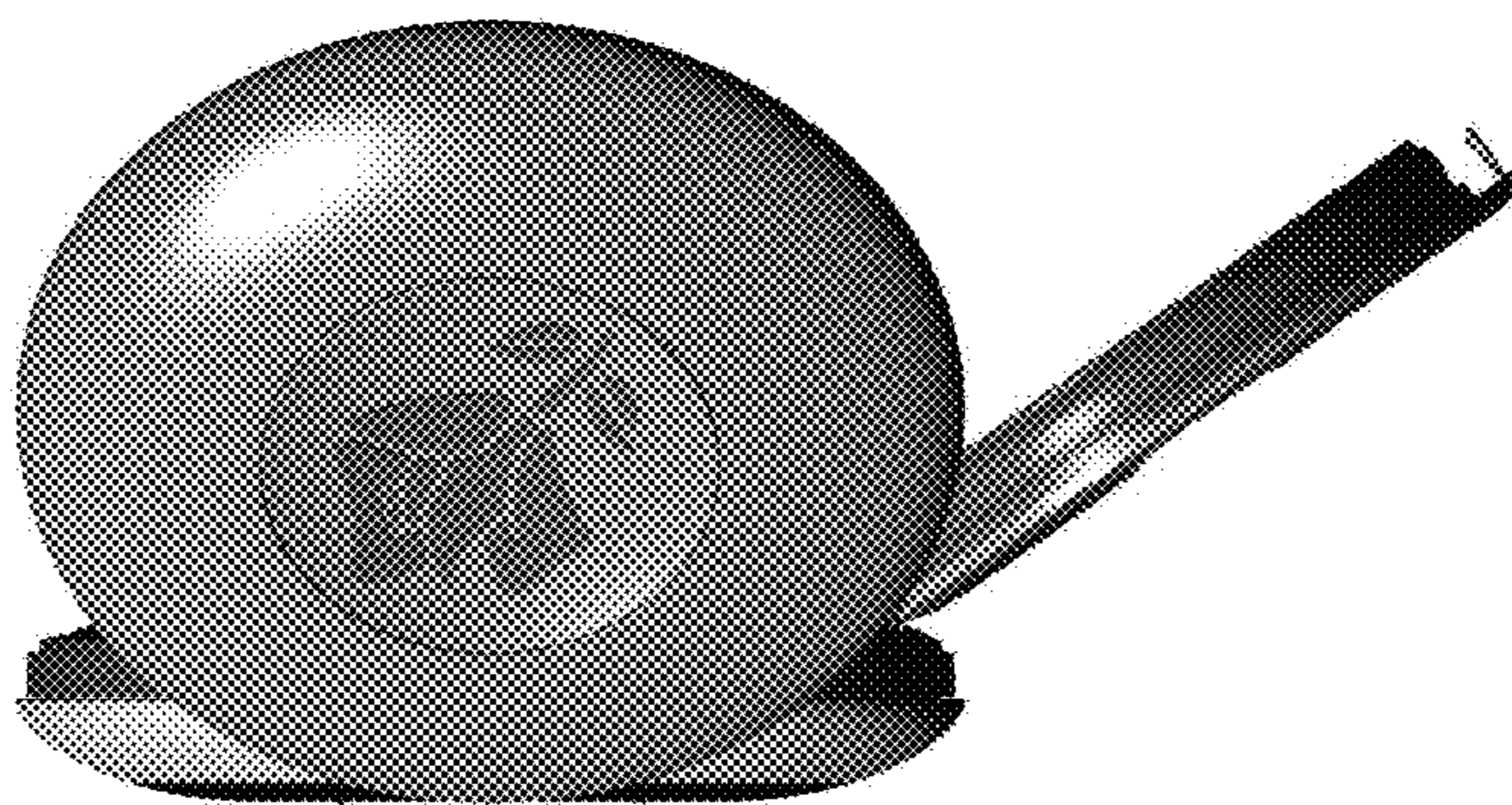

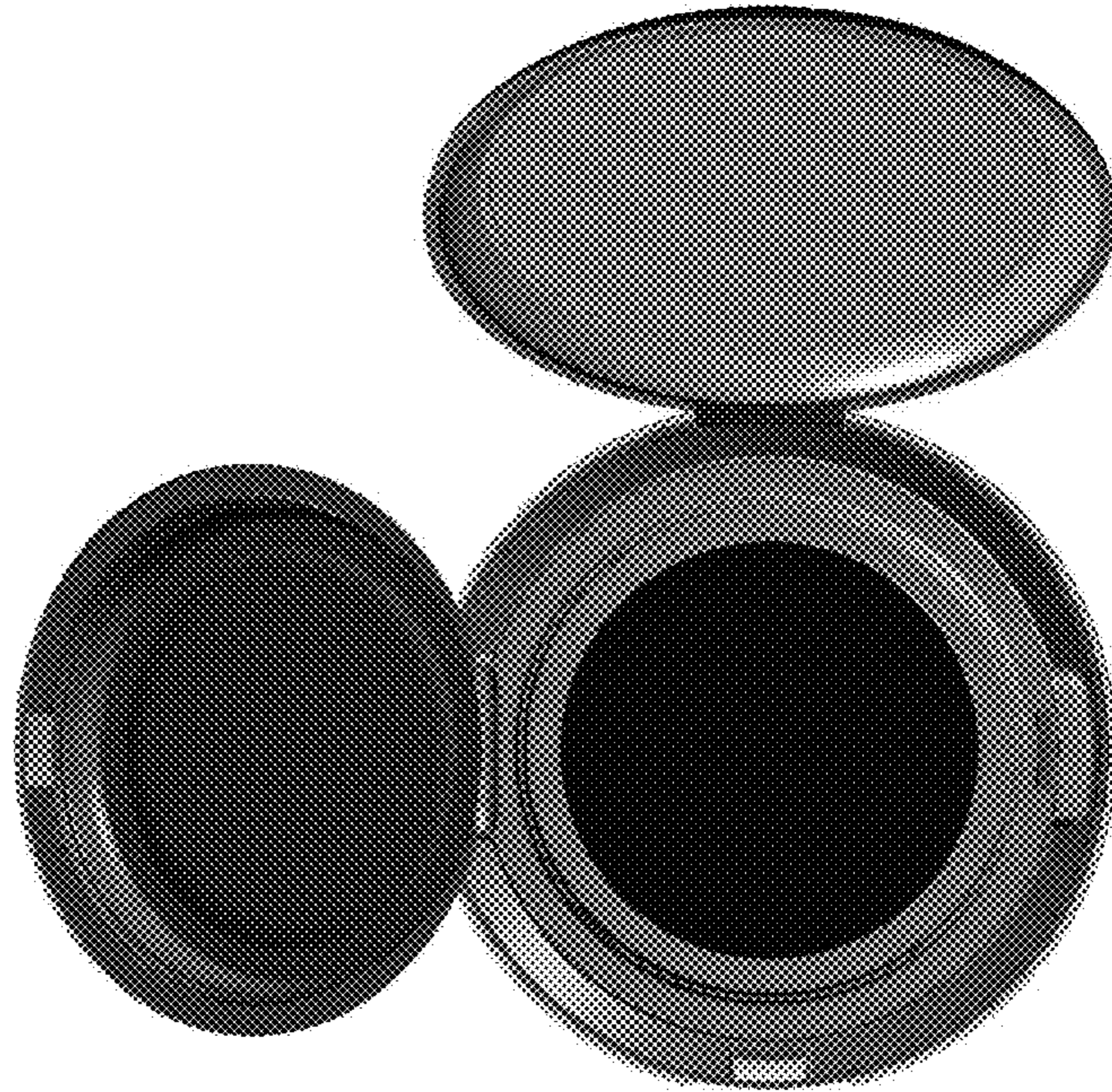

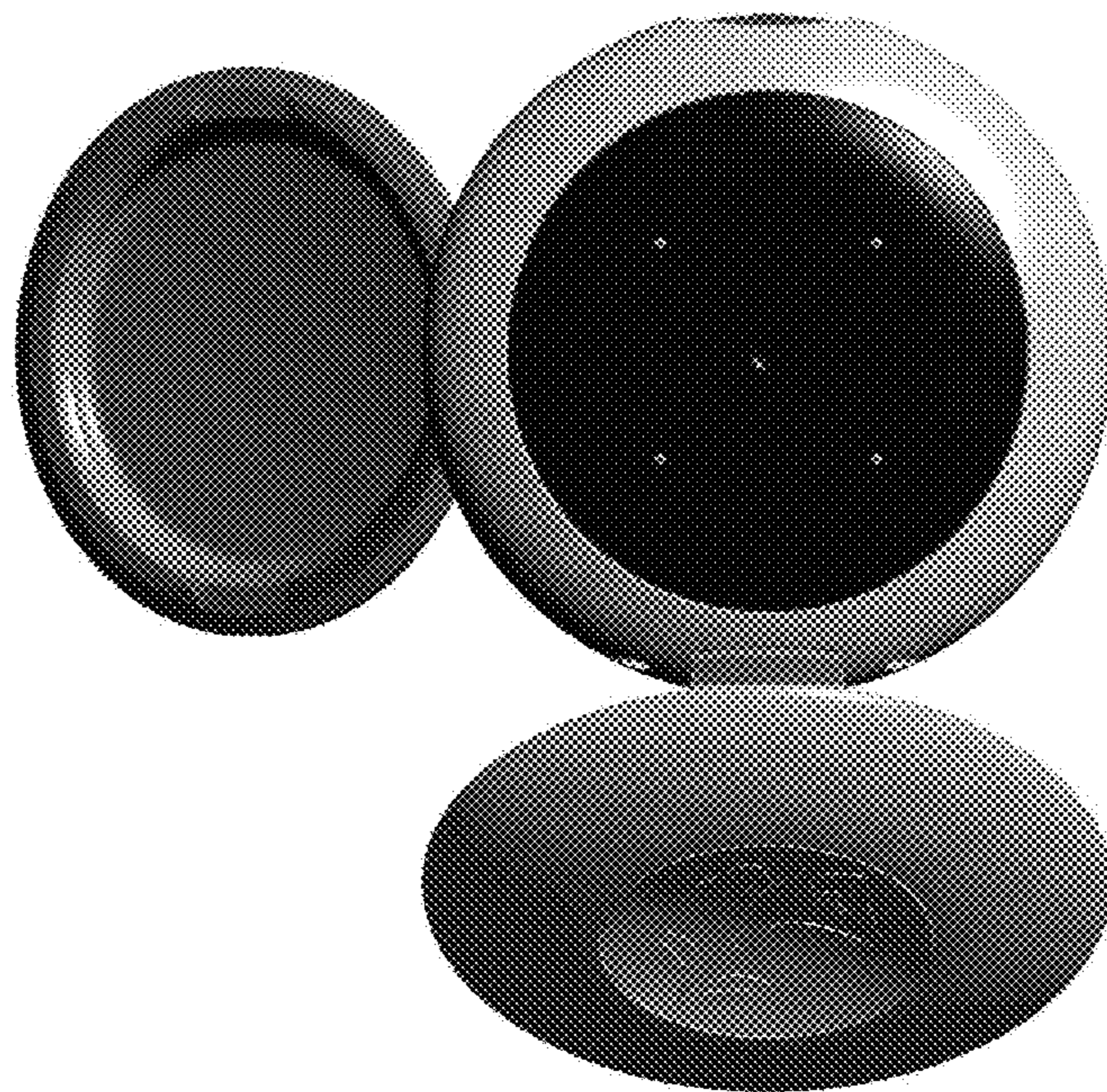
