The ornamental design for a video gaming glove, as shown and described.

DESCRIPTION

FIG. 1 is a front left side perspective view for a video gaming glove showing my new design, with the velcro strap in a closed position;

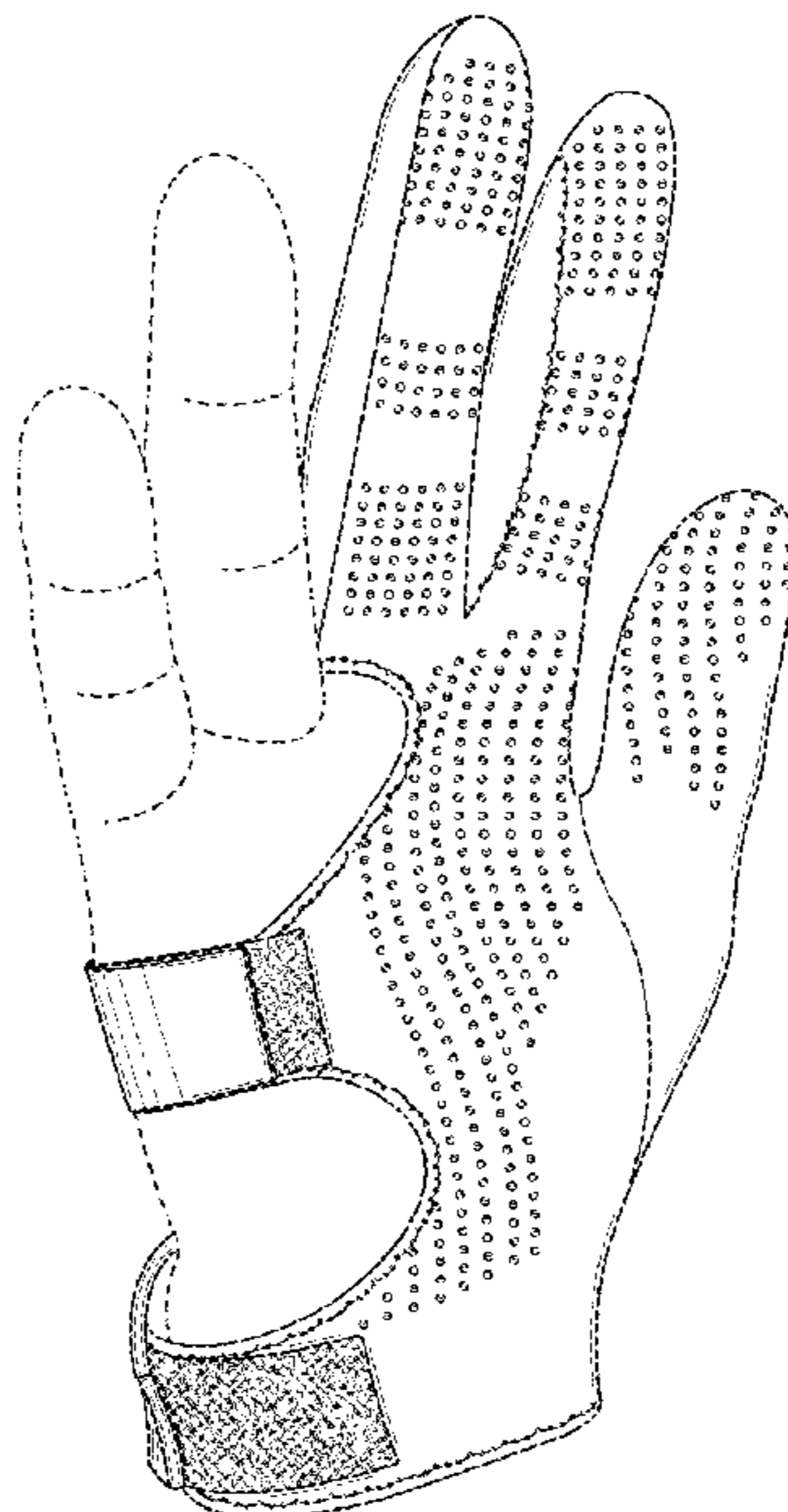
FIG. 2 is a front elevational view of FIG. 1 thereof;

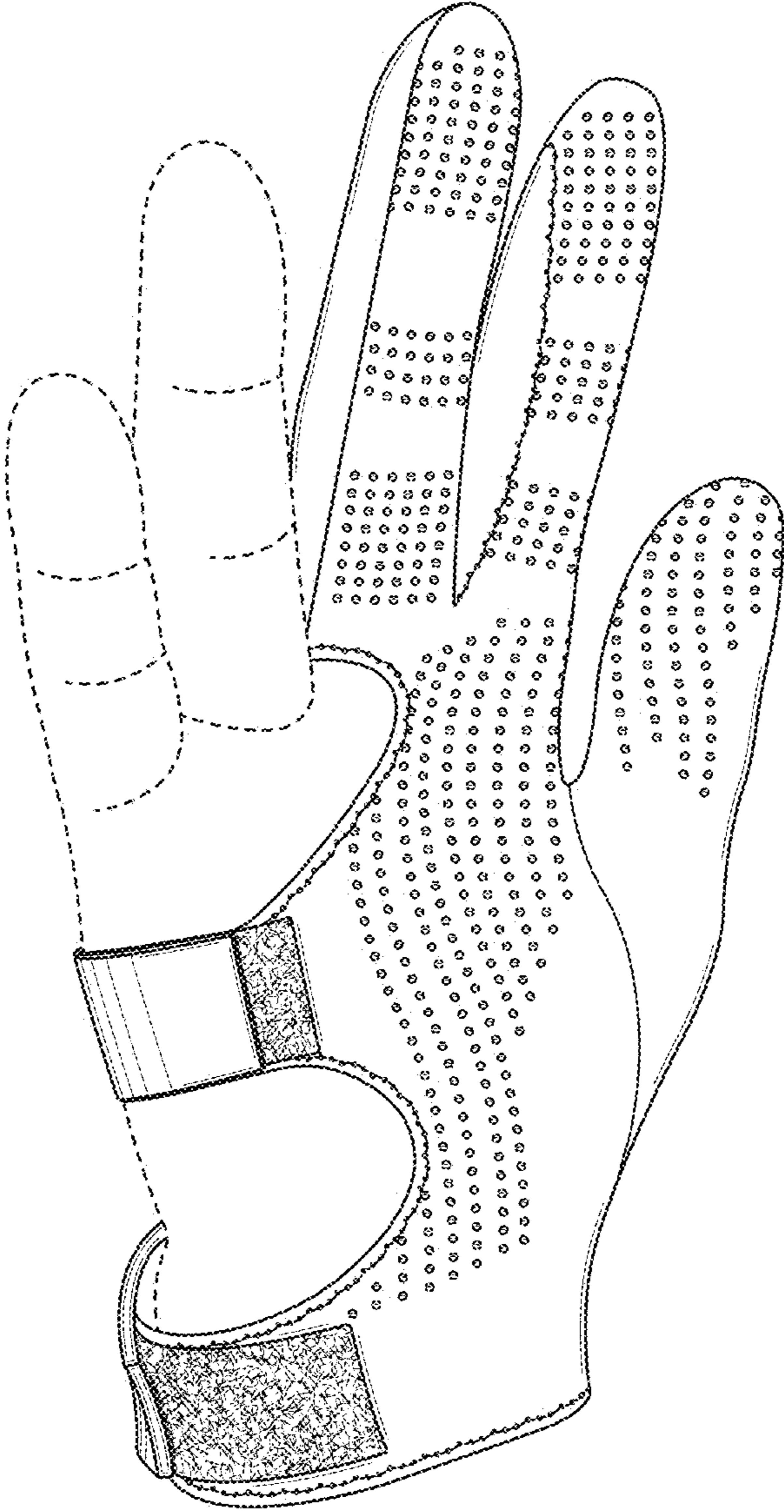

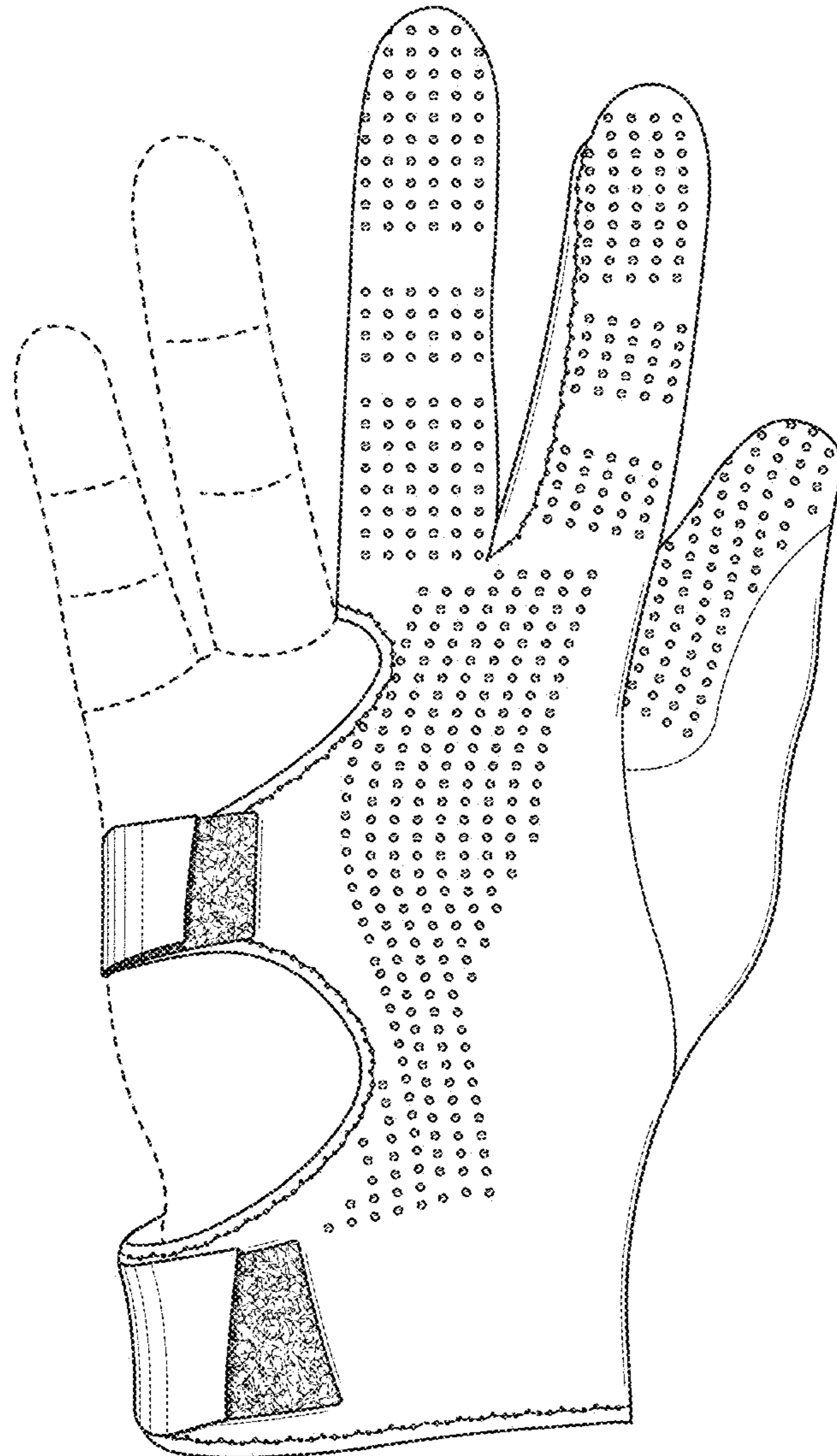

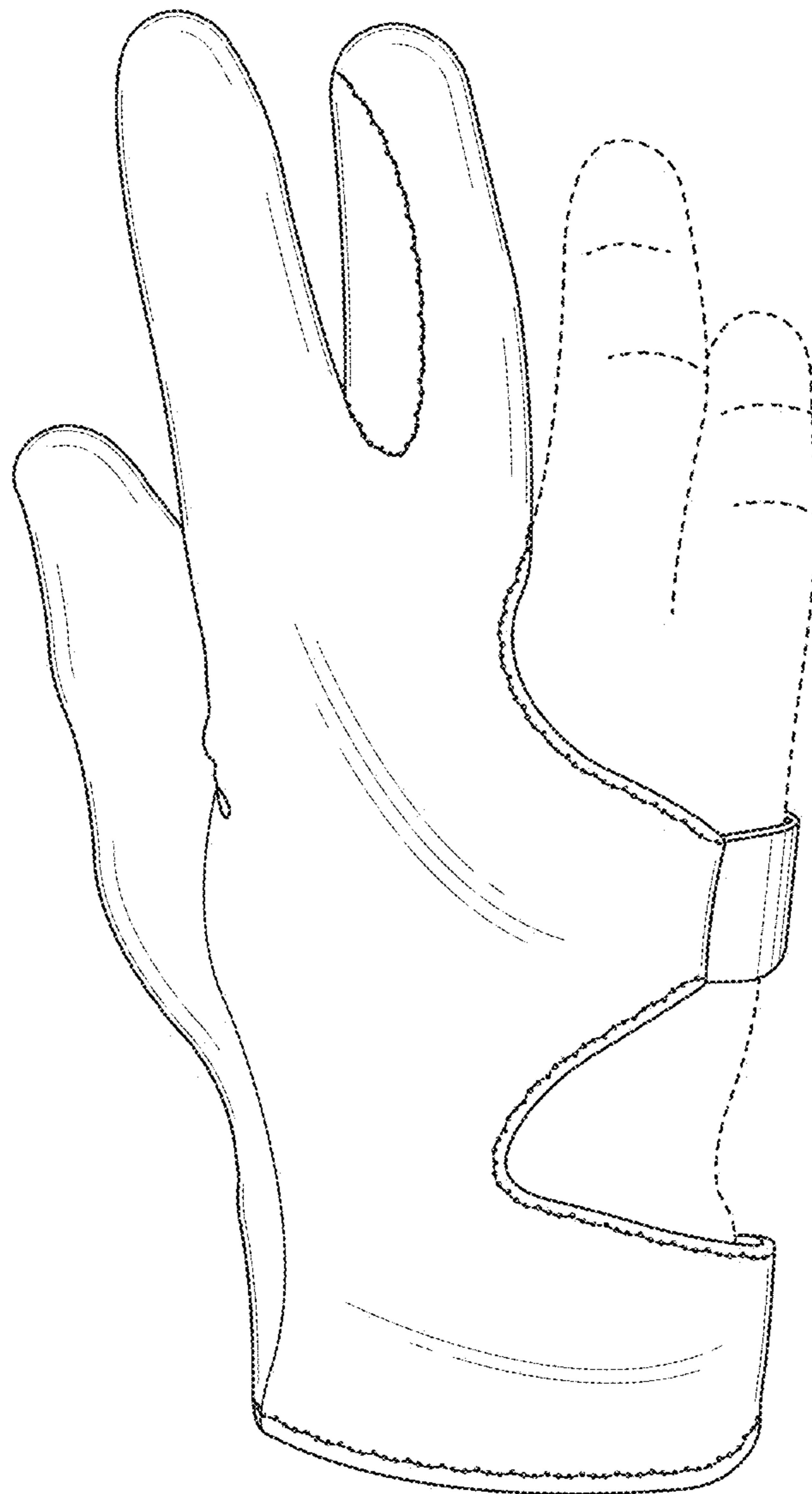

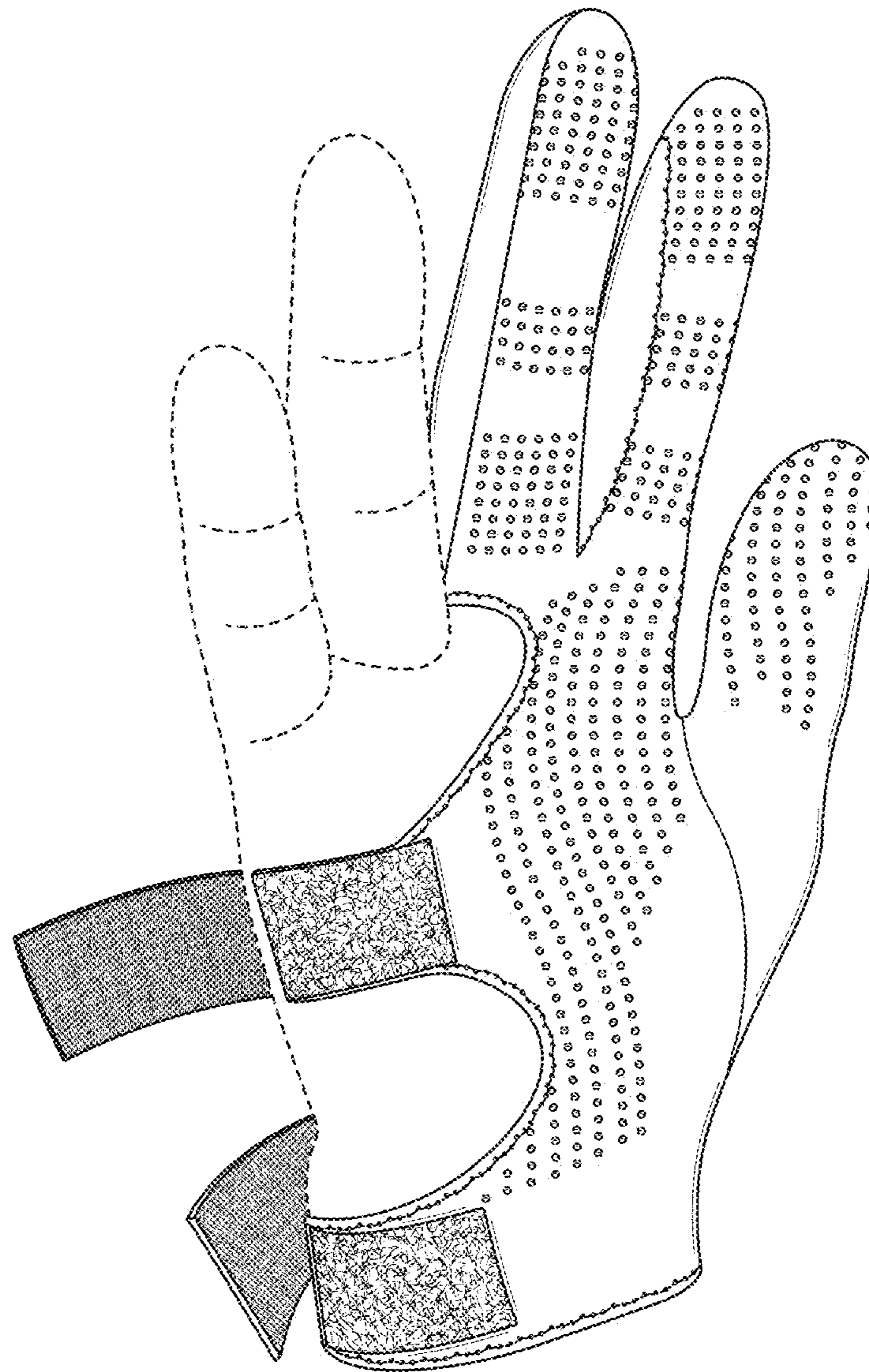
